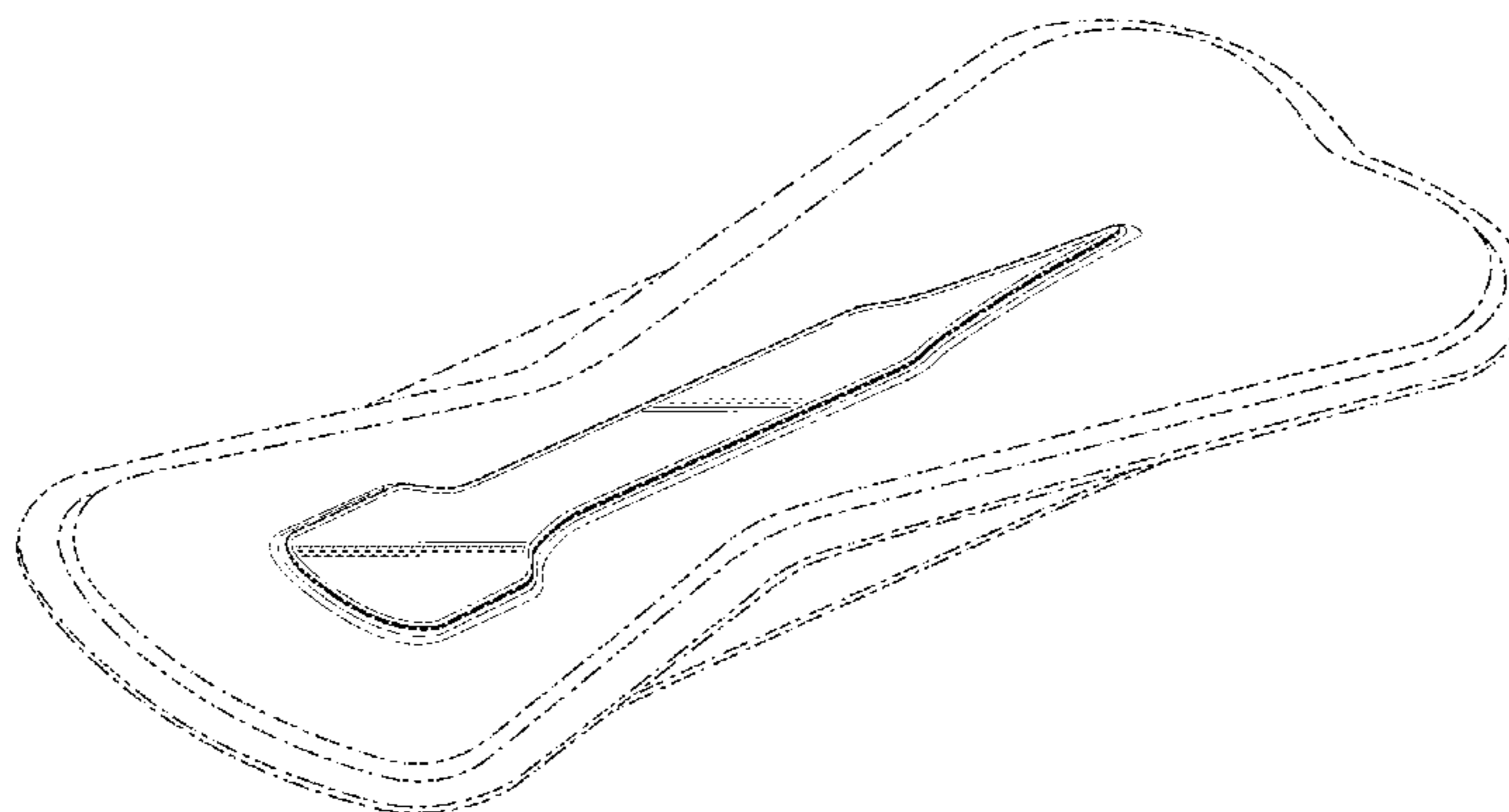
(57) **CLAIM**

We claim the ornamental design for the feminine pad with raised structure, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the body-facing surface of a feminine pad with raised structure.  
FIG. 2 is a top view of the feminine pad of FIG. 1.  
FIG. 3 is a first side view of the feminine pad of FIG. 1.  
FIG. 4 is a second side view of the feminine pad of FIG. 1.  
FIG. 5 is a first end view of the feminine pad of FIG. 1.  
FIG. 6 is a second end view of the feminine pad of FIG. 1; and, FIG. 7 is a back view of the feminine pad of FIG. 1.  
The broken lines shown are for the purpose of illustrating environmental structure and form no part of the claimed design.

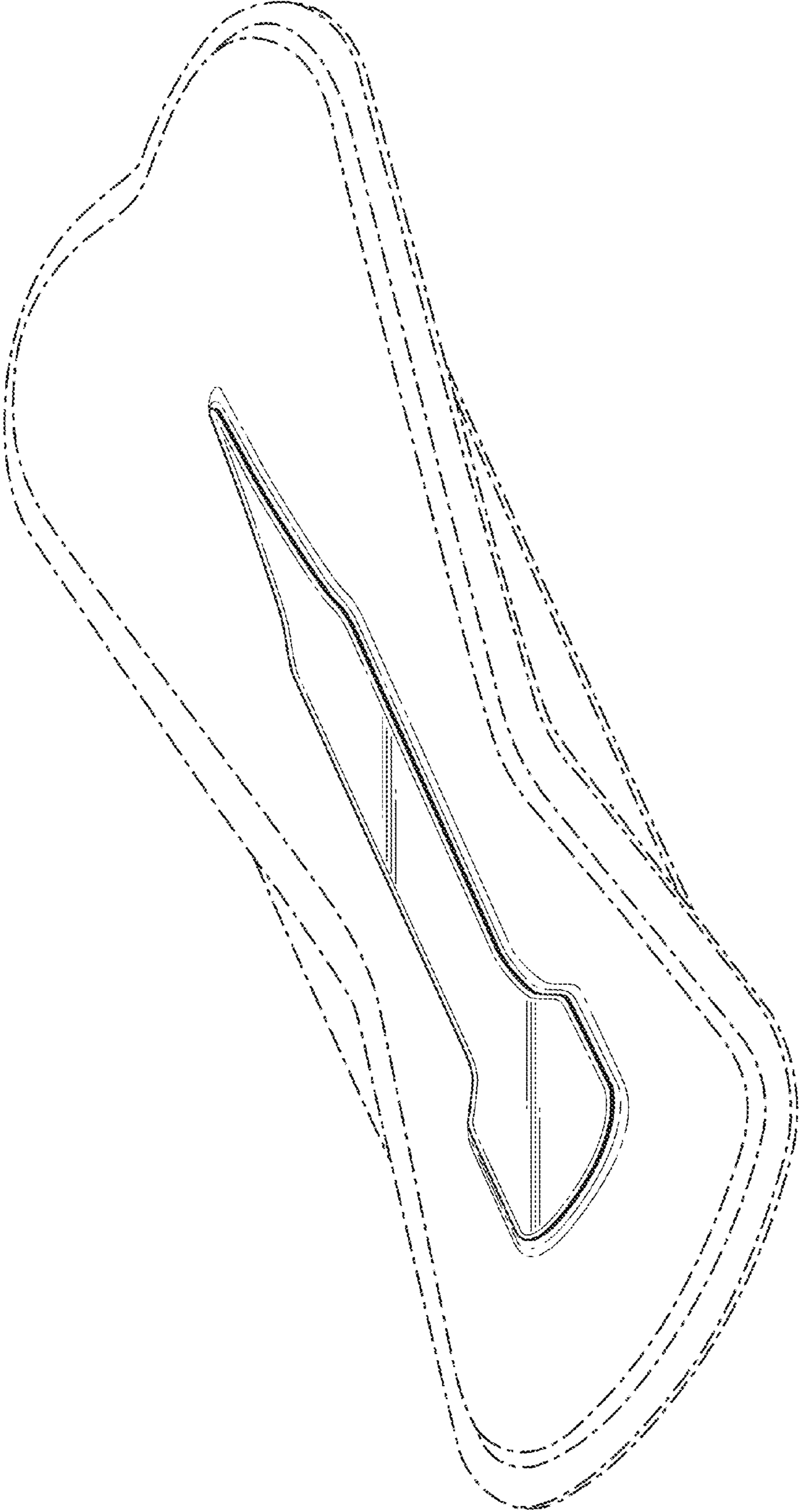

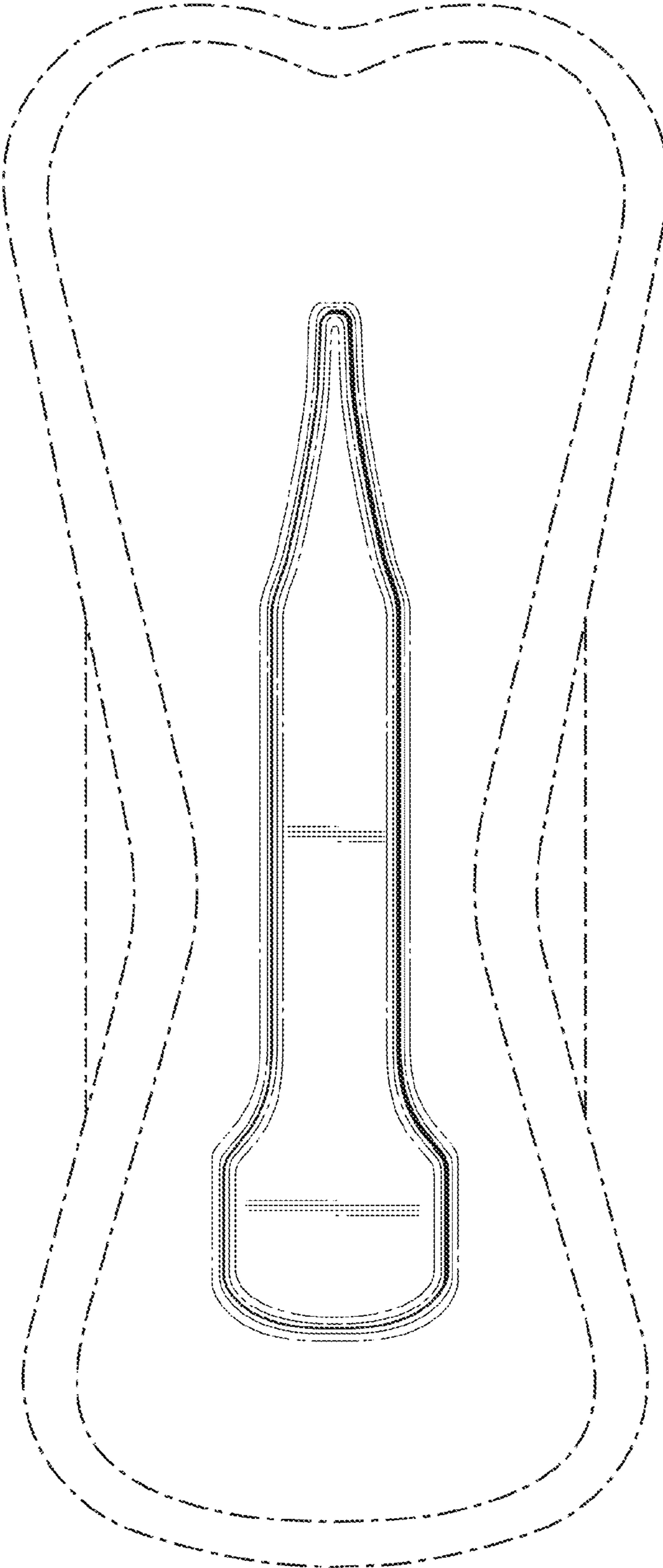

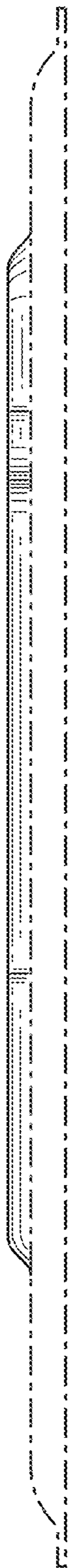

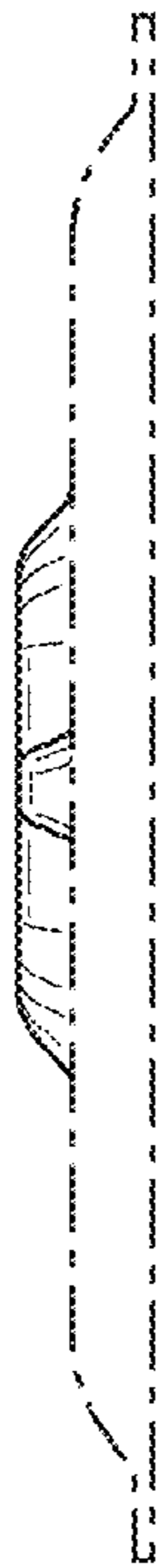

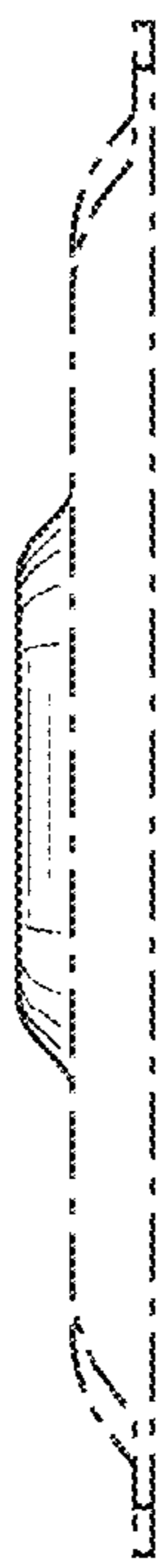

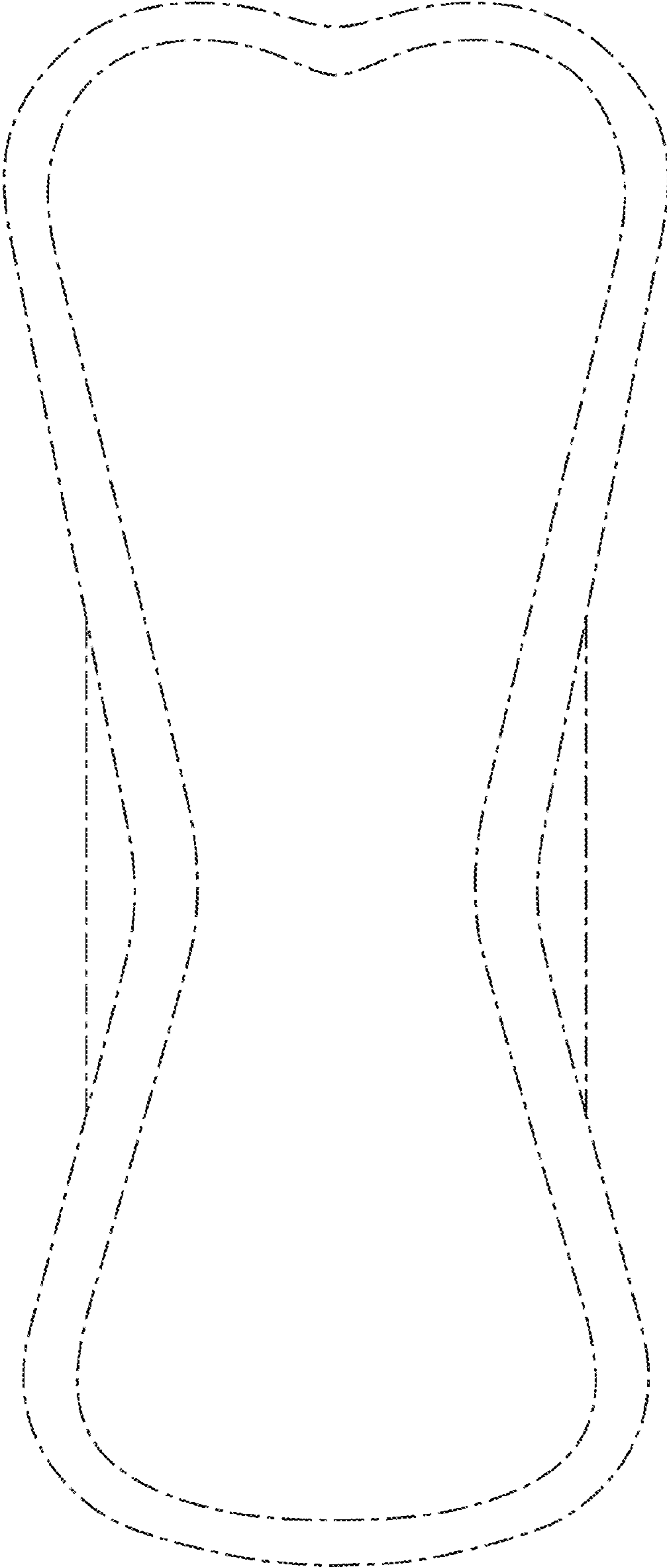
