(57) **CLAIM**

The ornamental design for an anatomical neckband, as shown and described.

DESCRIPTION

FIG. 1 is a front, left isometric view of anatomical neckband being worn by a user.

FIG. 2 is an isometric view of the anatomical neckband;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a right side elevation view thereof;

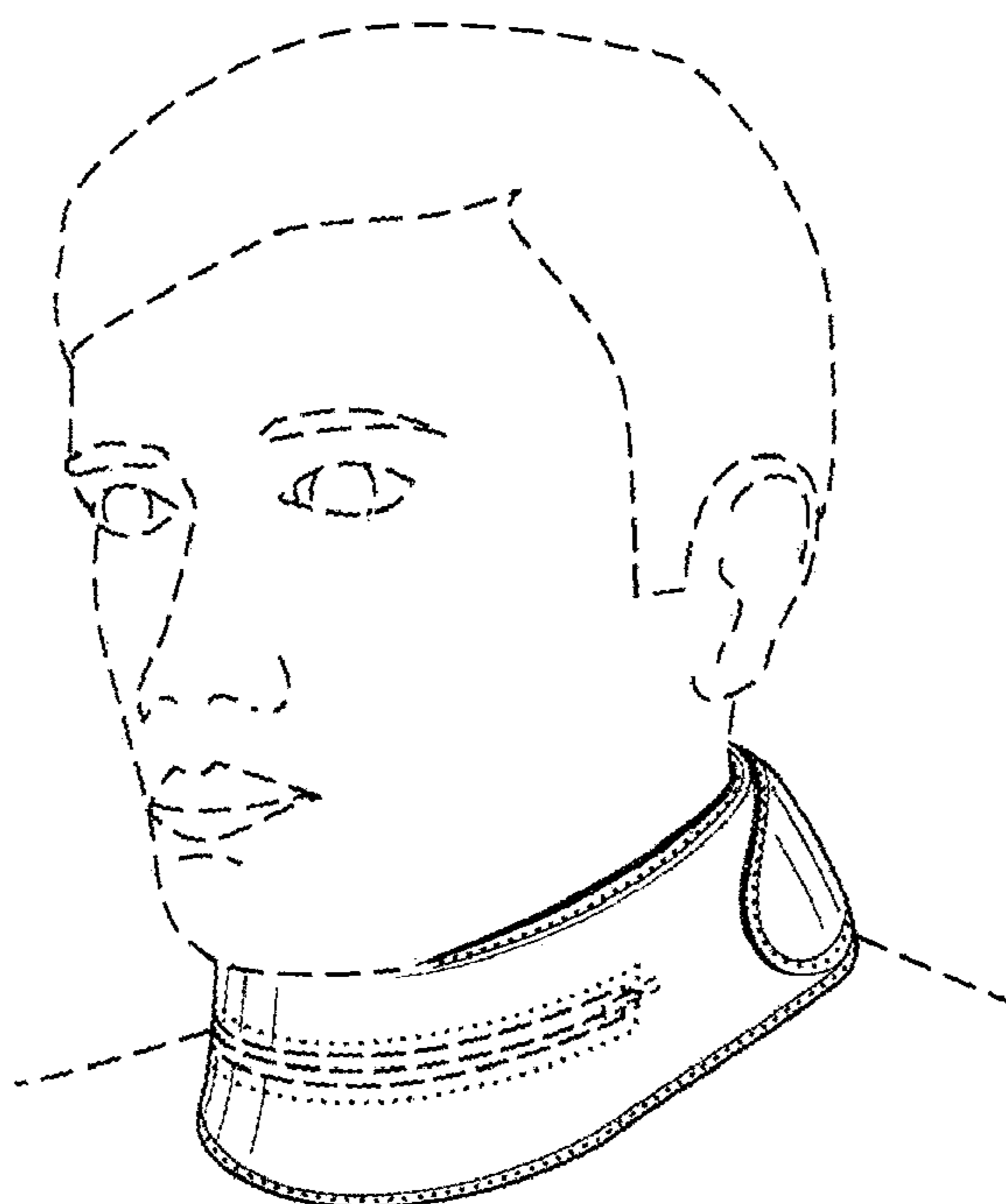
FIG. 6 is a left side elevation view thereof;

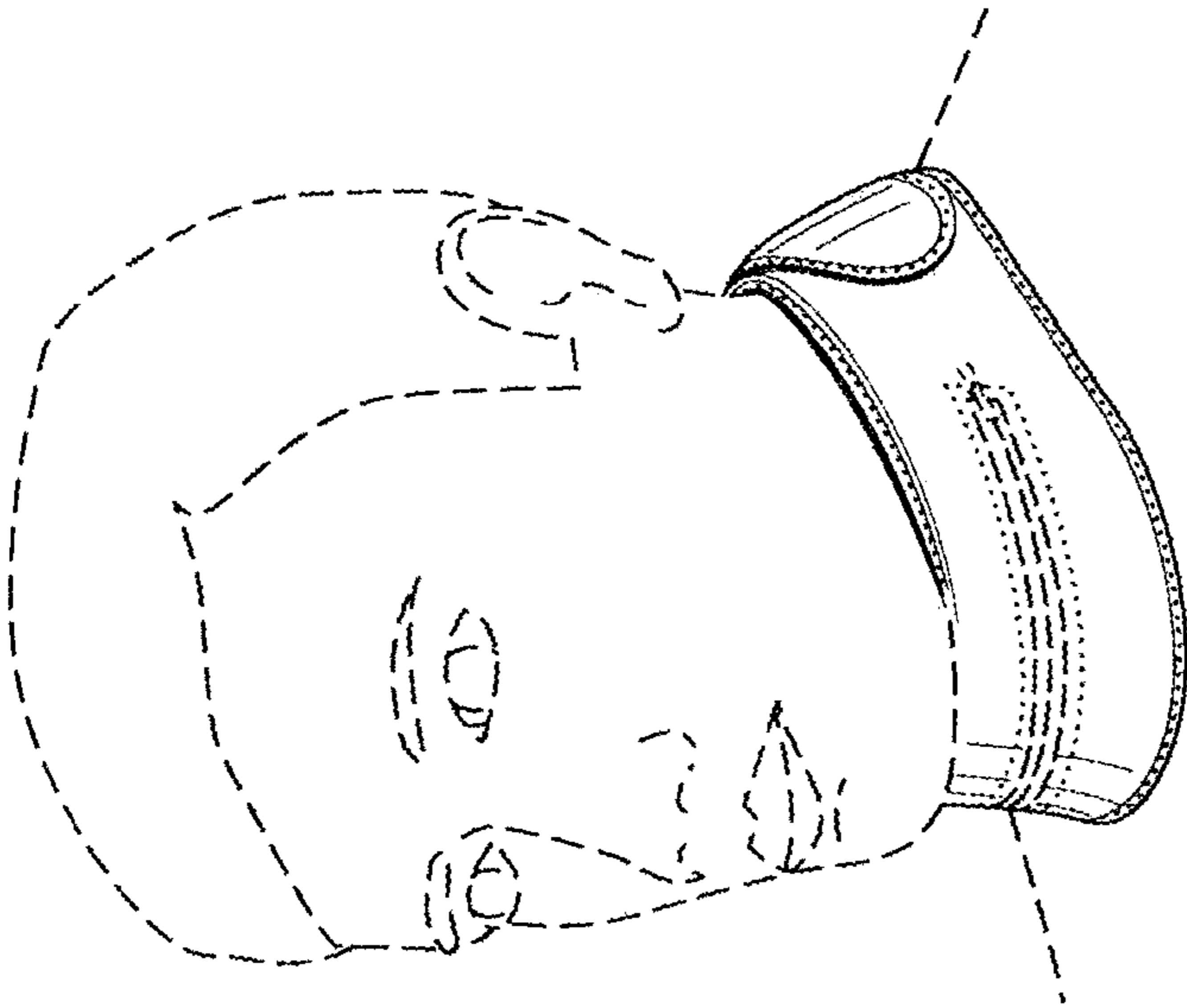

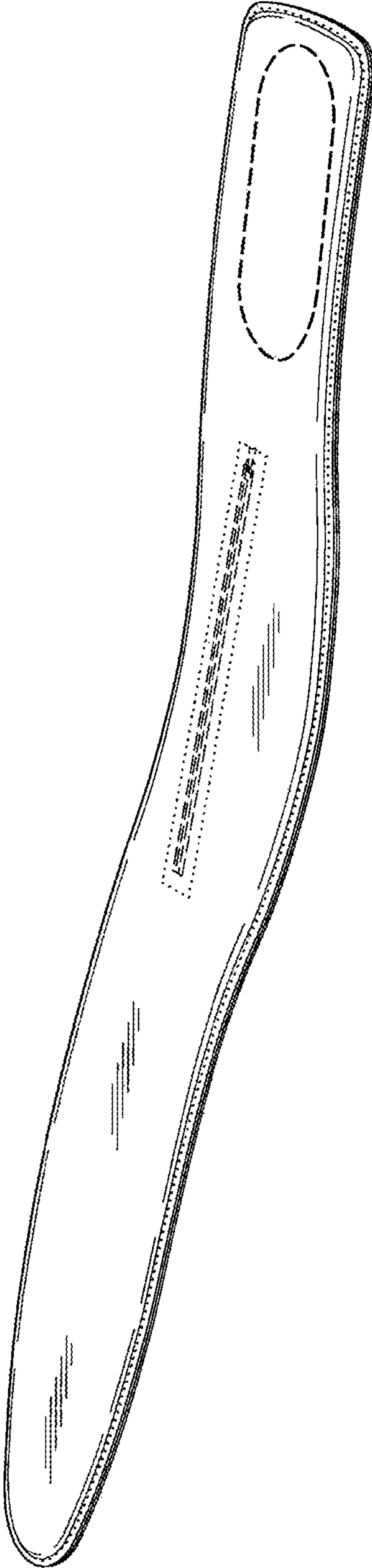

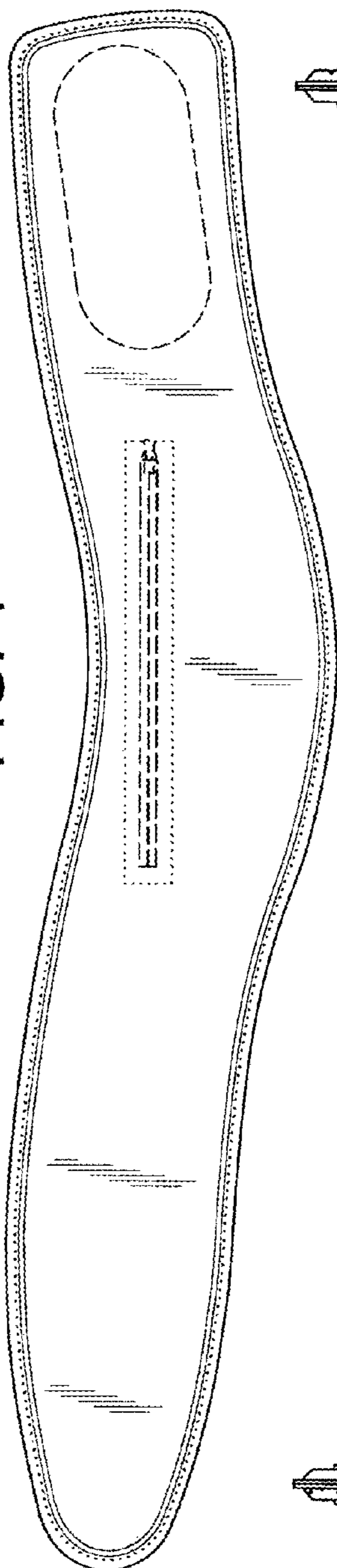

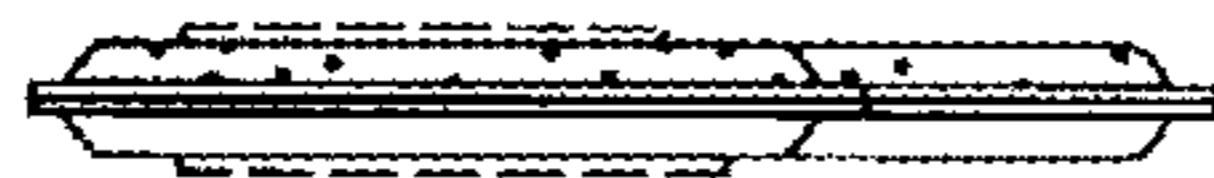

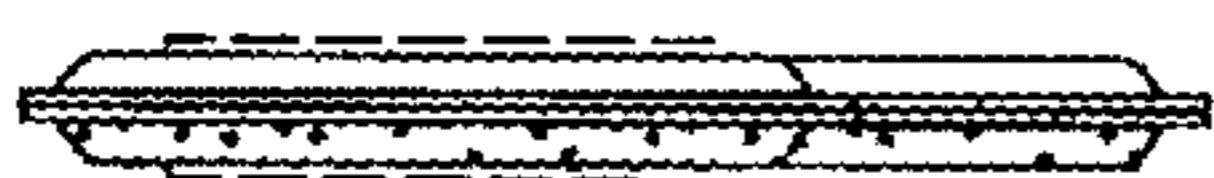

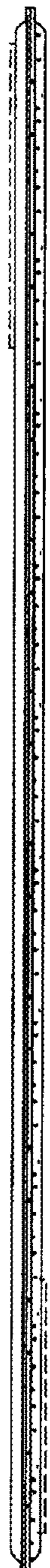

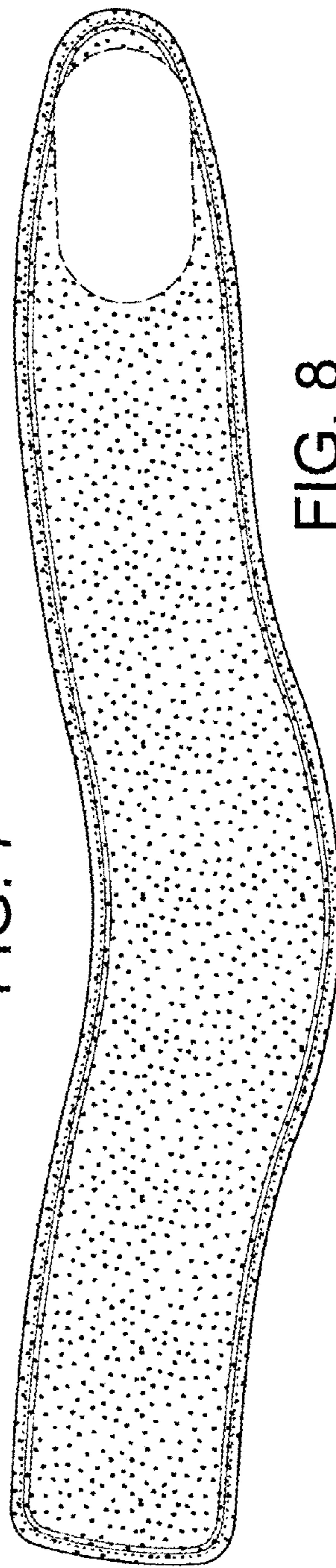
