(57) **CLAIM**

The ornamental design for a canopy light system, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of a canopy light system accord-
ing to the present invention.

FIG. 2 is an enlarged bottom perspective view of the light
fixture of the canopy light system illustrated in FIG. 1, it being
understood that all four fixtures are identical;

FIG. 3 is a top perspective view of the light fixture illustrated
in FIG. 2.

FIG. 4 is bottom plan view of the light fixture illustrated in
FIG. 2.

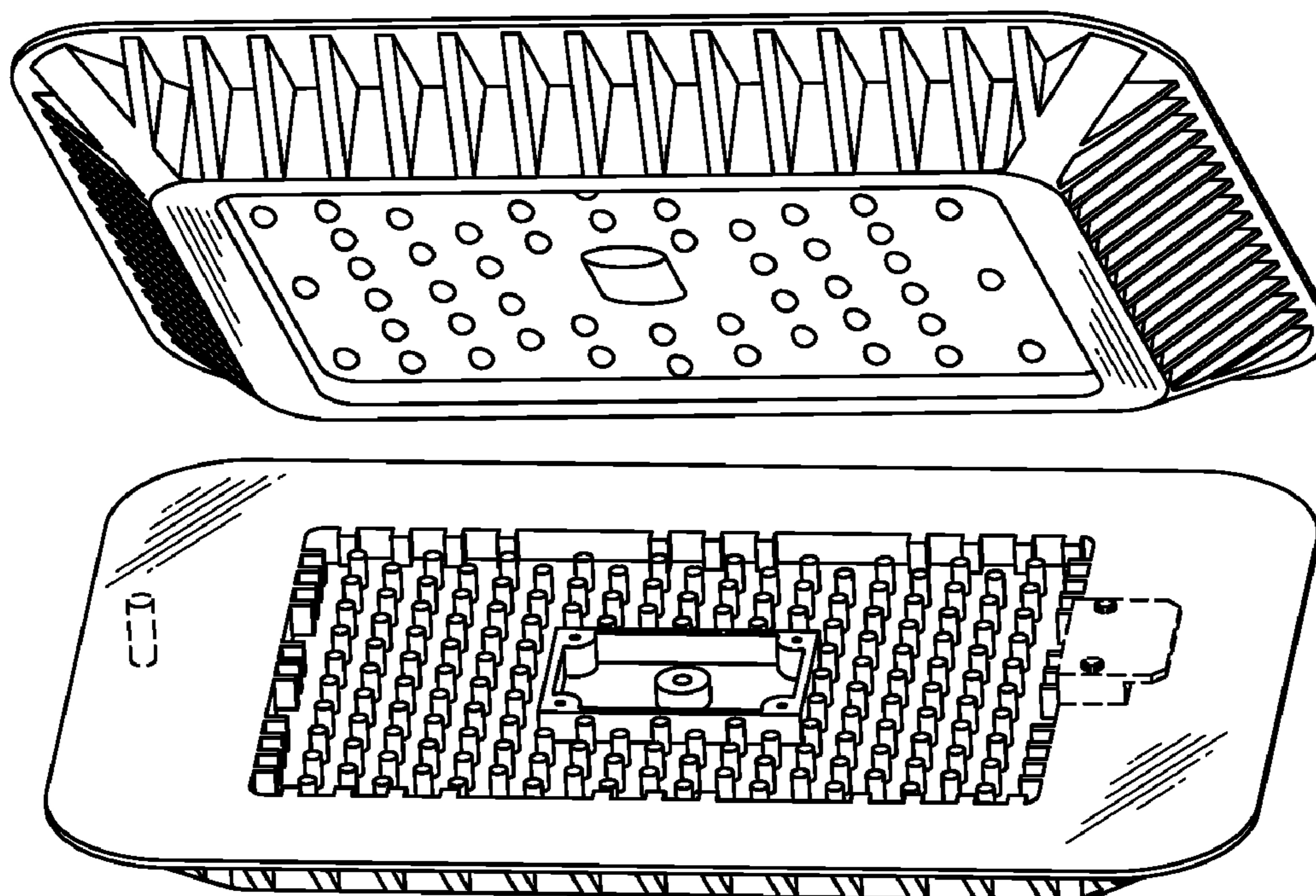
FIG. 5 is a top plan view of the light fixture illustrated in FIG.
2.

FIG. 6 is a side elevation view of the light fixture illustrated in
FIG. 2; and,

FIG. 7 is another side elevation view of the light fixture

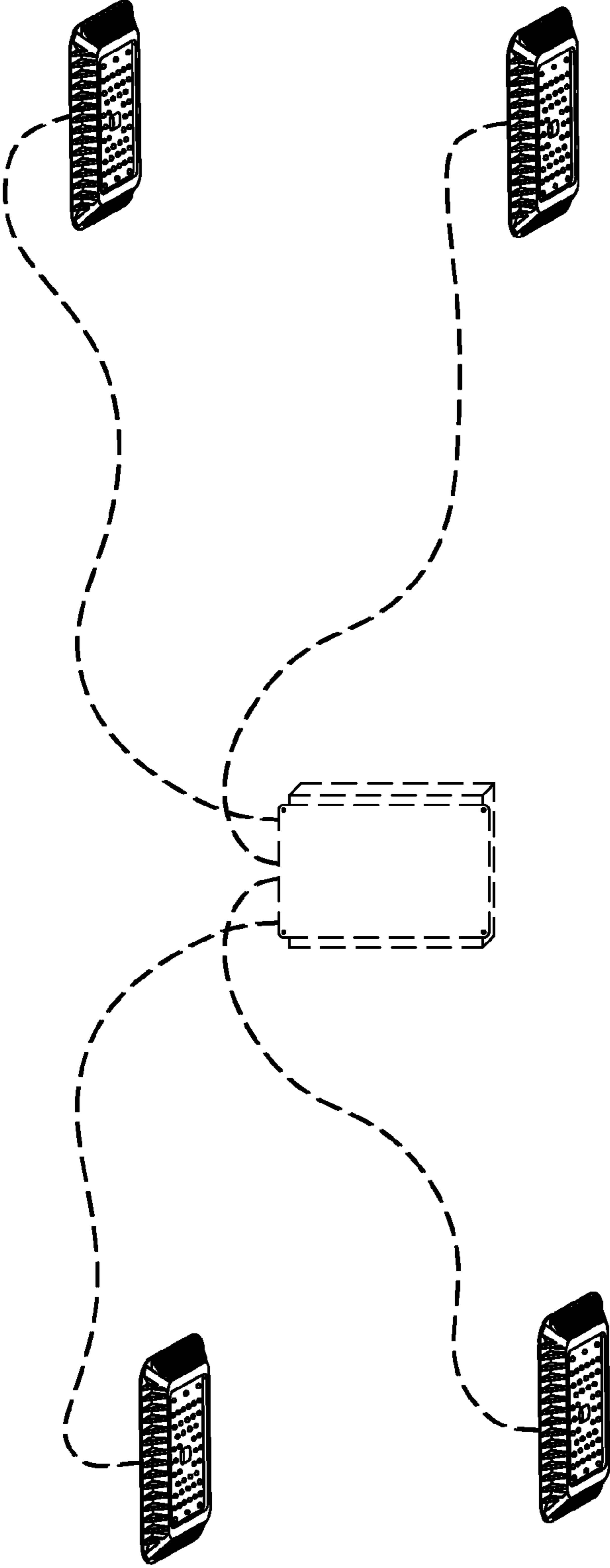

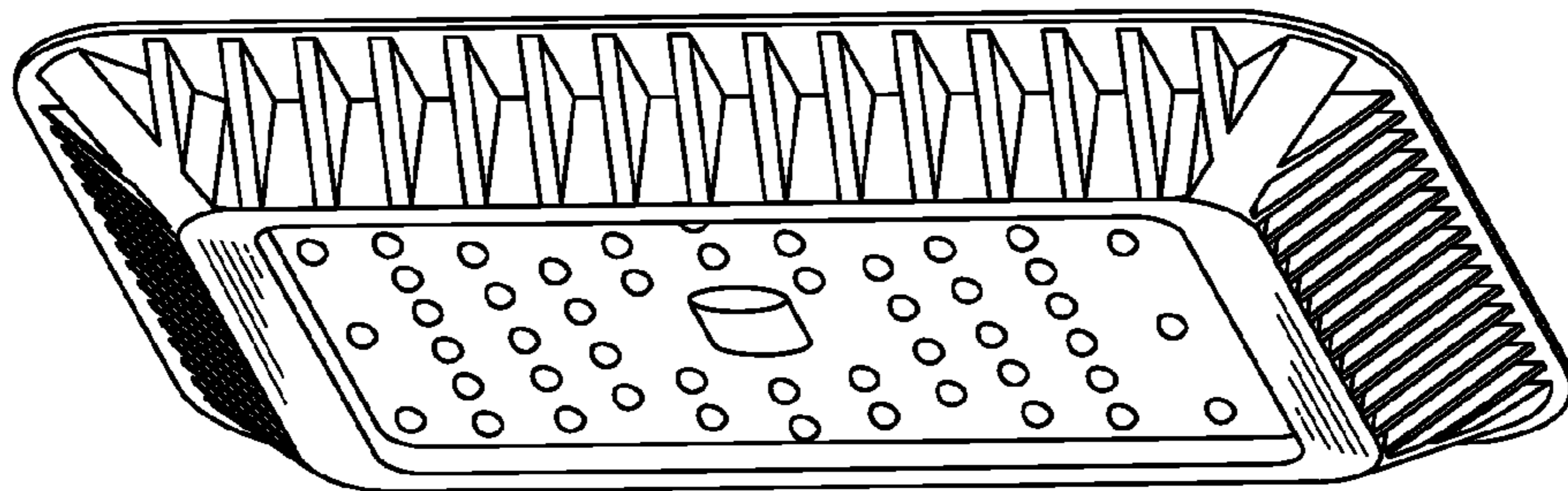

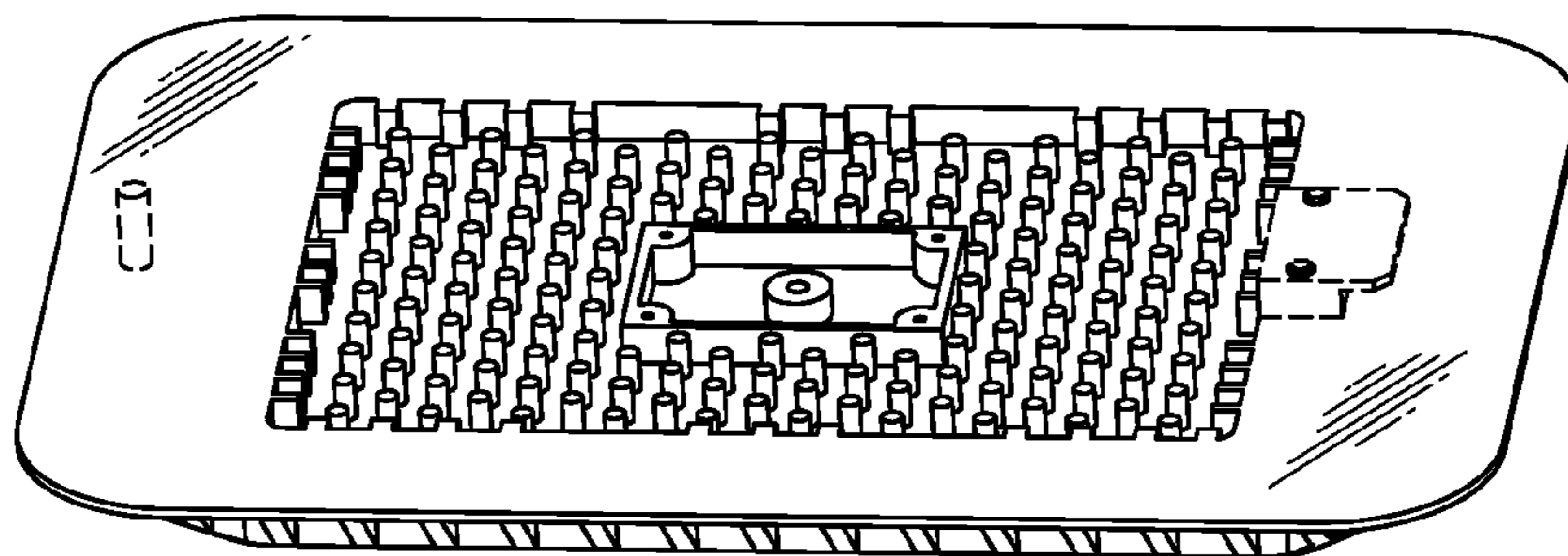

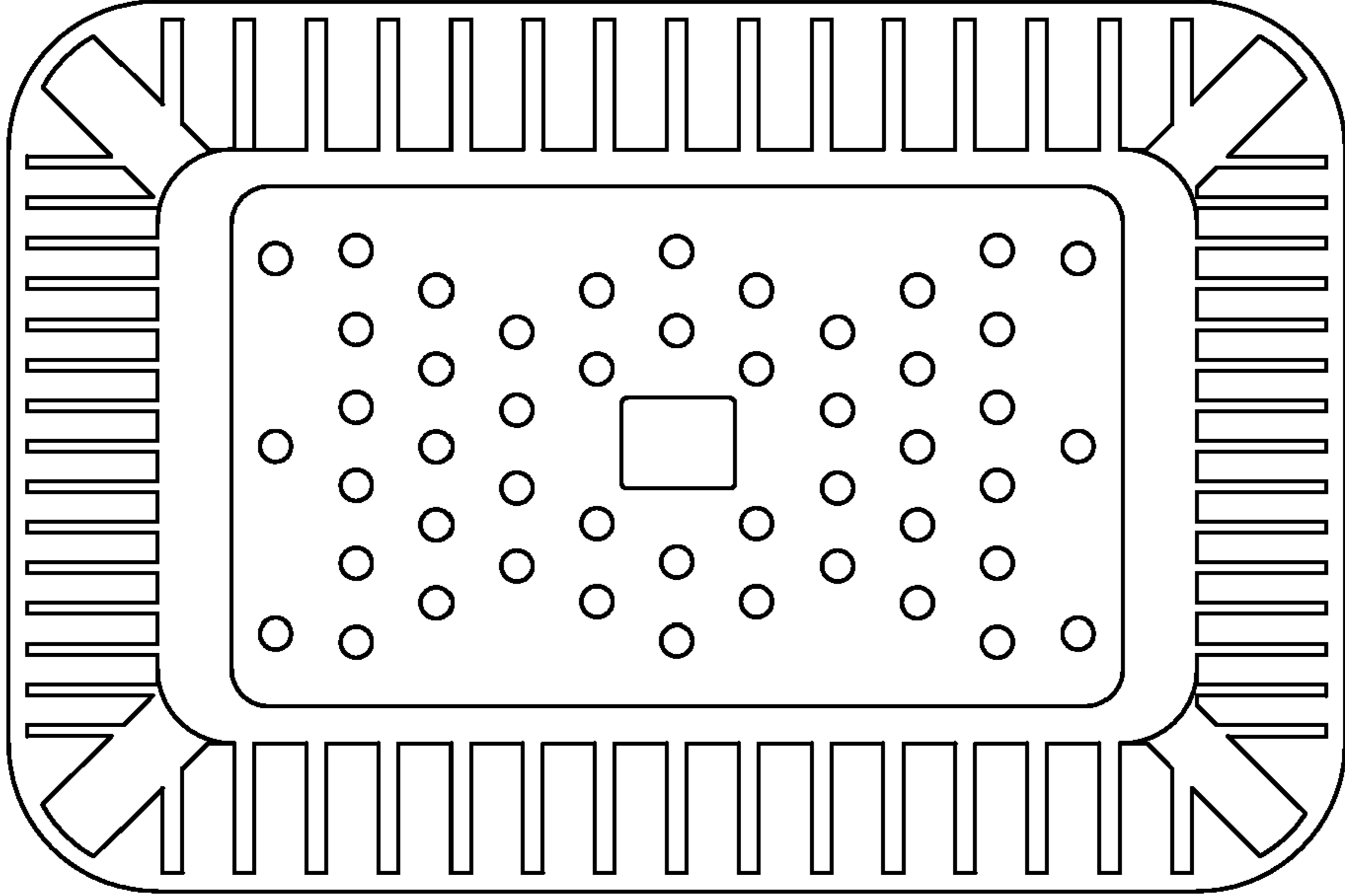

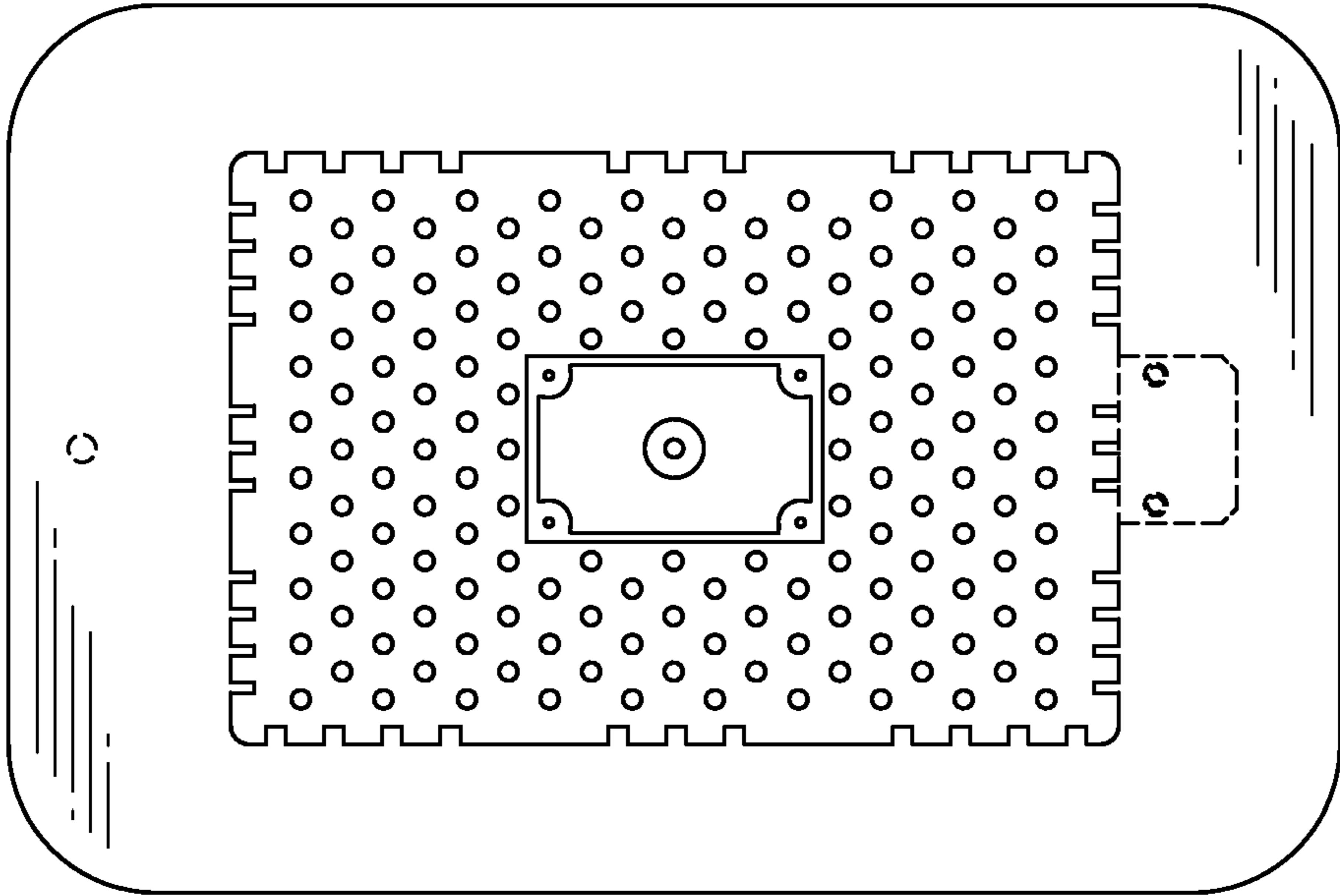

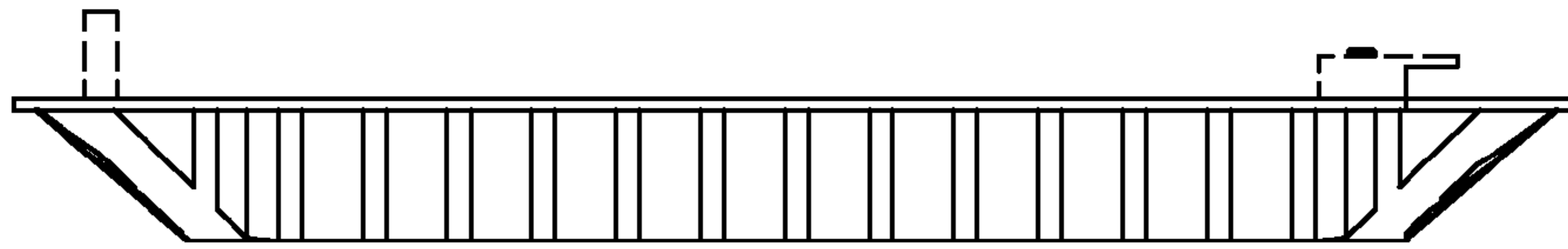

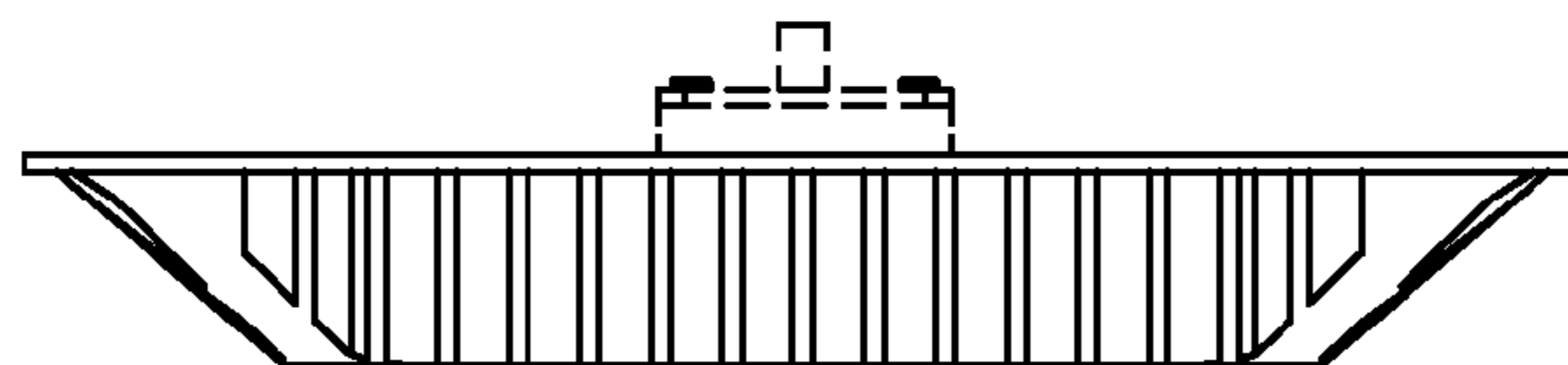
