**DESCRIPTION**

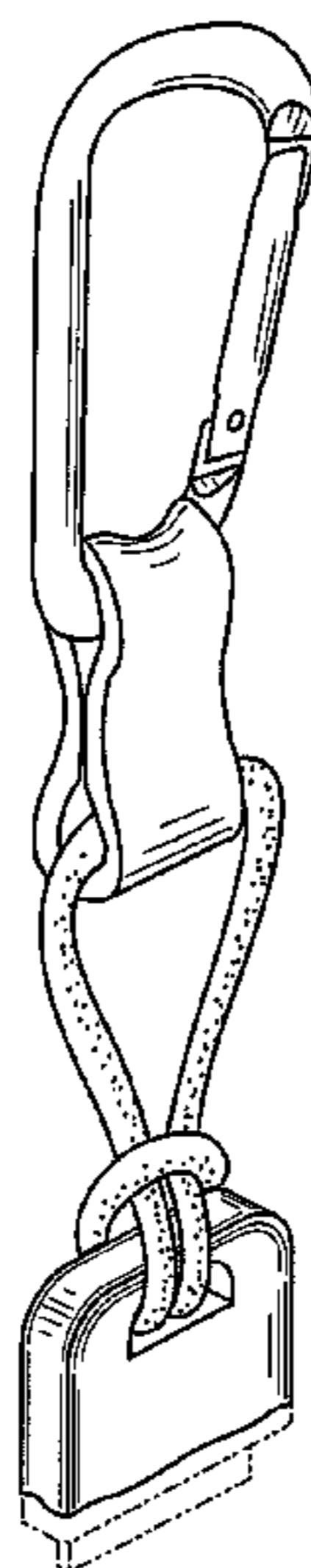
FIG. 1 is a perspective view of an embodiment of a leash showing my new design;

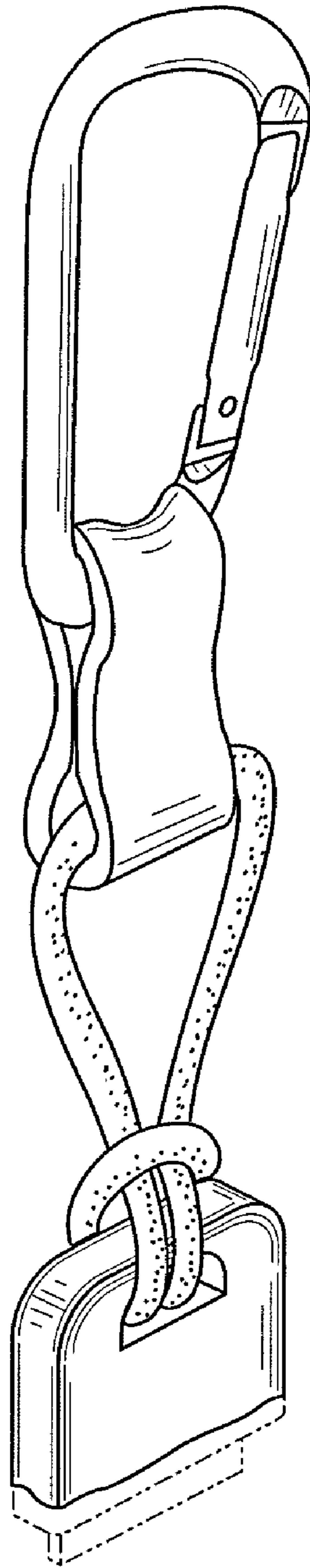

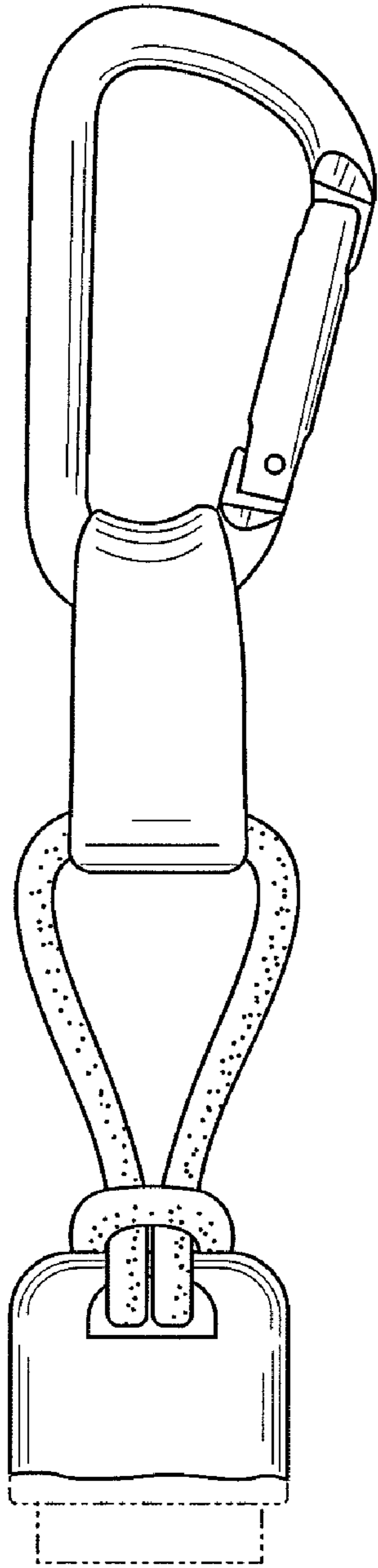

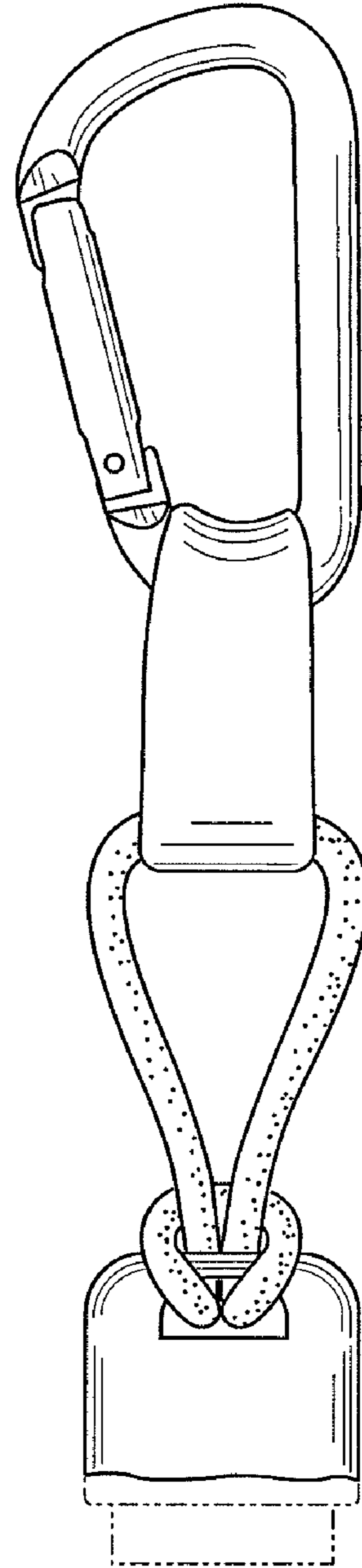

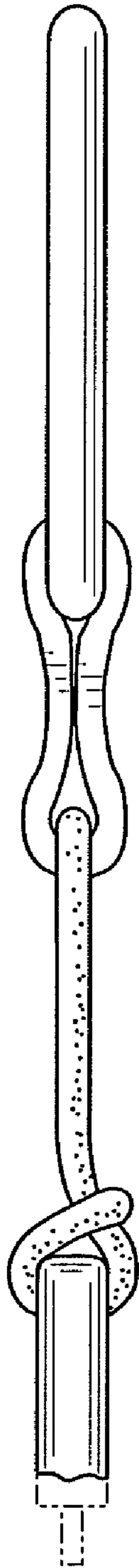

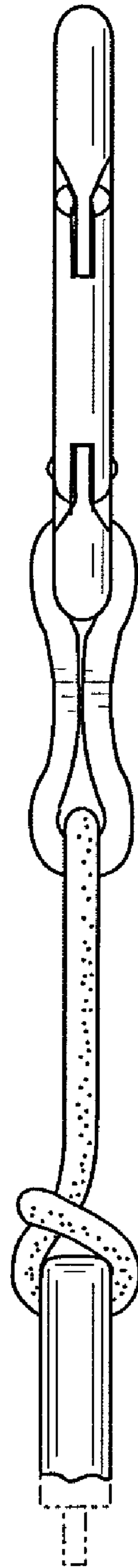
