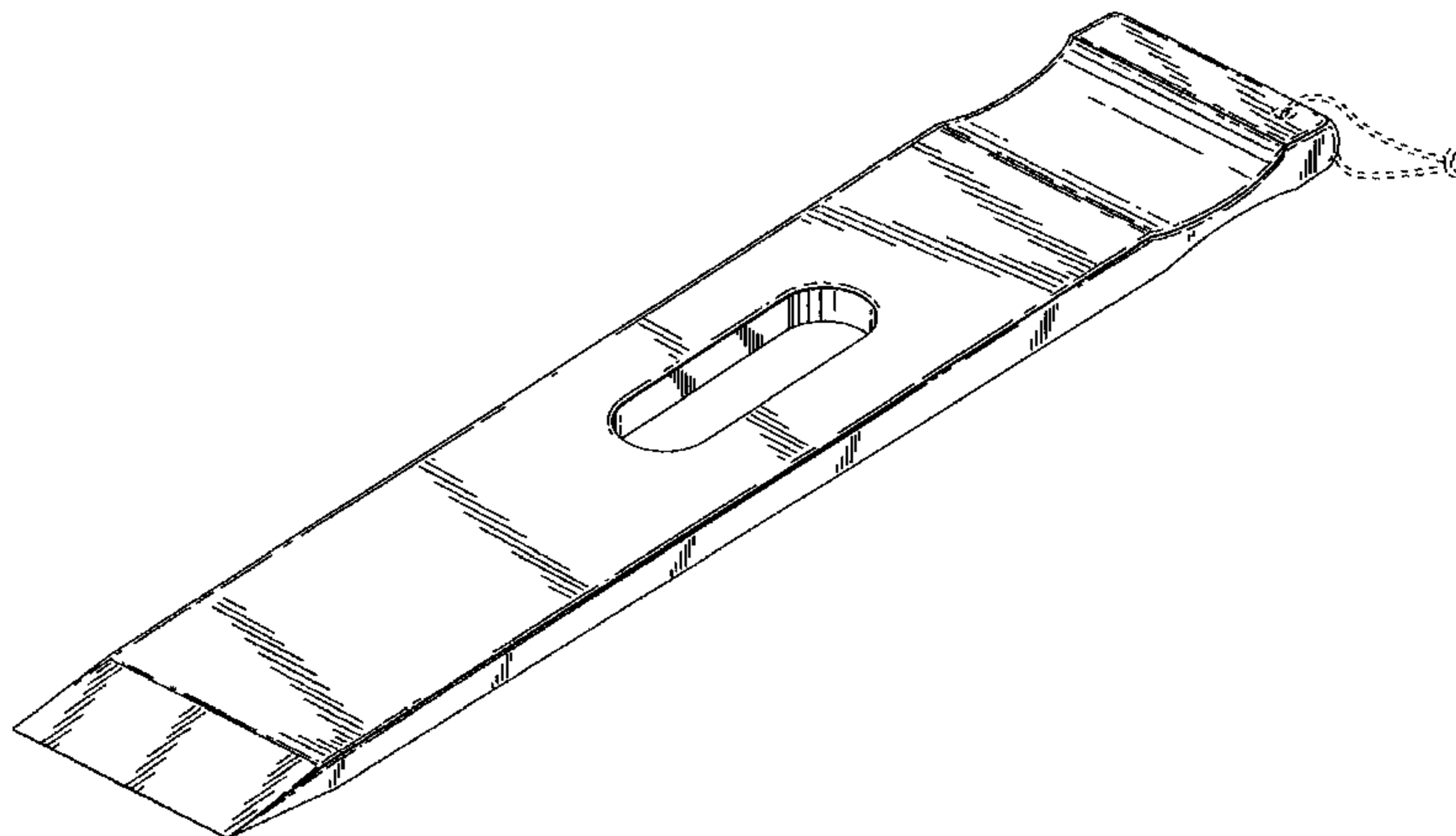
(57) **CLAIM**

We claim the ornamental design for a grill scraper, as shown.

DESCRIPTION

FIG. 1 is a front perspective view of a grill scraper showing our new design;
FIG. 2 is a right-side elevation view thereof;
FIG. 3 is a left-side elevation view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a front elevation view thereof; and,
FIG. 7 is a rear elevation view thereof.
The broken lines in the figures depict a hole and lanyard that form no part of the claimed design.

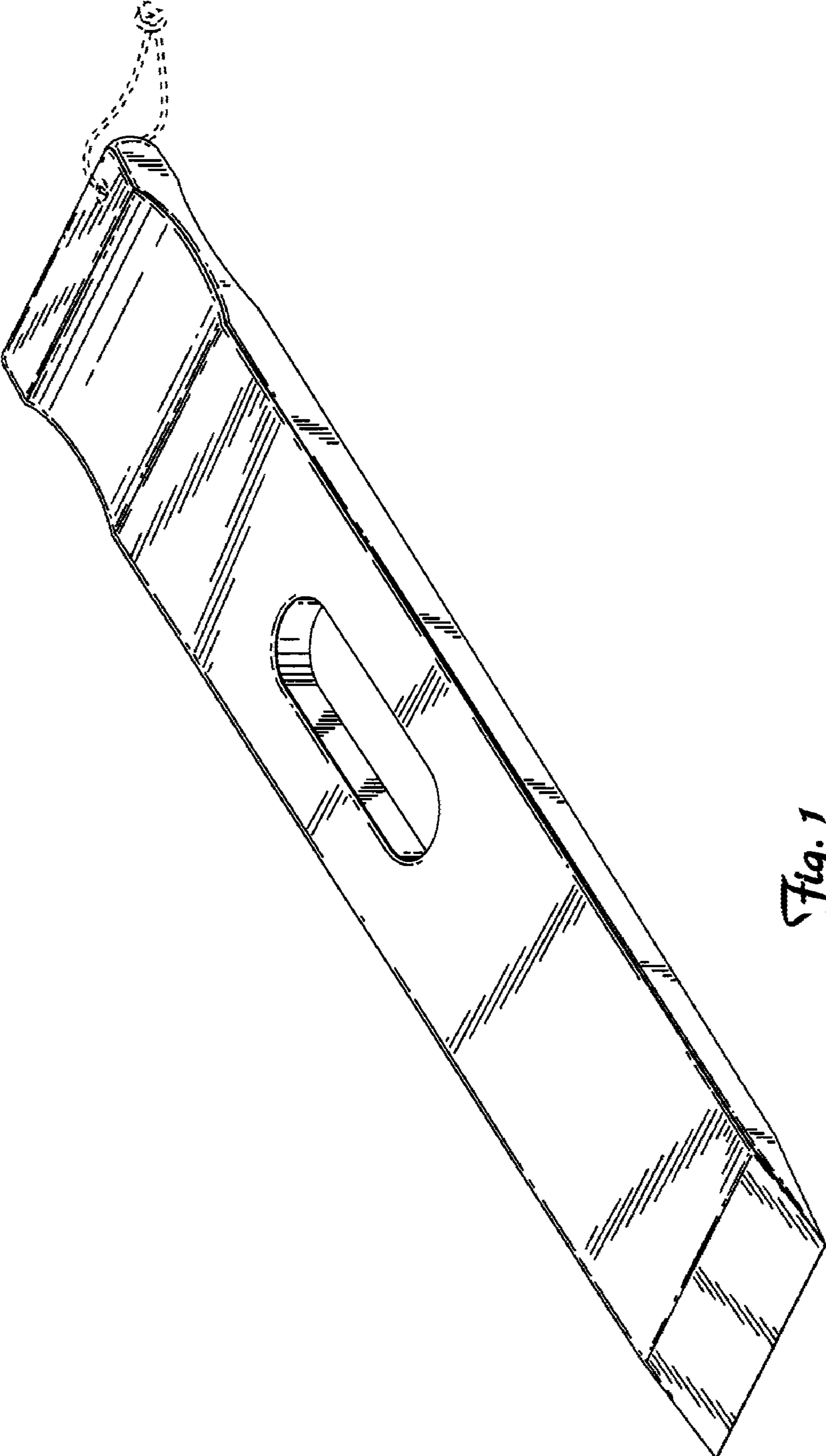

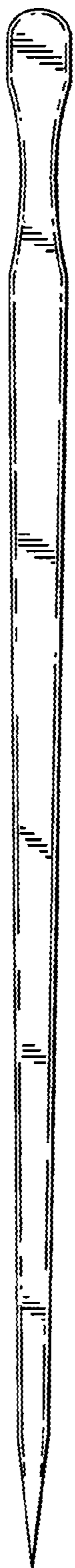

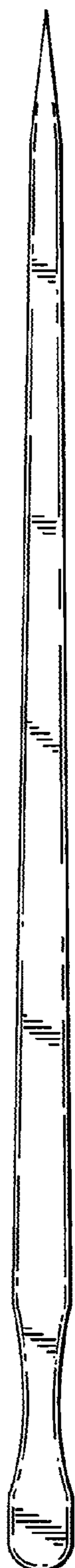

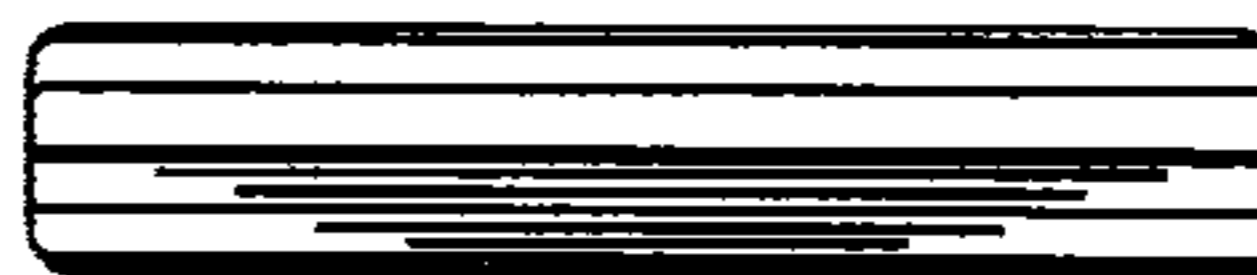

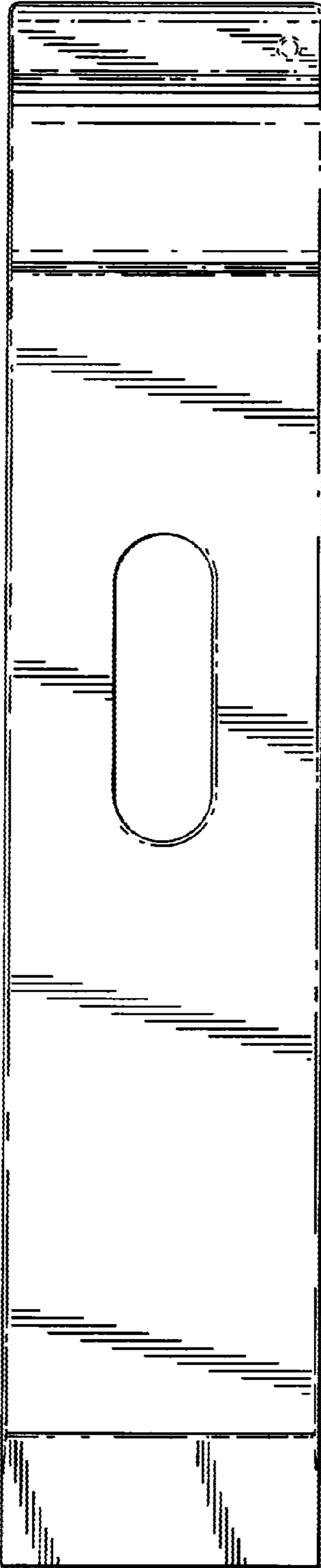

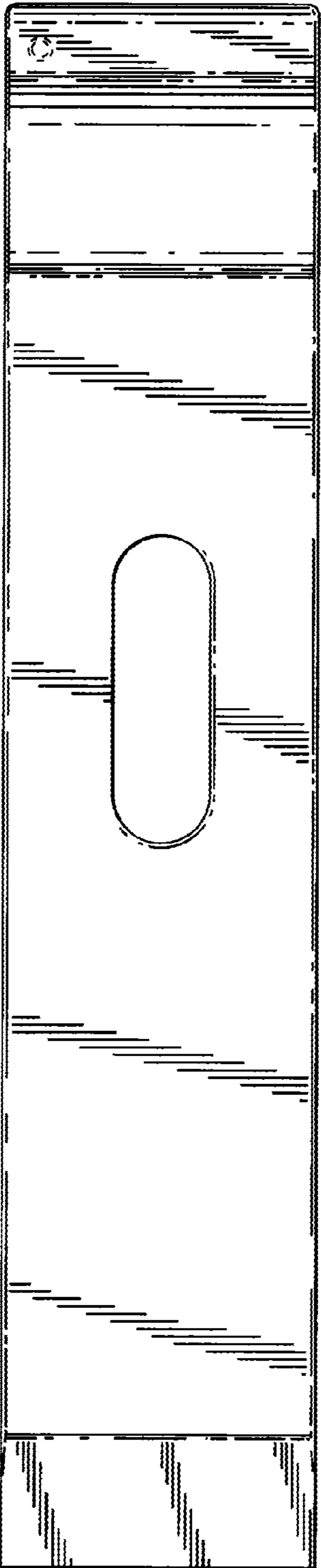
