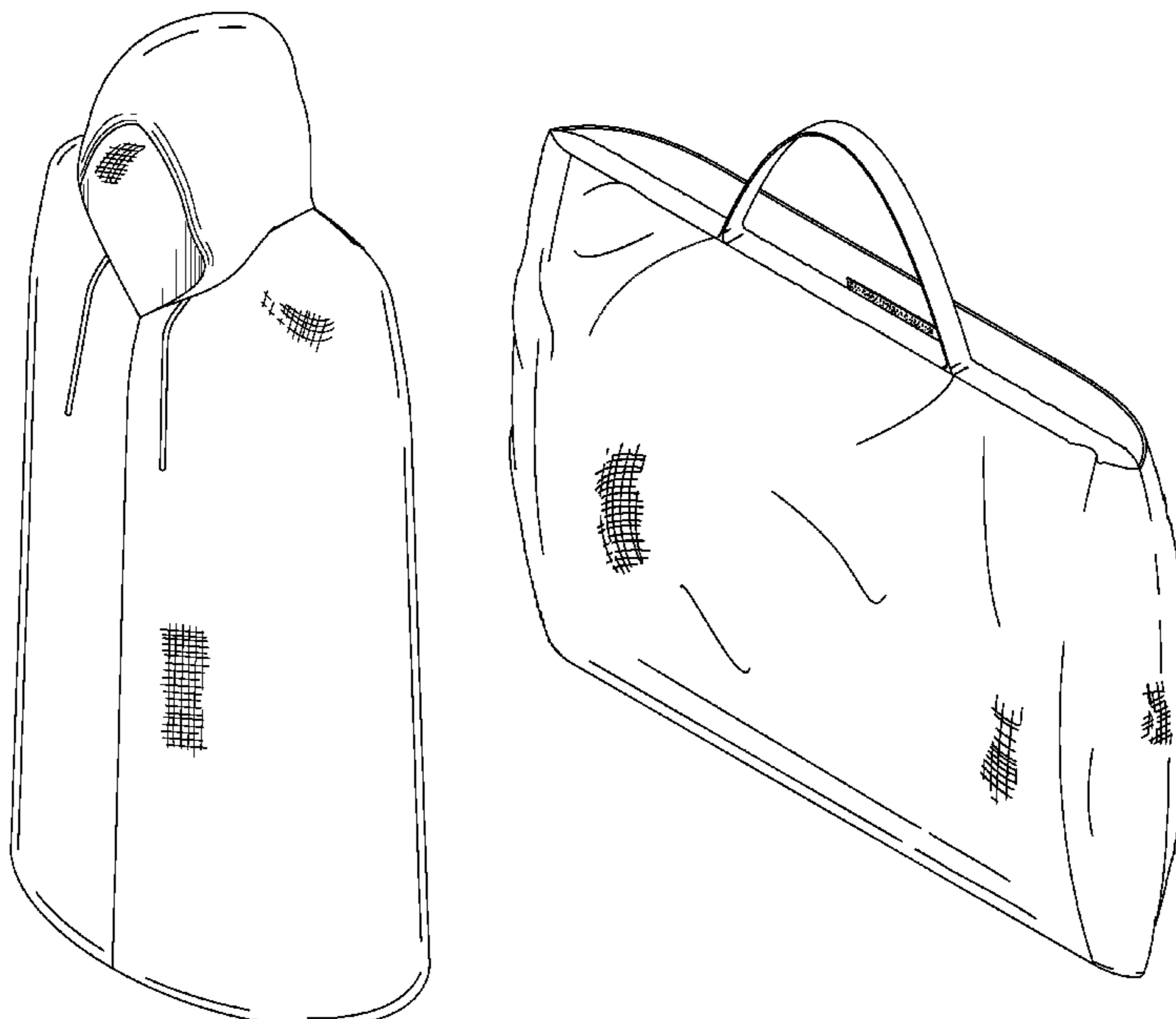
(57) **CLAIM**

The ornamental design for a convertible cushion and hooded body wrap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a convertible cushion and hooded body wrap;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a right-side elevational view thereof;
 FIG. 5 is a left-side elevational view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a top plan view thereof;
 FIG. 8 is an open view thereof showing the inside pockets;
 FIG. 9 is a perspective view of the convertible cushion and hooded body wrap folded into its self-contained pouch with the handle showing; and,
 FIG. 10 is a front view of the convertible cushion and hooded body wrap folded into its self-contained pouch with the handle showing.

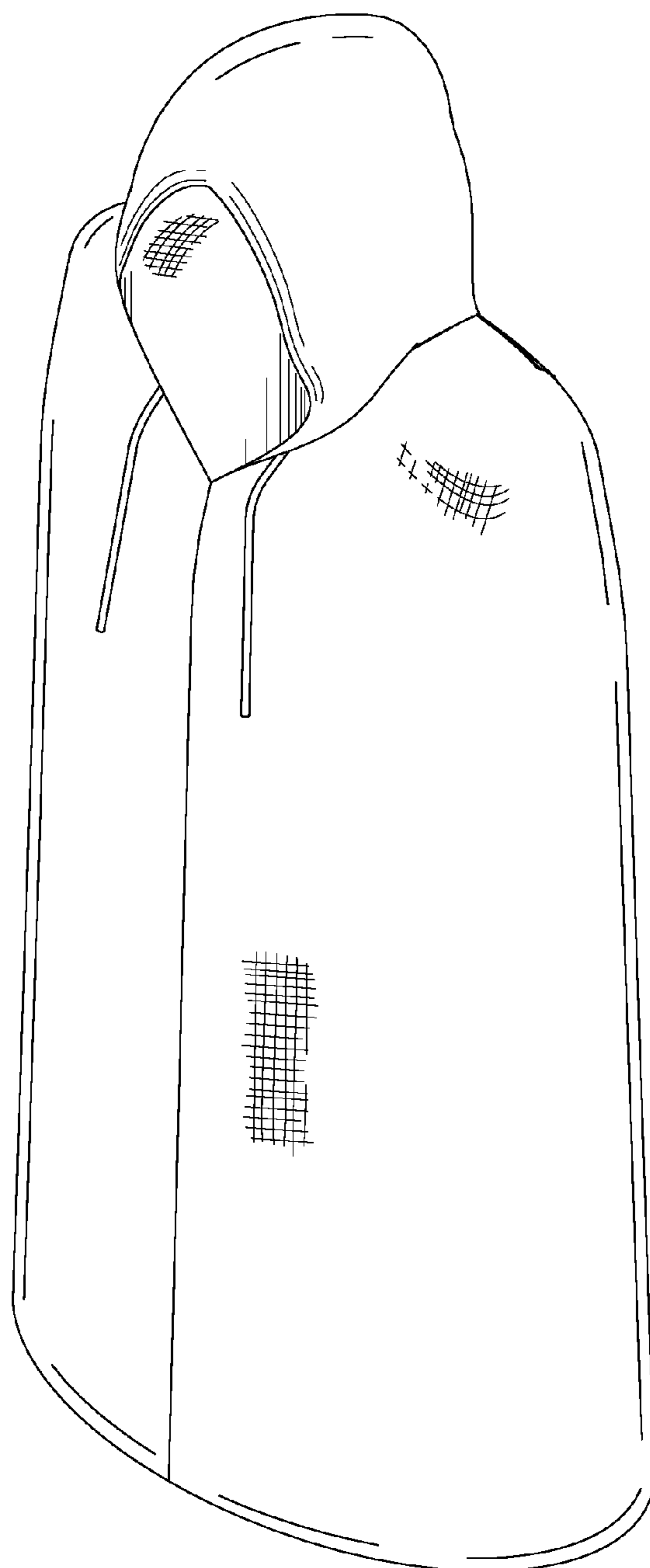

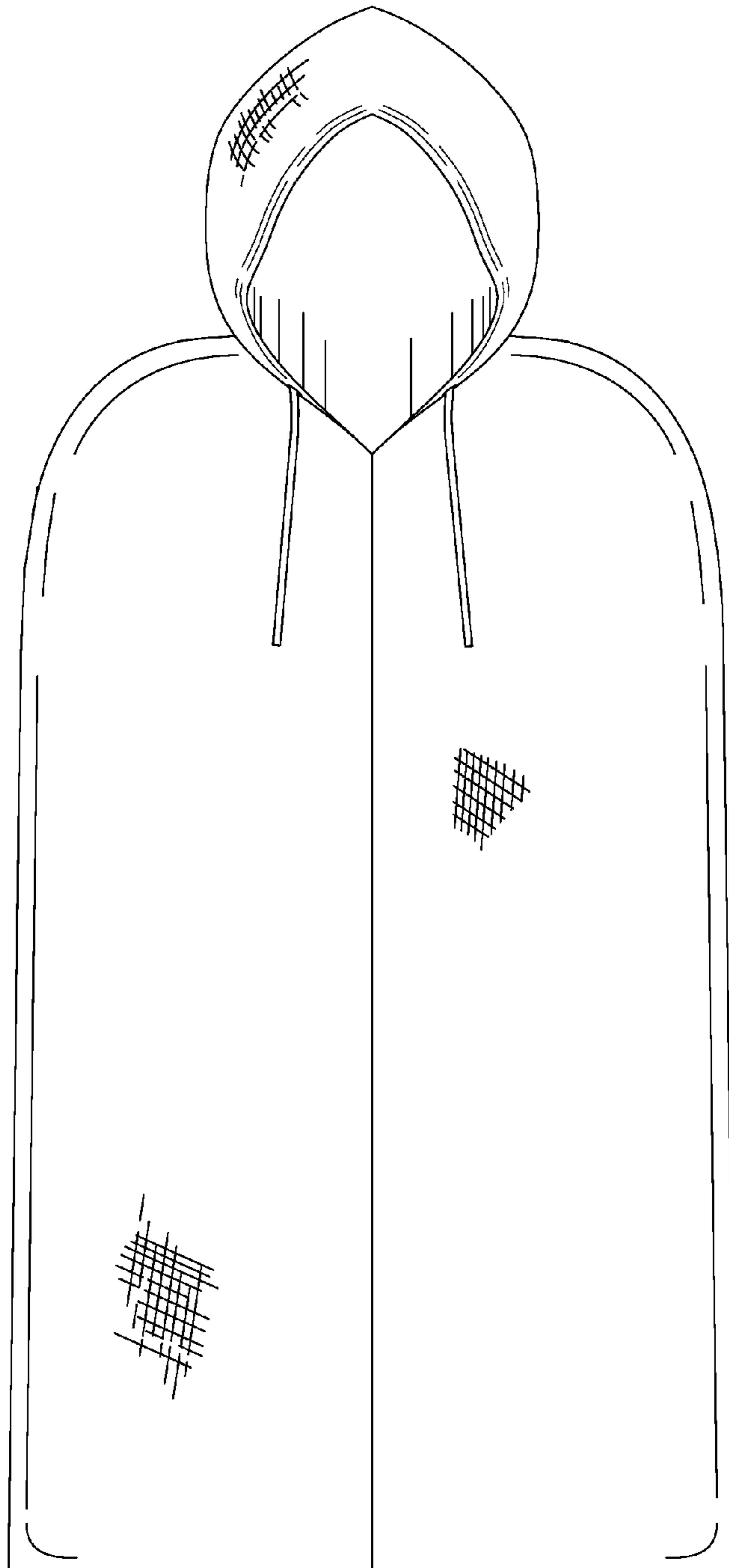

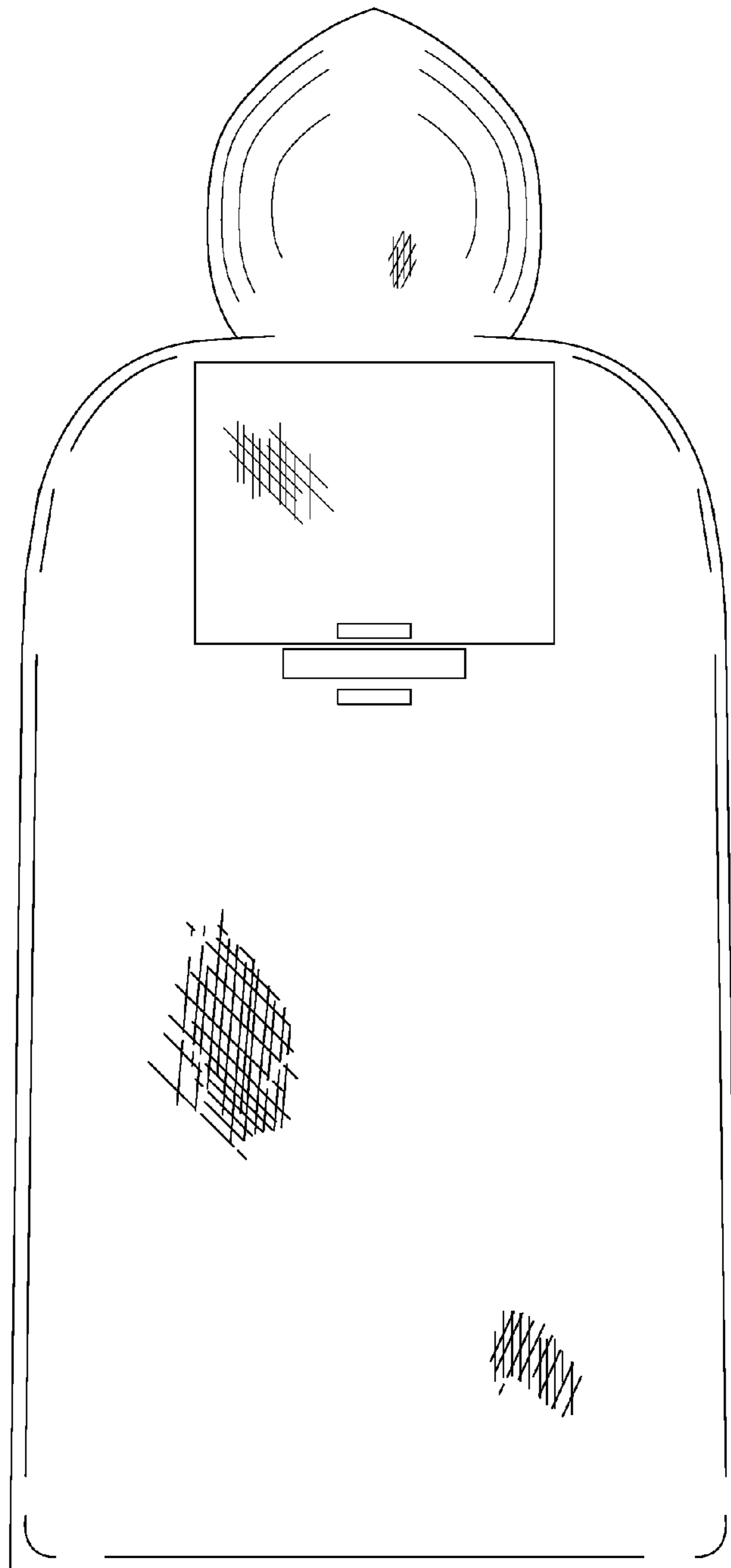

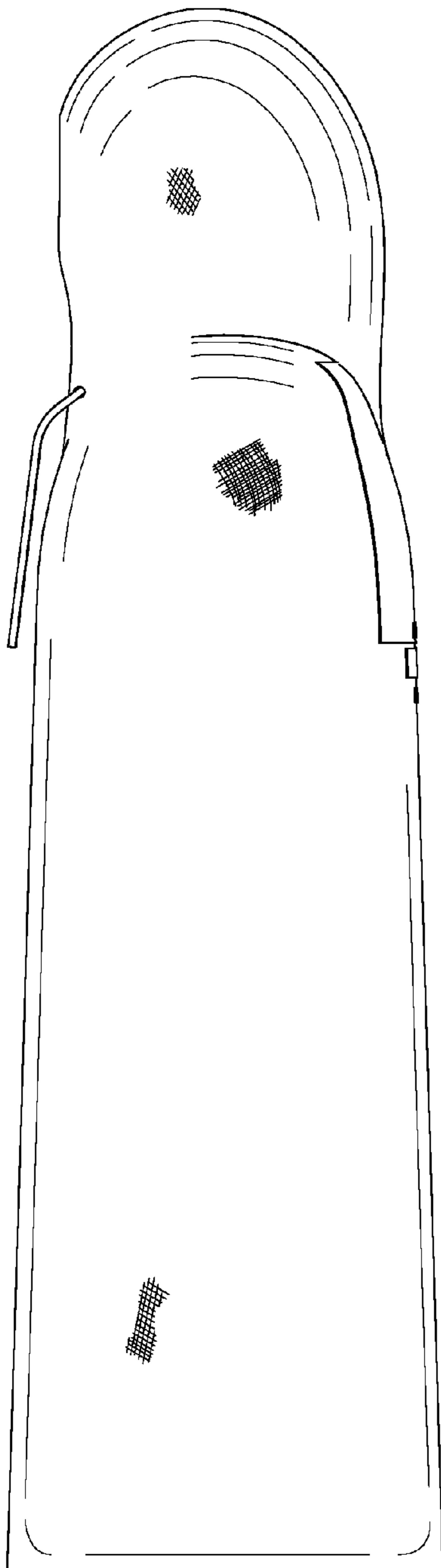

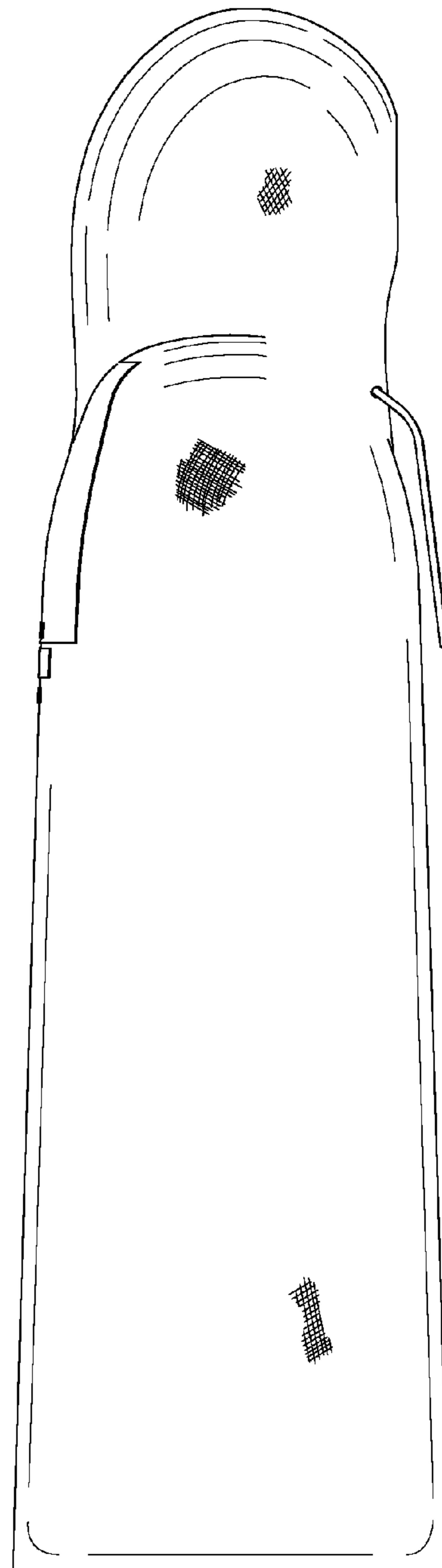

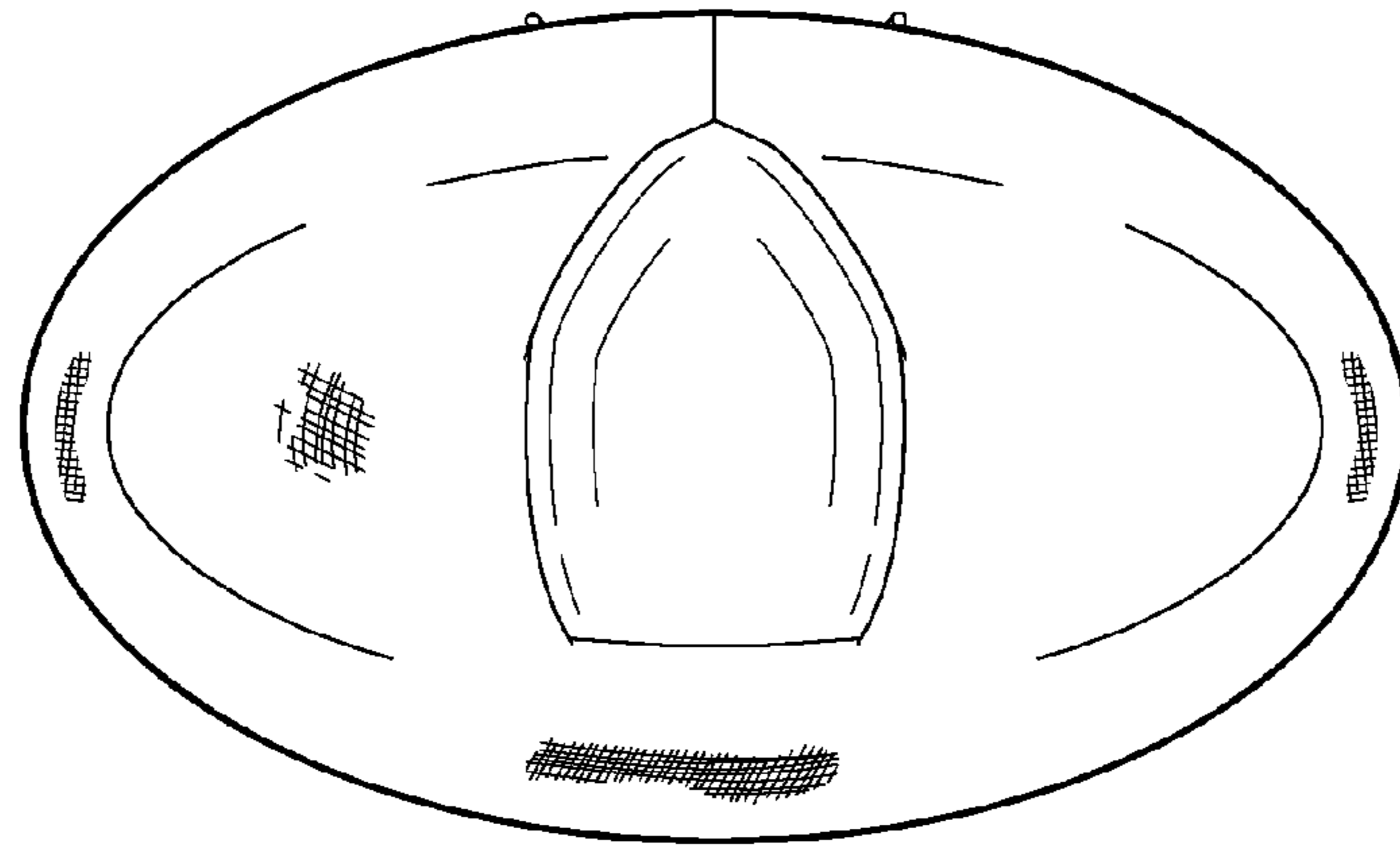

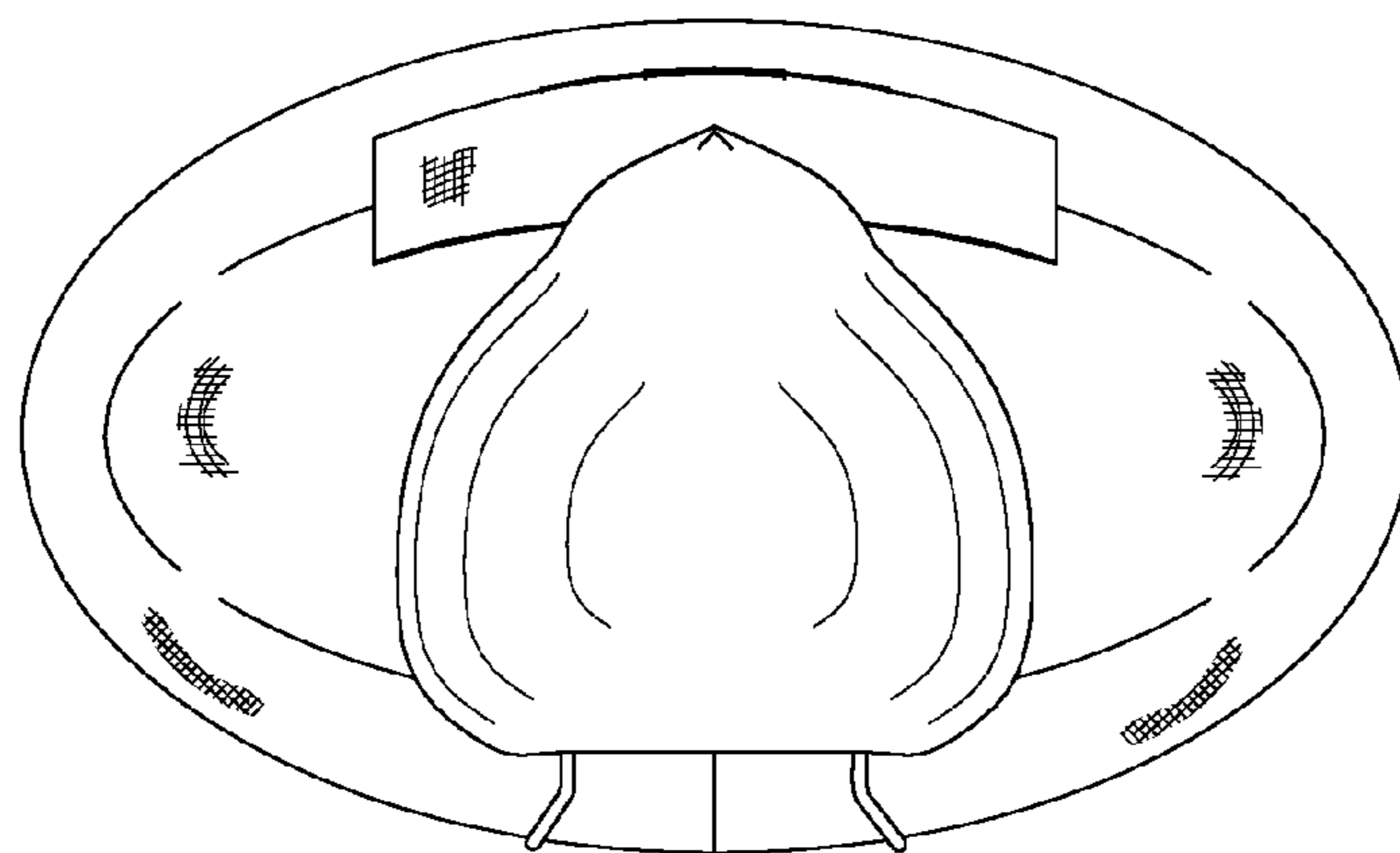

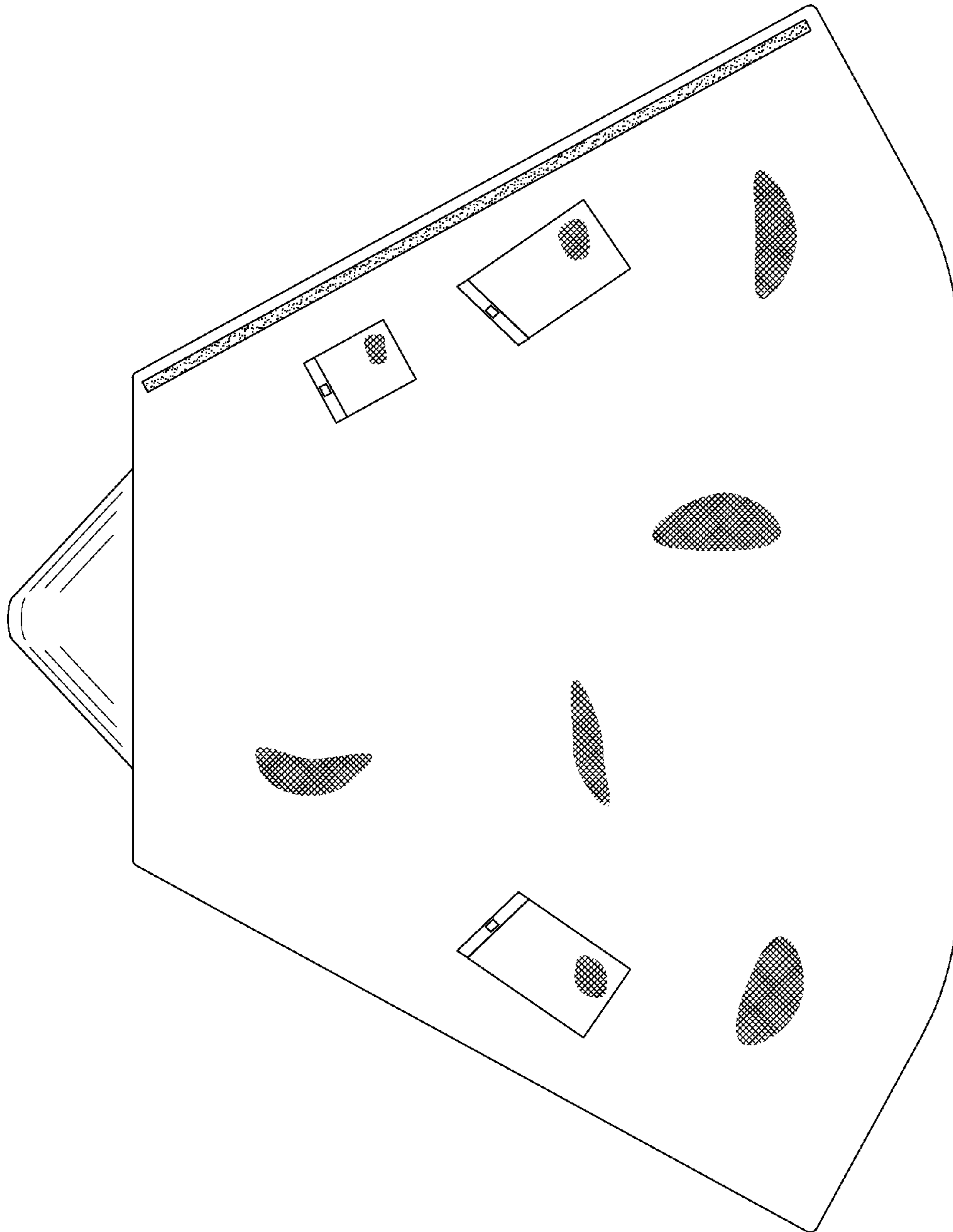

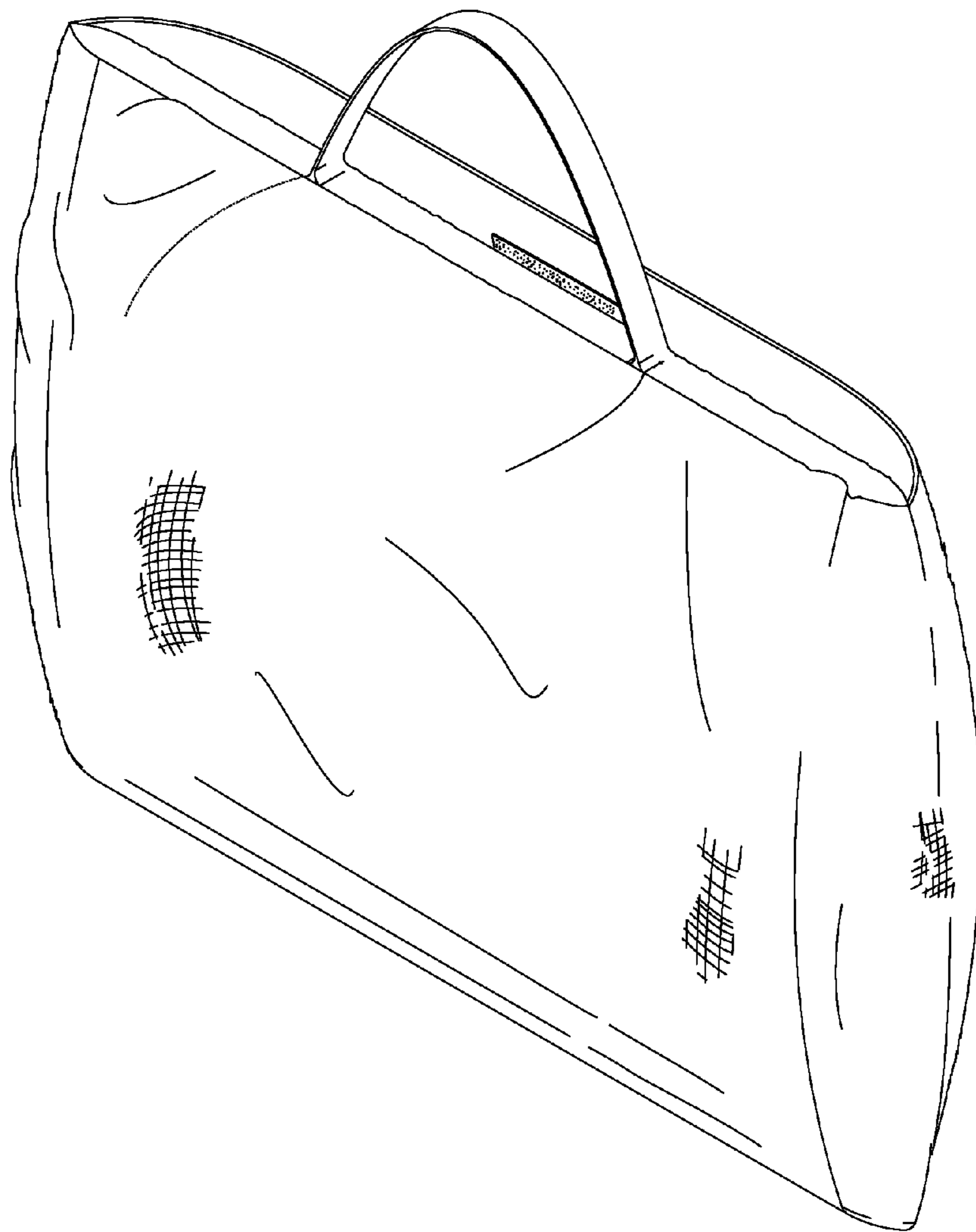

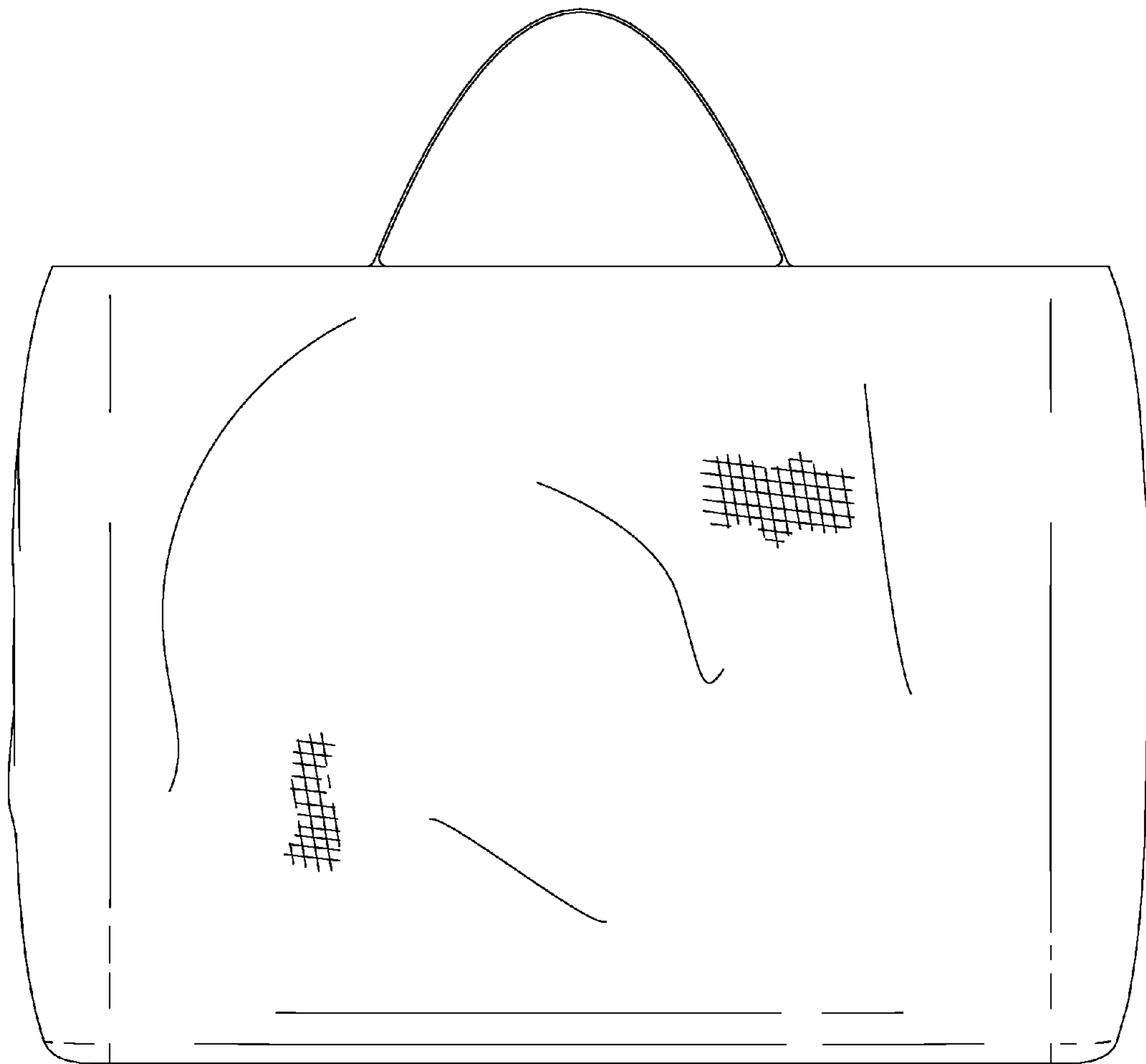
