The ornamental design for an article of footwear, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of an article of footwear, showing the claimed design;

FIG. 2 is an outer side view of the article of footwear shown in FIG. 1;

FIG. 3 is an inner side view of the article of footwear shown in FIG. 1;

FIG. 4 is a top view of the article of footwear shown in FIG. 1;

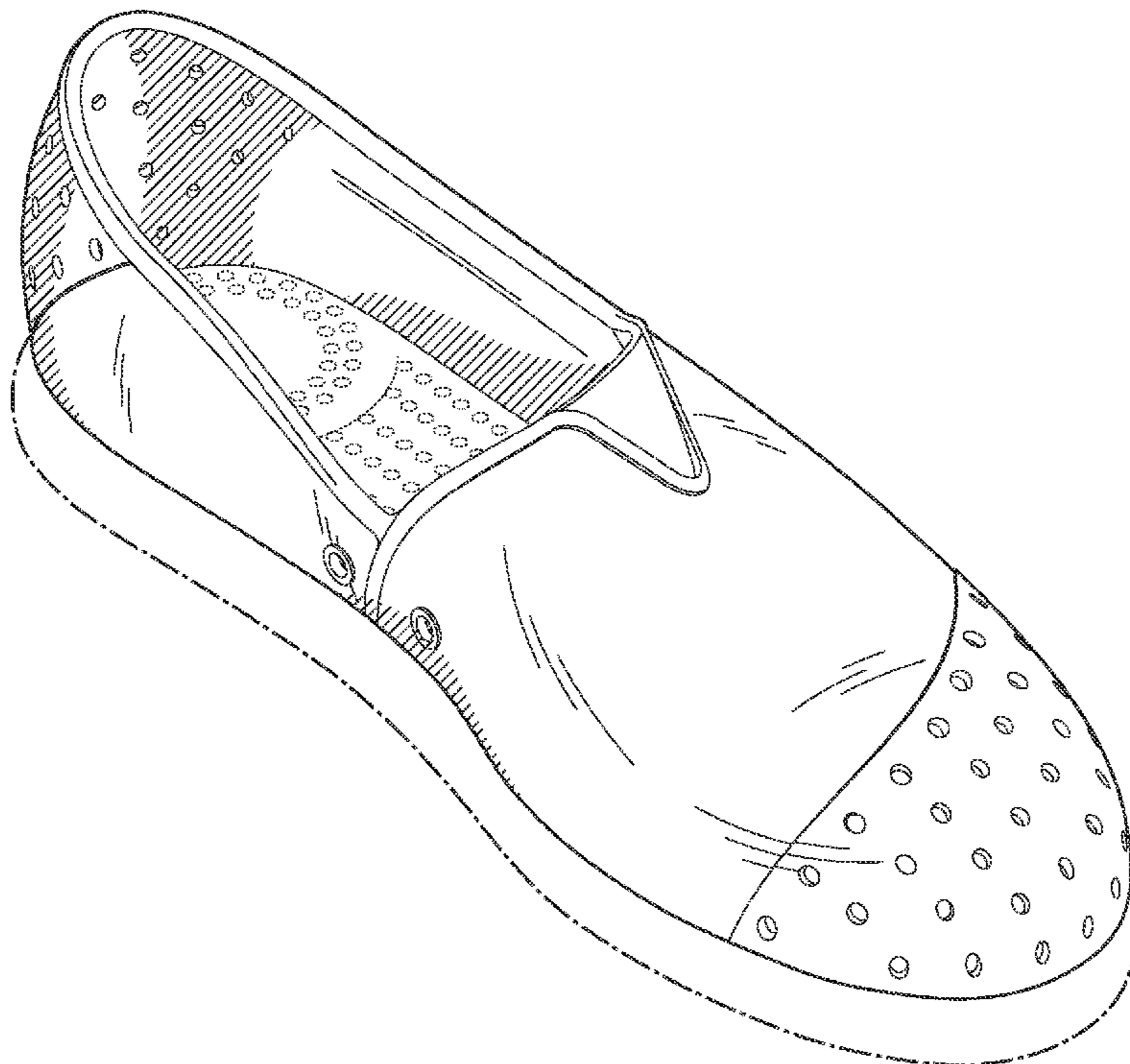
FIG. 5 is a rear view of the article of footwear shown in FIG. 1;

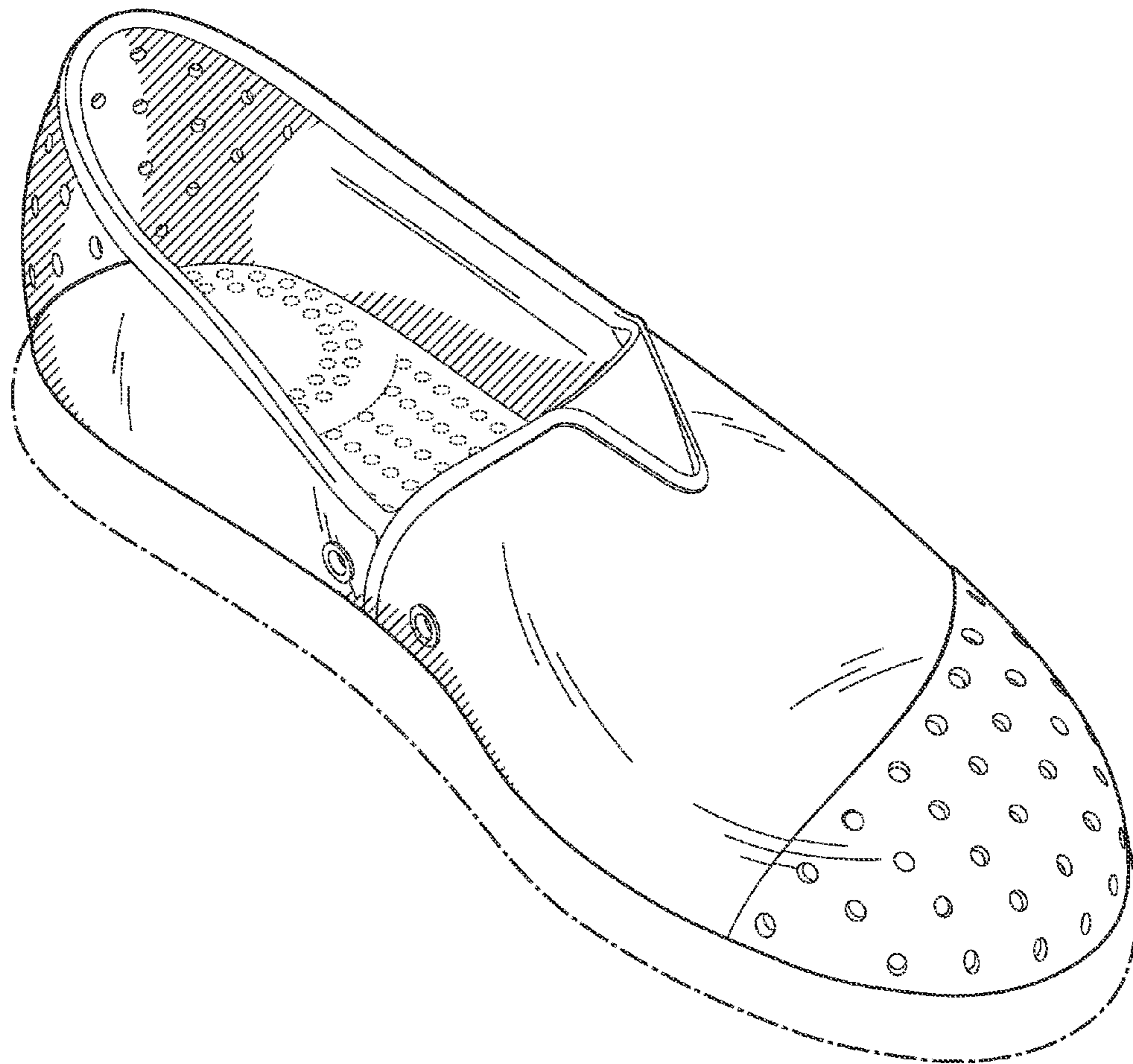

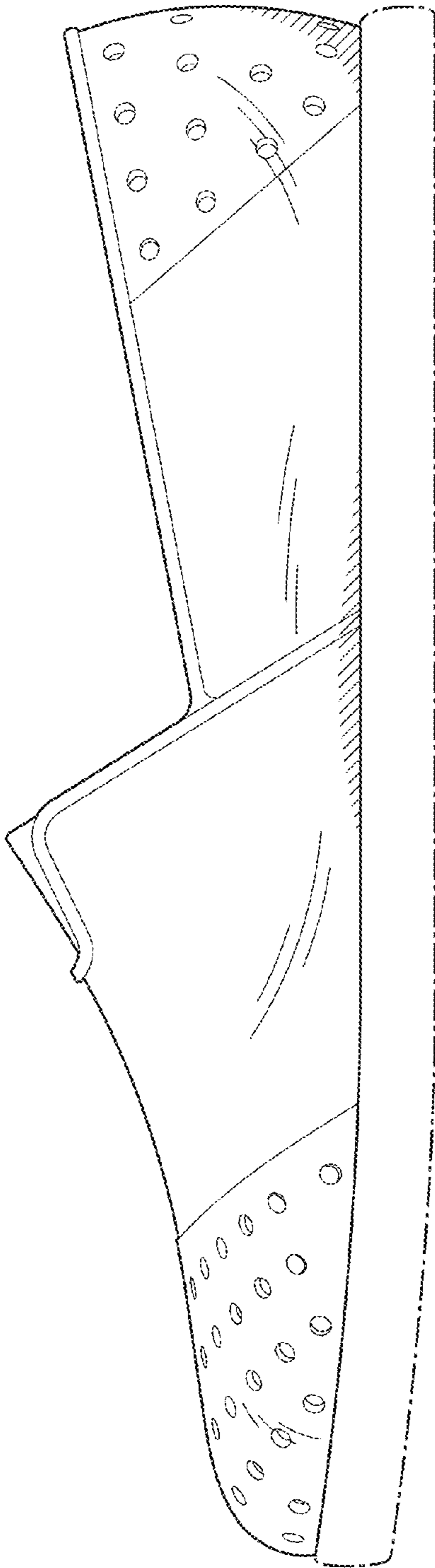

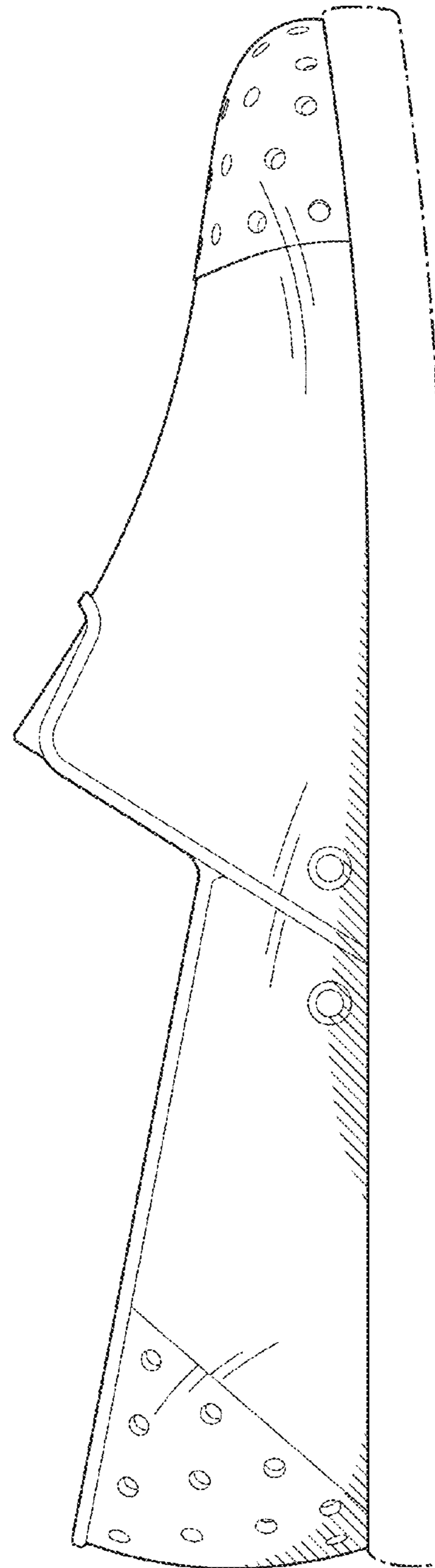

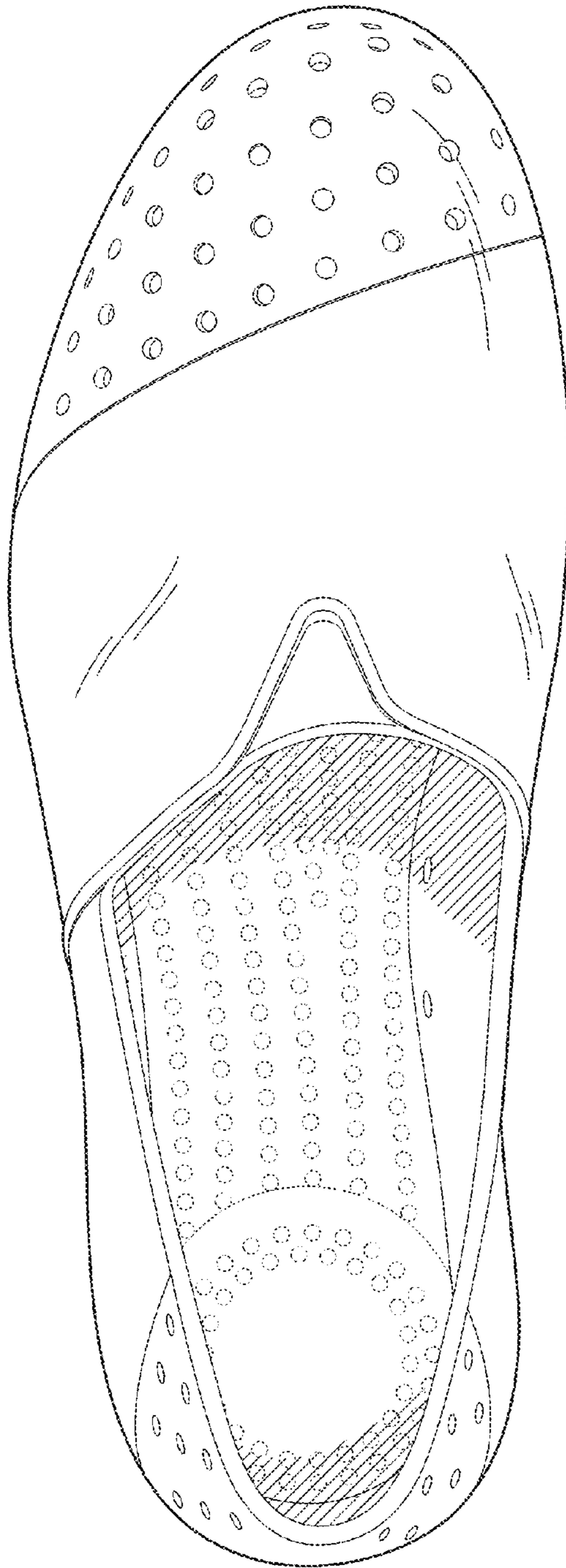

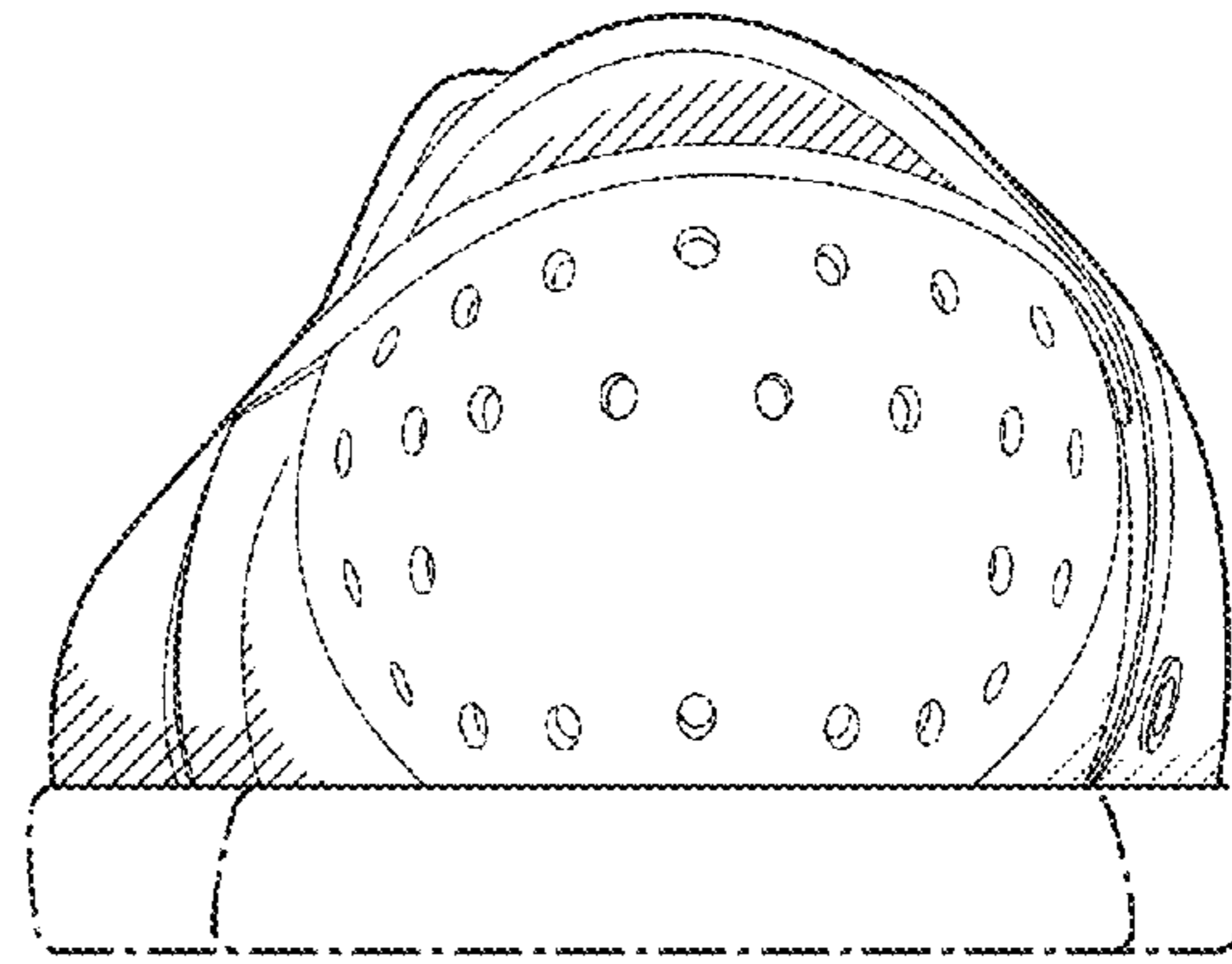

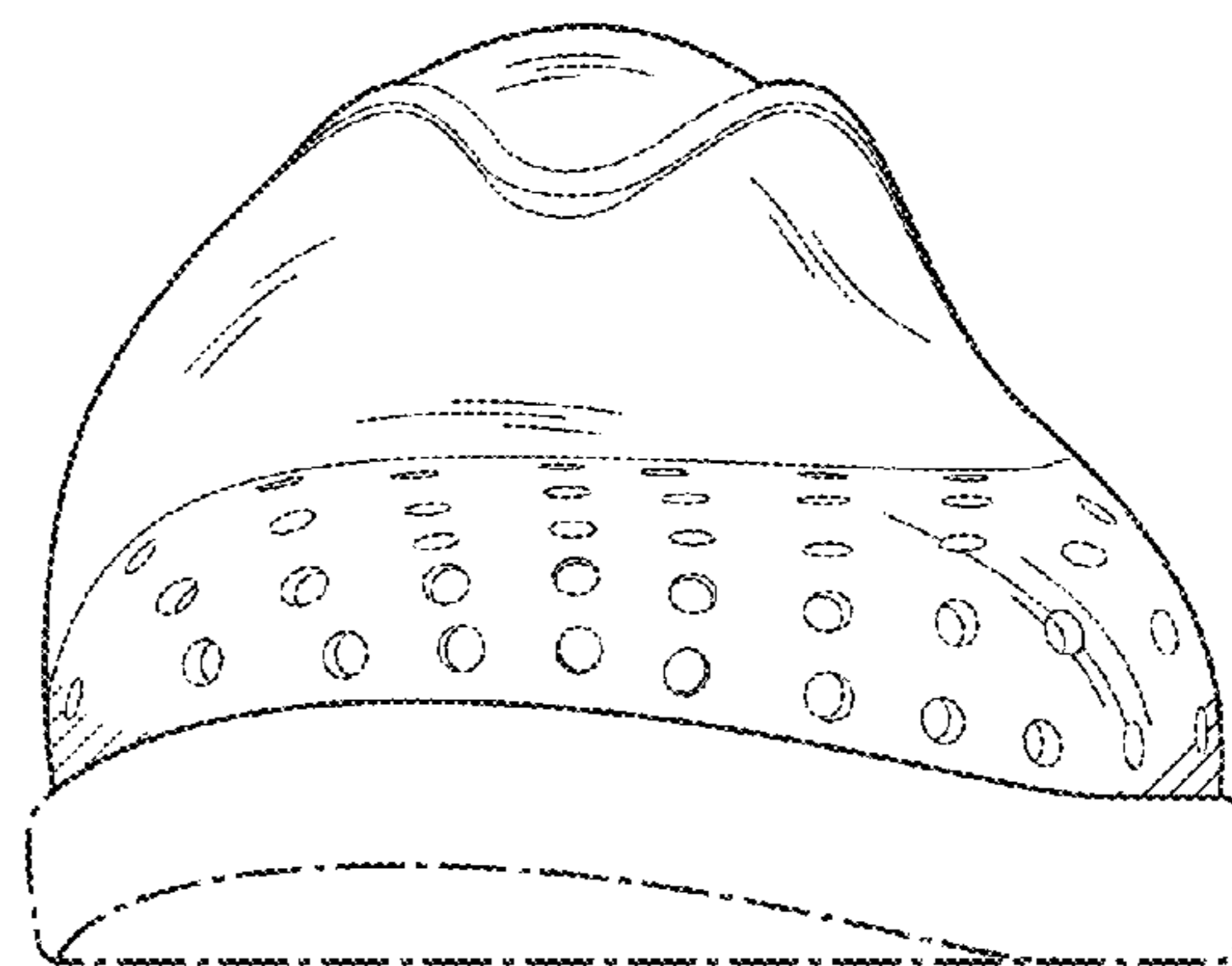

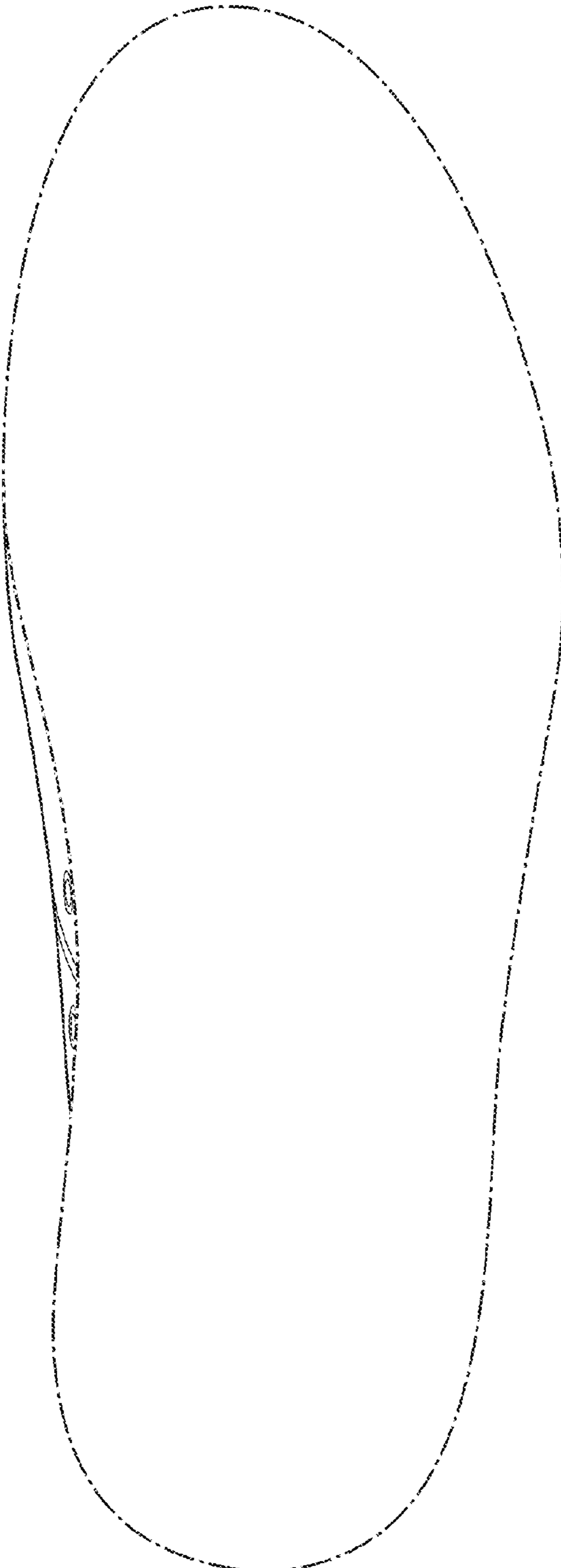
