(57) **CLAIM**
The ornamental design for a sewing supplies organizer, as shown and described.

DESCRIPTION

FIG. 1 is a front, perspective view of a sewing supplies organizer showing my new design, the organizer having two storage drawers in its left side, with a spool and bobbin shown in broken lines.

FIG. 2 is a front view of the sewing supplies organizer of FIG. 1 with the spool and bobbin shown in broken lines.

FIG. 3 is a rear view of the sewing supplies organizer of FIG. 1.

FIG. 4 is a left side view of the sewing supplies organizer of FIG. 1 with the spool and bobbin shown in broken lines.

FIG. 5 is a right side view of the sewing supplies organizer of FIG. 1 with the spool and bobbin shown in broken lines.

FIG. 6 is a top view of the sewing supplies organizer of FIG. 1 with the spool and bobbin shown in broken lines.

FIG. 7 is a bottom view of the sewing supplies organizer of FIG. 1.

FIG. 8 is a front, perspective view of an alternative sewing supplies organizer showing my new design, the organizer having two storage drawers in its right side, with a spool and bobbin shown in broken lines.

FIG. 9 is a front view of the sewing supplies organizer of FIG. 8 with the spool and bobbin shown in broken lines.

FIG. 10 is a rear view of the sewing supplies organizer of FIG. 8.

FIG. 11 is a left side view of the sewing supplies organizer of FIG. 8 with the spool and bobbin shown in broken lines.

FIG. 12 is a right side view of the sewing supplies organizer of FIG. 8 with the spool and bobbin shown in broken lines.

FIG. 13 is a top view of the sewing supplies organizer of FIG. 8 with the spool and bobbin shown in broken lines; and, FIG. 14 is a bottom view of the sewing supplies organizer of FIG. 8.

The broken lines depicting the spool and bobbin in FIGS. 1, 2, 4-6, 8, 9, and 11-13 are included for the purpose of illustrating environmental structure and form no part of the claimed design.

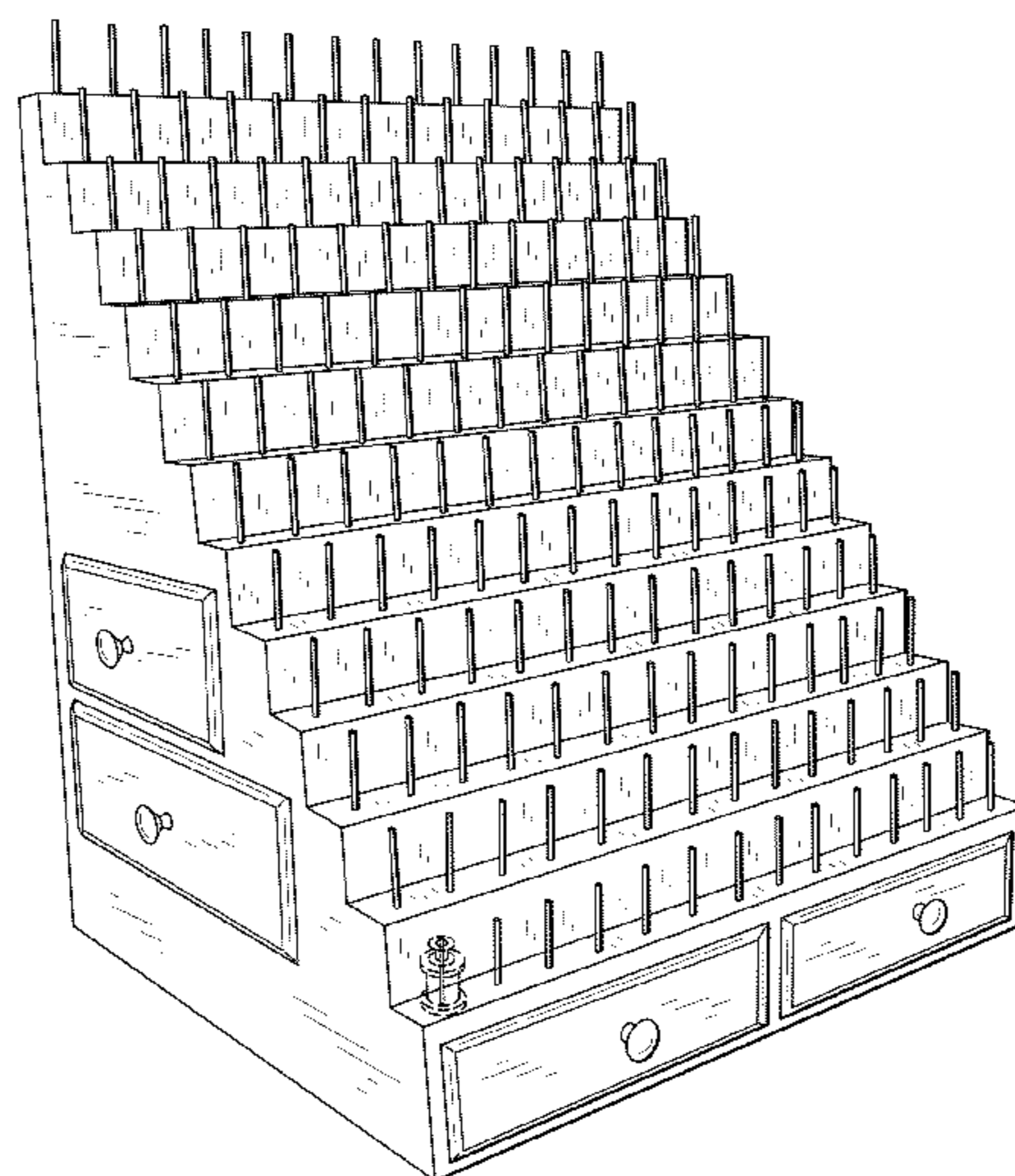

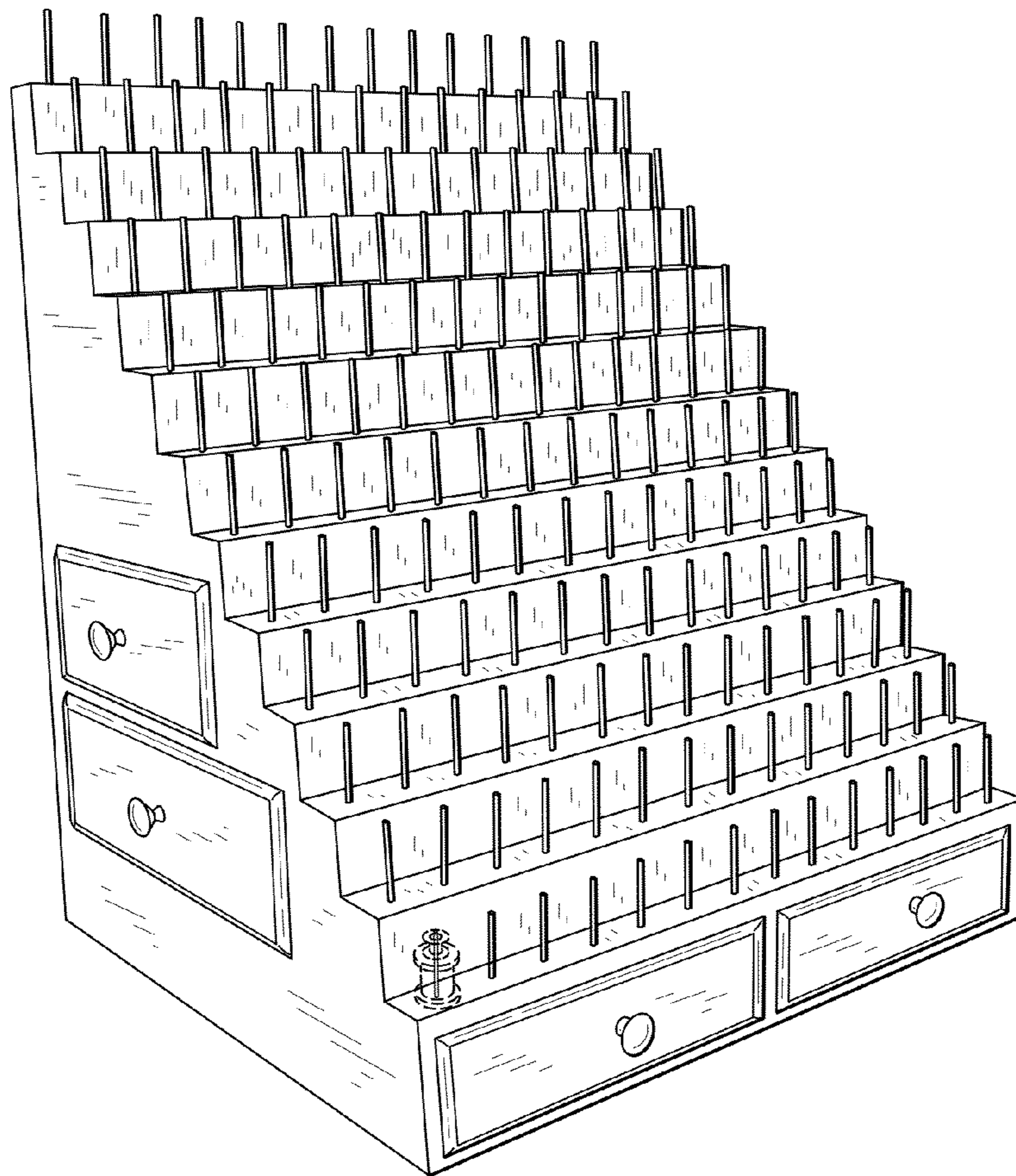

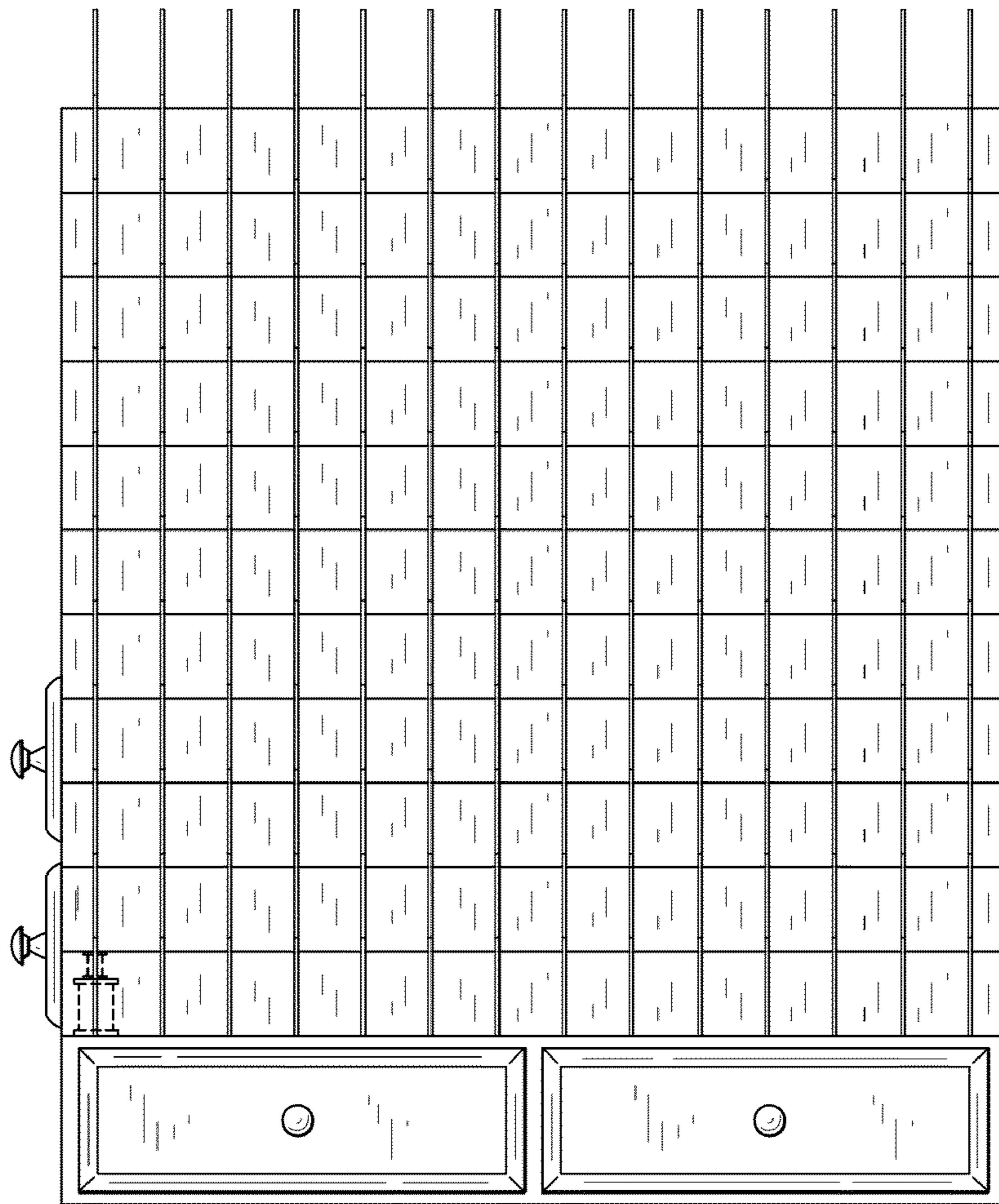

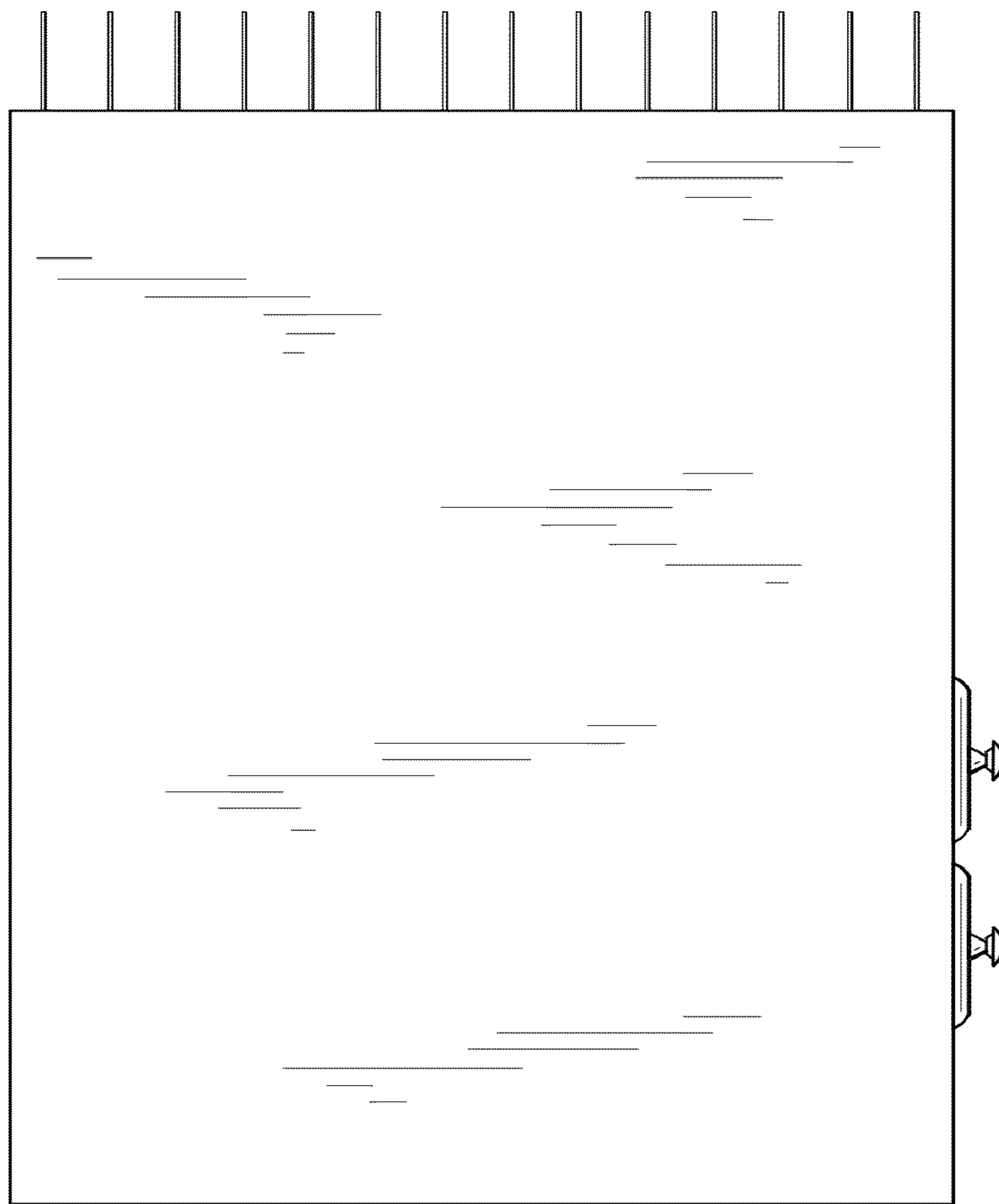

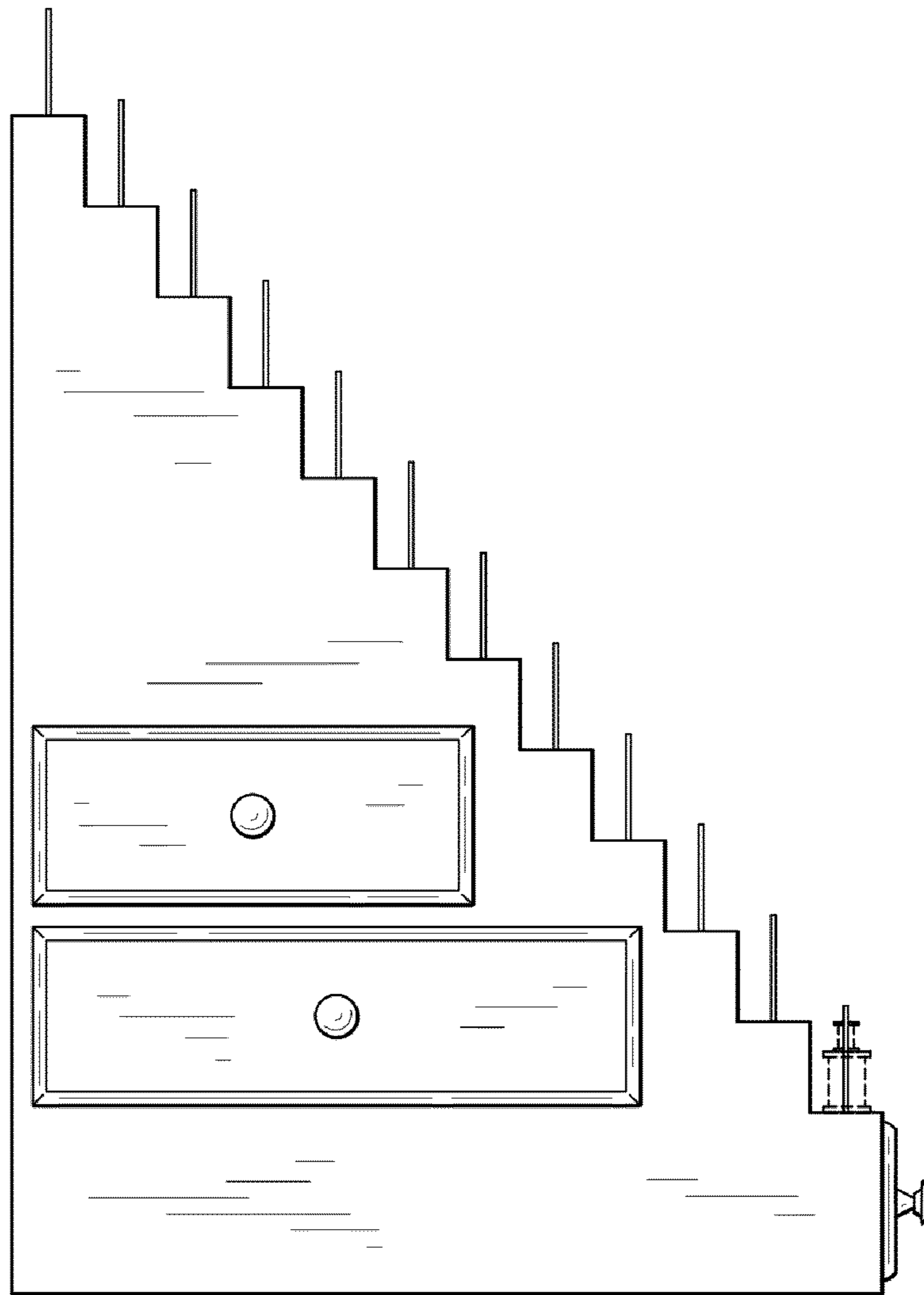

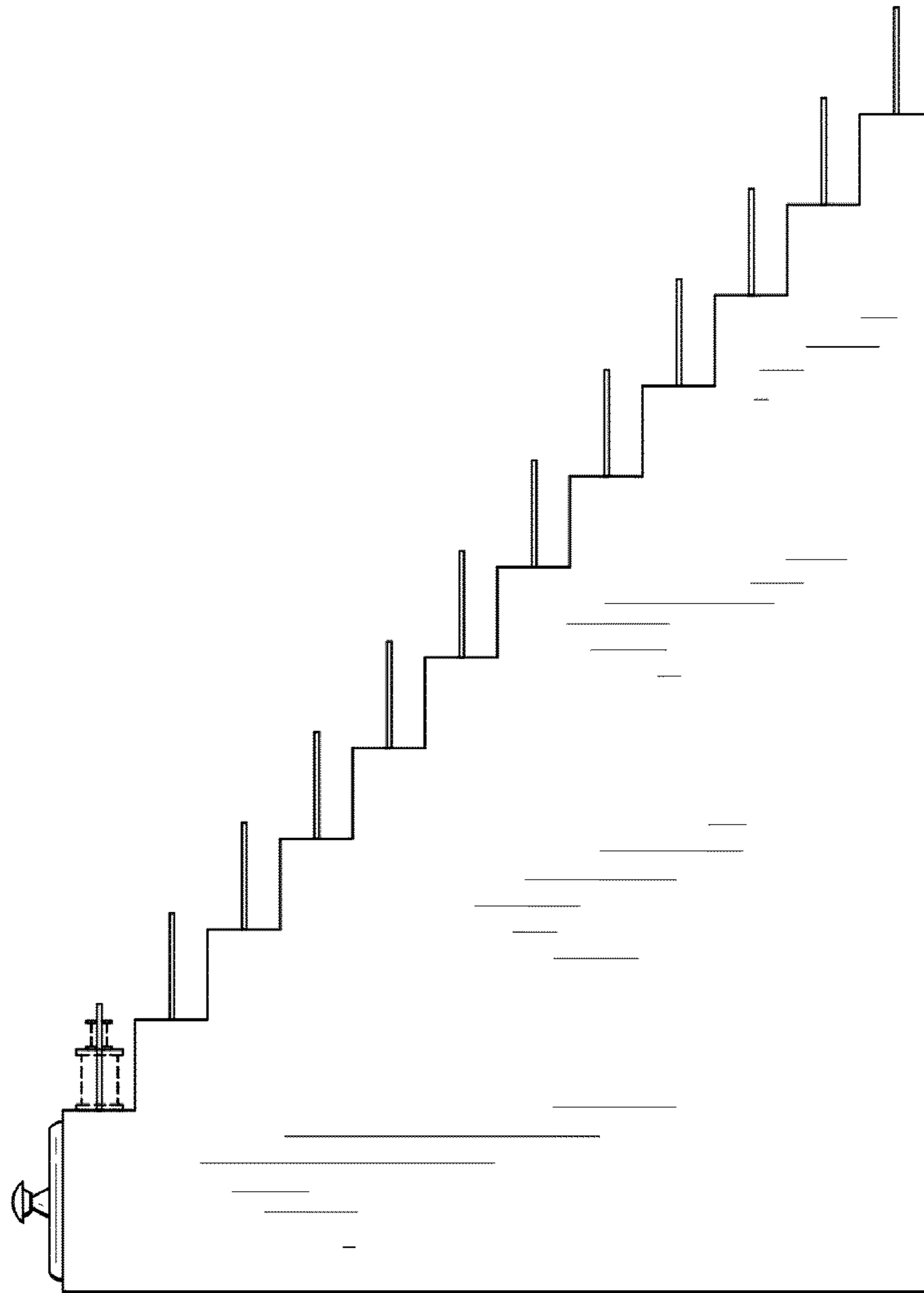

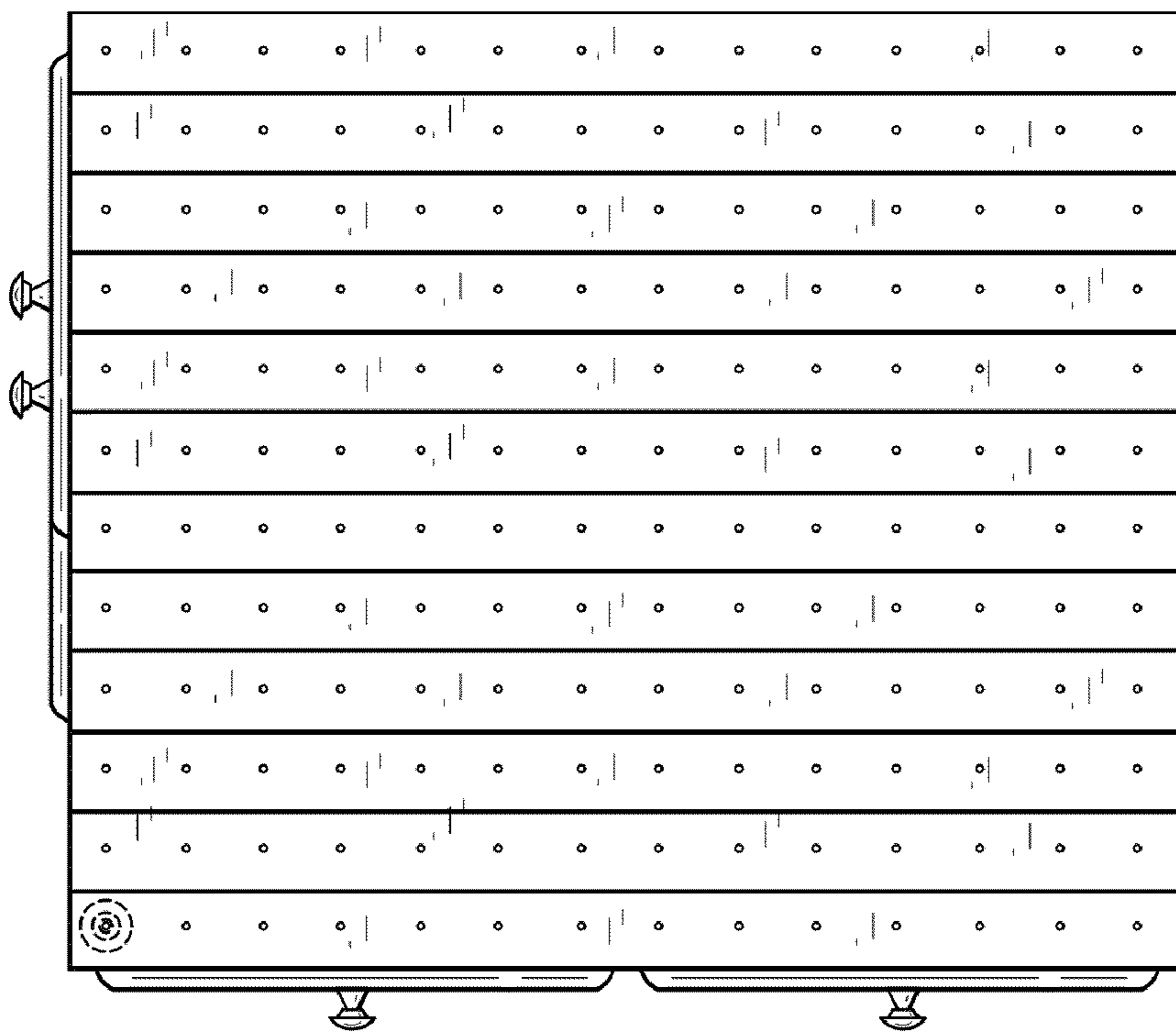

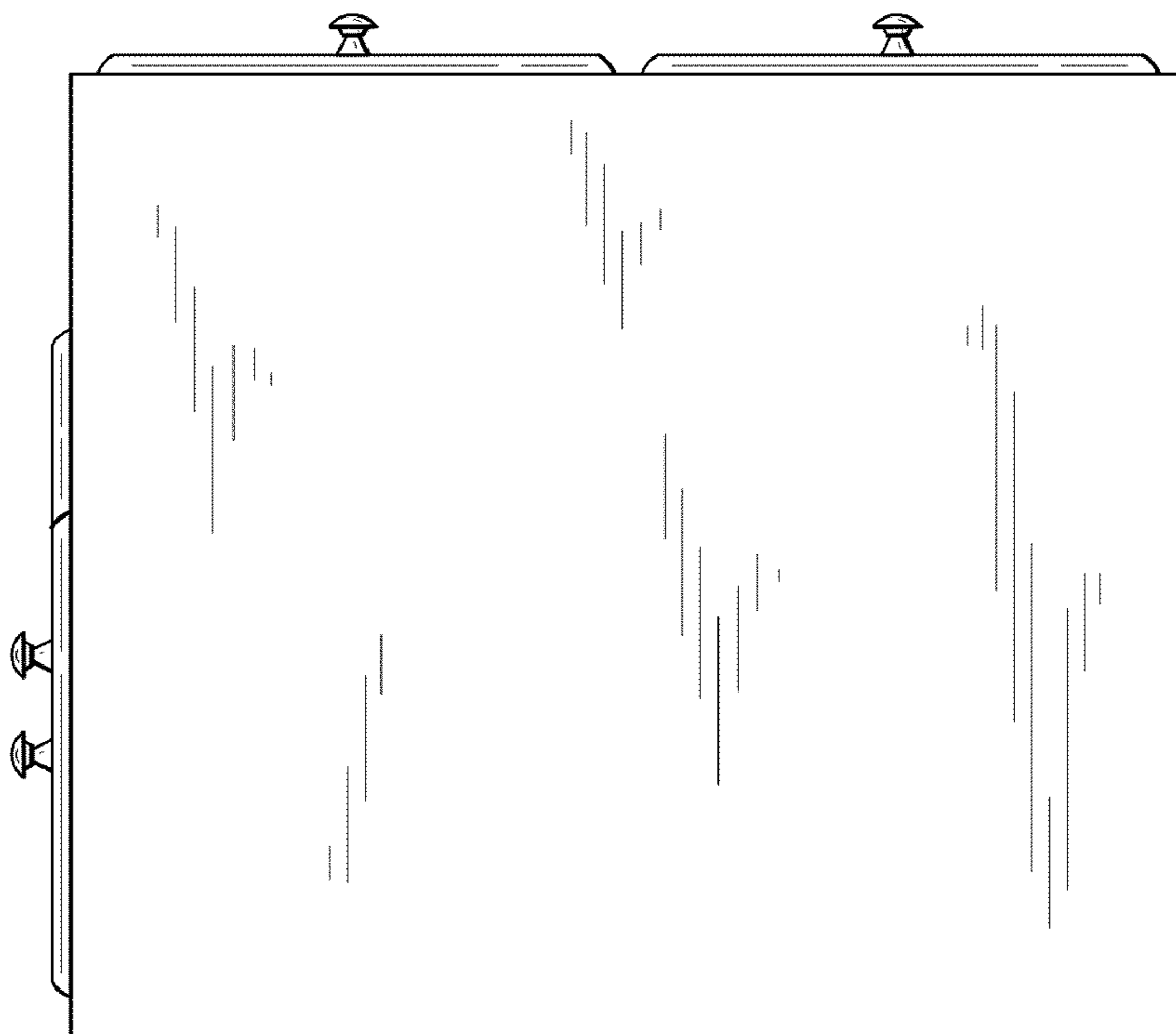

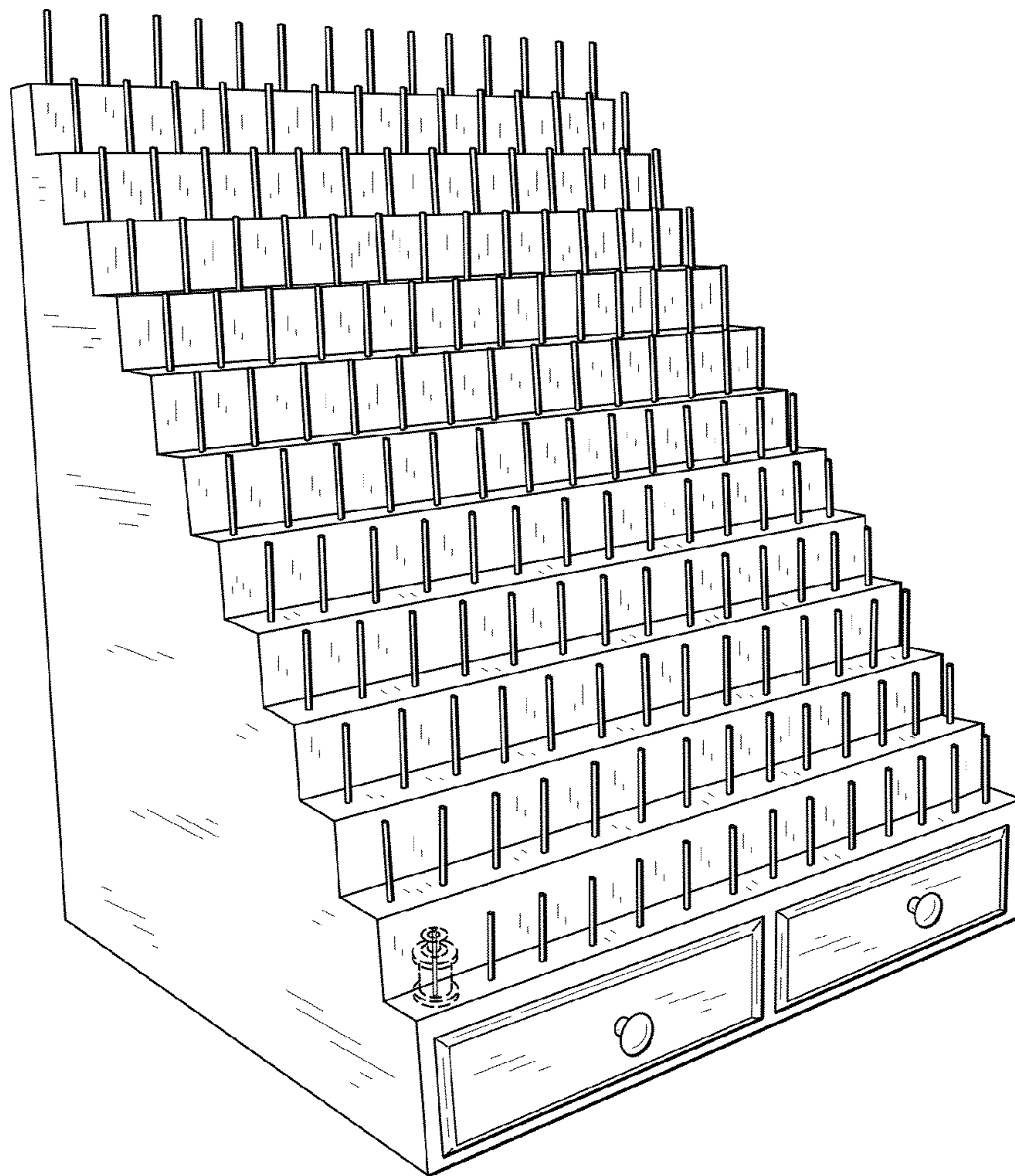

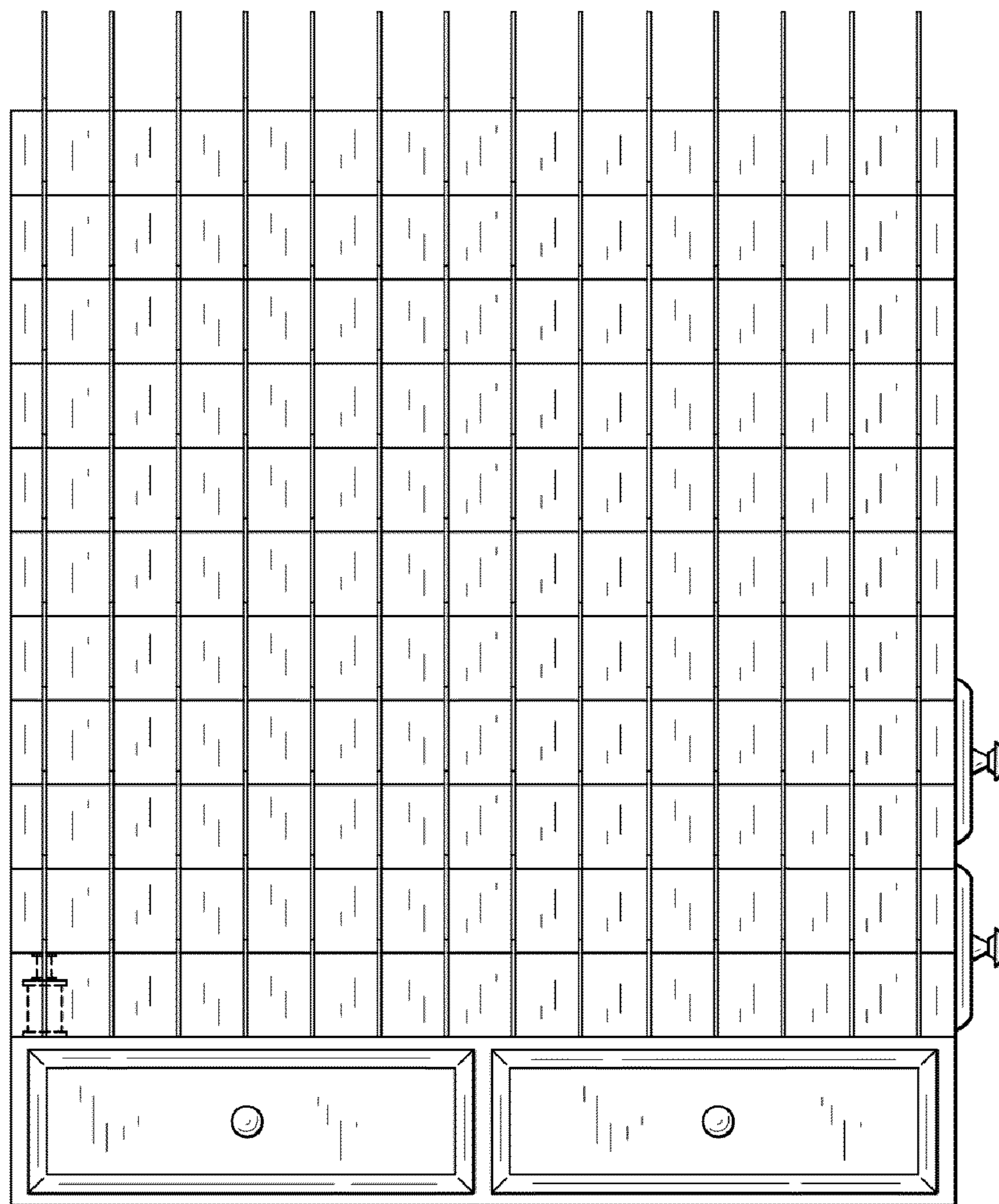

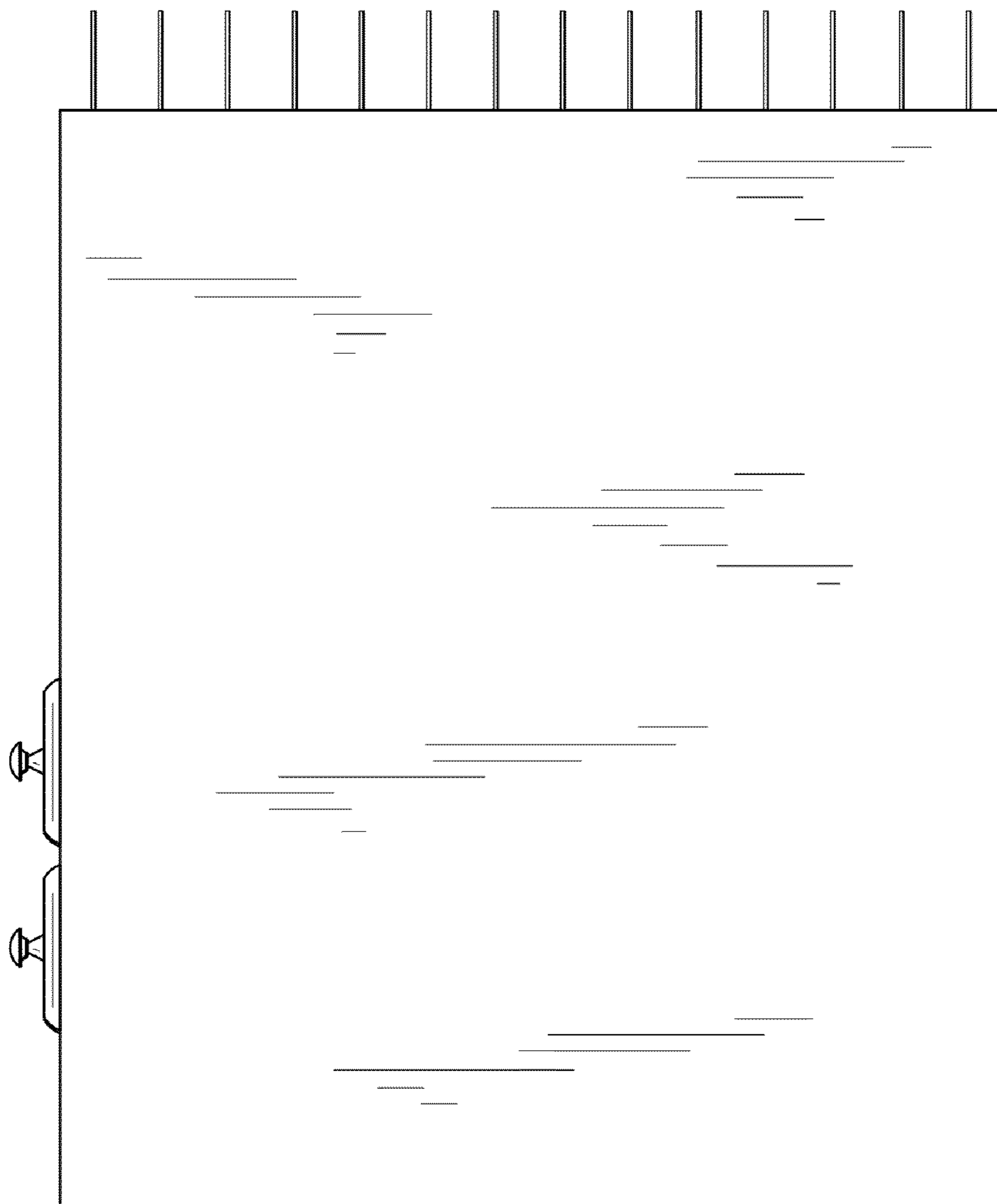

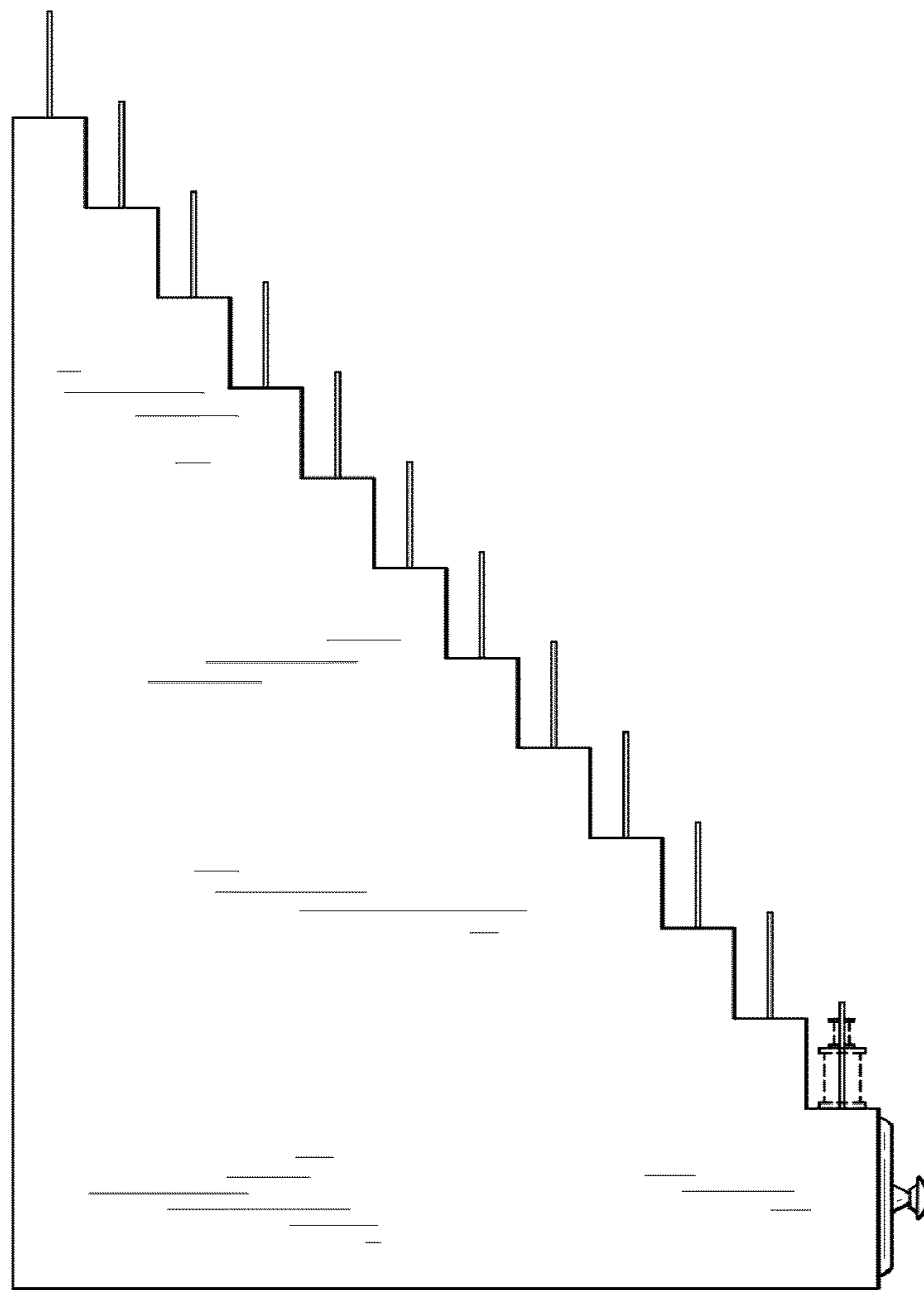

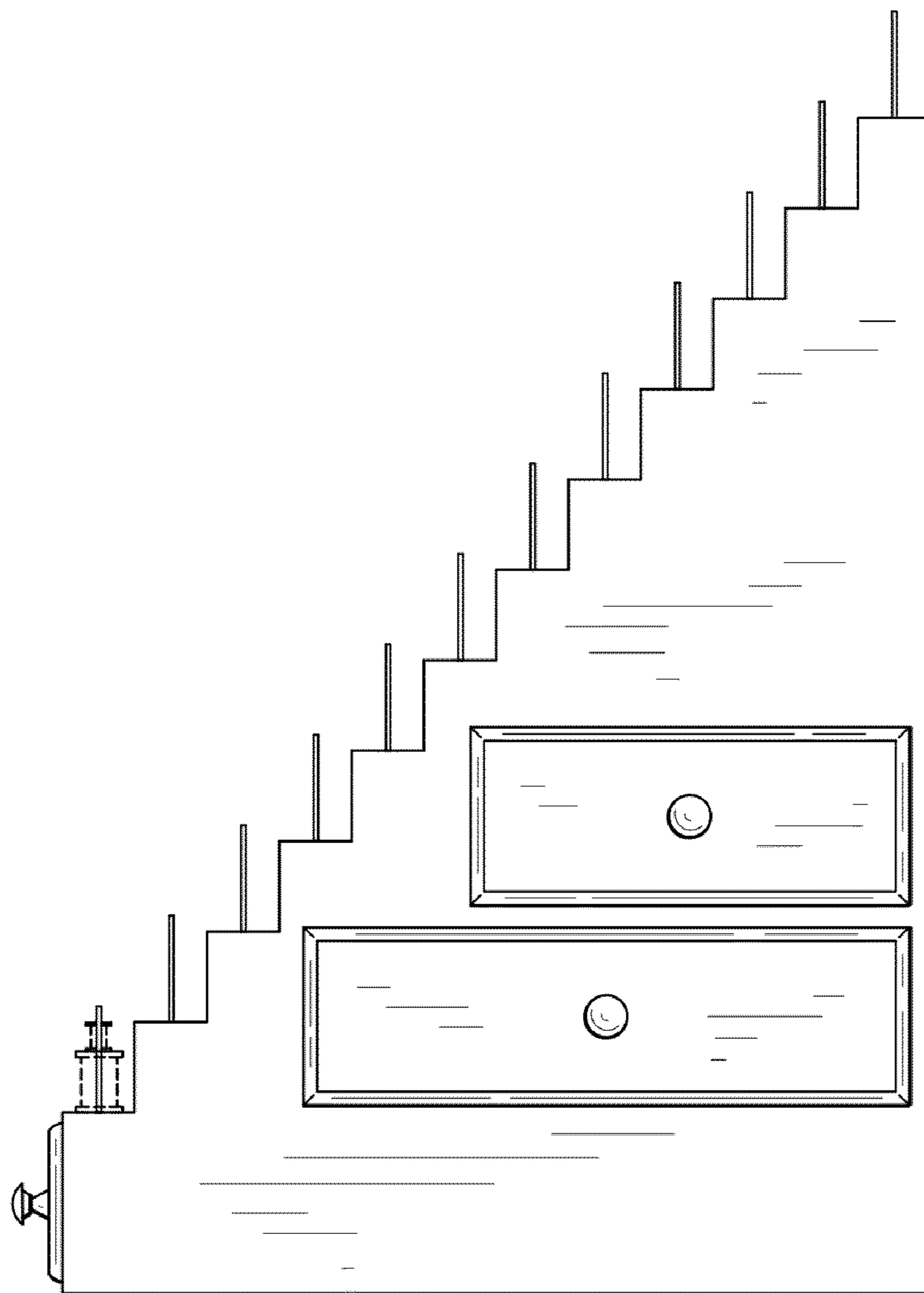

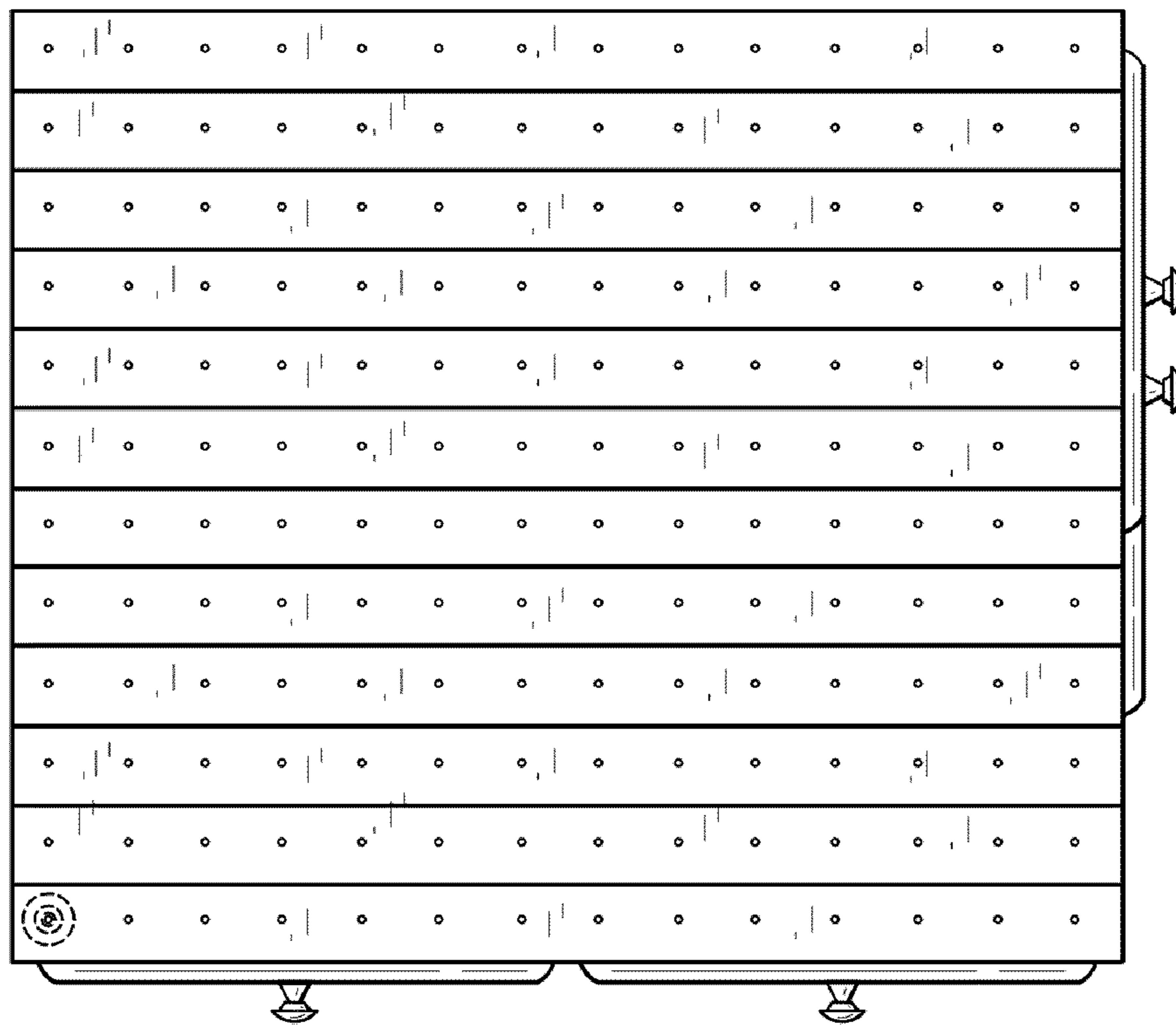
