The ornamental design for a case for an electronic device, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a case for an electronic device showing my new design;

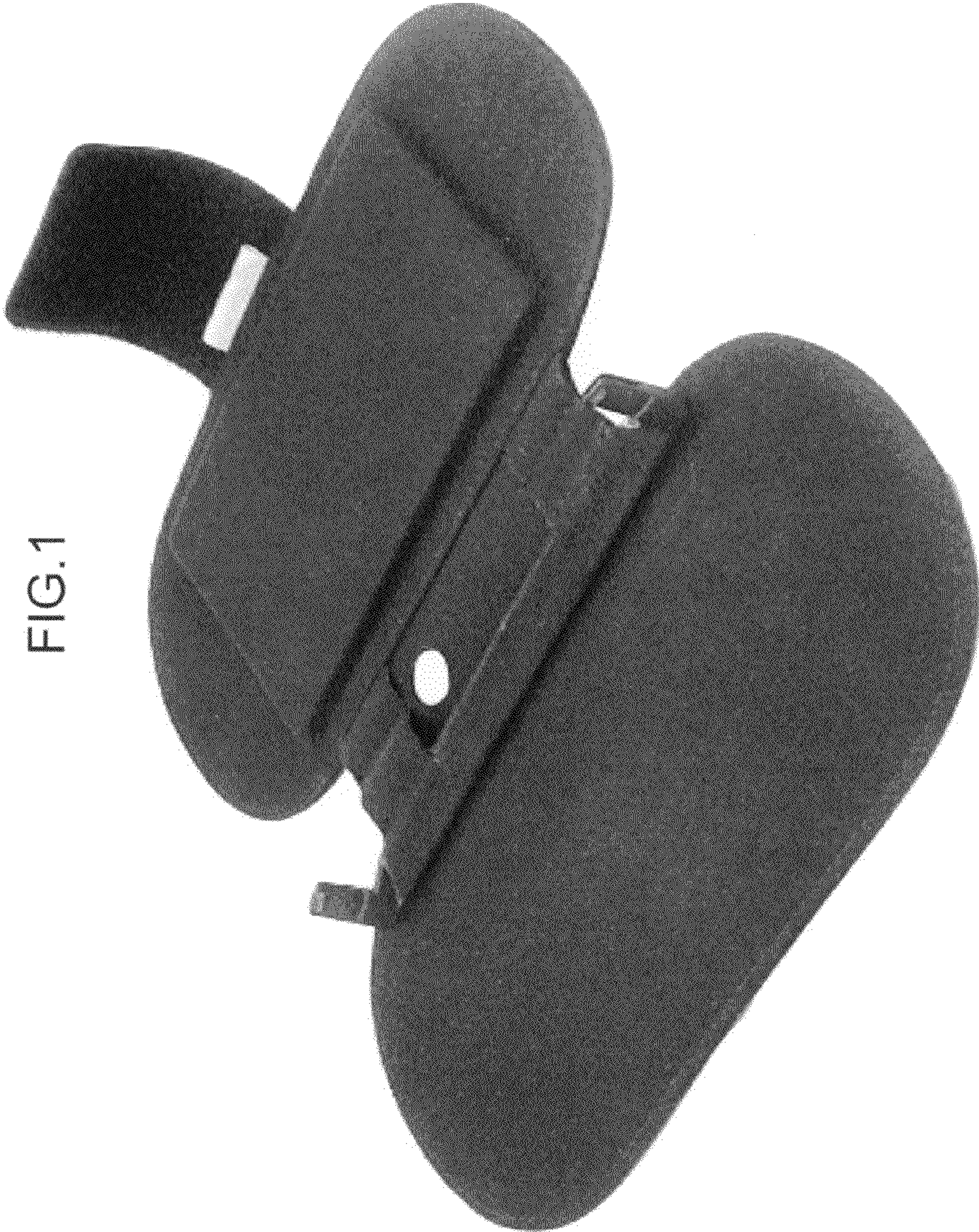

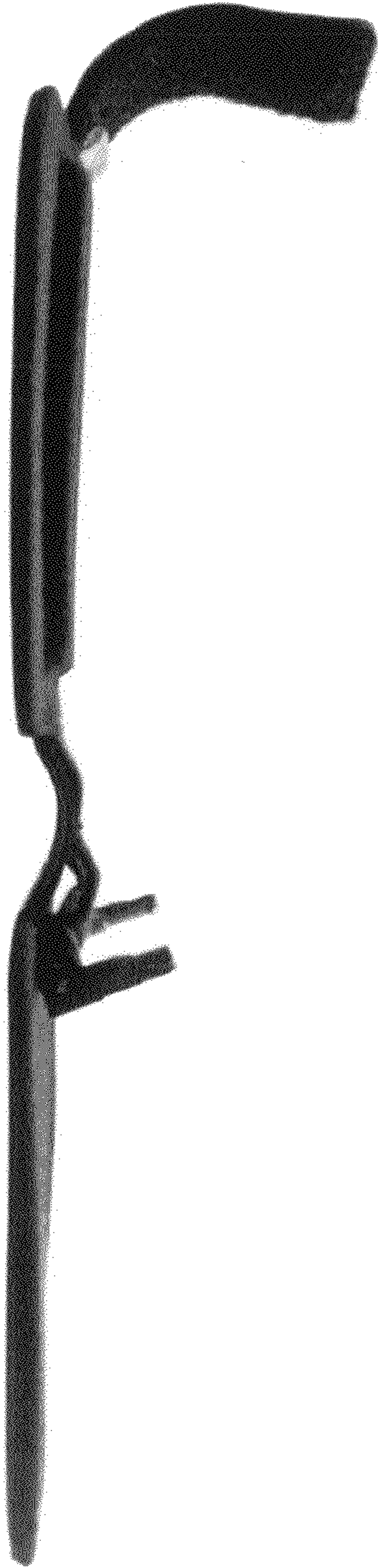
