The broken lines shown in the drawings illustrate portions of the article and form no part of the claimed design.

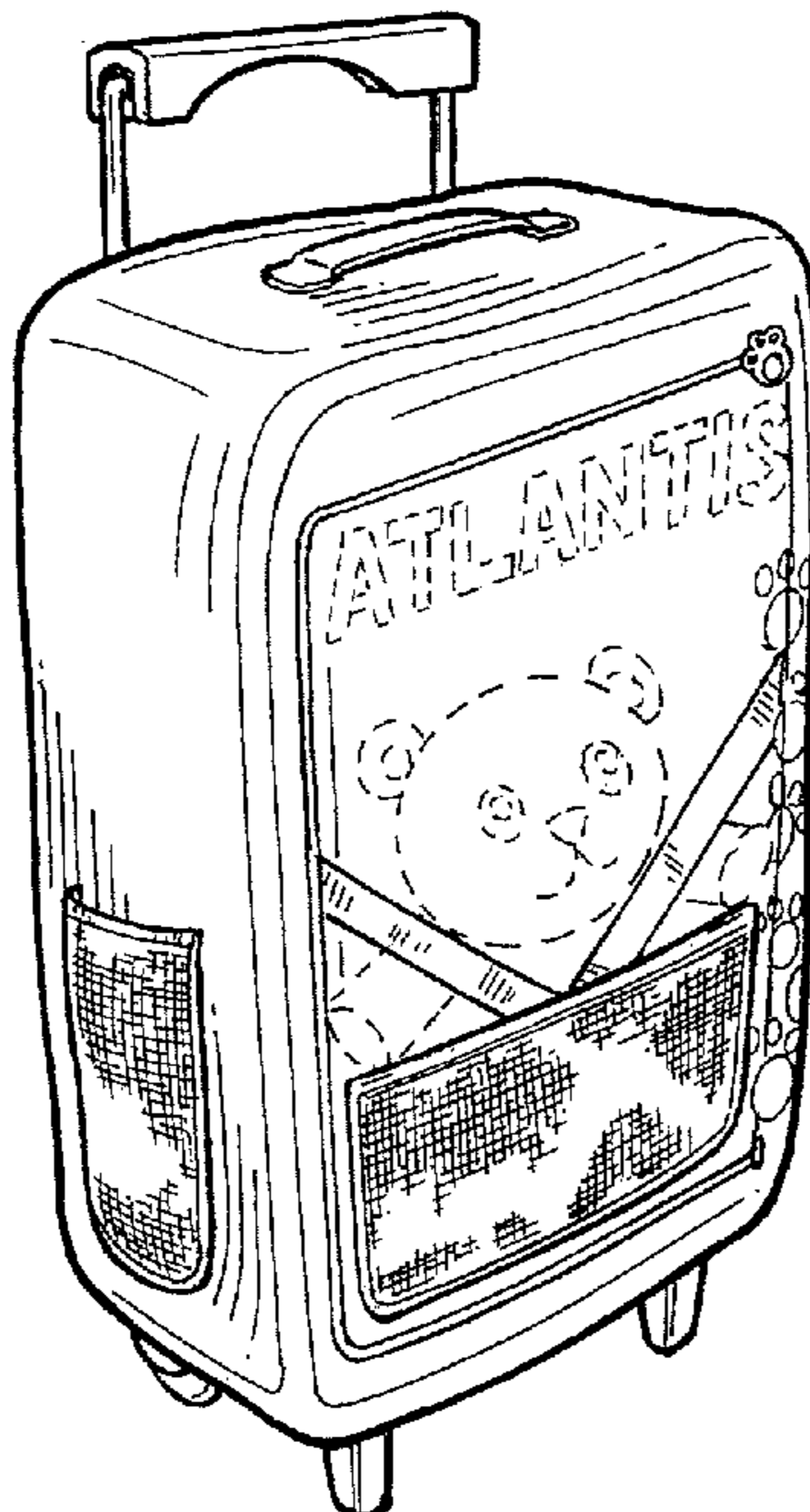

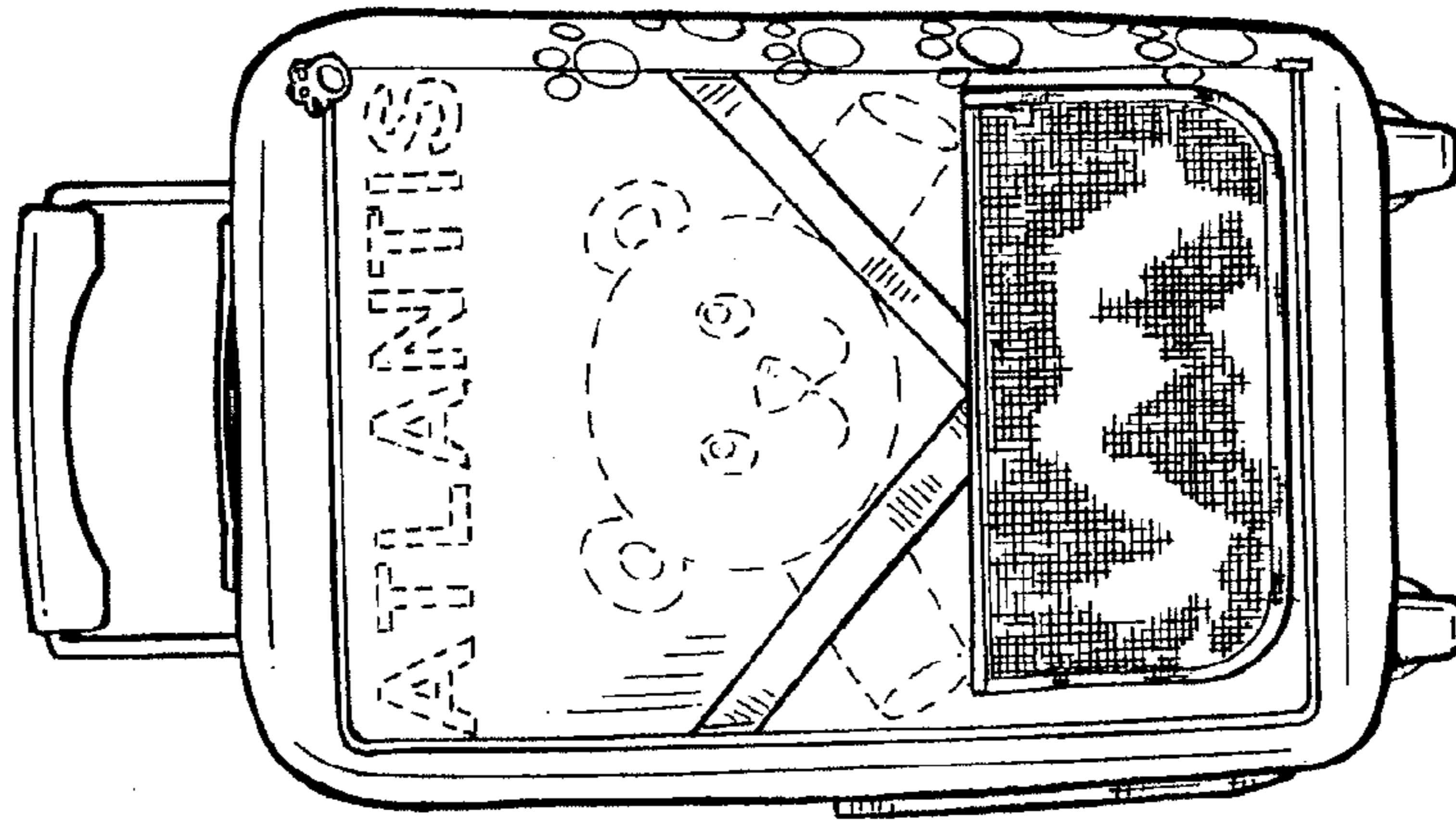

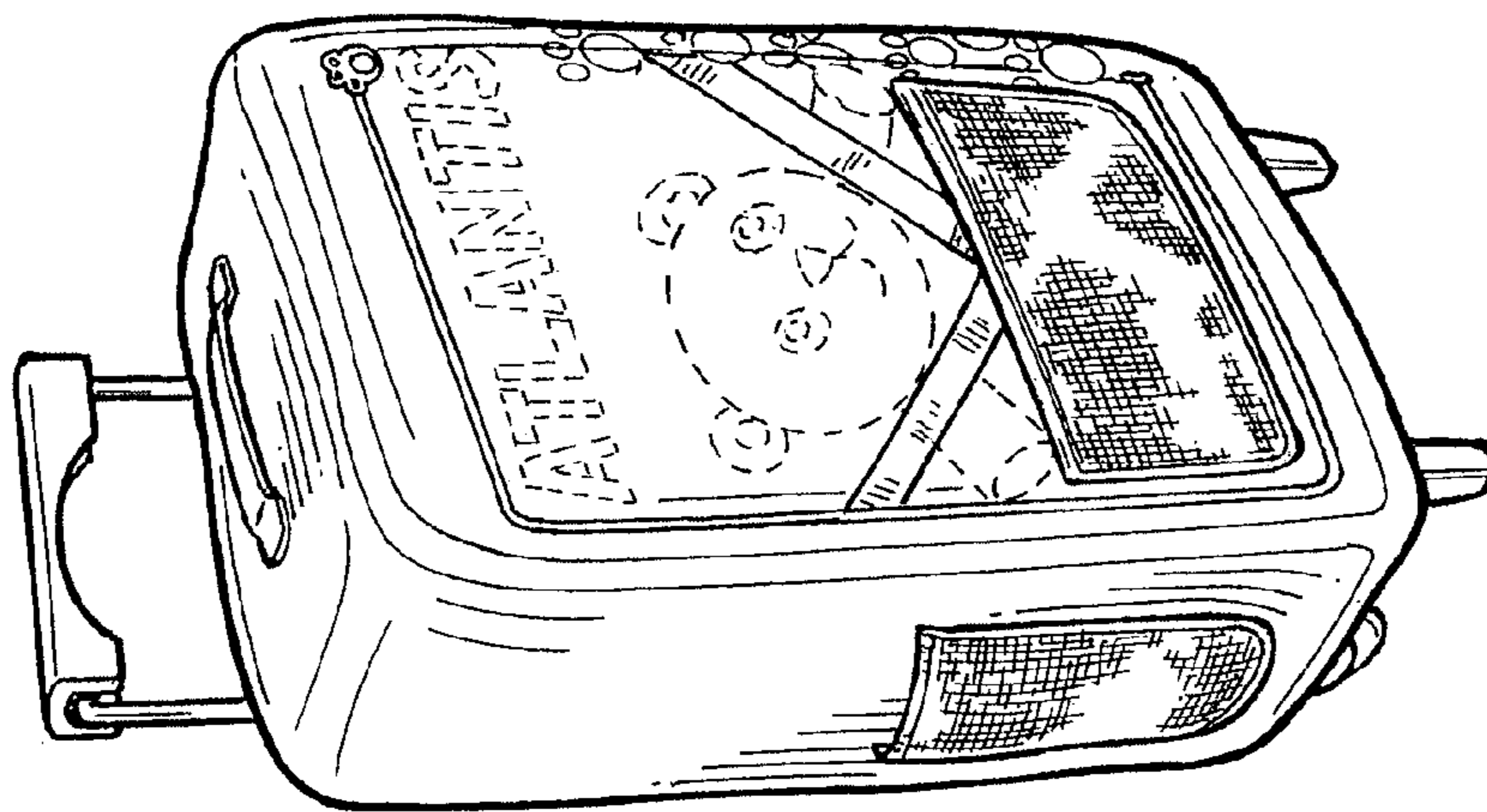

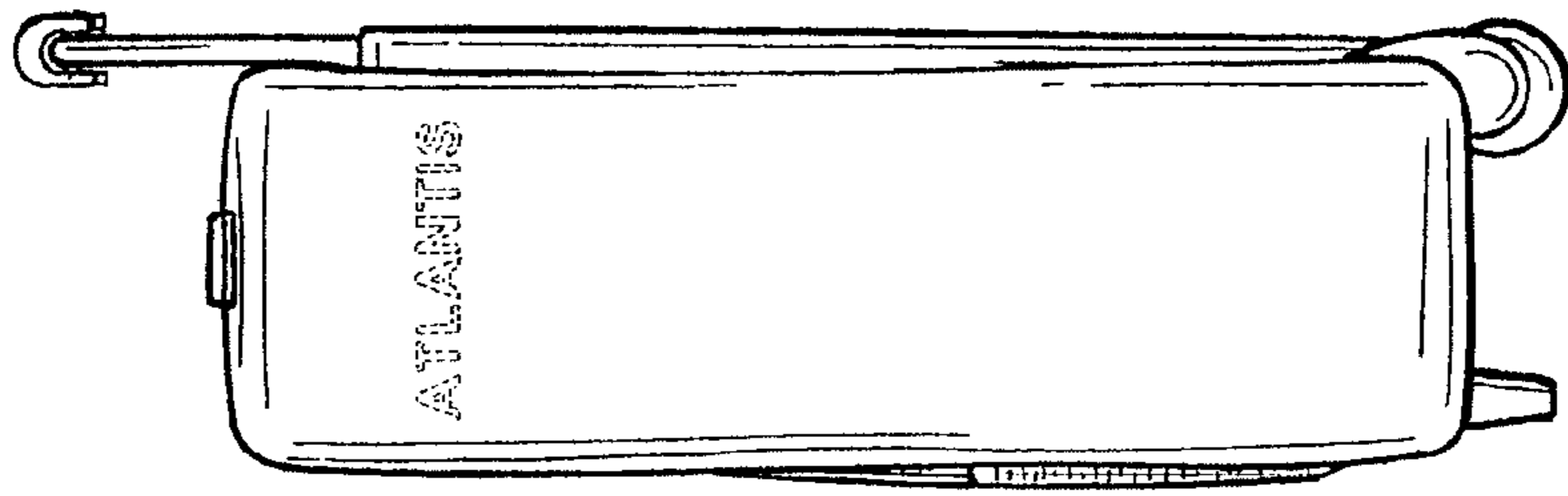

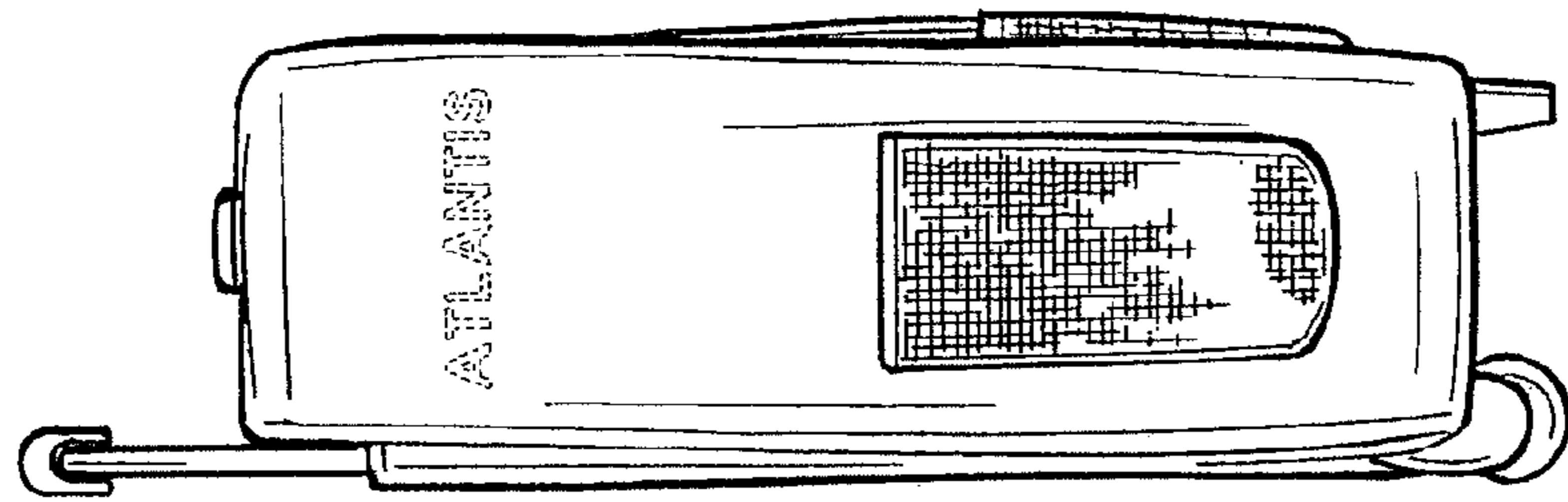

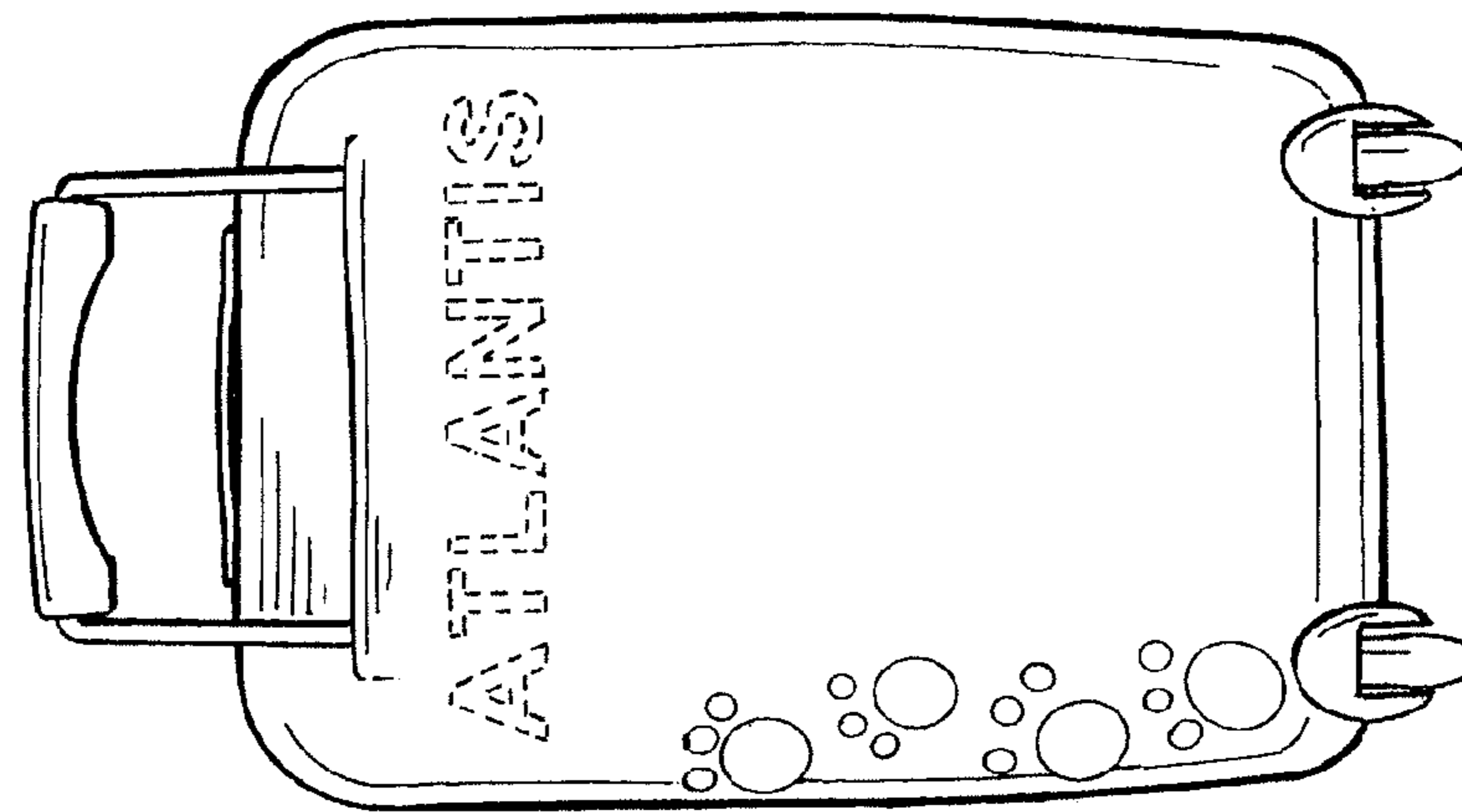

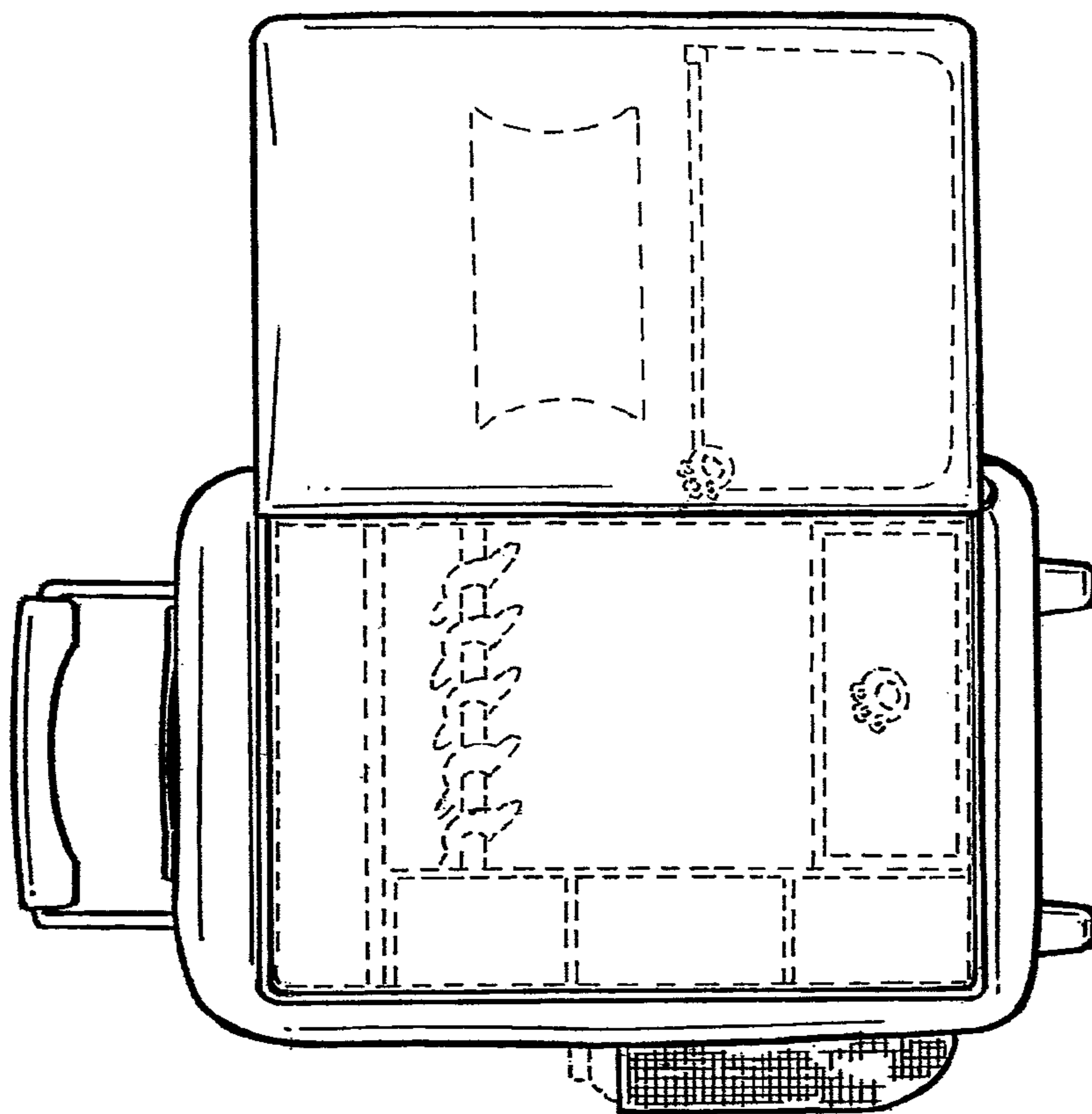

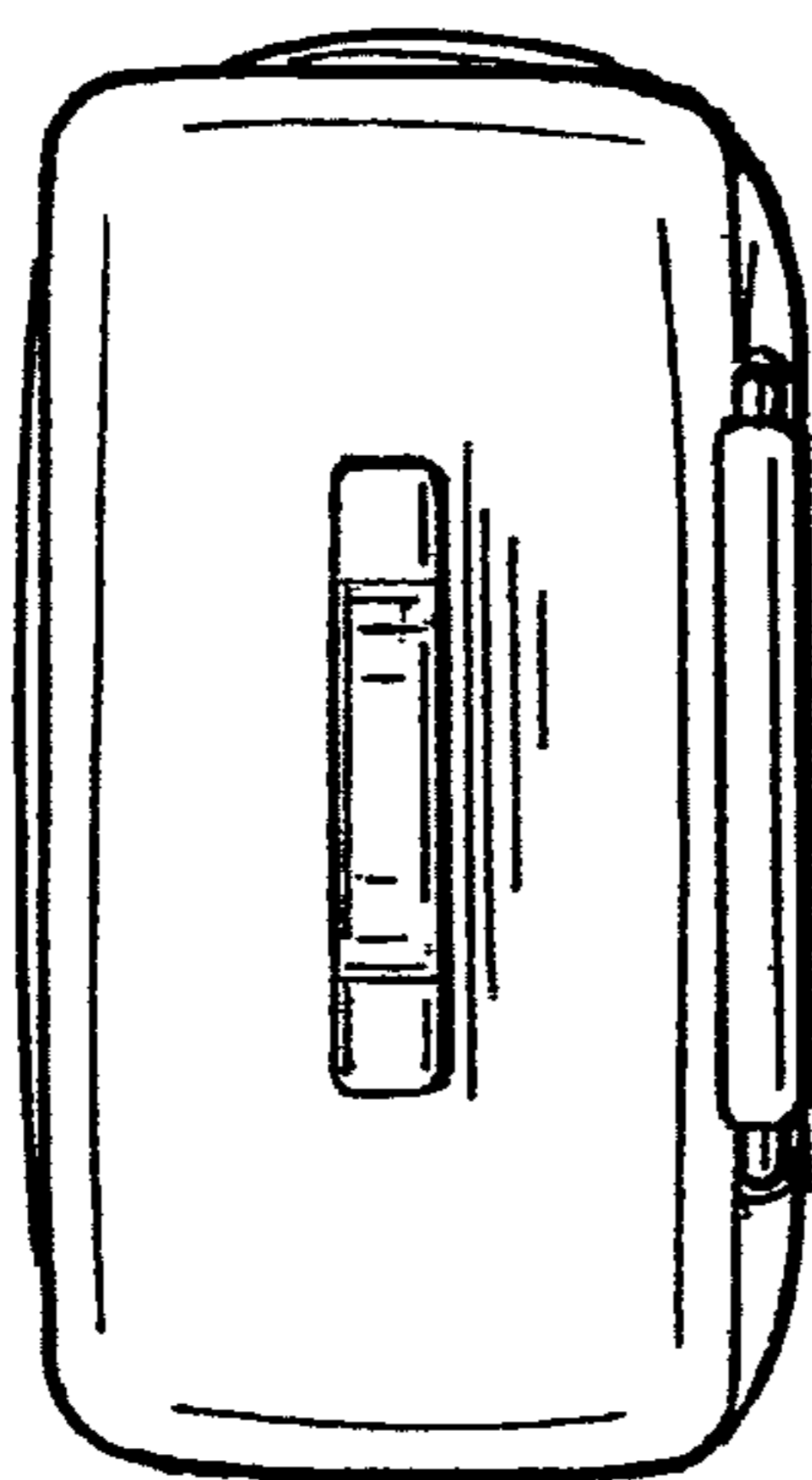
