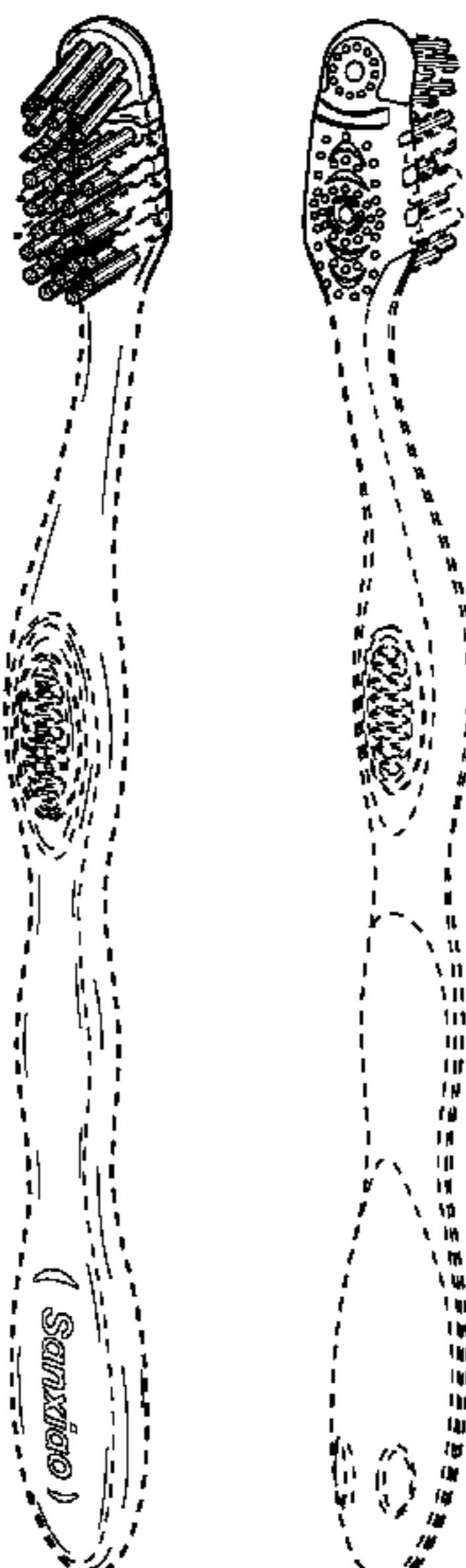
FIG. 1 is a right, front perspective view of a head portion of an oral care implement according to the new design;

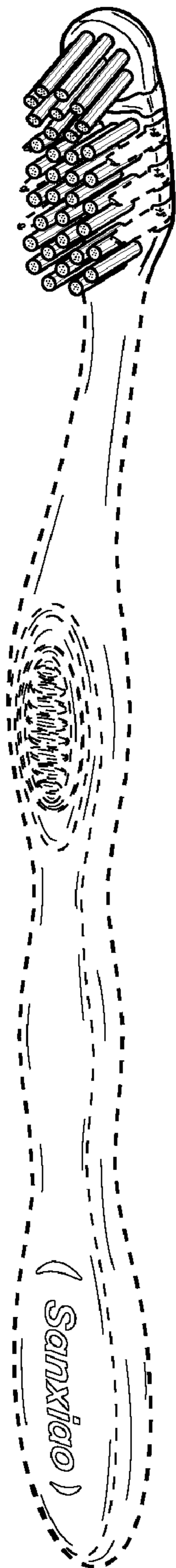

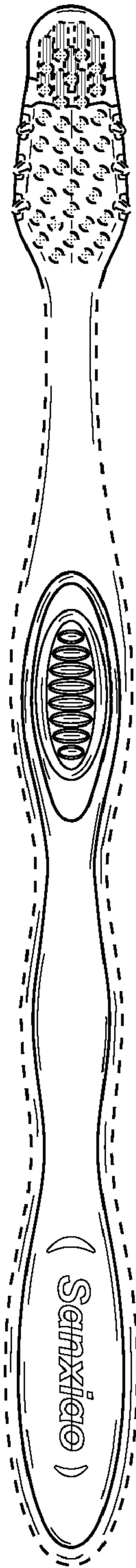

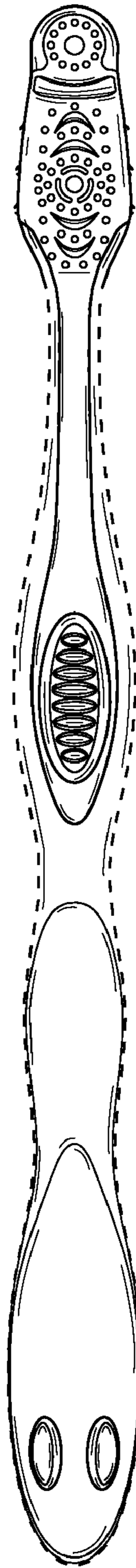

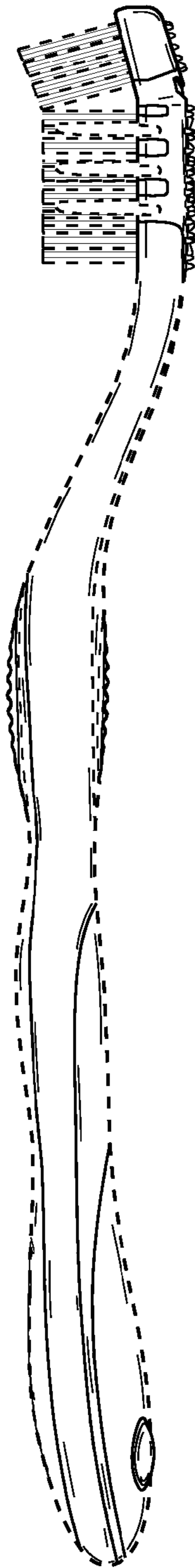

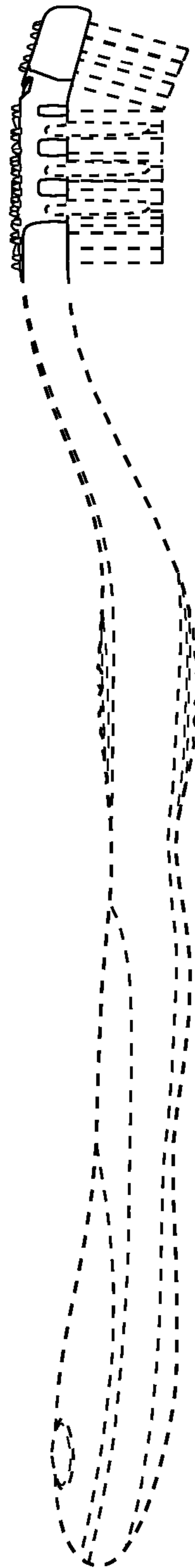

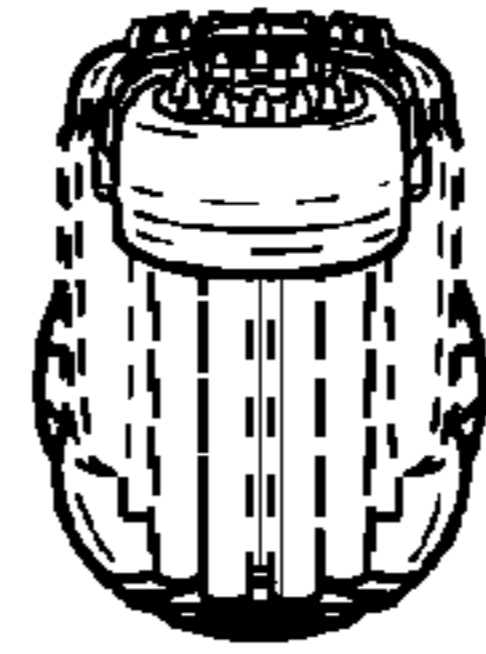

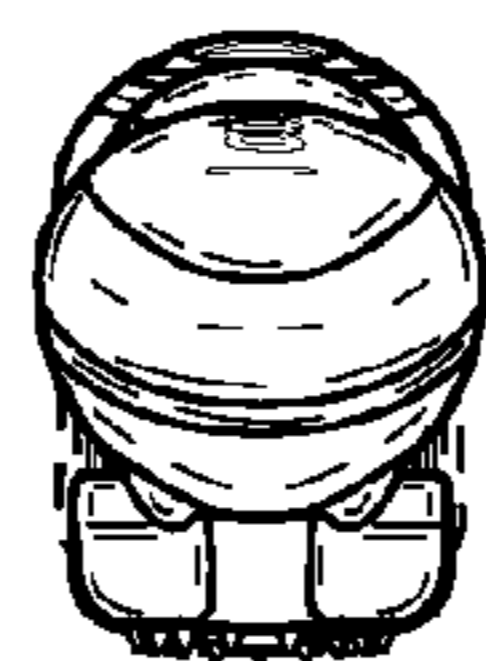
