(57) **CLAIM**

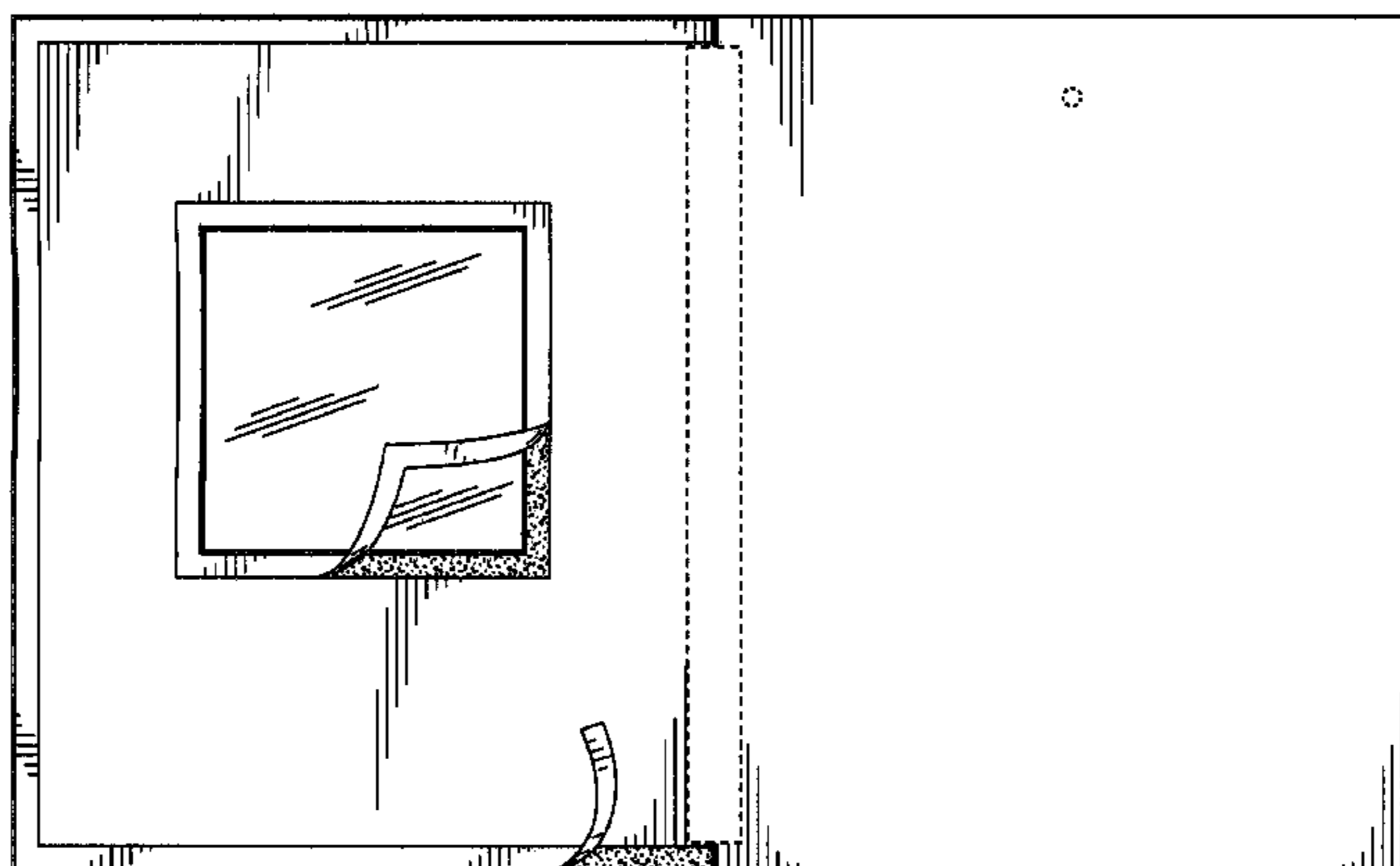
The ornamental design for a photo frame with adhesive tape, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a photo frame;
FIG. 2 is a front view thereof;
FIG. 3 is a back view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is a left side view thereof;
FIG. 7 is a right side view thereof;
FIG. 8 is an interior view thereof showing the adhesive tape;
and,
FIG. 9 is an interior view when the adhesive tape is peeled back.

The broken line showings of the photo frame with adhesive tape in FIGS. 1-9 are for the purpose of illustrating an environment only and form no part of the claimed design.

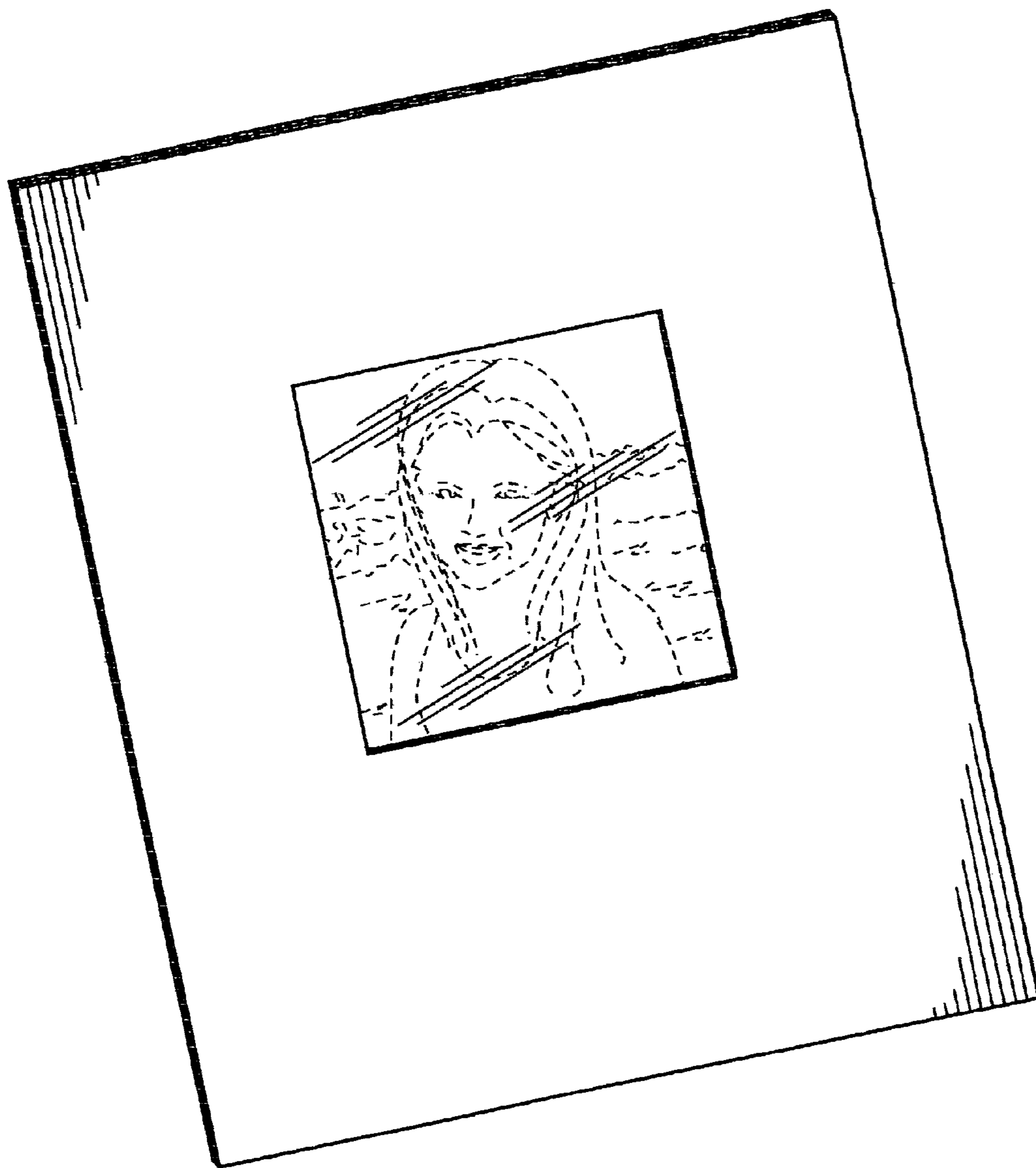

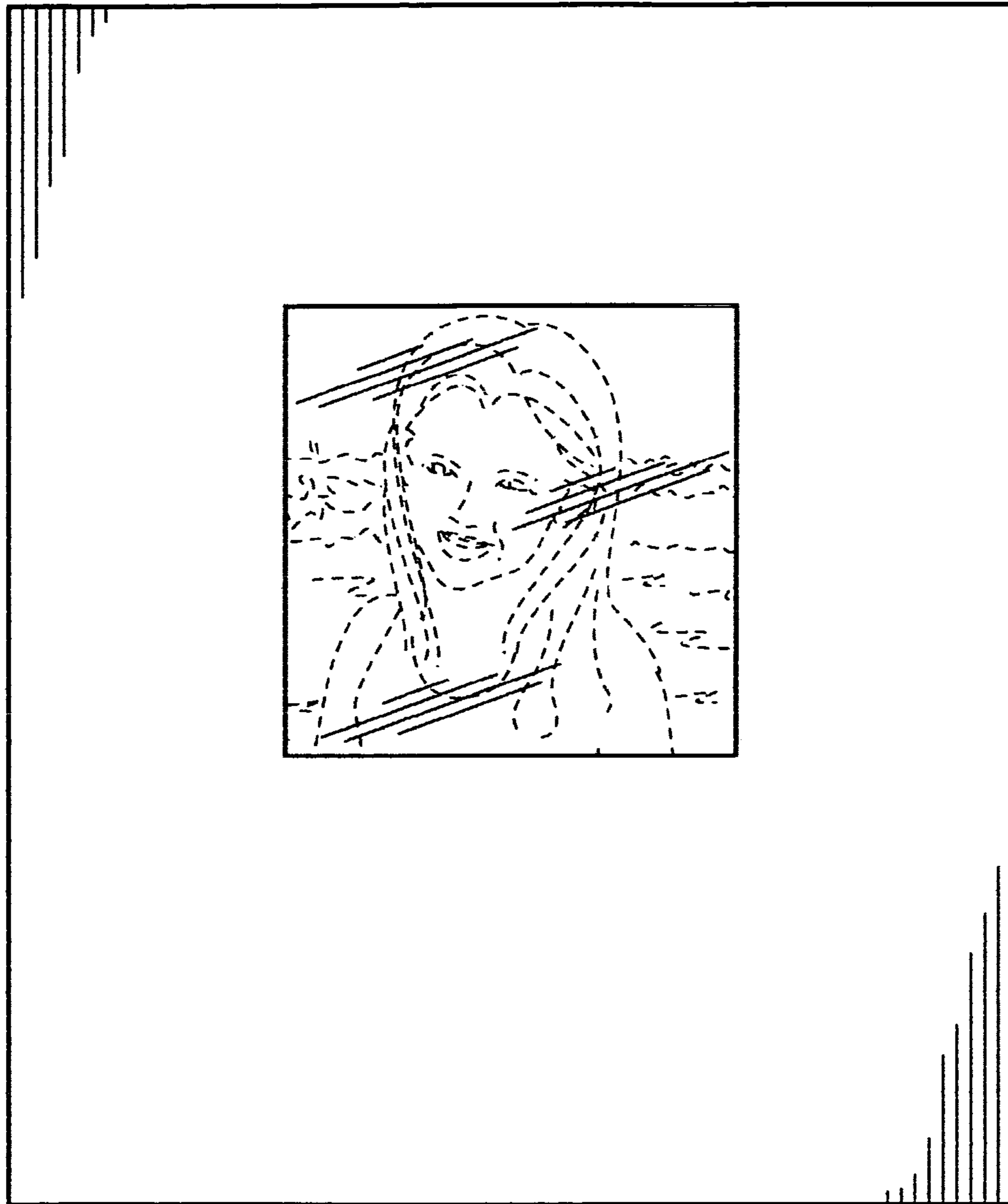

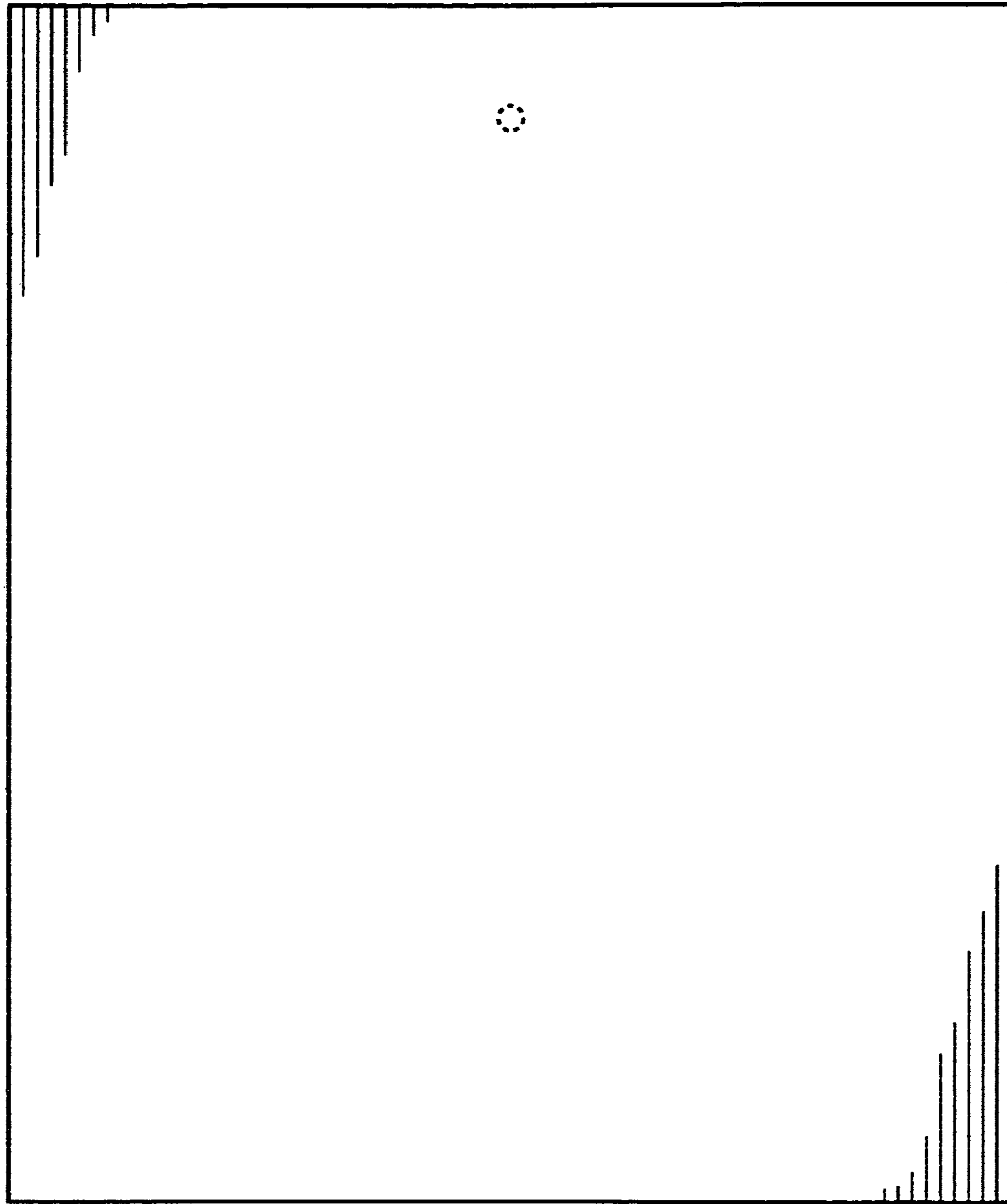

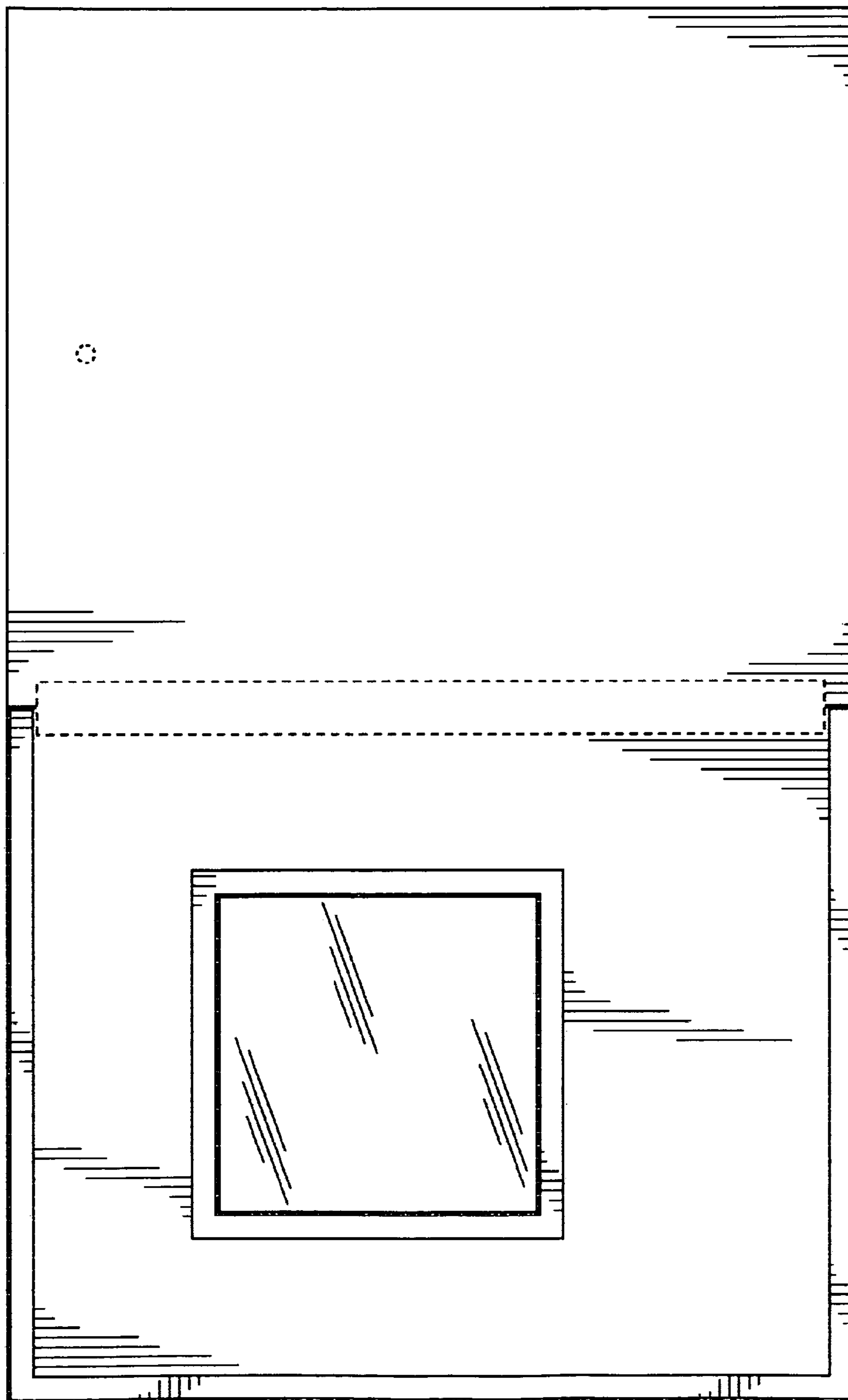

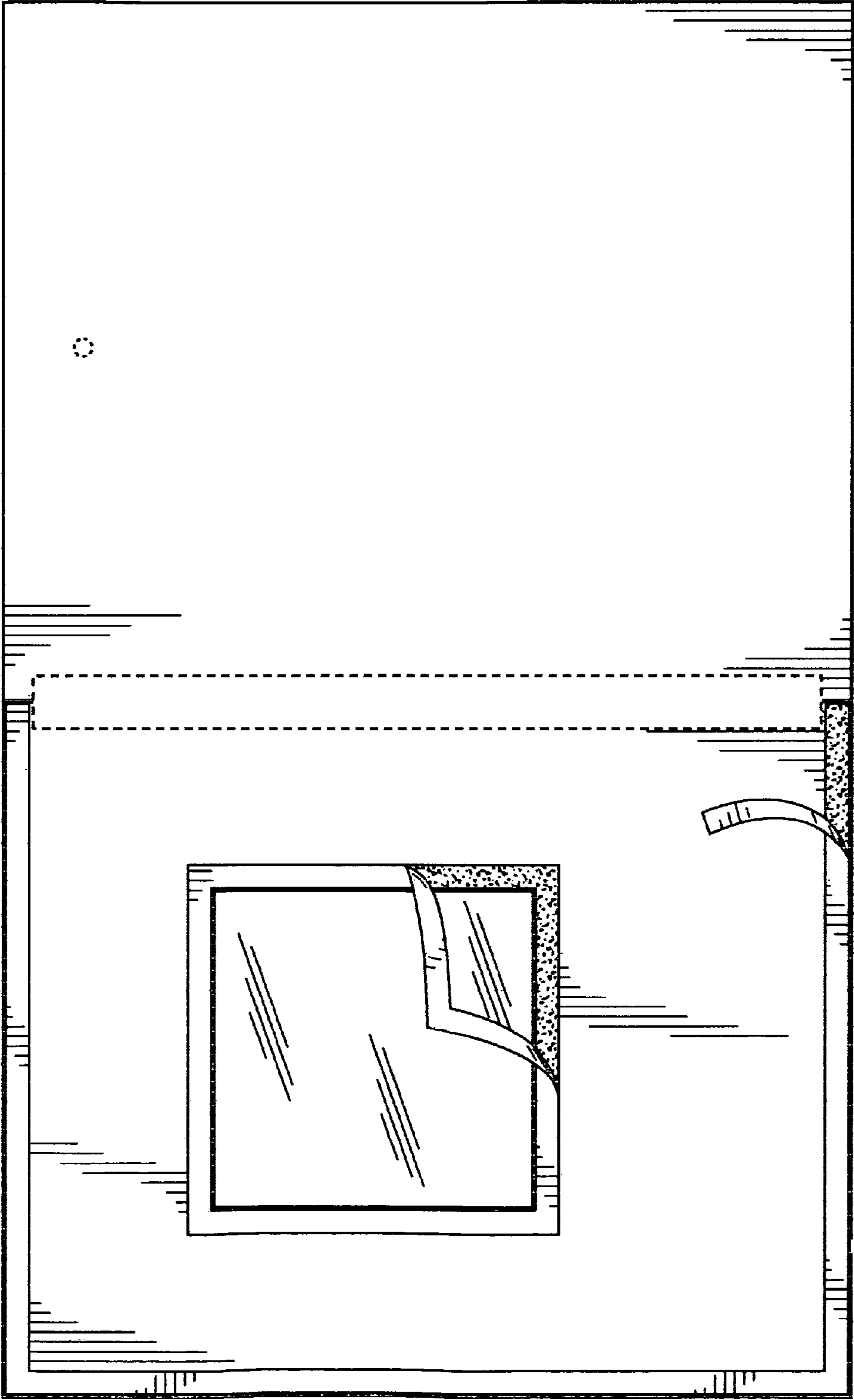
