(57) **CLAIM**

The ornamental design for a vehicle rallye seat, as shown and described.

DESCRIPTION

FIG. 1 is a left front perspective view of a new and ornamental design for a vehicle rallye seat;
FIG. 2 is a right side view thereof, and it being understood that the left side view is not needed as it is a mirror image of the right side view;
FIG. 3 is a front view thereof;
FIG. 4 is a back view thereof; and,
FIG. 5 is a top plan view thereof.

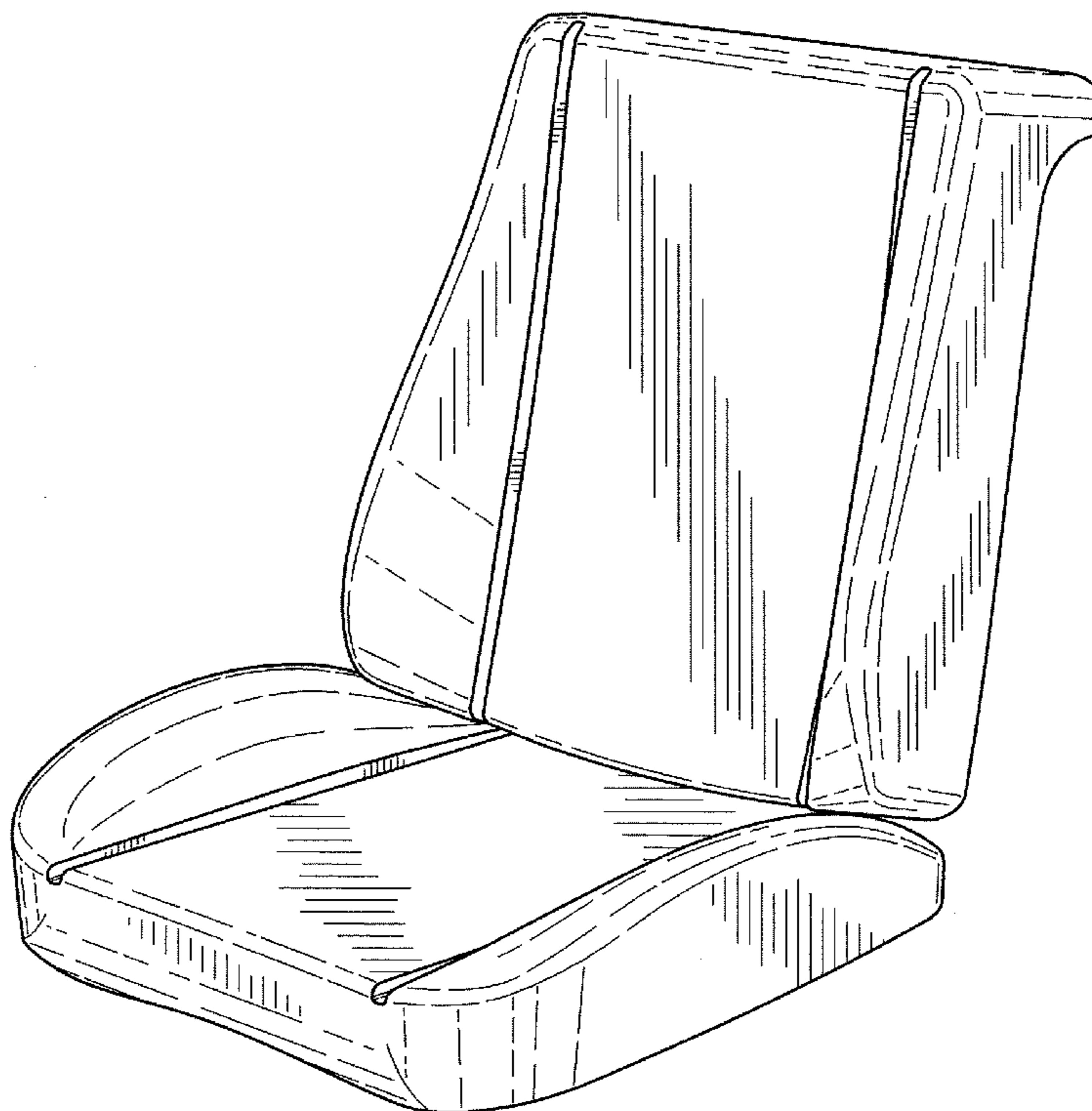

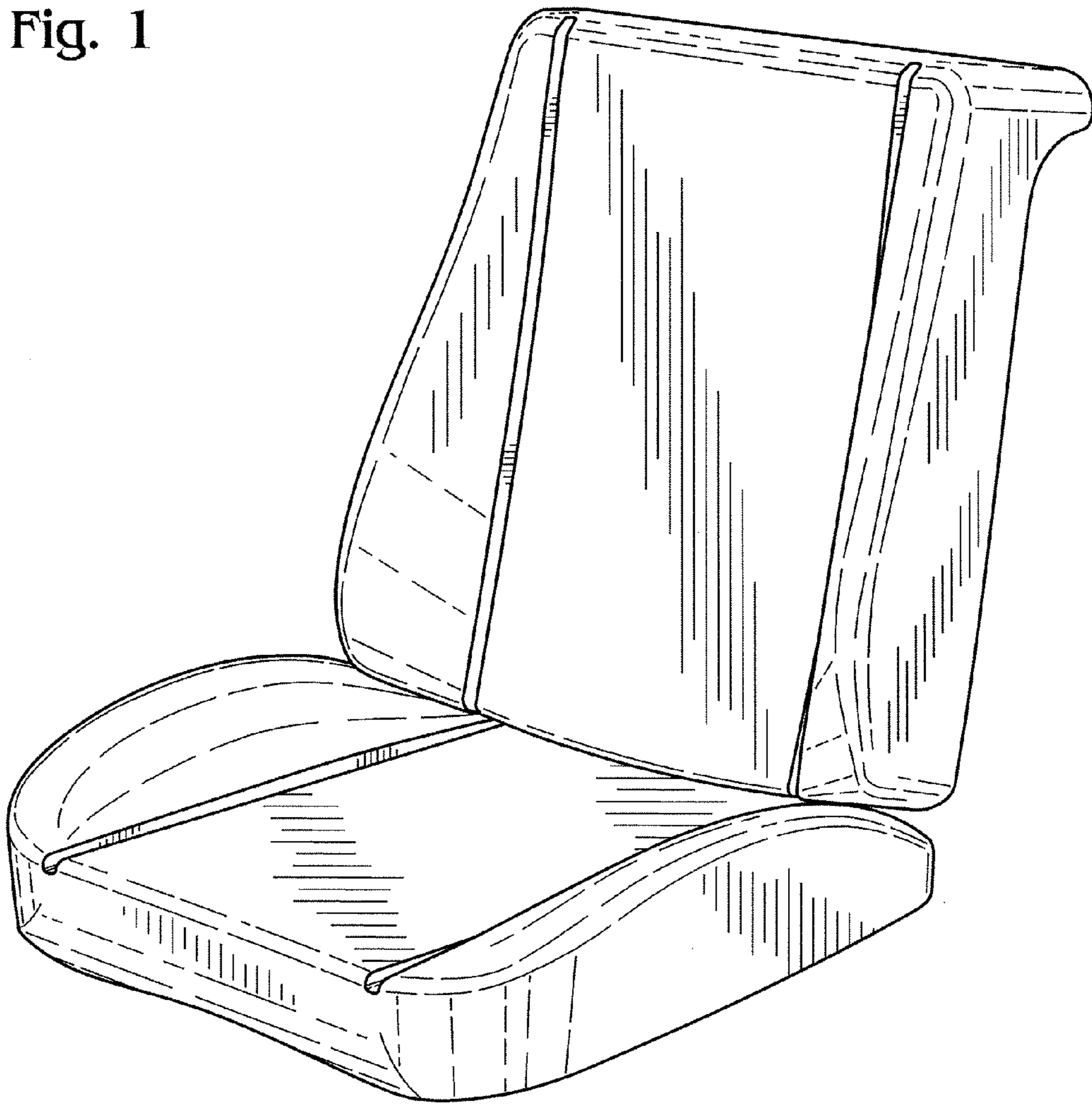

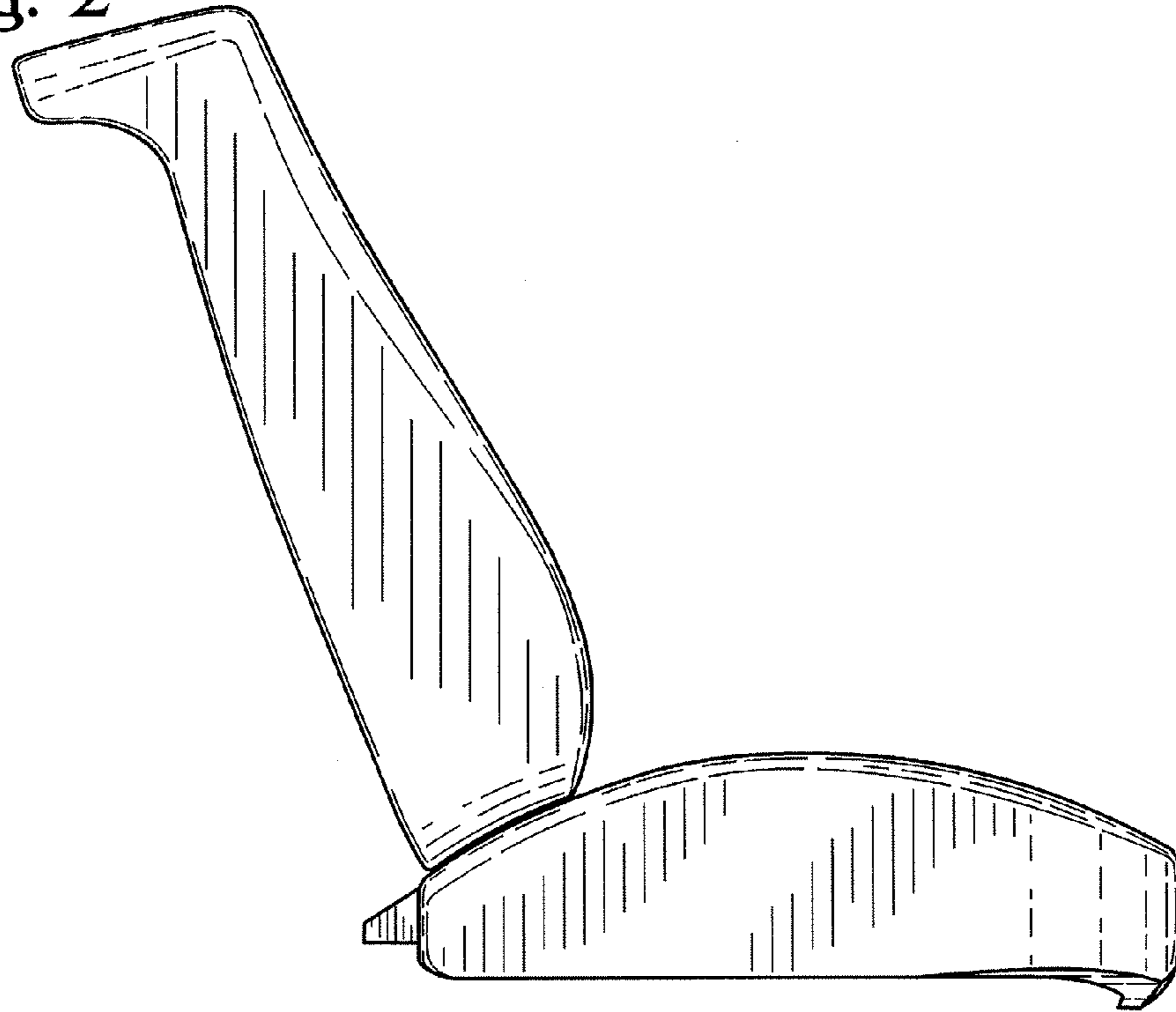

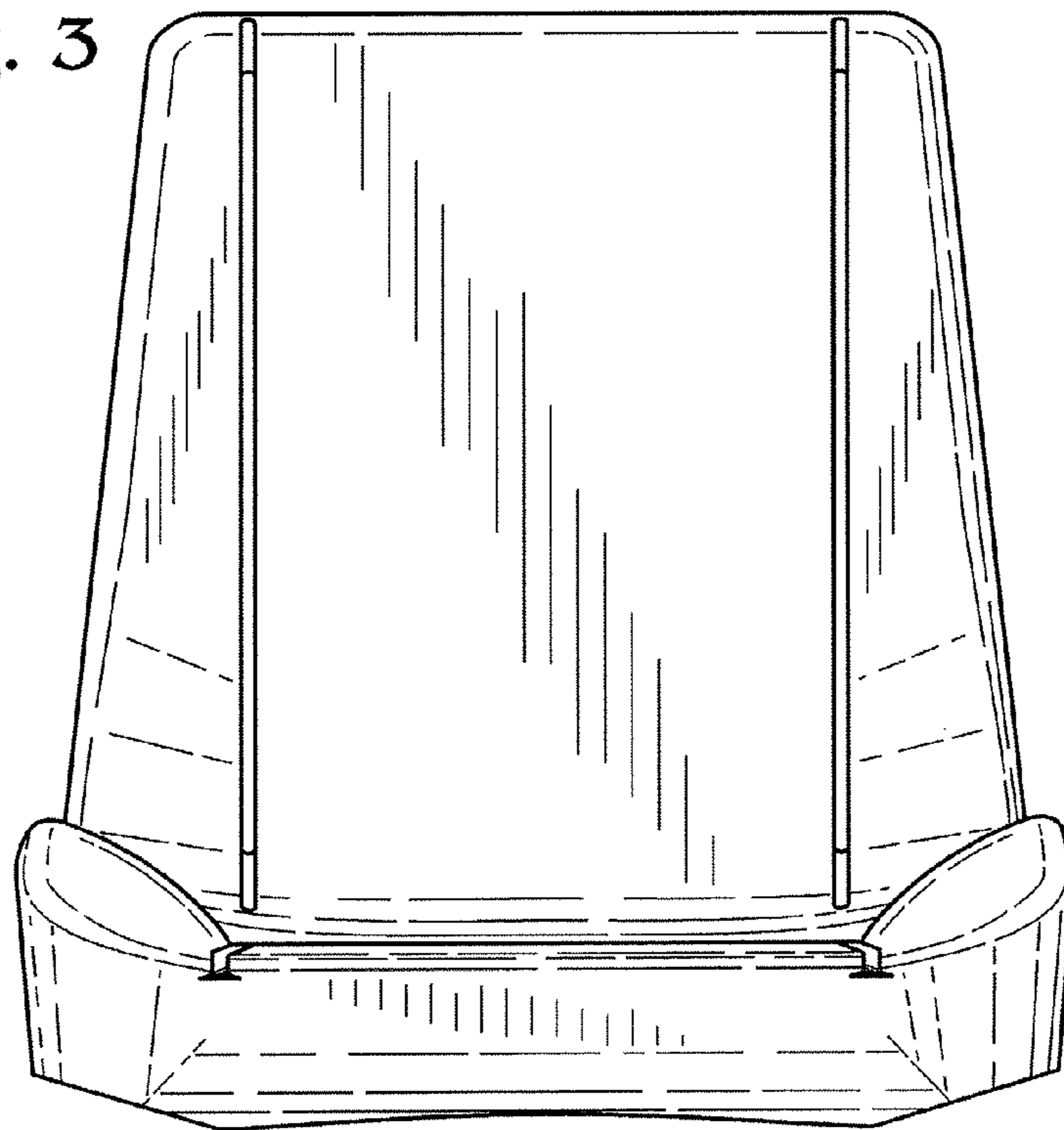

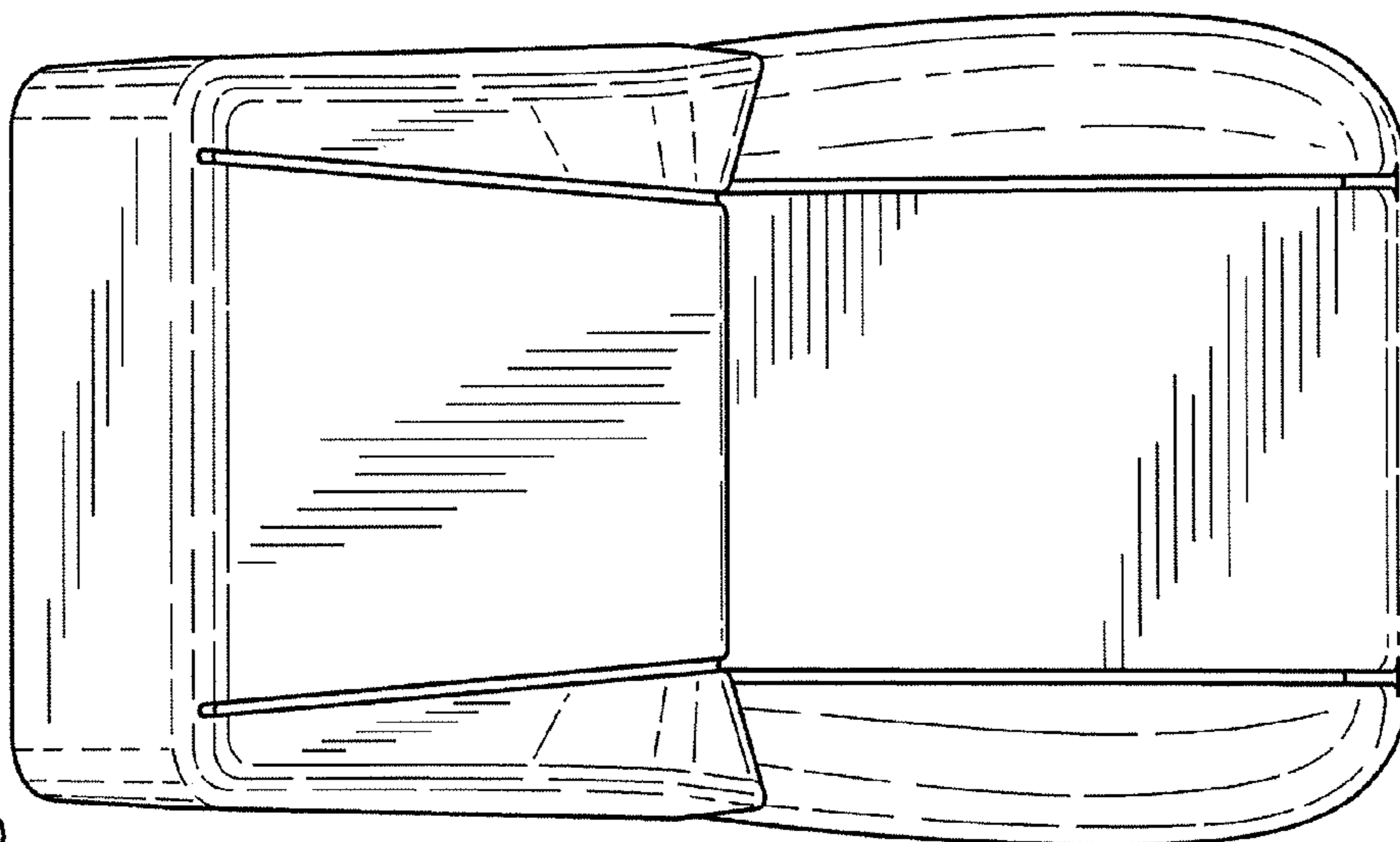
