The ornamental design for a chair, as shown and described.

DESCRIPTION

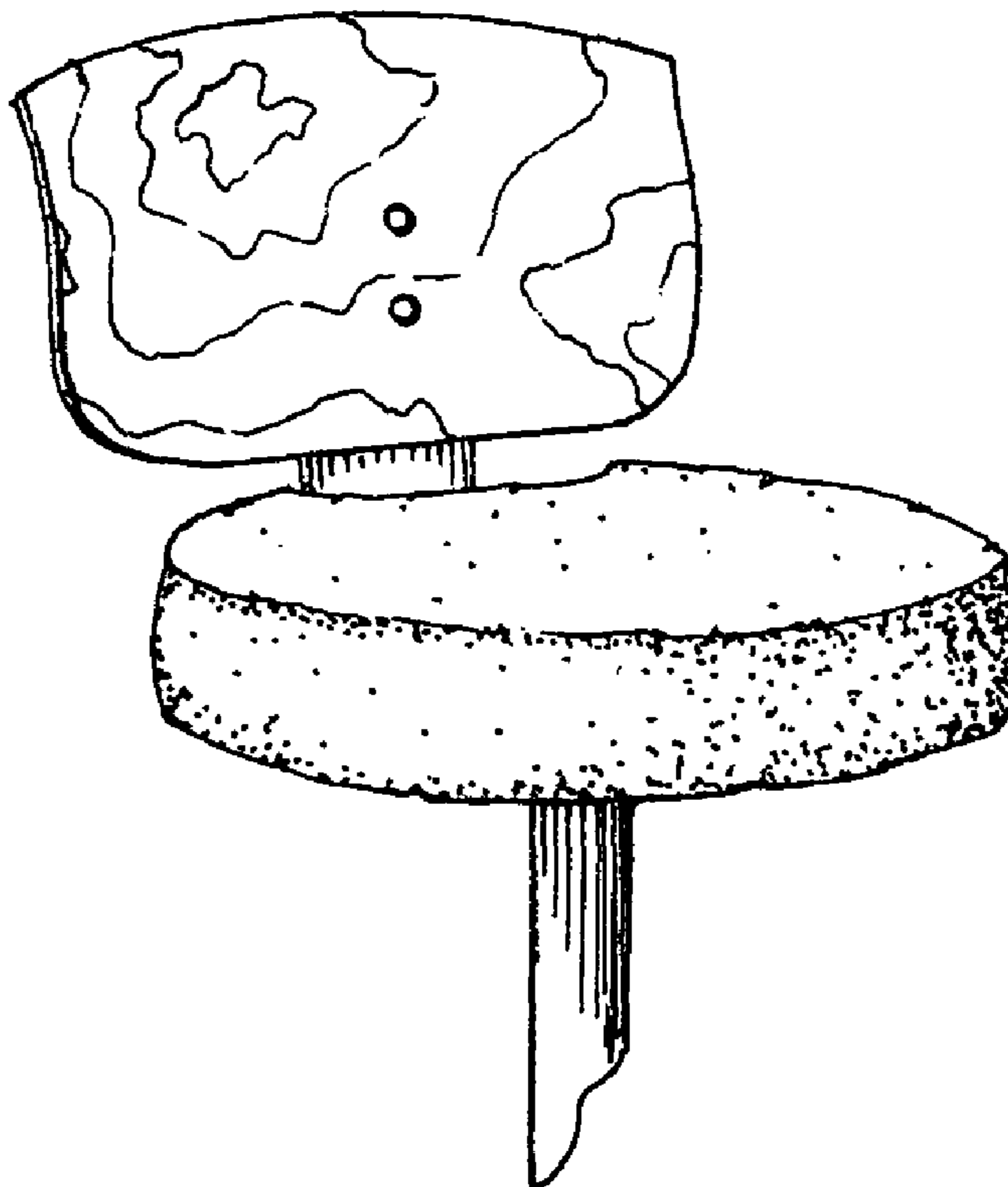
FIG. 1 is a right front perspective view of a pedestal mounted chair showing my new design. A left front perspective is omitted because it is a mirror image to the right front perspective view; and,

FIG. 2 is a right rear perspective view thereof. A left rear perspective is omitted because it is a mirror image to the left rear perspective view.

A bottom view of the claimed design is unornamented, and thus, has been omitted.

Portions of the chair not shown, such as a pedestal base and casters, form no part of the claimed design.

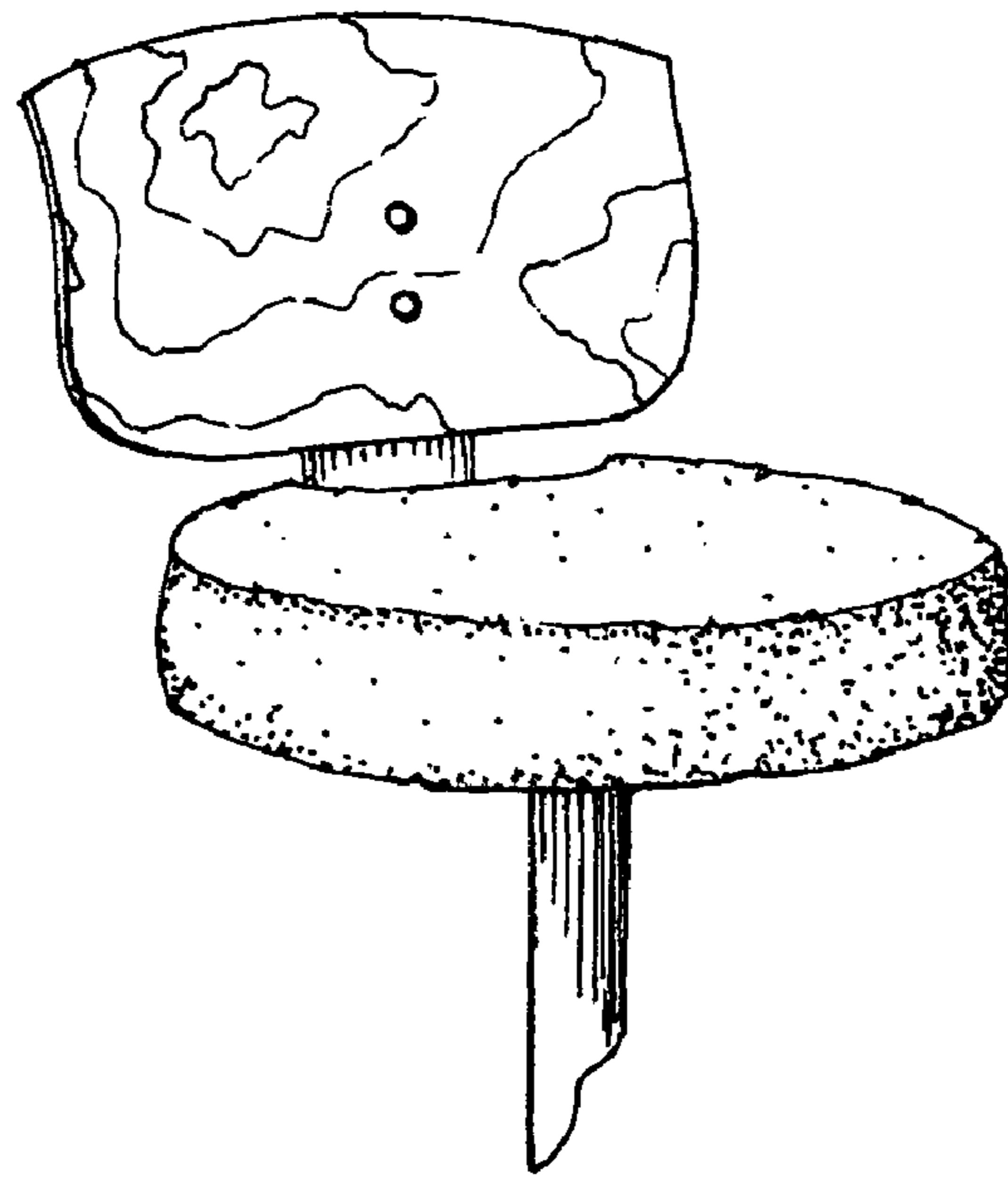

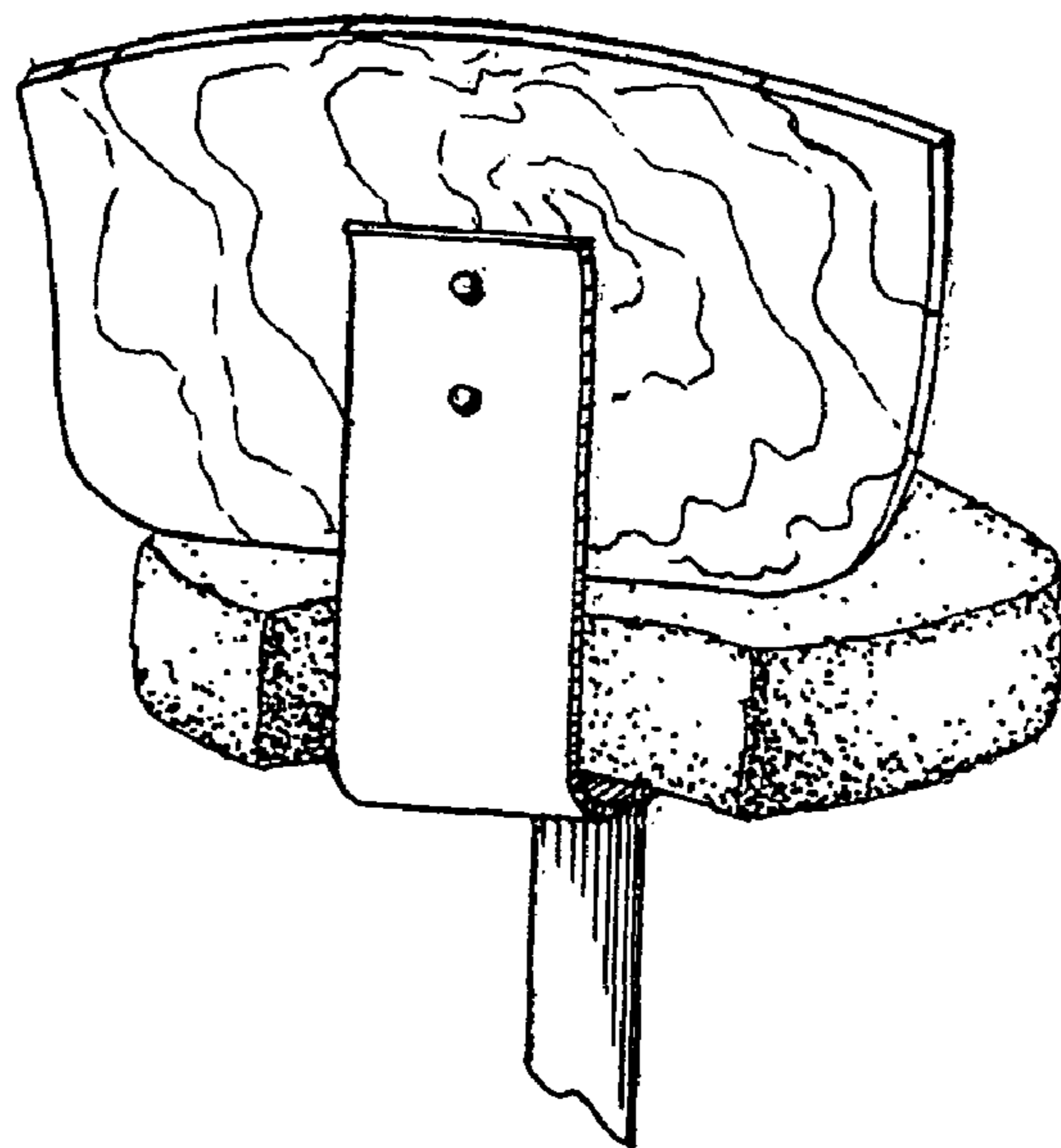
