(57) **CLAIM**

The ornamental design for bed covering set, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the head end of the bed coverings in accordance with the design;

FIG. 2 is a perspective view thereof from proximate the foot end;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a left side elevation view thereof;

FIG. 6 is a right side elevation view thereof;

FIG. 7 is a head end elevation view thereof;

FIG. 8 is a foot end elevation view thereof;

FIG. 9 is a head end perspective view of the design, in a condition of having the bed coverings turned down;

FIG. 25 is a right side elevation view thereof;

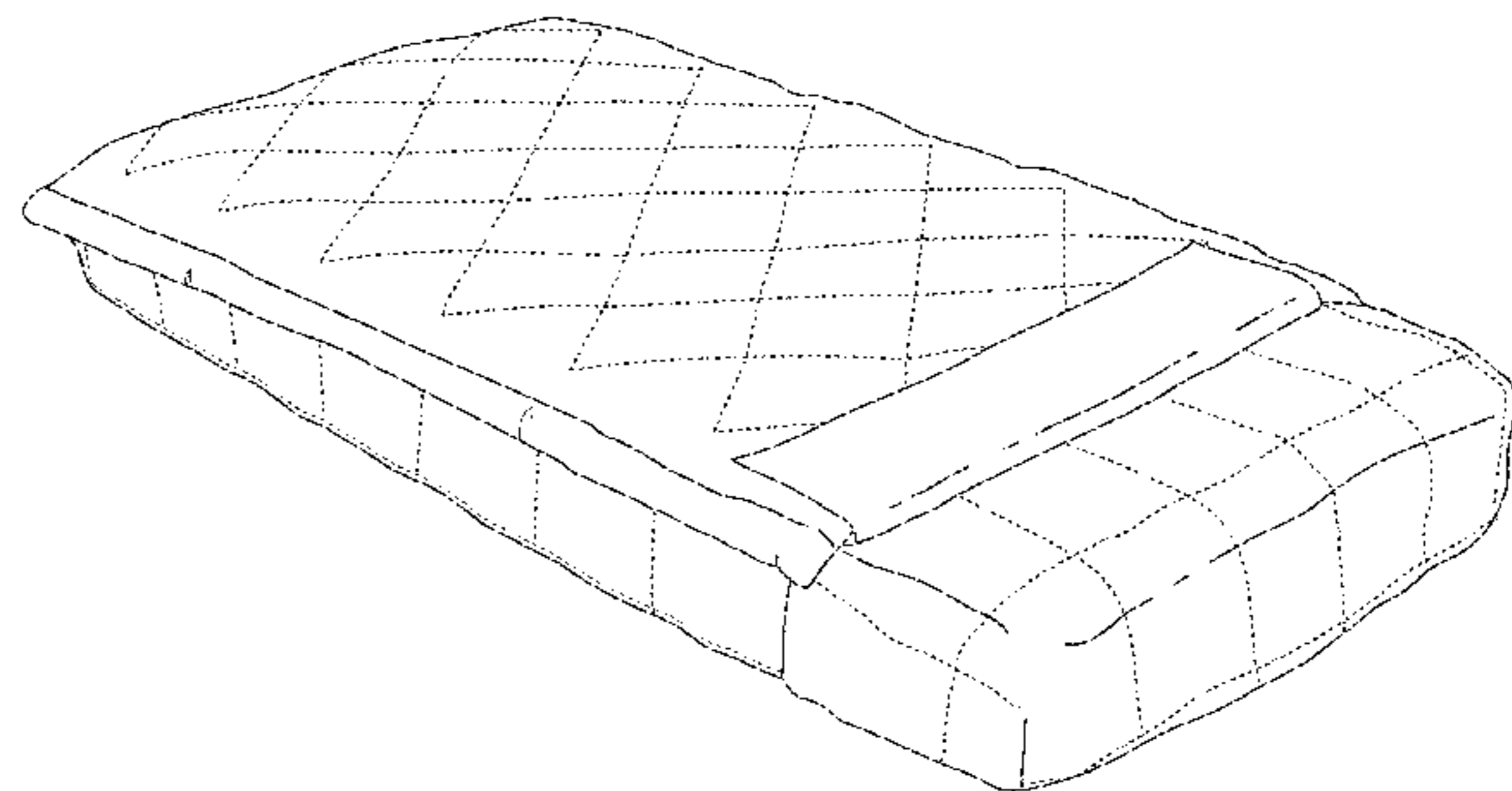
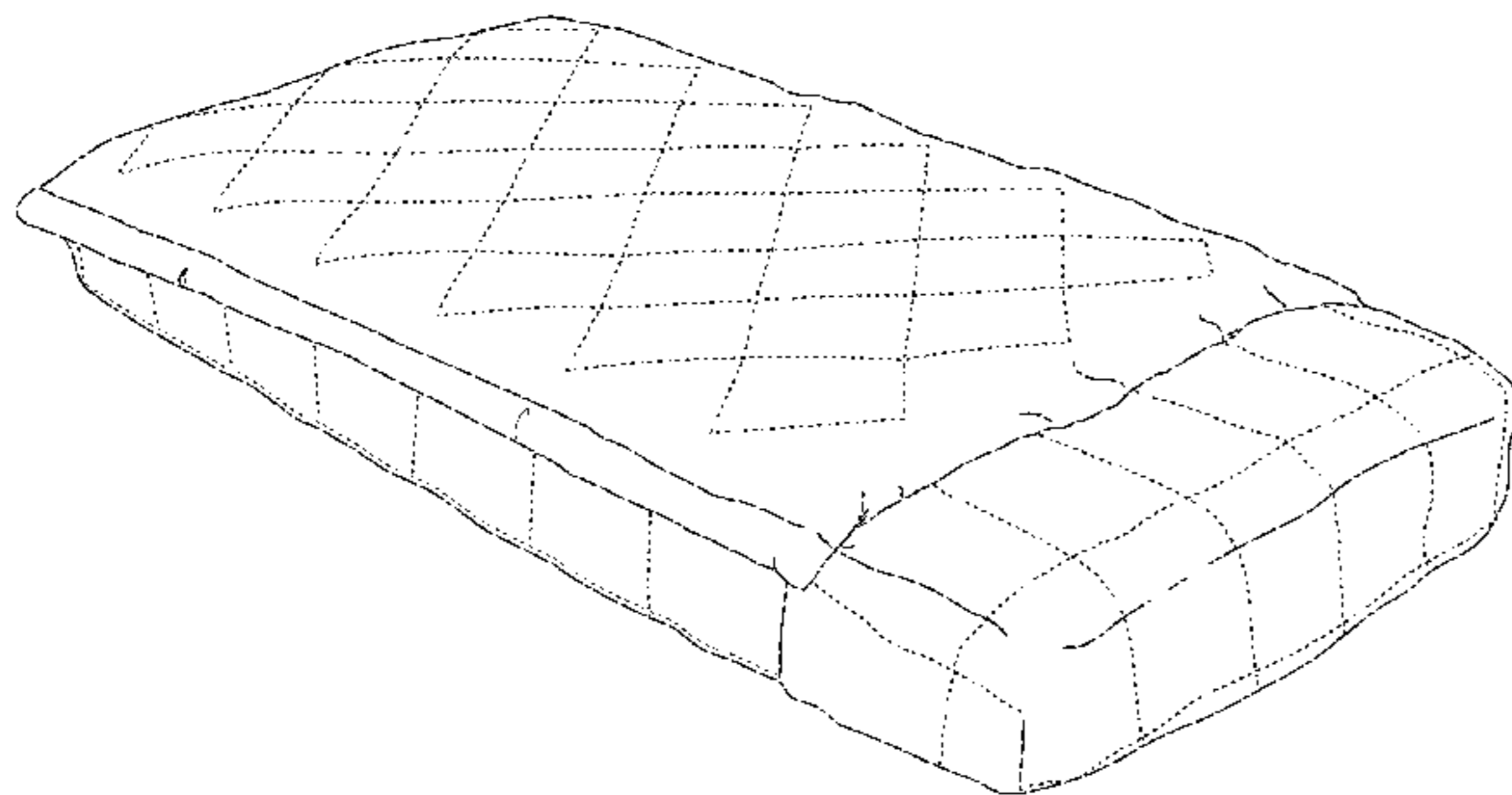

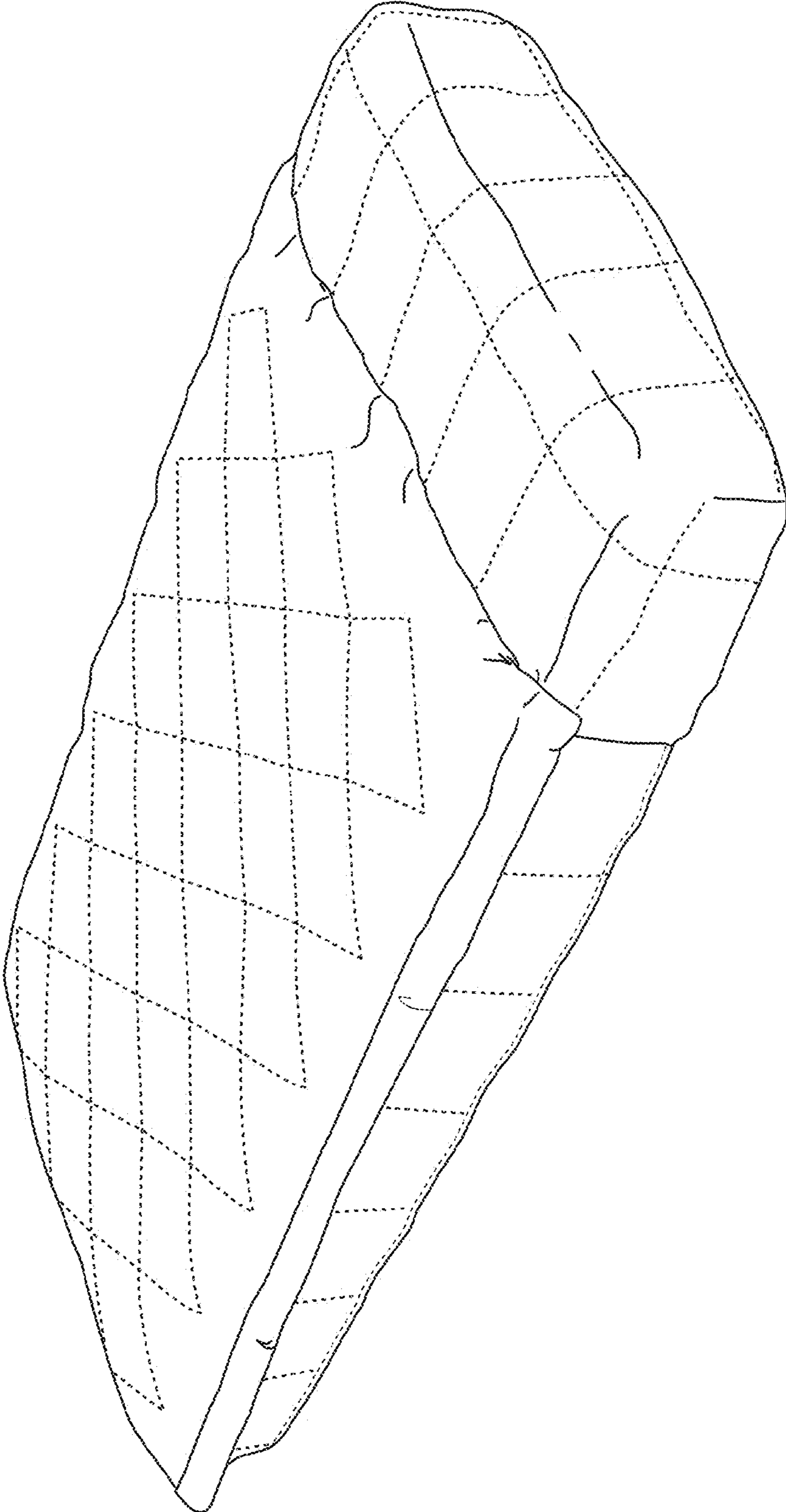

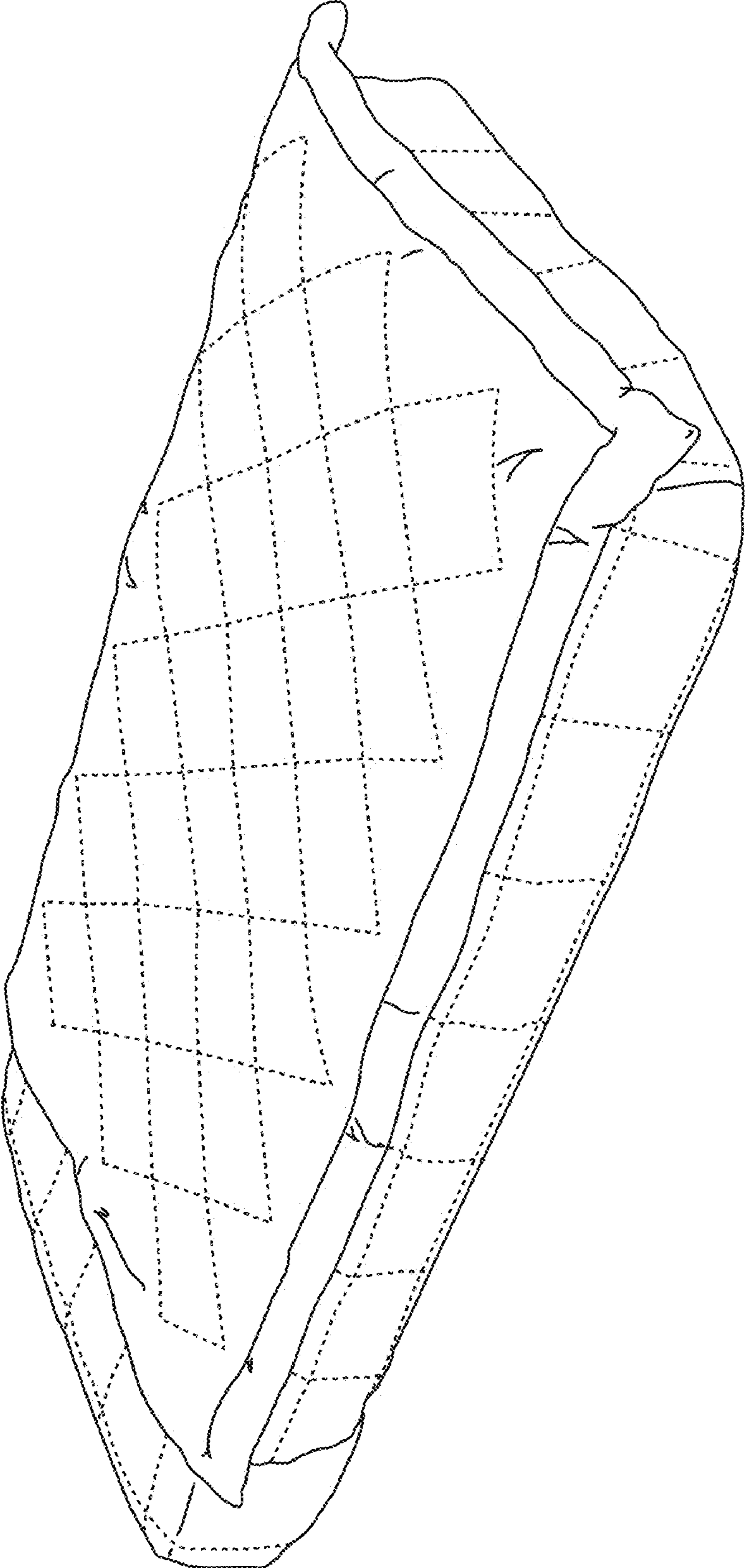

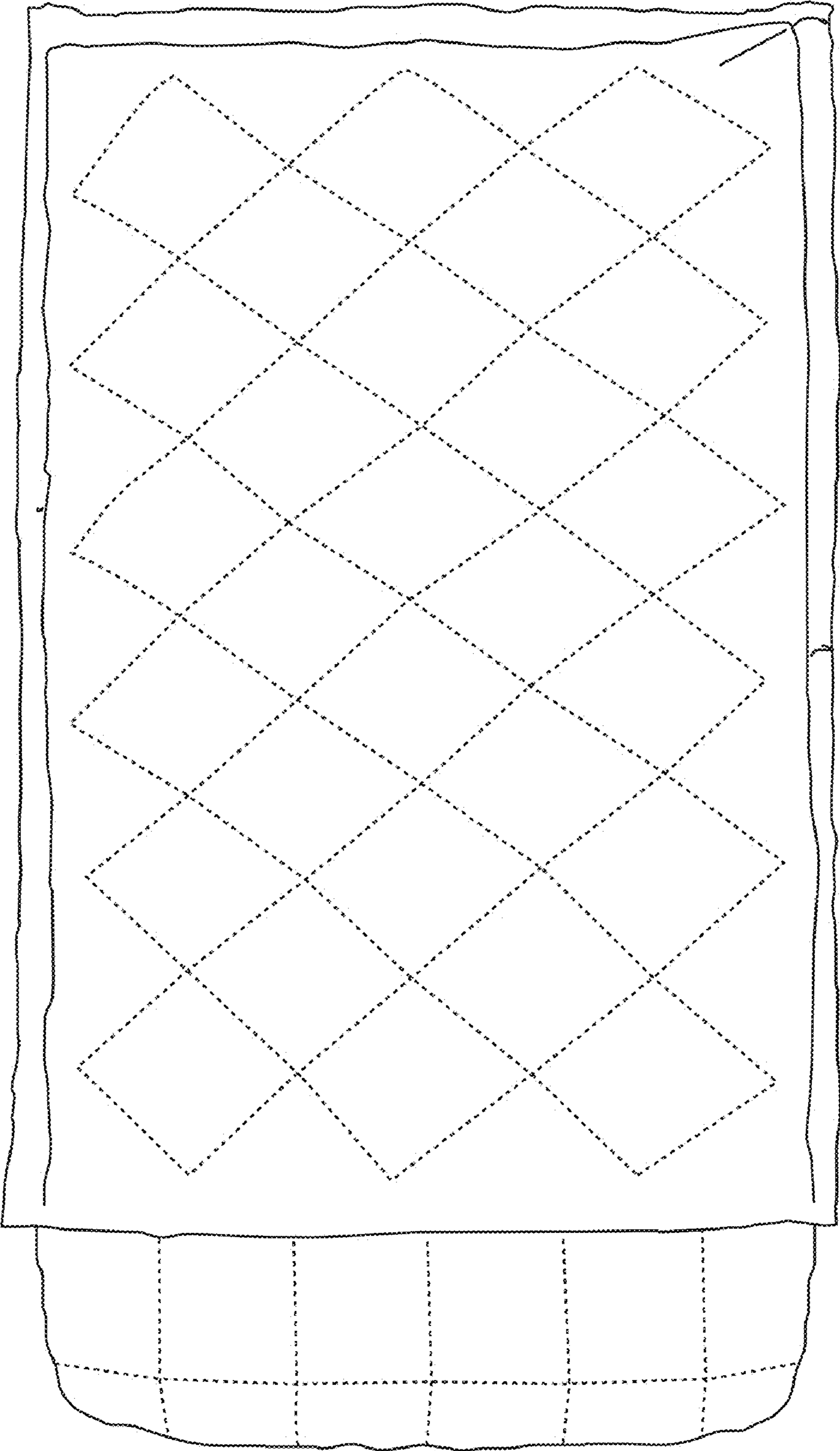

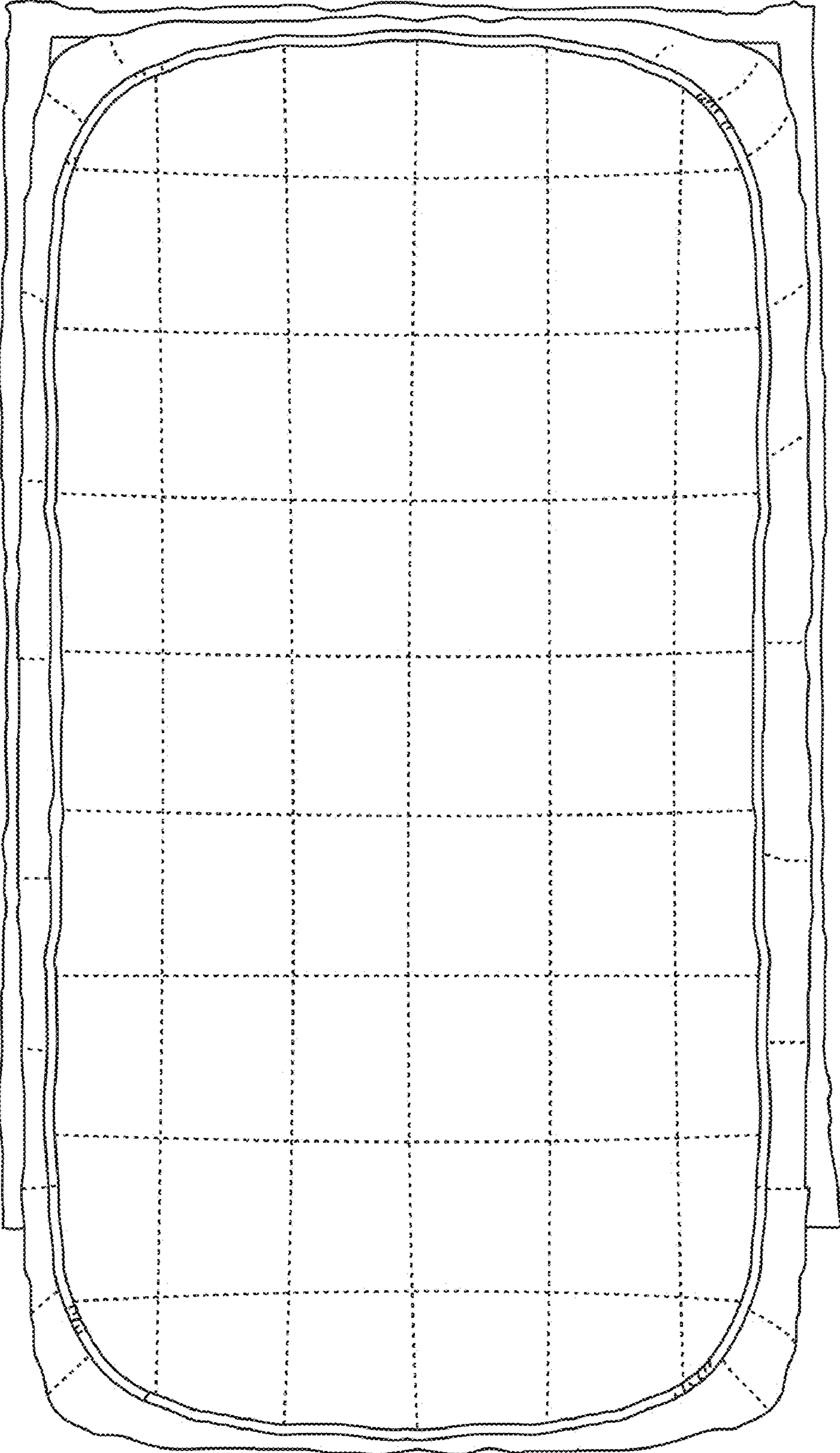

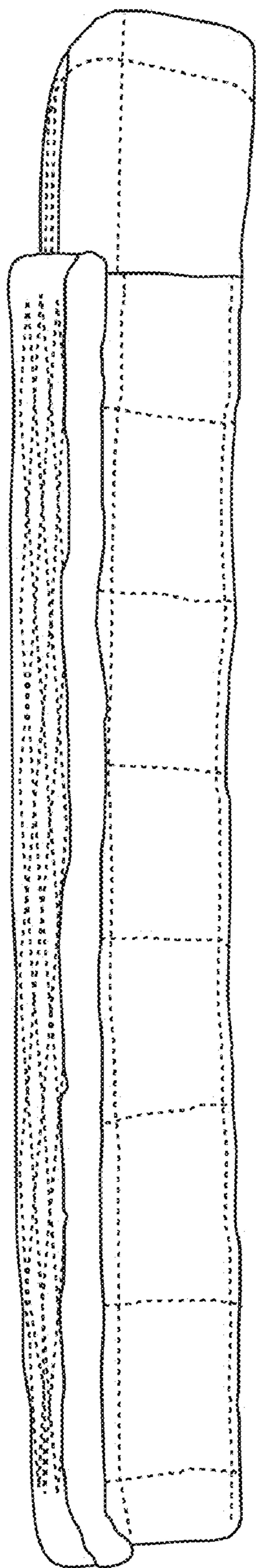

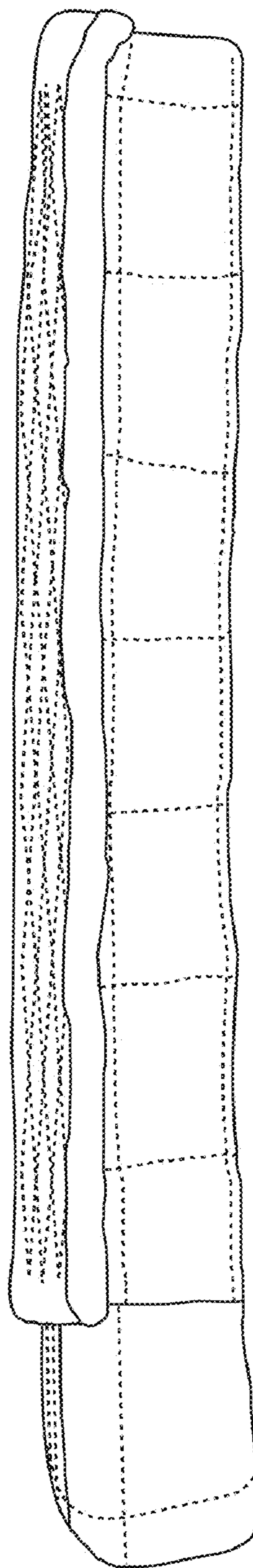

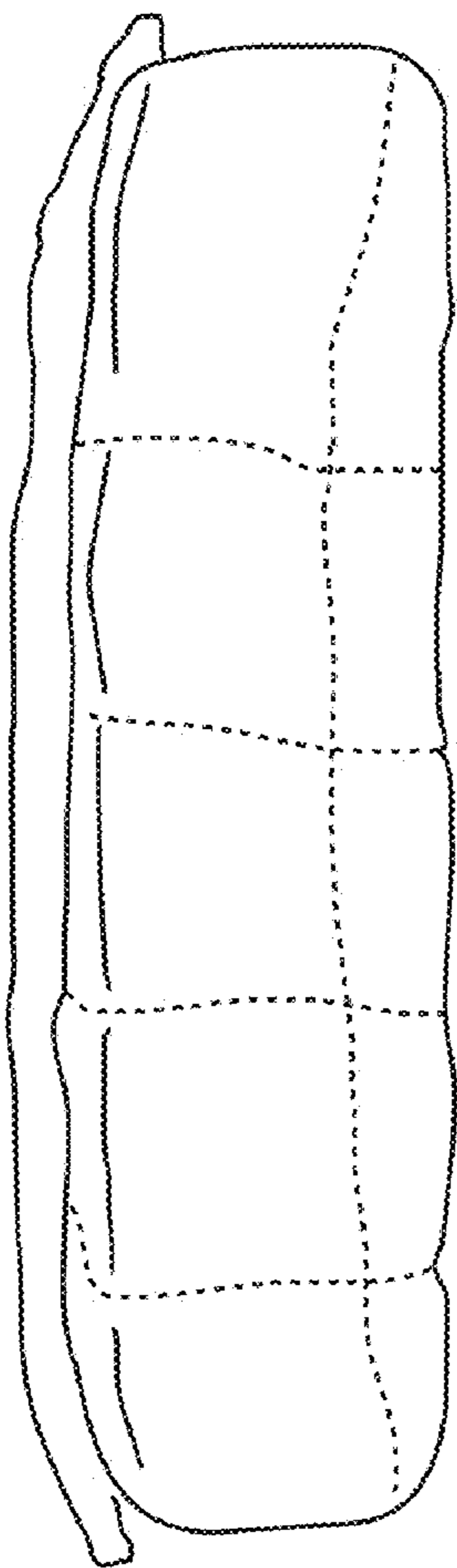

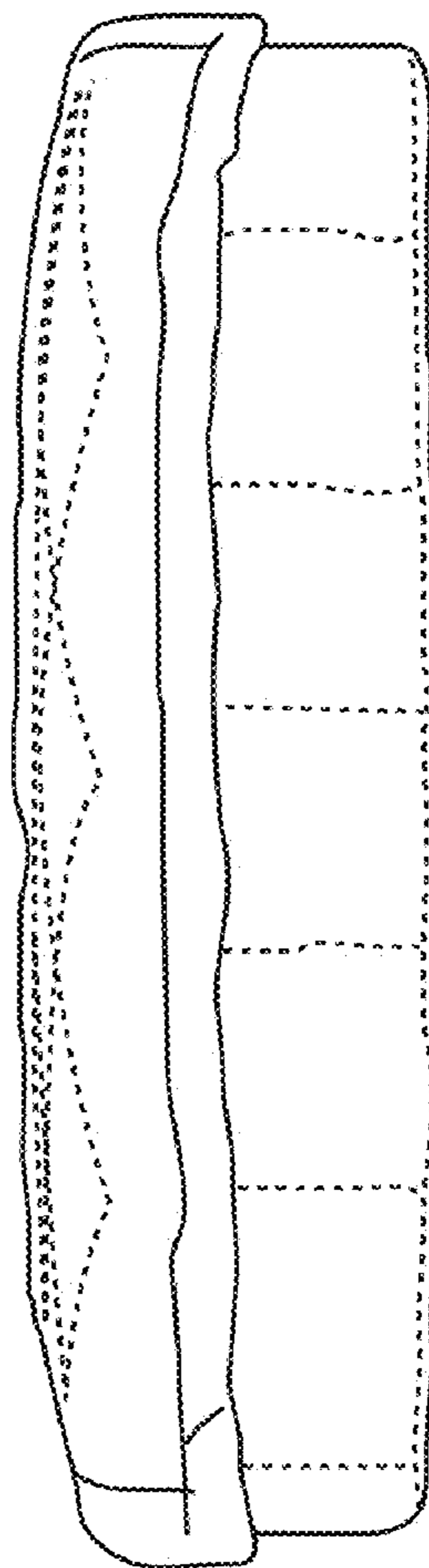

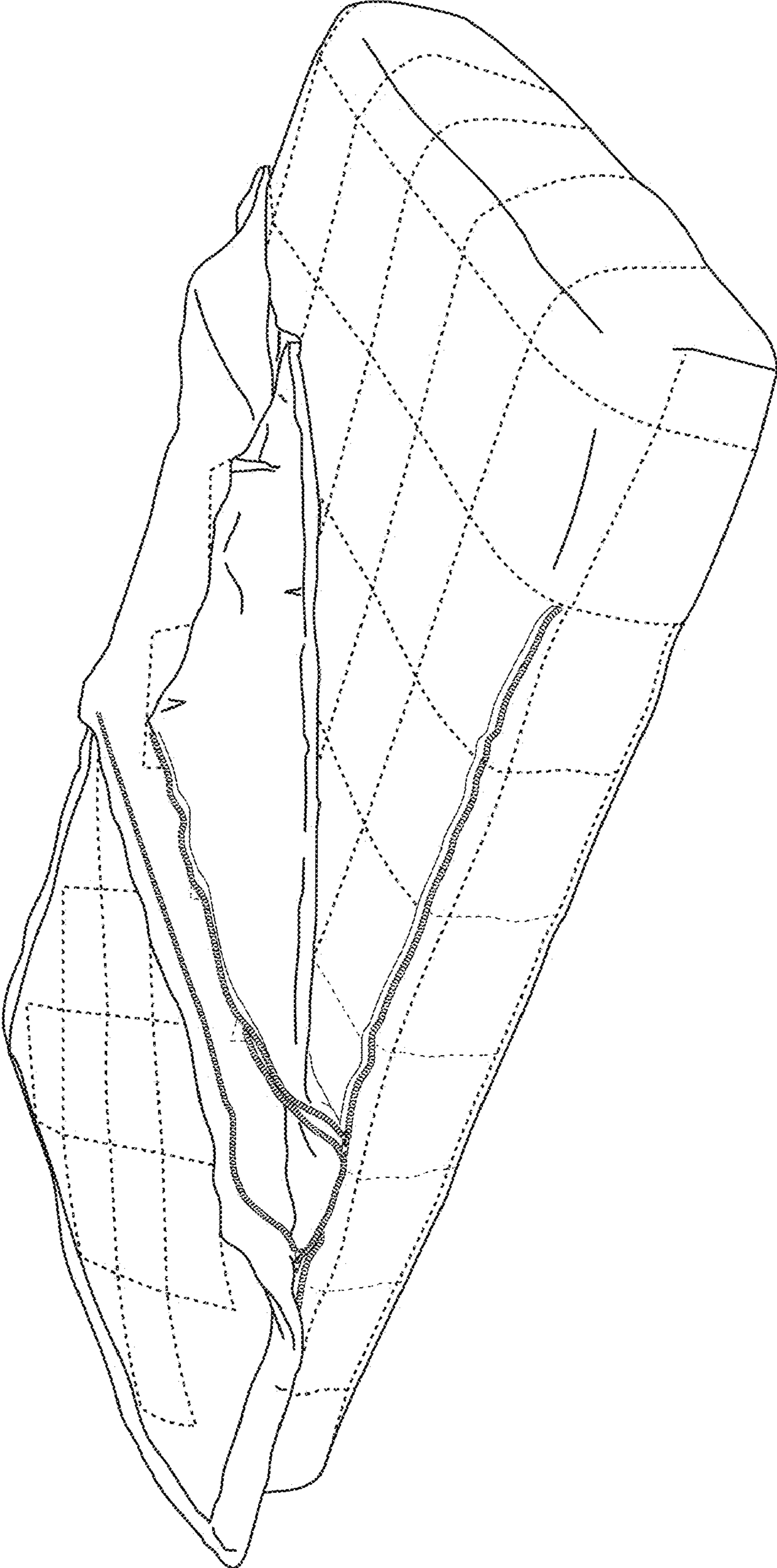

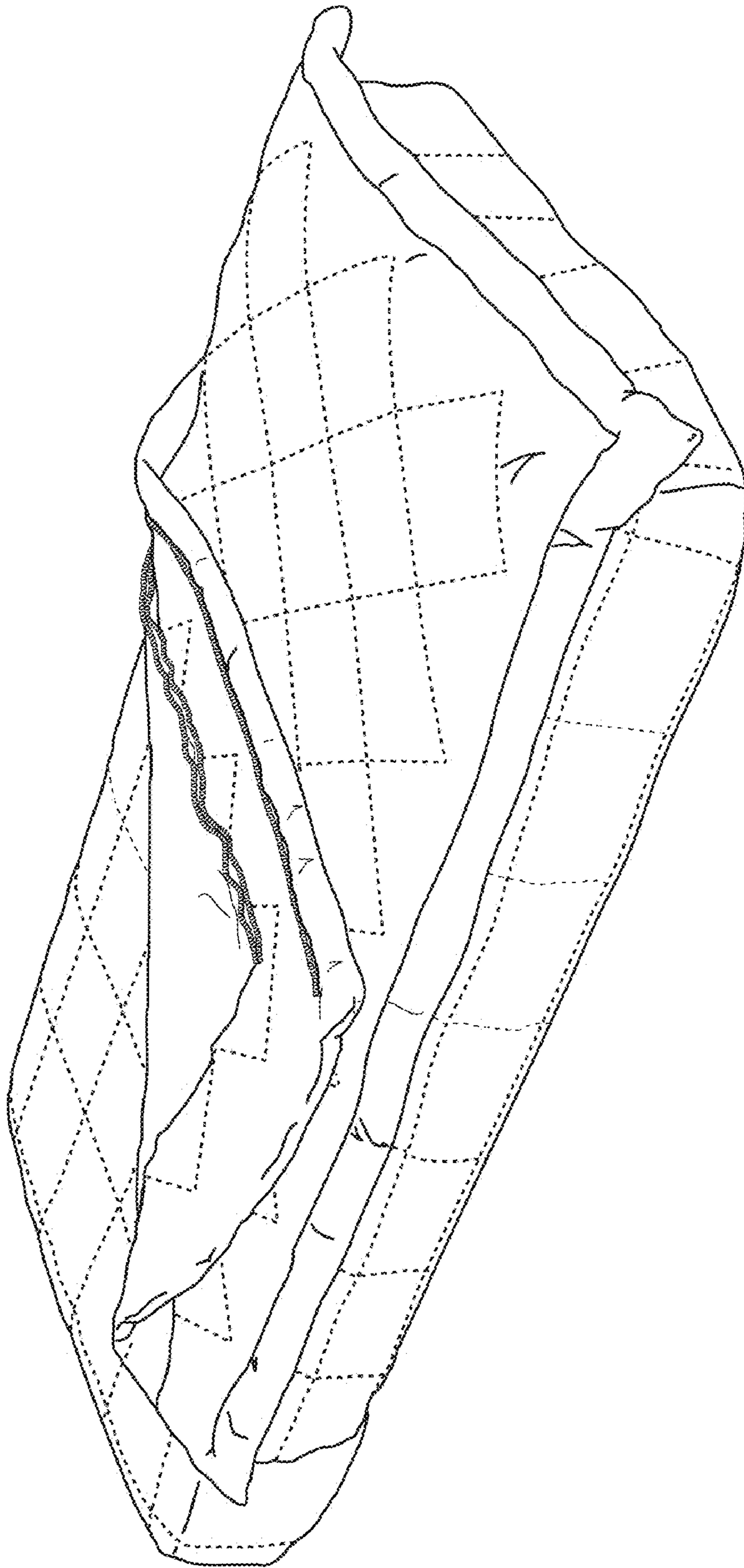

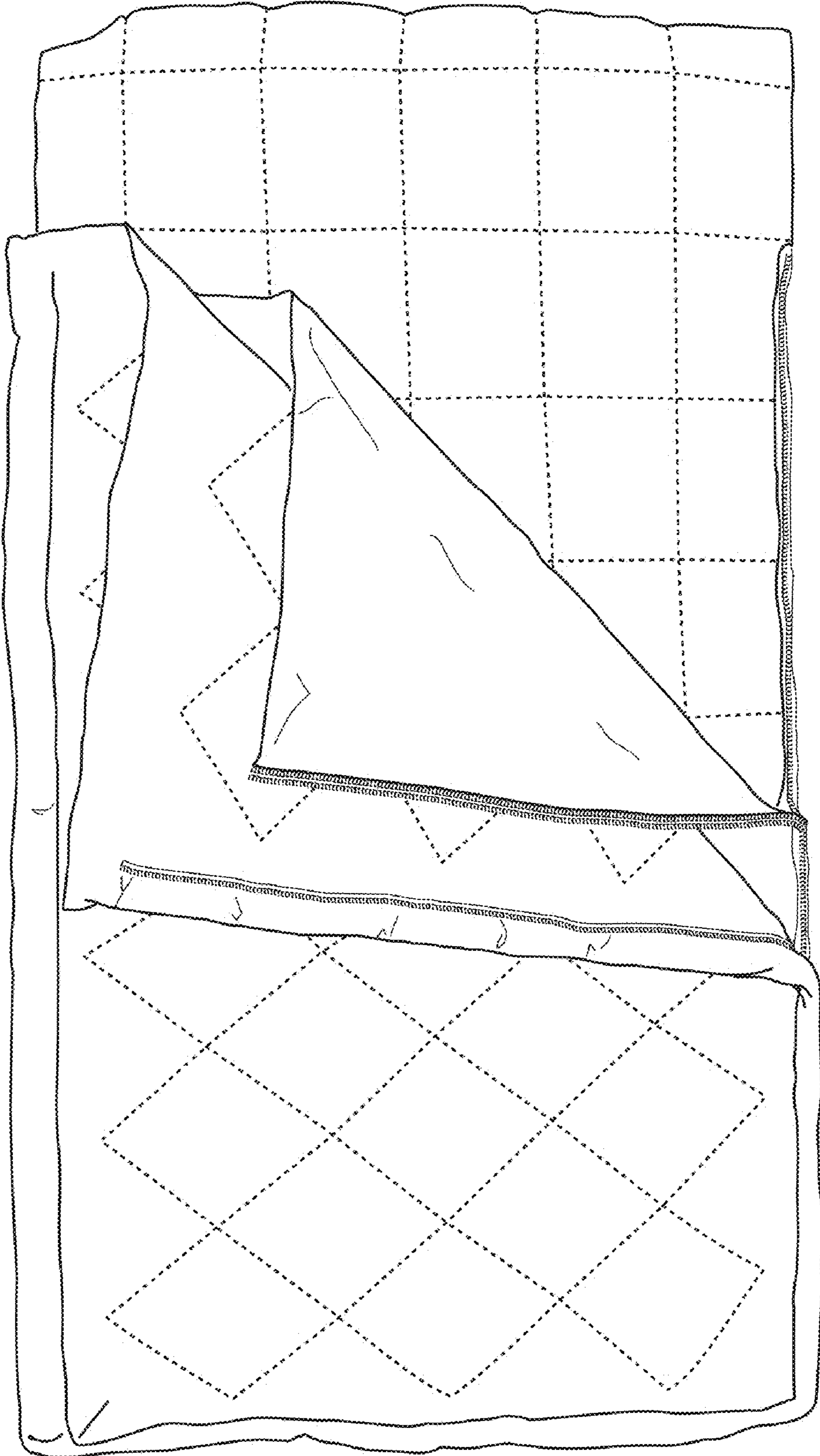

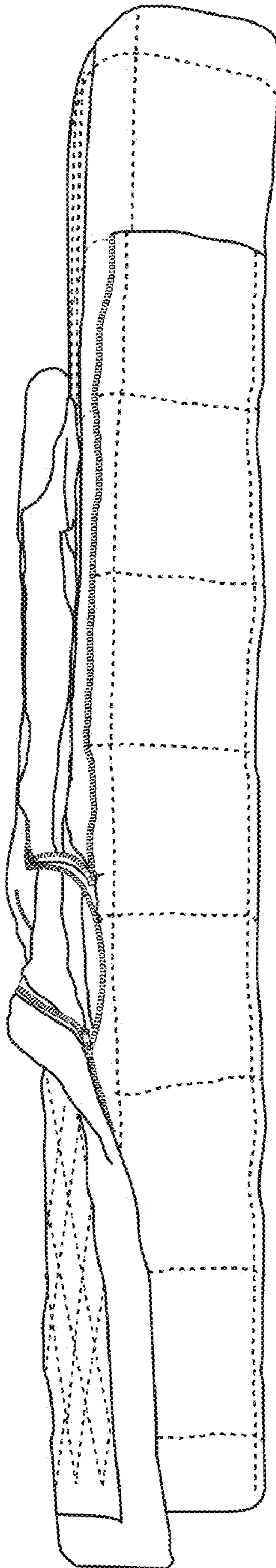

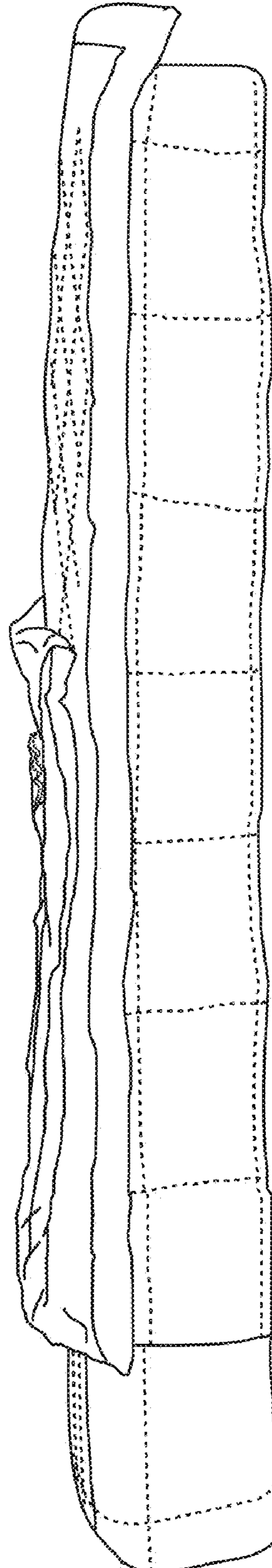

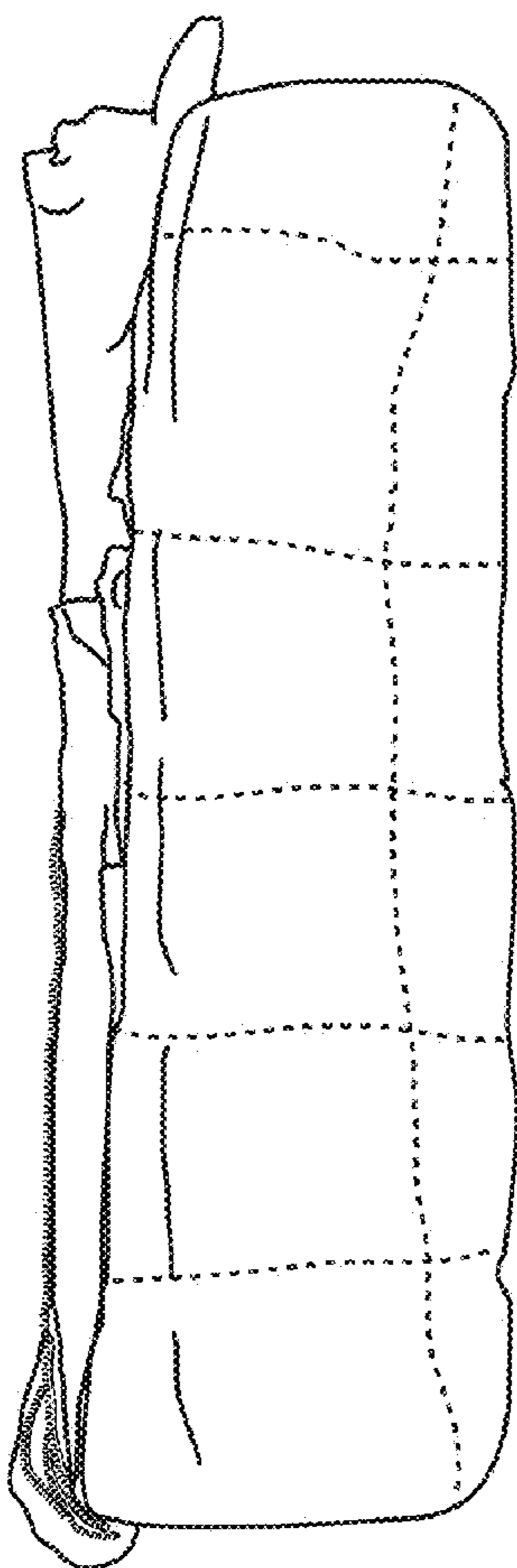

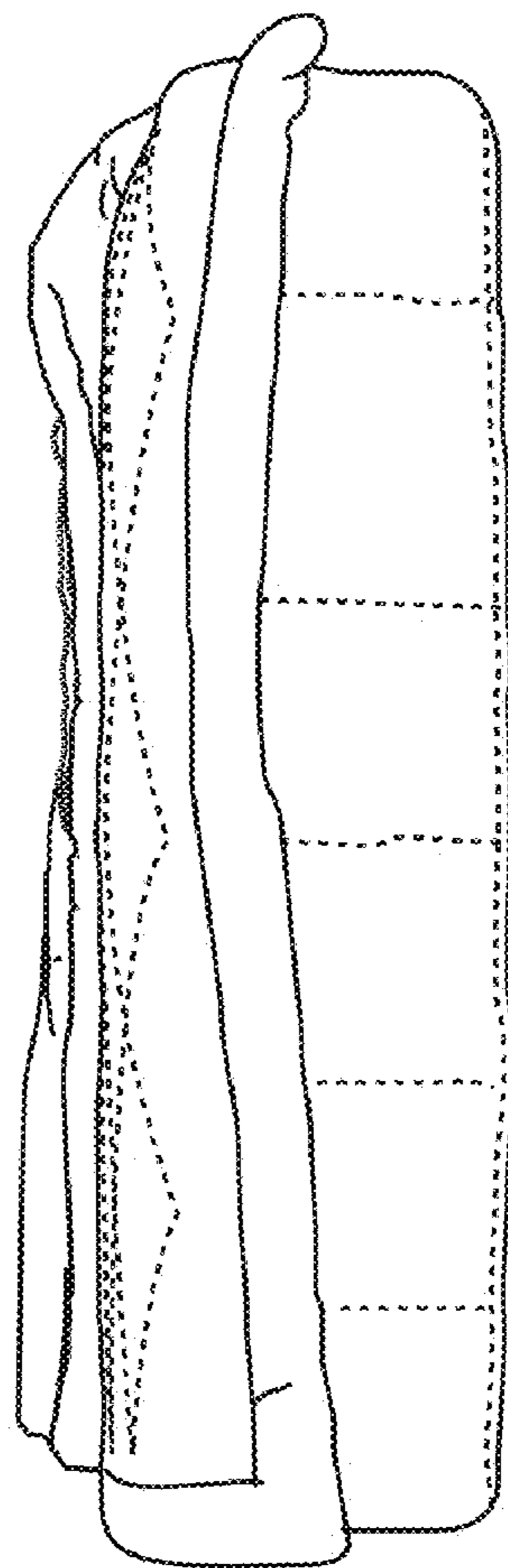

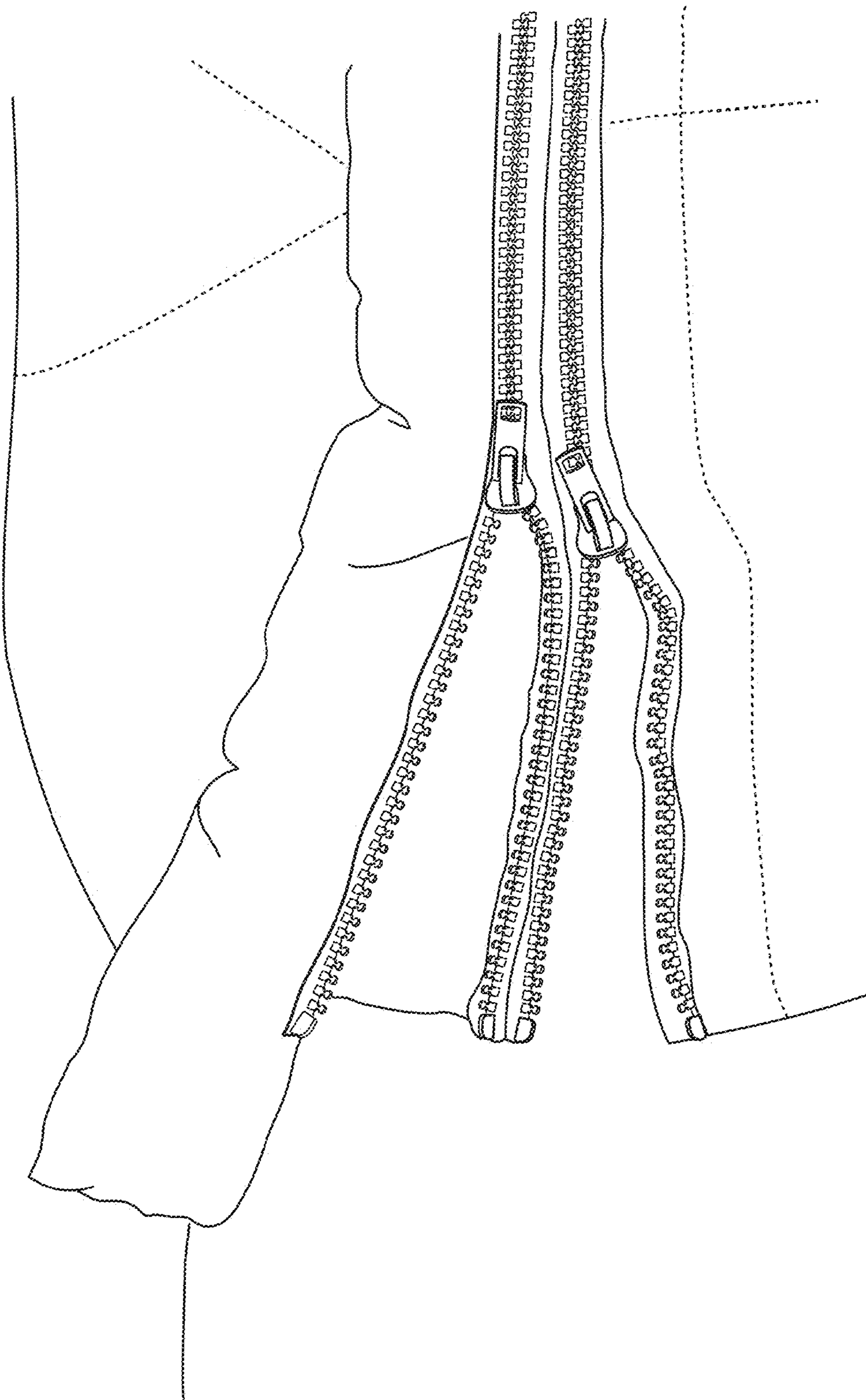

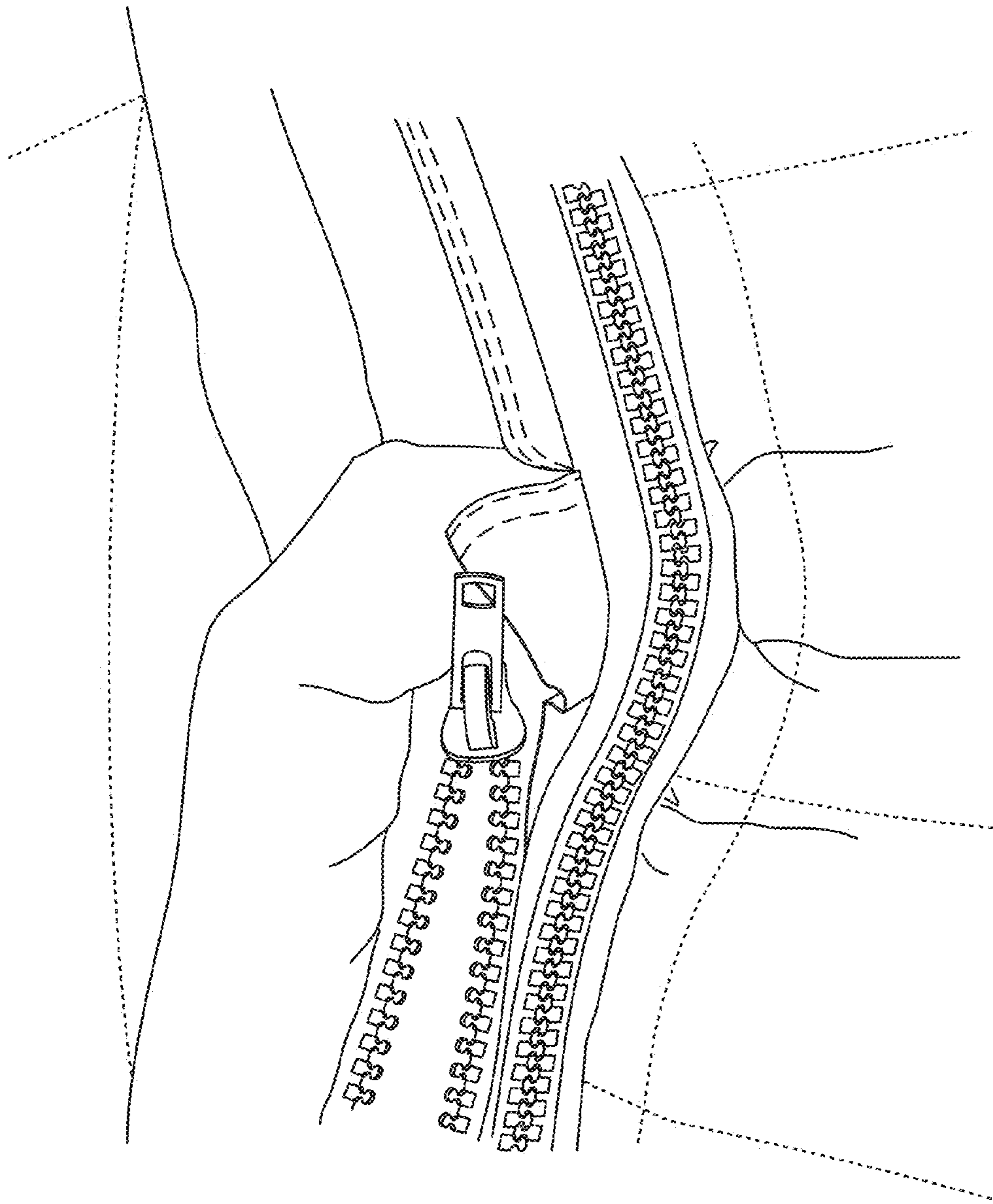

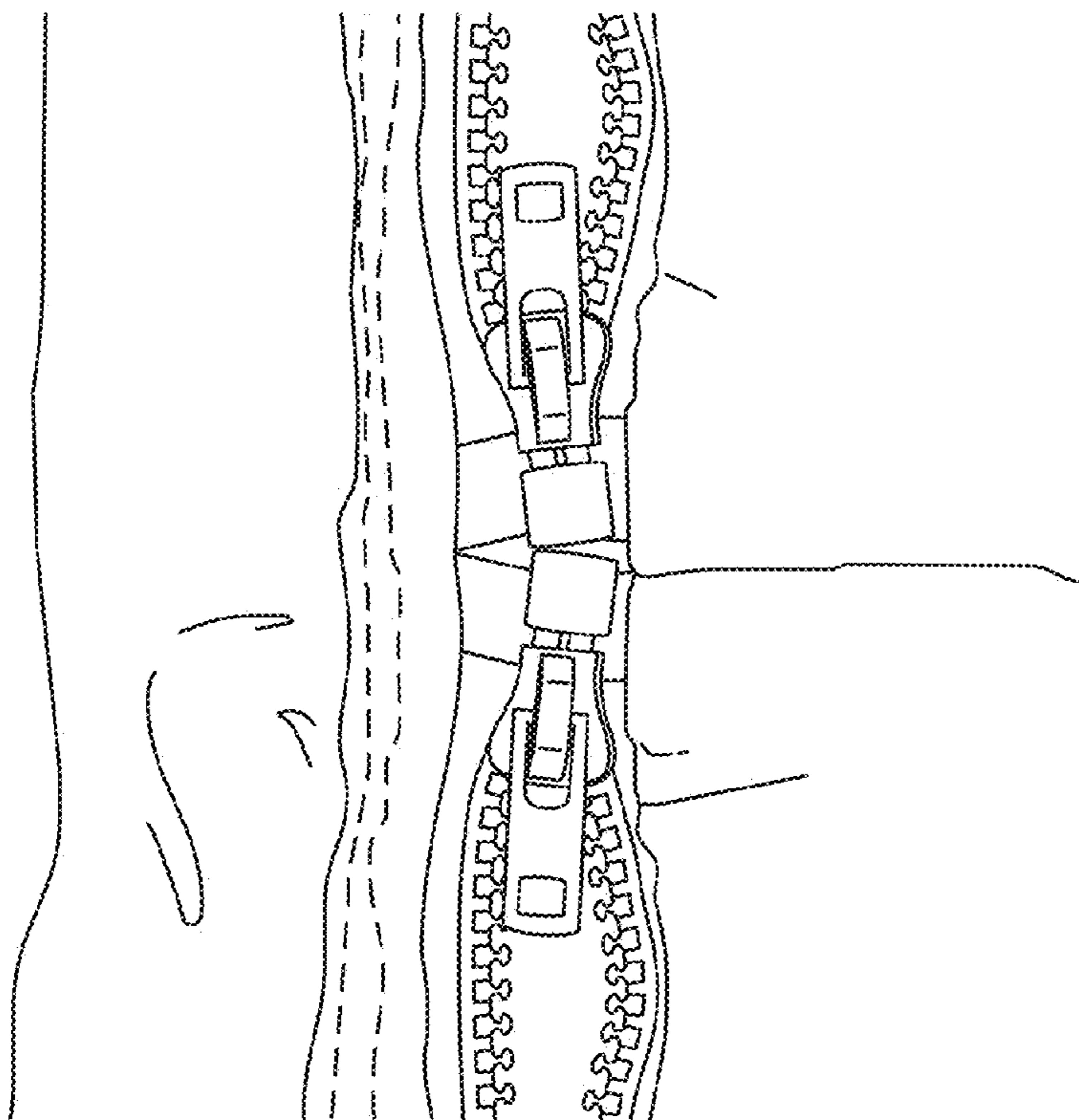

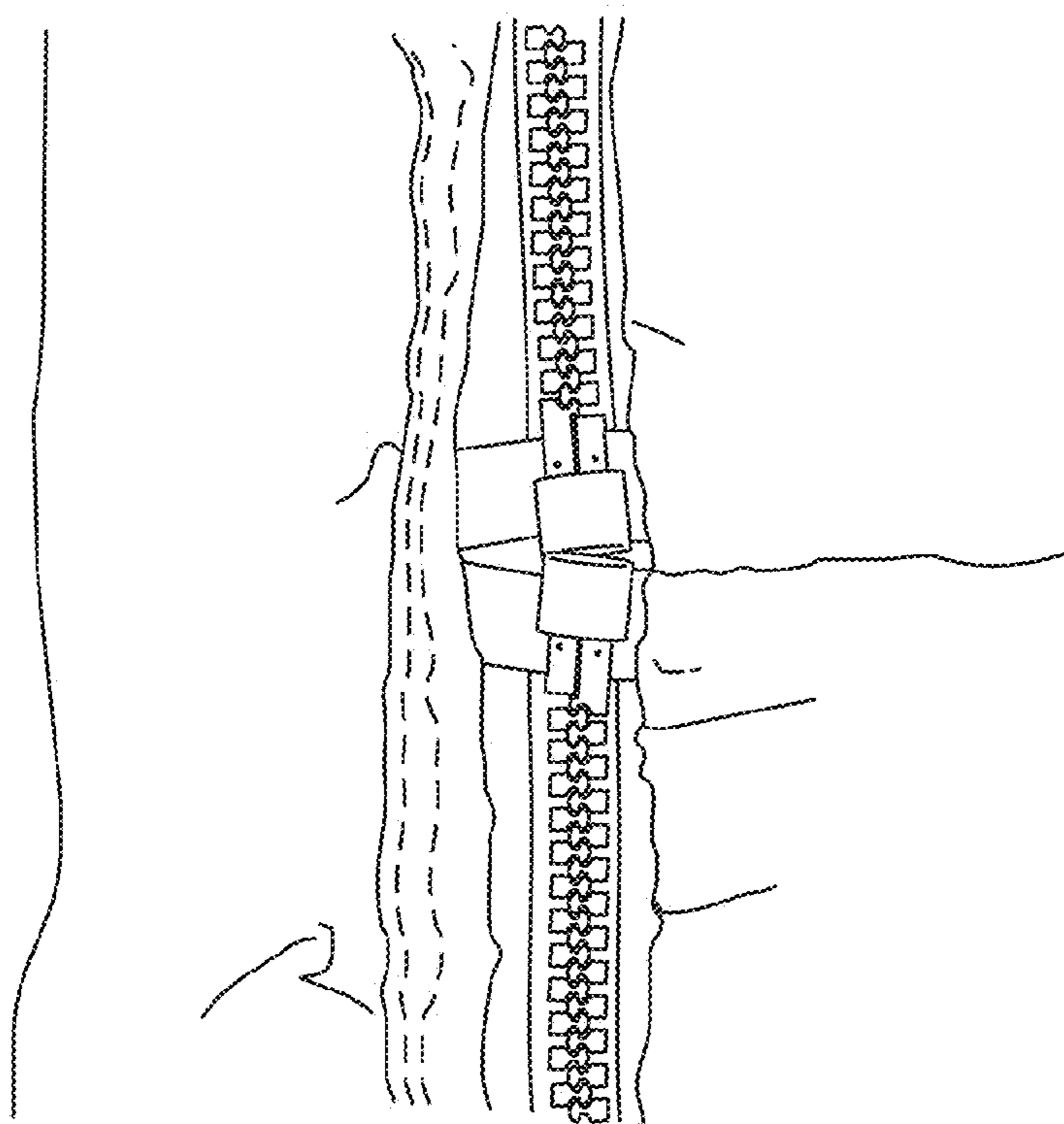

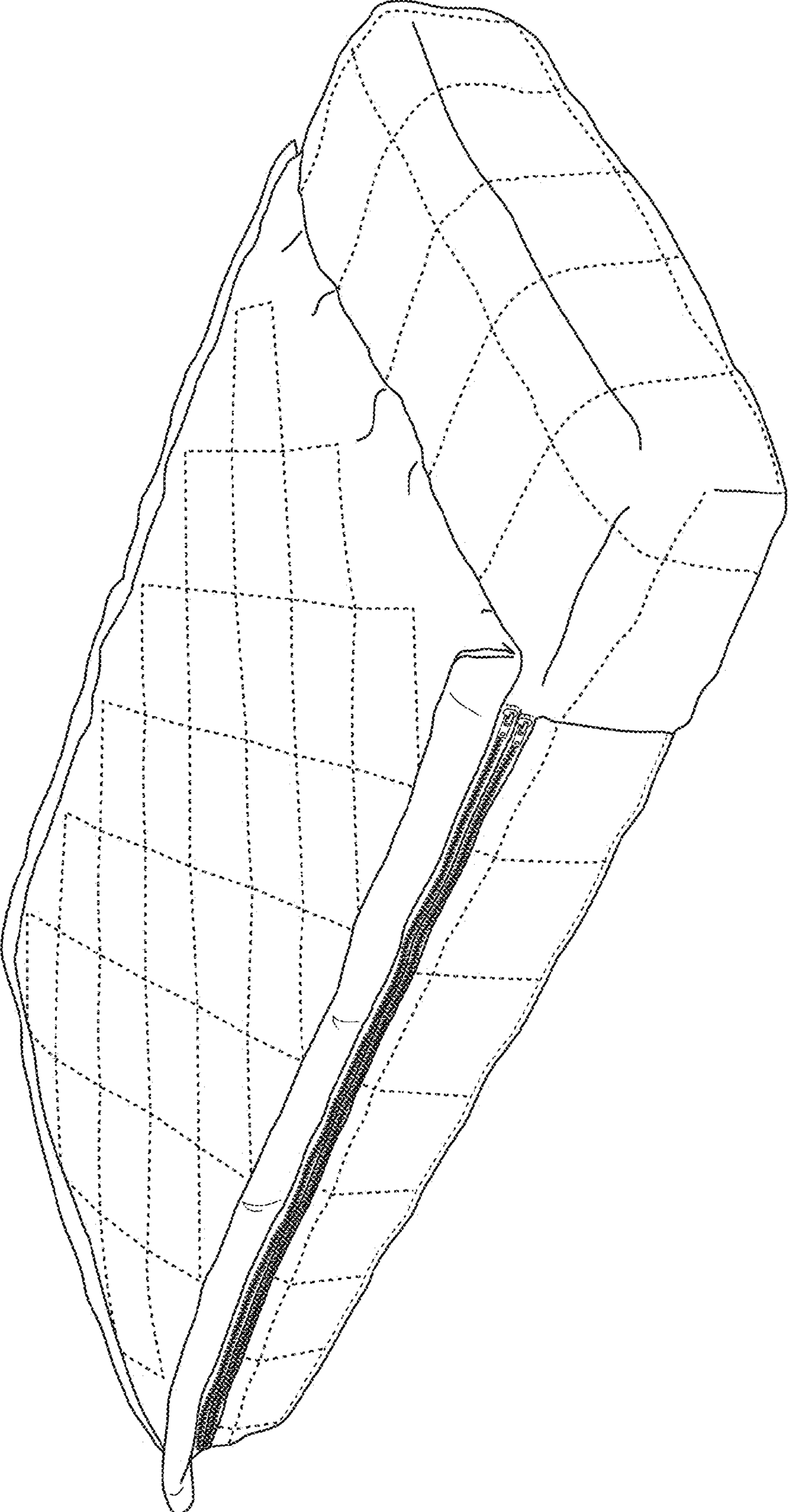

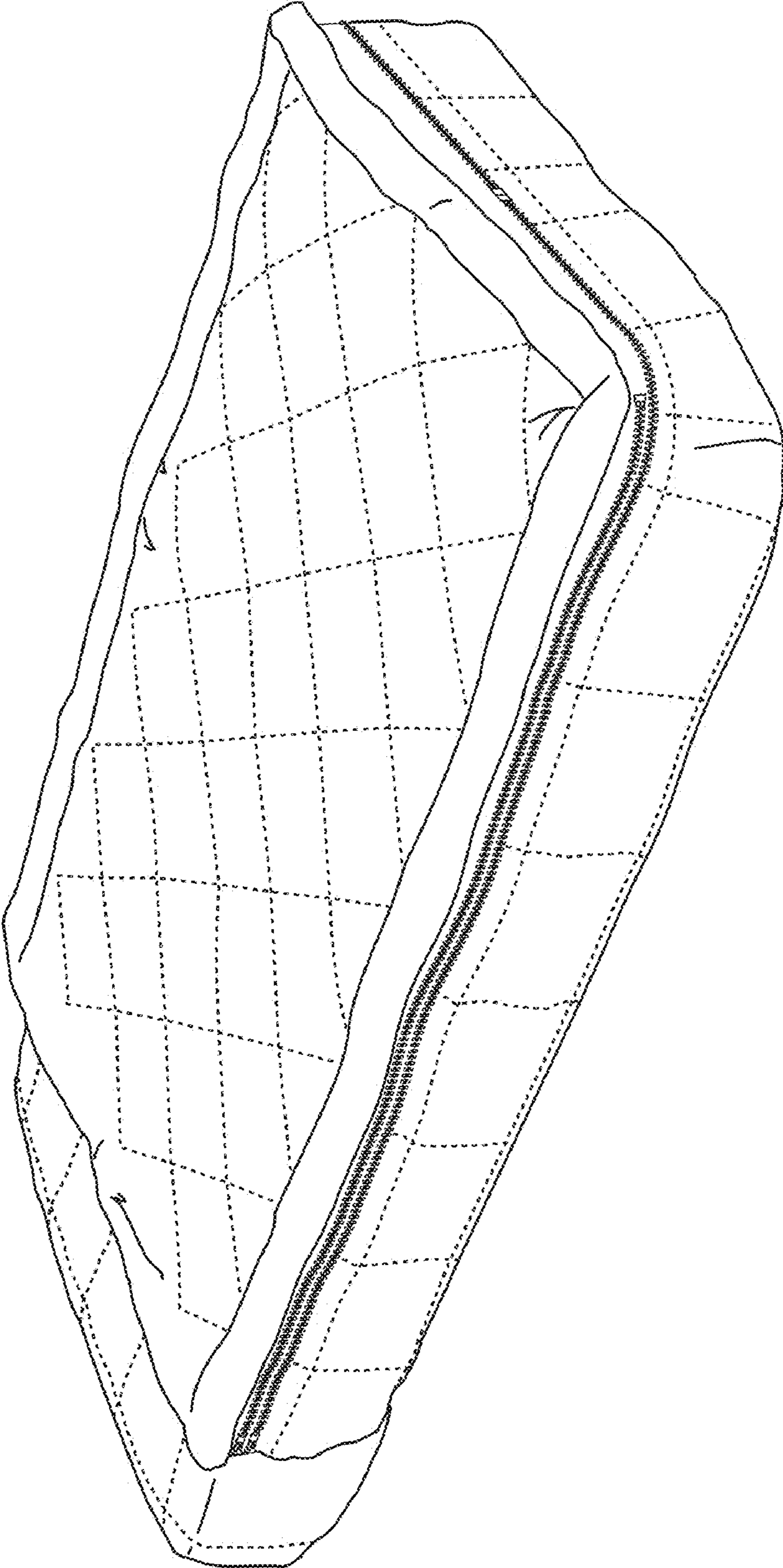

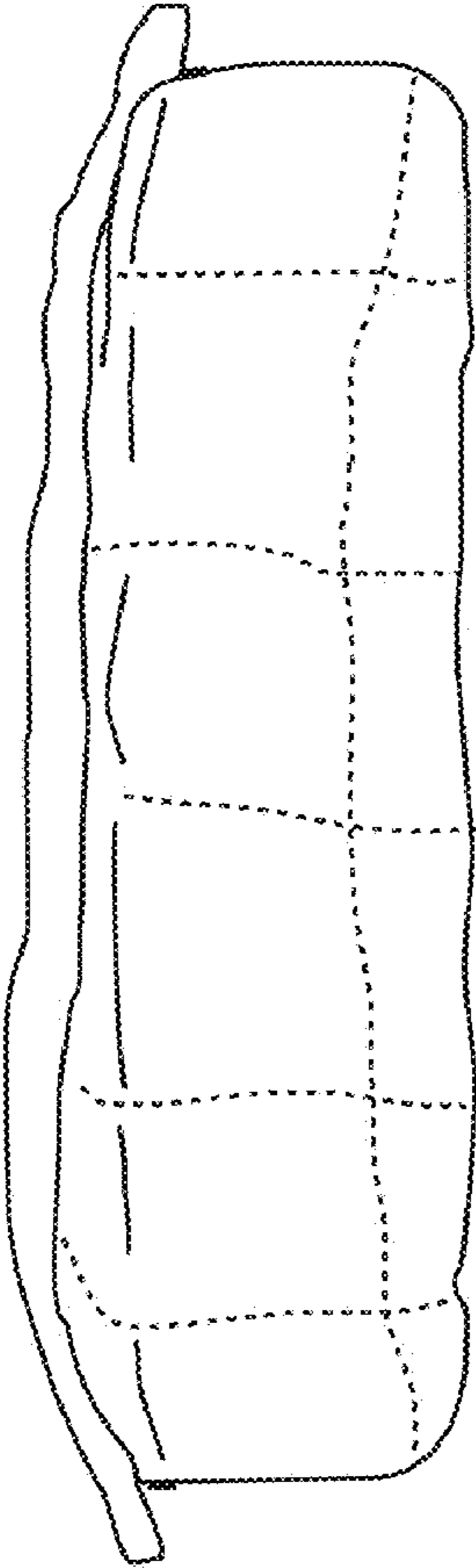

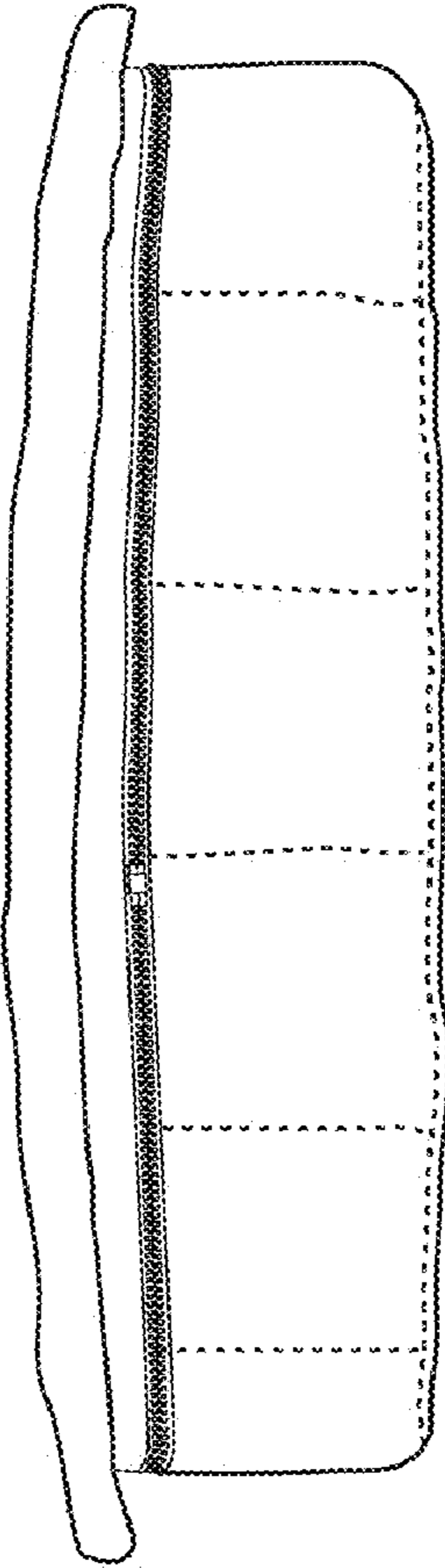

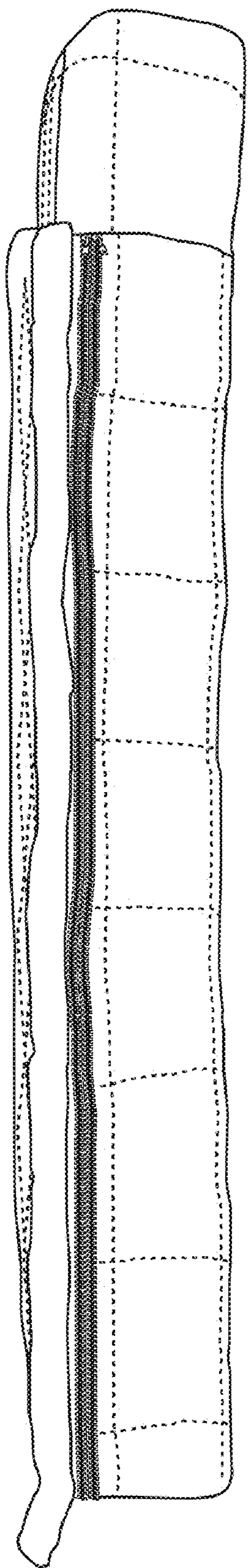

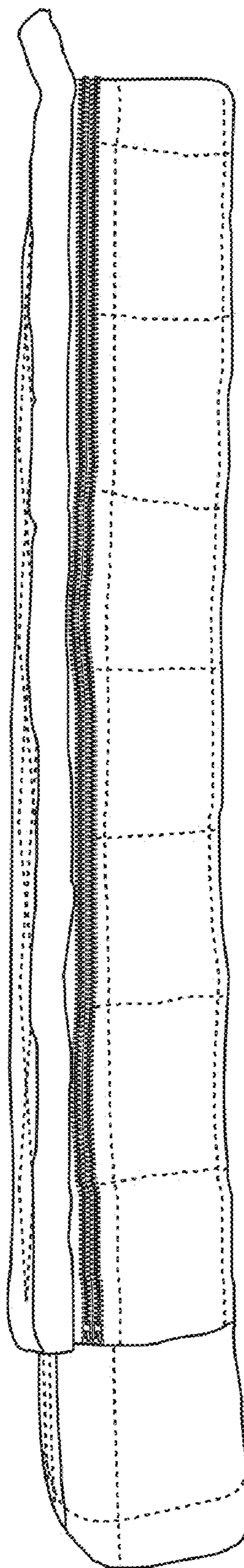

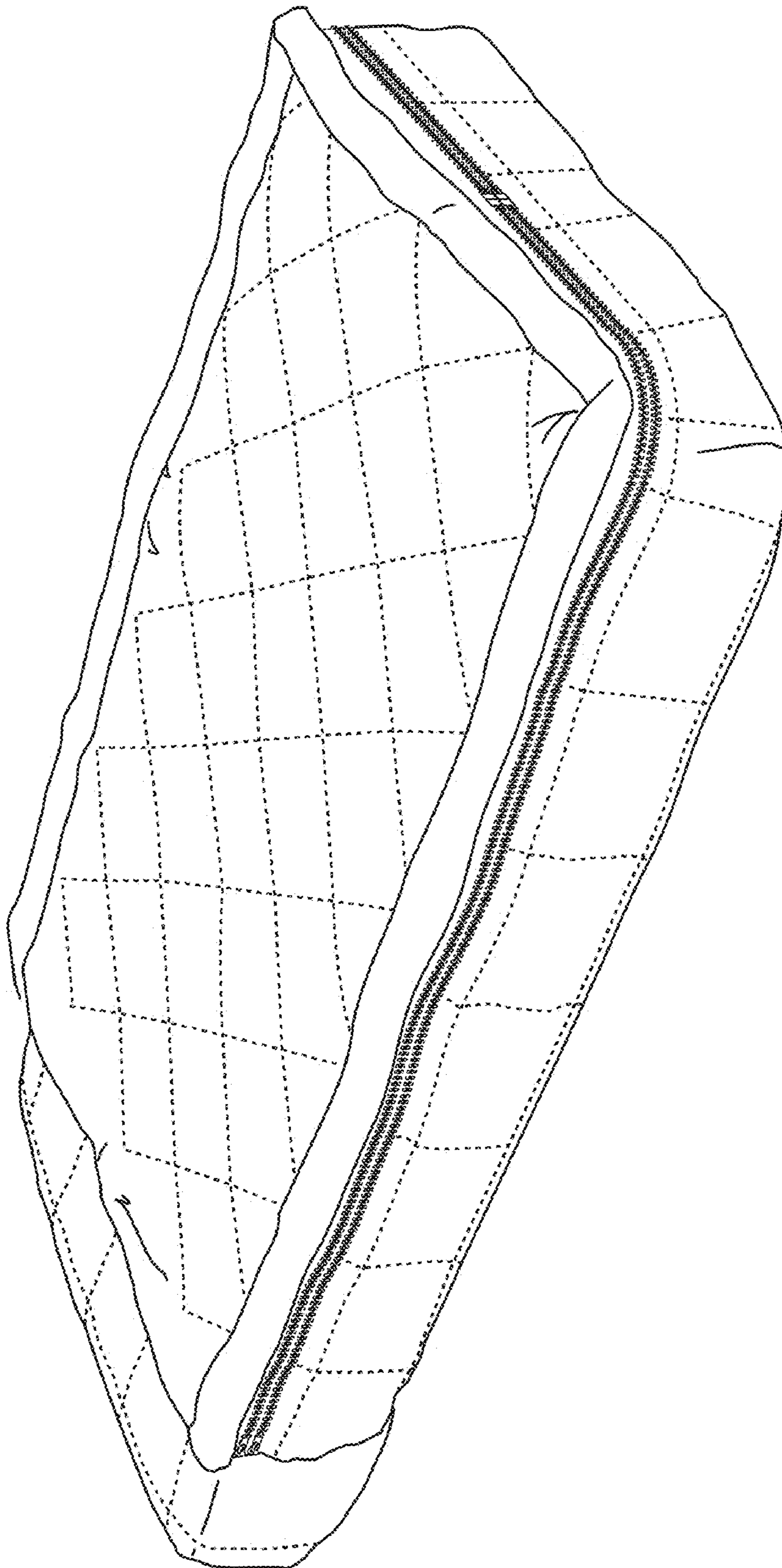

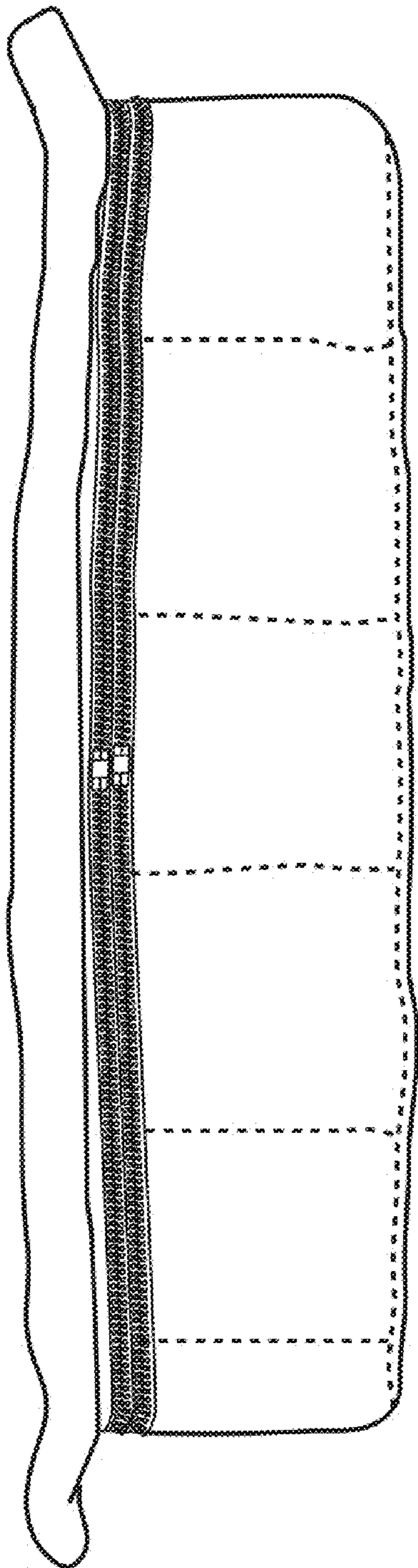

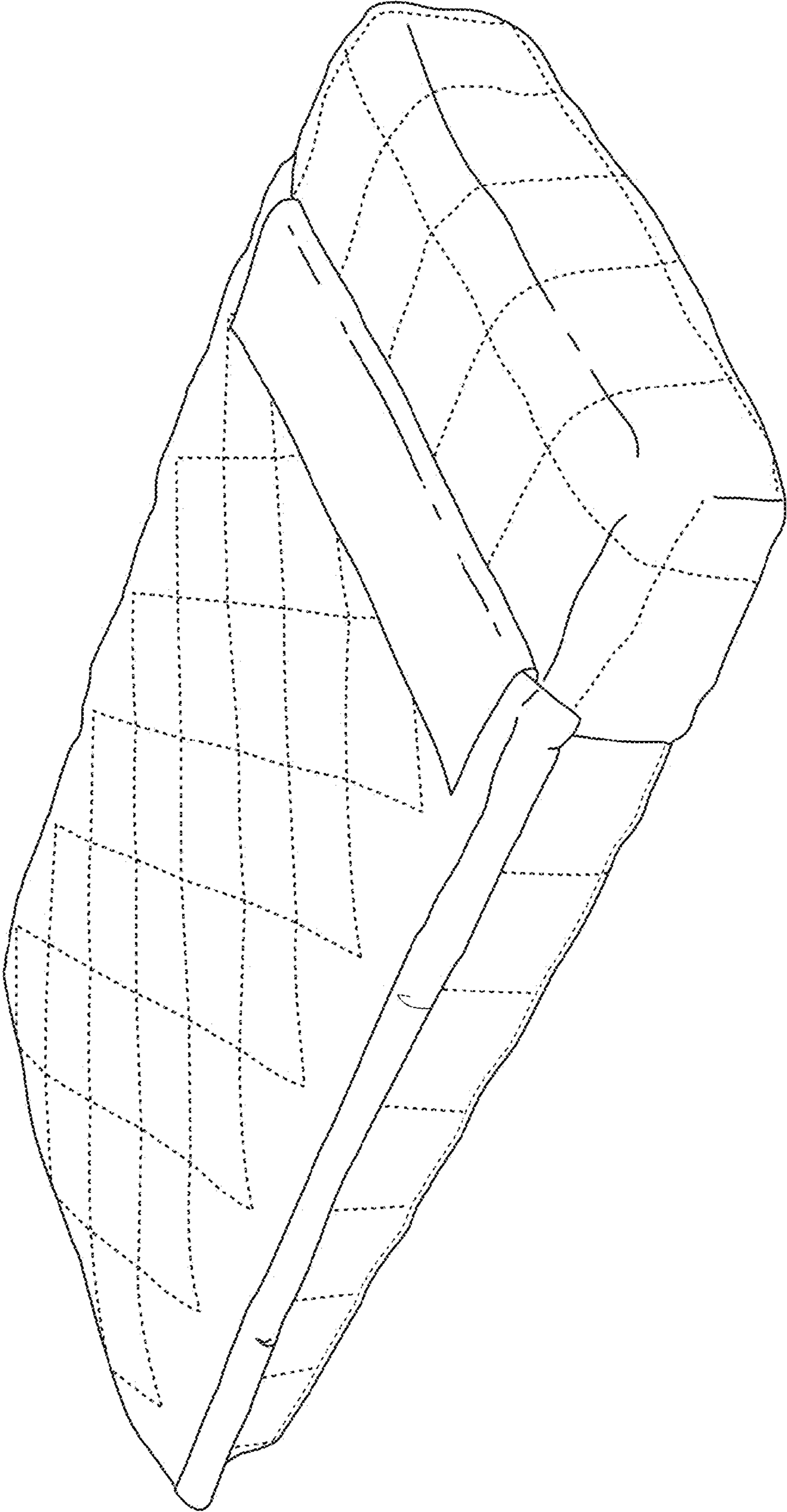

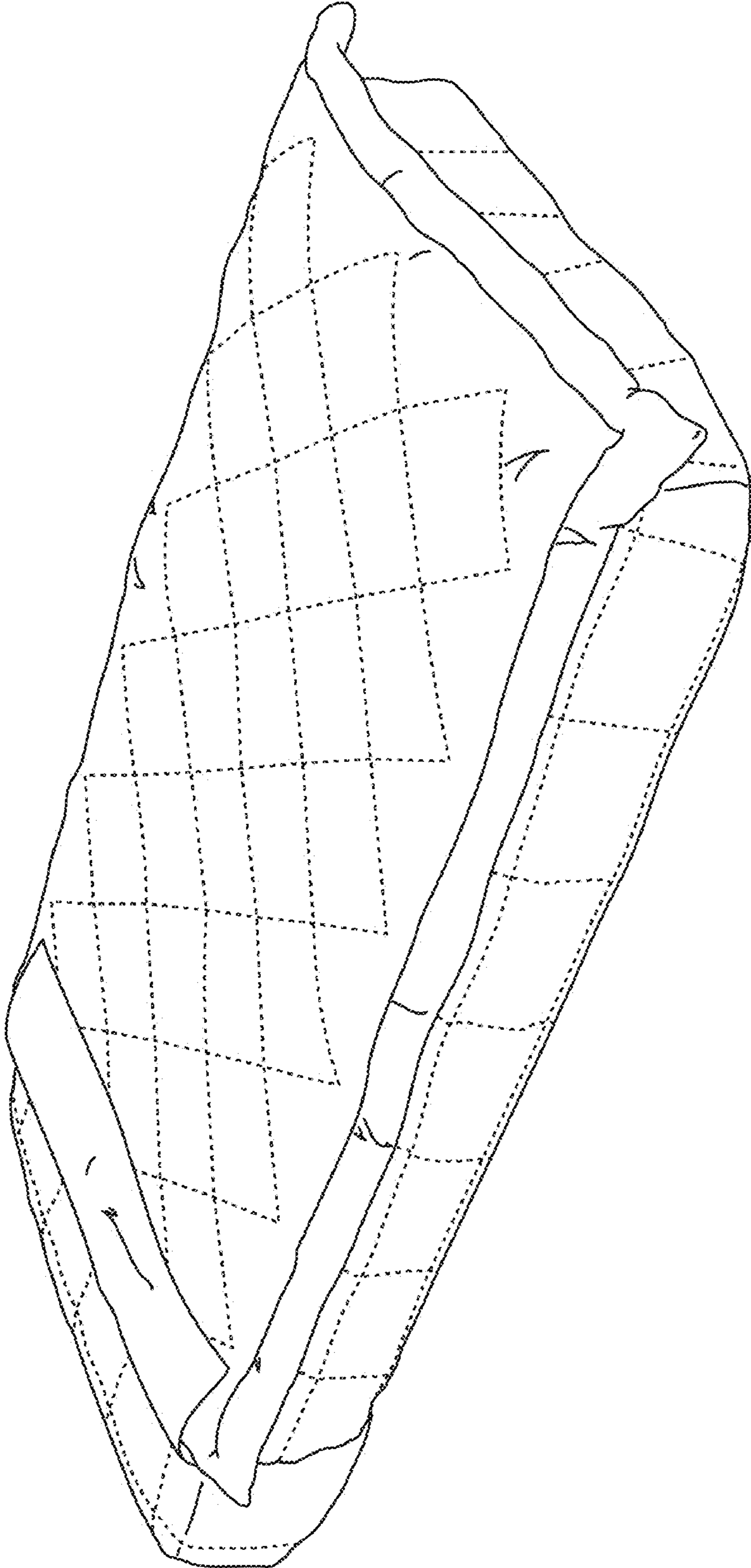

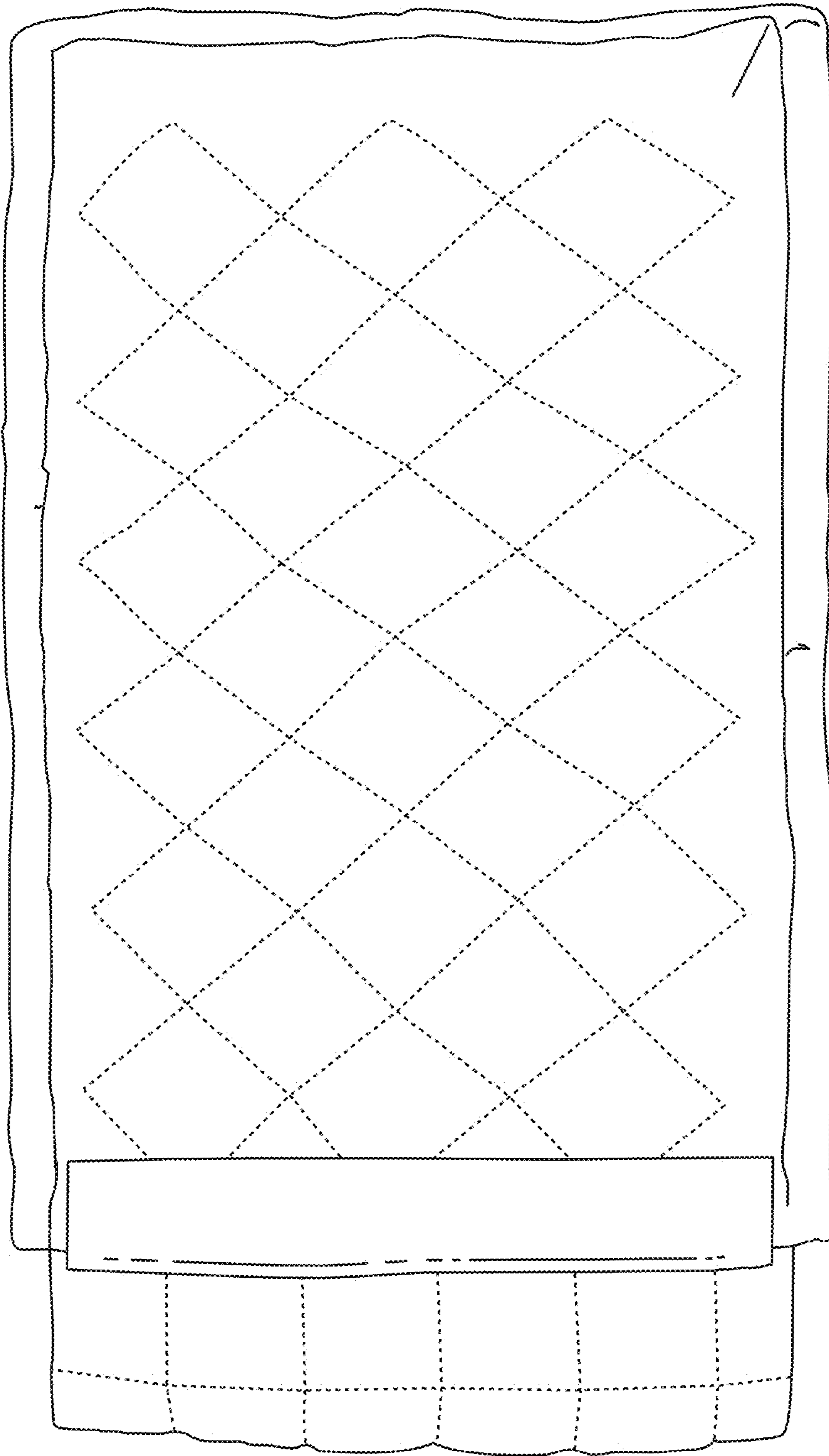

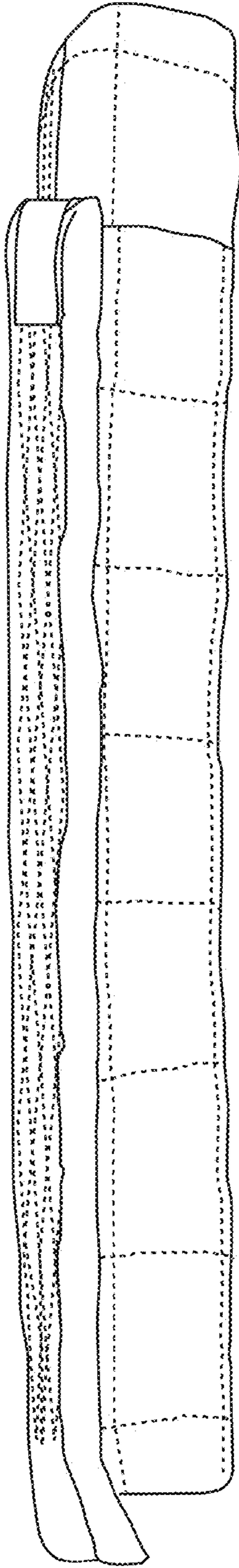

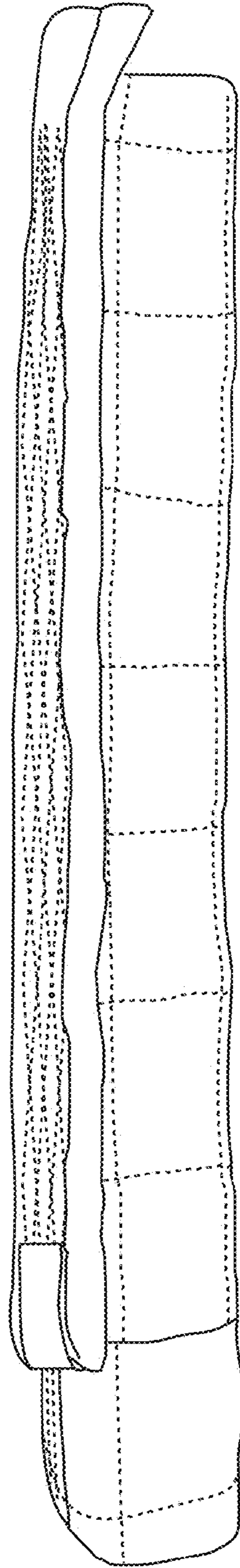

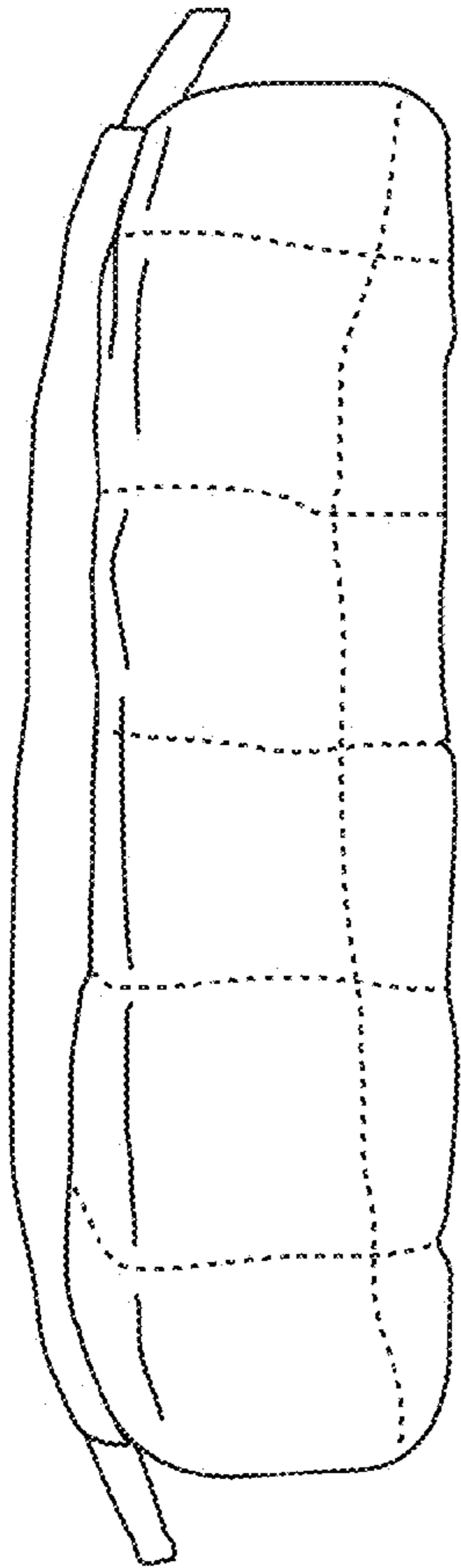

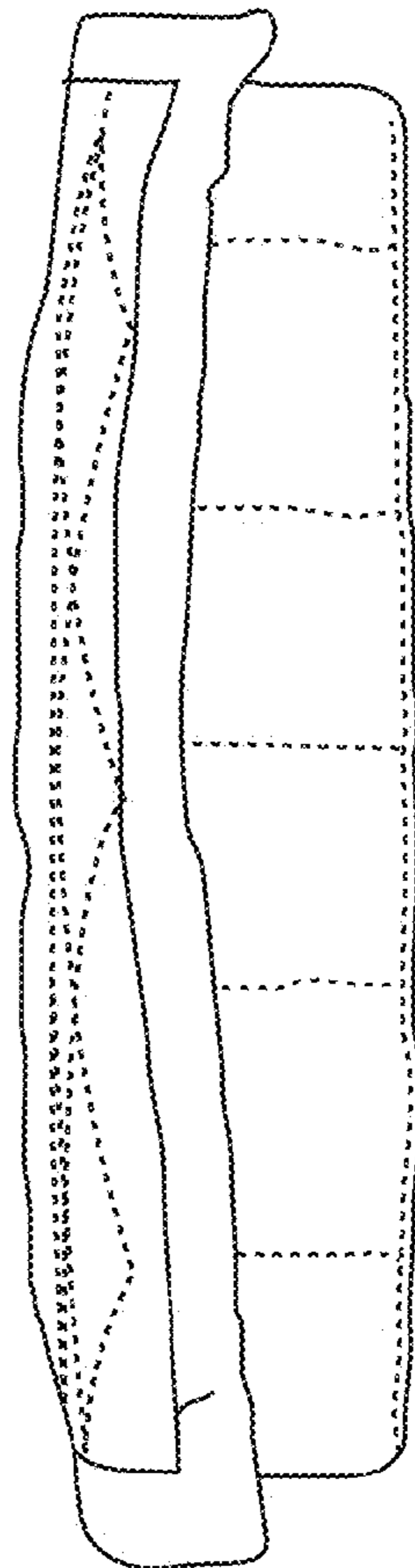

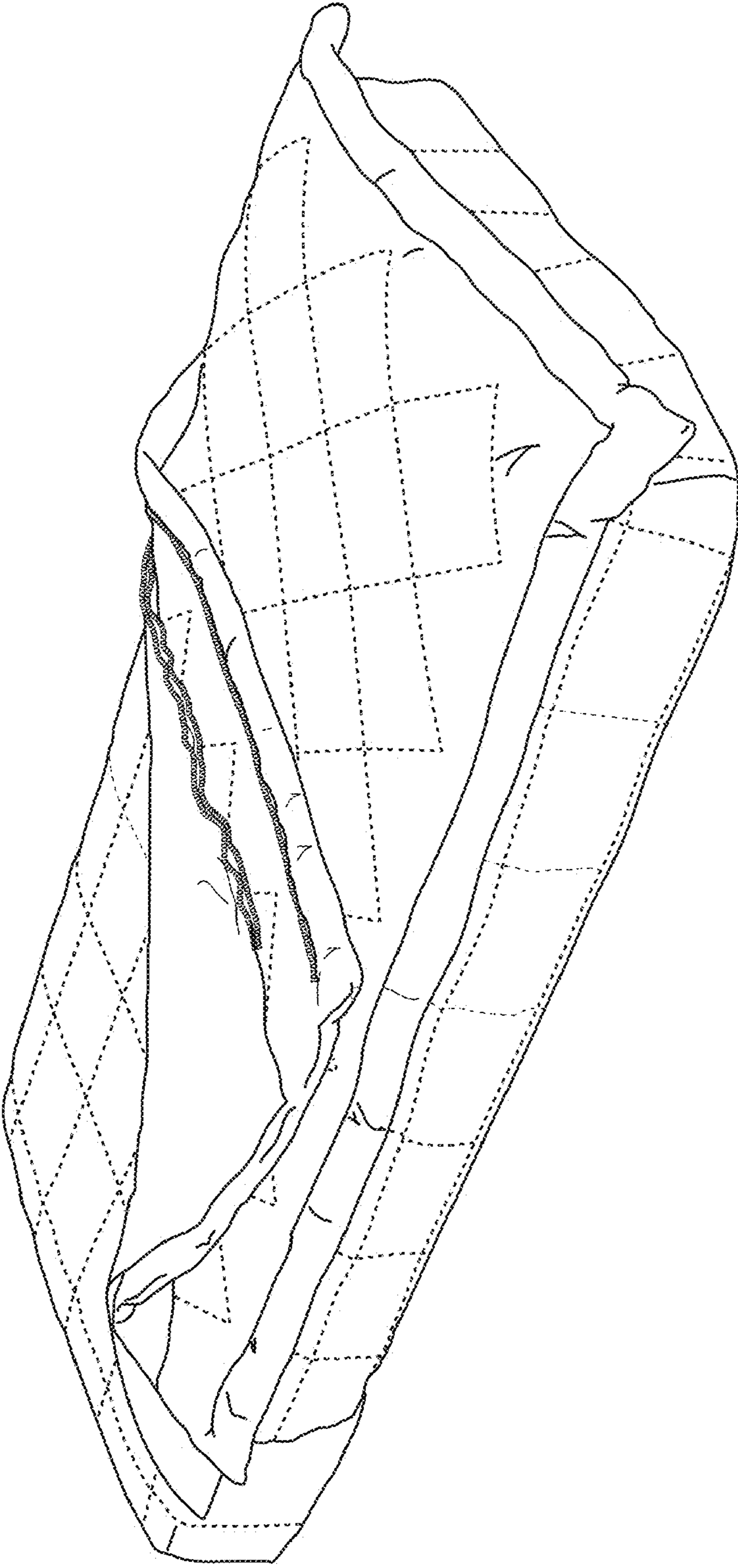

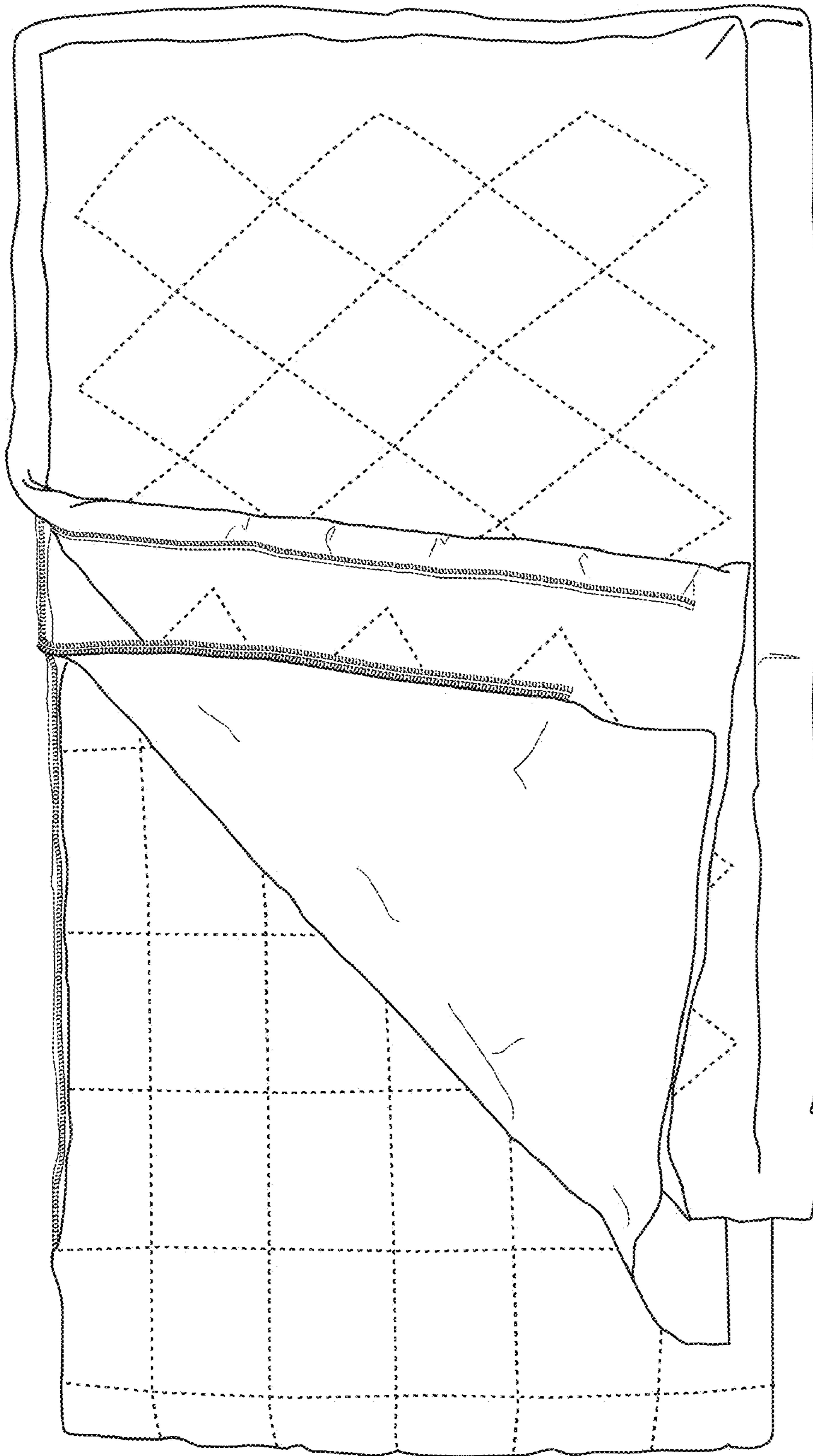

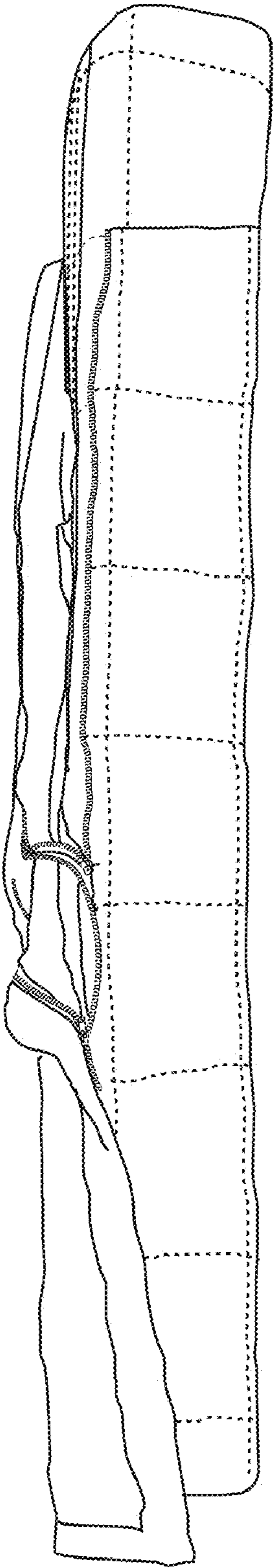

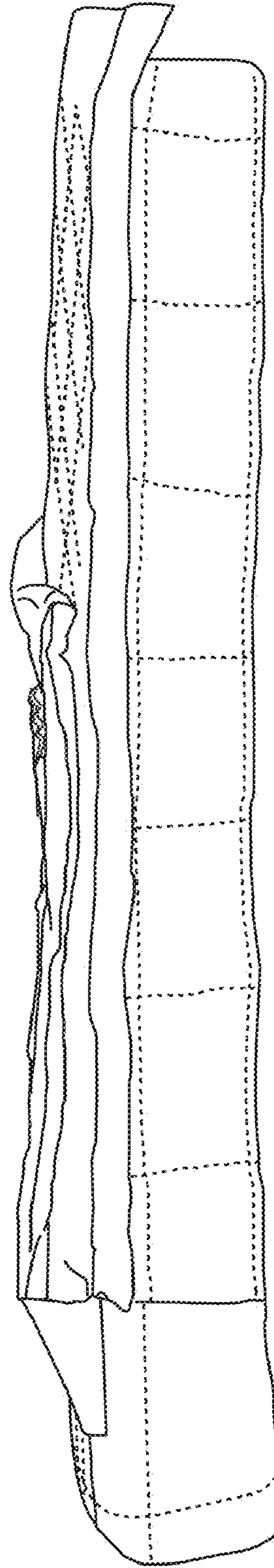

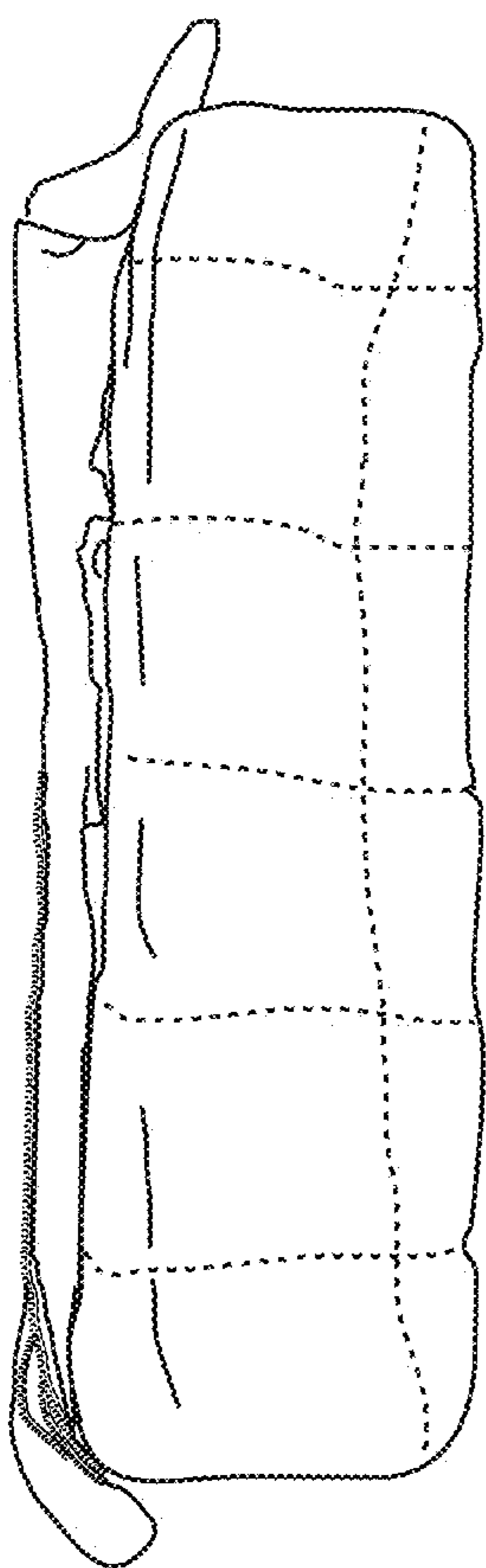

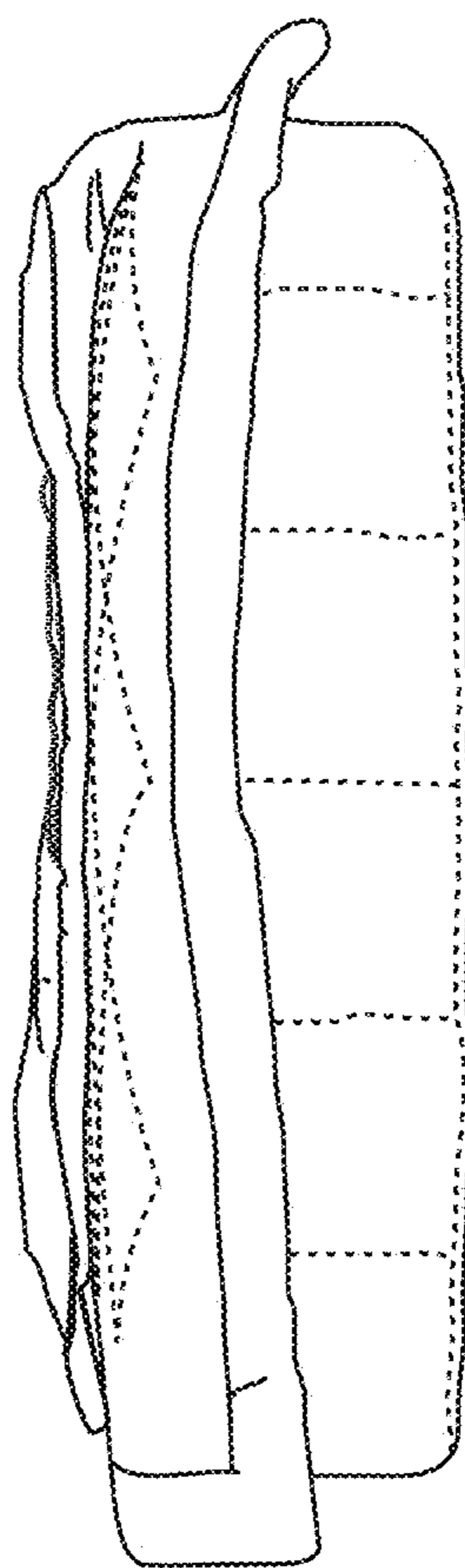
