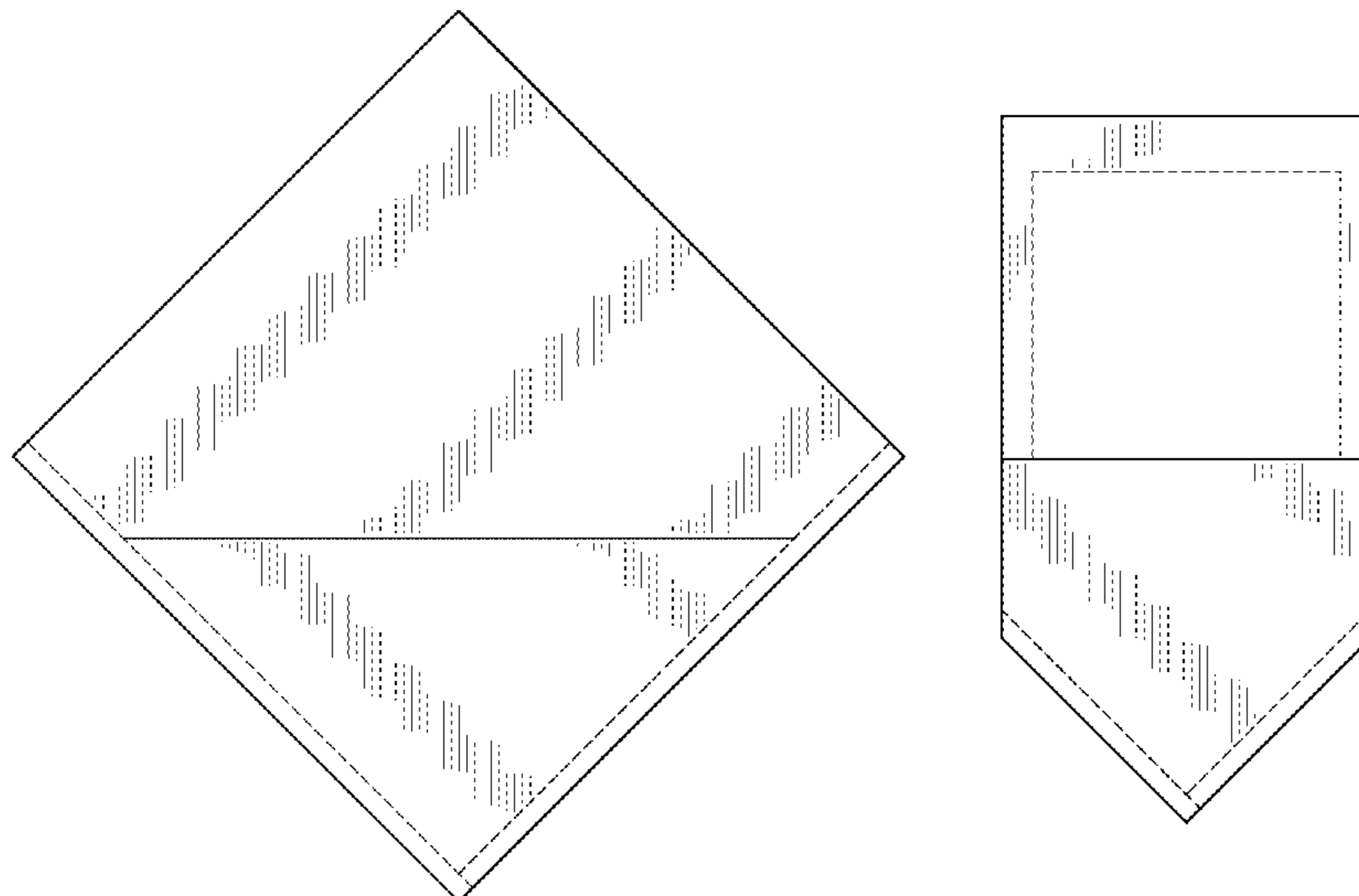
(57) **CLAIM**

The ornamental design for an napkin, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of an napkin showing our new design as it appears with a pocket;  
 FIG. 2 is a rear view of the napkin;  
 FIG. 3 is a rear view of the napkin as it appears showing a first fold;  
 FIG. 4 is a rear view of the napkin as it appears showing a second fold;  
 FIG. 5 is a rear view of the napkin as it appears showing an example of a third fold lying underneath the first two folds;  
 FIG. 6 is a front view of the napkin as it appears folded;  
 FIG. 7 is a front view of the napkin as it appears folded with an example of an accessory adorned to the pocket;  
 FIG. 8 is a front view of the napkin as it appears folded with an example of an accessory inserted into the pocket; and,  
 FIG. 9 is a front view of the napkin as it appears folded with an example of an accessory inserted into the pocket.  
 The broken lines form no part of the claimed design.

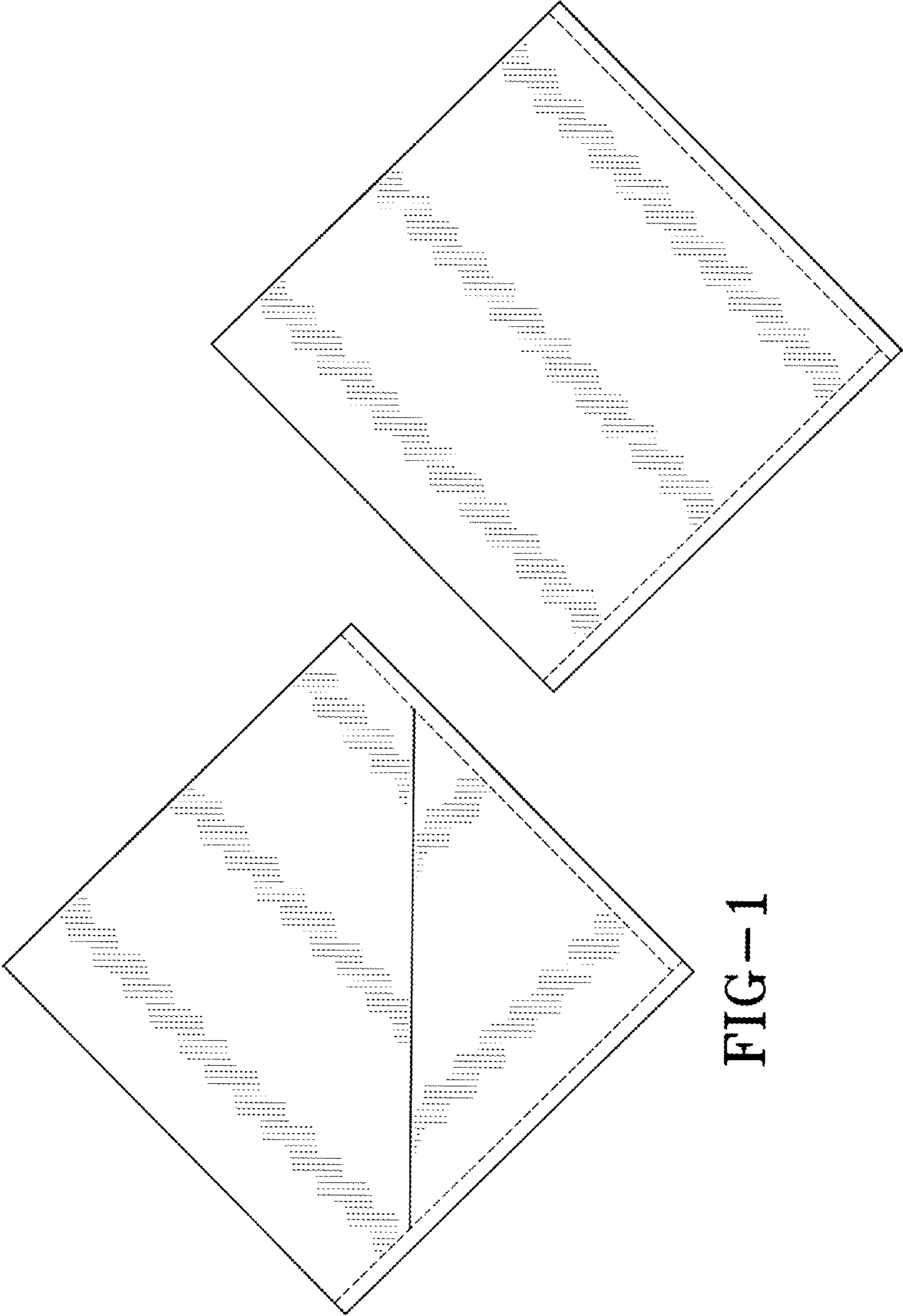

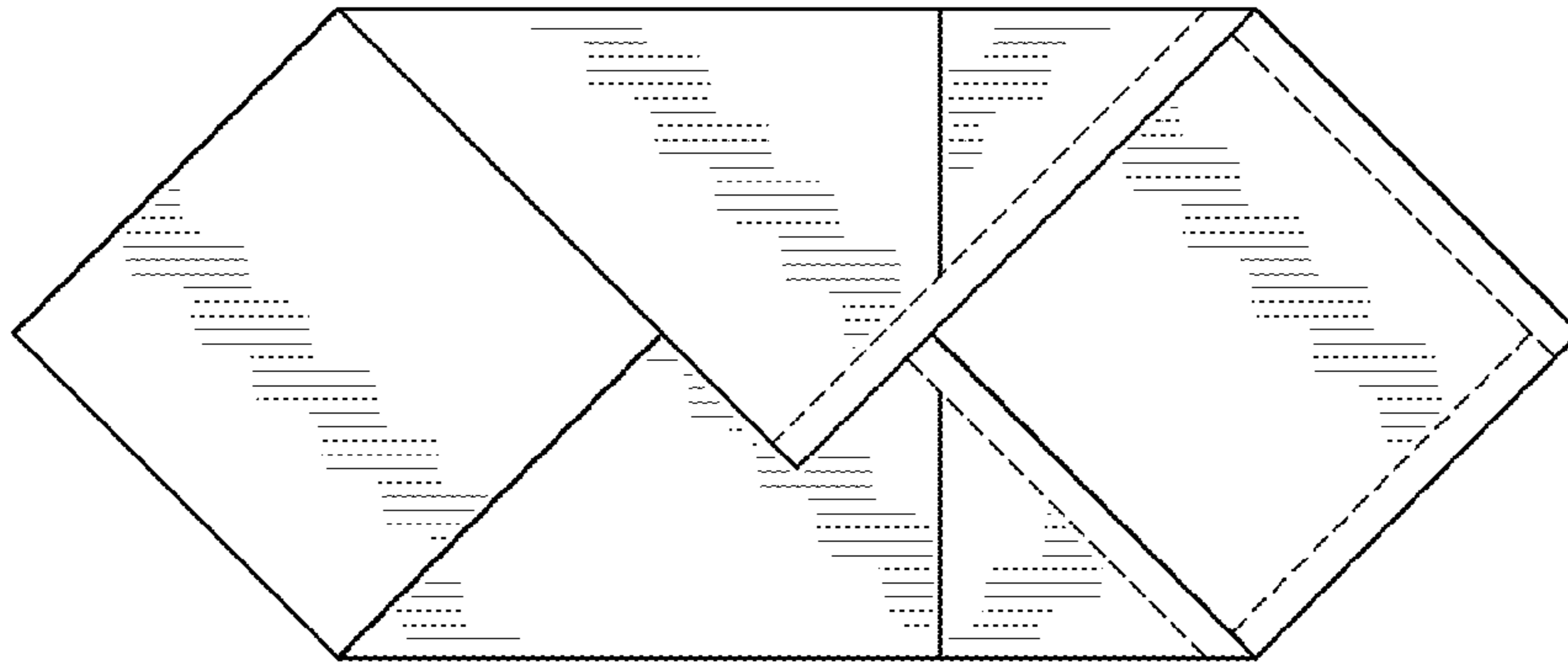

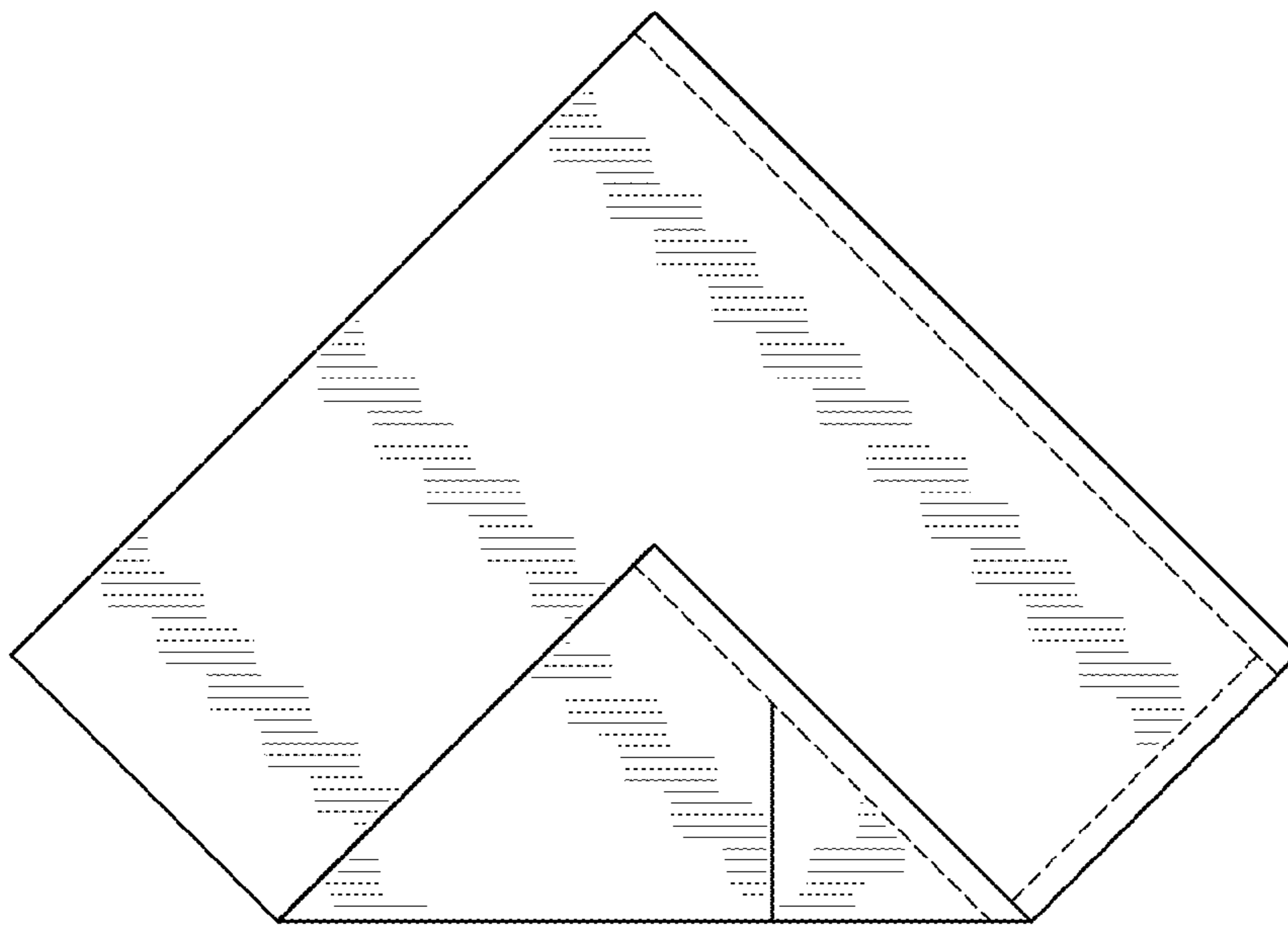

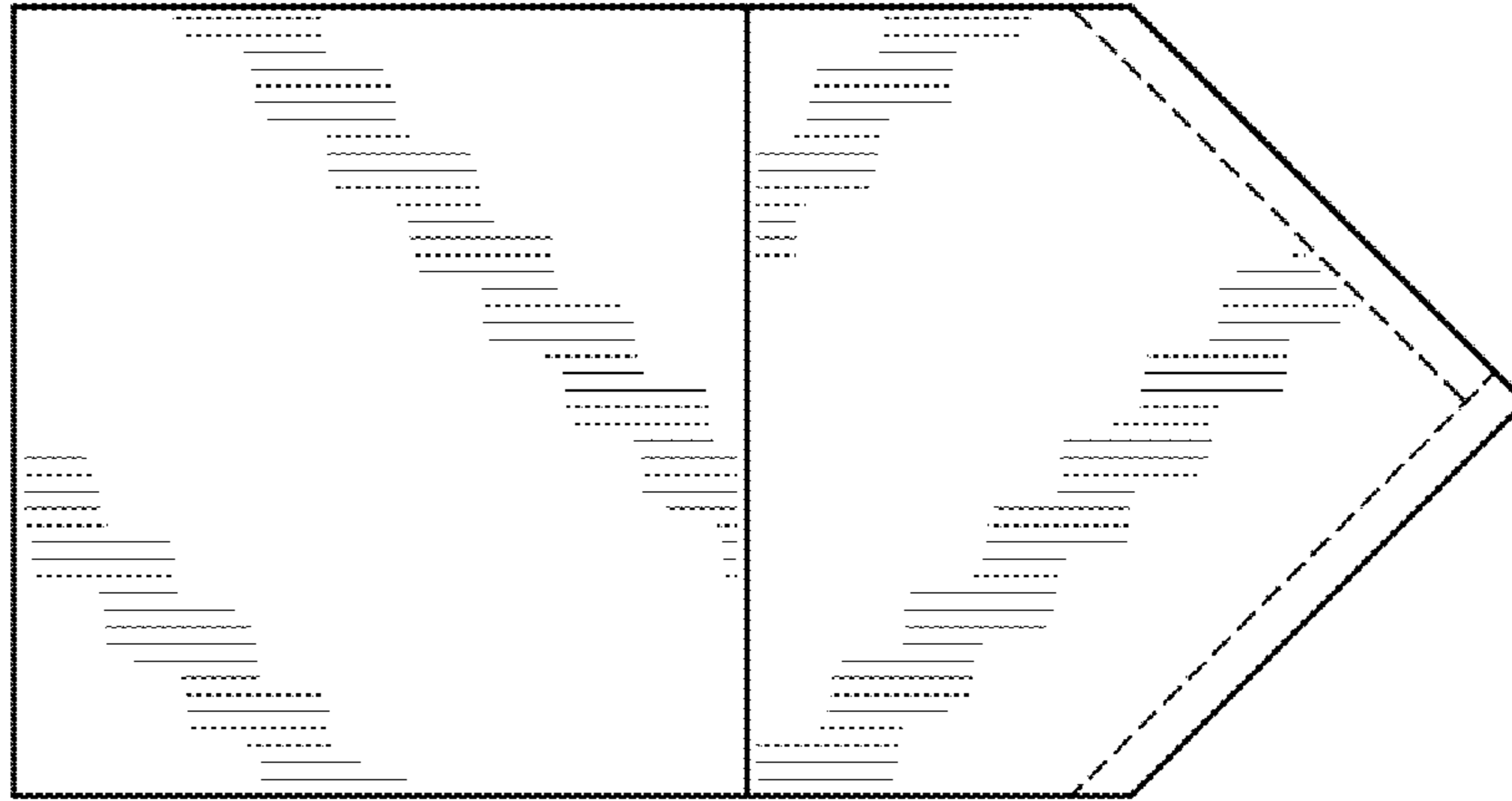

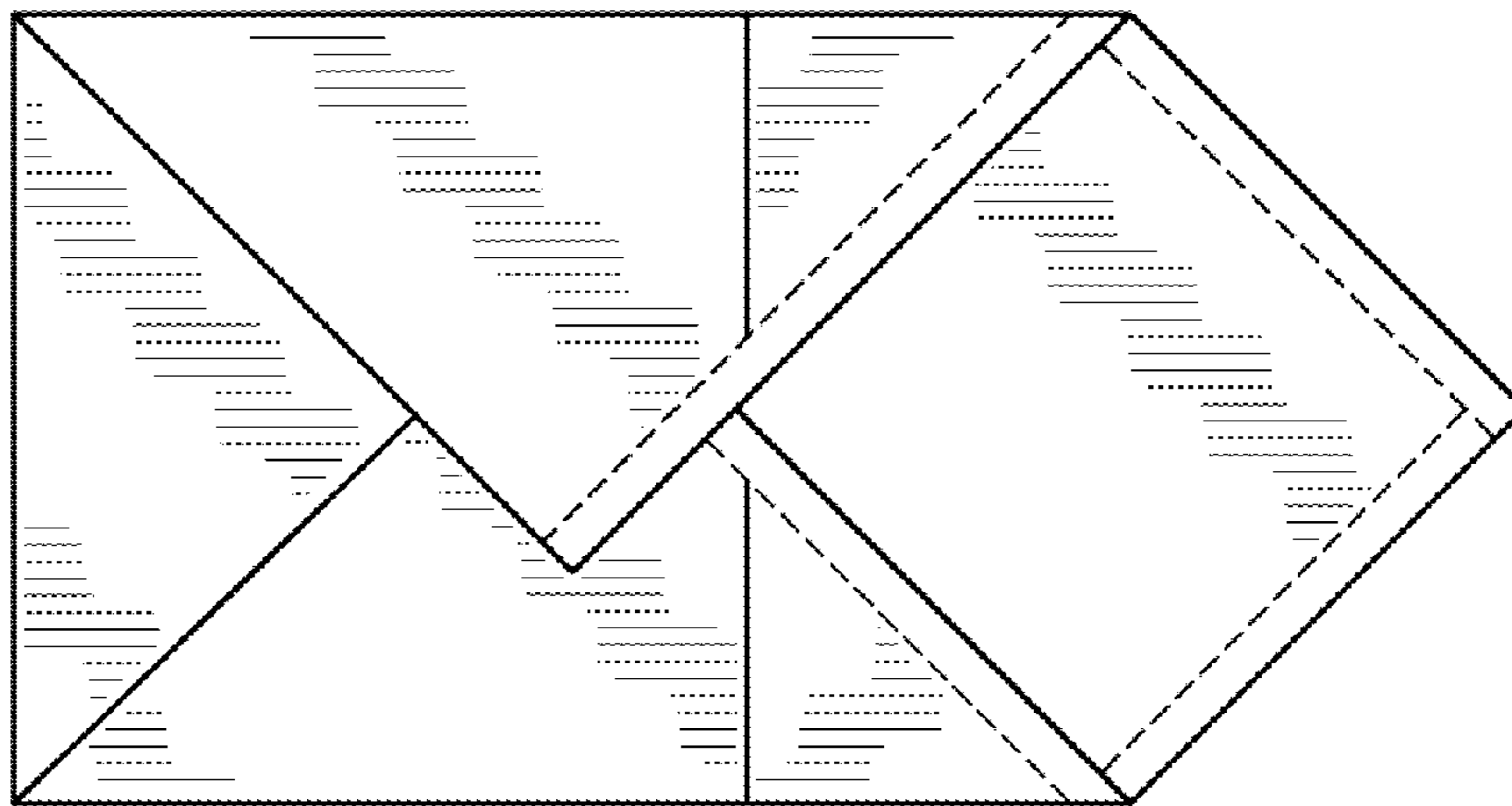

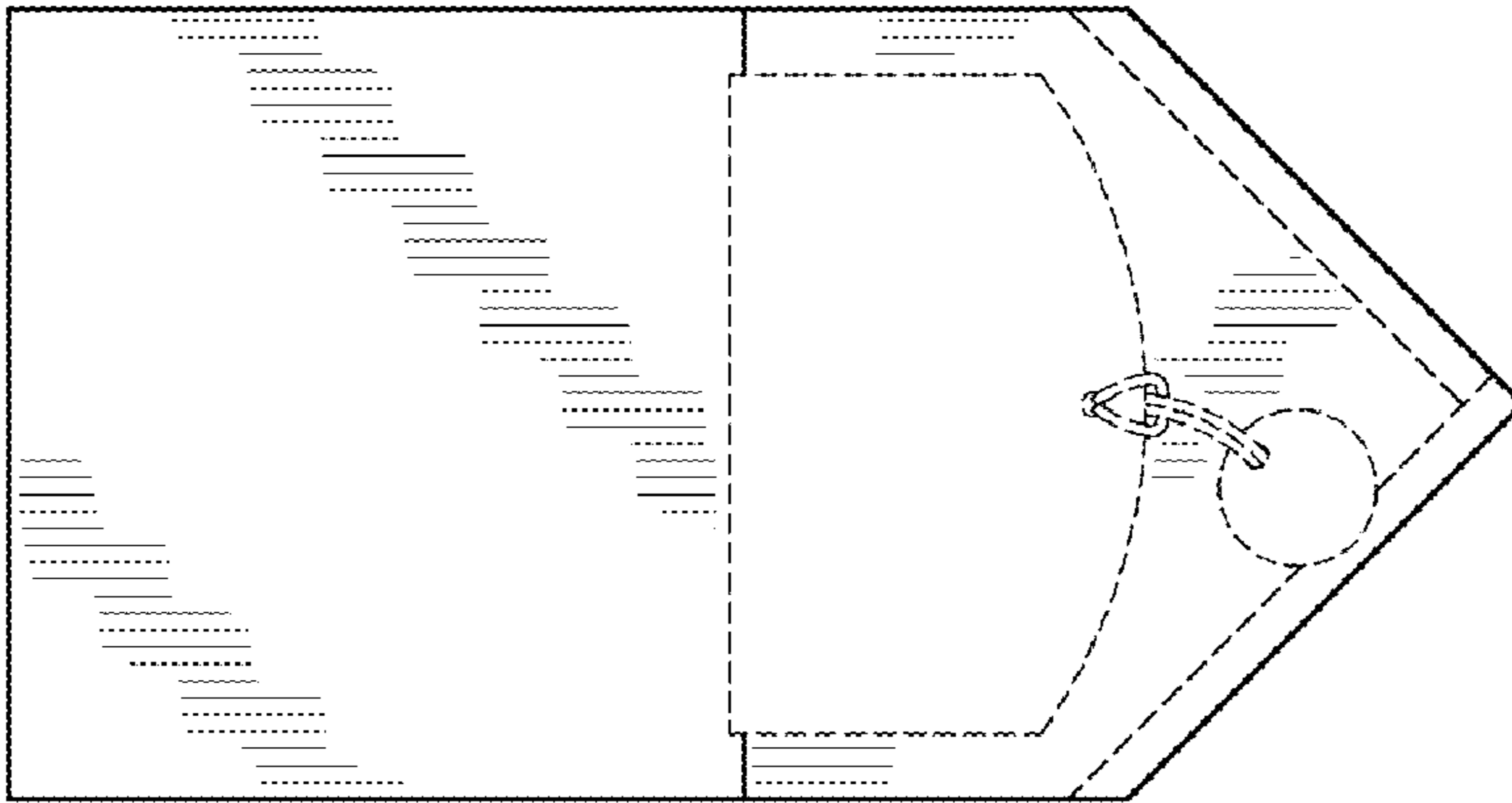

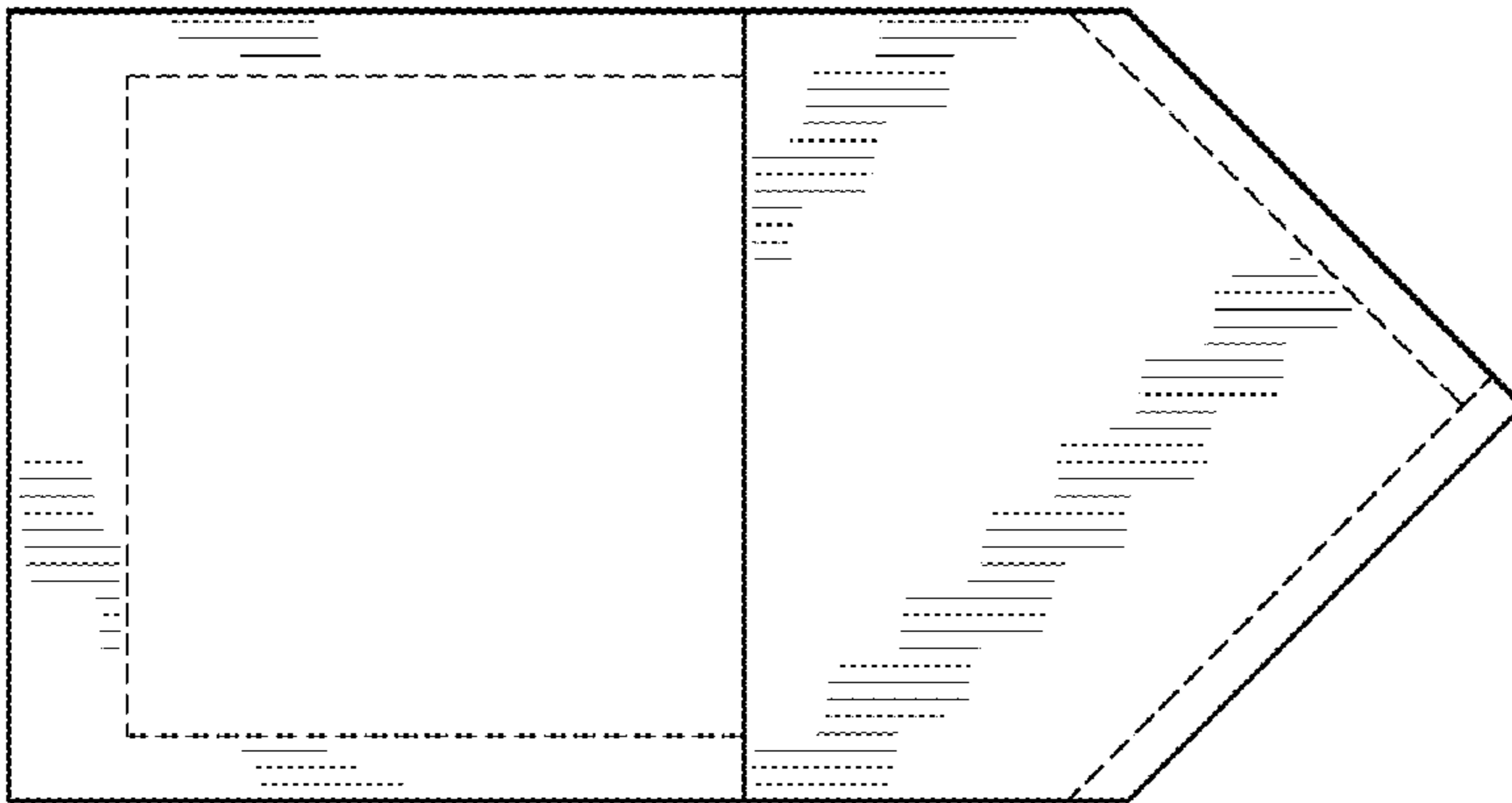

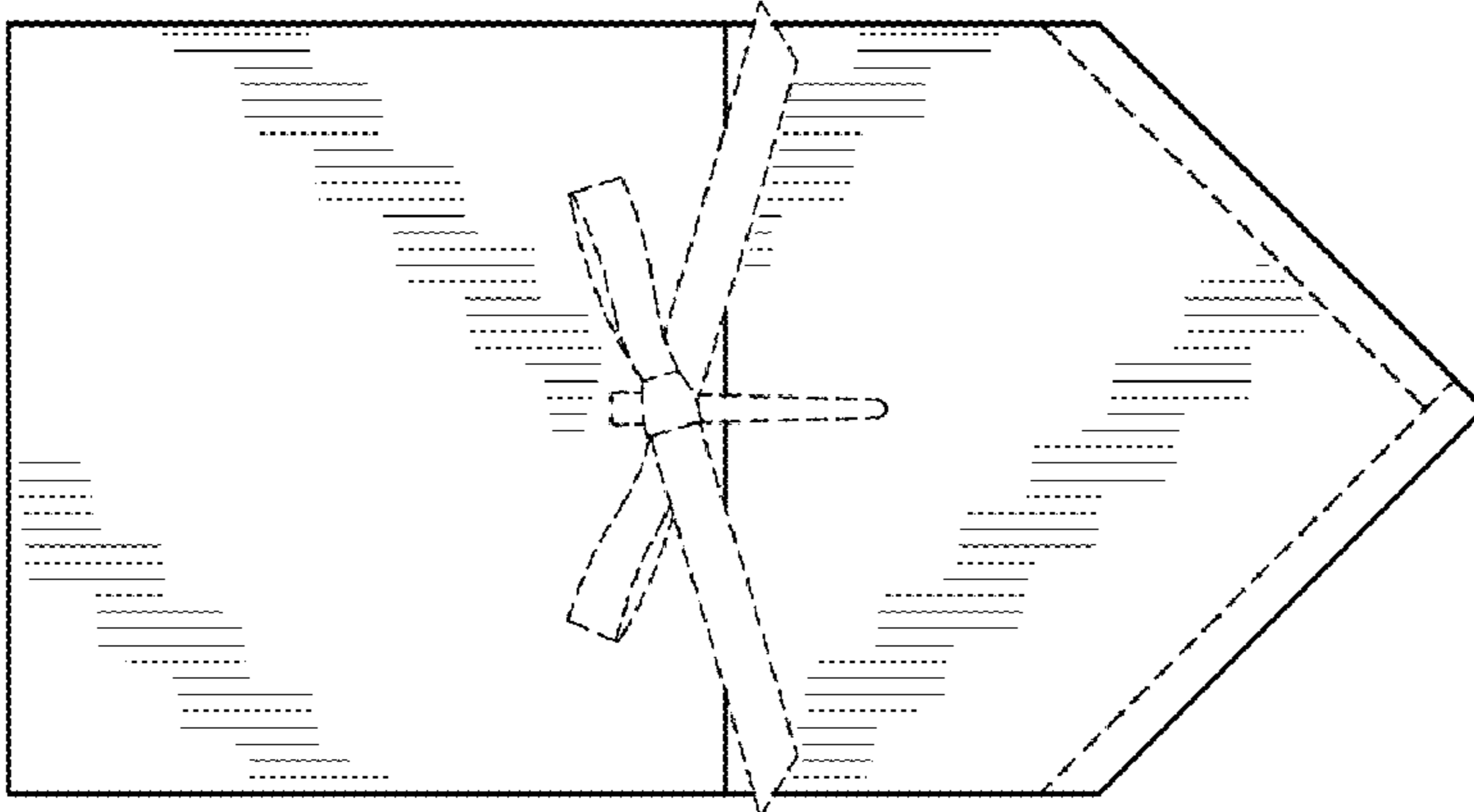
