DESCRIPTION

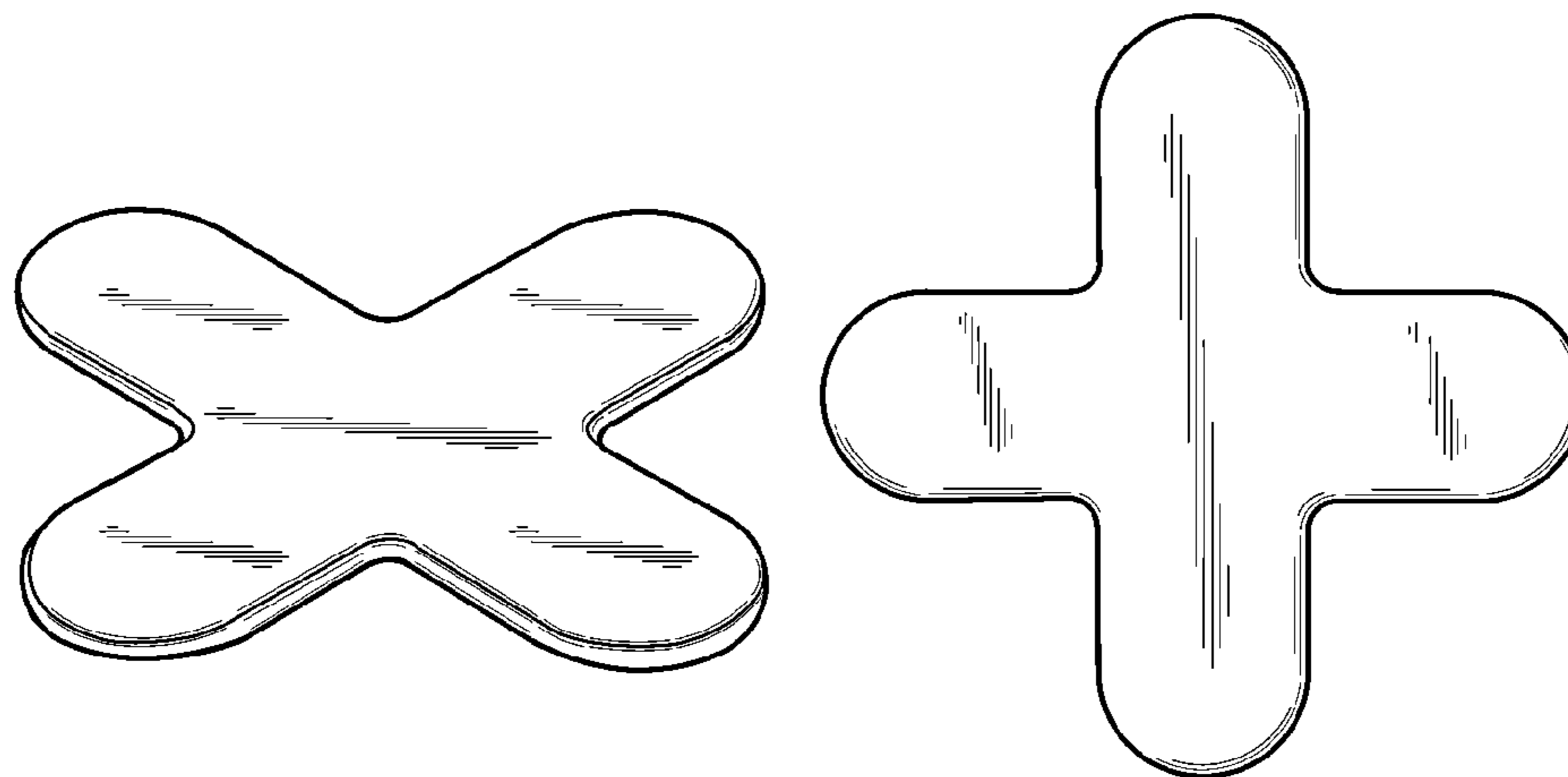
FIG. 1 is a perspective view of a trivet showing our new design;

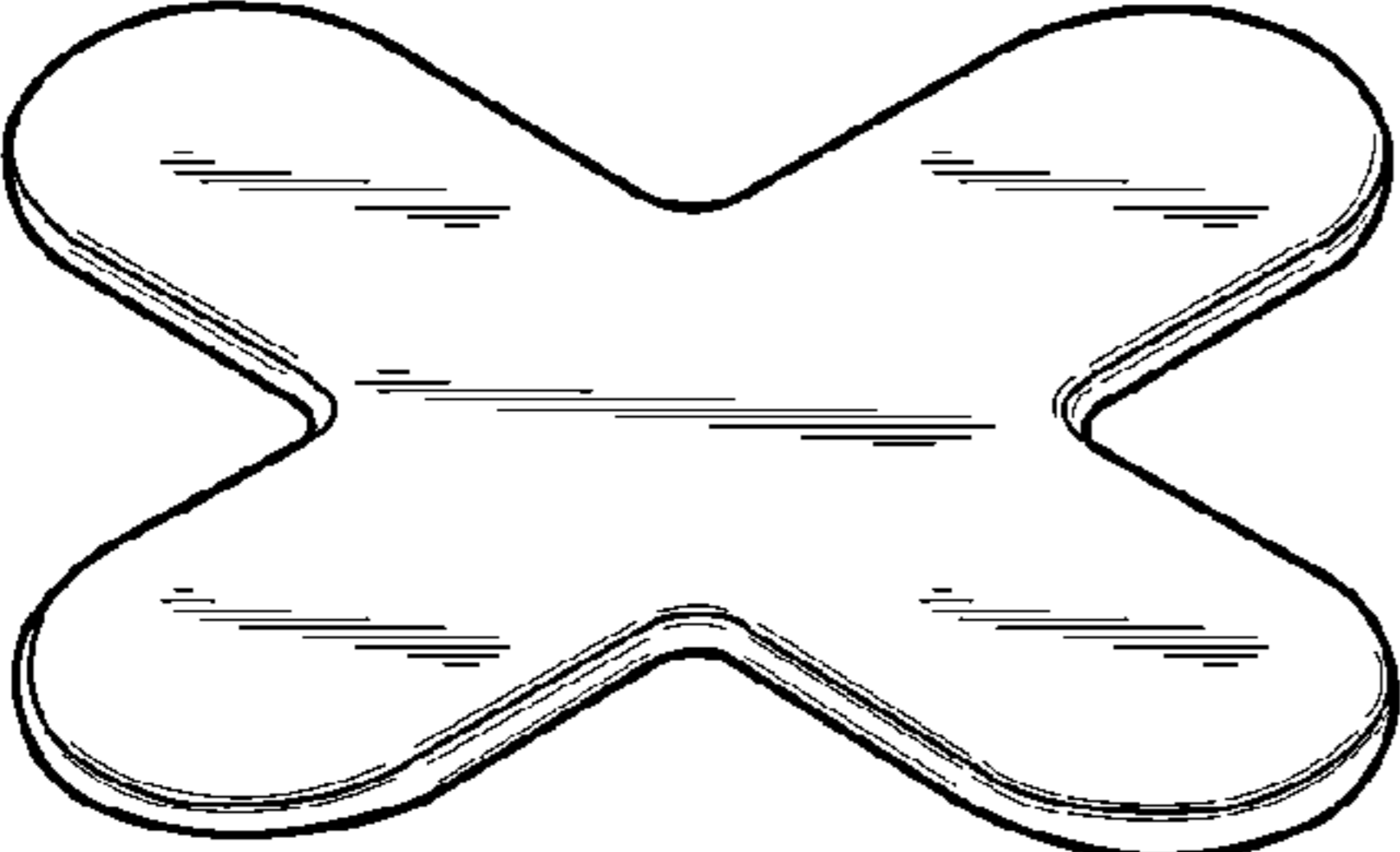

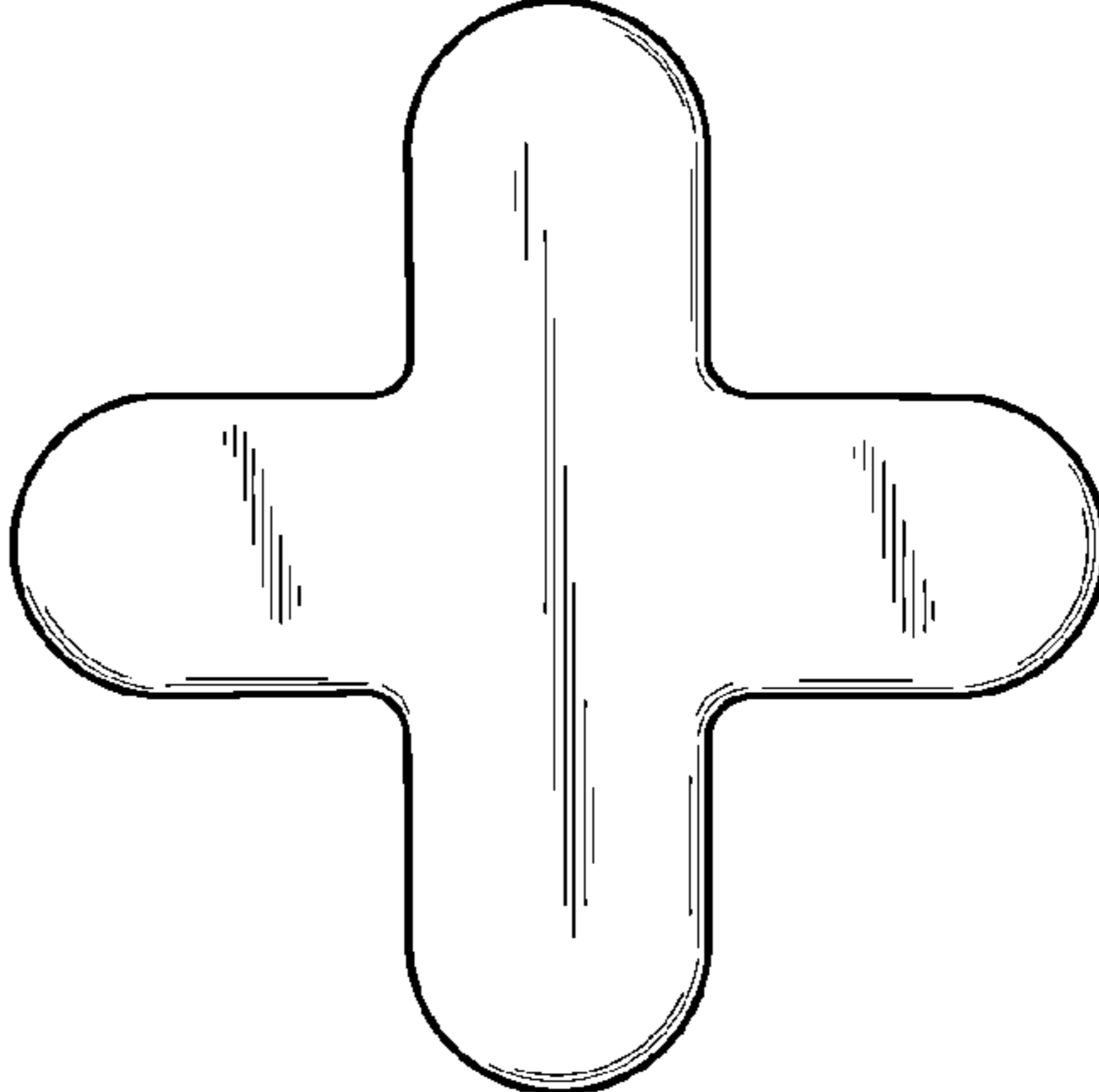

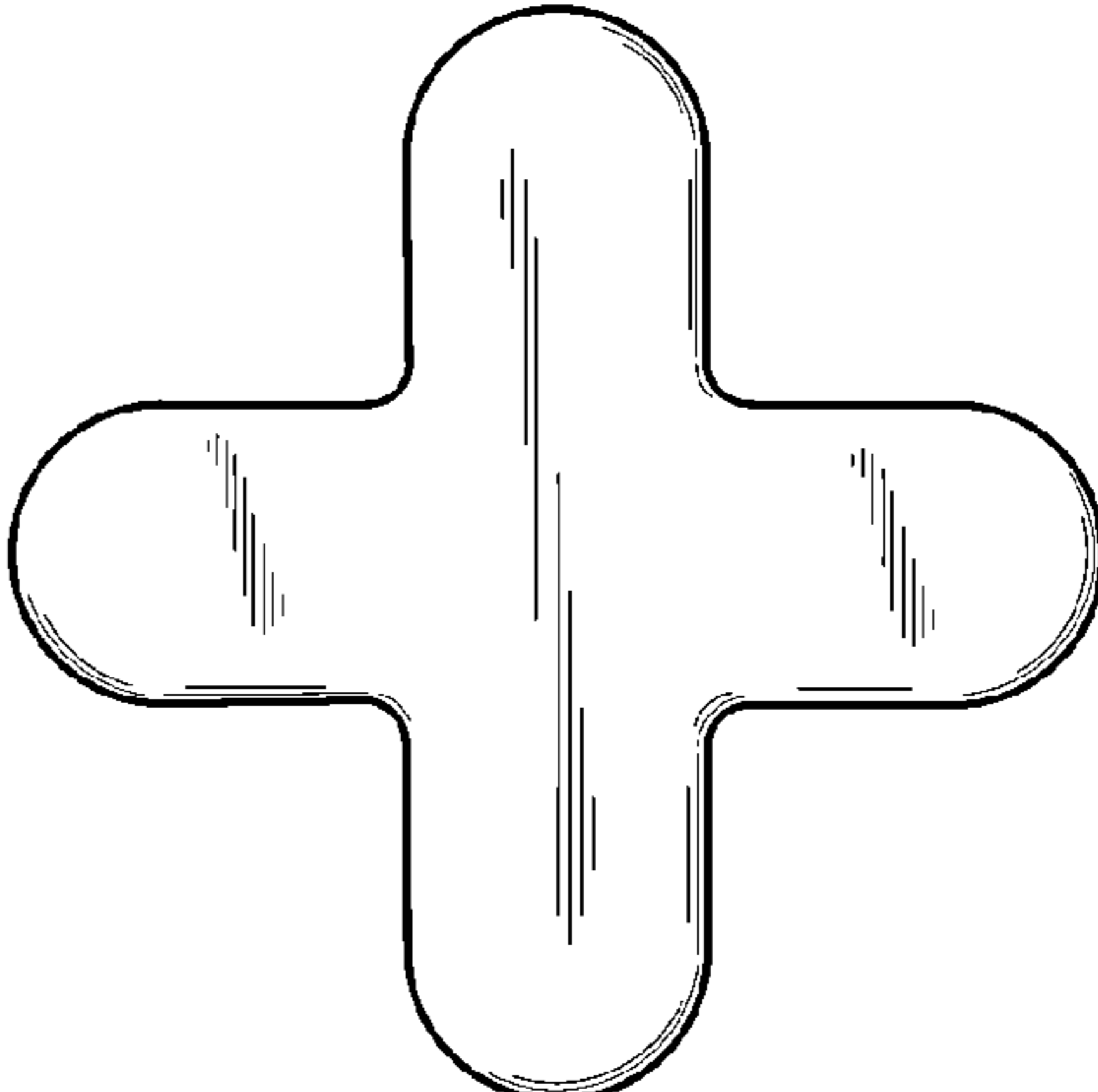
