DESCRIPTION

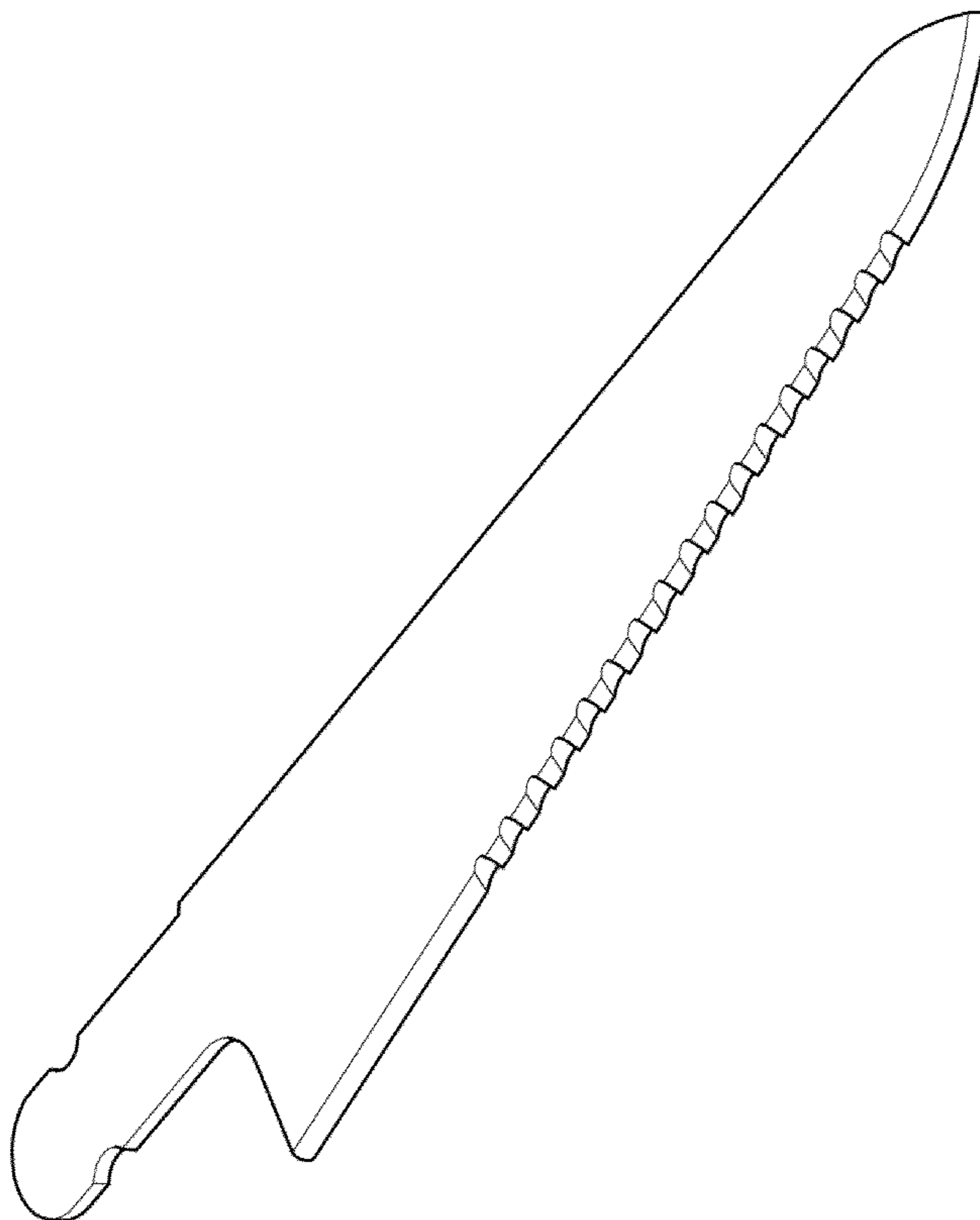
FIG. 1 is a perspective view of a knife blade showing my new design;

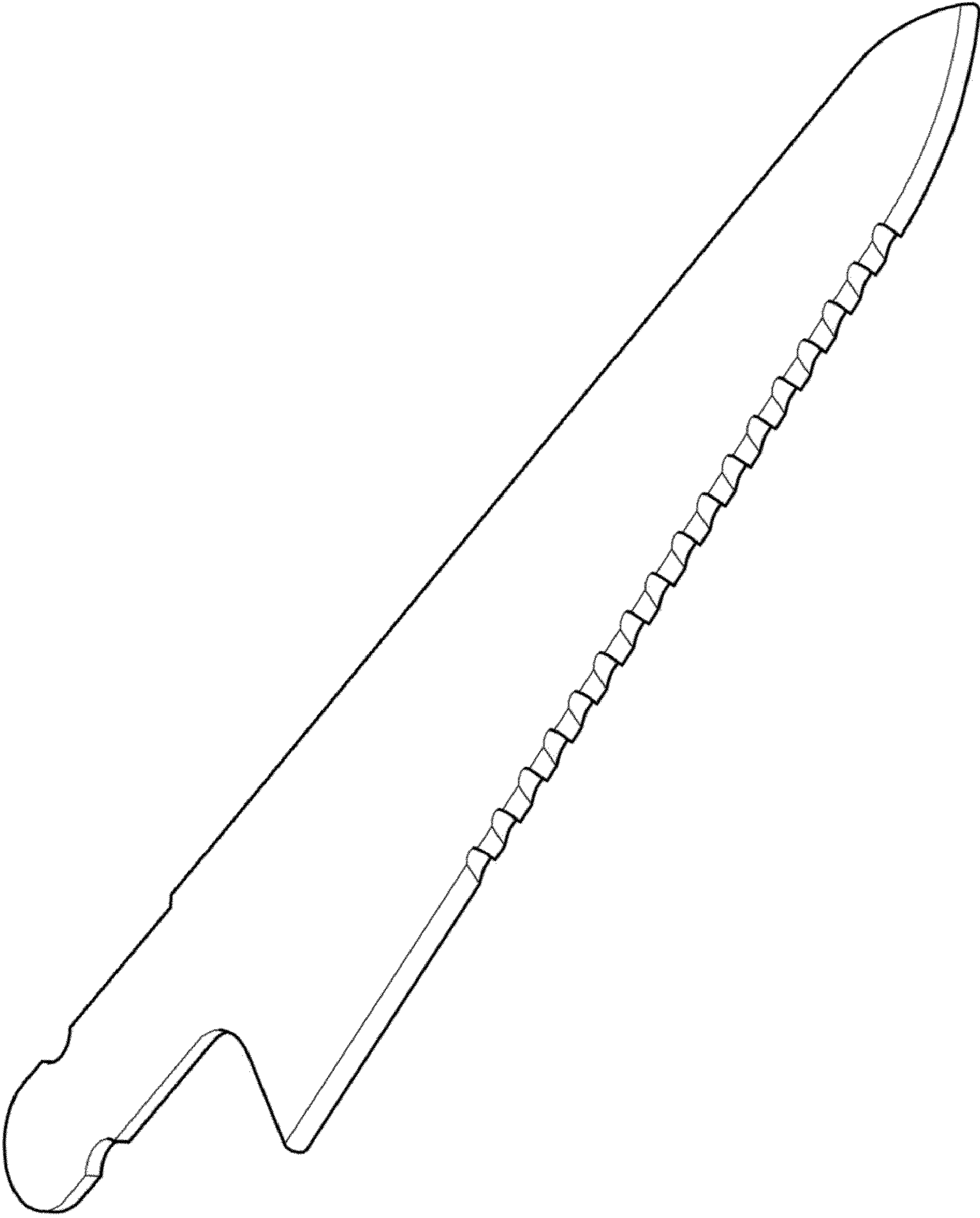

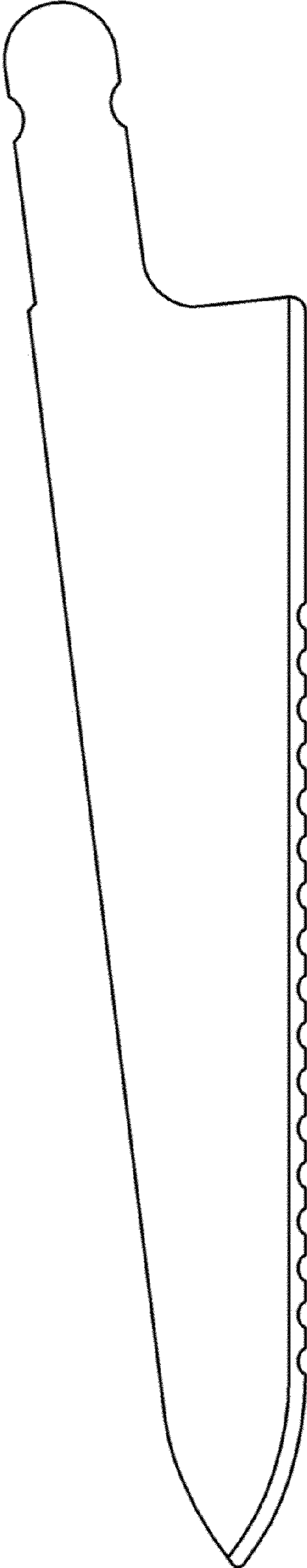

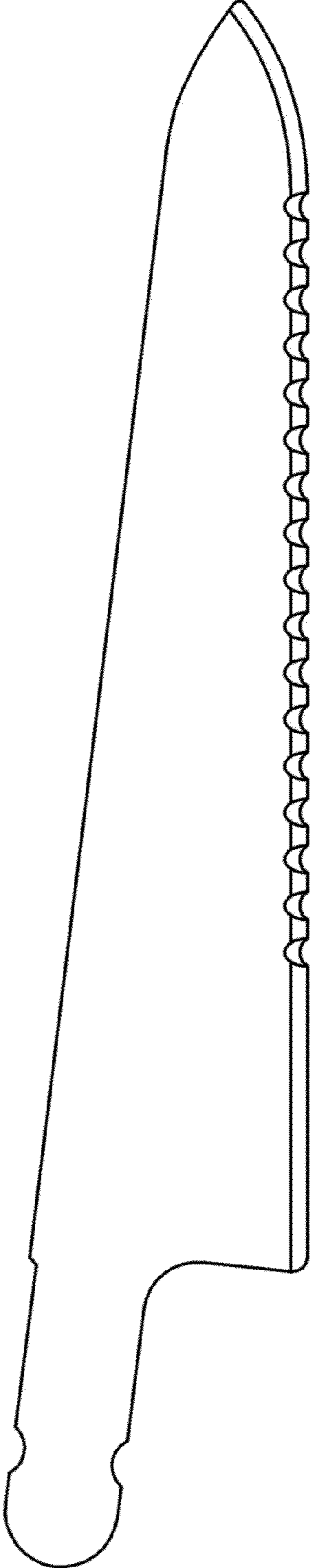

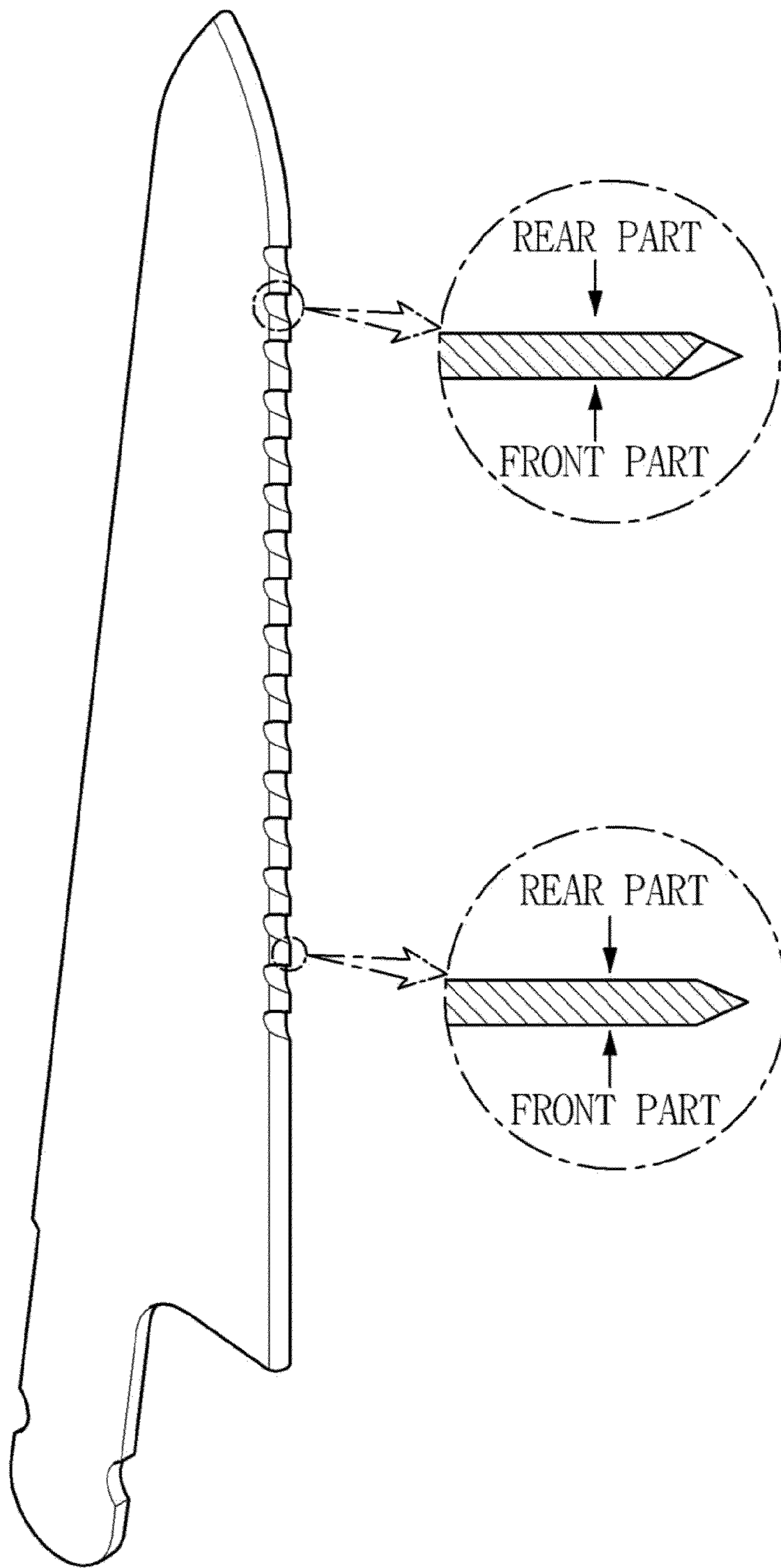
