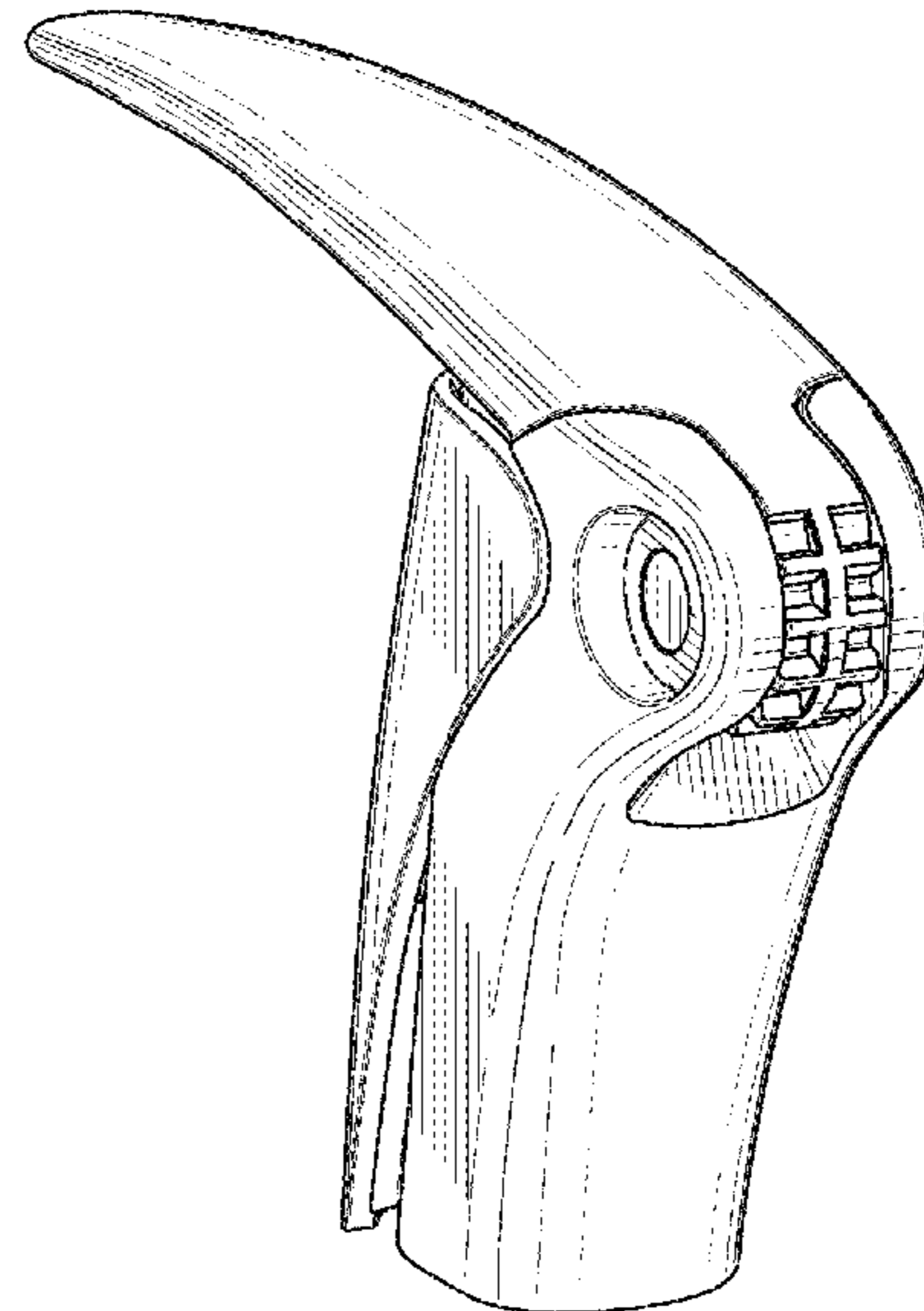
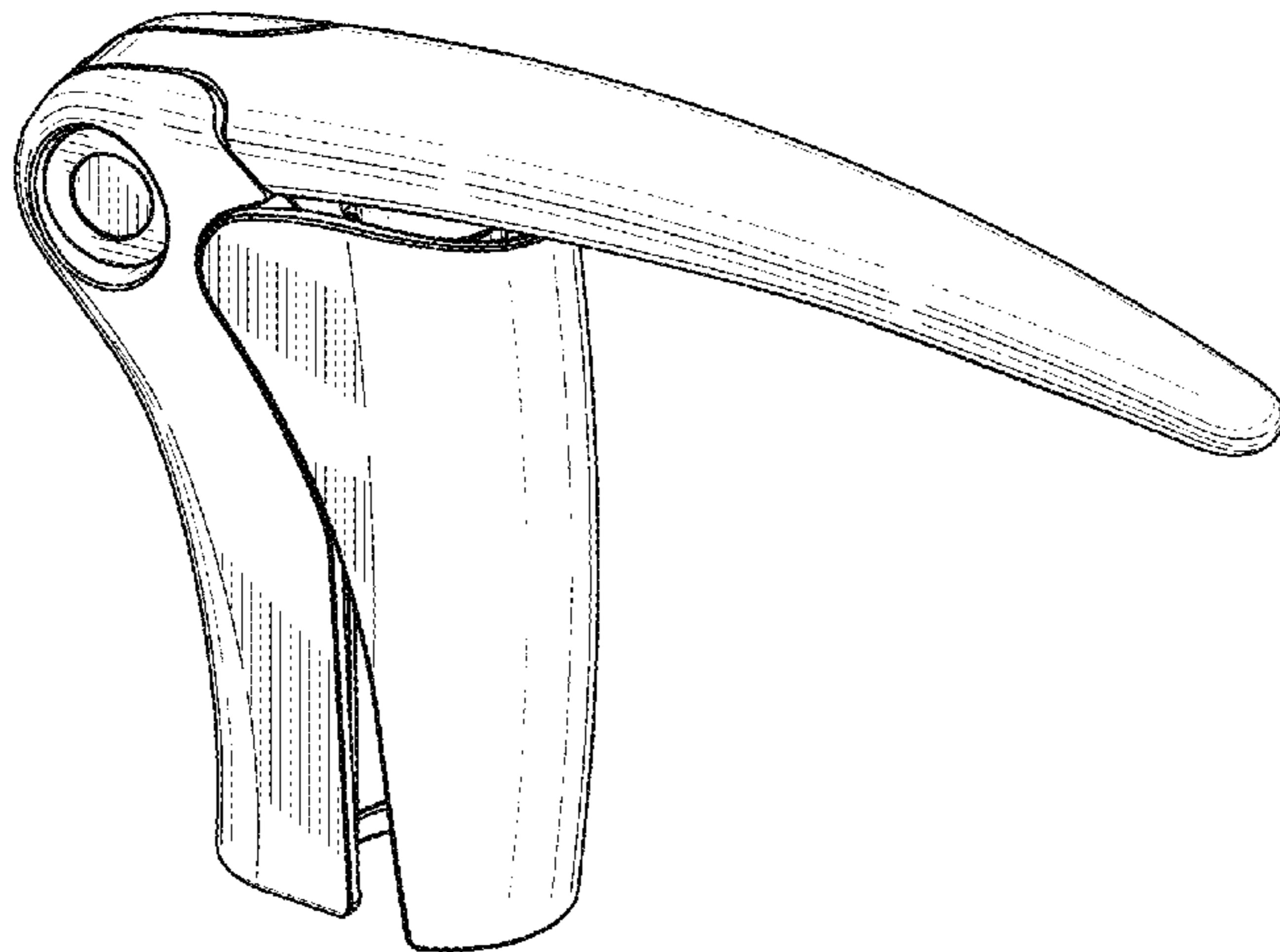
(57) **CLAIM**

The design for a corkscrew, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a corkscrew showing my new design;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a right side elevational view thereof; the left side elevational view being a mirror image thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a front elevational view thereof;
FIG. 6 is a rear elevational view thereof; and,
FIG. 7 is a bottom plan view thereof, with the broken lines depicting portions of corkscrew which form no part of the claimed design.

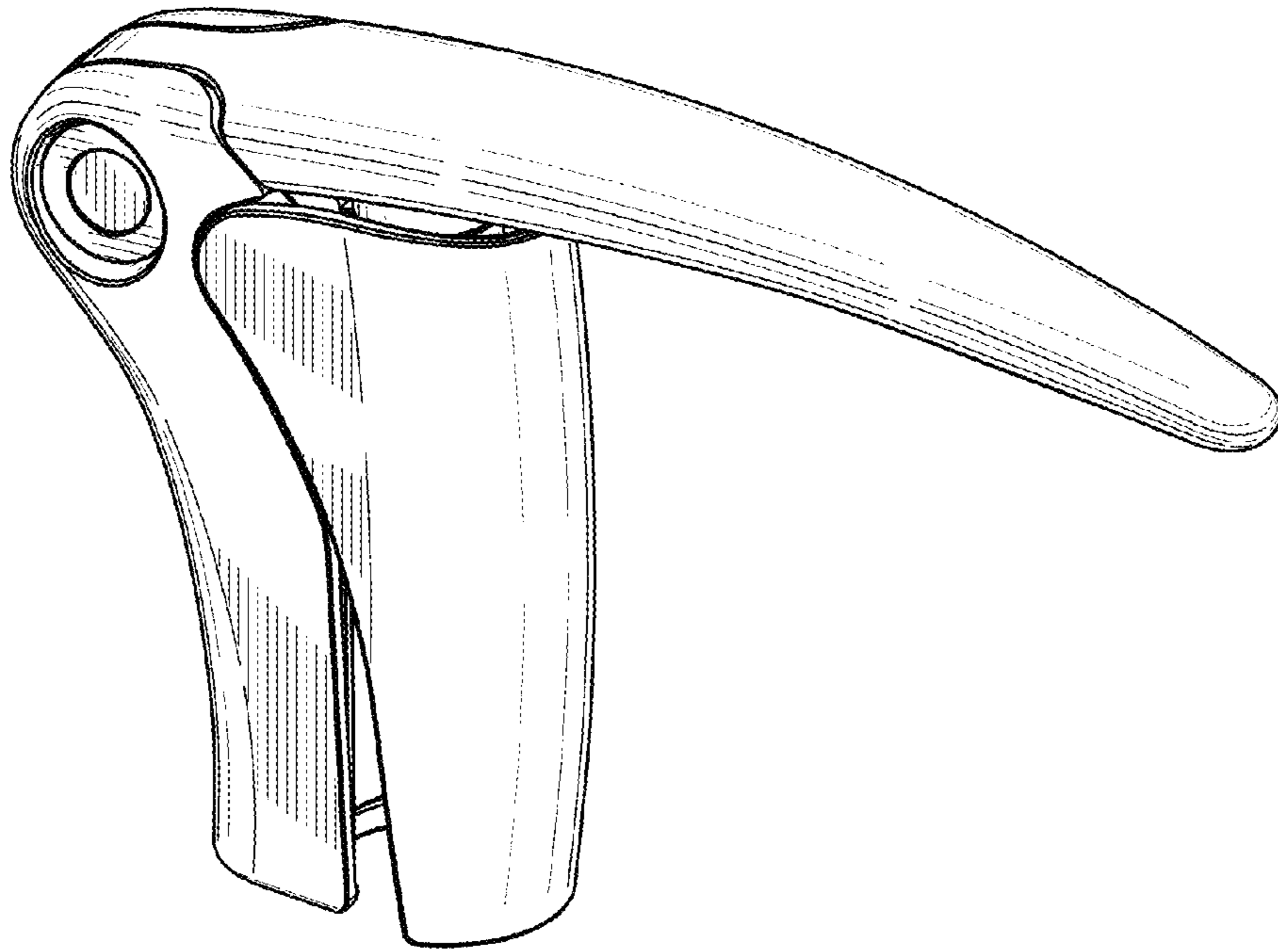

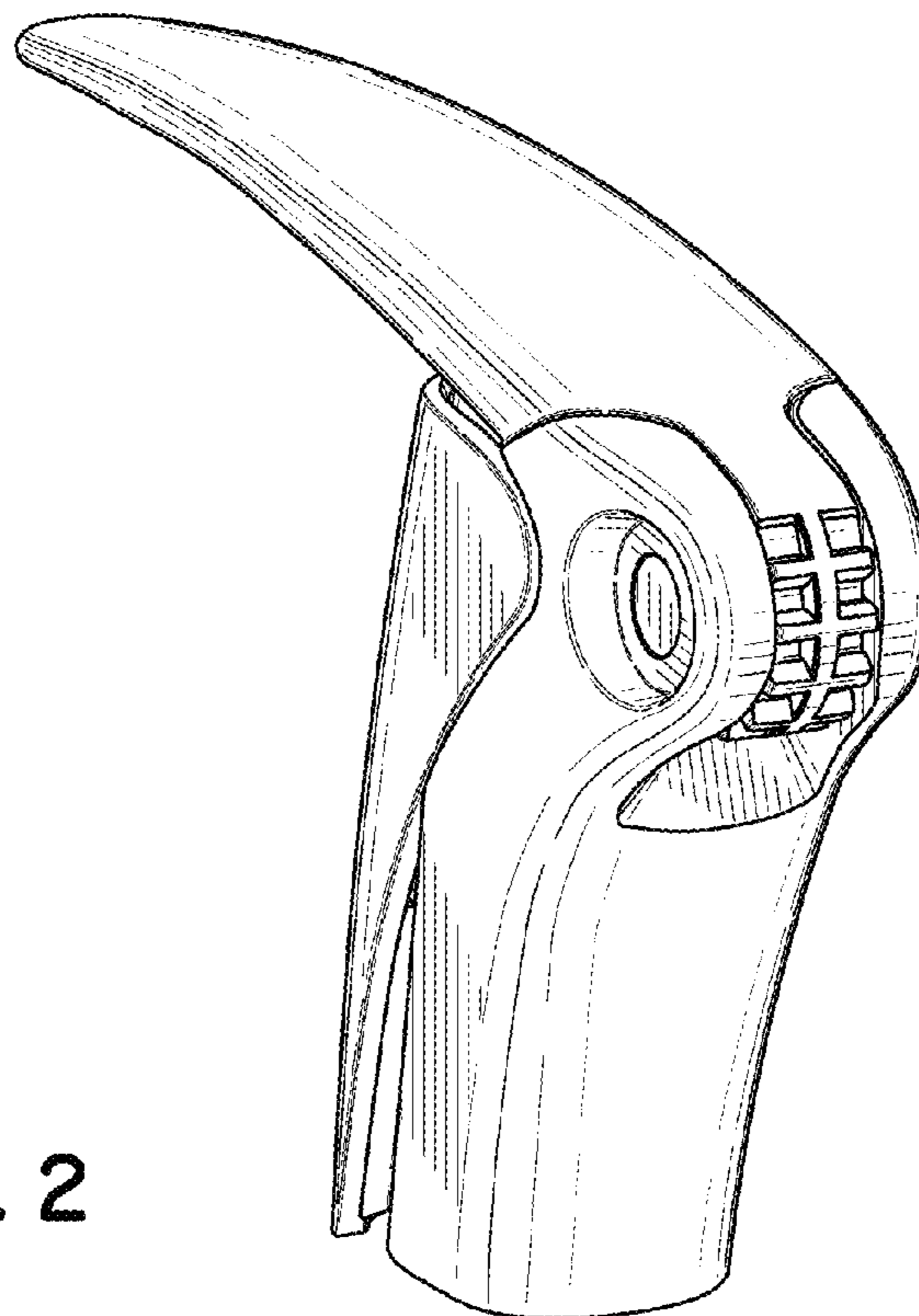

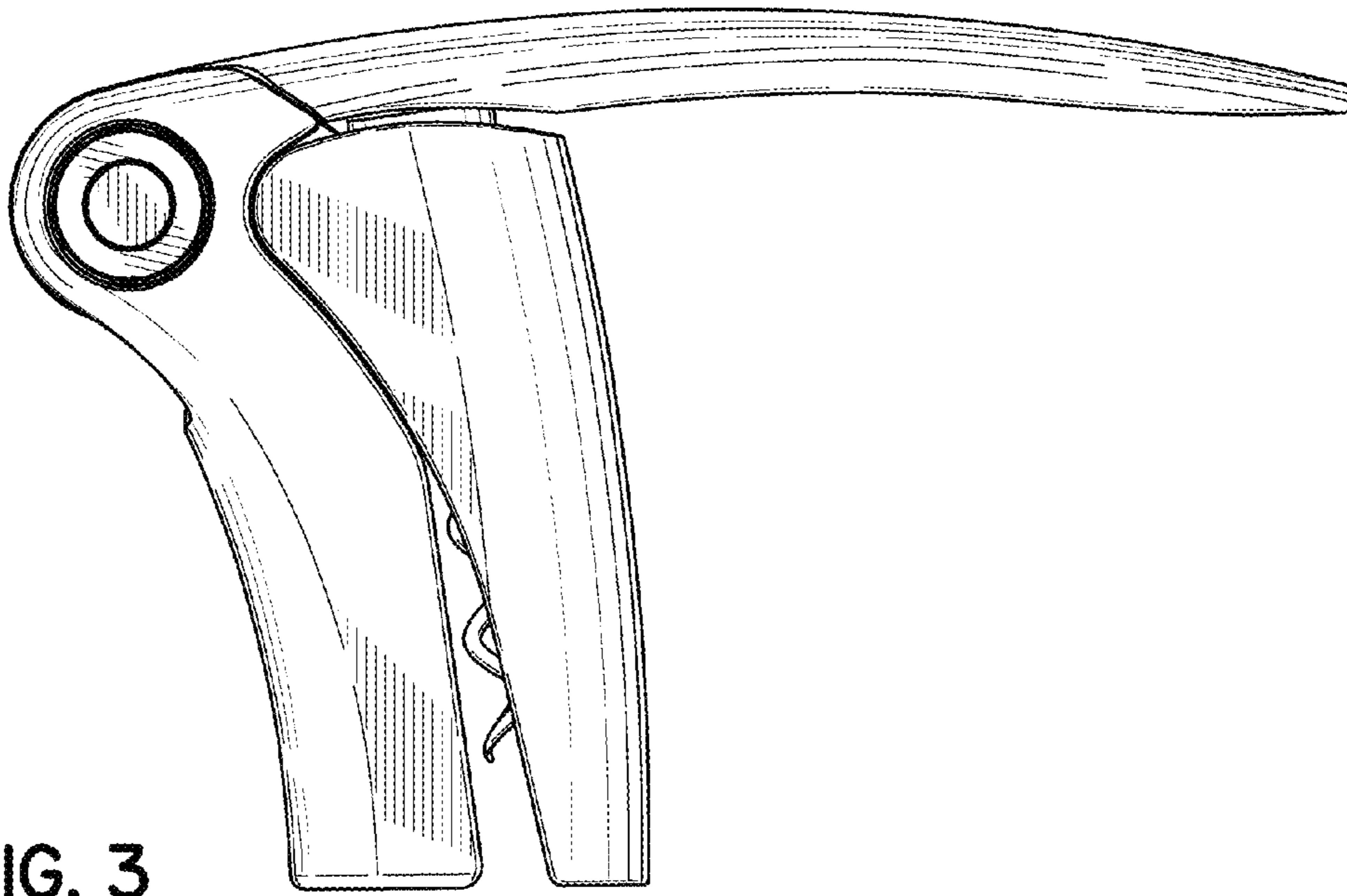

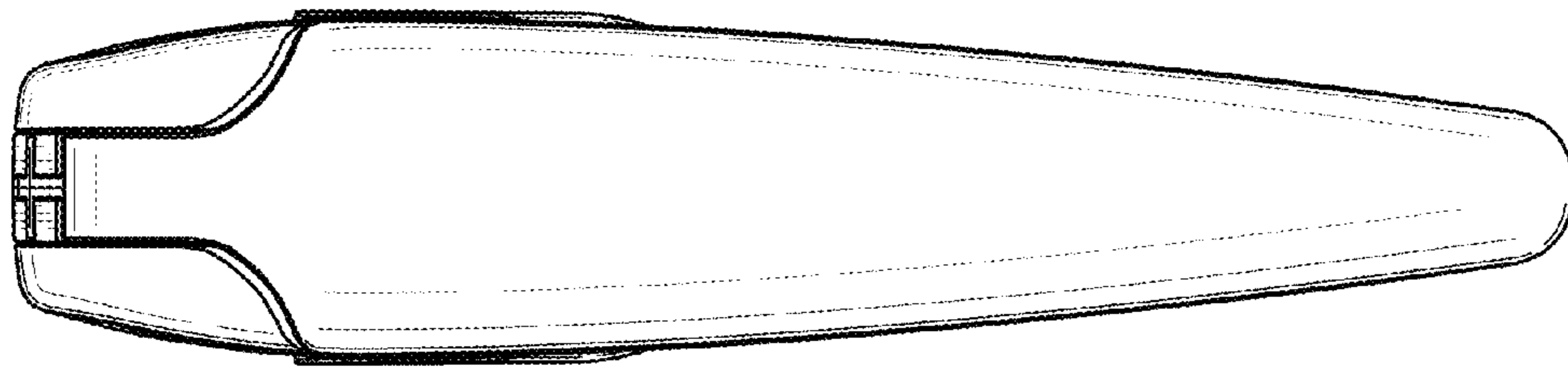

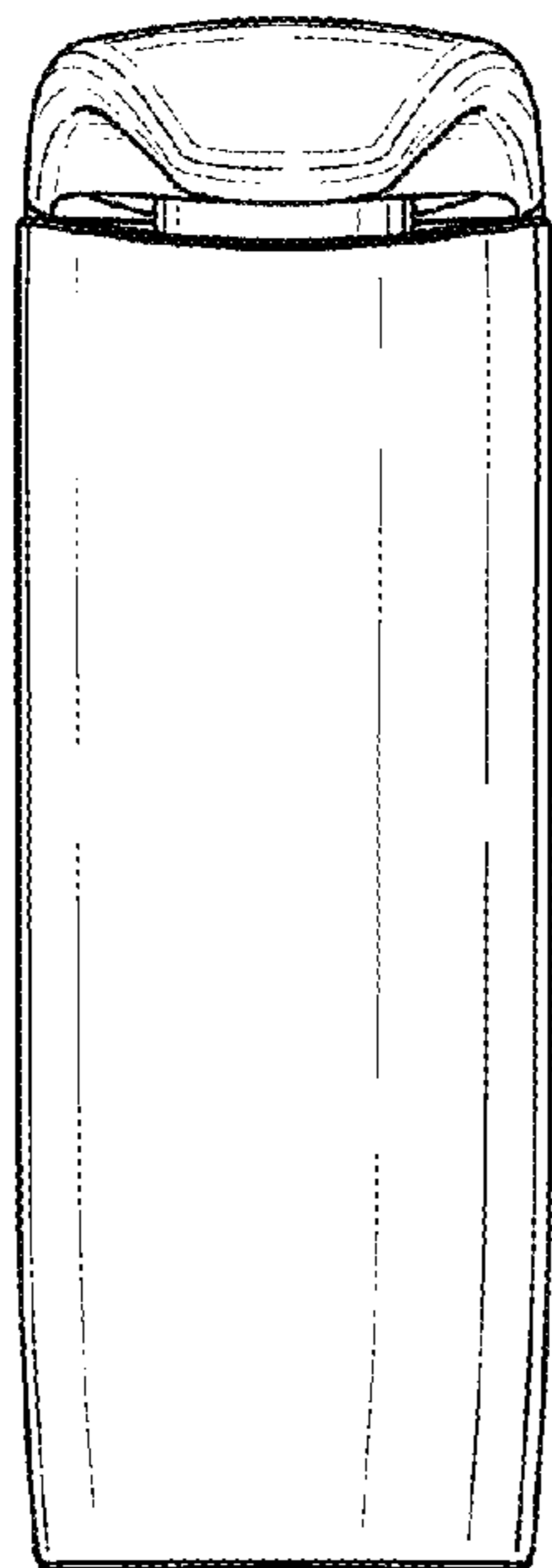

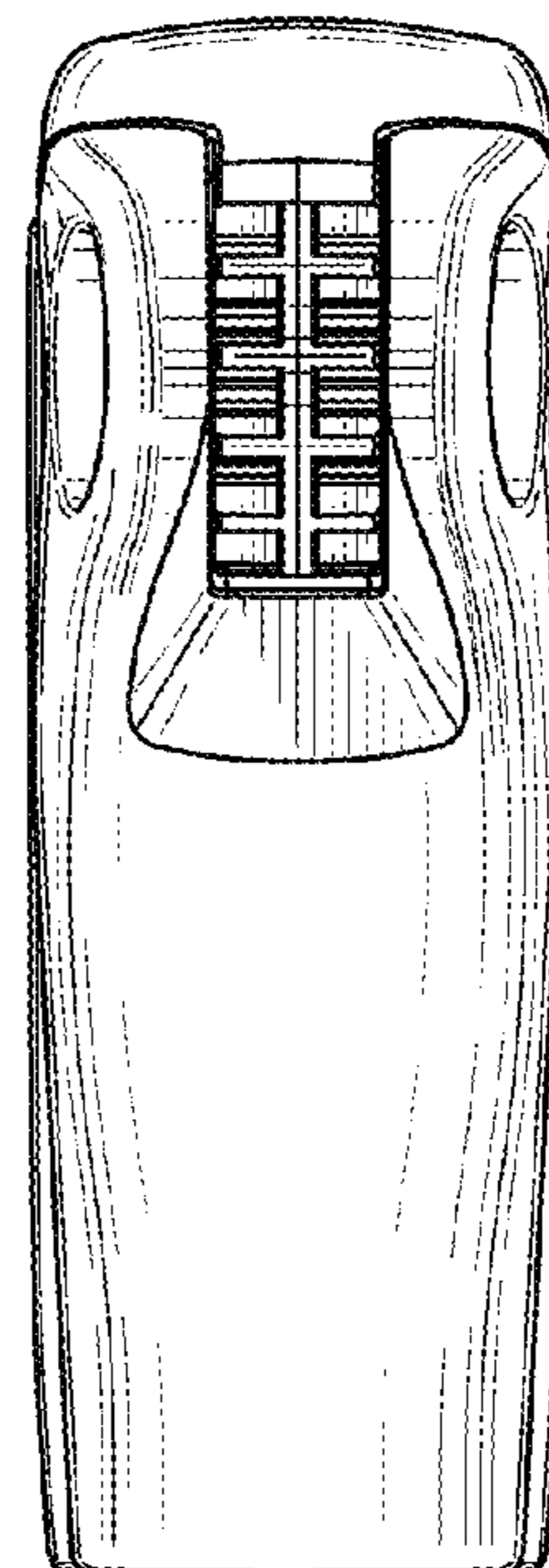

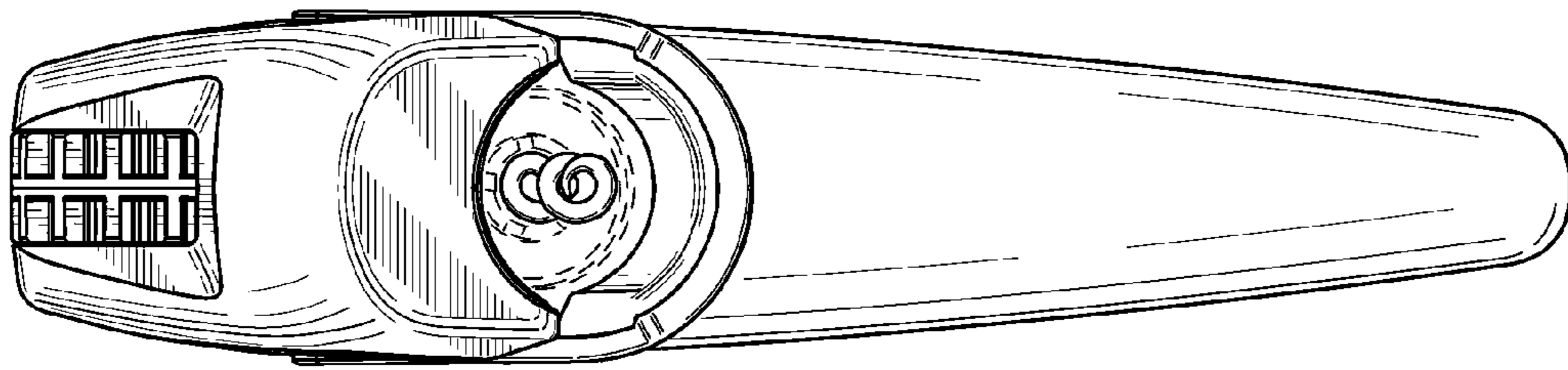
