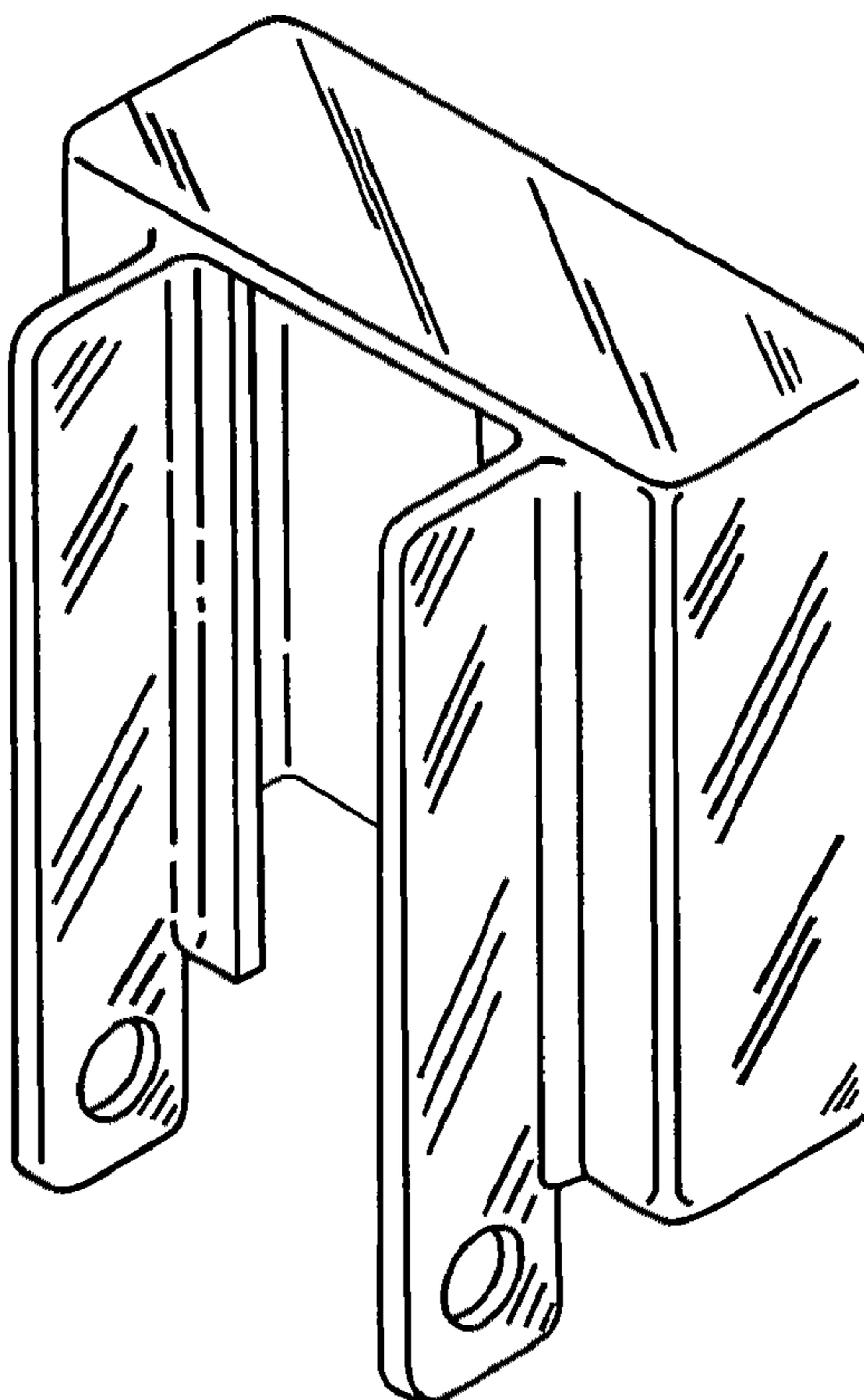
(57) **CLAIM**

The ornamental design for a plow lock, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a plow lock showing my new design, shown in its environmental use;
FIG. 2 is a perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a top plan view thereof;

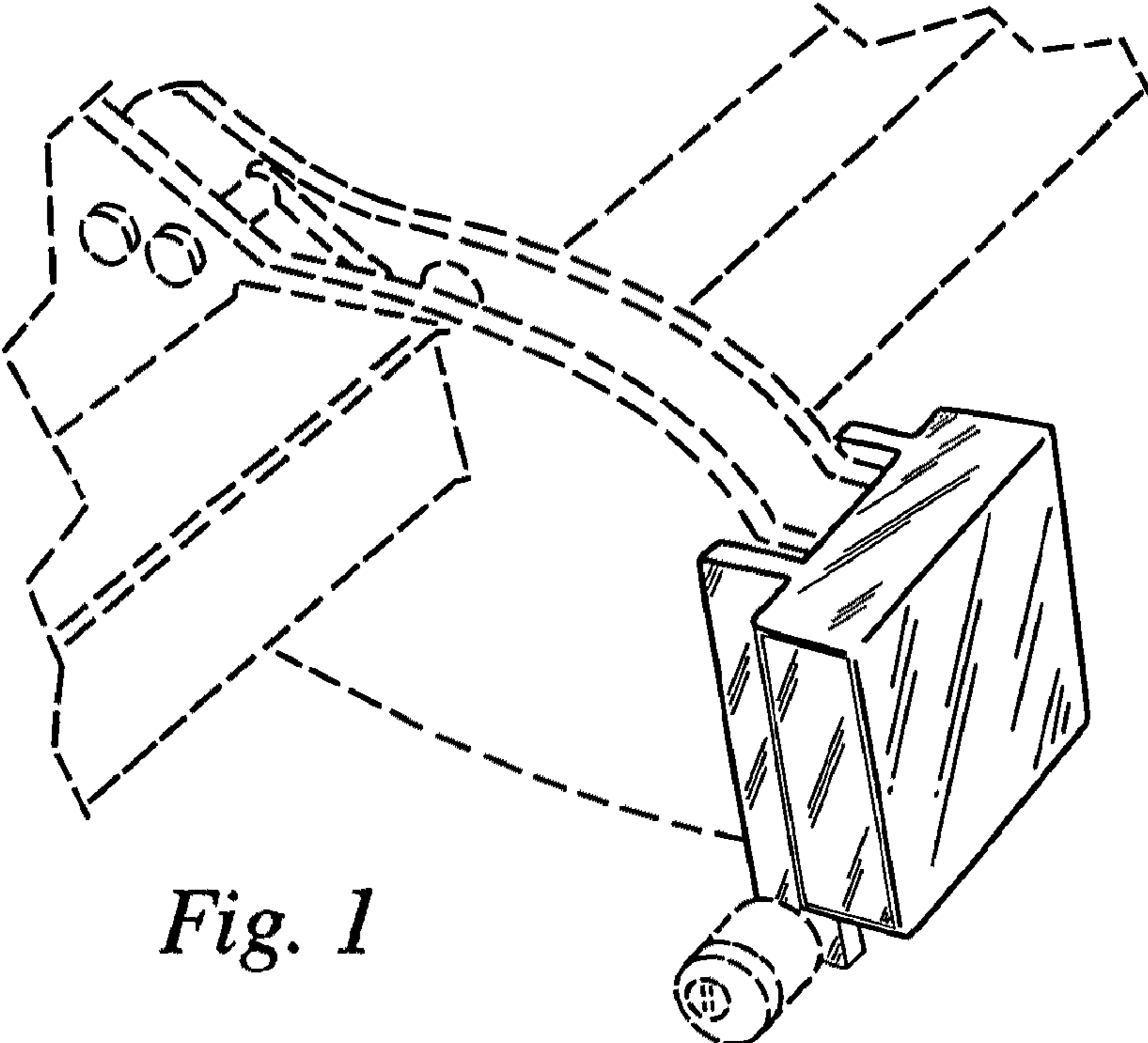

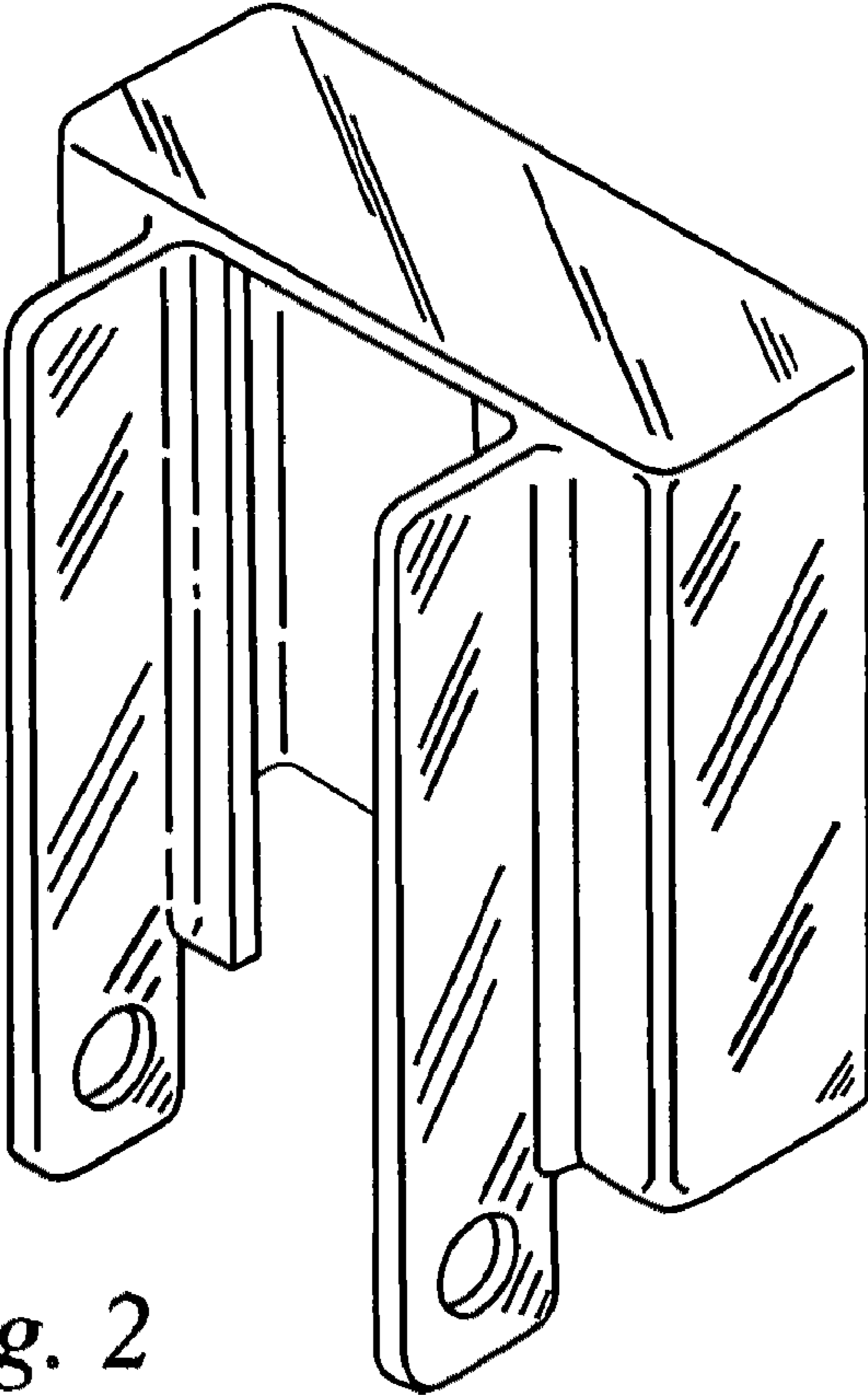

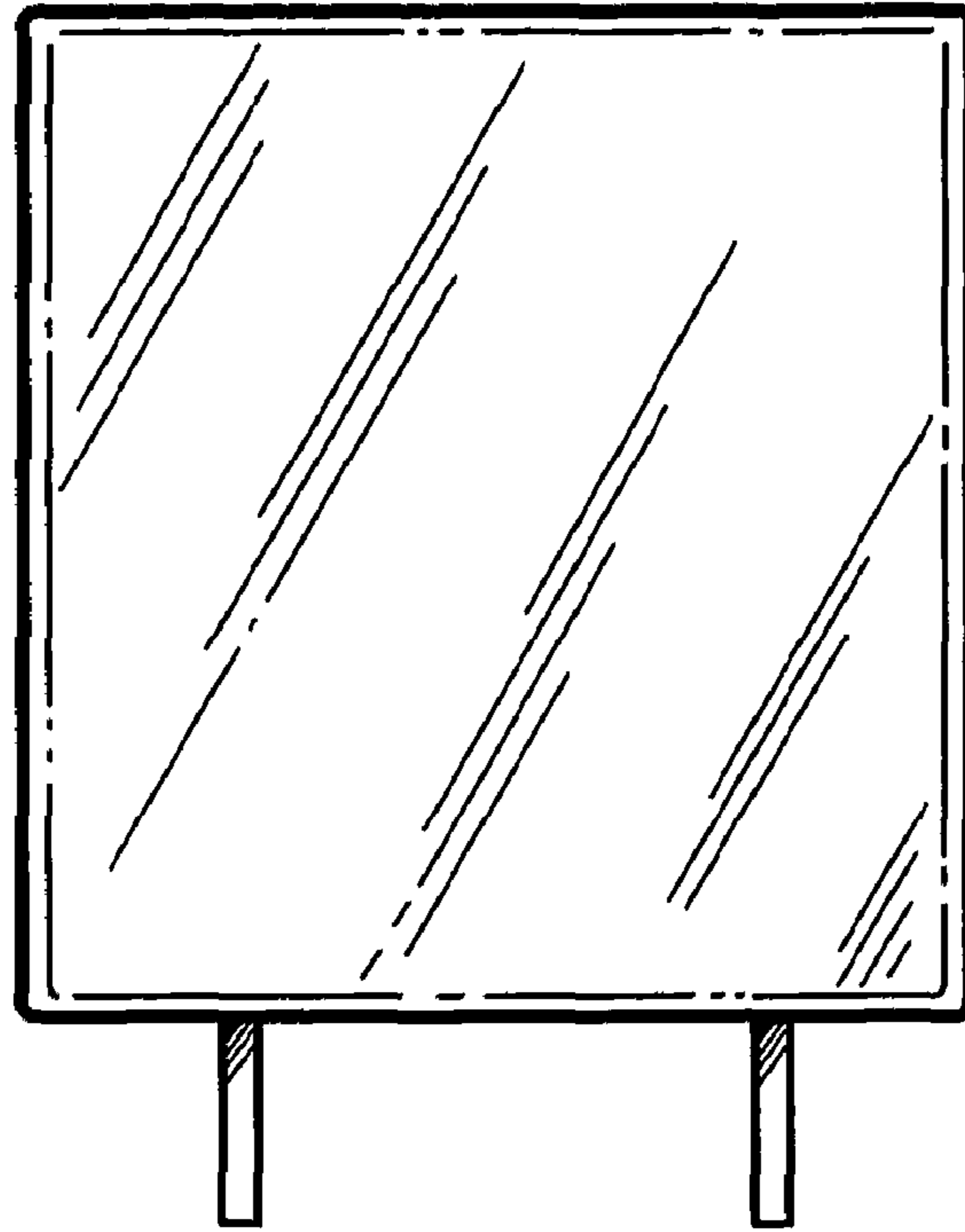

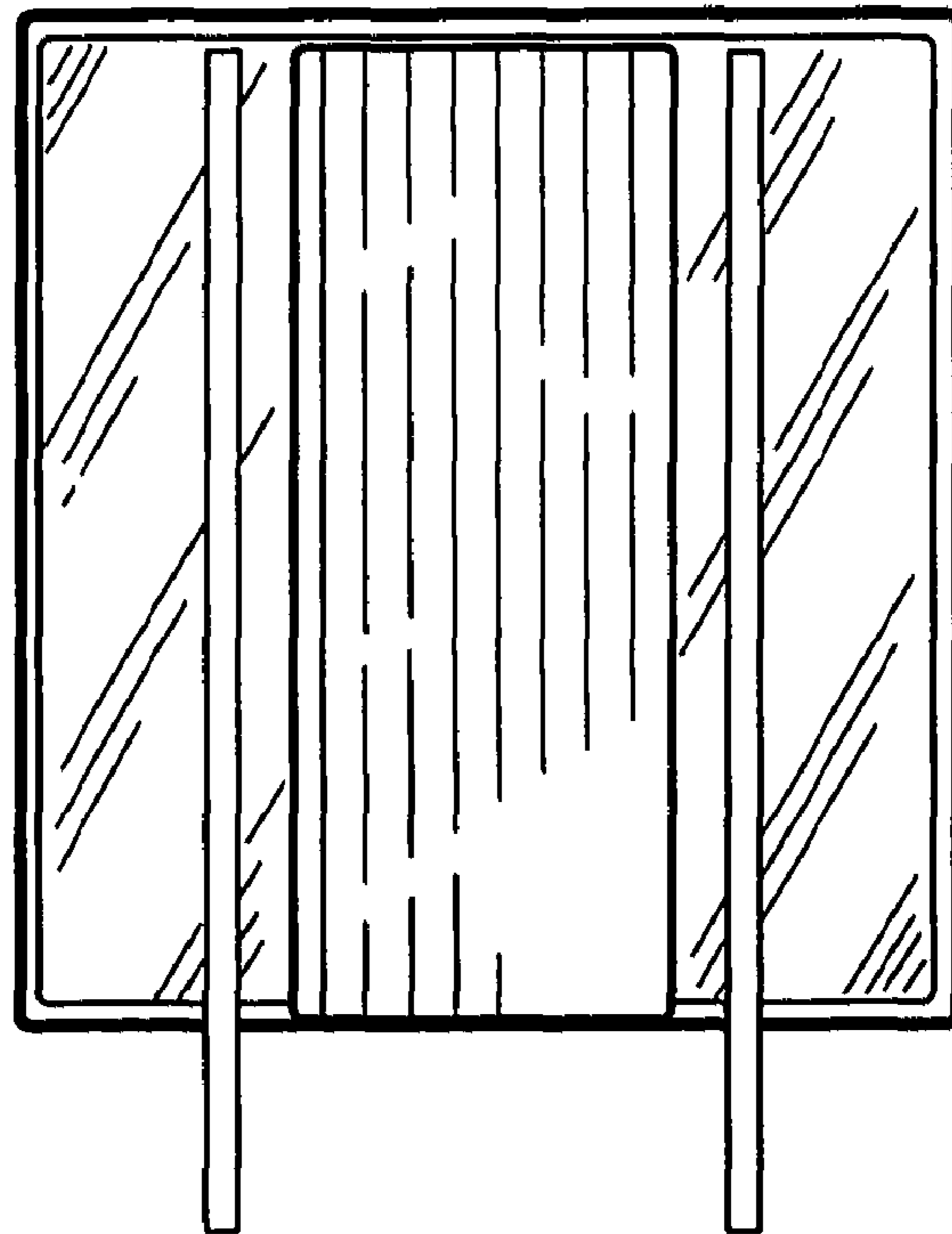

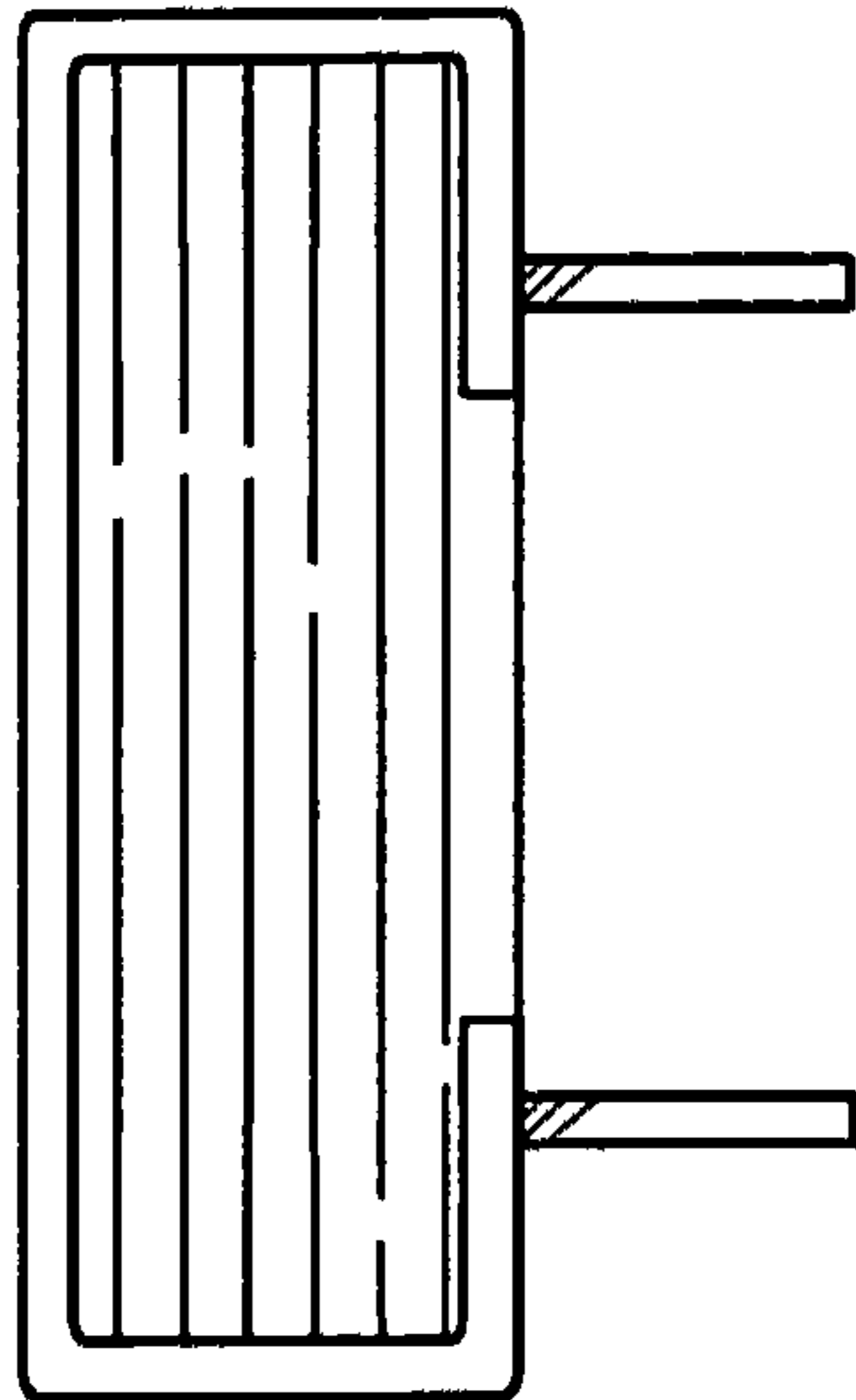

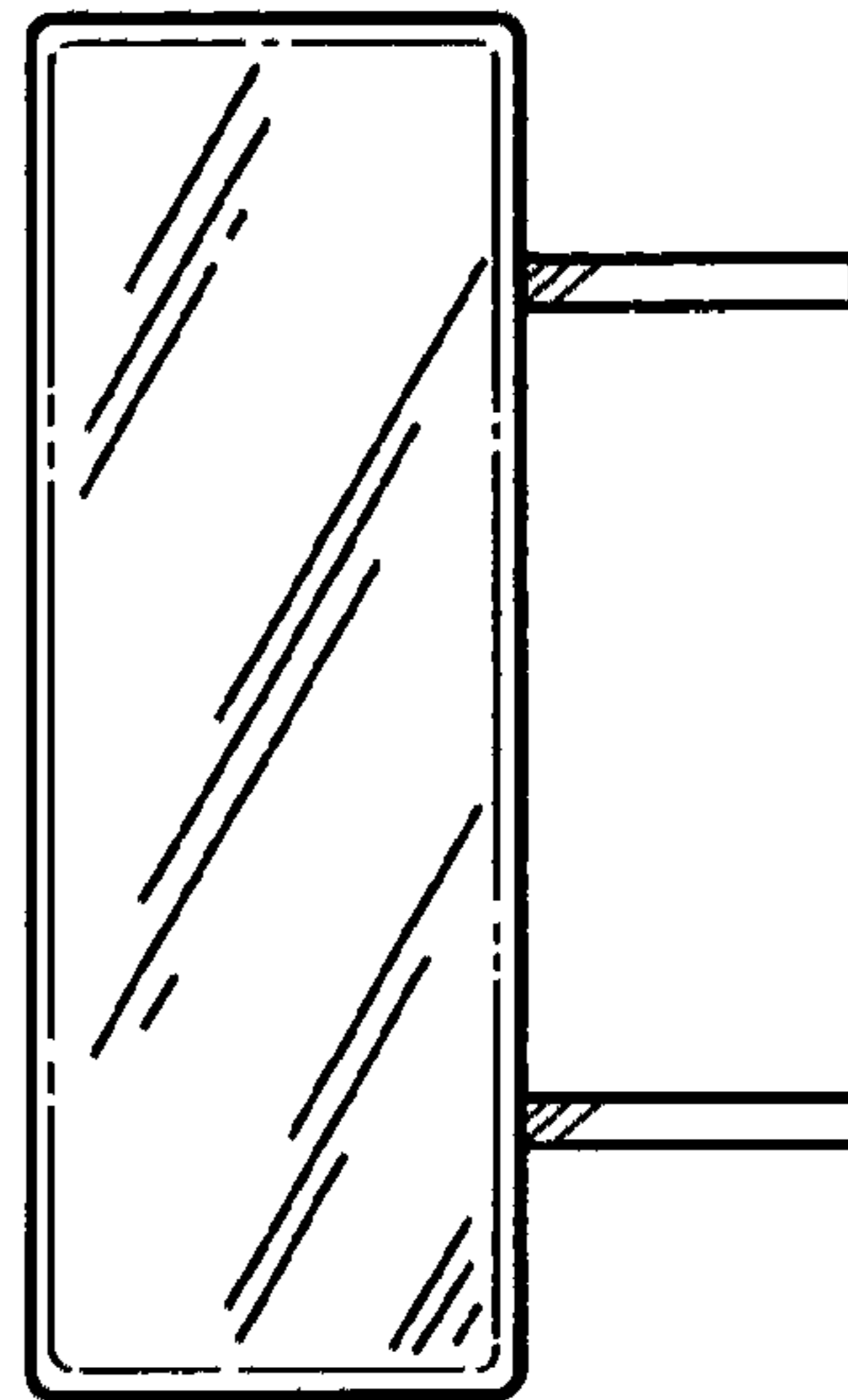

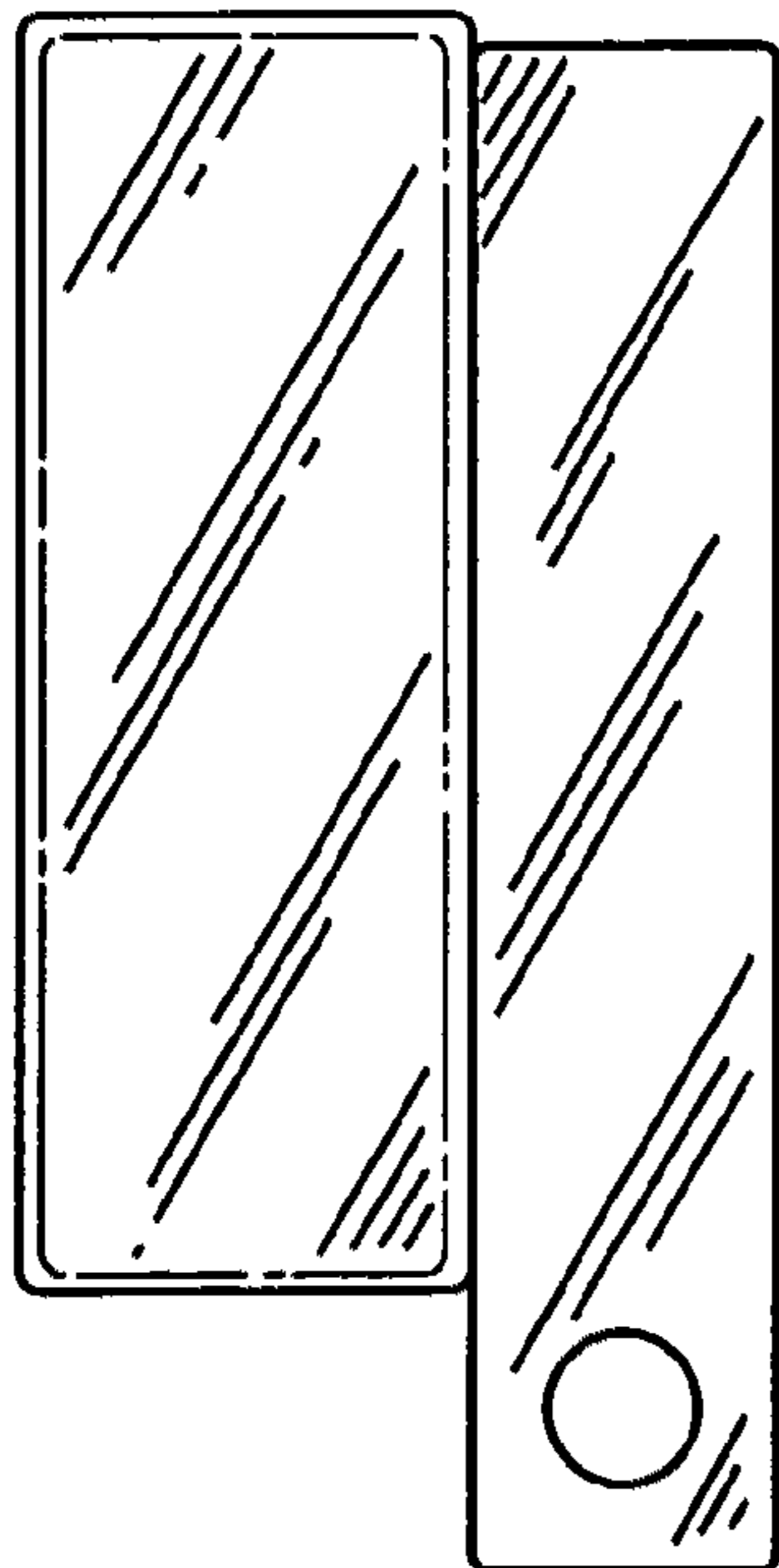

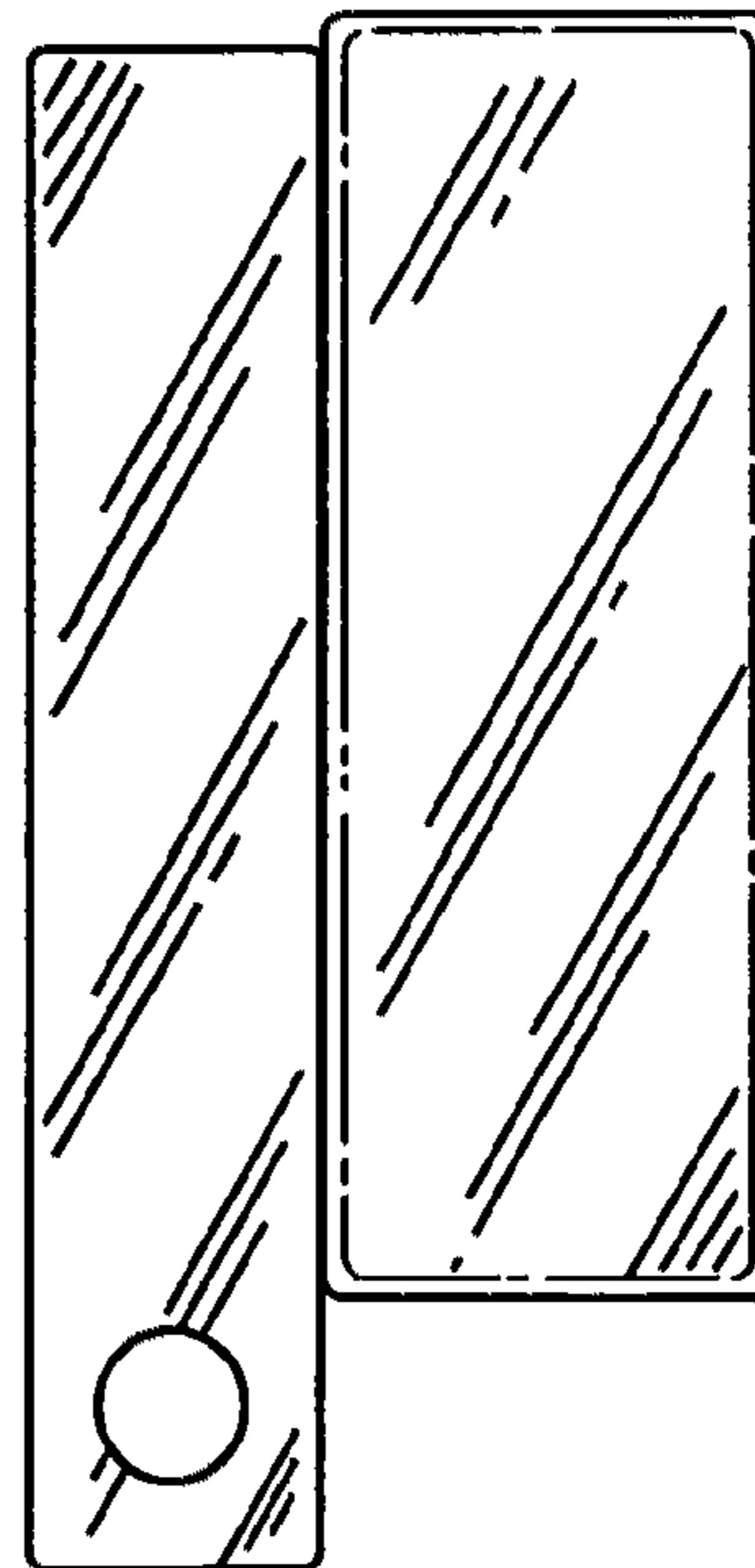
