(57) **CLAIM**

The ornamental design for a food packaging for frozen or shelf-stable foods, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a food packaging for frozen or shelf-stable foods showing my new design.

FIG. 2 is a top plan view of the first embodiment of the food packaging for frozen or shelf-stable foods of FIG. 1.

FIG. 3 is a bottom plan view of the first embodiment of the food packaging for frozen or shelf-stable foods of FIG. 1.

FIG. 4 is a left elevation view of the first embodiment of the food packaging for frozen or shelf-stable foods of FIG. 1.

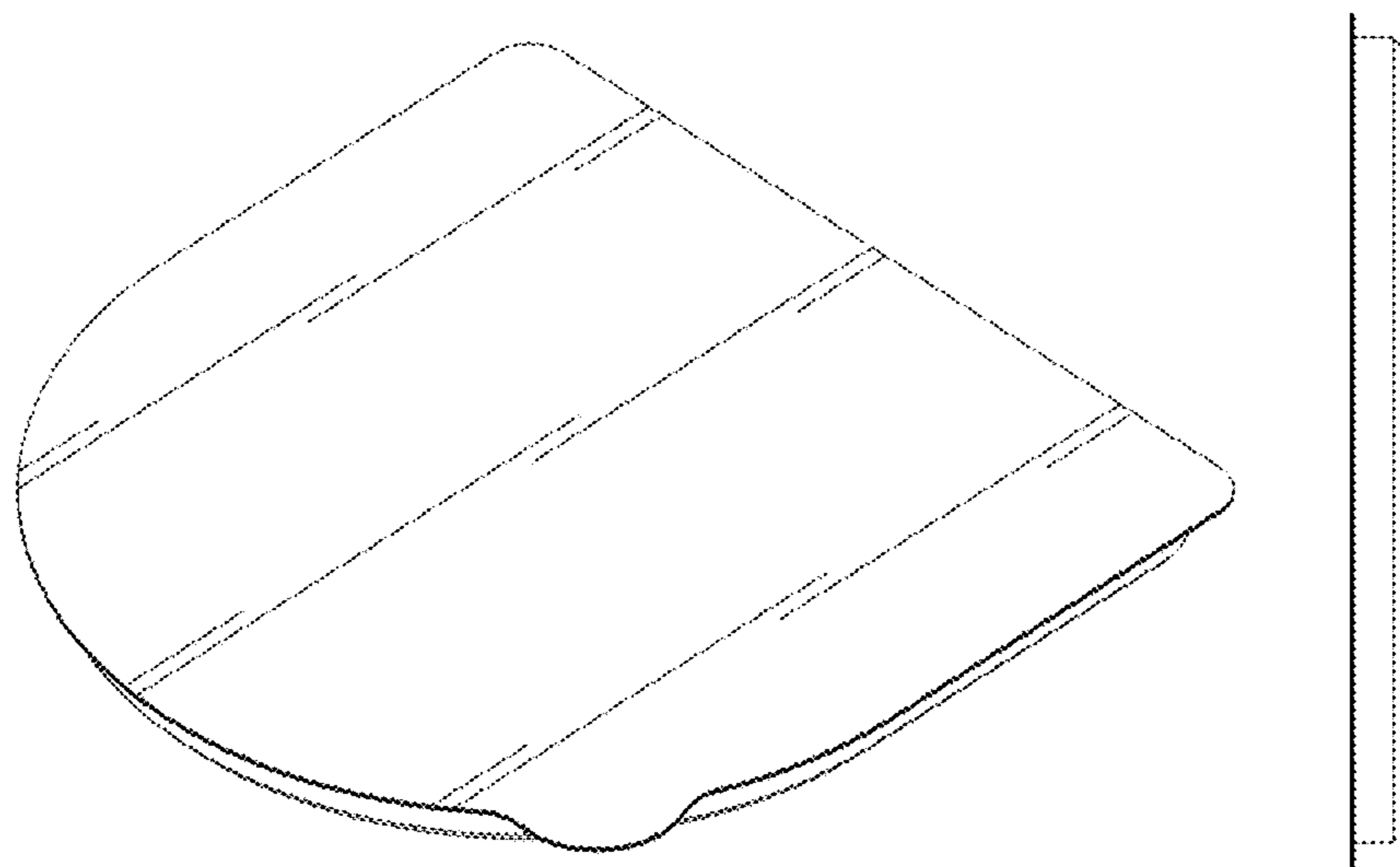
FIG. 5 is a right elevation view of the first embodiment of the food packaging for frozen or shelf-stable foods of FIG. 1.

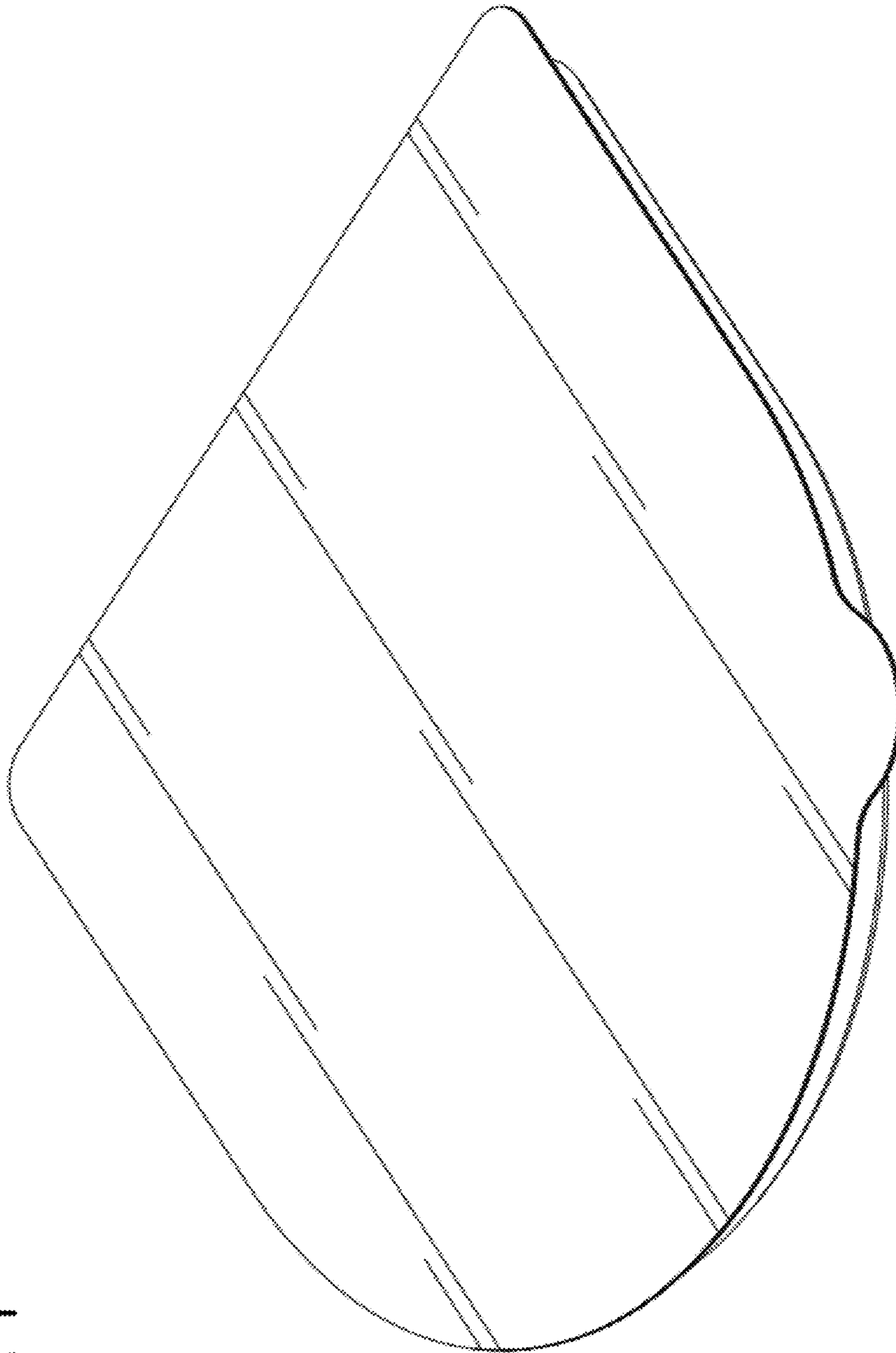

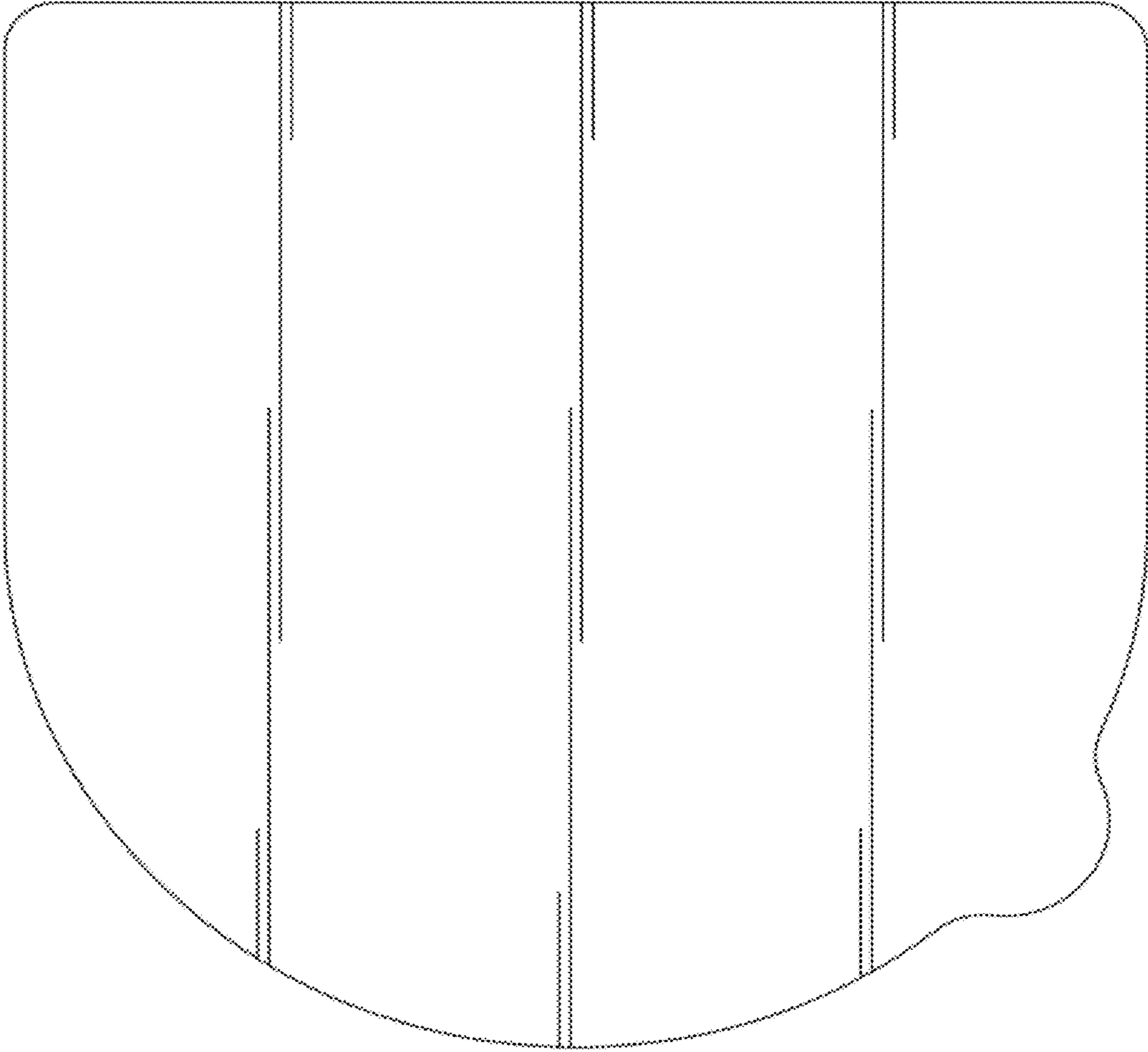

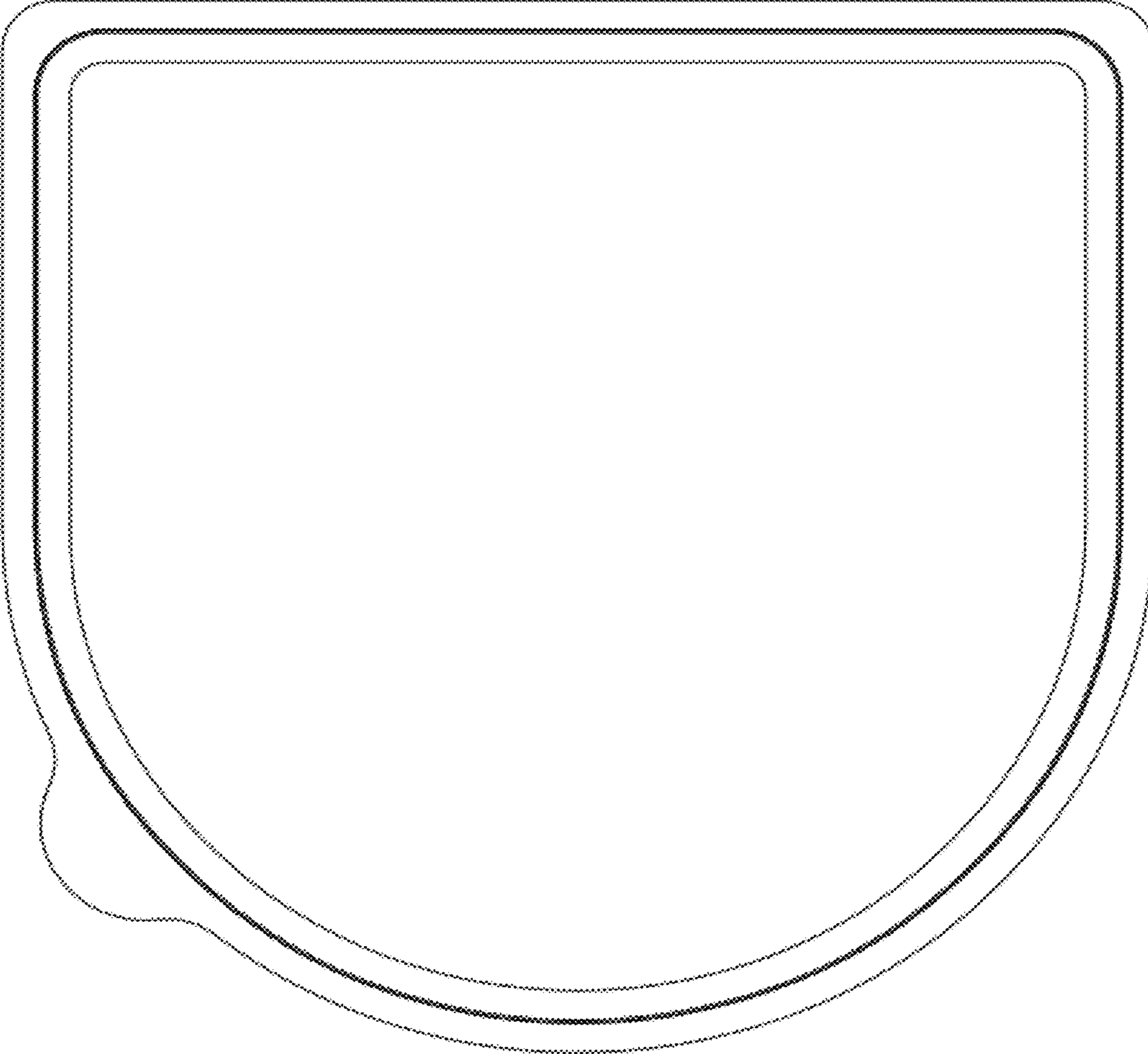

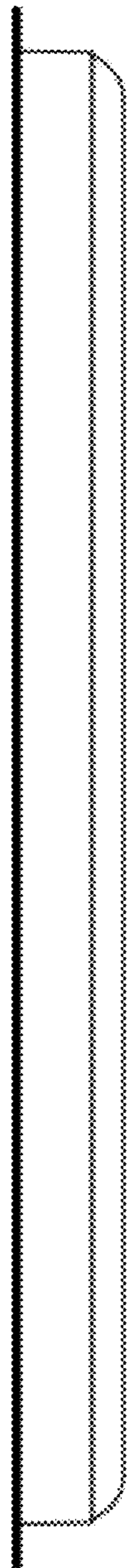
