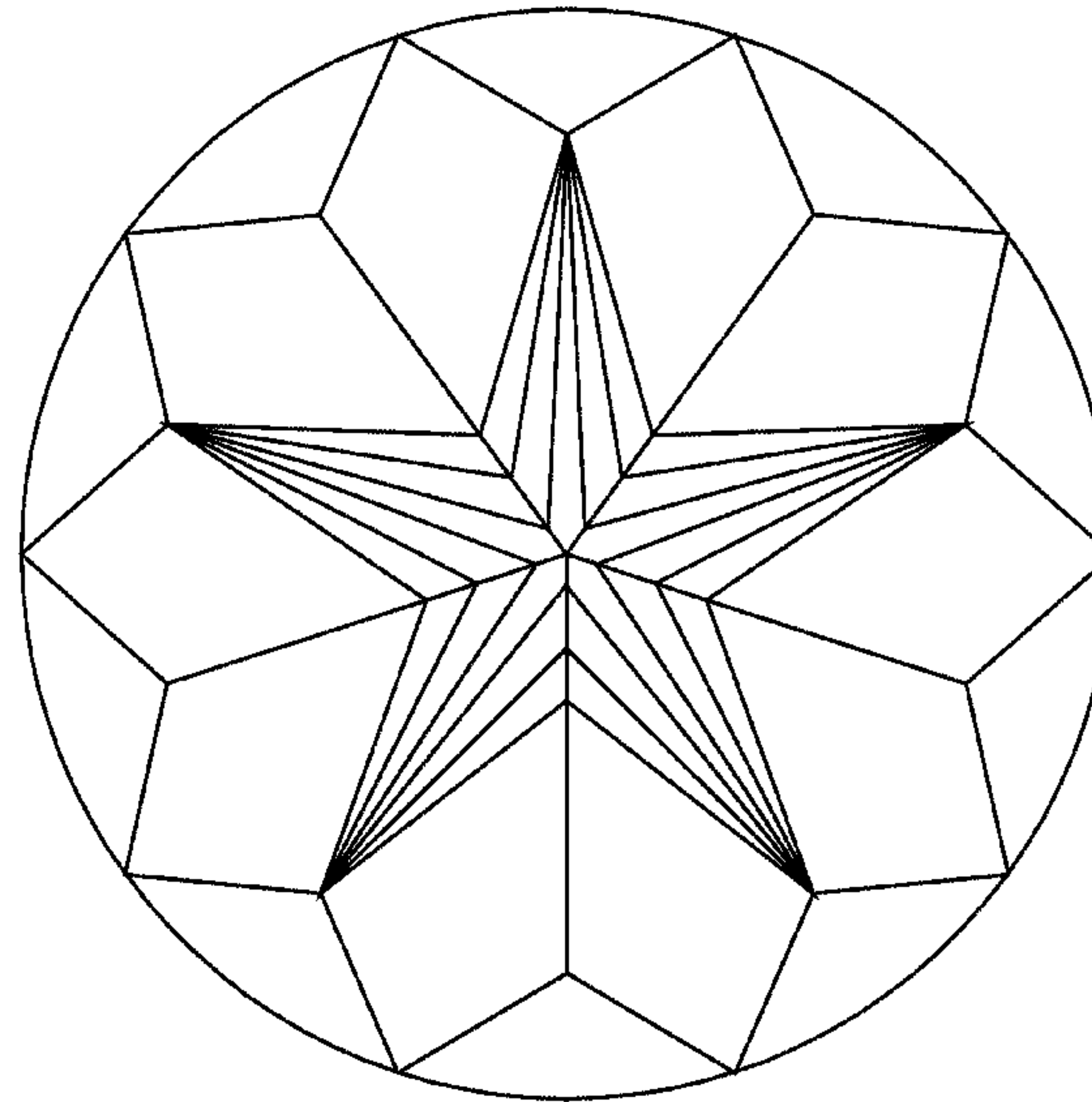
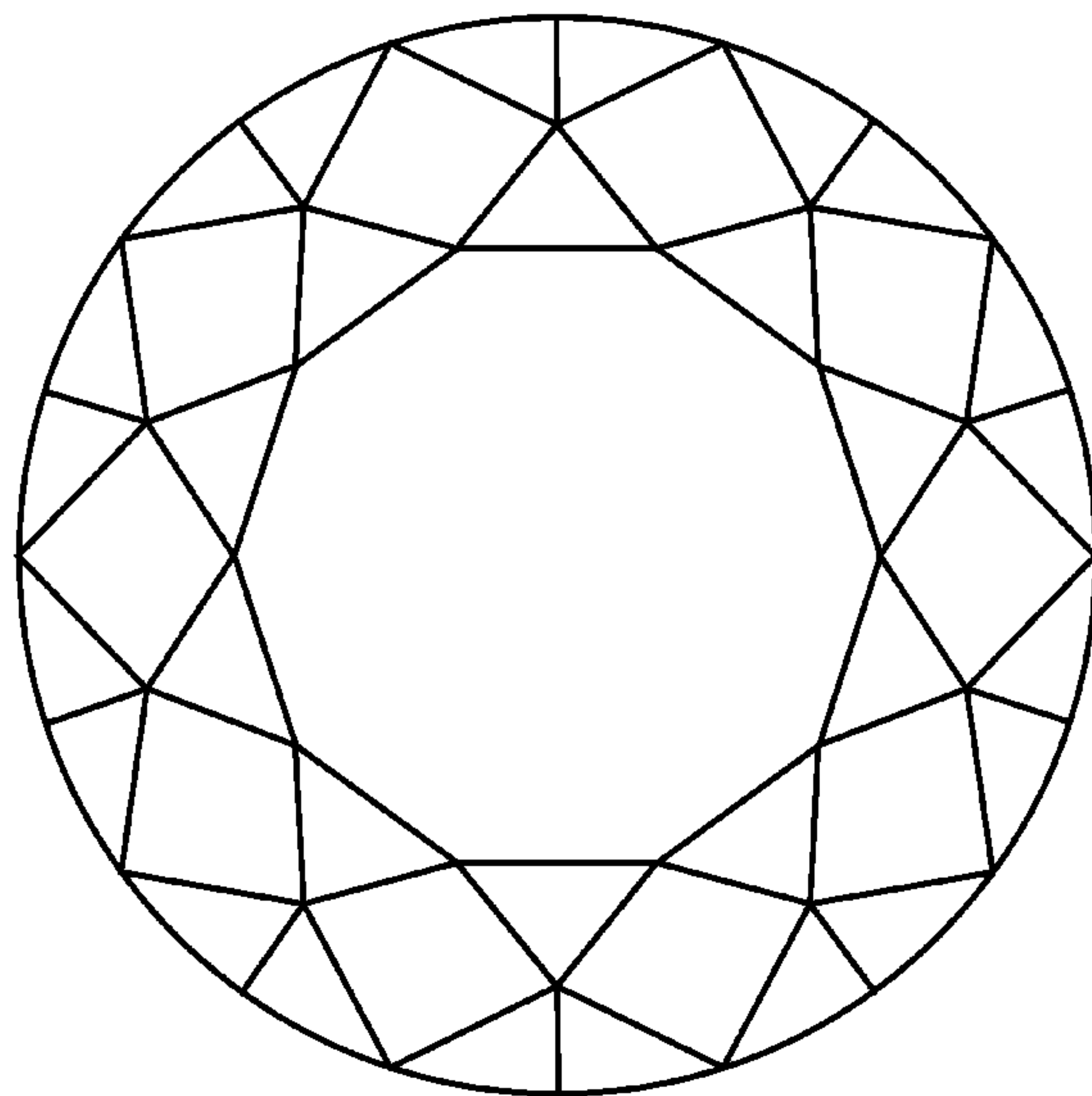

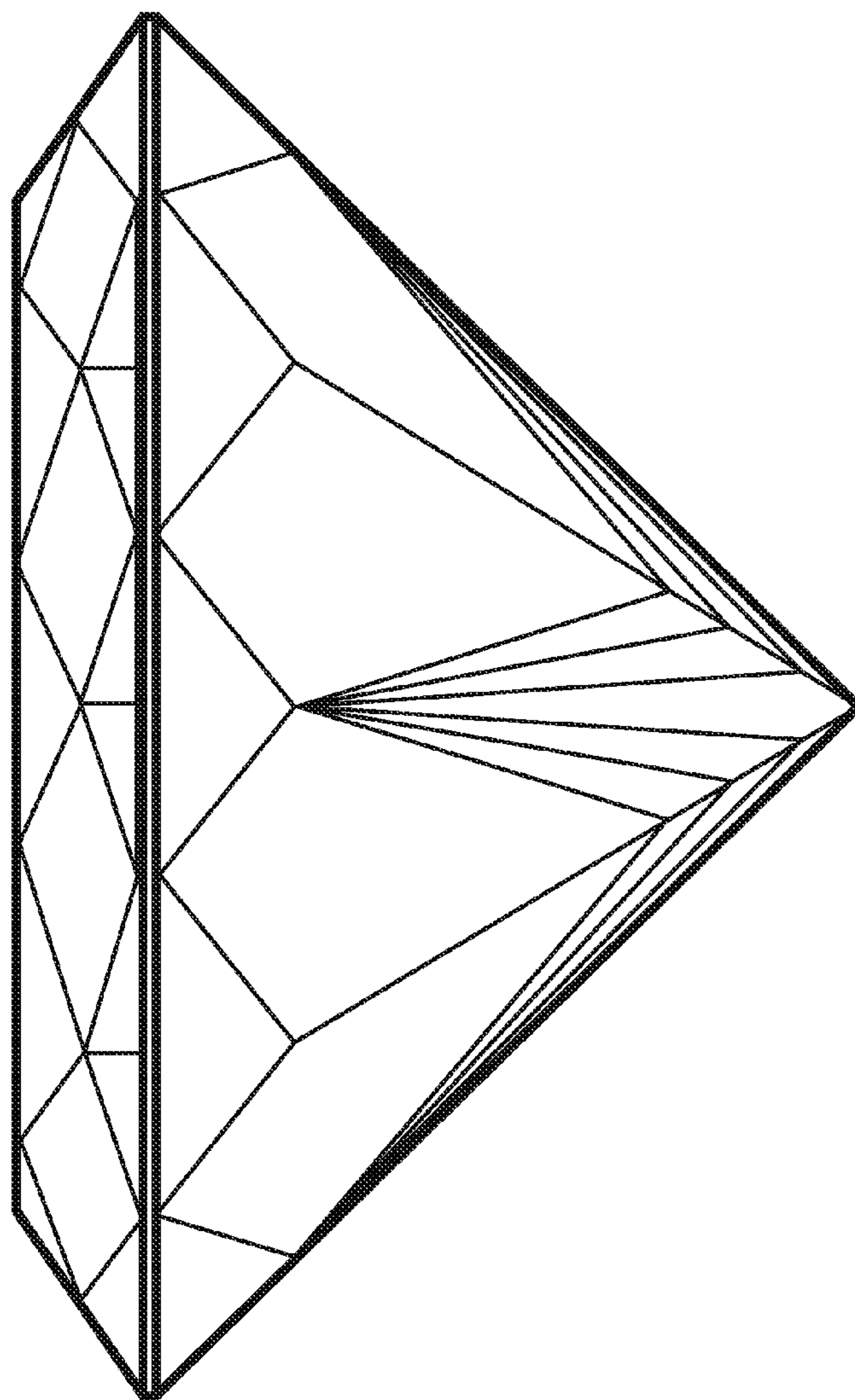
FIG. 1 is a side view of a gemstone;

FIG. 3 is a bottom view thereof, showing the pavilion.

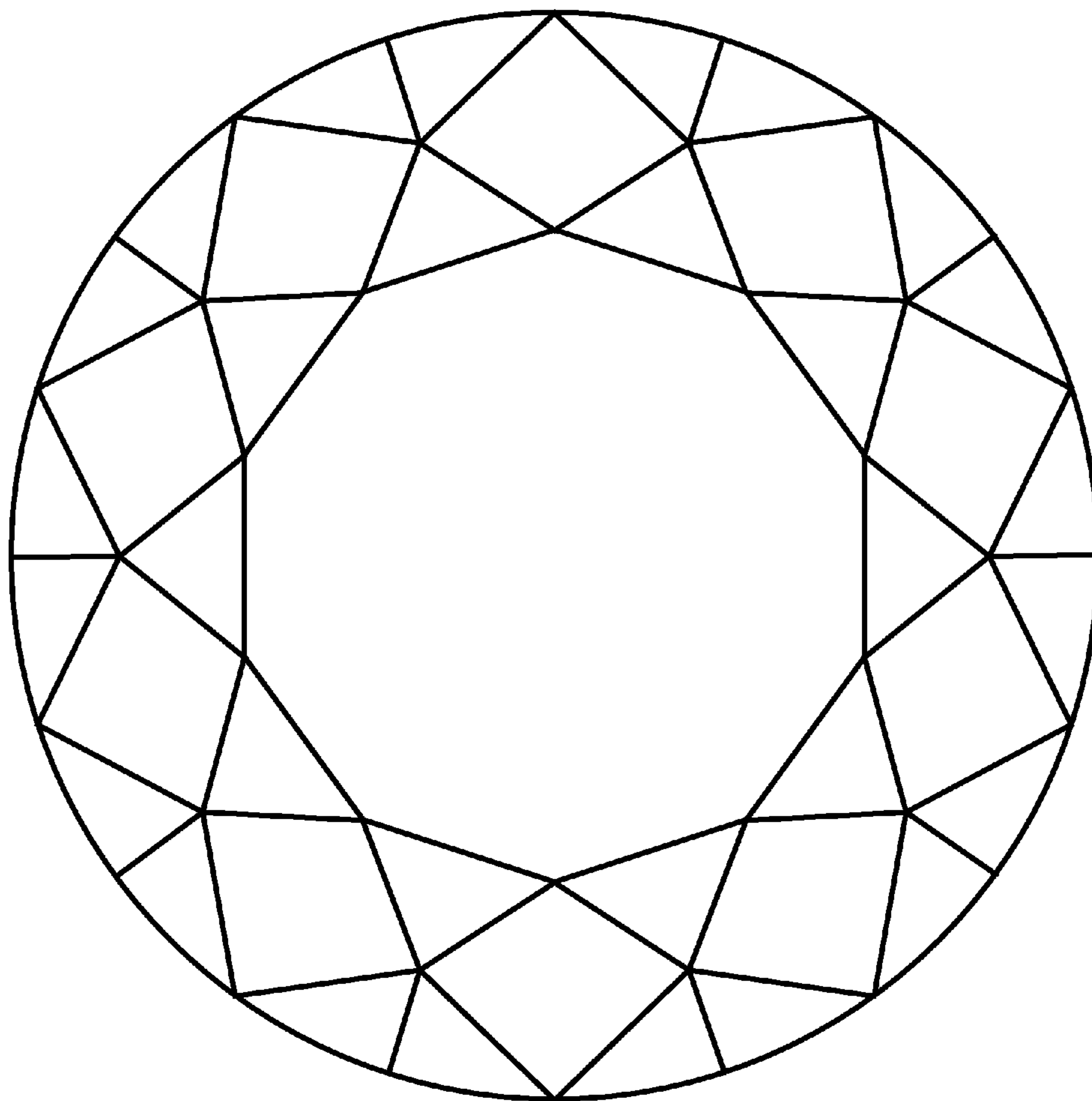

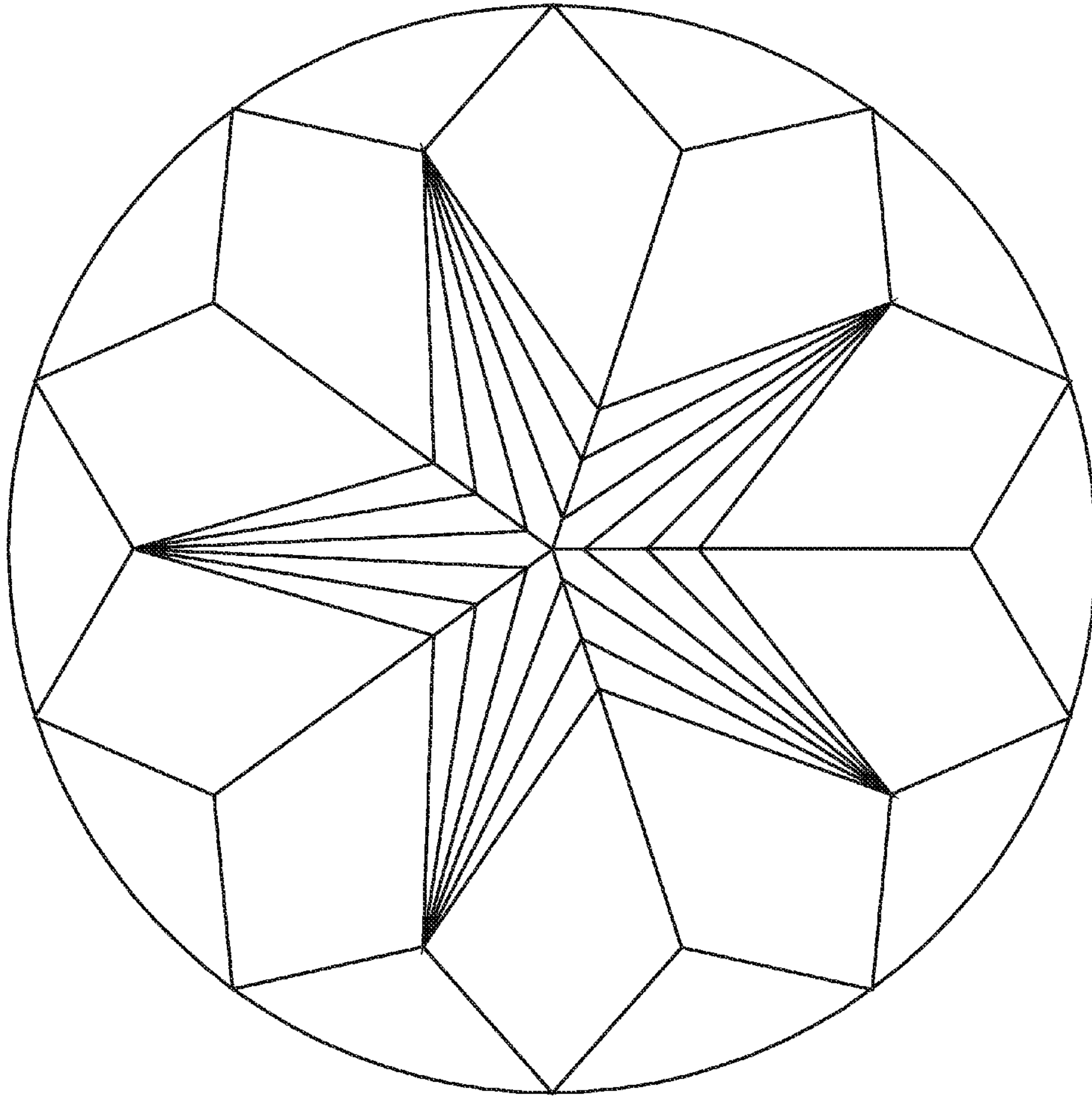
