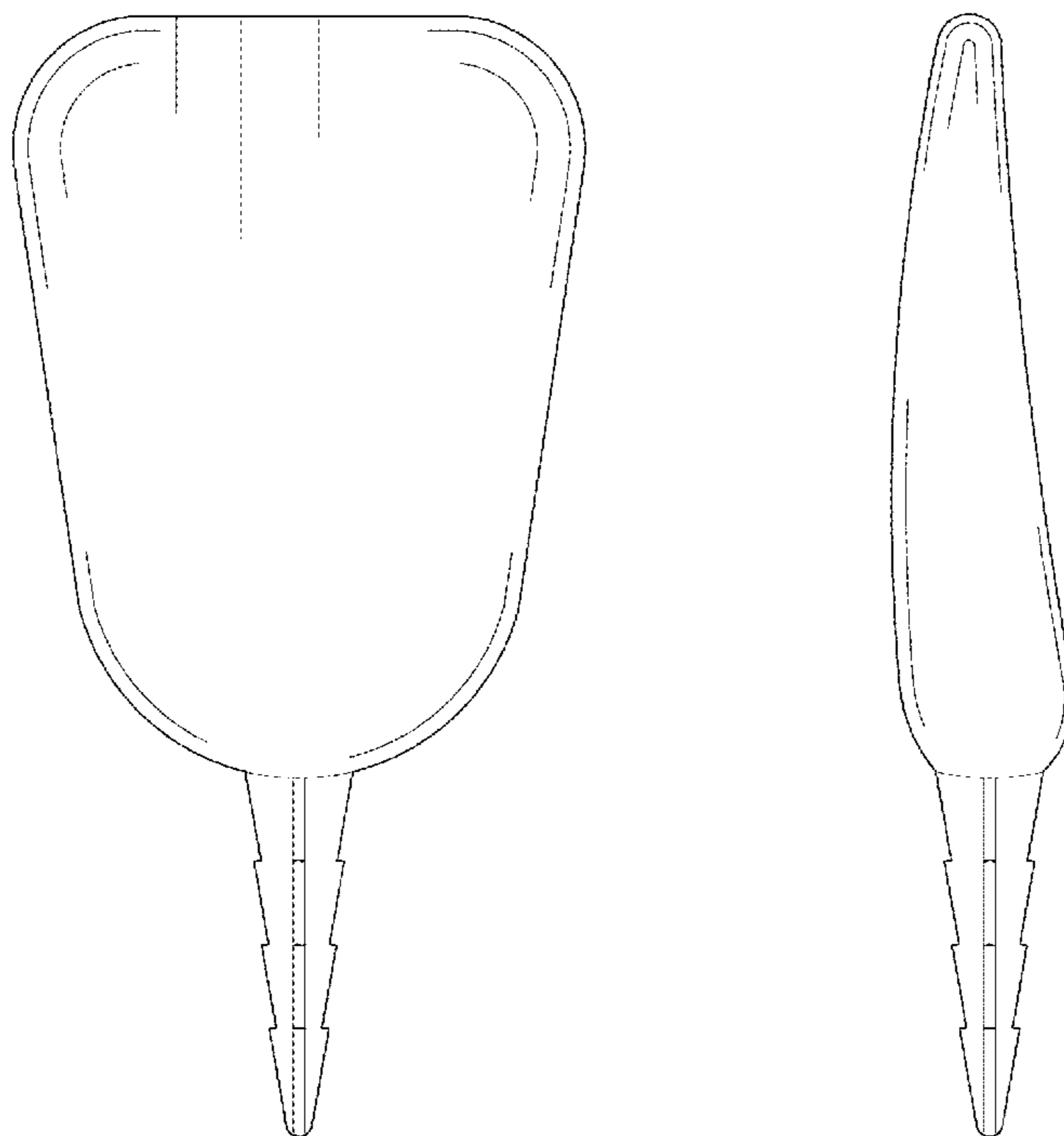
(57) **CLAIM**

The ornamental design for a pumpkin tooth, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a pumpkin tooth showing my new design, the back view being a mirror image.
FIG. 2 is a right side elevational view thereof, the left side being a mirror image;
FIG. 3 is a top plan view thereof; and,
FIG. 4 is a bottom plan view thereof.

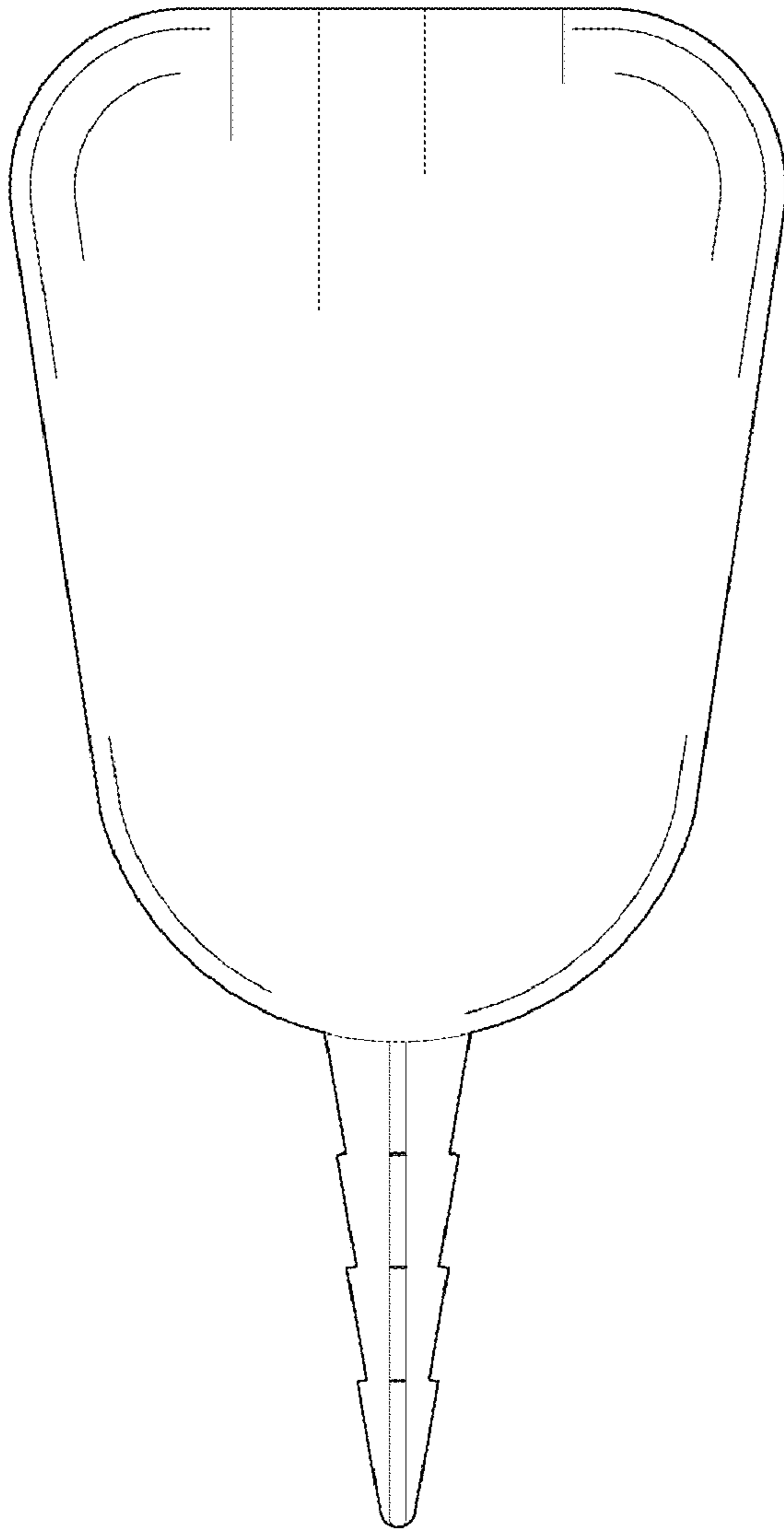

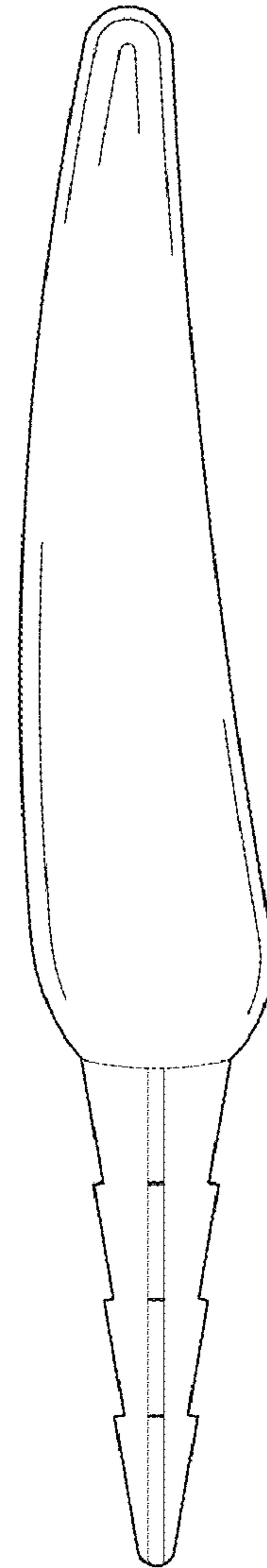

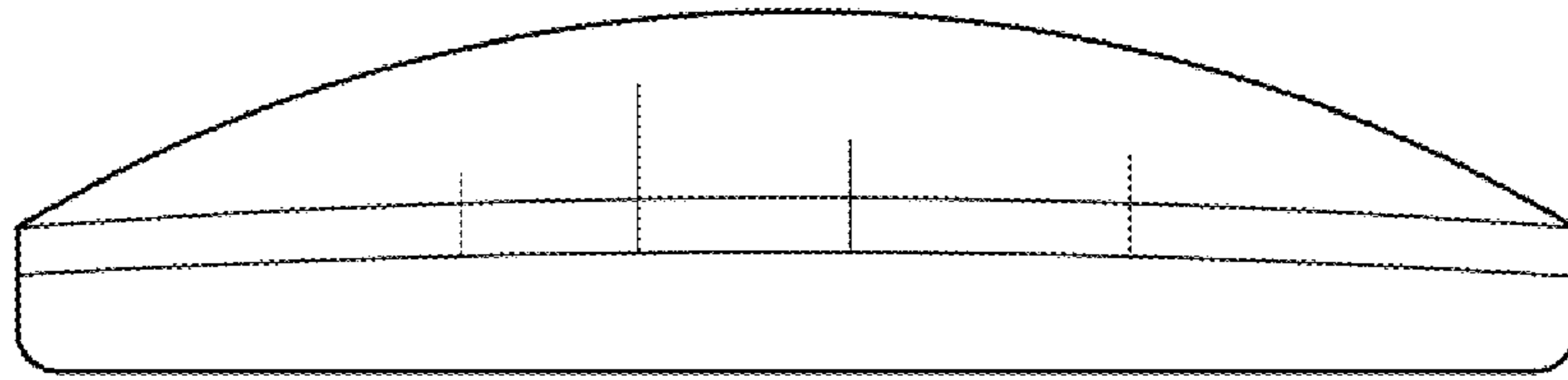

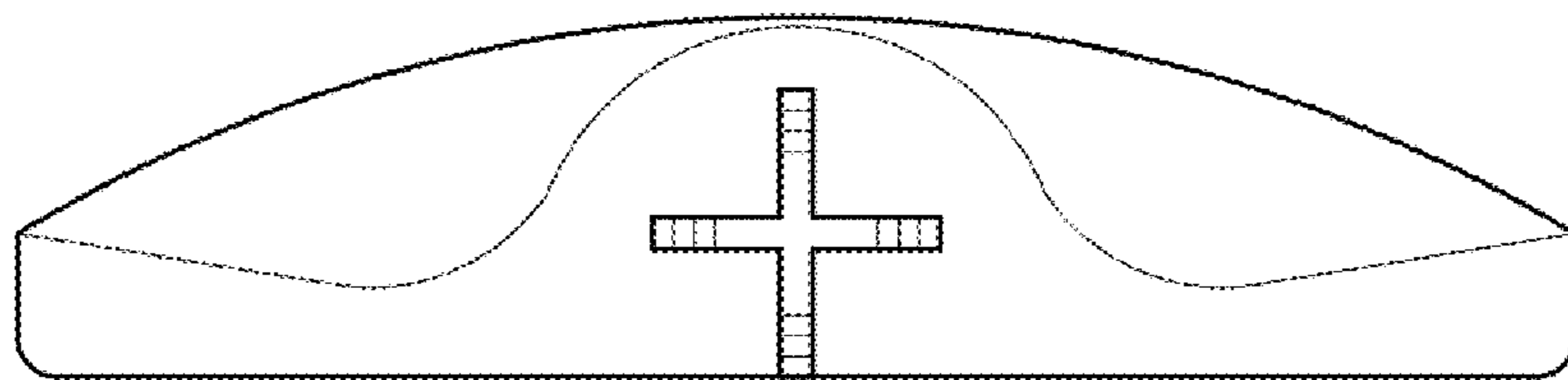
