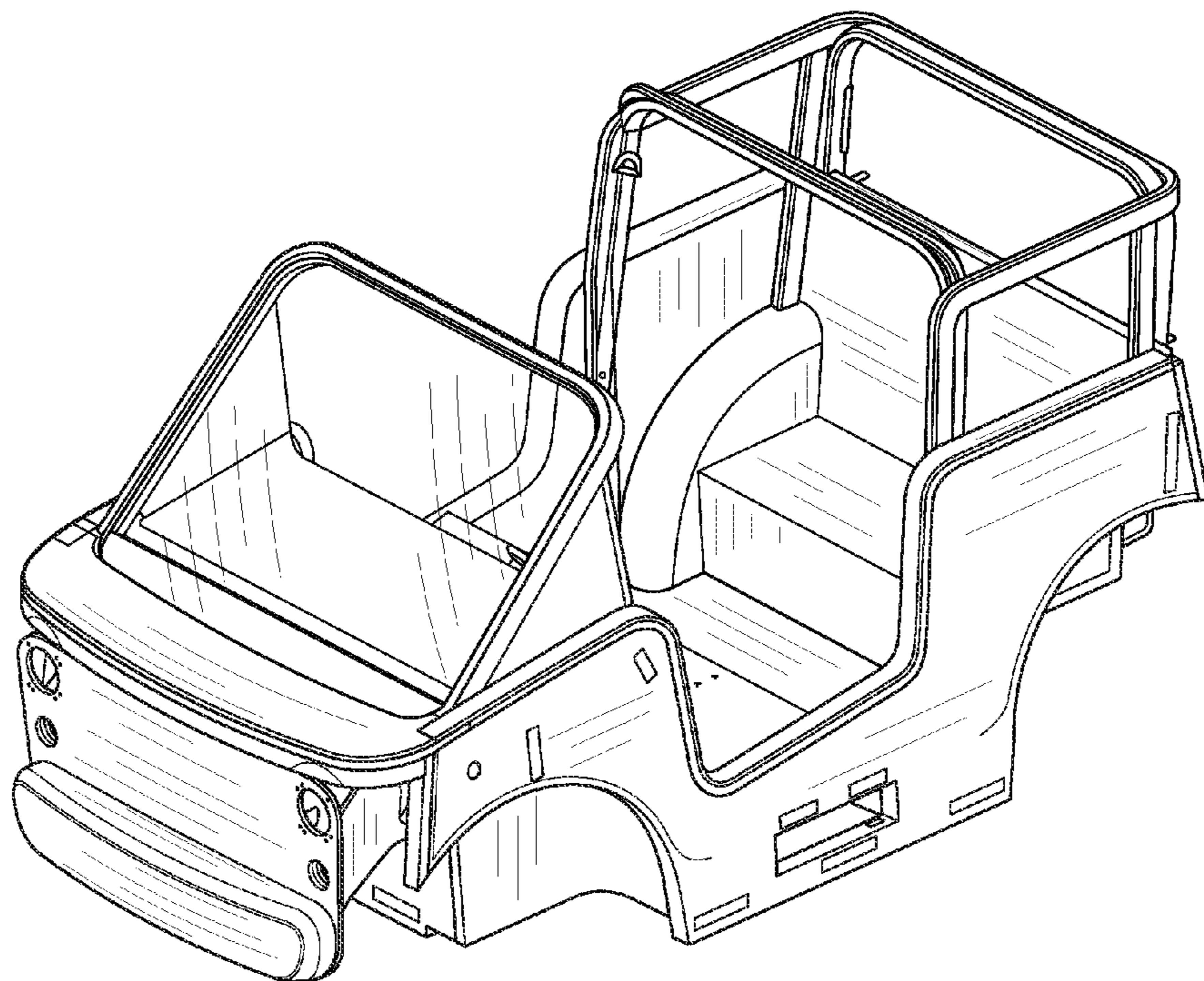
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a left front perspective view of an embodiment of a motor car body, in accordance with my novel design;

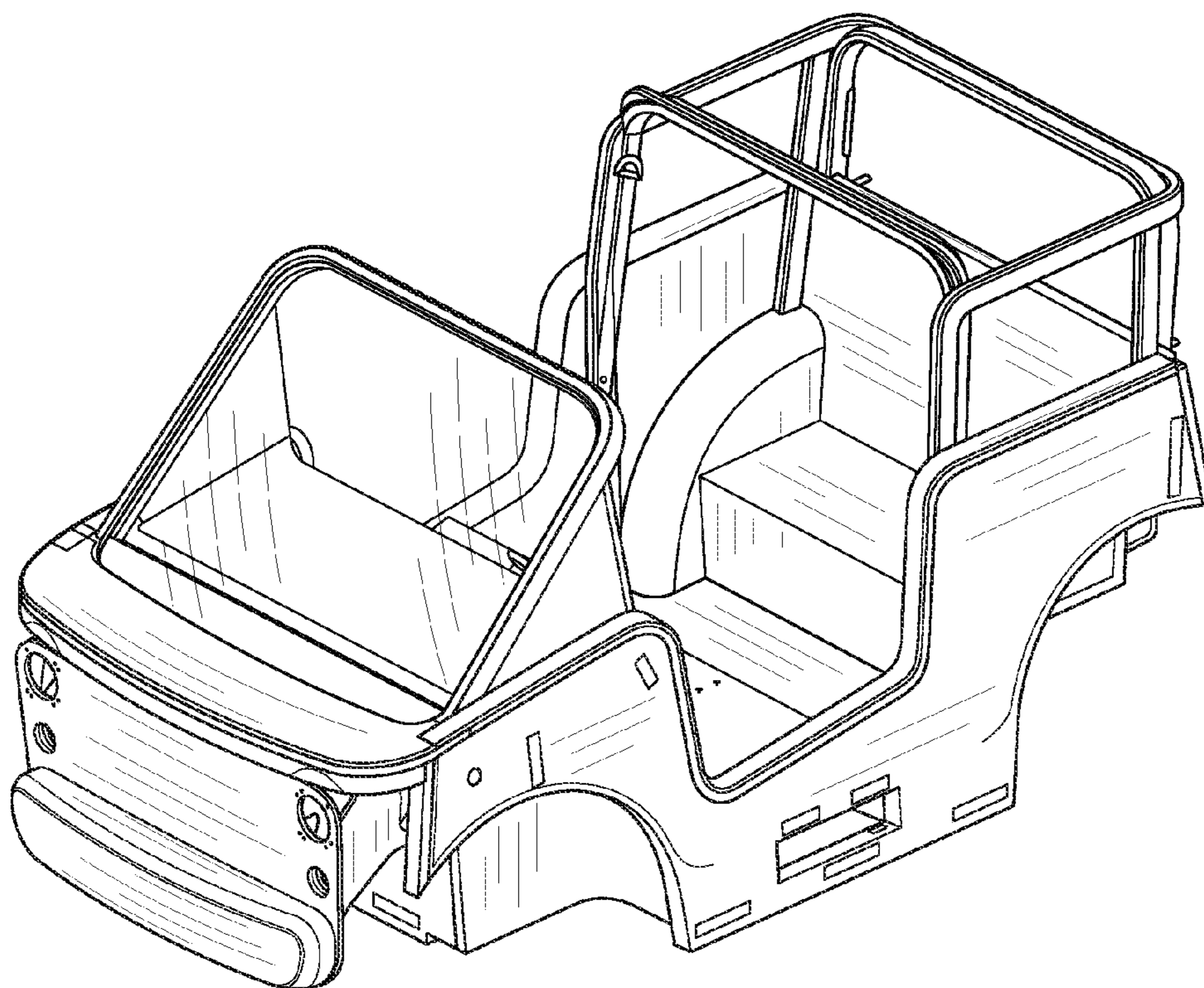

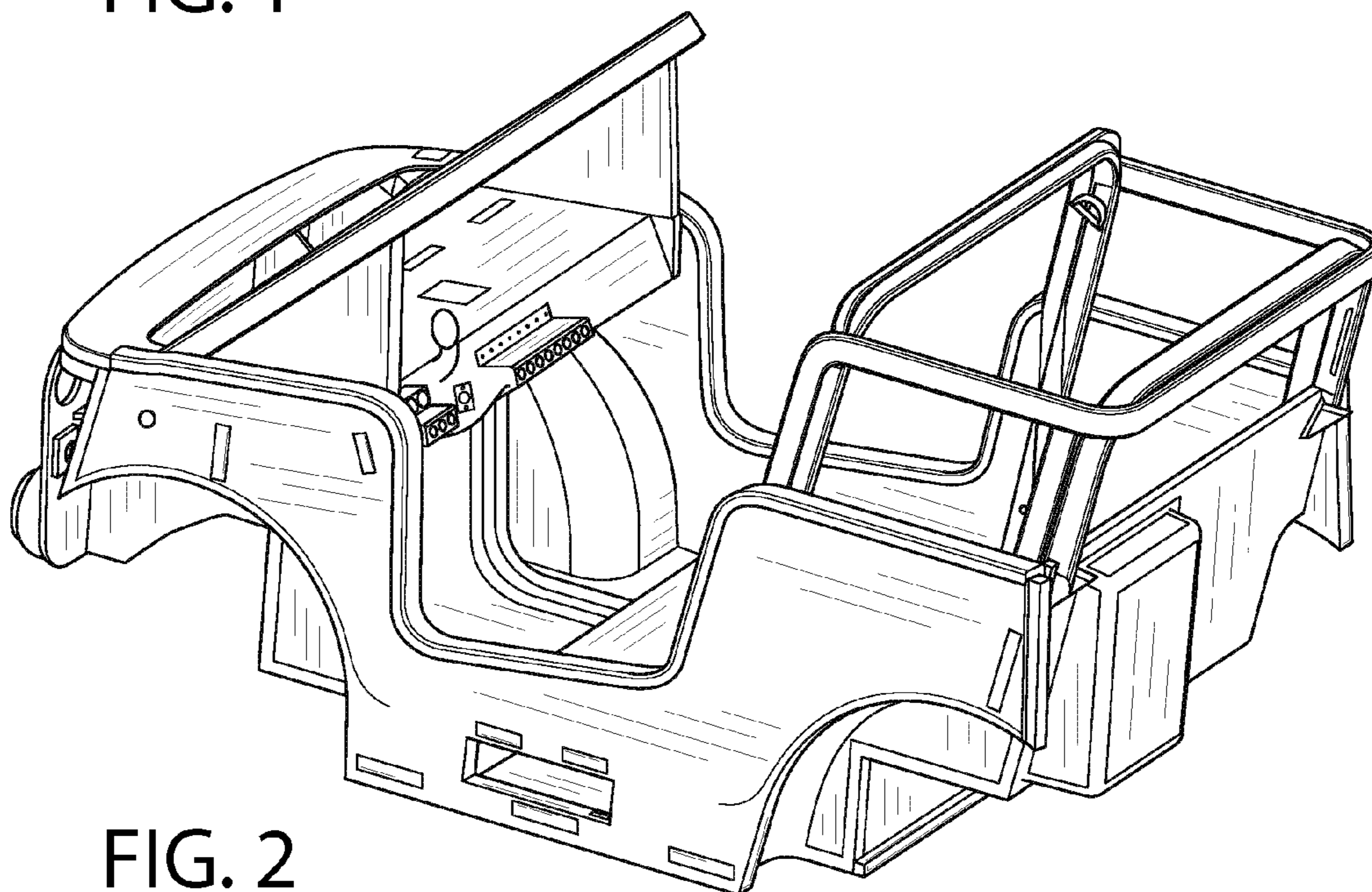

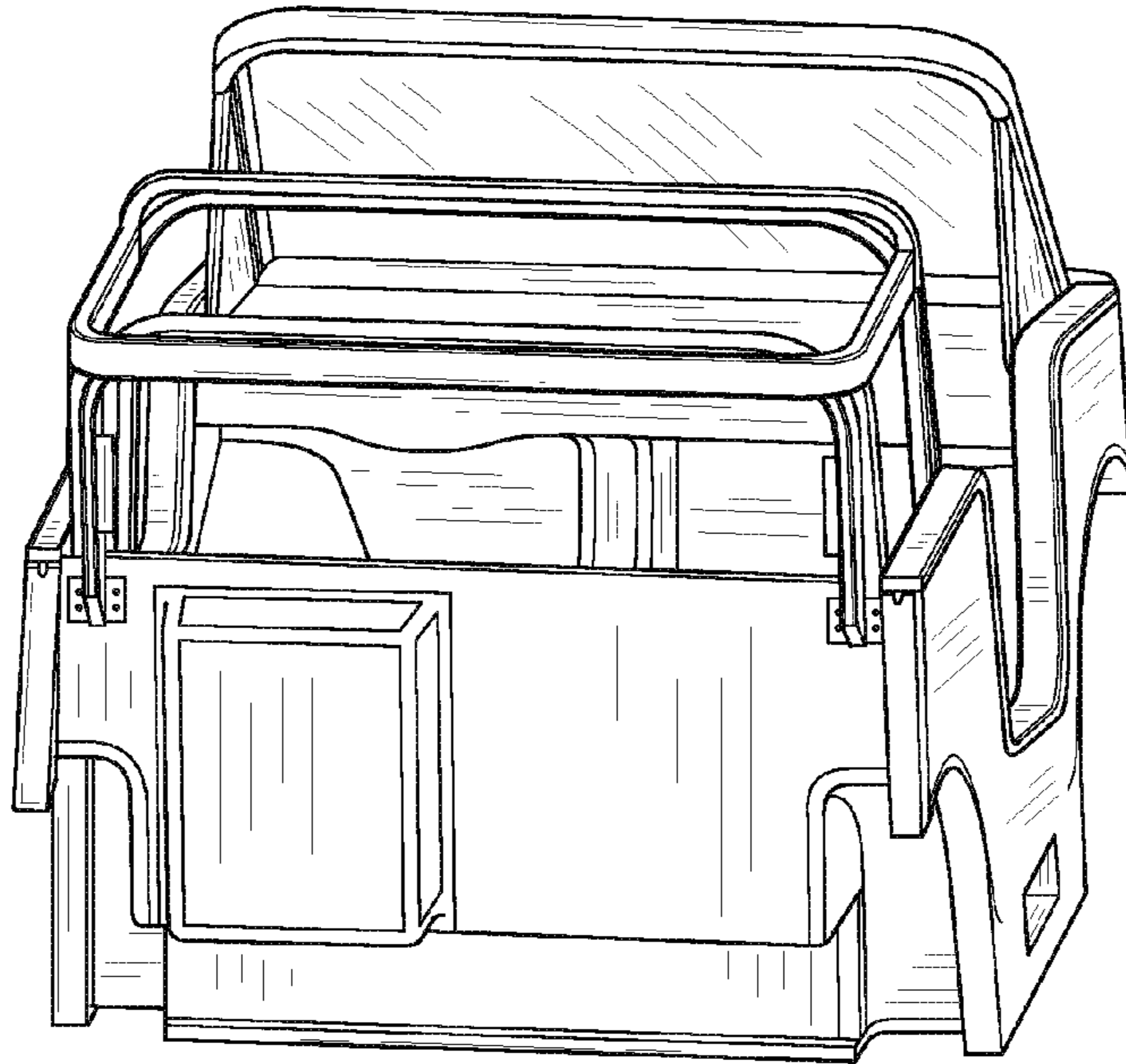

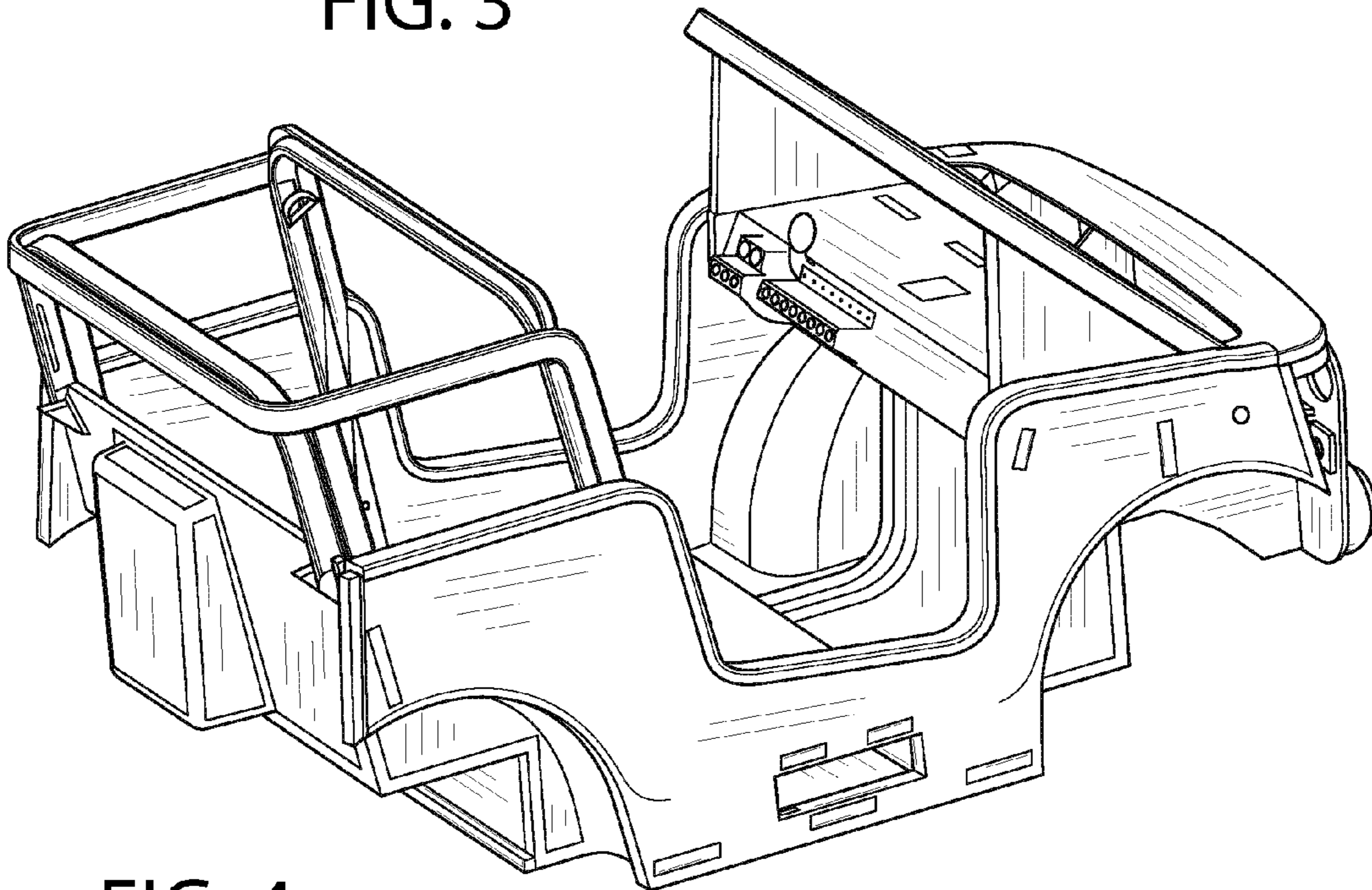

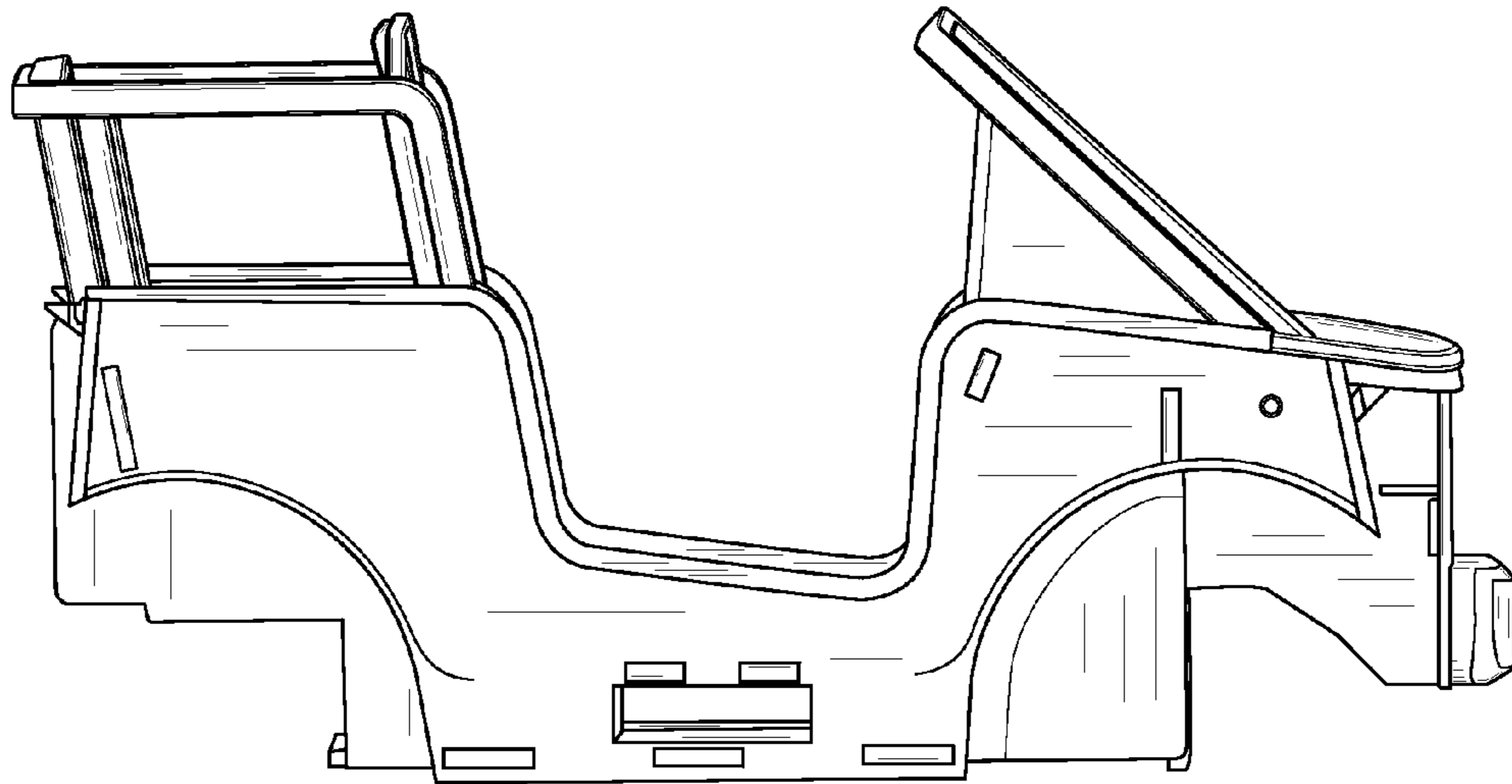

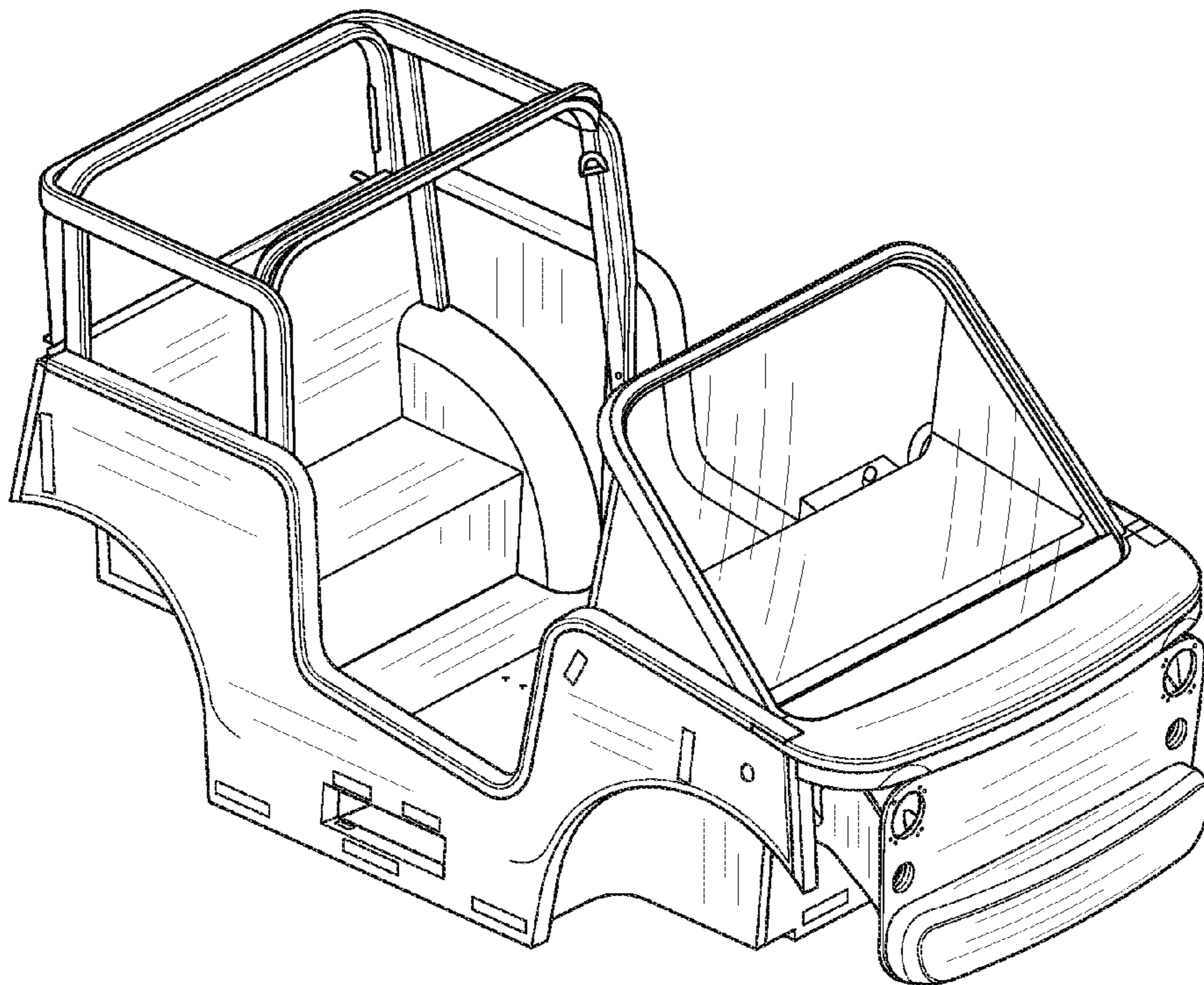

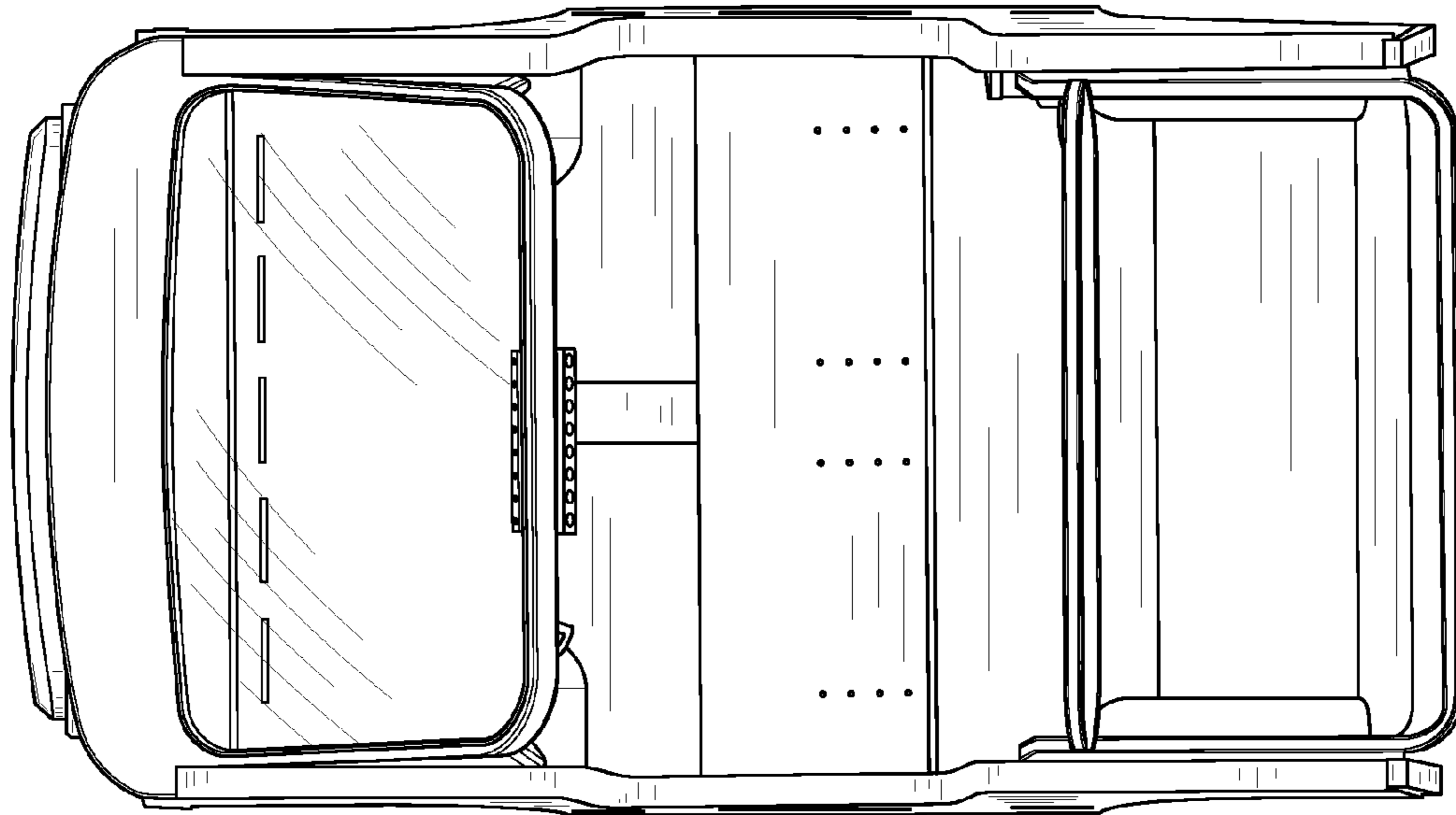

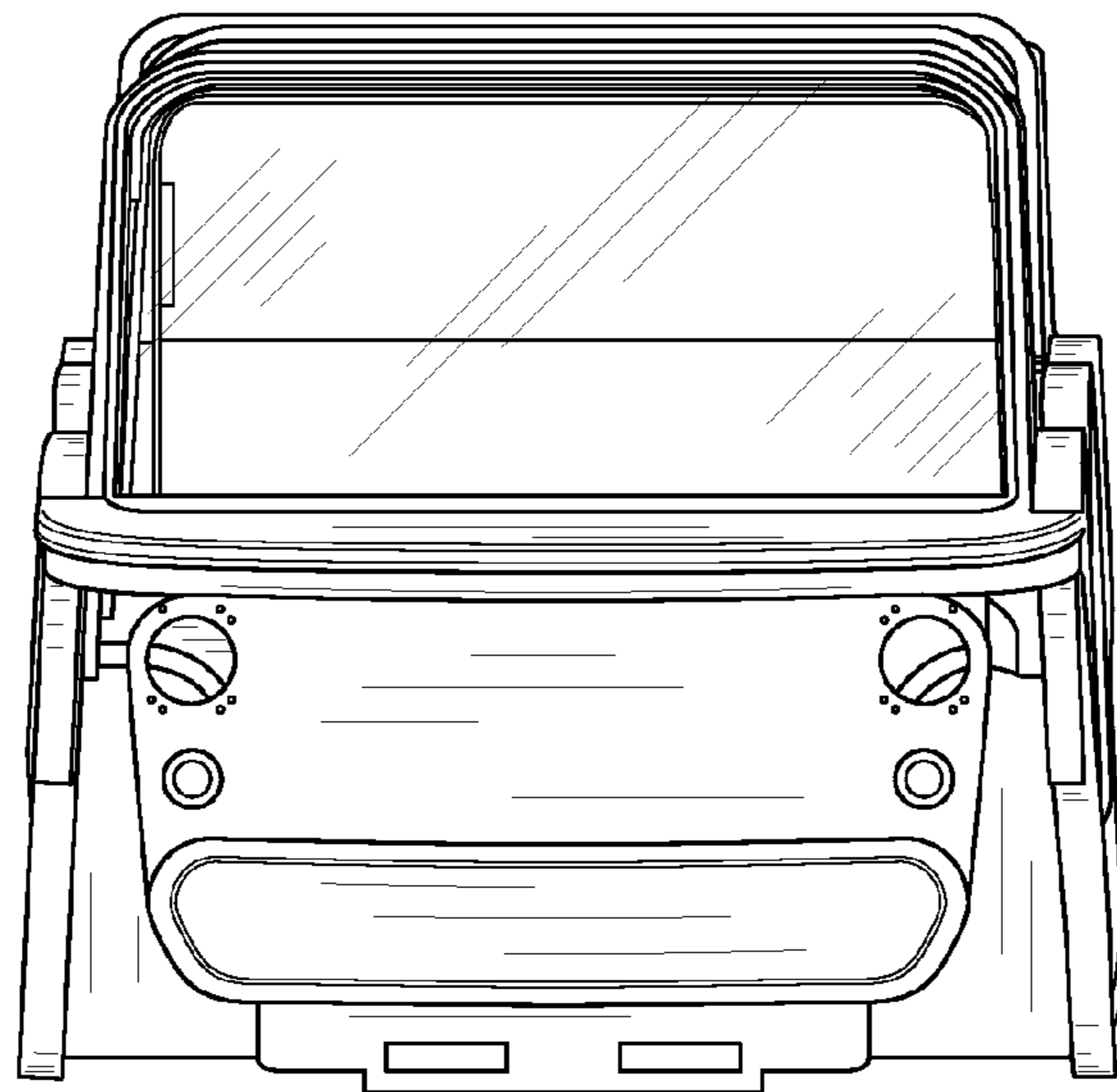
