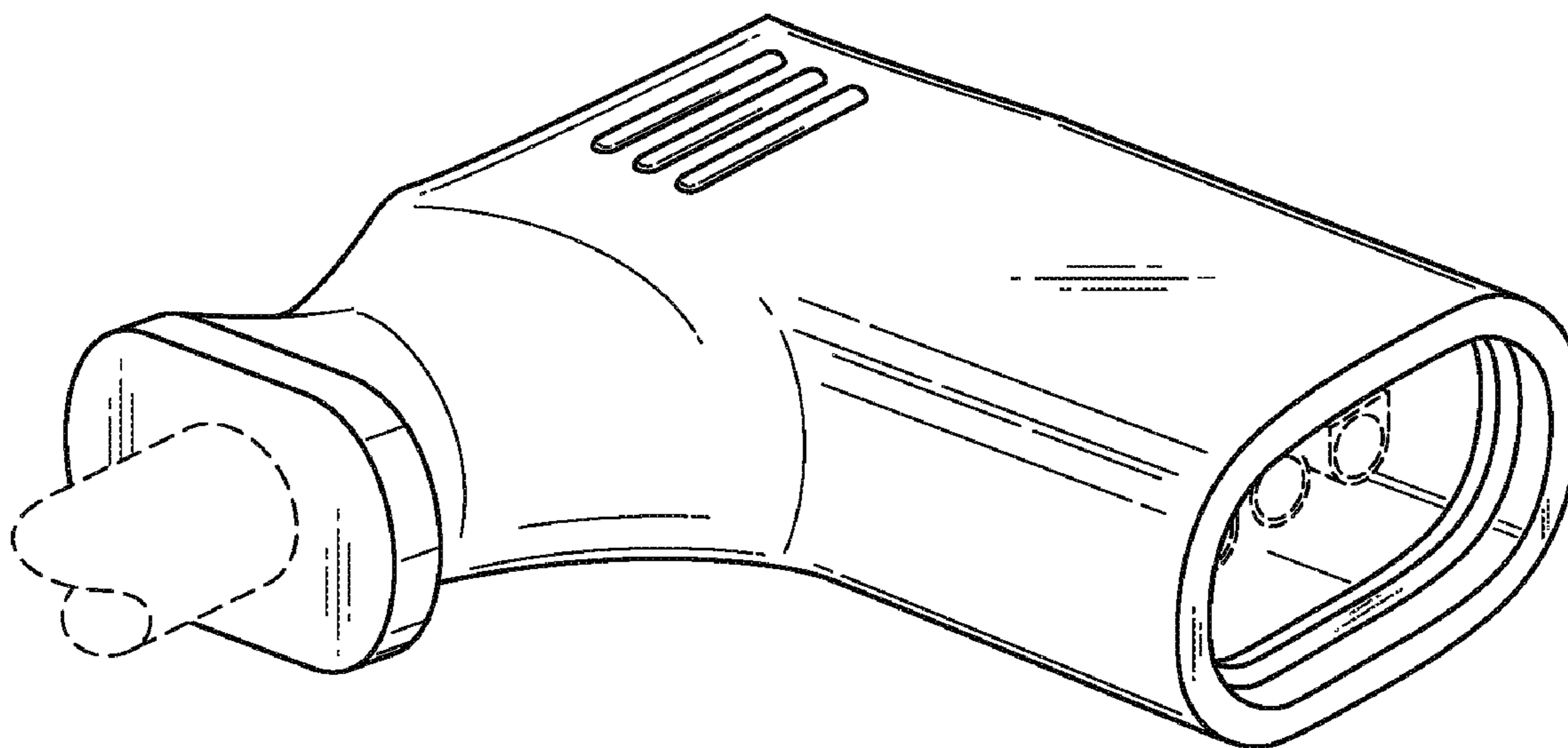
(57) **CLAIM**

I claim the ornamental design for an electrical connector, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top, left side perspective view of my new design for an electrical connector;  
FIG. 2 is a top plan view thereof, the bottom plan view being a mirror image thereof;  
FIG. 3 is a front side elevation view thereof;  
FIG. 4 is a back side elevation view thereof;  
FIG. 5 is a right side elevation view thereof; and,  
FIG. 6 is a left side elevation view thereof.  
The broken lines are included to show unclaimed environment structure and form no part of the claimed design.

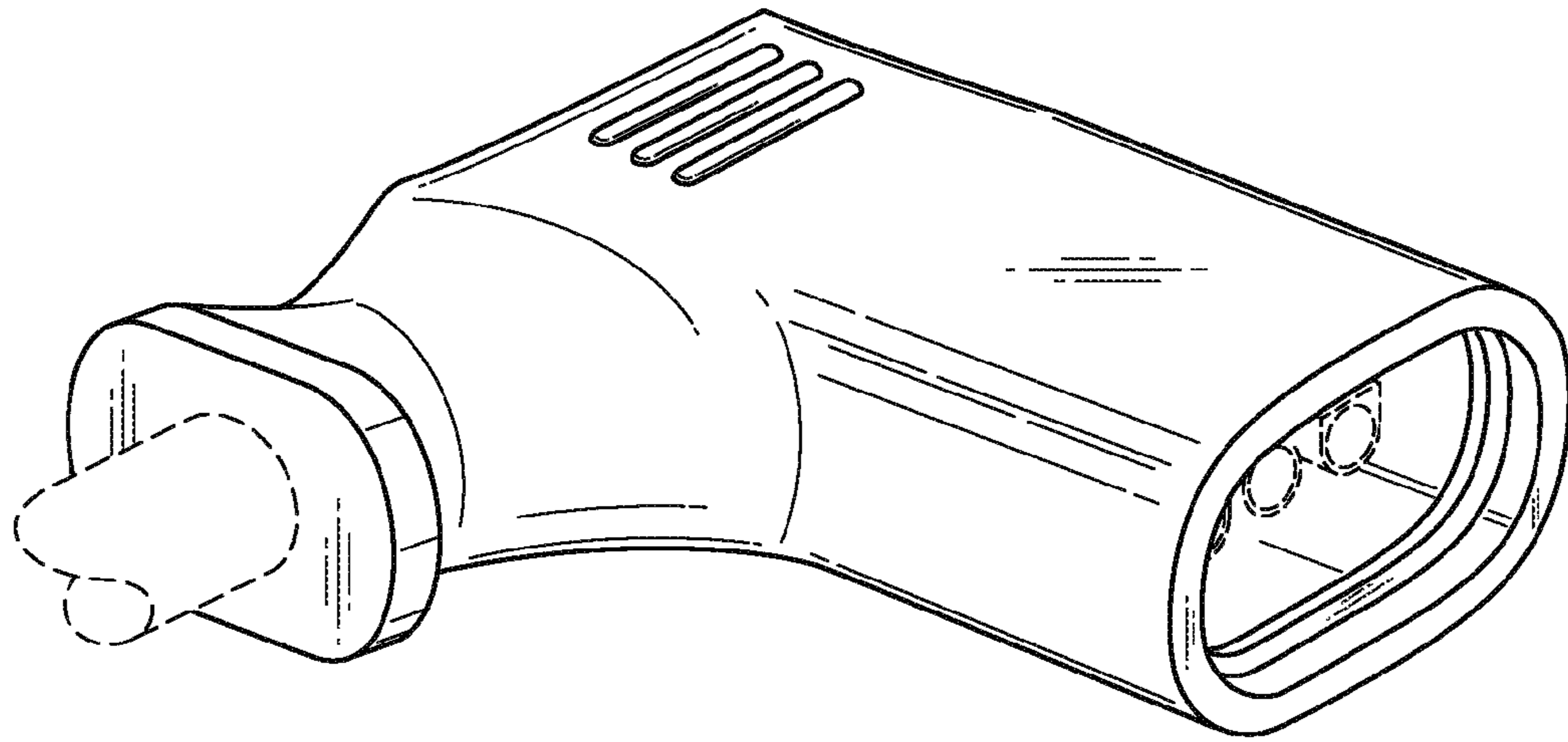

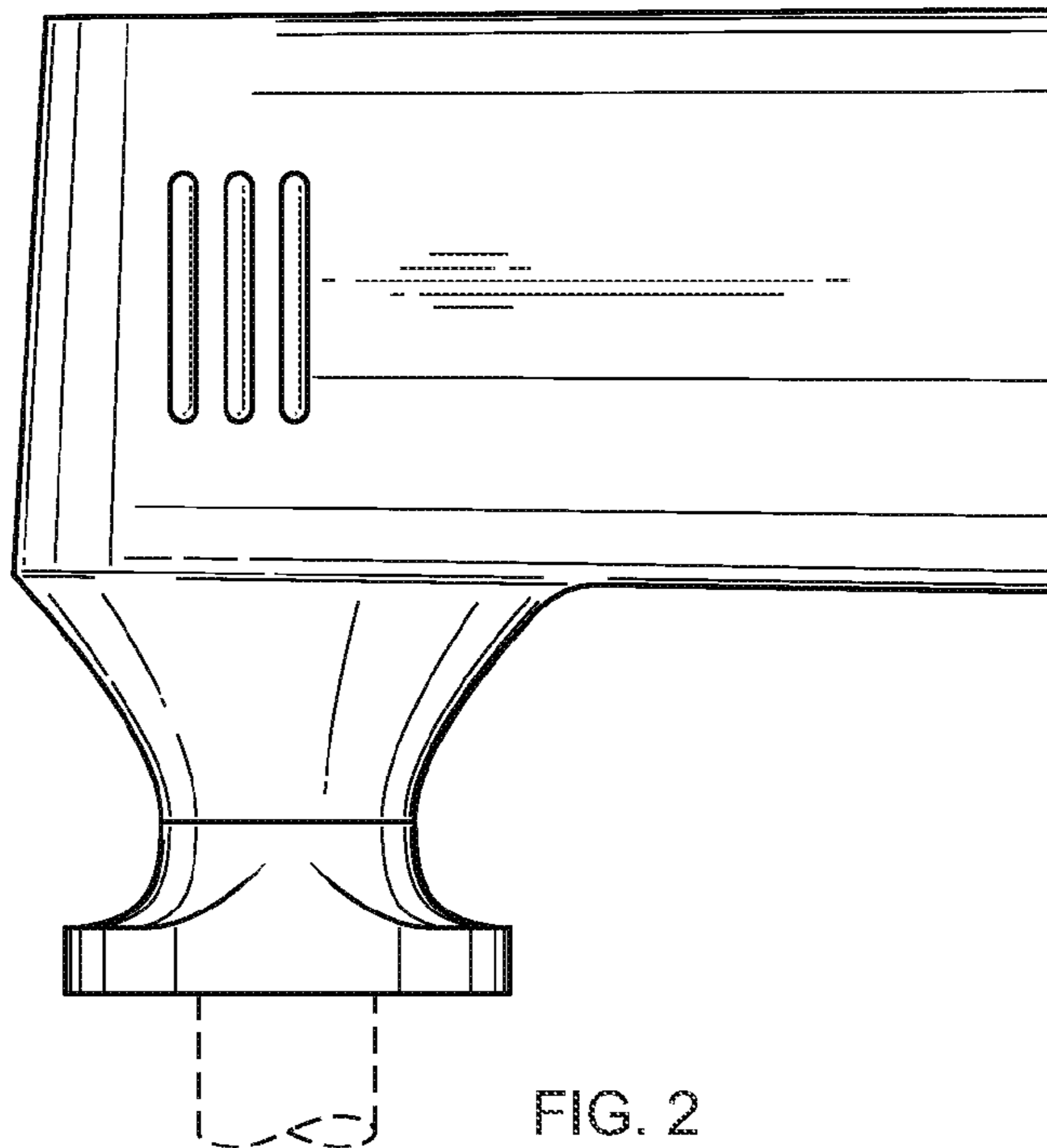

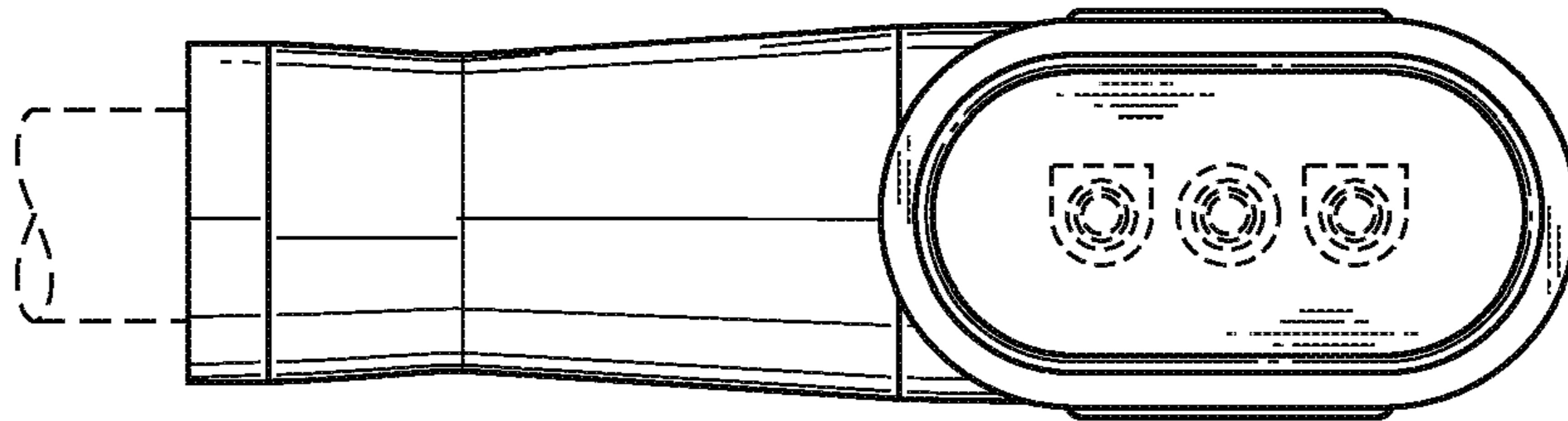

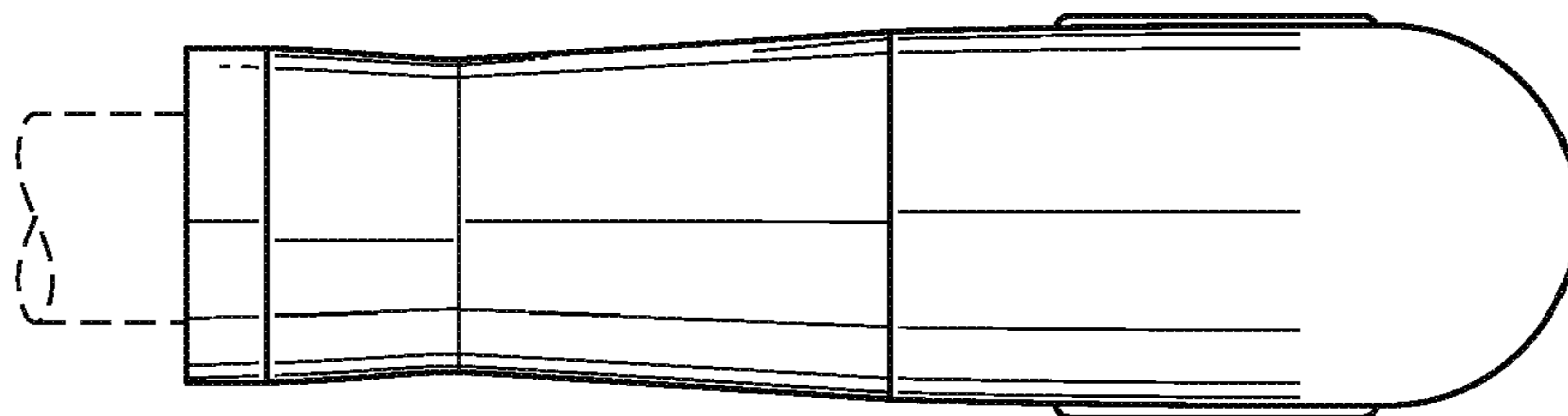

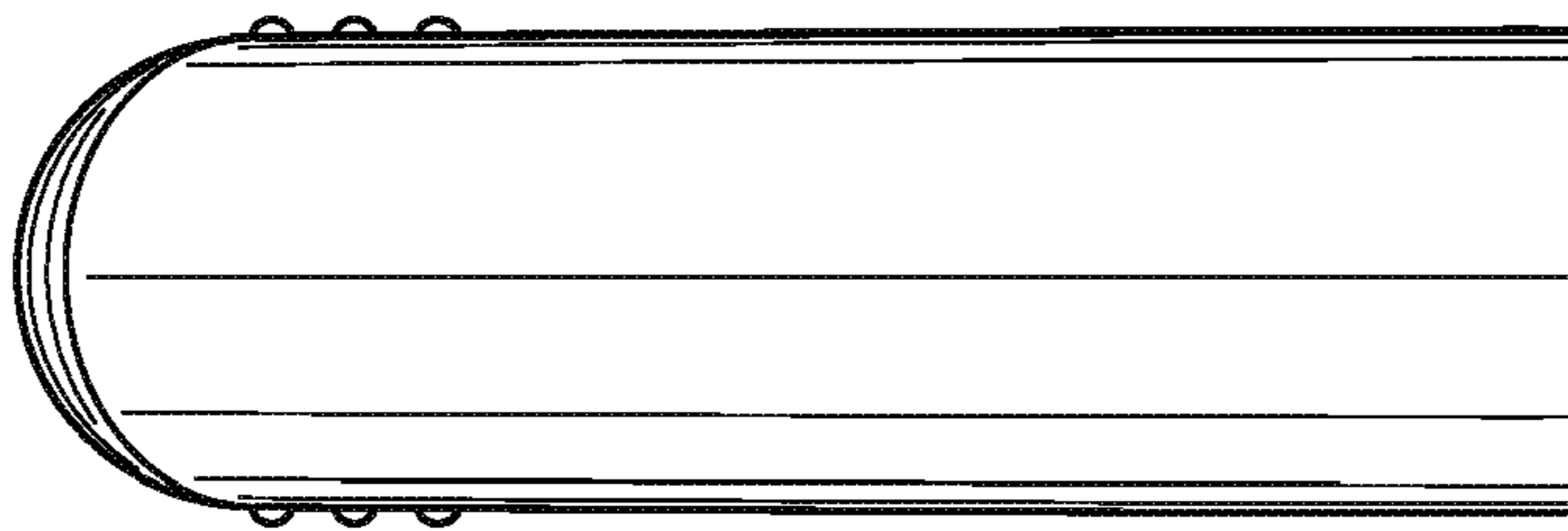

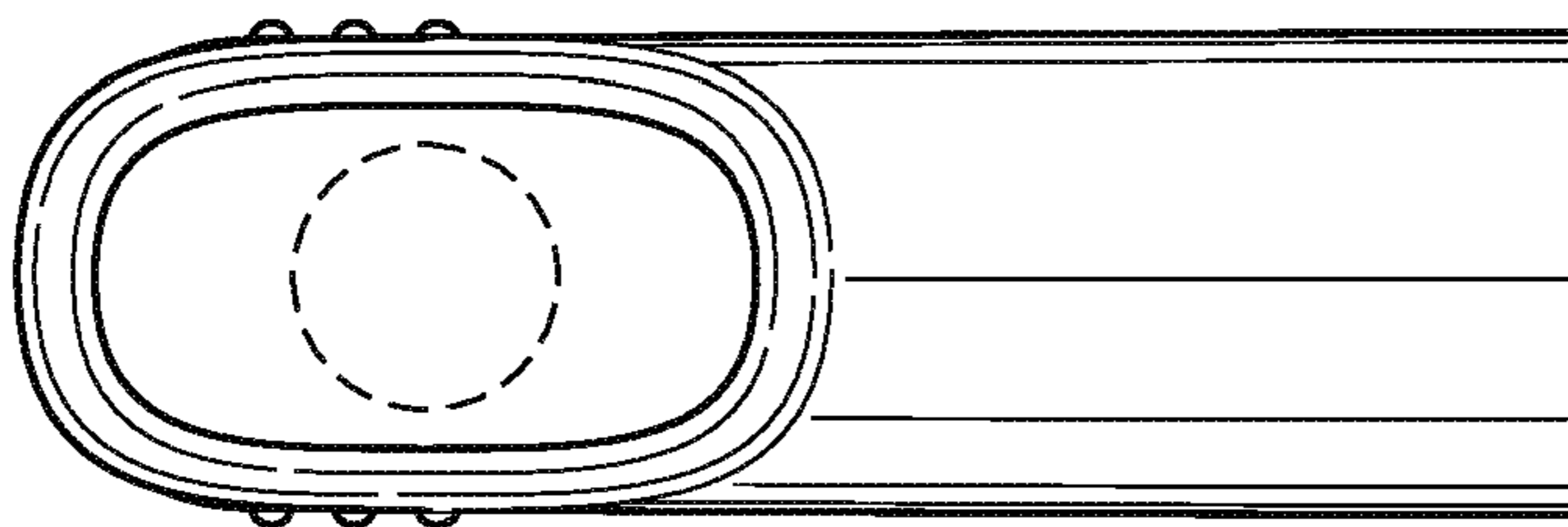
