The ornamental design for an electroluminescence module, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an electroluminescence module;

FIG. 2 is a front view thereof;

FIG. 3 is a right side view thereof;

FIG. 4 is a plan view thereof;

FIG. 5 is a rear view thereof; and,

FIG. 6 is a bottom plan view thereof.

A left side view of the electroluminescence module is a mirror image of the right side view shown in FIG. 3, and therefore omitted.

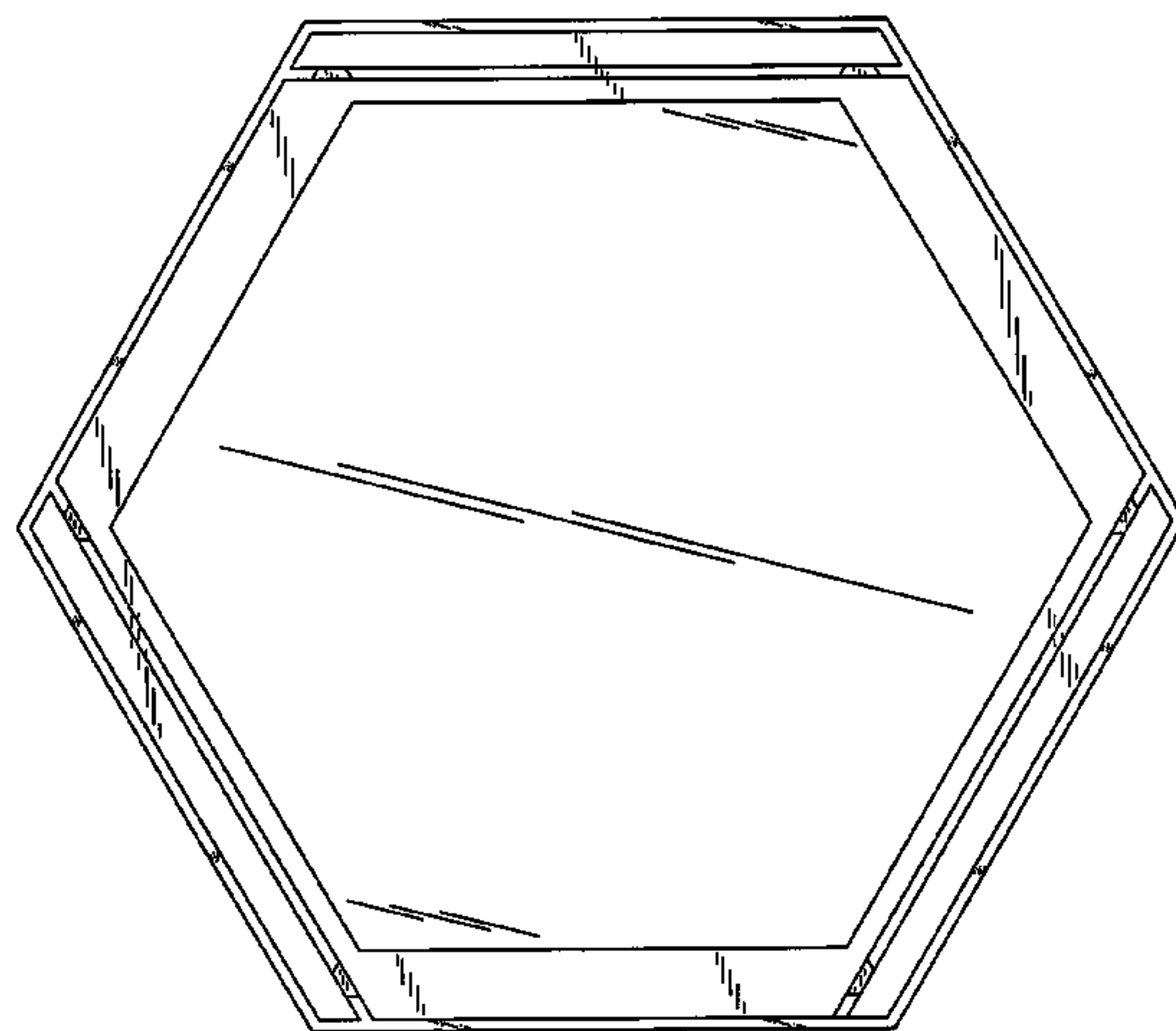
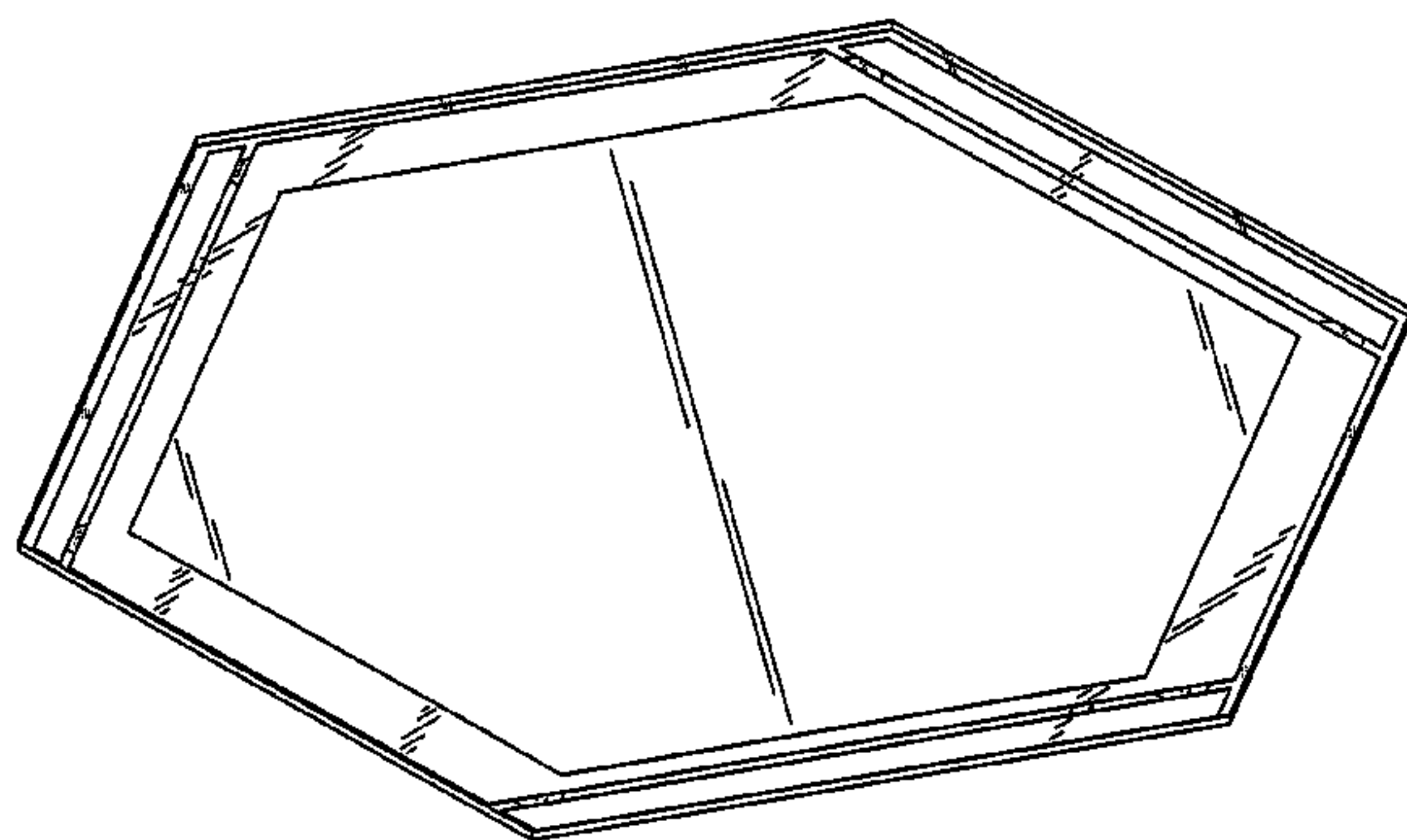

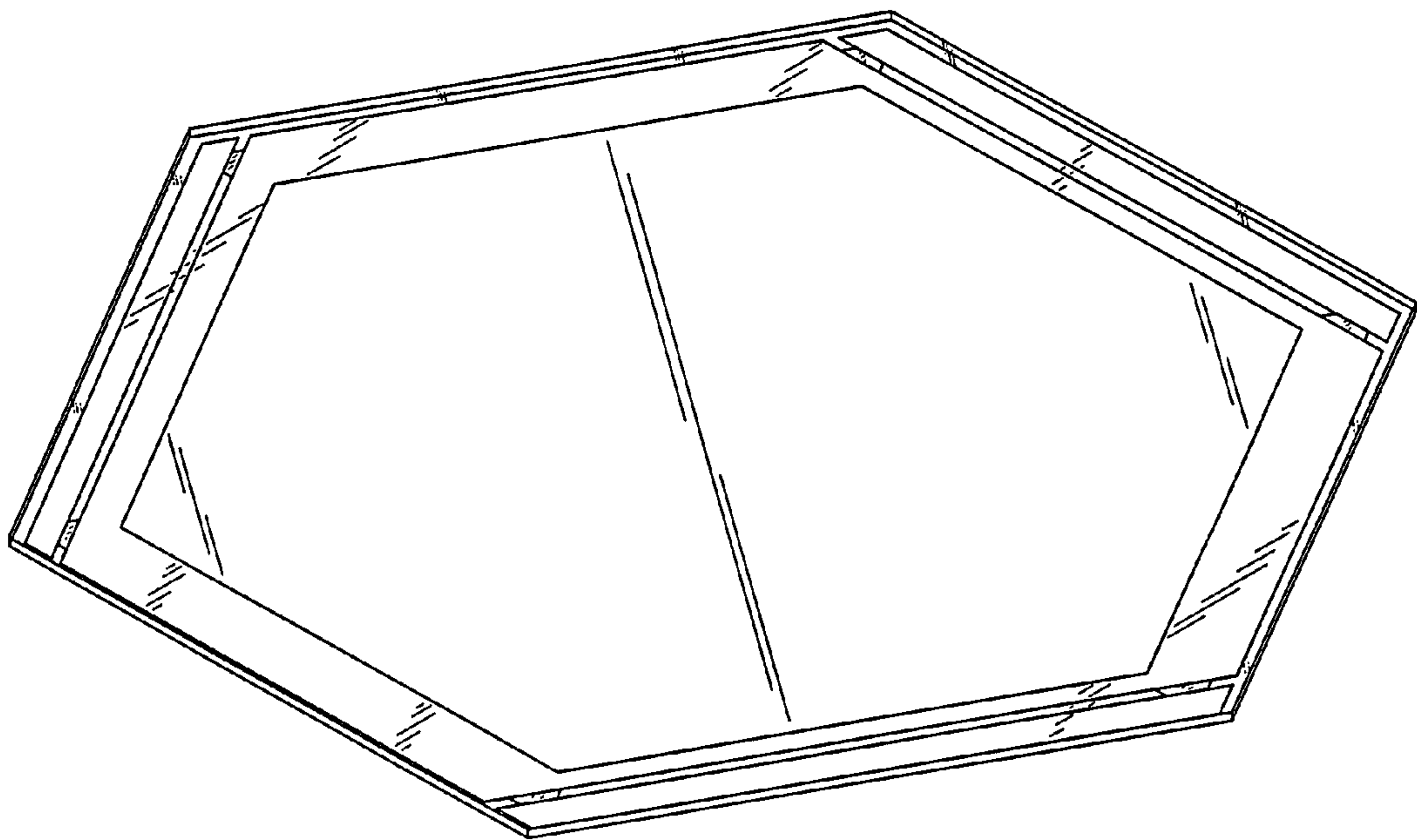

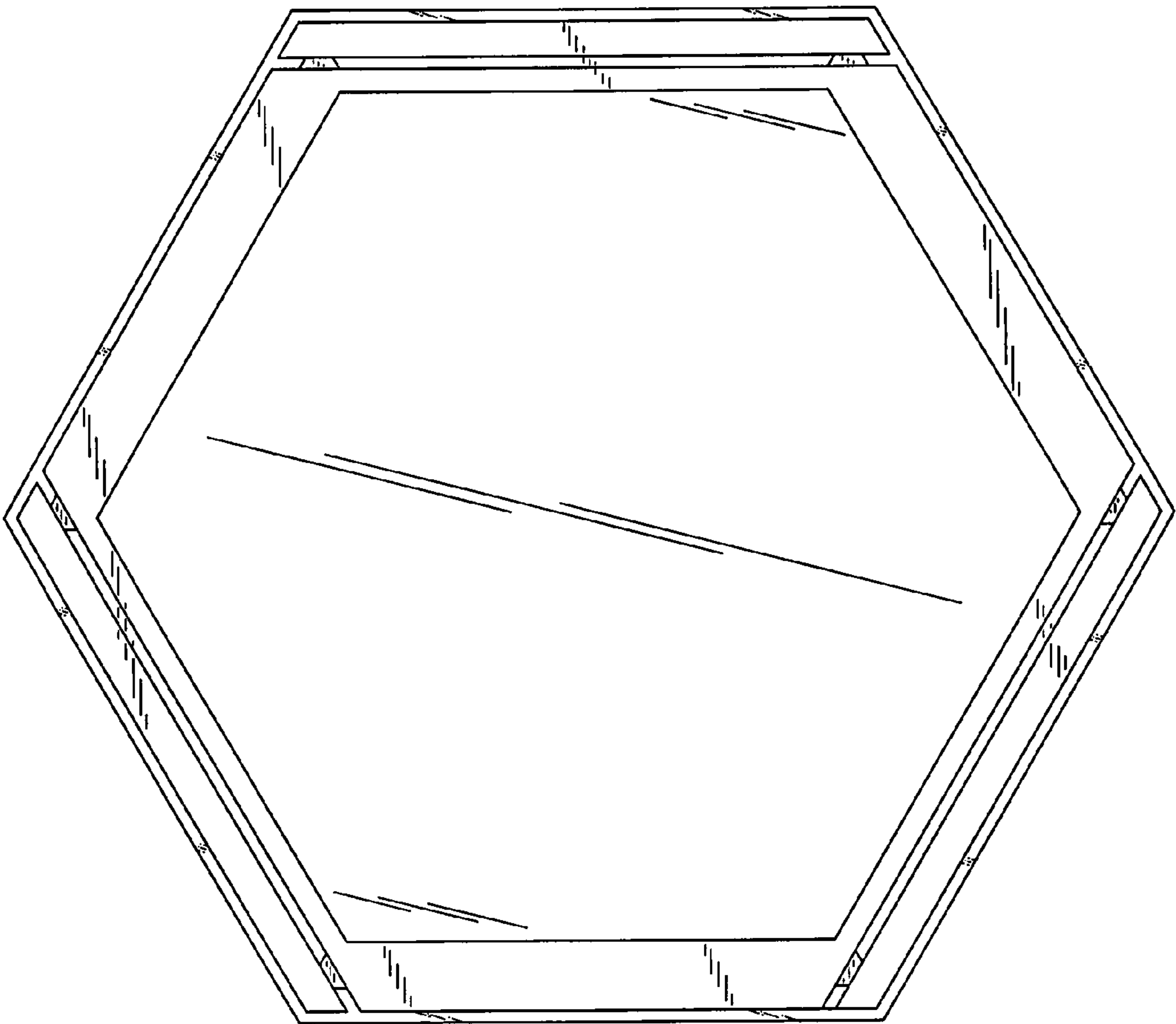

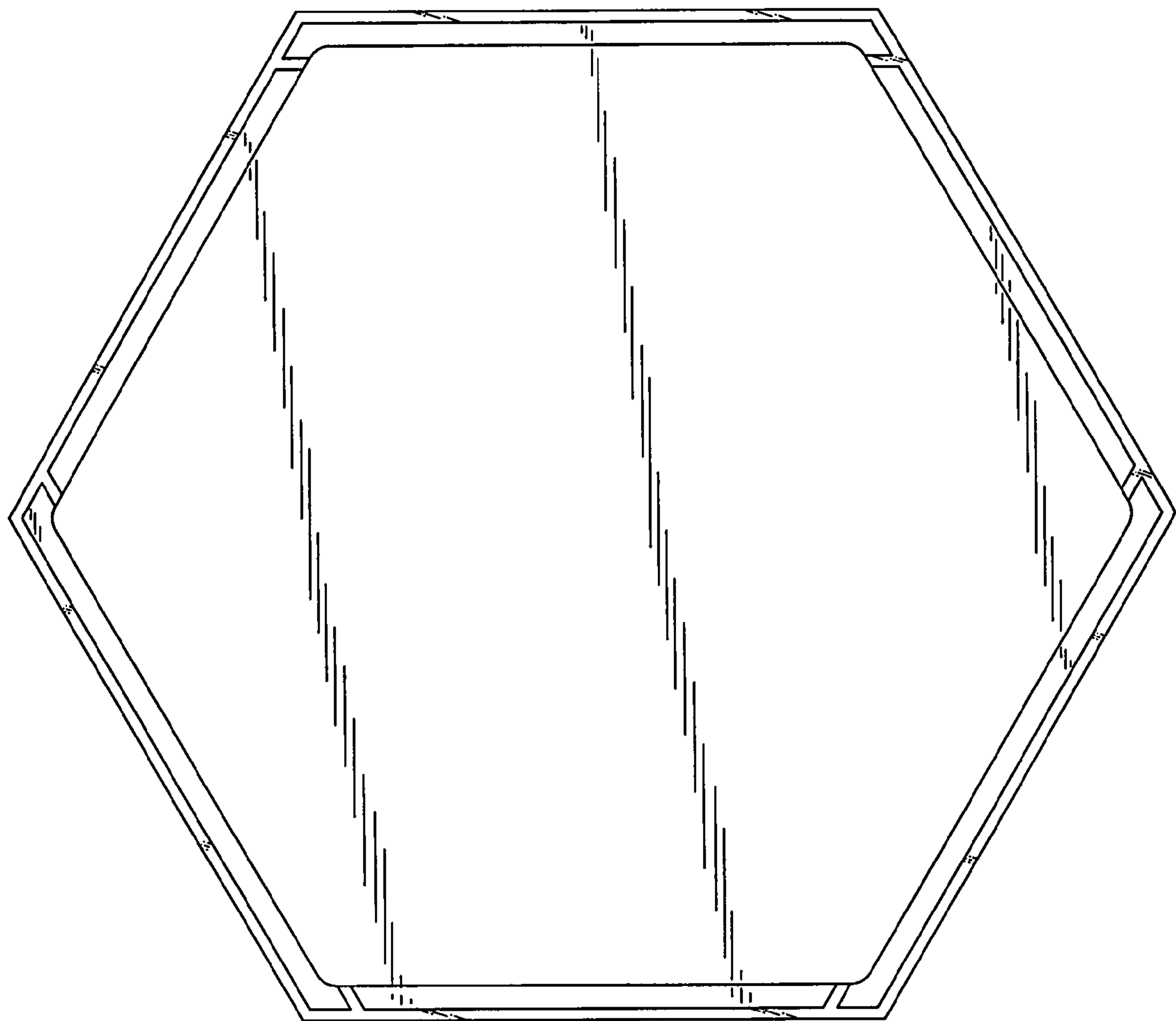
