The ornamental design for a bight headphone, as shown and described.

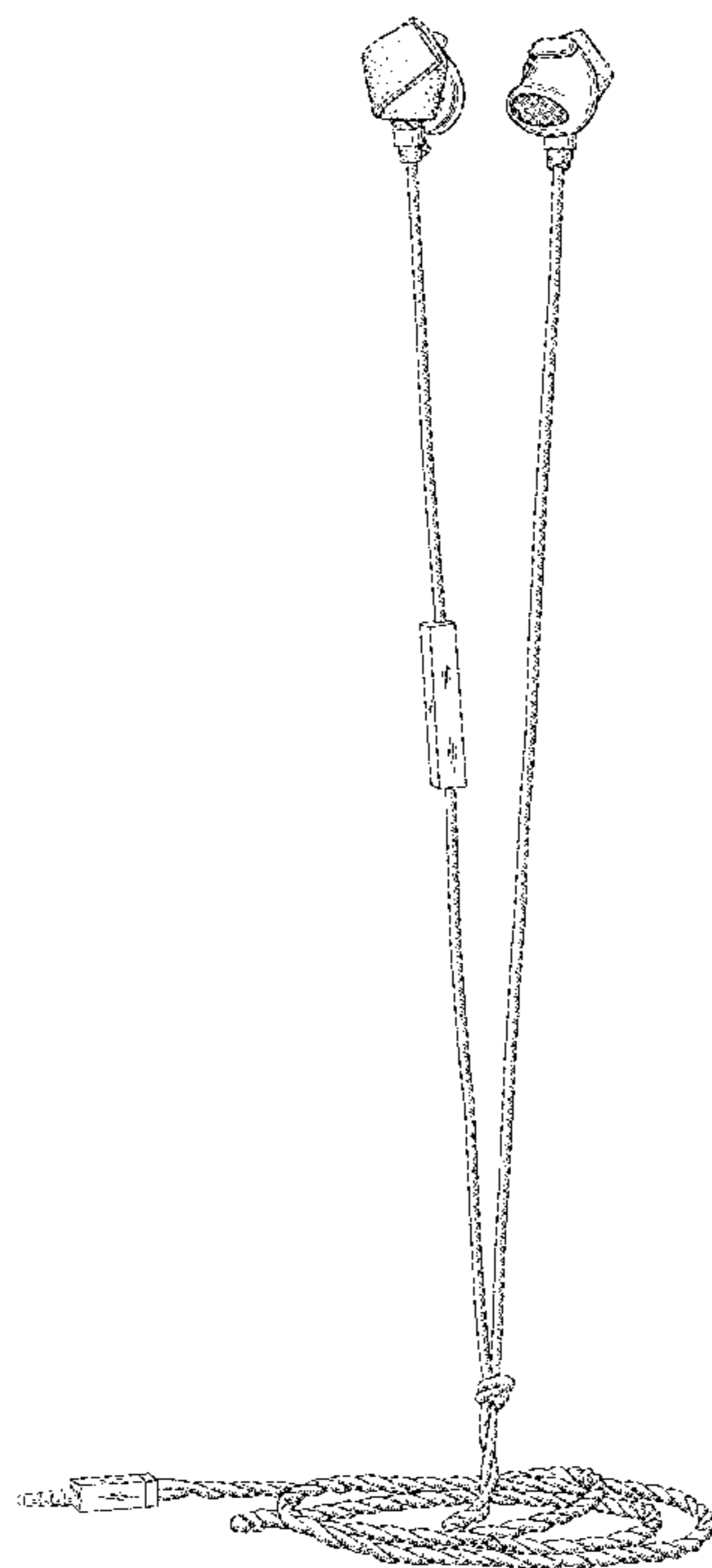
**DESCRIPTION**

FIG. 1 is a perspective view of a bight headphone showing my new design;

FIG. 2 is an enlarged front view thereof, the earphones of the bight headphone are shown separately for purposes of illustration; and,

FIG. 3 is an enlarged rear view thereof, the earphones of the bight headphone are shown separately for purposes of illustration.

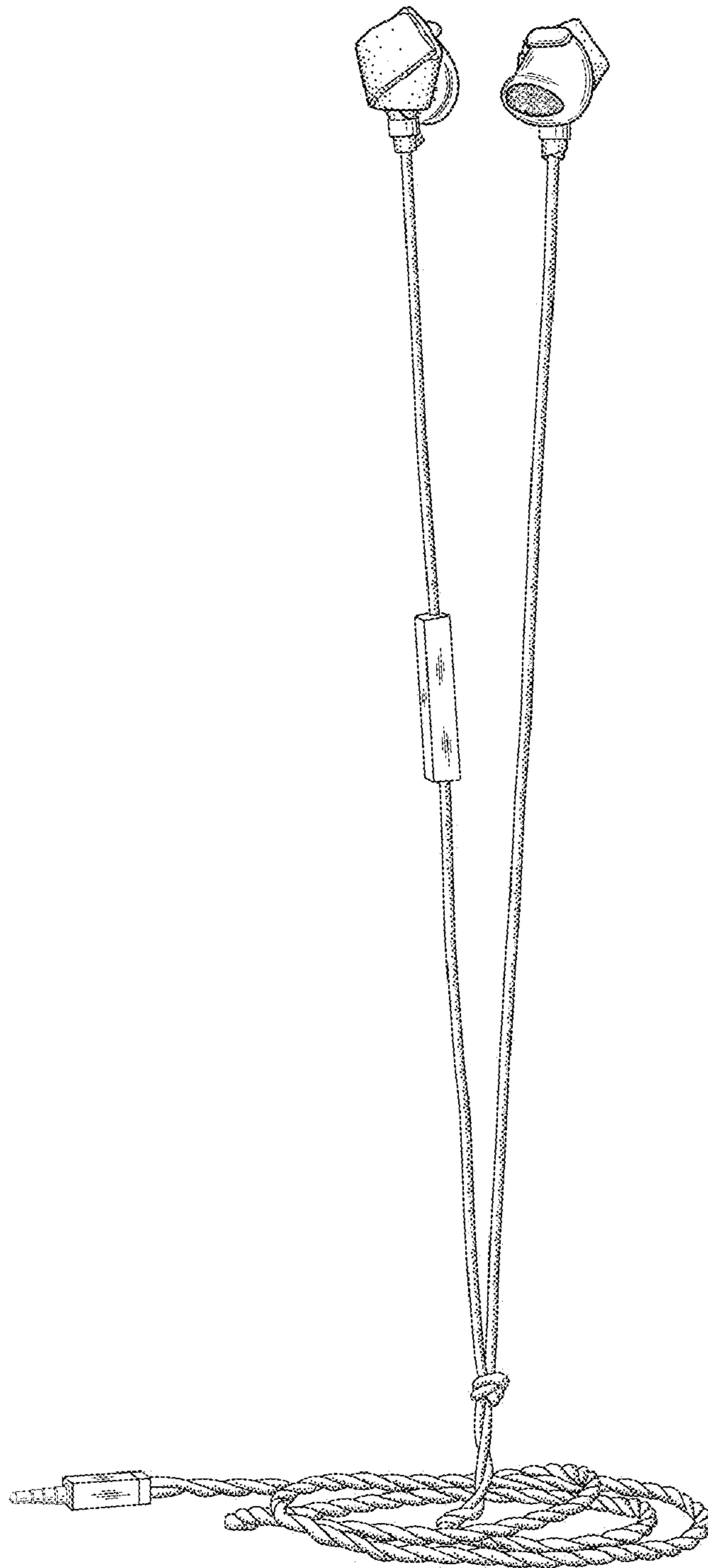

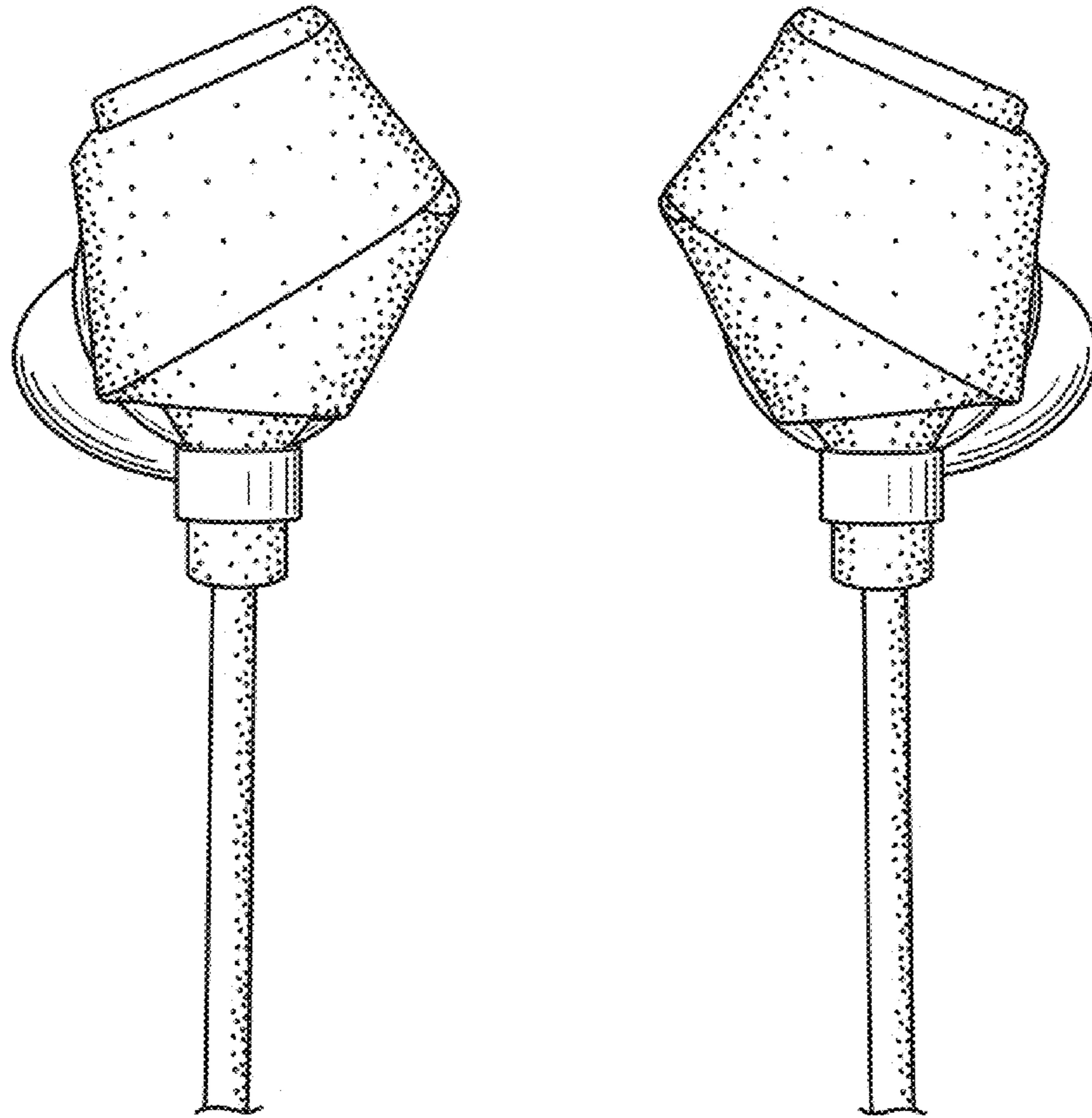

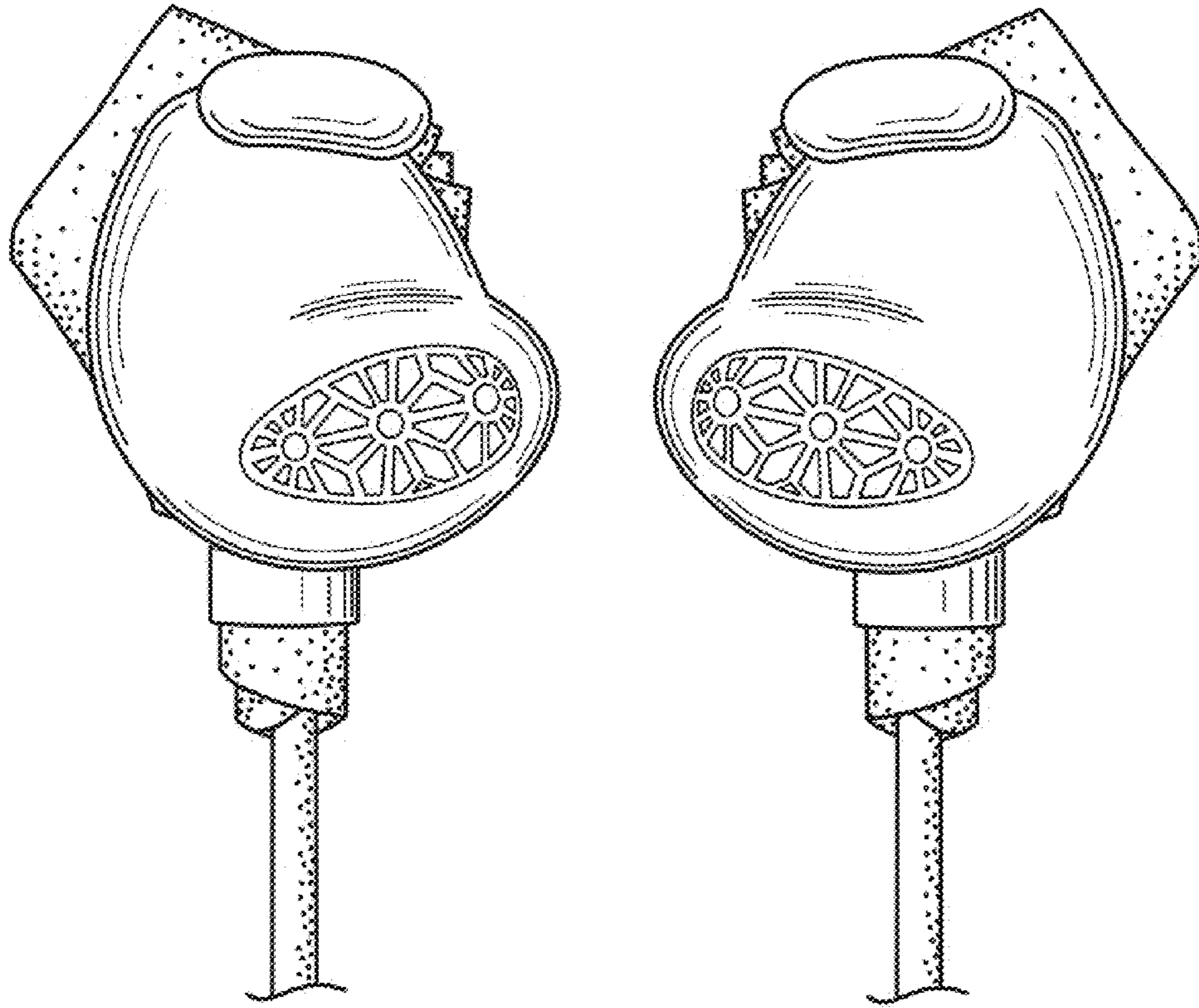
