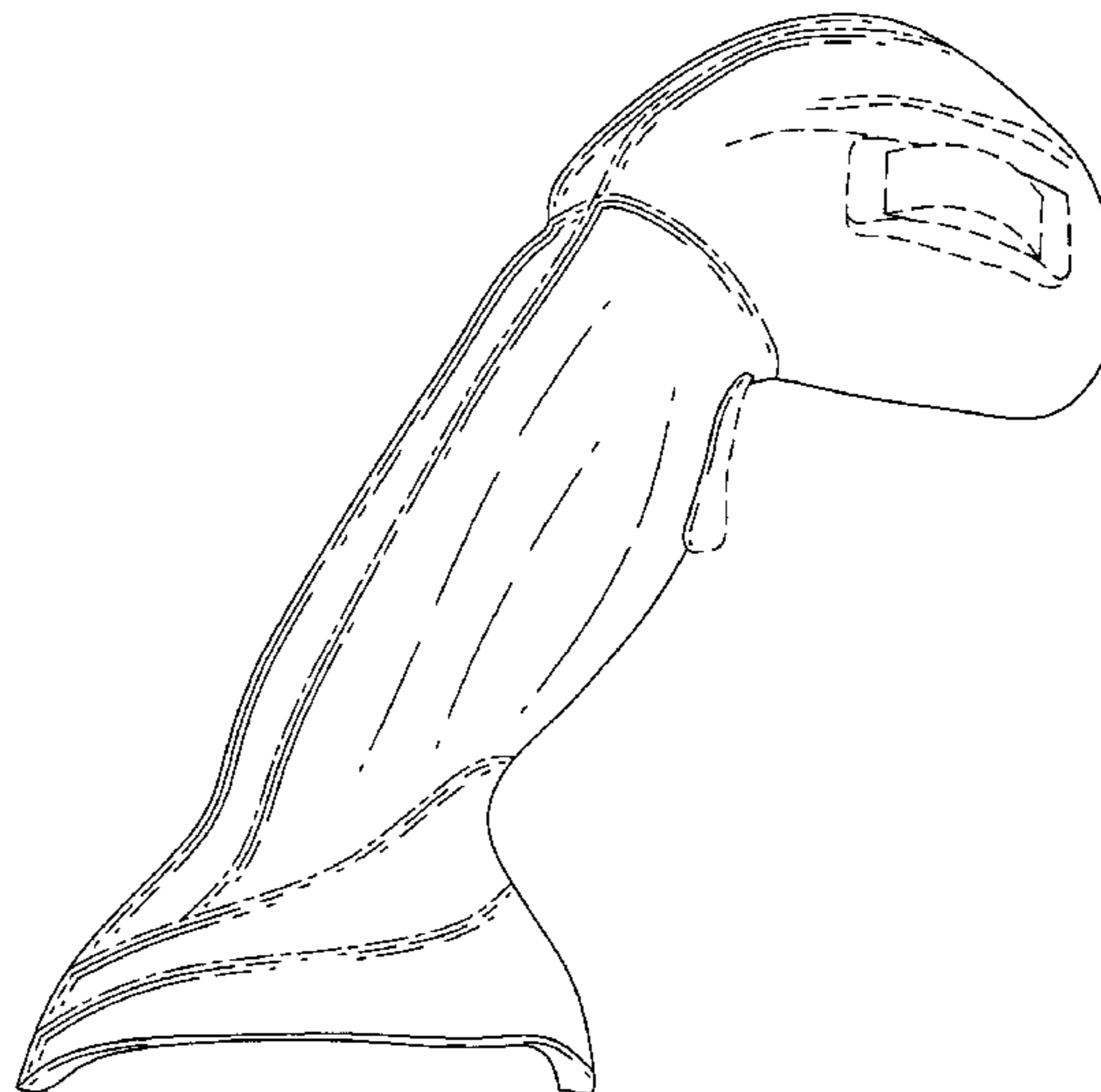
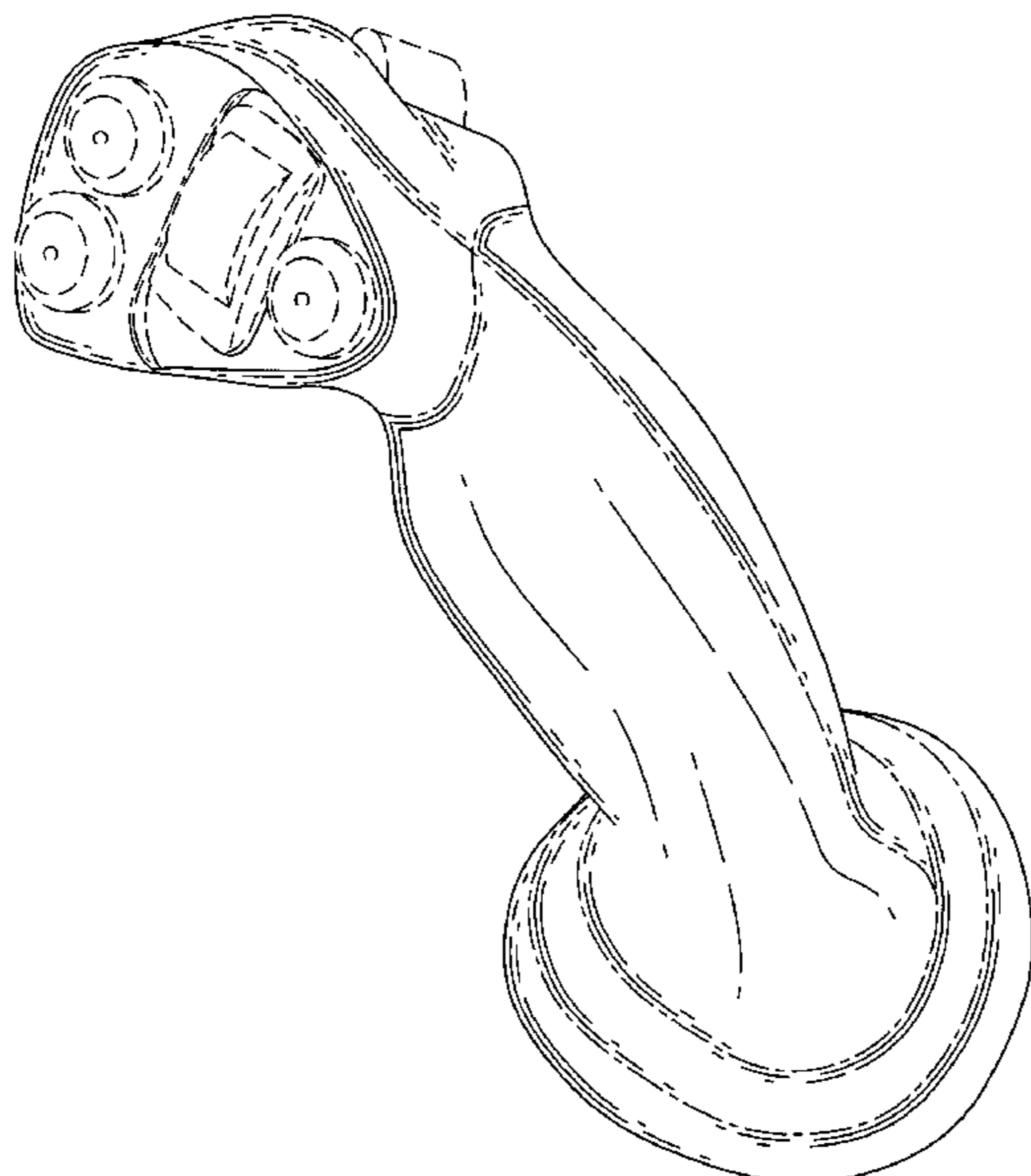
The ornamental design for a vertical grip assembly, as shown and described.

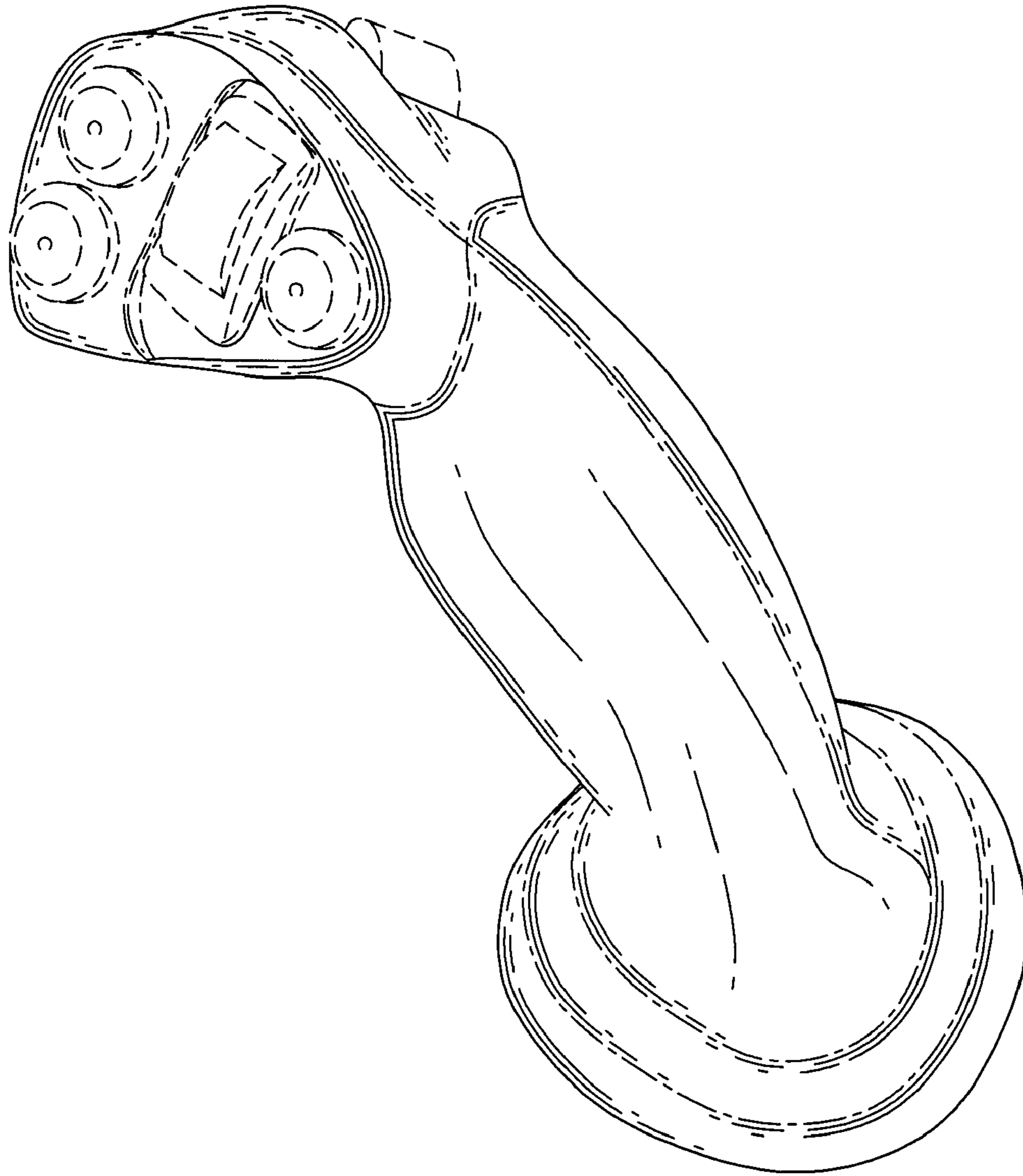
**DESCRIPTION**

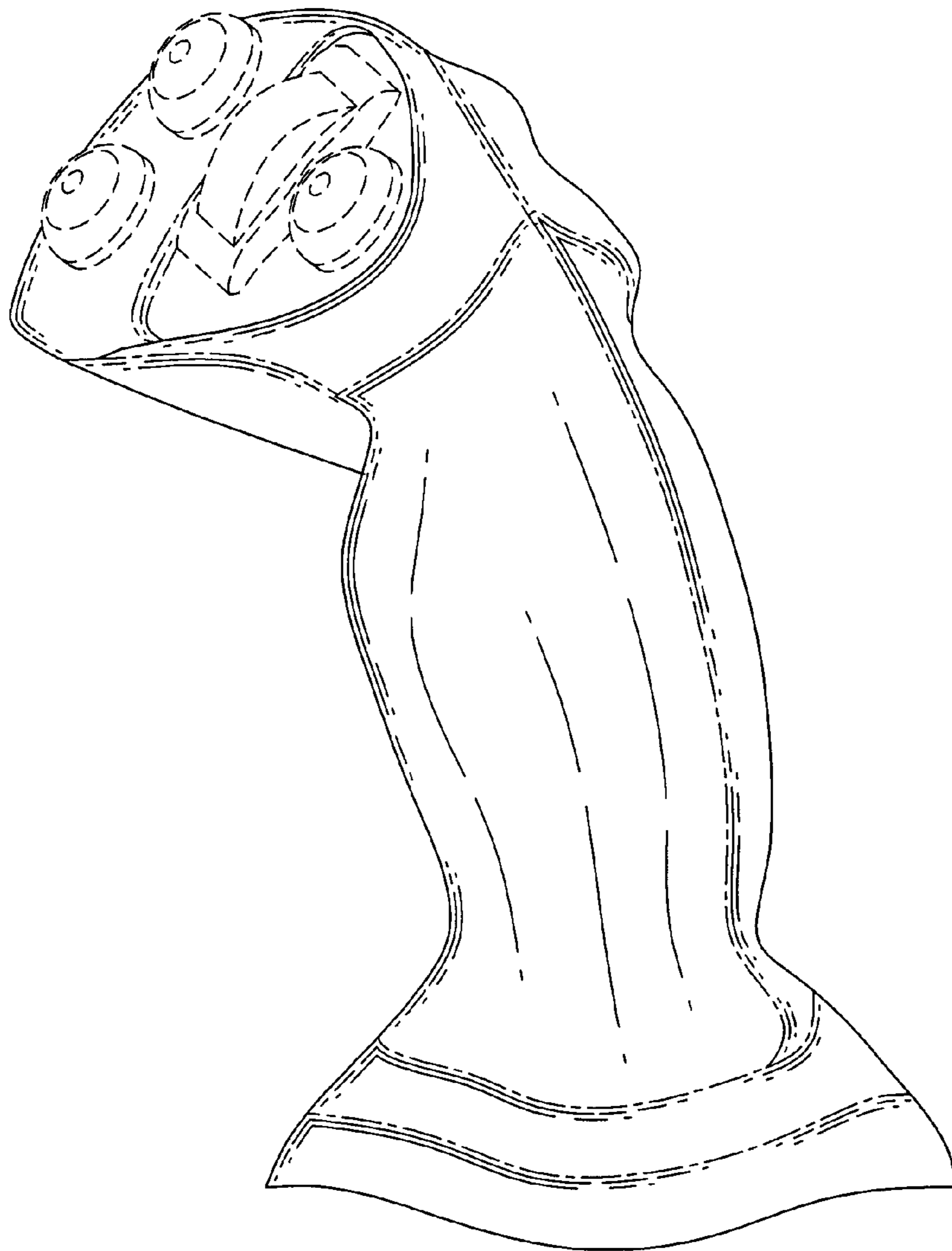

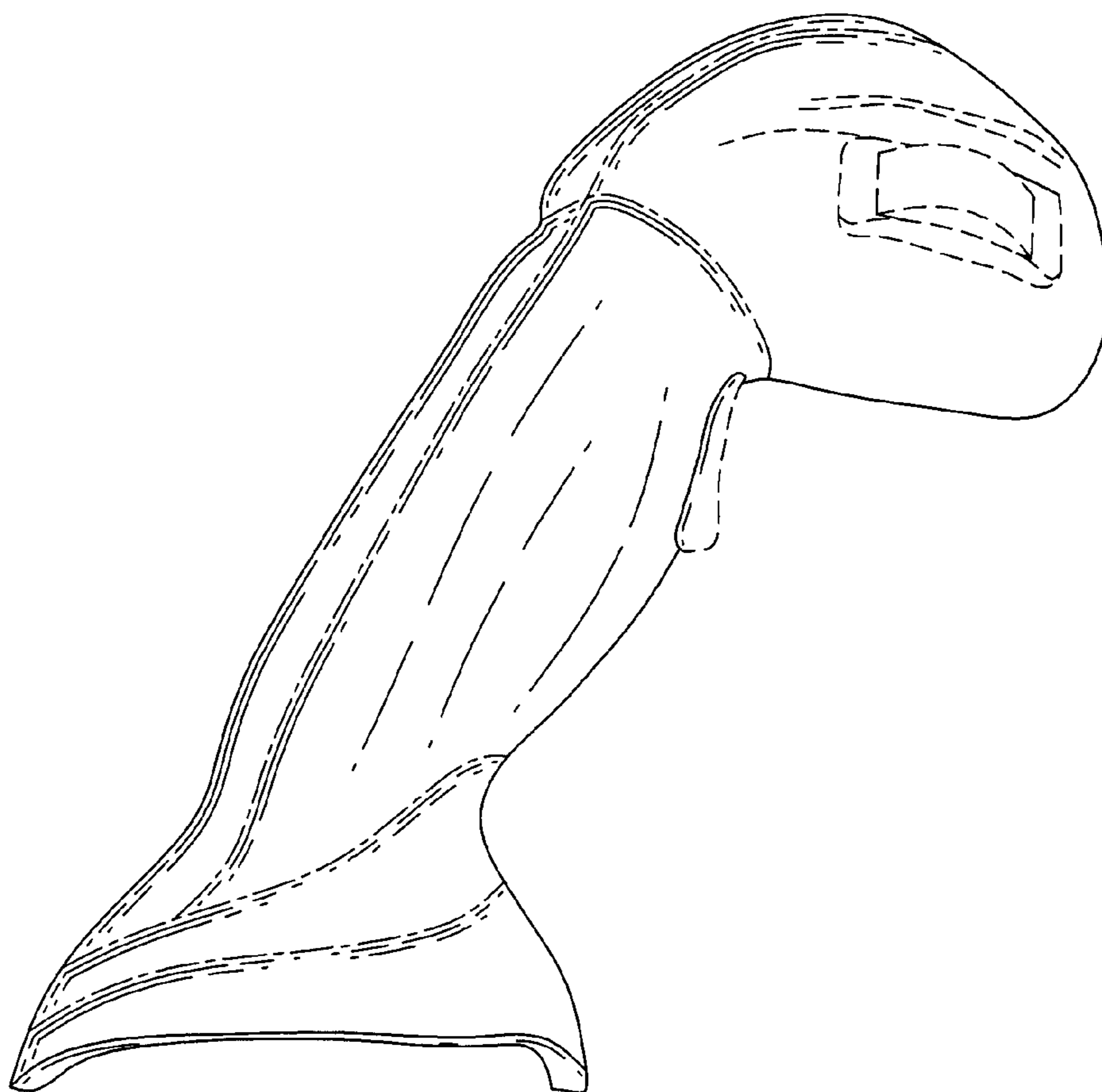

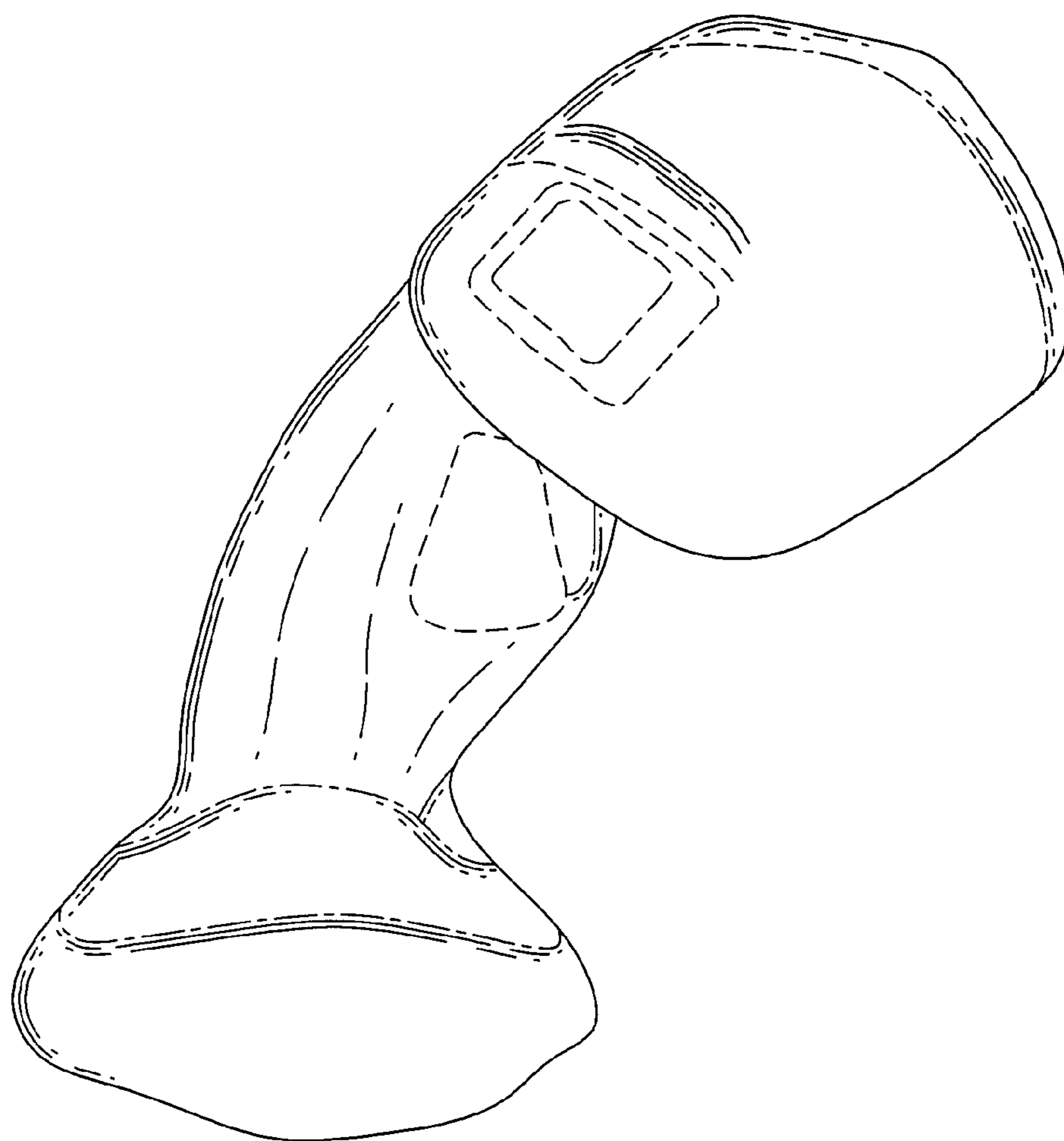

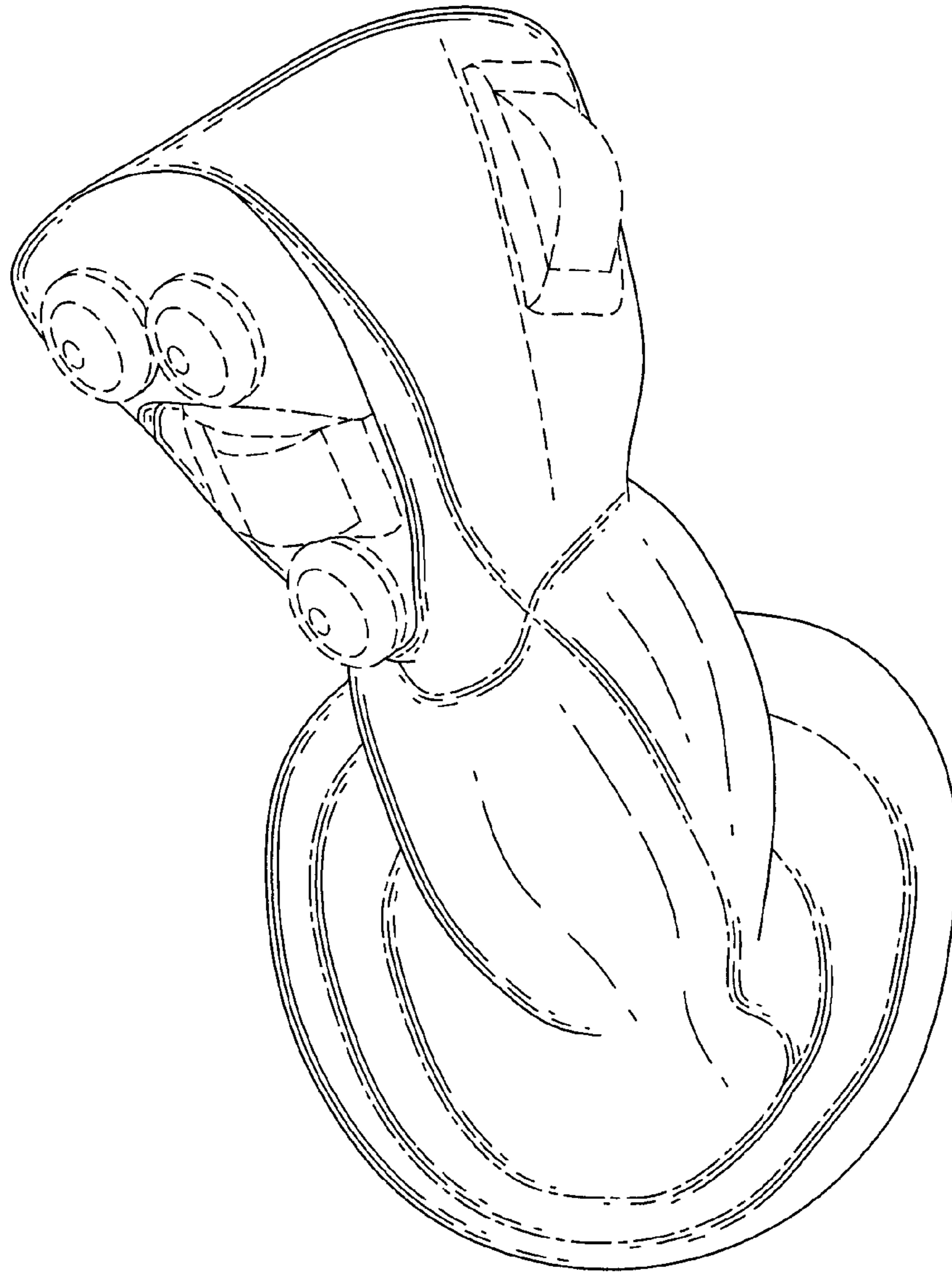

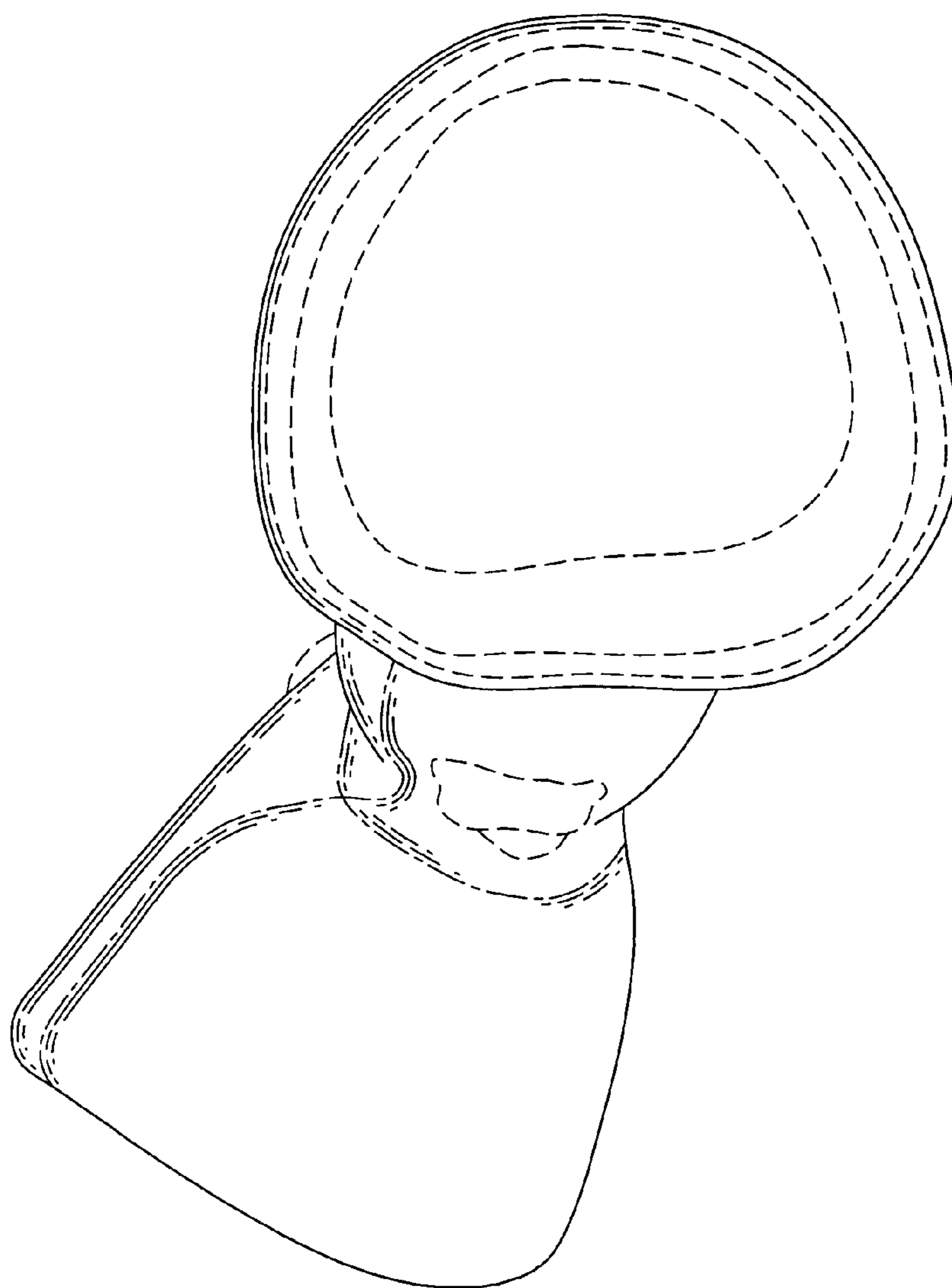
