DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface showing our new design; FIG. 2 is a front view of a second embodiment thereof; FIG. 3 is a front view of a third embodiment thereof; FIG. 4 is a front view of a fourth embodiment thereof; FIG. 5 is a front view of a fifth embodiment thereof; FIG. 6 is a front view of a sixth embodiment thereof; FIG. 7 is a front view of a seventh embodiment thereof; FIG. 8 is a front view of an eighth embodiment thereof; FIG. 9 is a front view of a ninth embodiment thereof; FIG. 10 is a front view of a tenth embodiment thereof; FIG. 11 is a front view of an eleventh embodiment thereof; and, FIG. 12 is a front view of a twelfth embodiment thereof. The broken lines in the Figures, showing the display screen or portion thereof form no part of the claimed design. 






















