The broken line representations of portions of the portable hydraulic pump in FIGS. 1 to 7 are shown for illustrative purposes only and form no part of the claimed design.

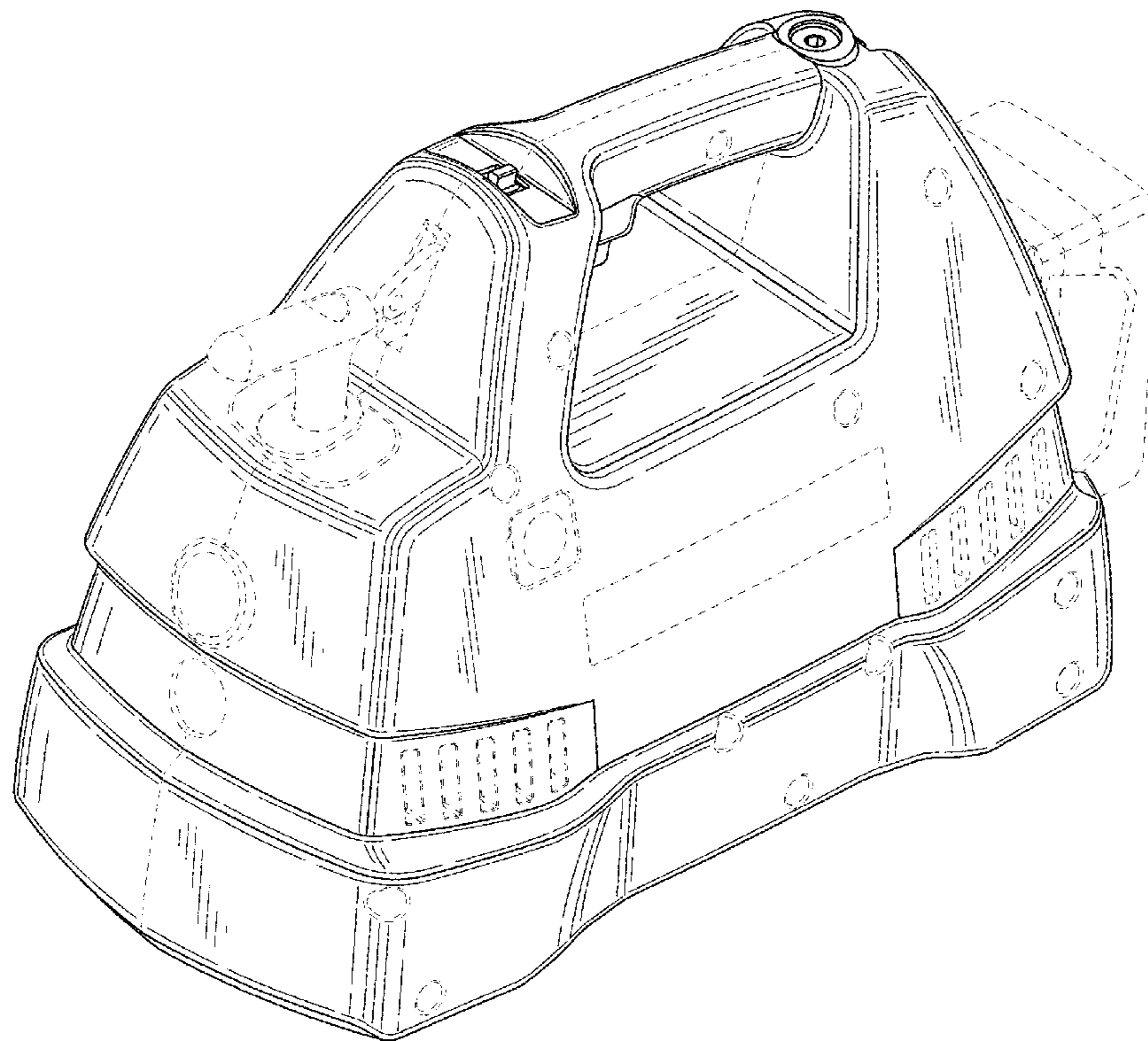

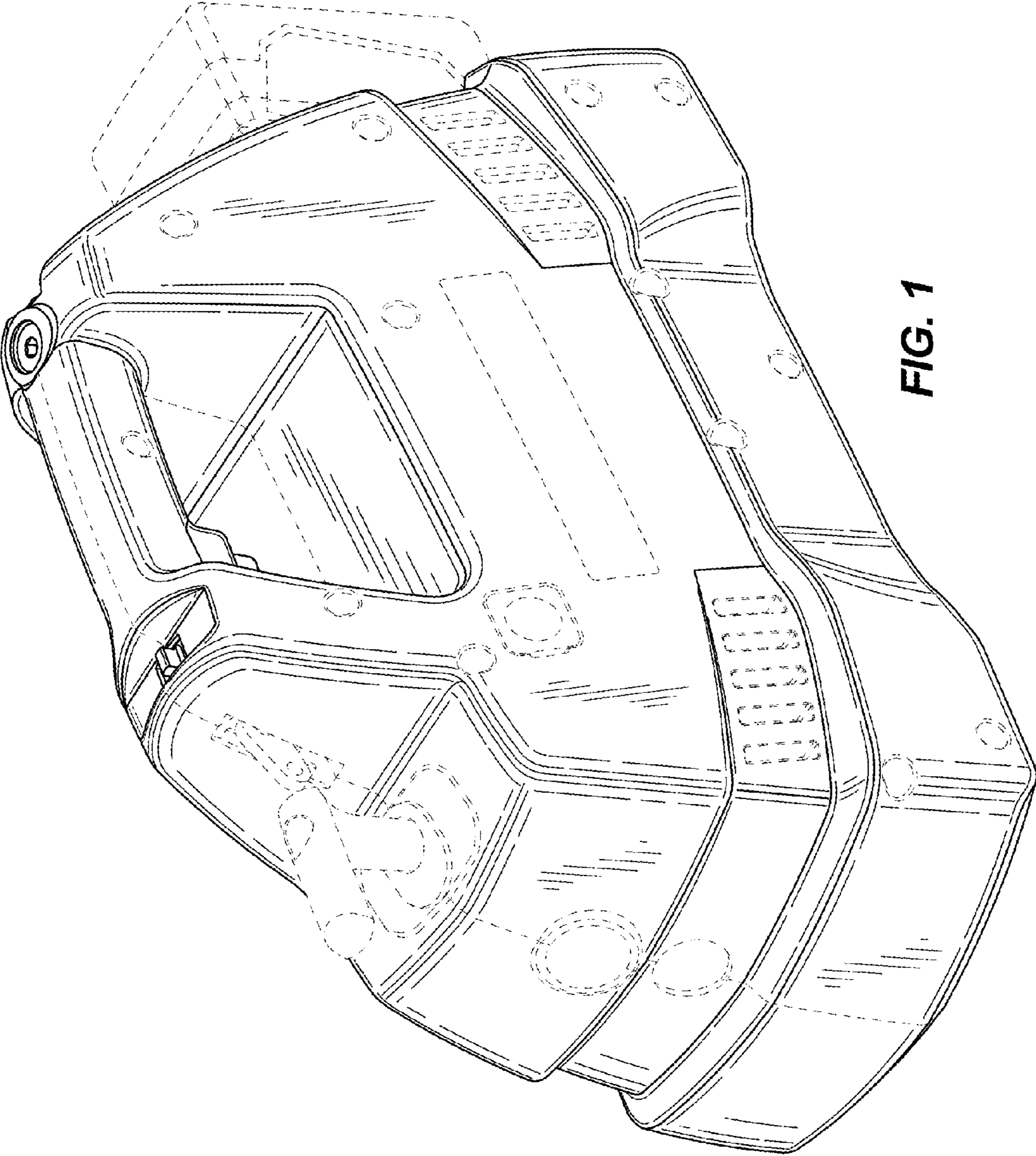

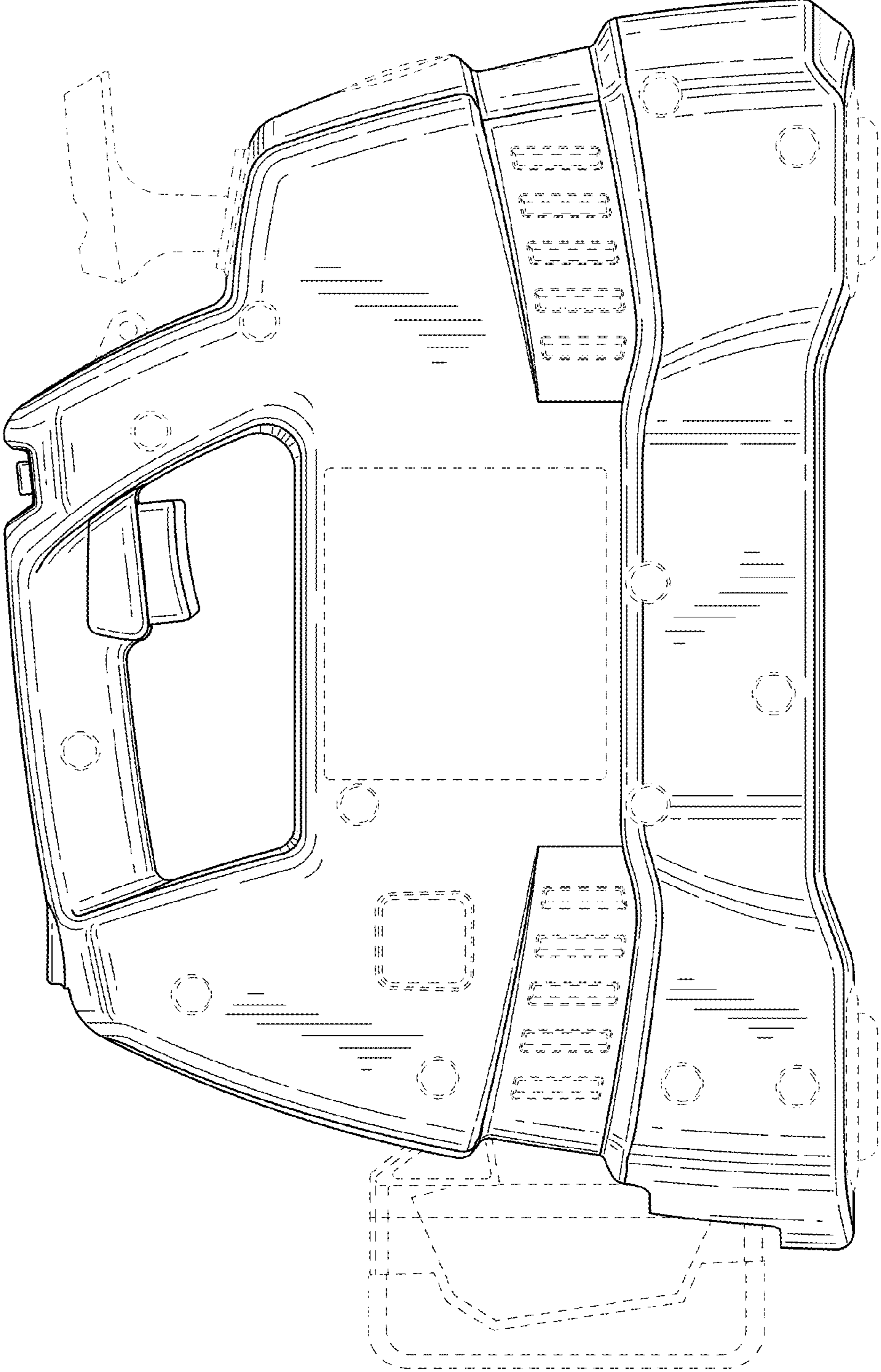

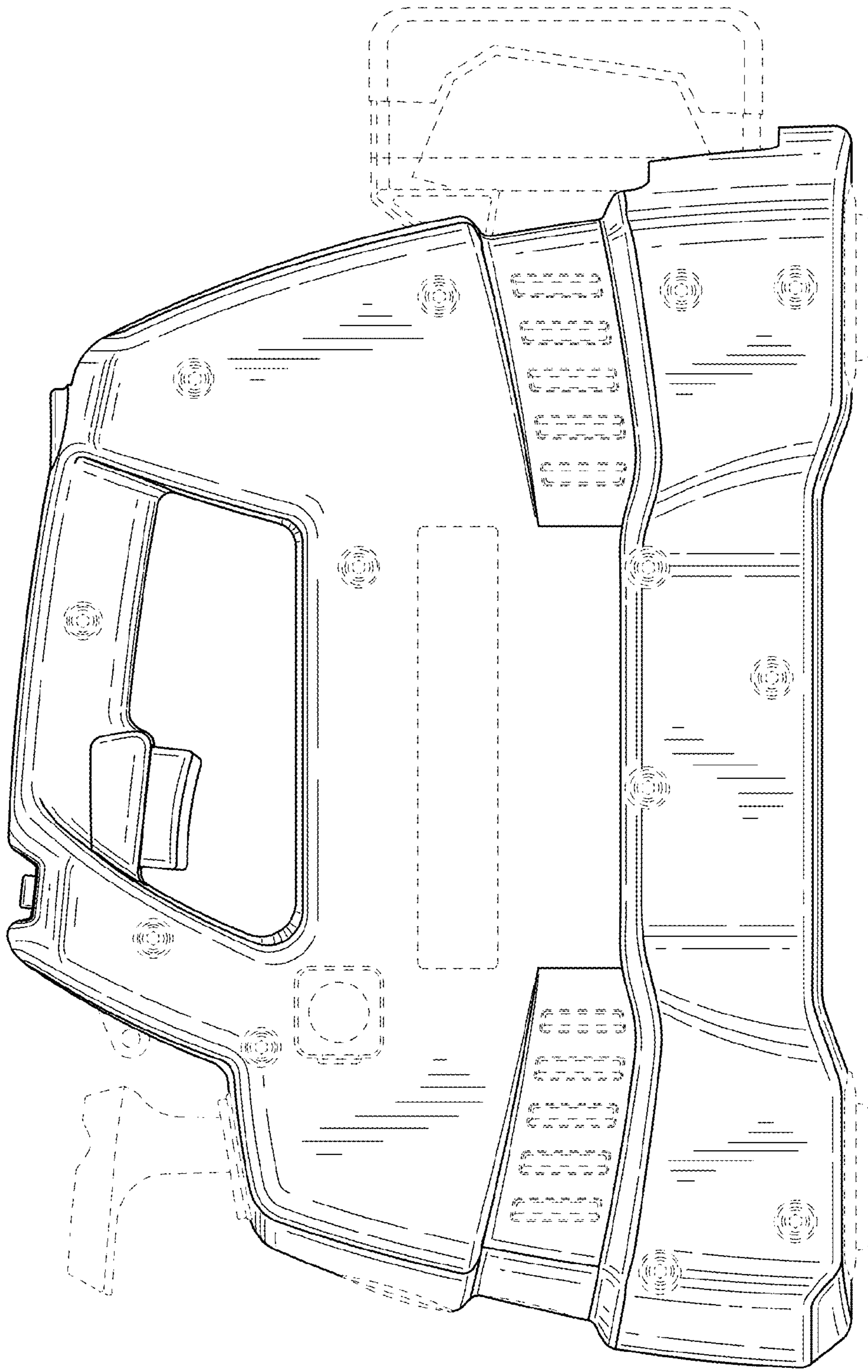

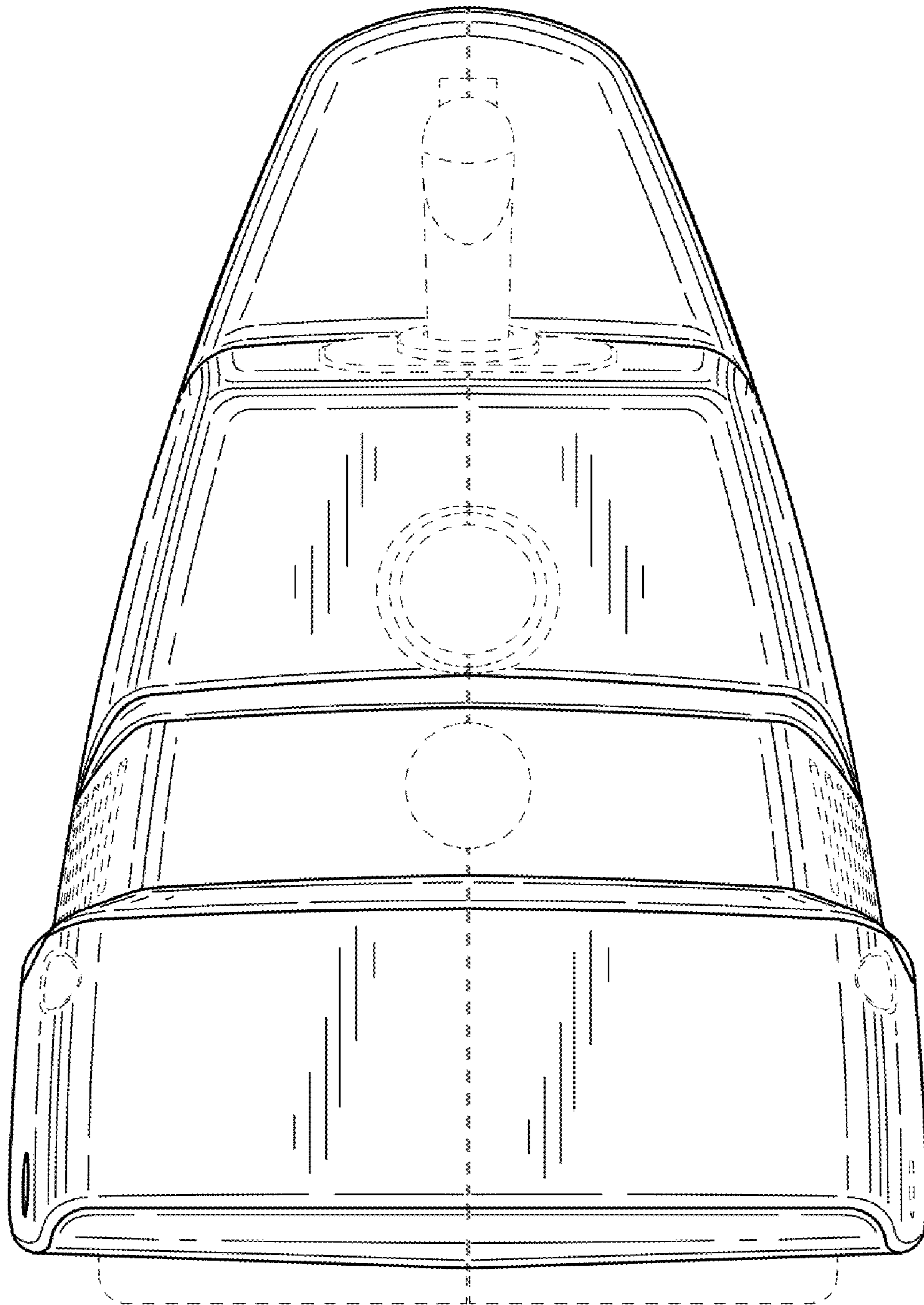

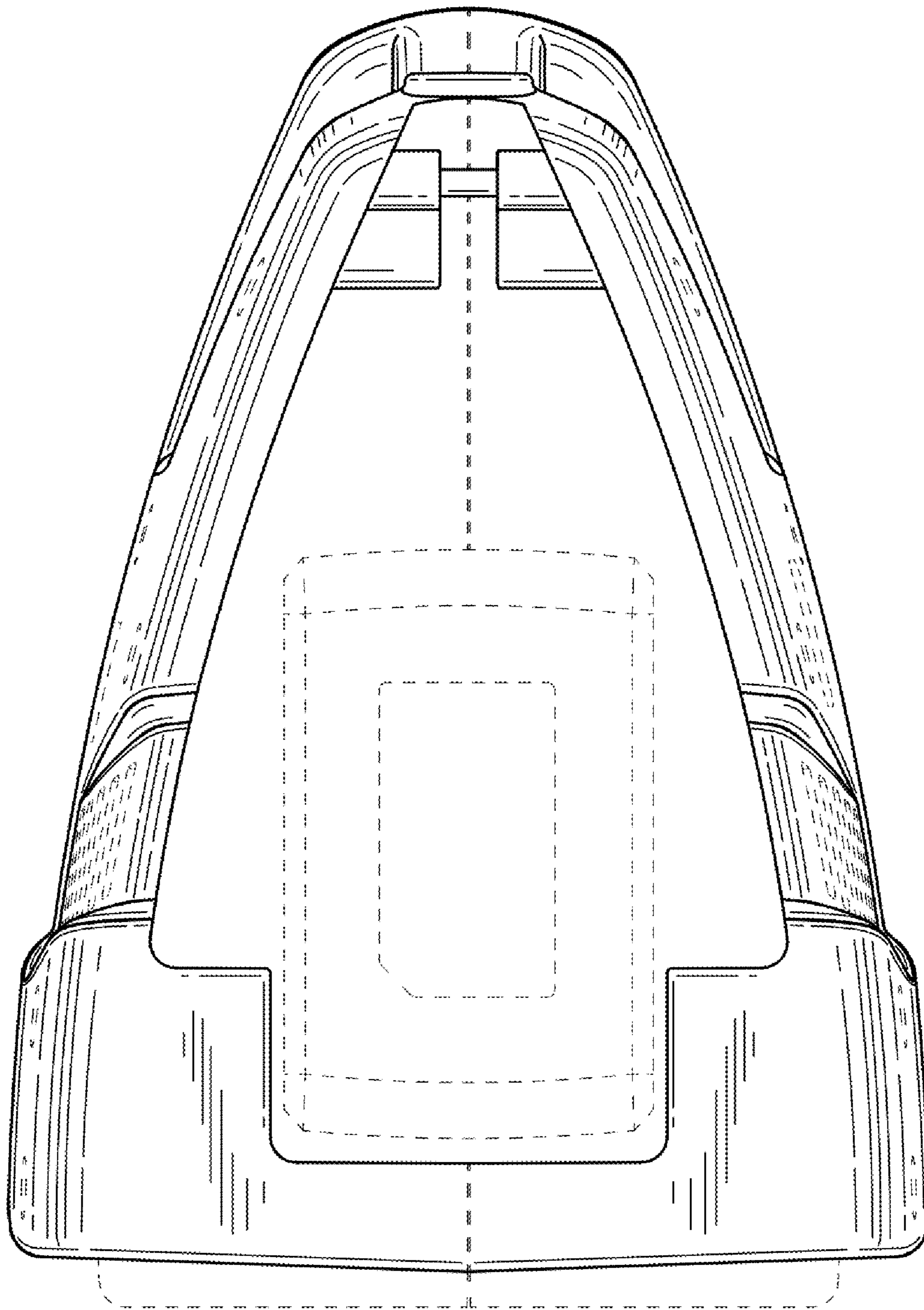

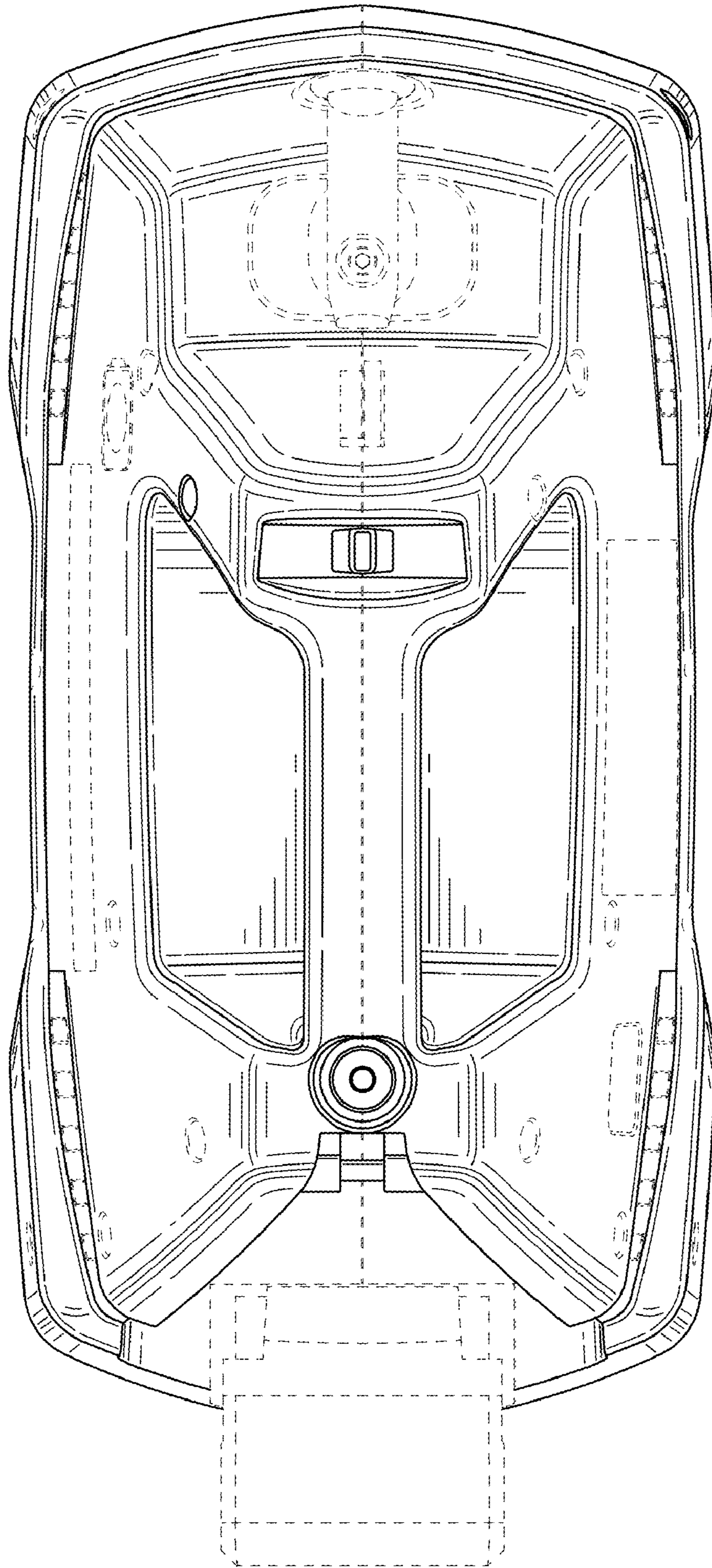

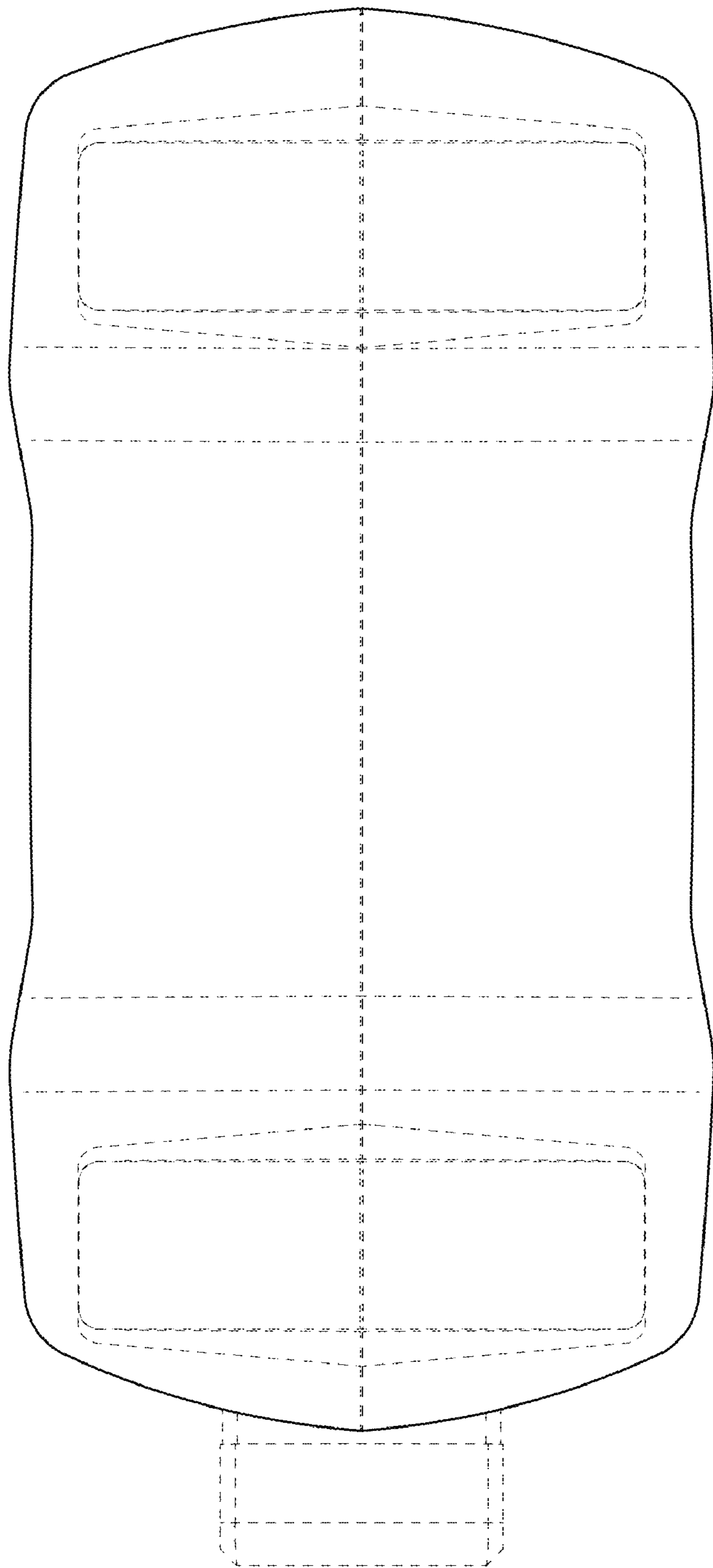
