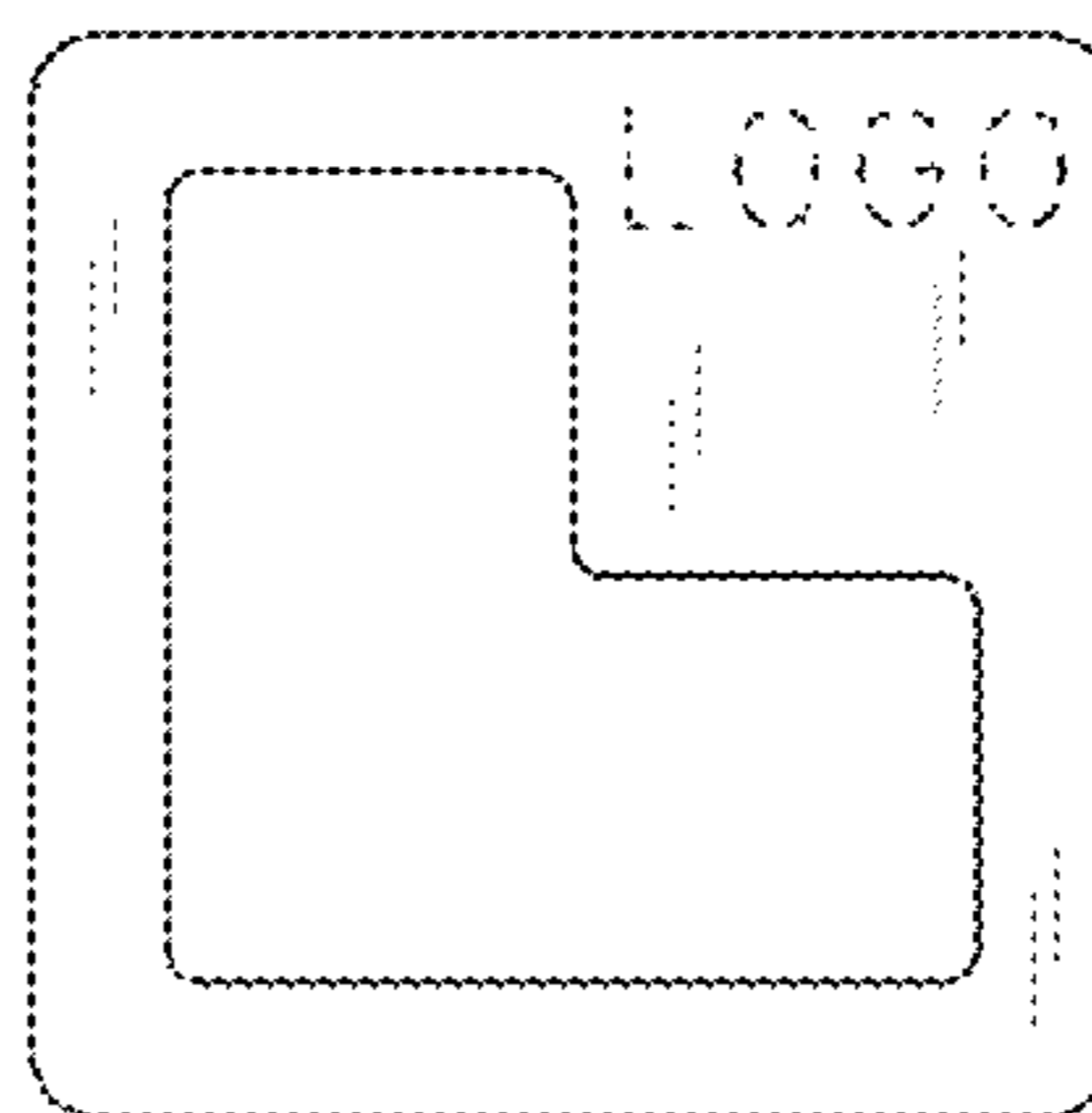
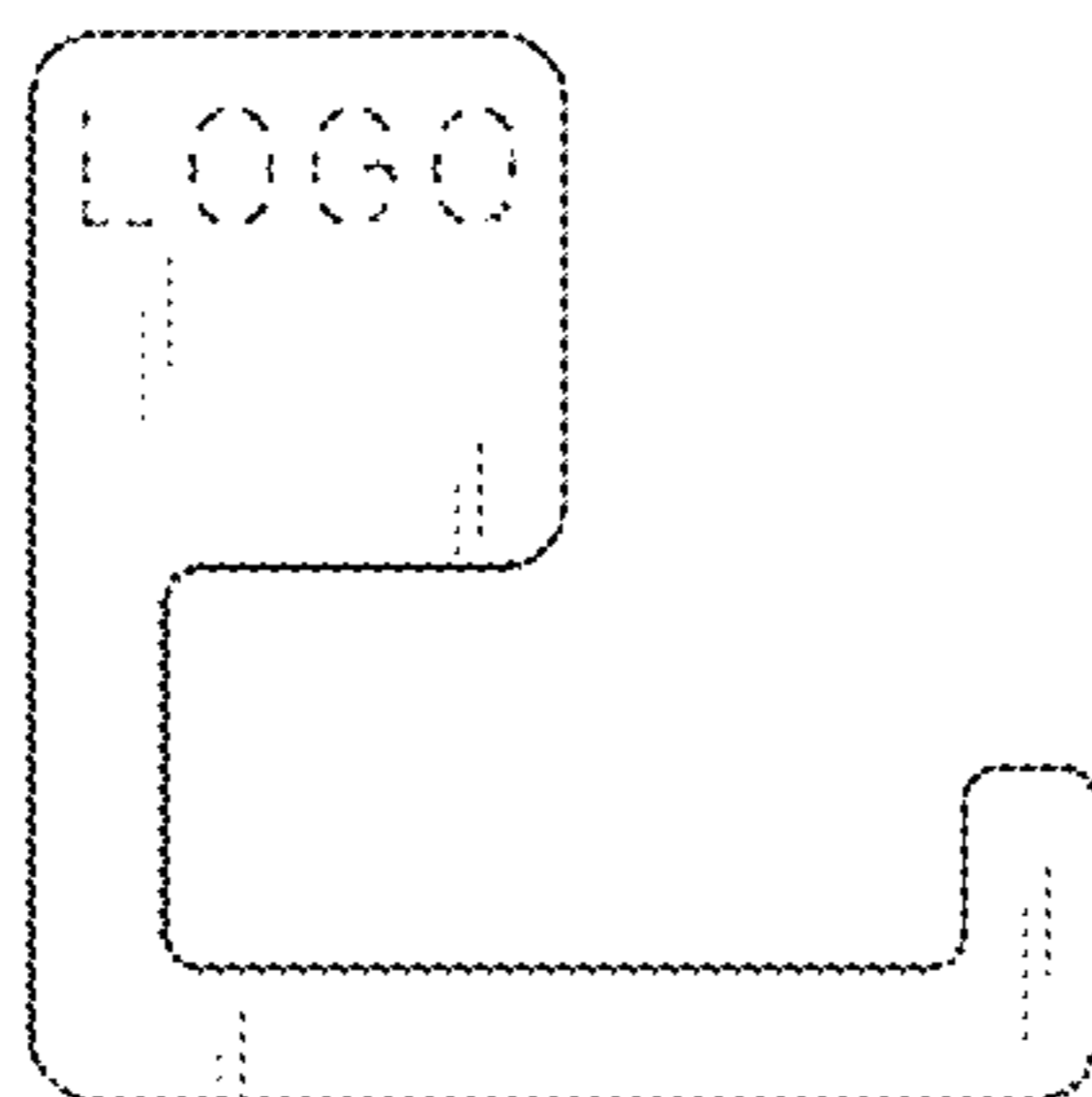
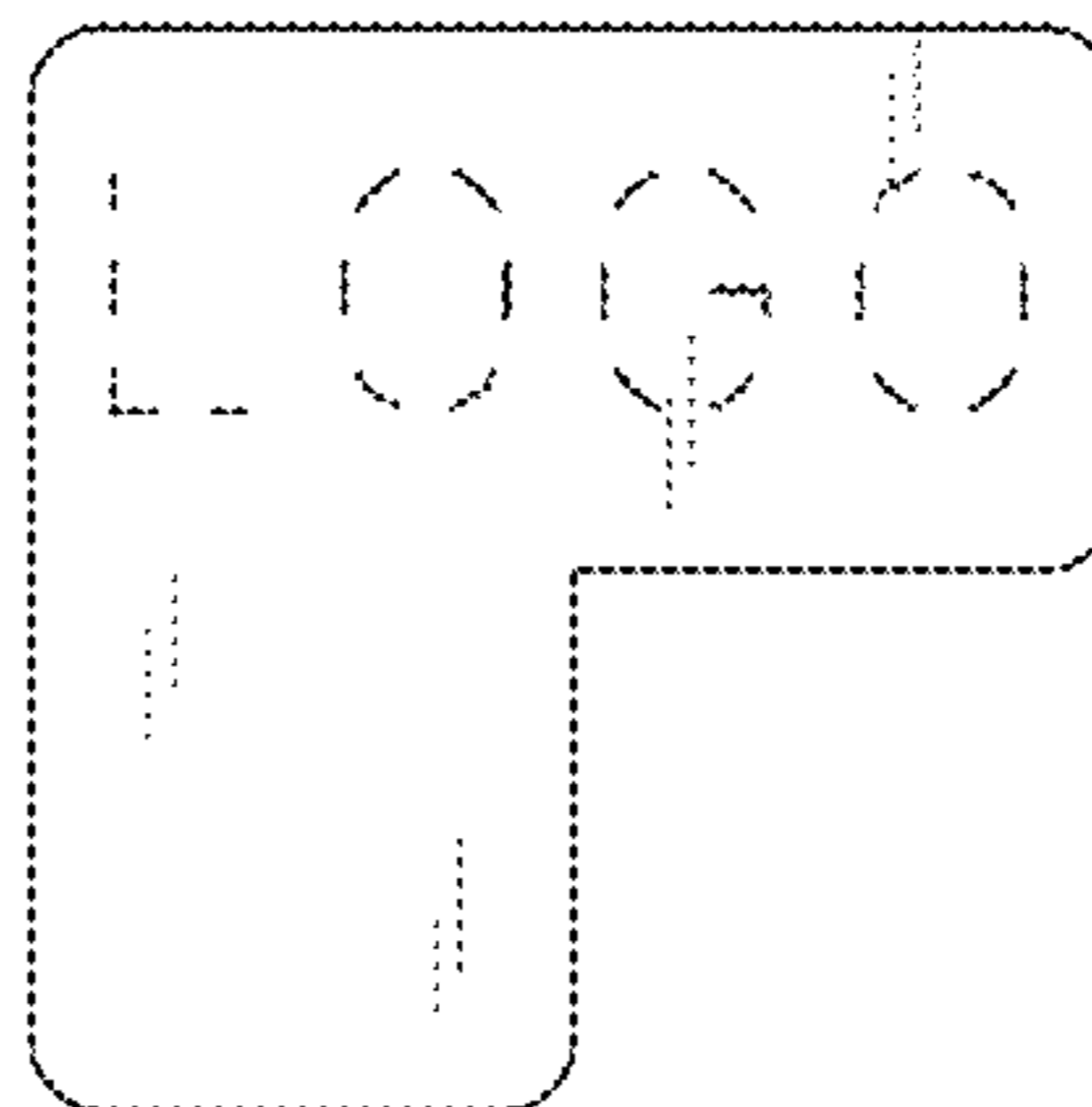
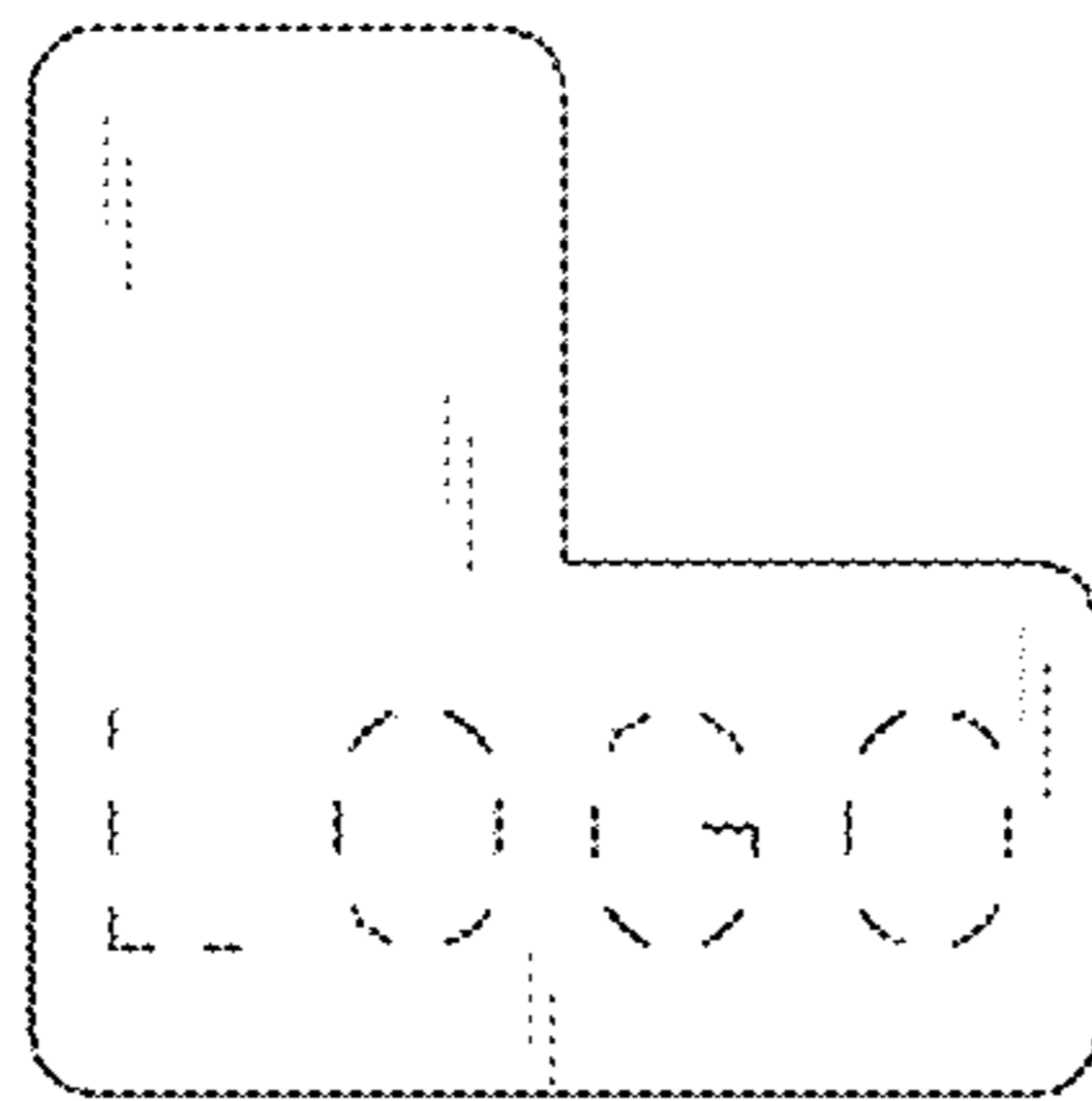
(57) **CLAIM**

I claim the ornamental design for the set of instant photograph filters, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the set of instant photograph filters. FIG. 2 is a rear view of the claimed design. FIG. 3 is a right side view of the claimed design. FIG. 4 is a top view of the claimed design; and, FIG. 5 is an isometric view of one of the set of instant photograph filters in use with an instant photograph camera, which is depicted in broken lines and forms no part of the claimed design.

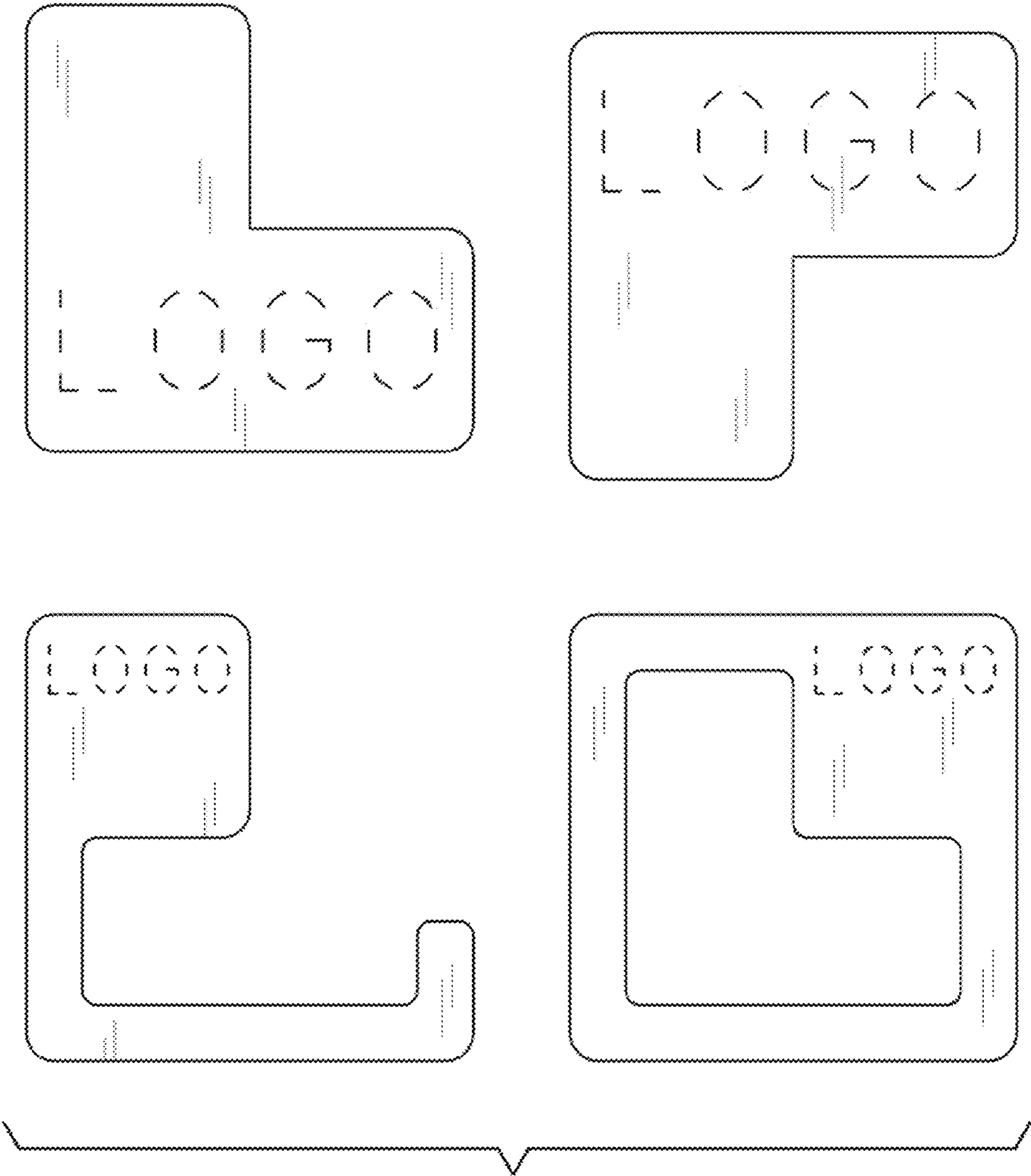

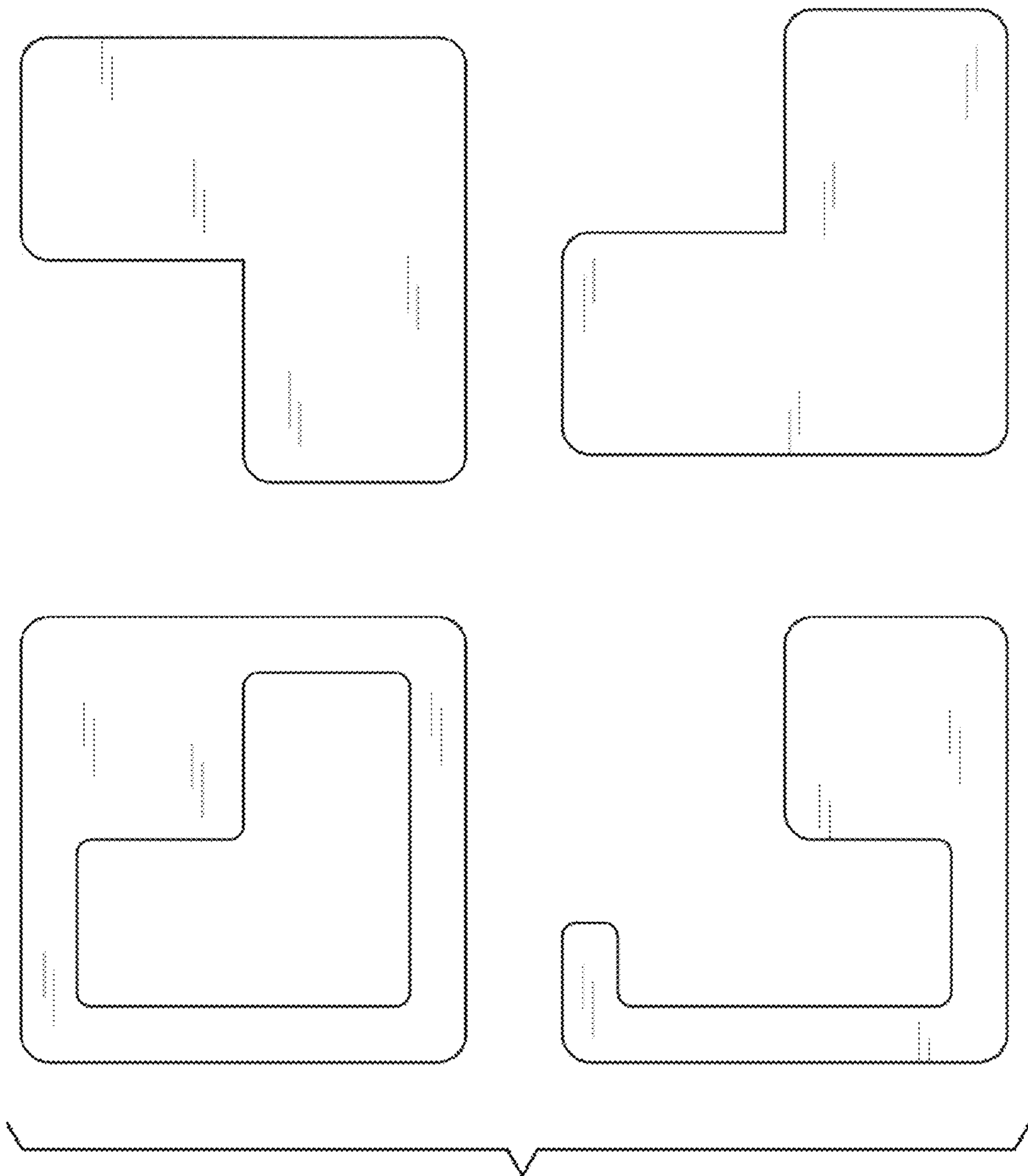

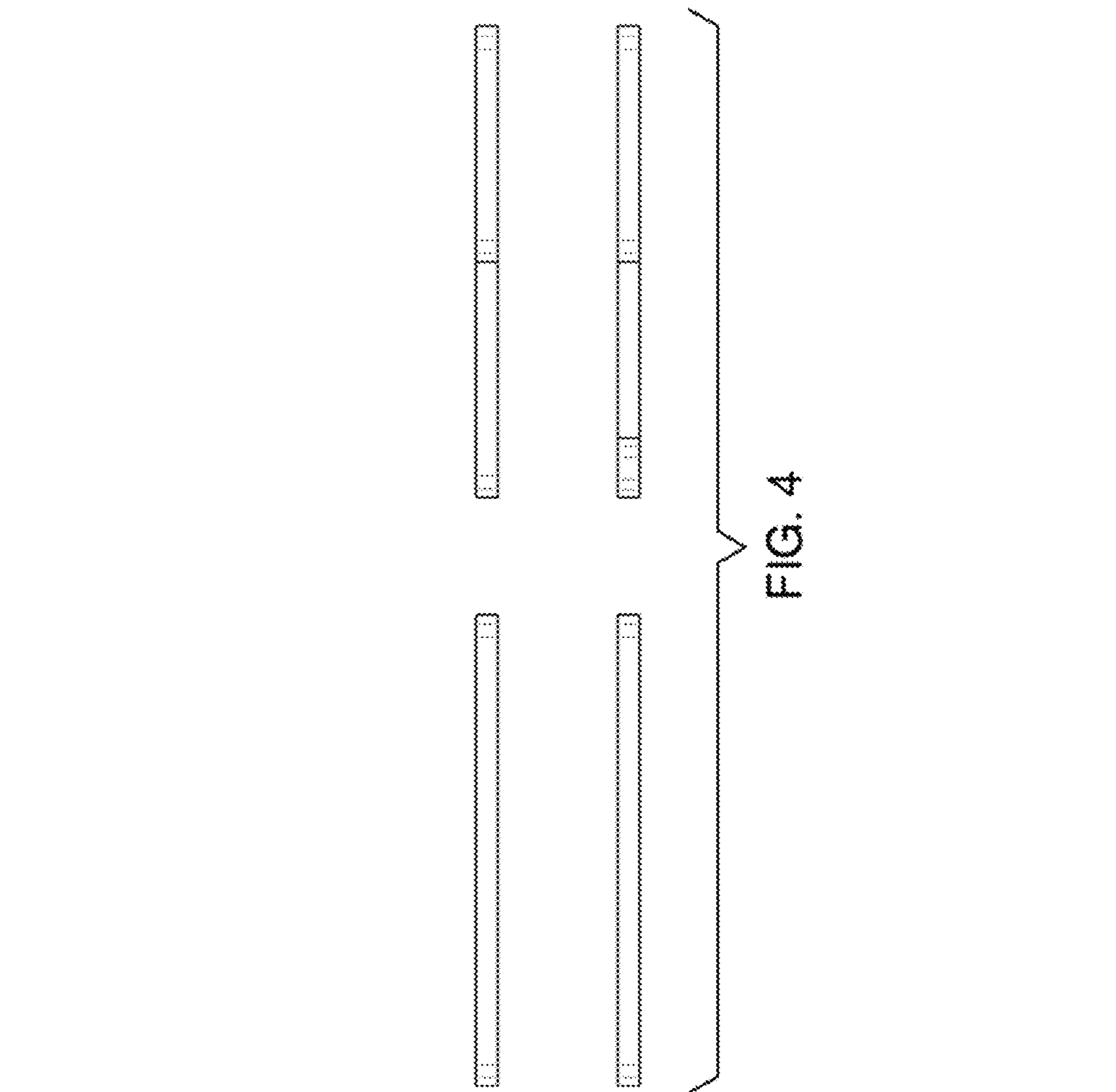

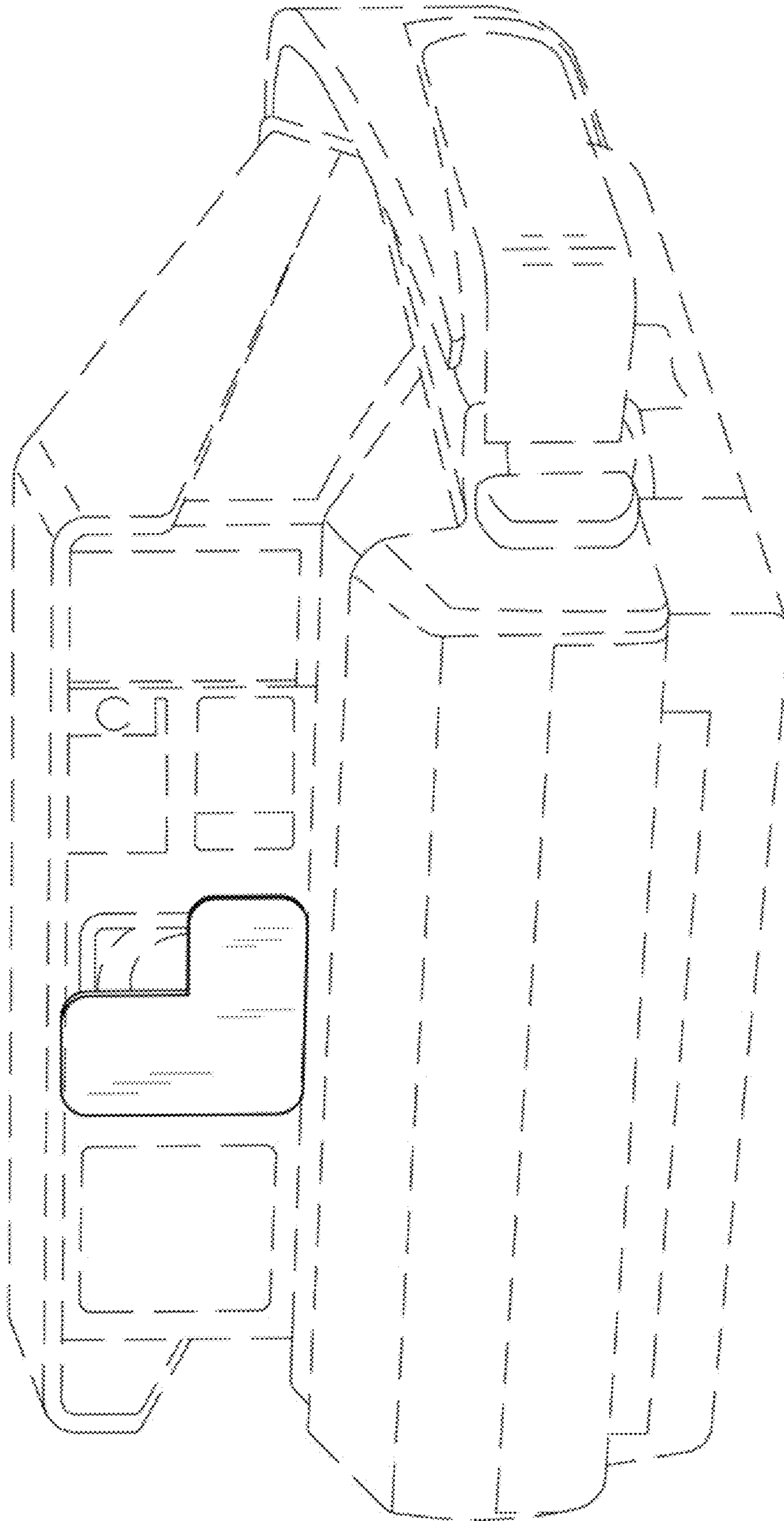
