FIG. 3 is a rear elevational view of the camera handle;

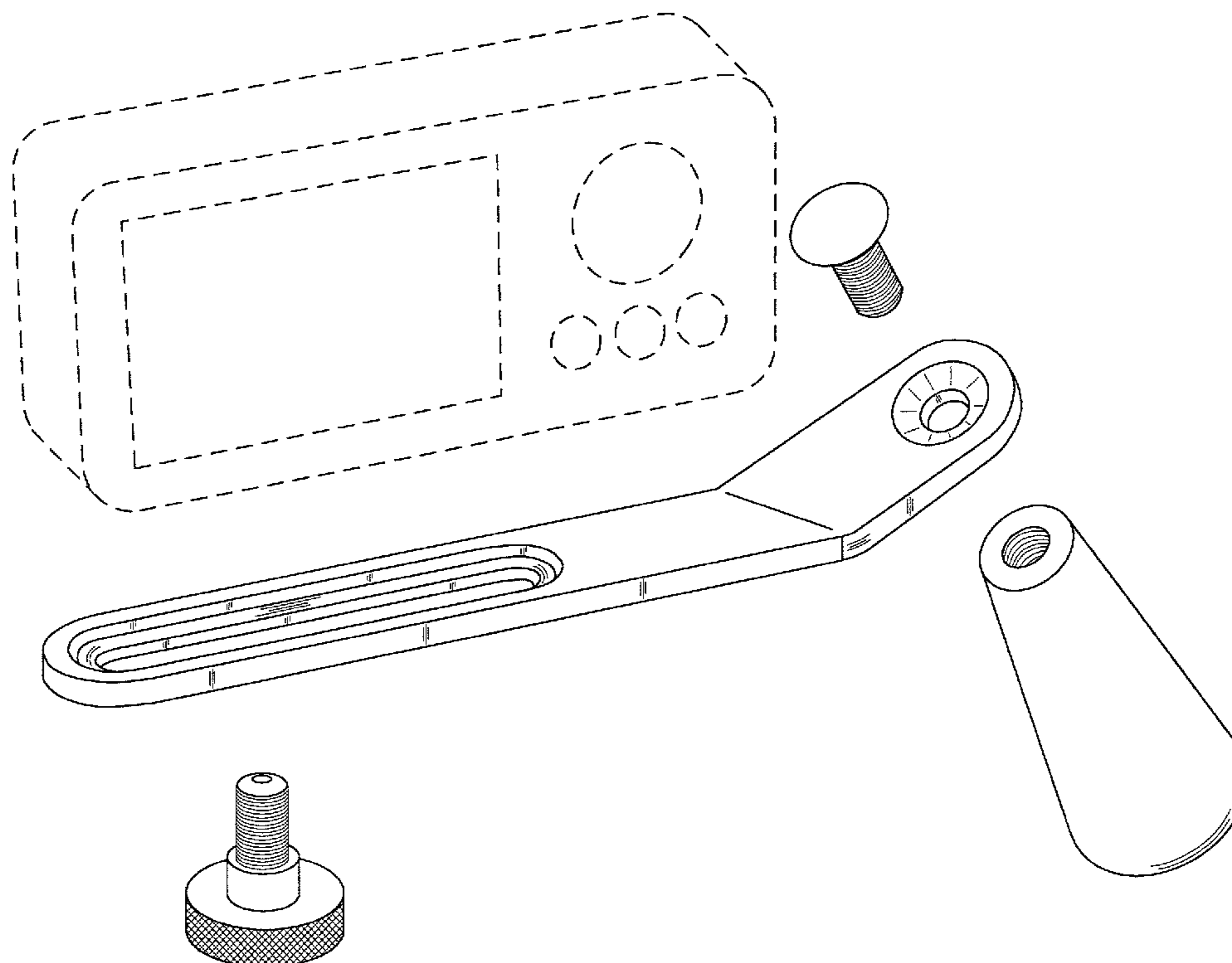
FIG. 4 is a top plan view of the camera handle;

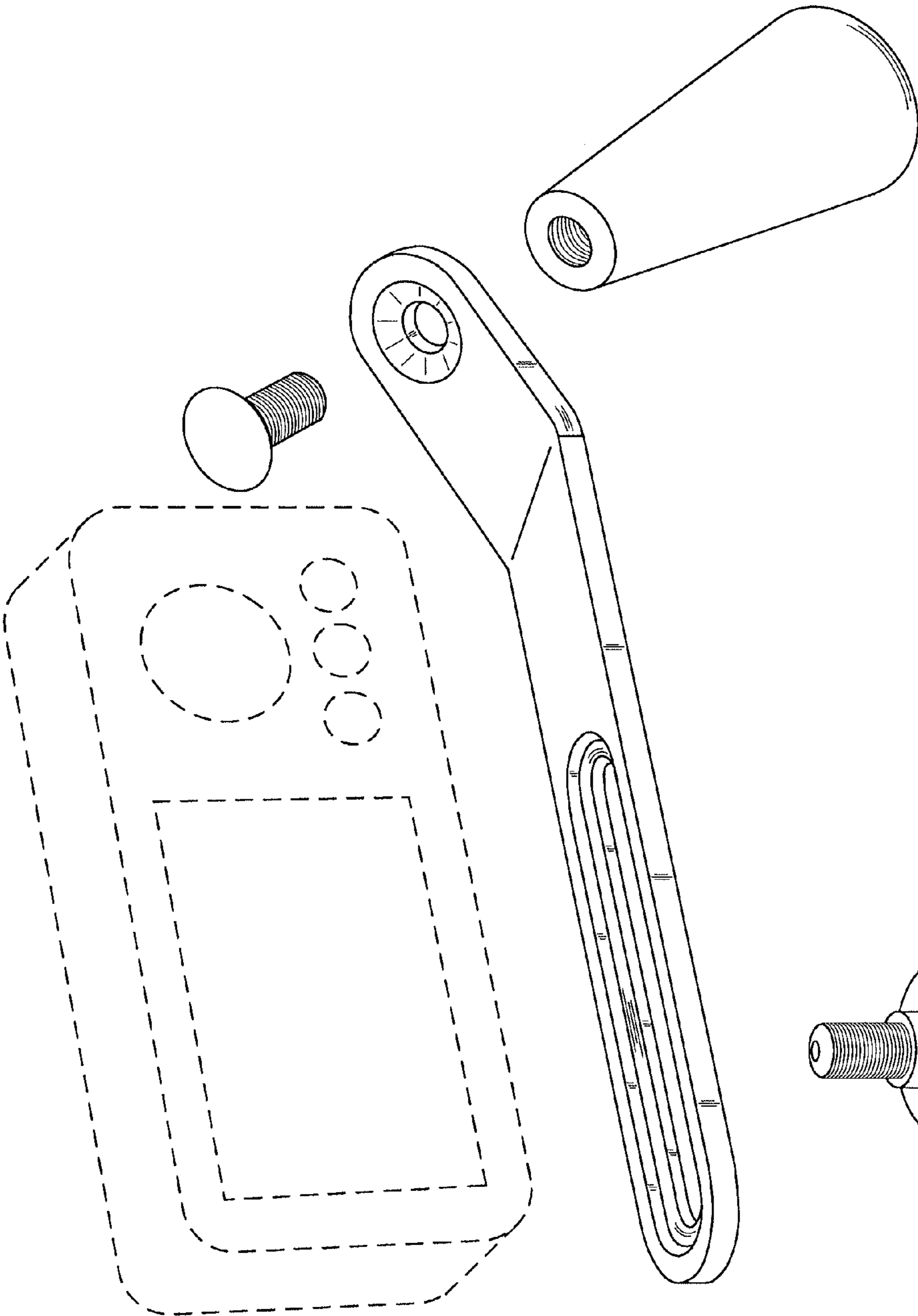

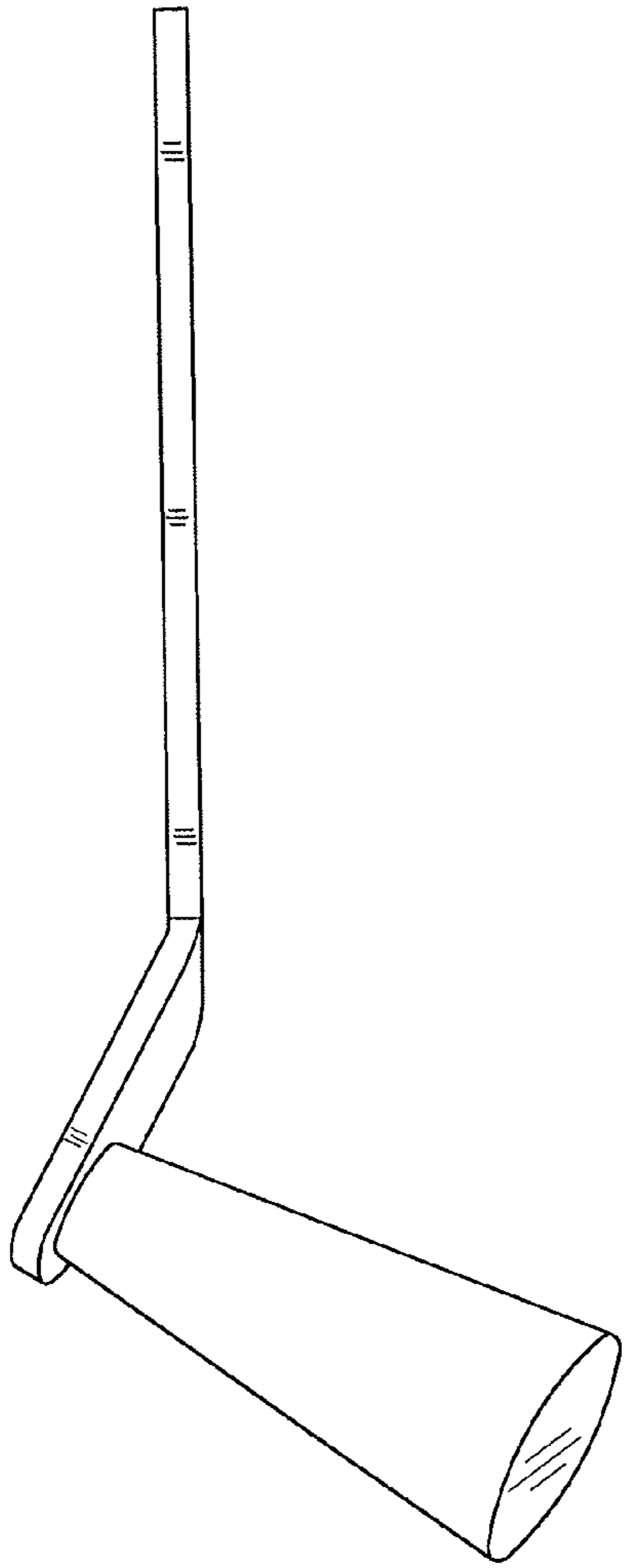

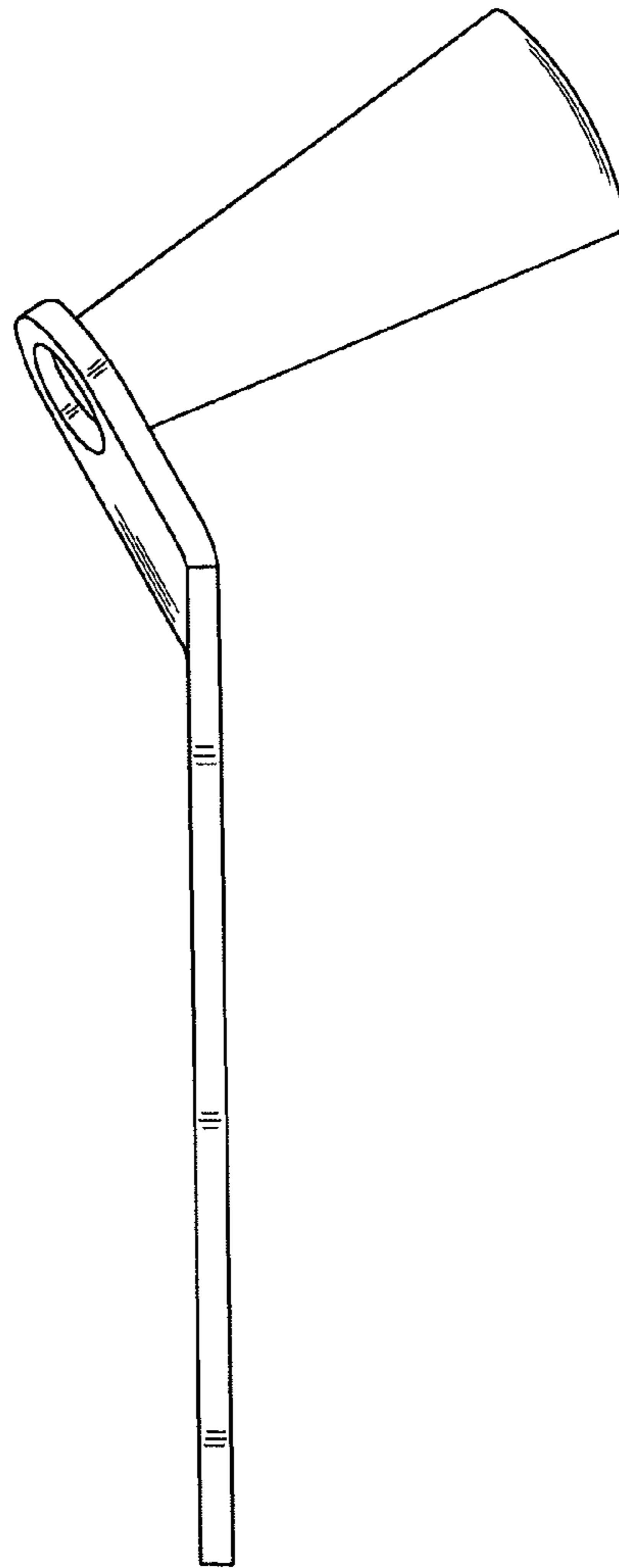

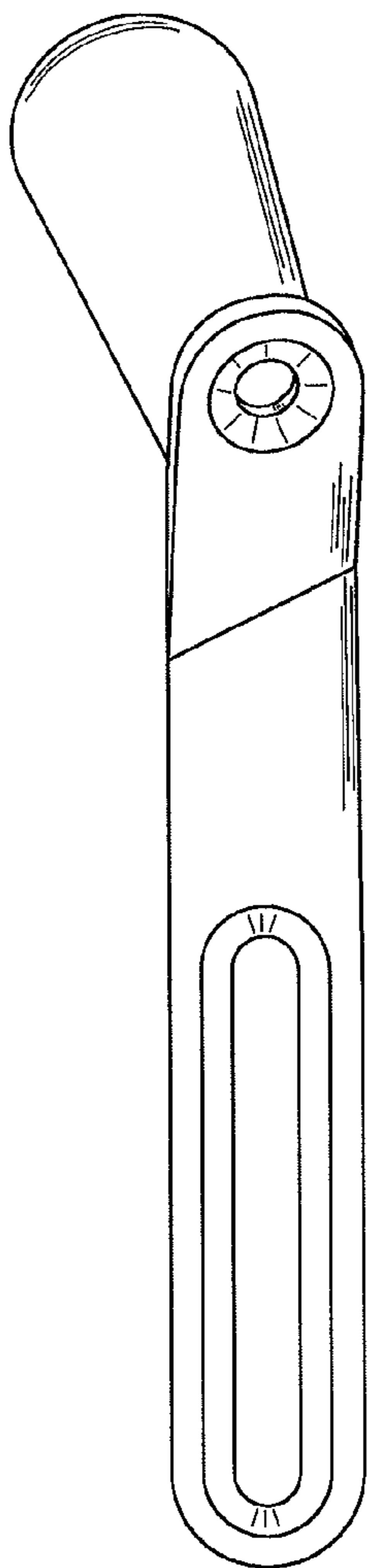

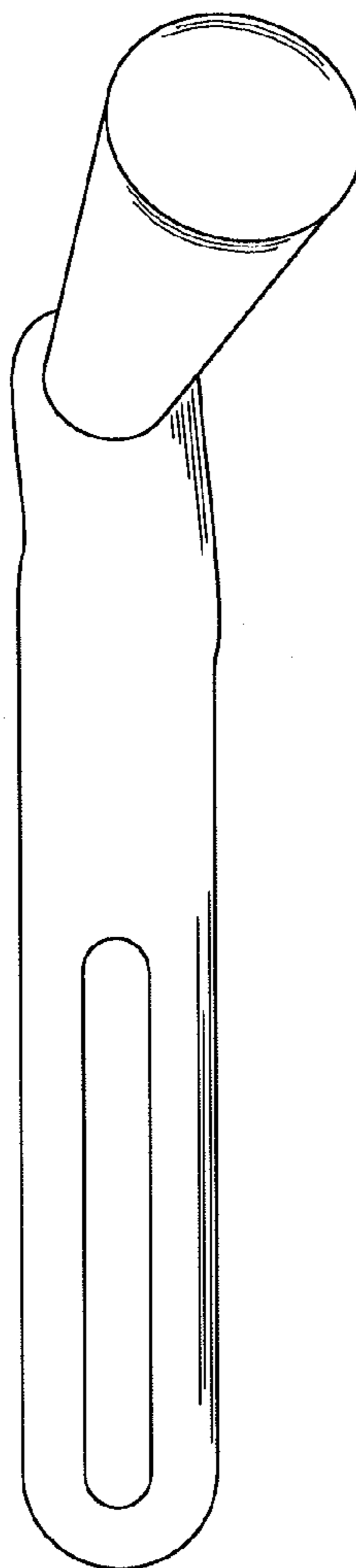

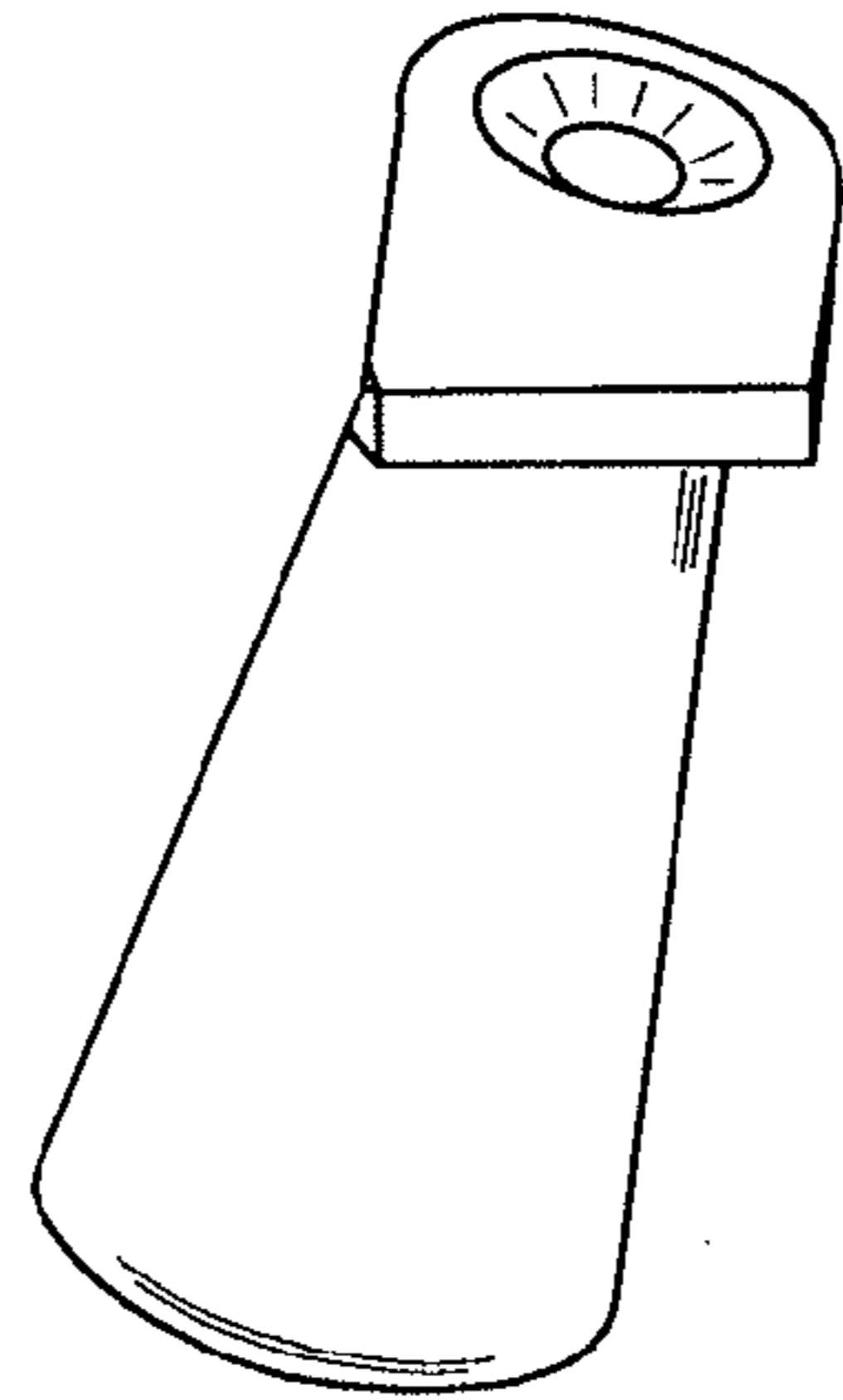

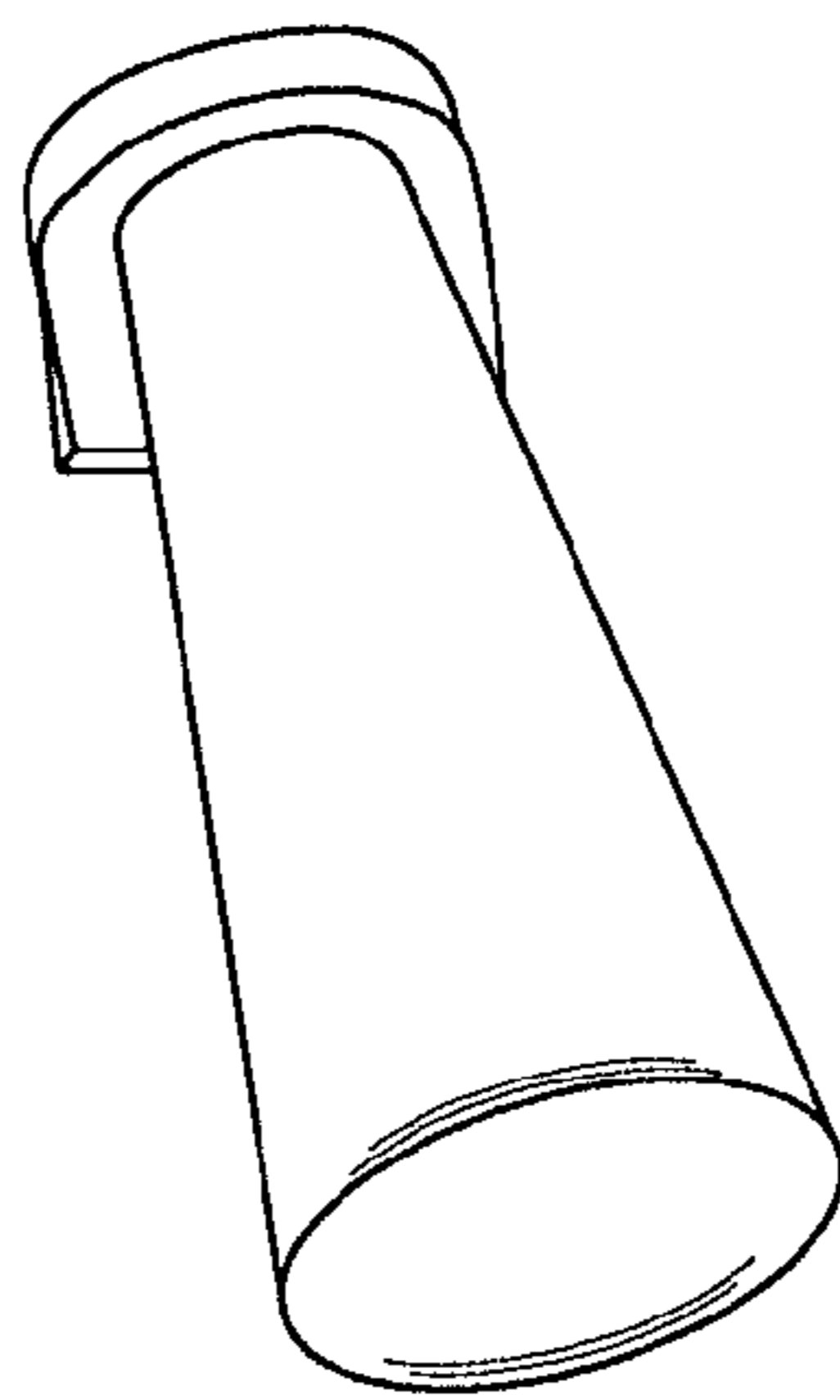
