(57) **CLAIM**

The ornamental design for a connector paint box, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side, top perspective view of the connector paint box;

FIG. 2 is a right side elevational view of the connector paint box shown in FIG. 1, the left side being identical thereto;

FIG. 3 is a front elevational view of the connector paint box shown in FIG. 1, the rear being identical thereto;

FIG. 4 is a top plan view of the connector paint box shown in FIG. 1;

FIG. 5 is a front, right side, top perspective view of the connector paint box in a stacked configuration;

FIG. 6 is a right side elevational view of the connector paint box in a stacked configuration shown in FIG. 5, the left side being identical thereto;

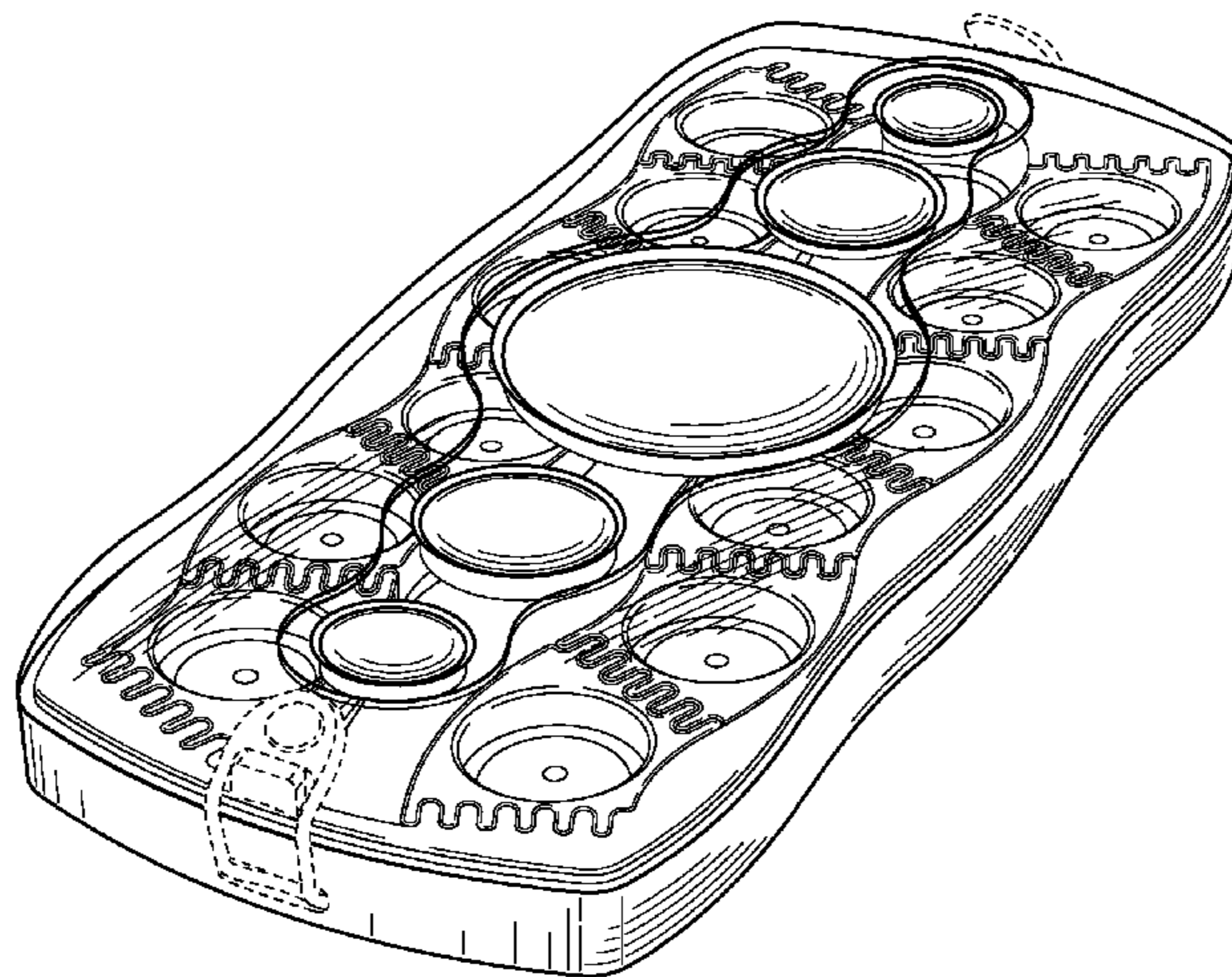
FIG. 7 is a front elevational view of the connector paint box in a stacked configuration shown in FIG. 5, the rear being identical thereto;

FIG. 8 is a top exploded view of the connector paint box shown in FIGS. 1 and 5; and,

FIG. 9 is a bottom plan view of the connector paint box shown in FIGS. 1 and 5.

The broken lines showing latches on the ends in FIGS. 1-9, the lower connector paint box in FIGS. 5-7, and the features and surfaces on the bottom in FIG. 9 are included for the purpose of showing portions of the connector paint box that form no part of the claimed design.

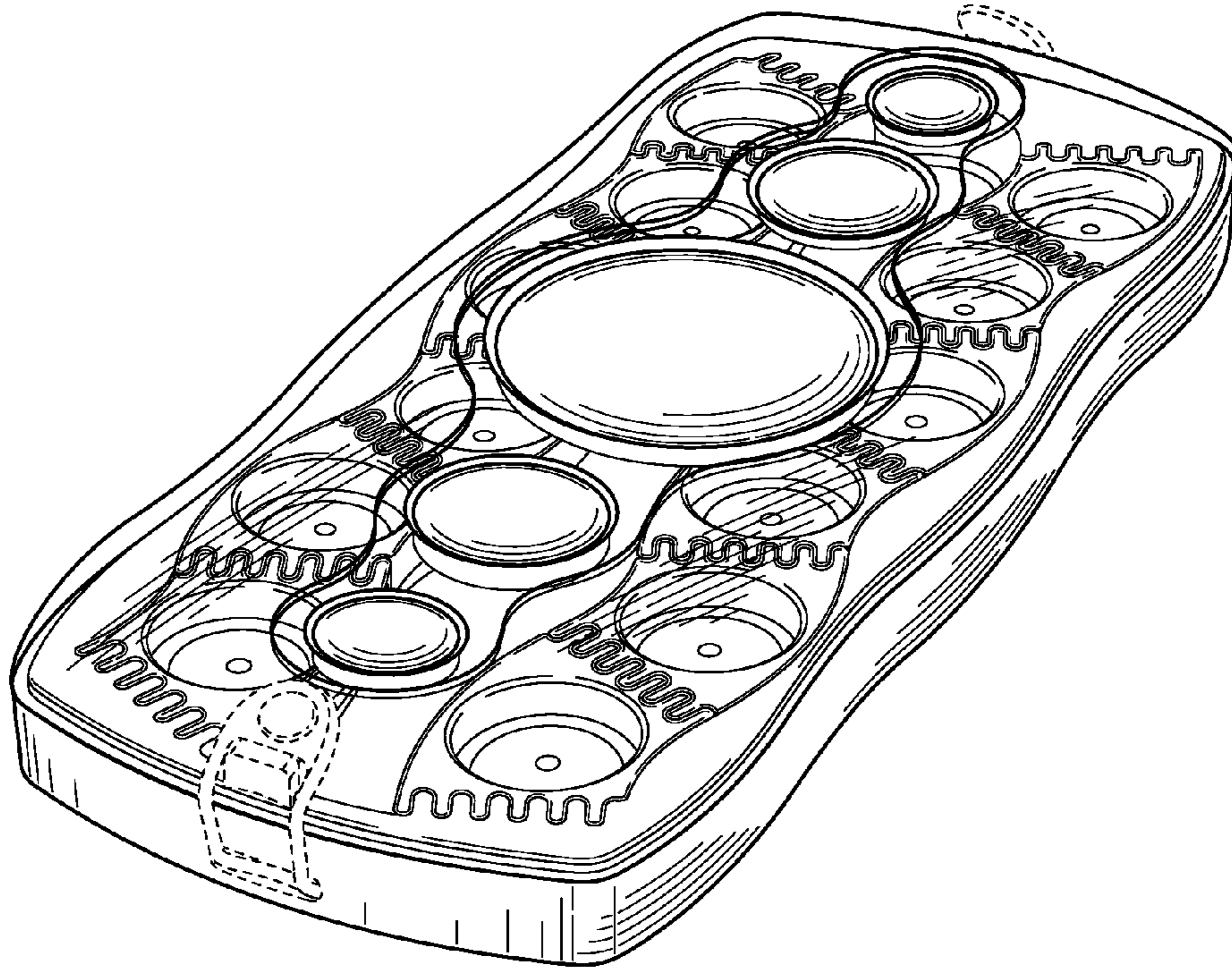

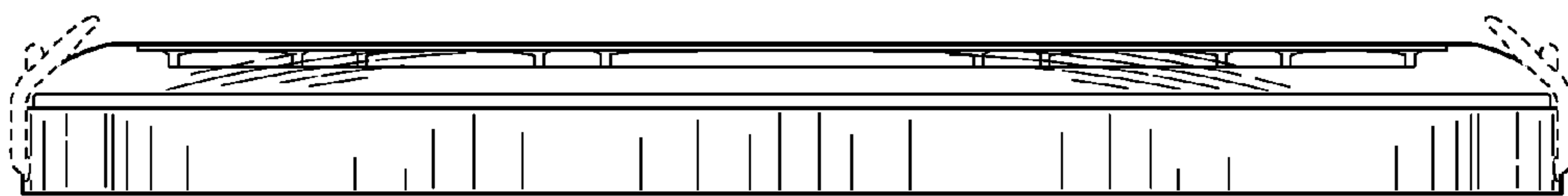

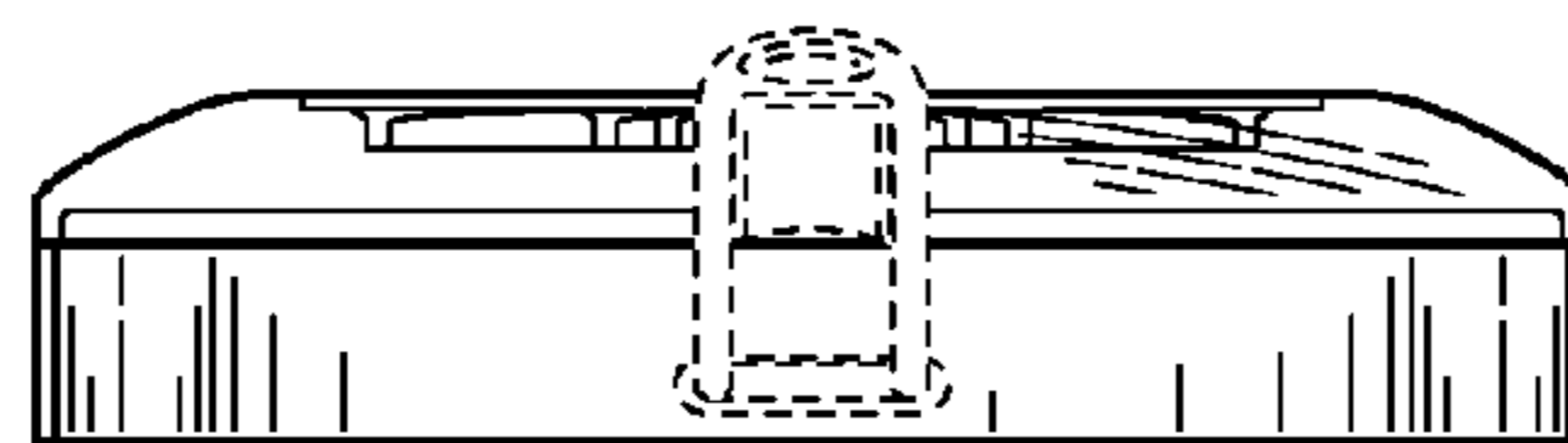

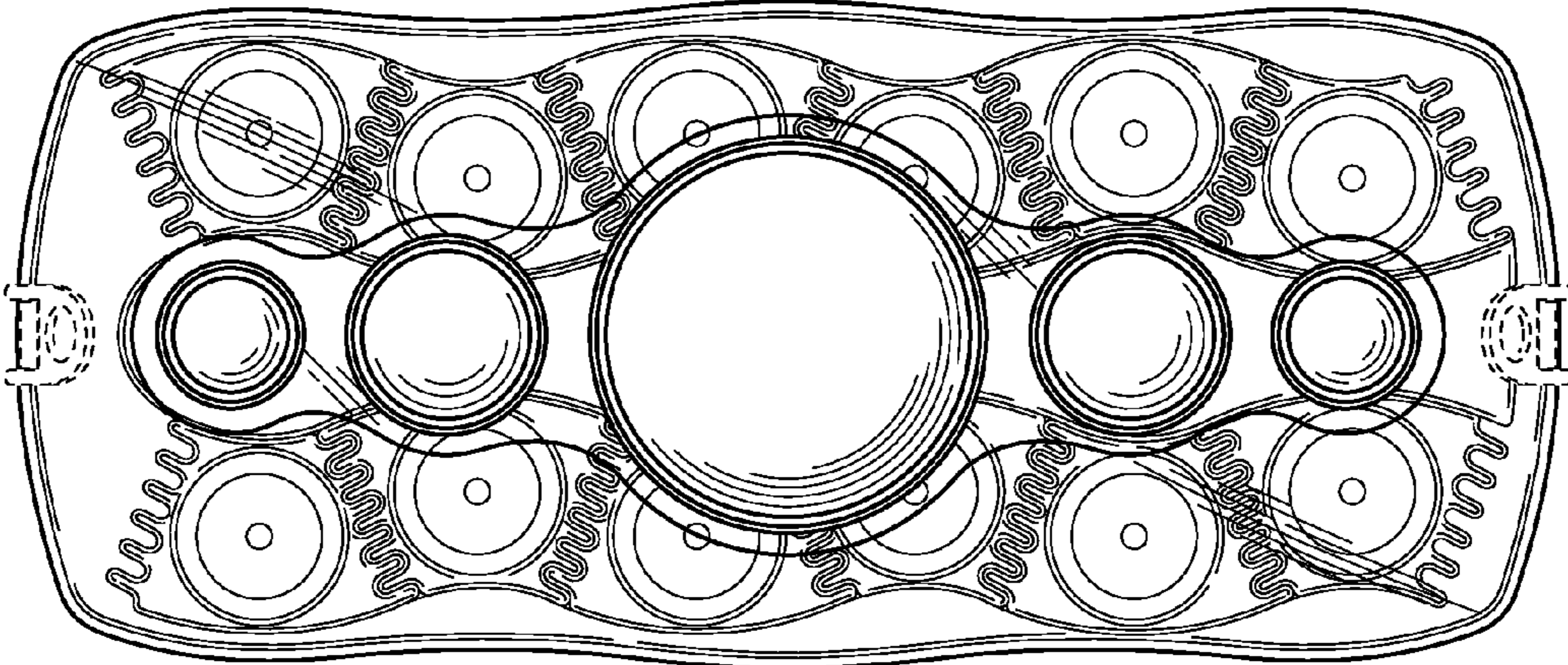

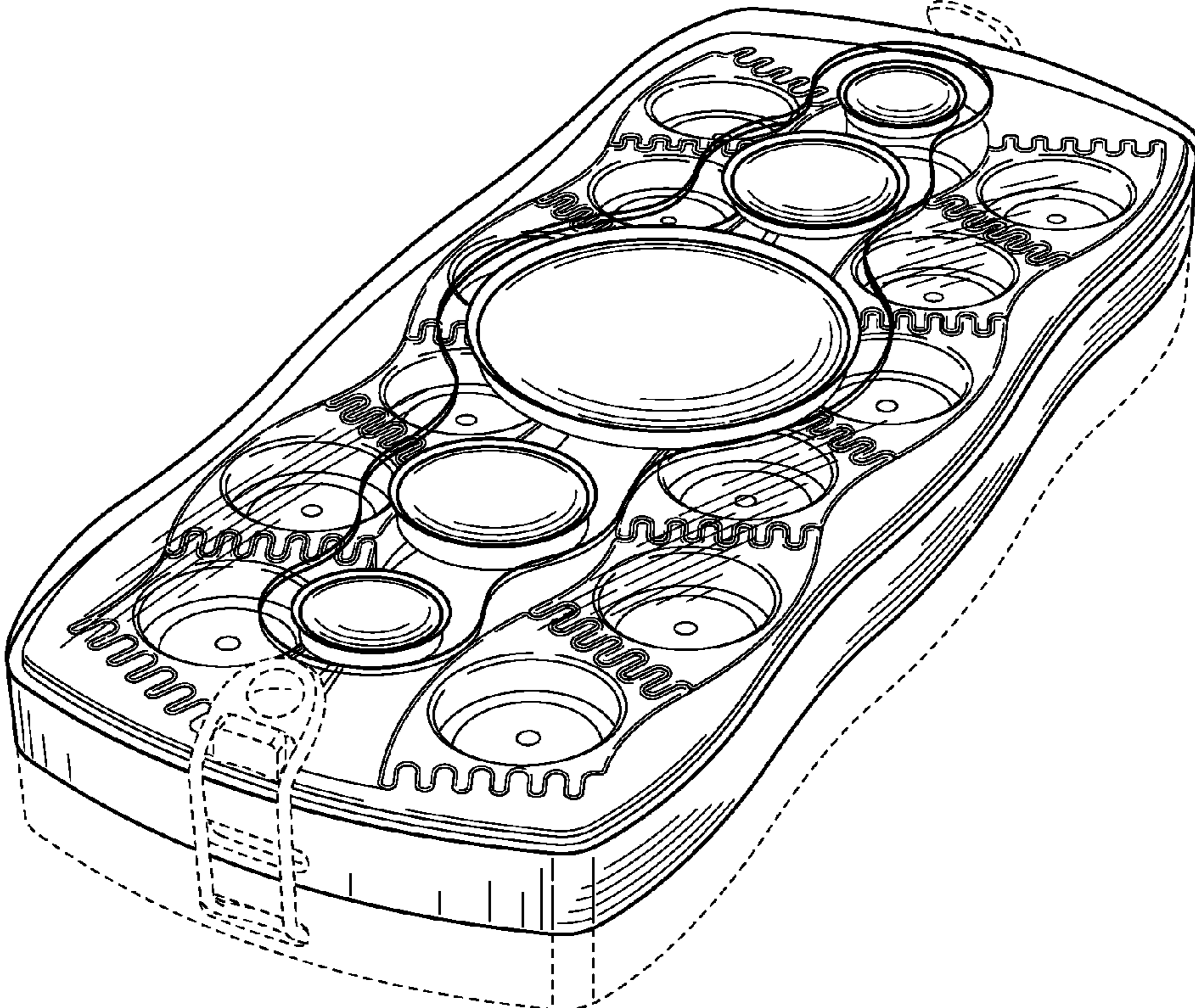

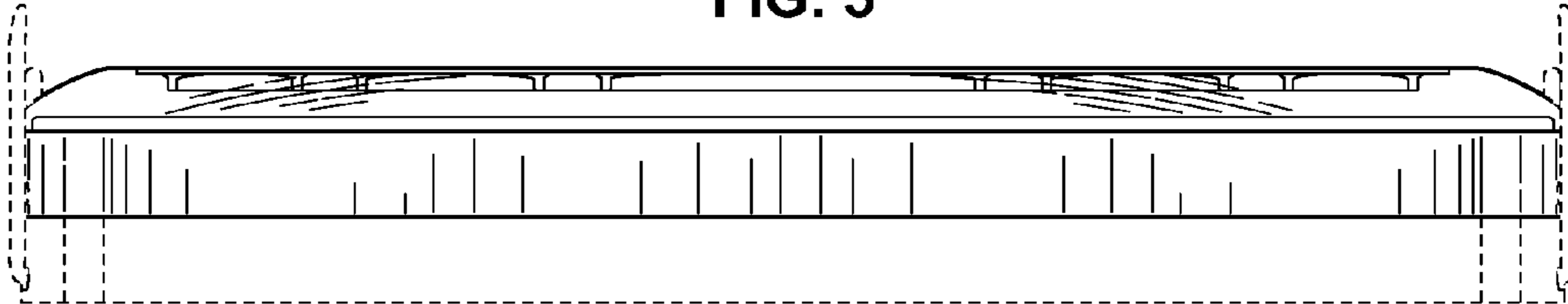

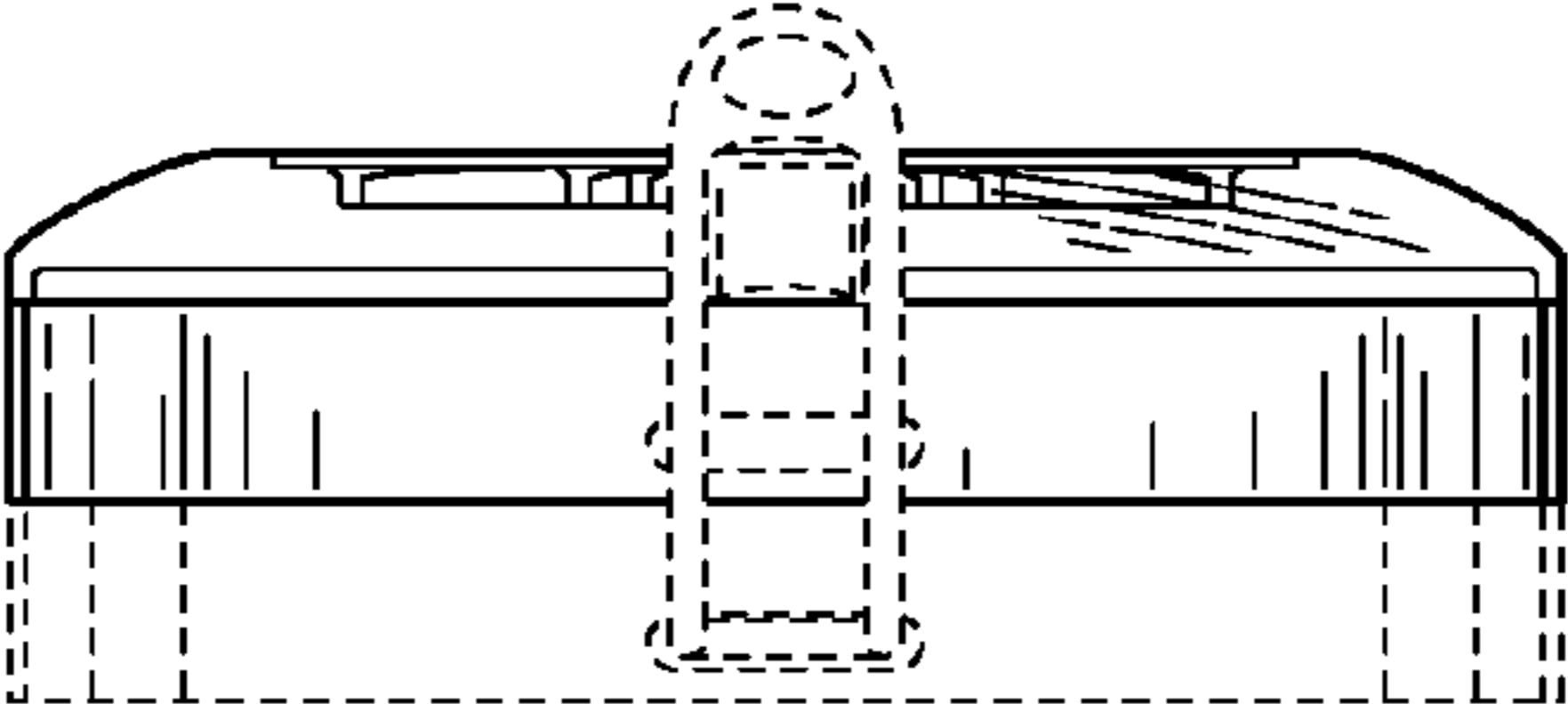

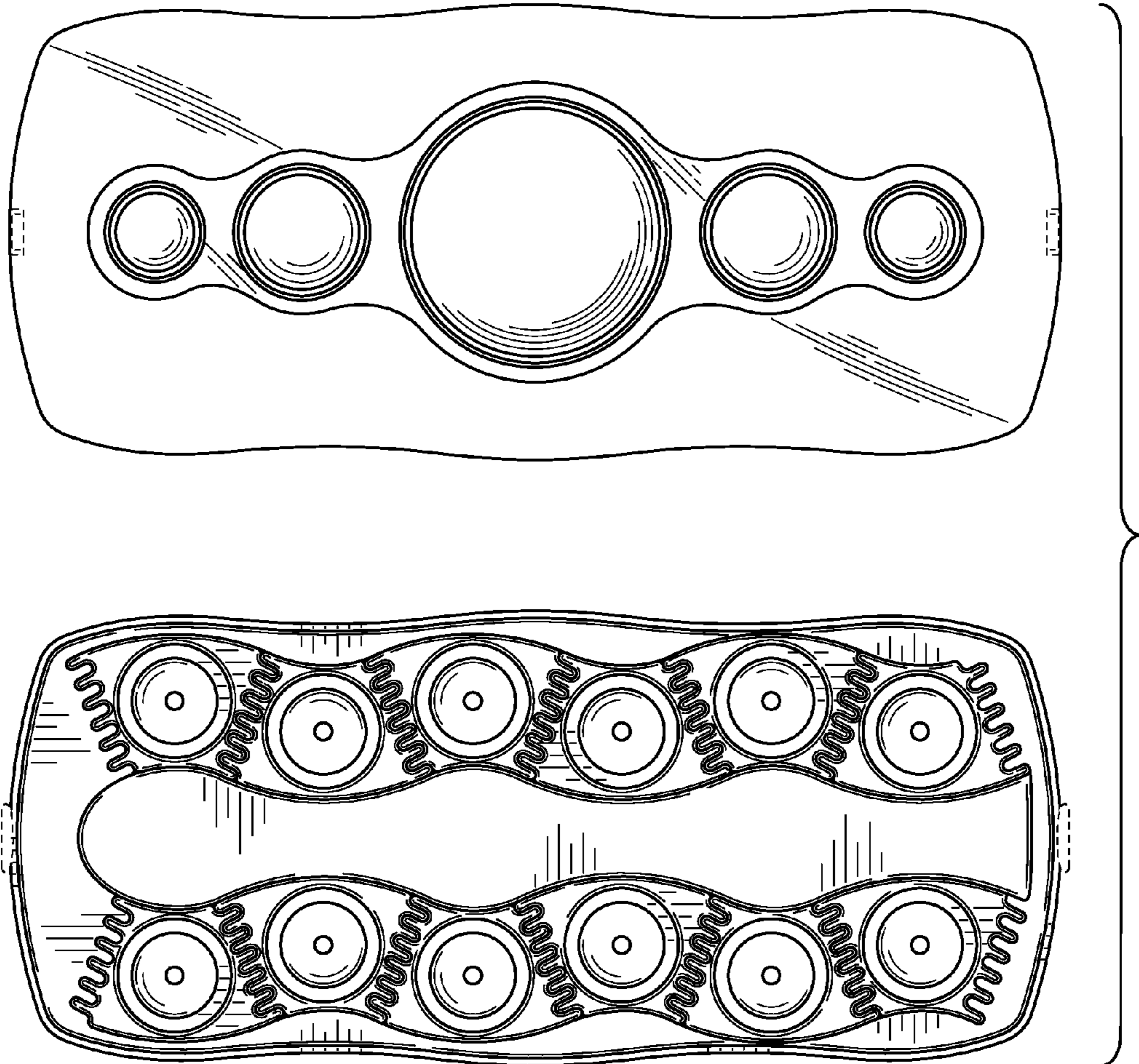

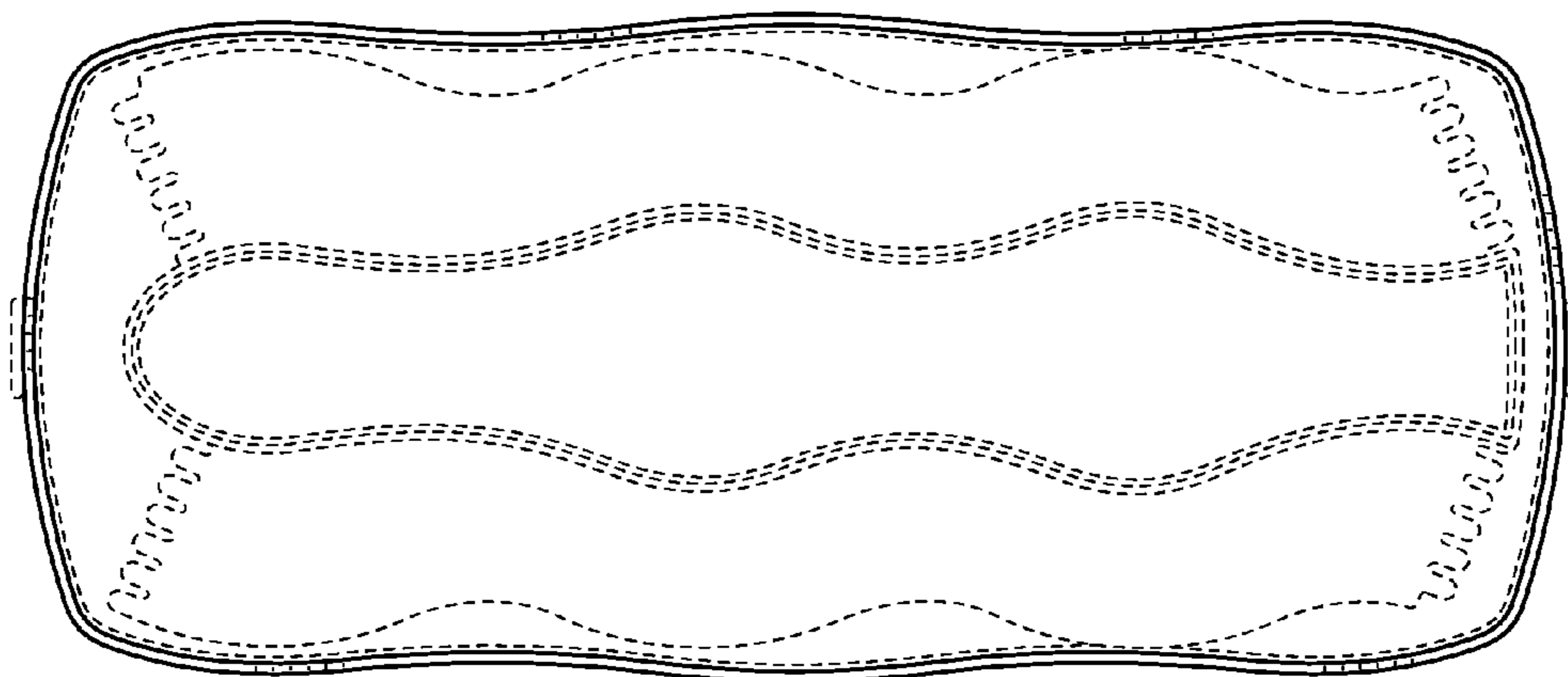
