FIG. 4 is a bottom view of FIG. 1;

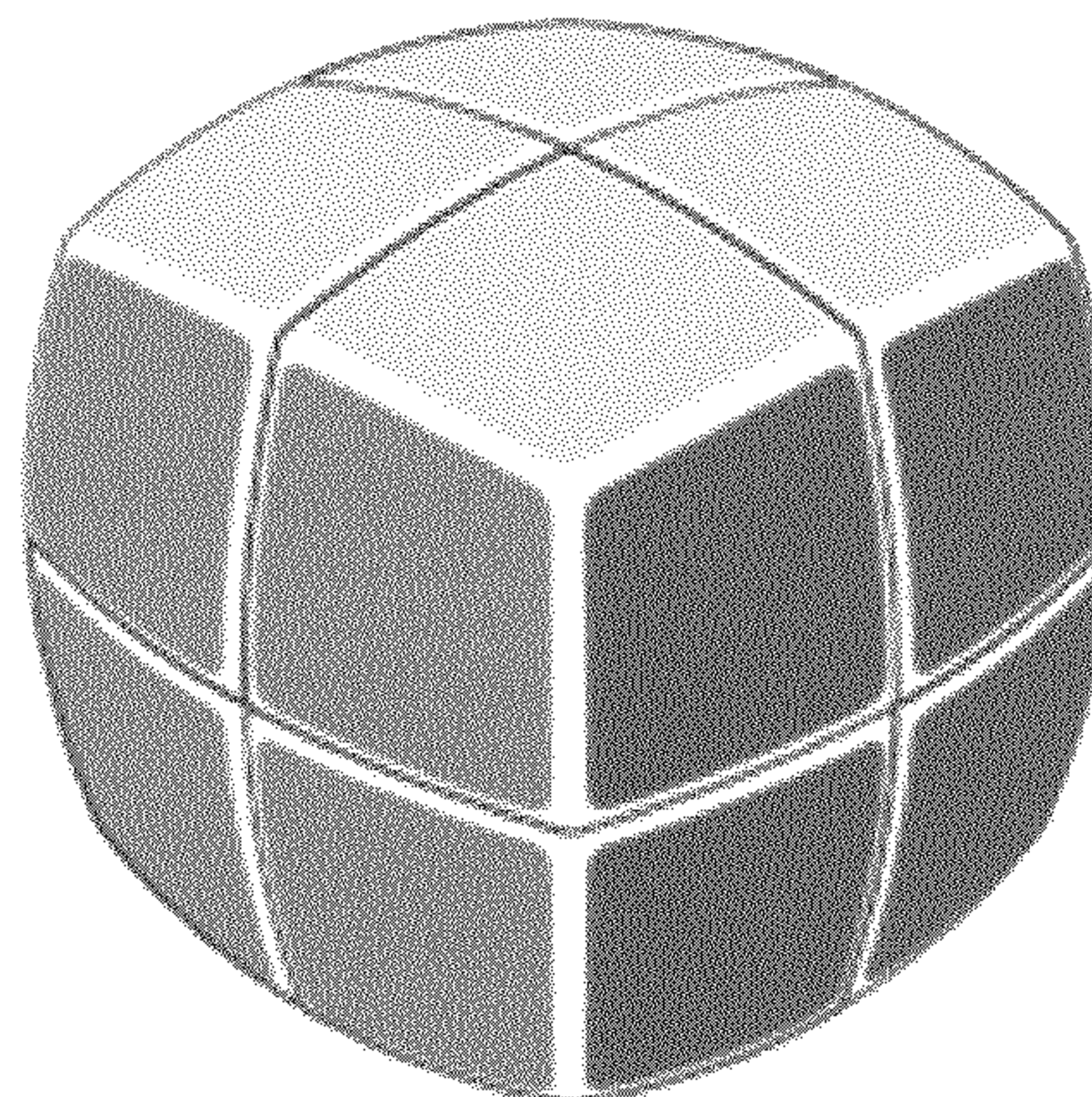
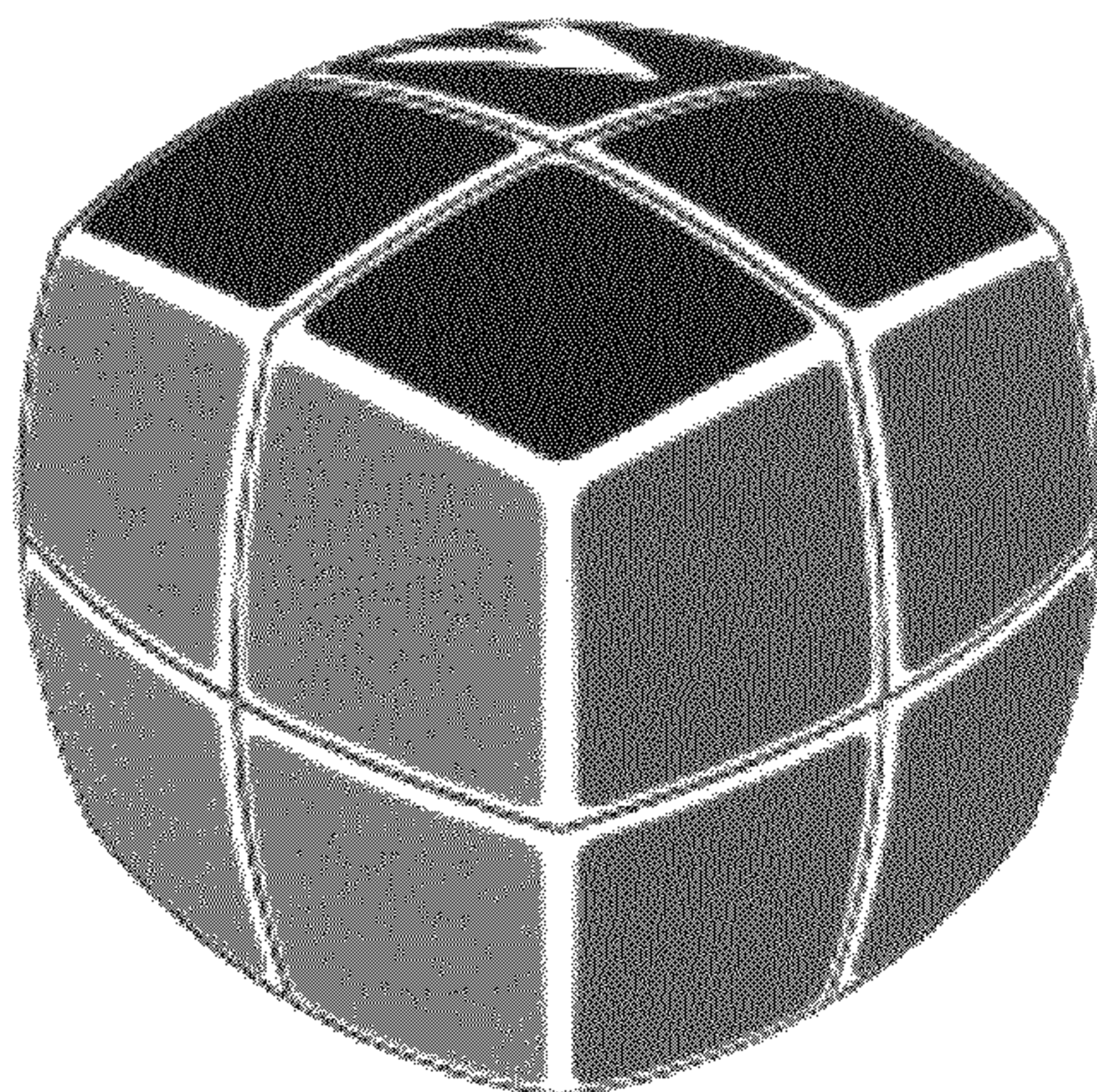
FIG. 5 is a left side view of FIG. 1;

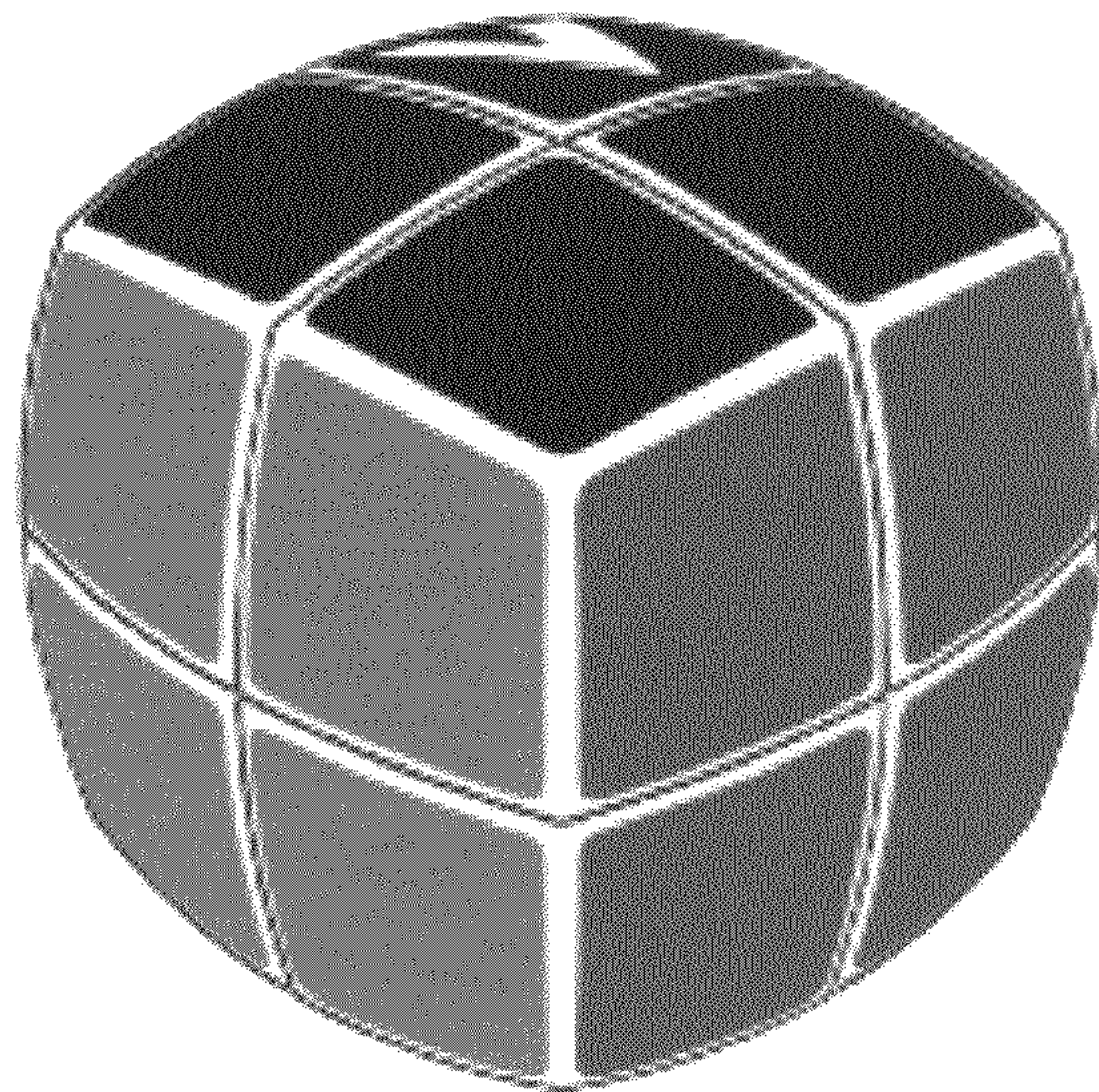

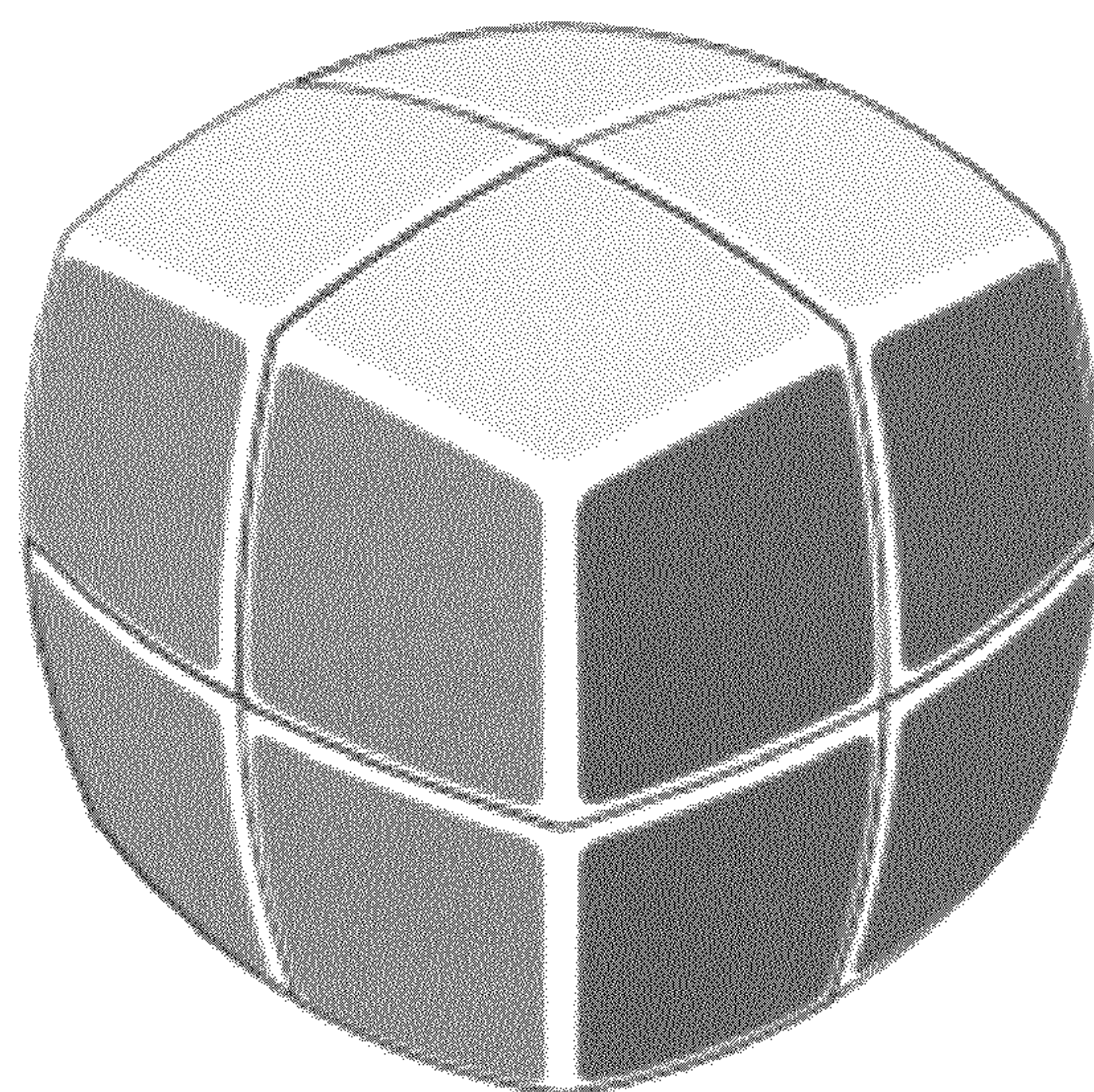

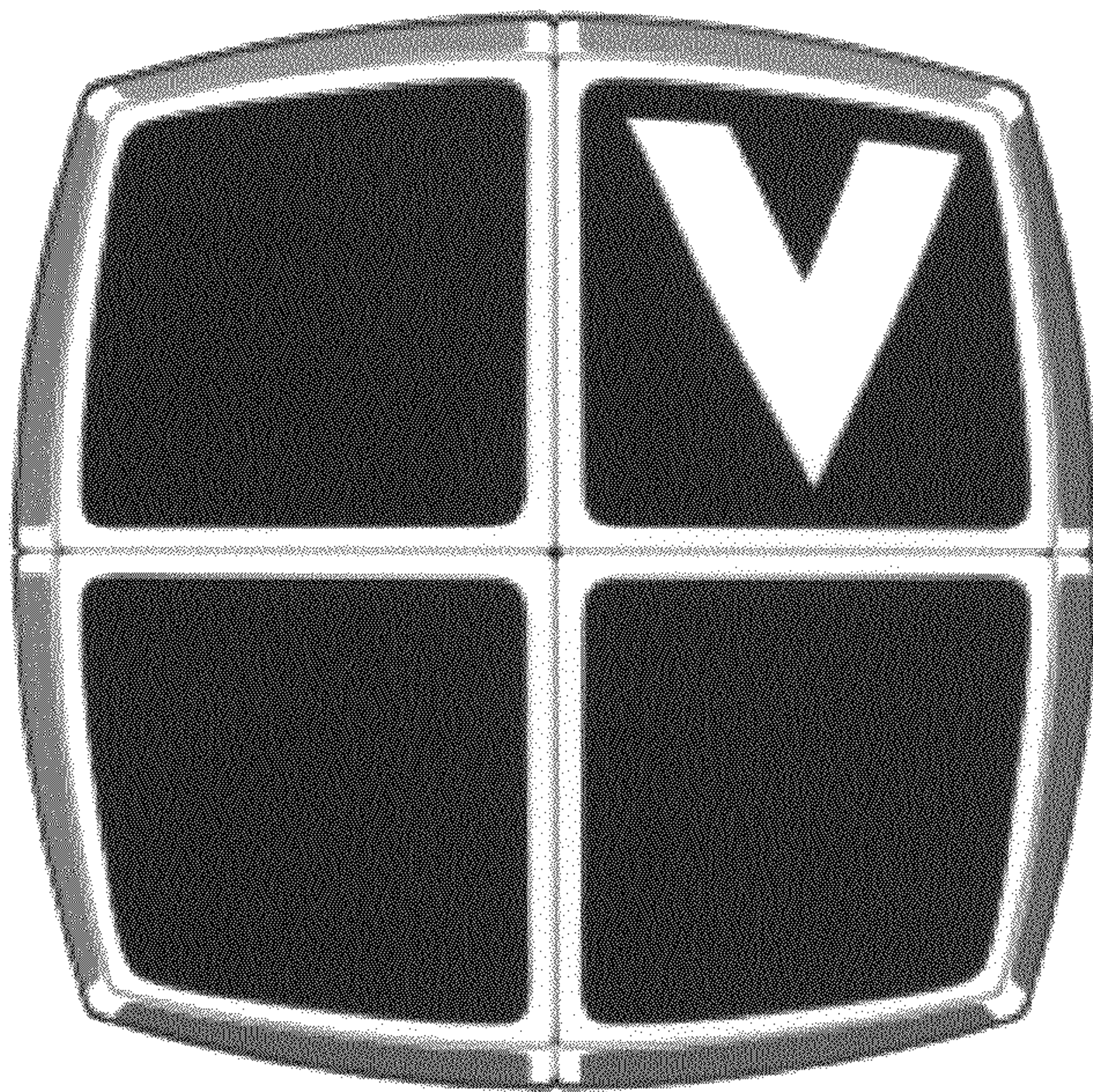

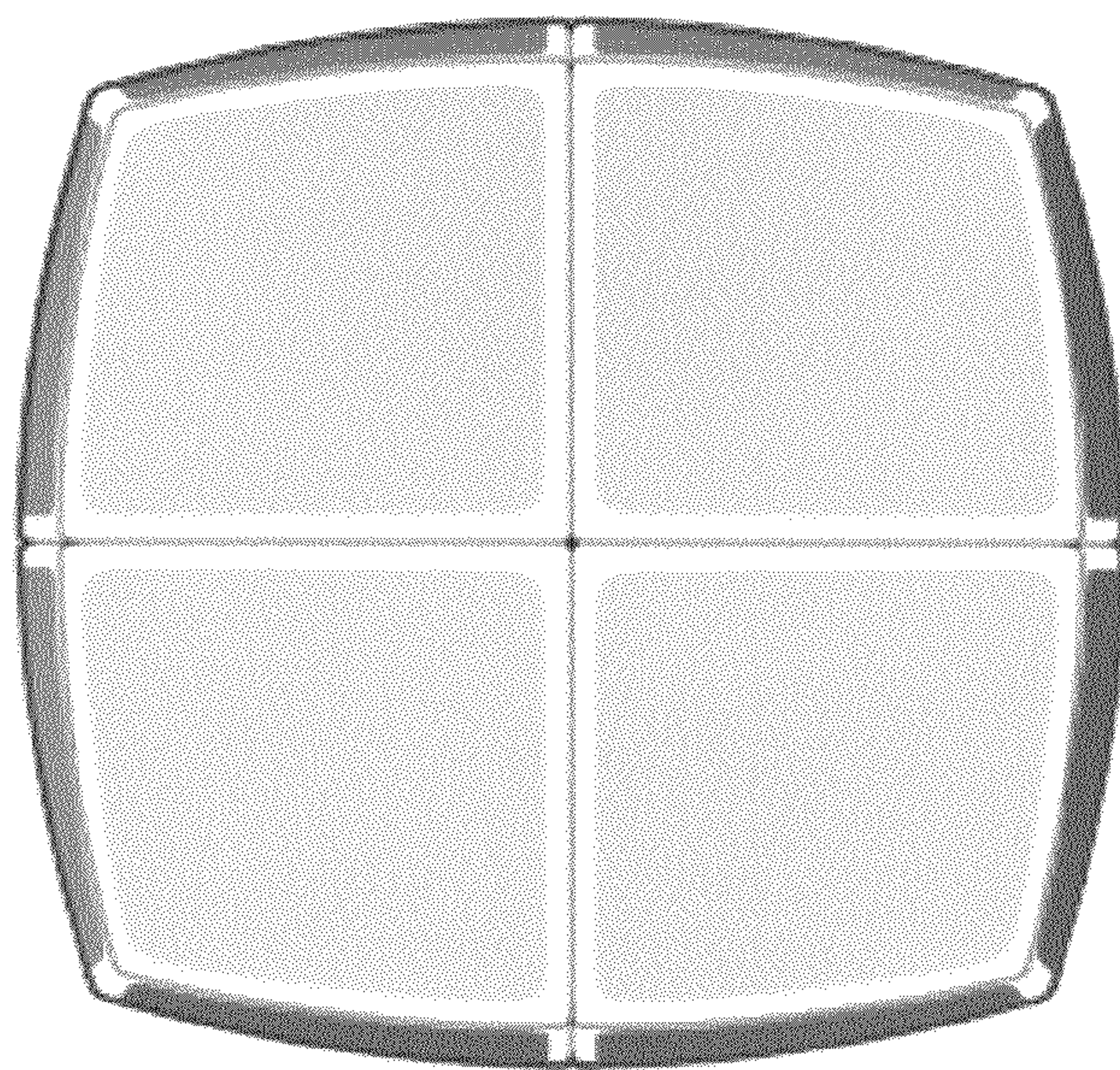

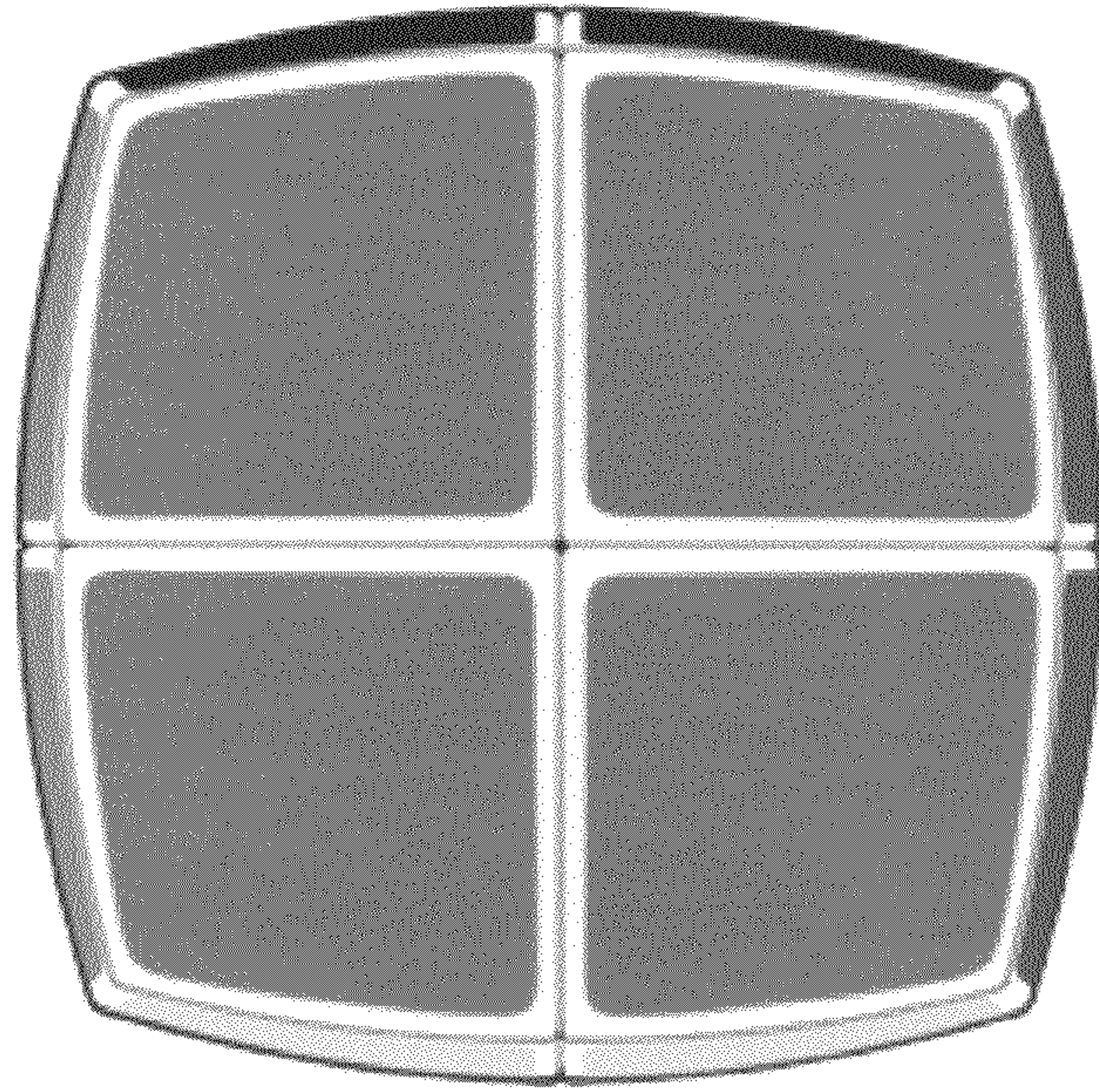

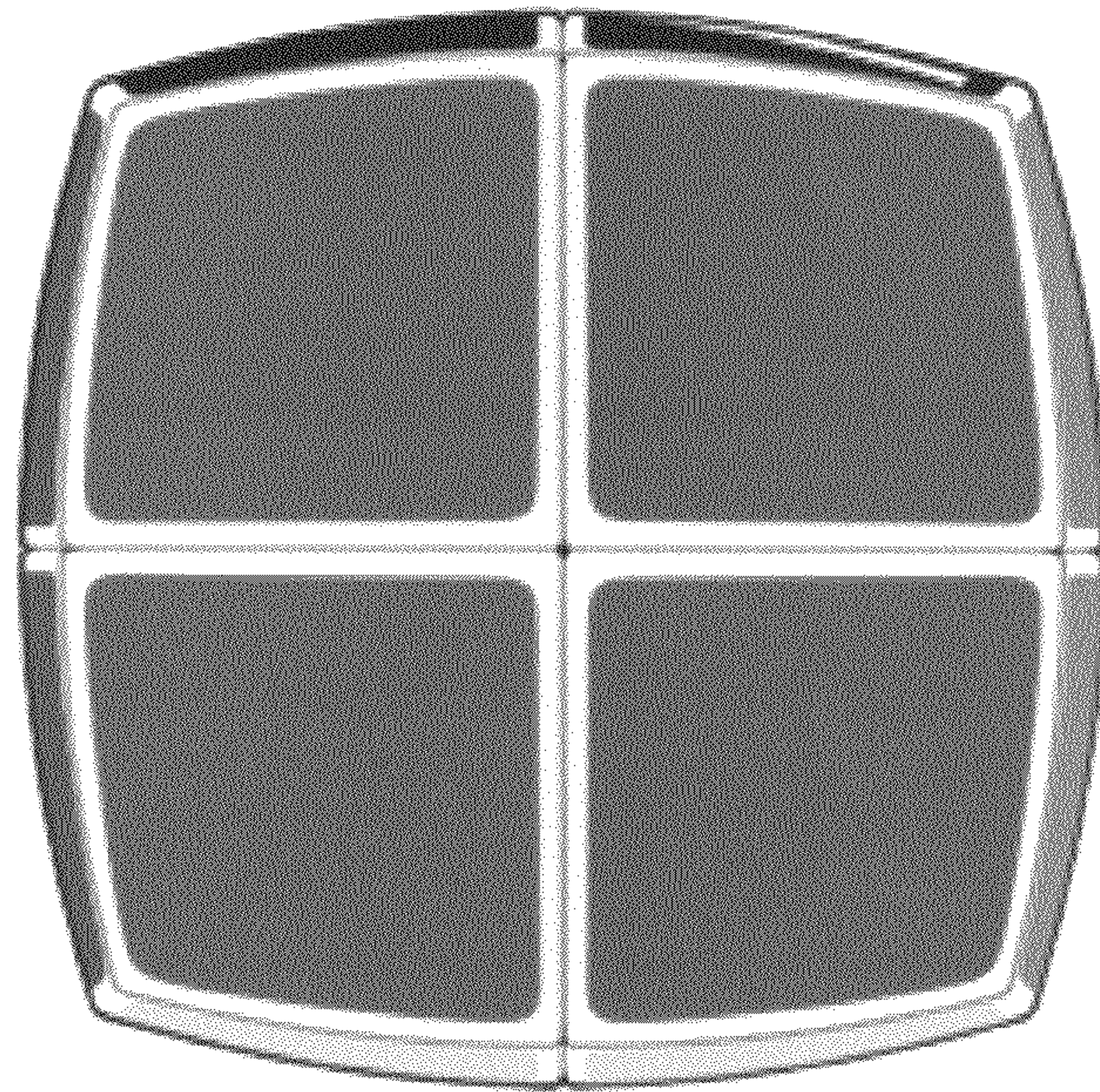

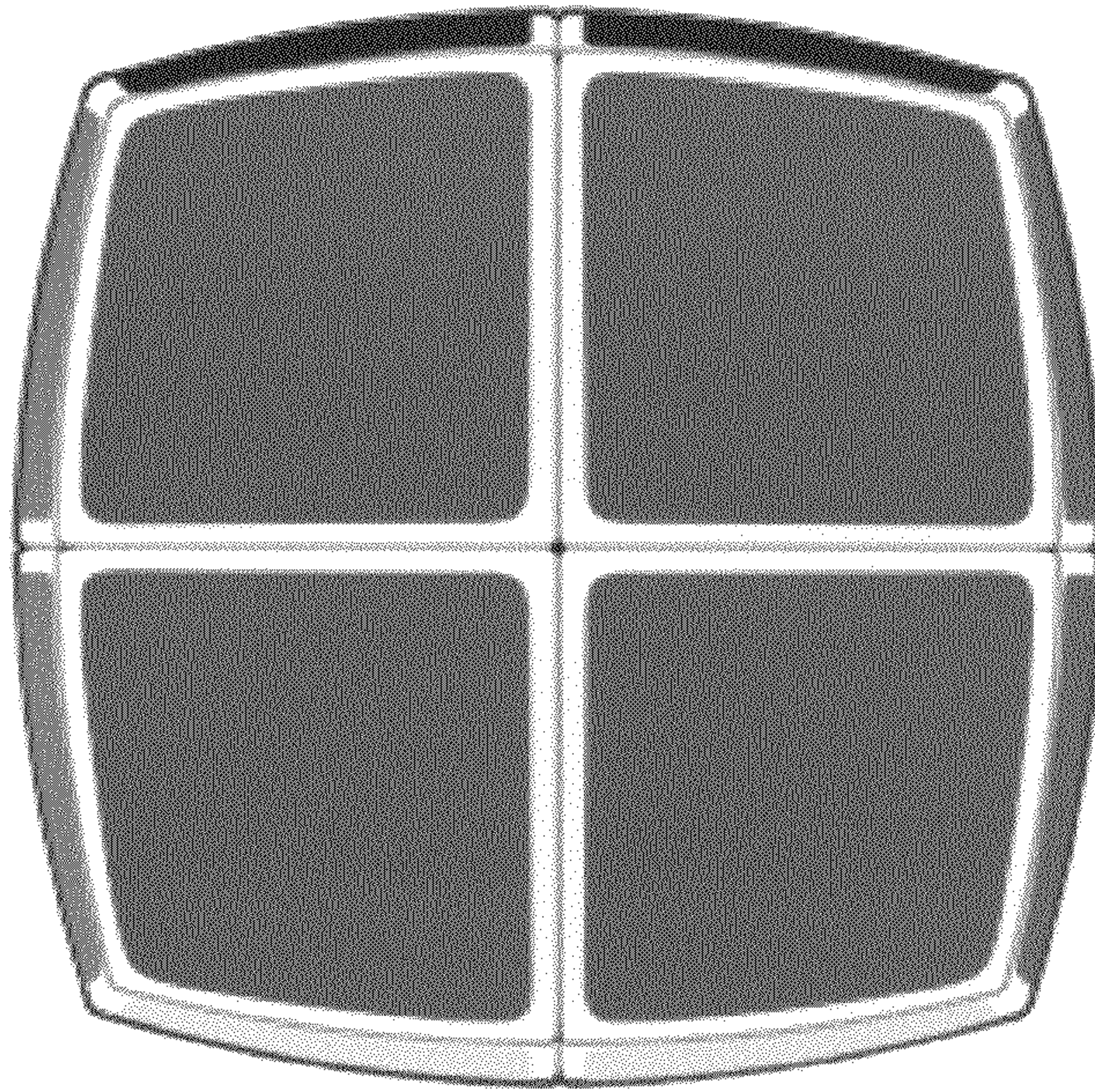

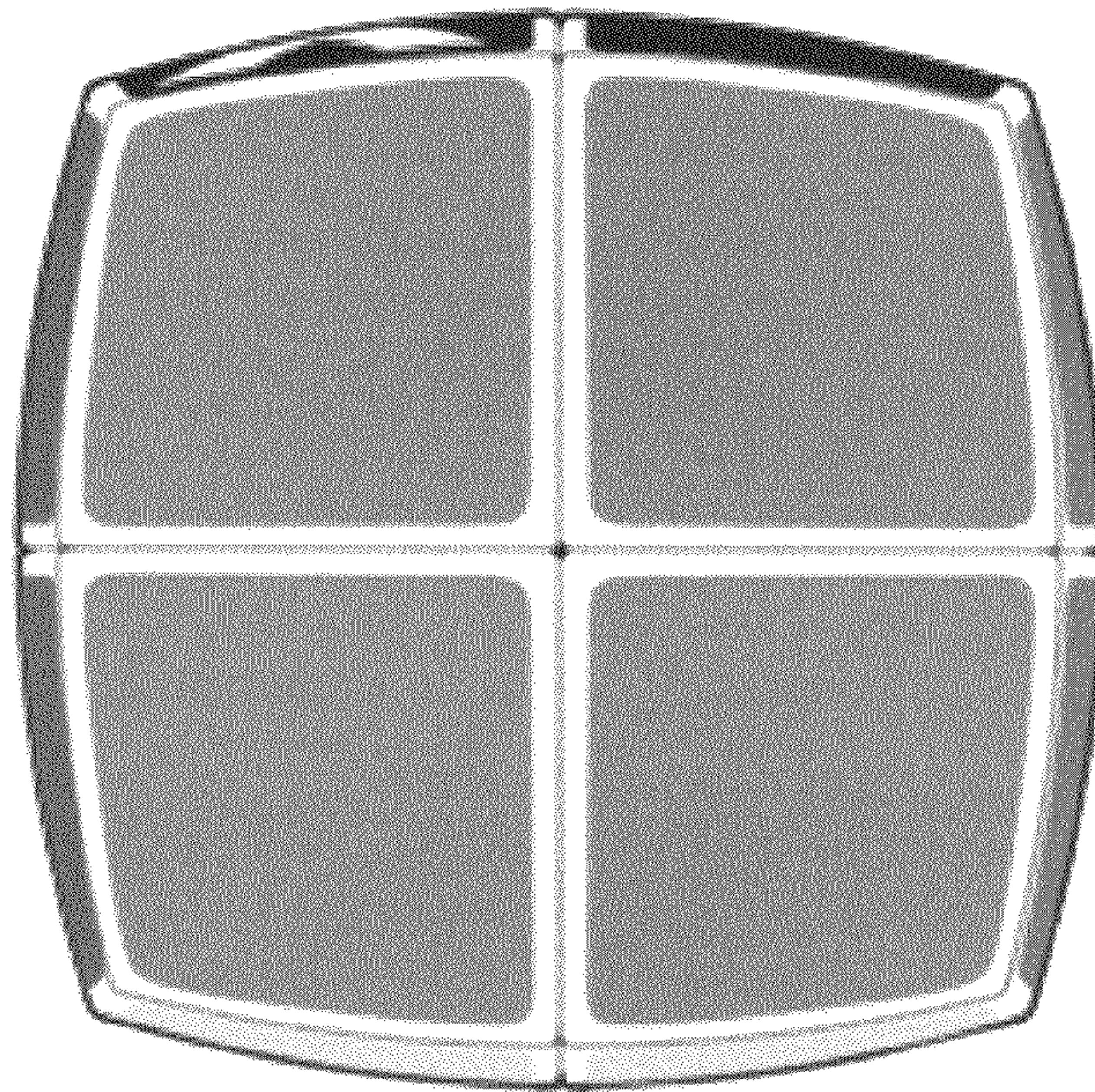
