FIG. 2 is a front view of the claimed design of FIG. 1;

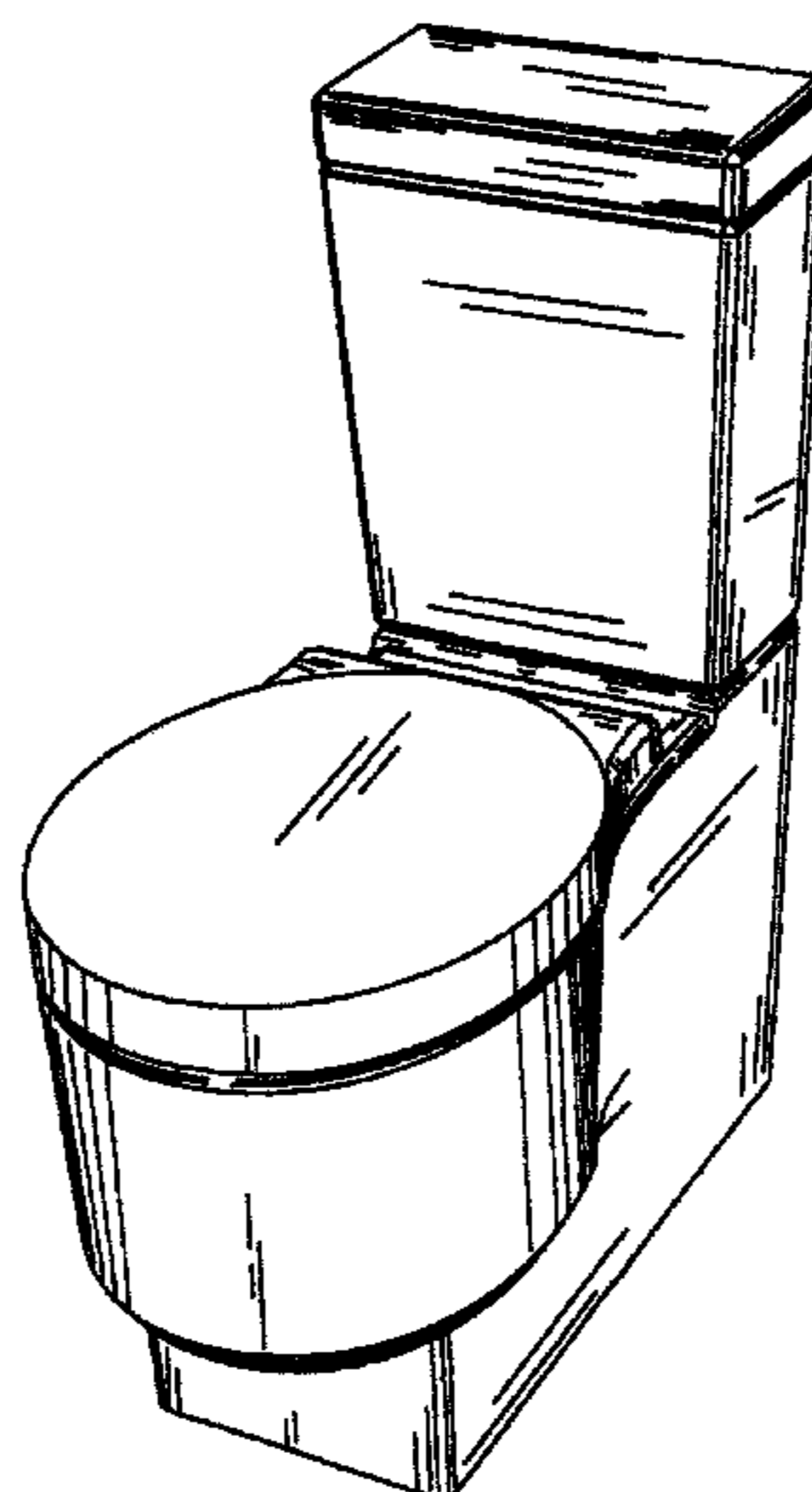
FIG. 3 is a top plan view of the claimed design of FIG. 1;

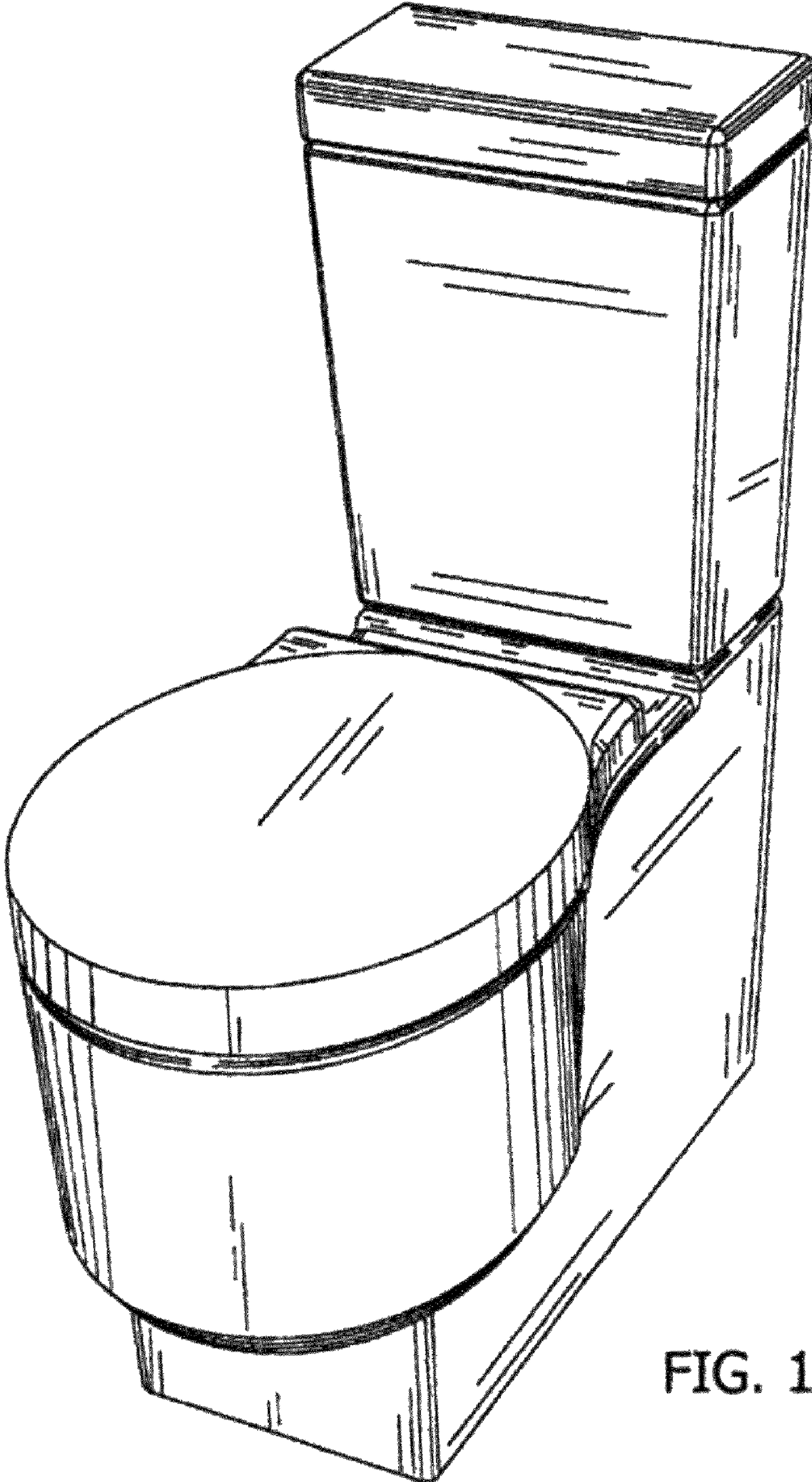

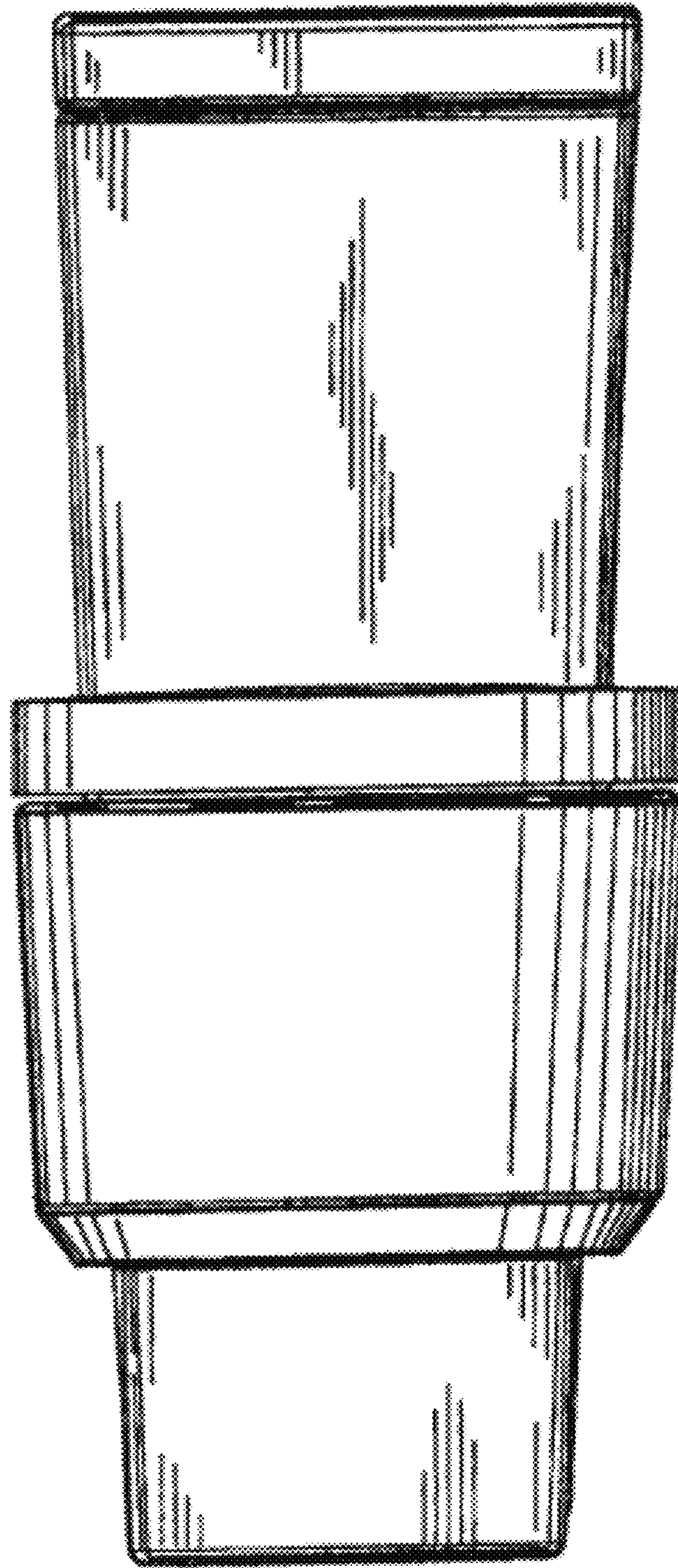

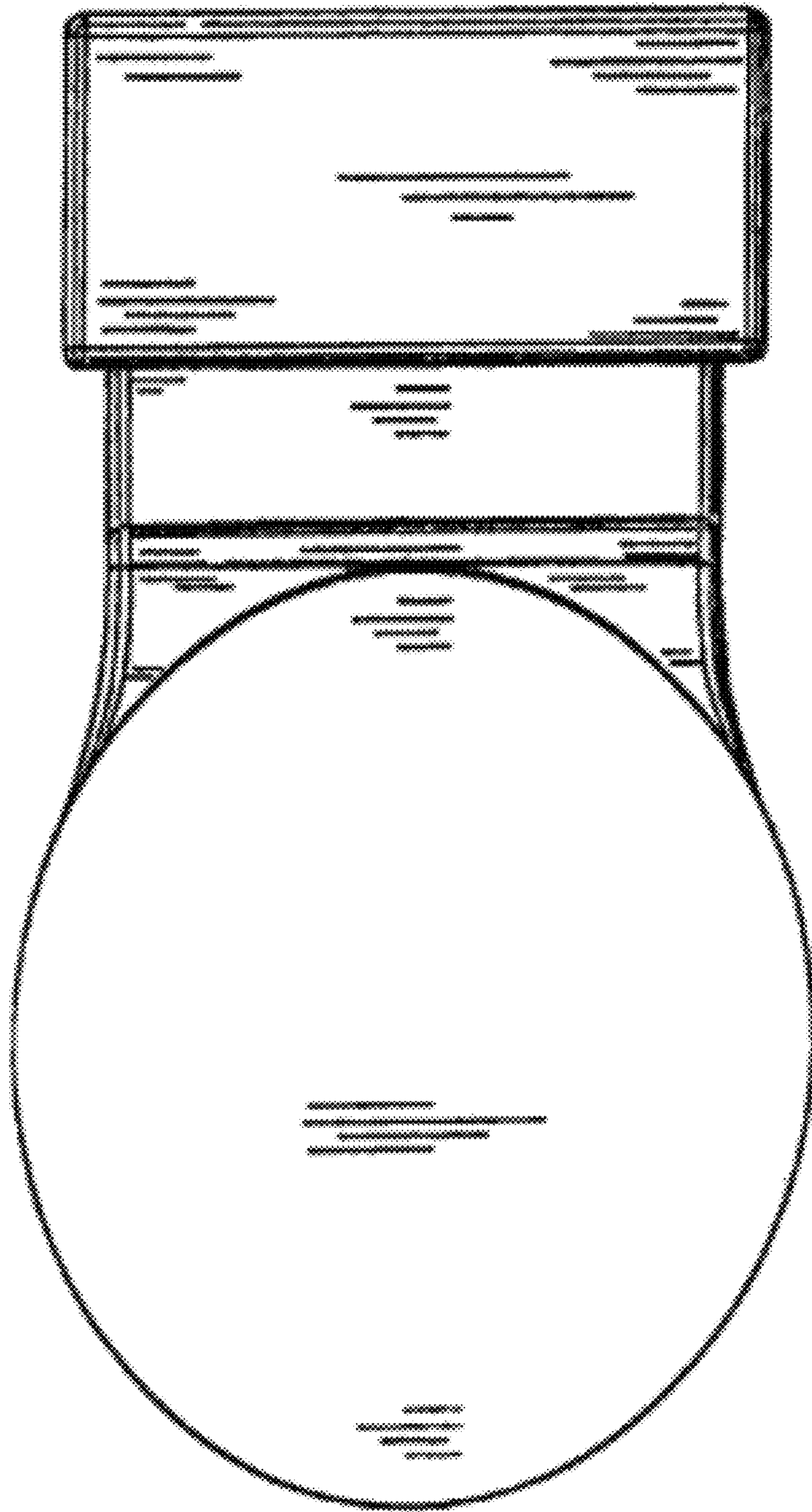

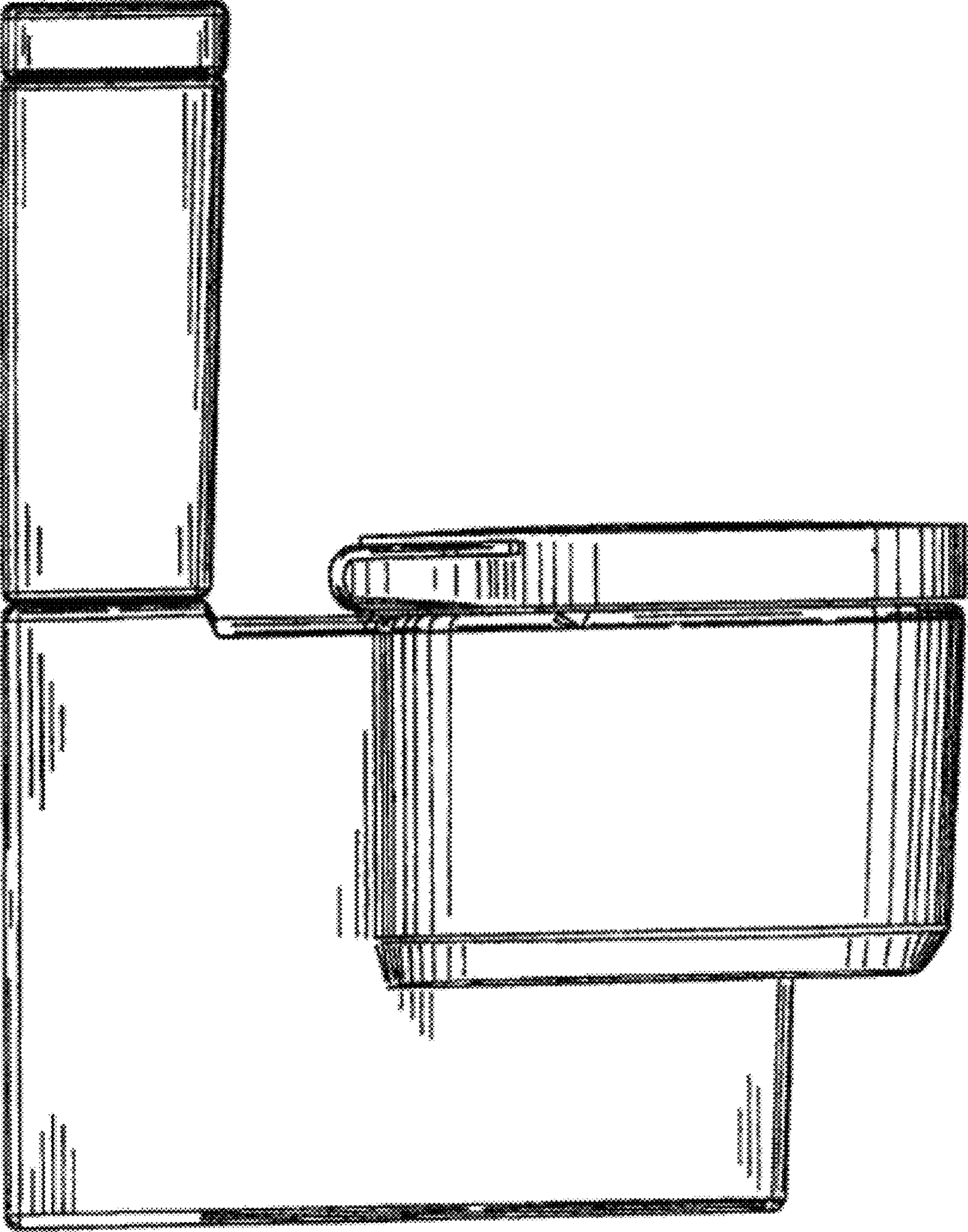

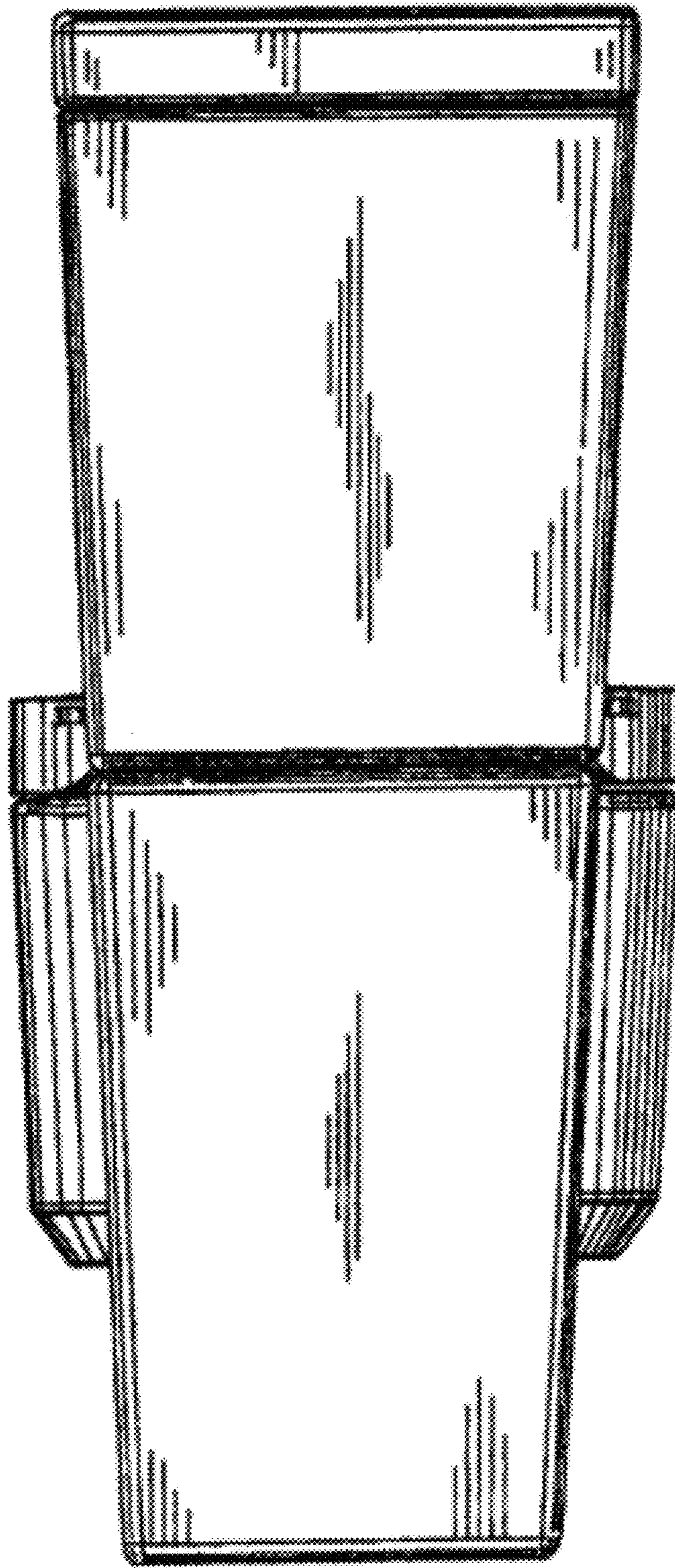
