**DESCRIPTION**

FIG. 16 is left front perspective view of FIG. 15;

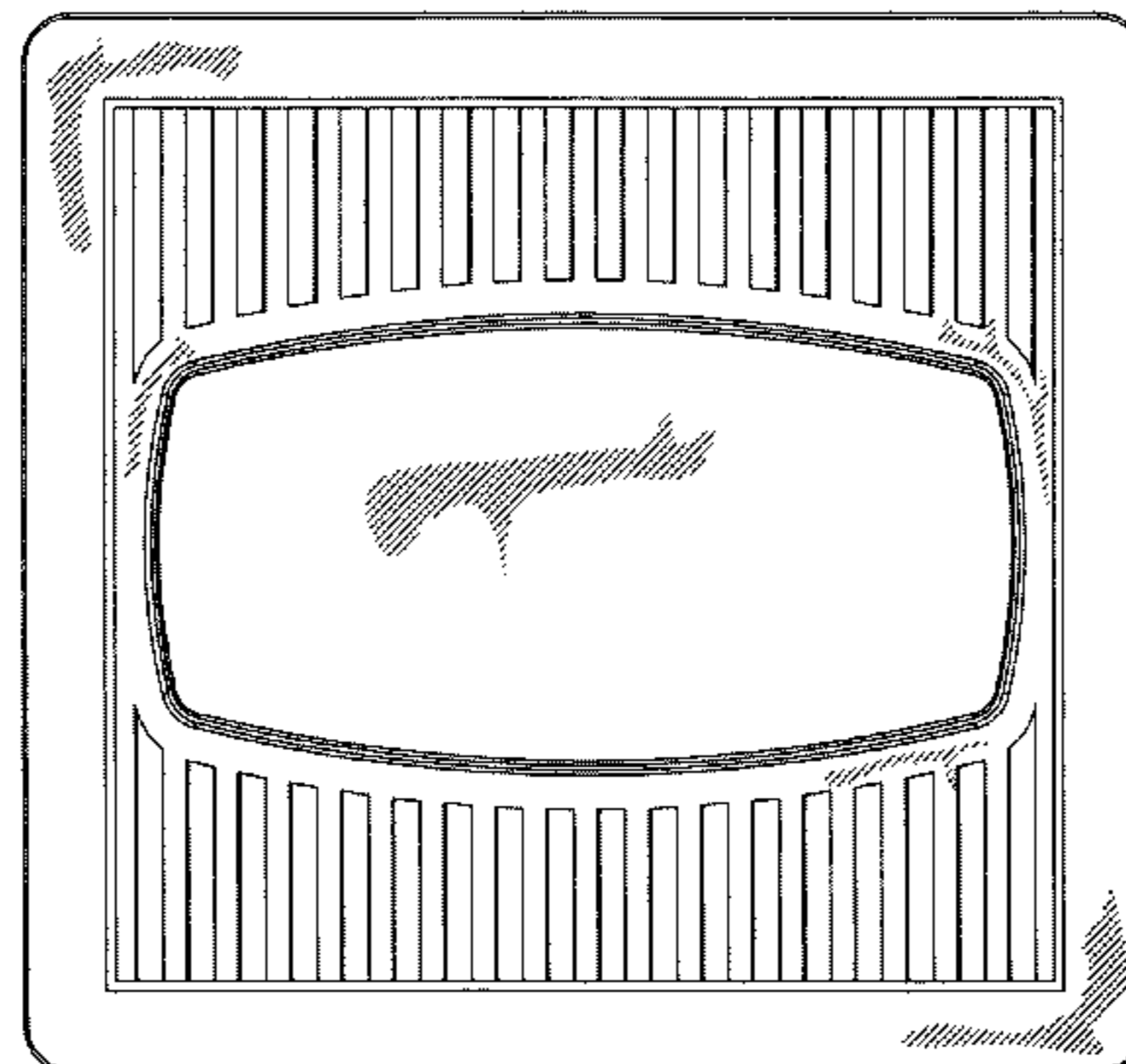
FIG. 17 is a right front perspective view of FIG. 15;

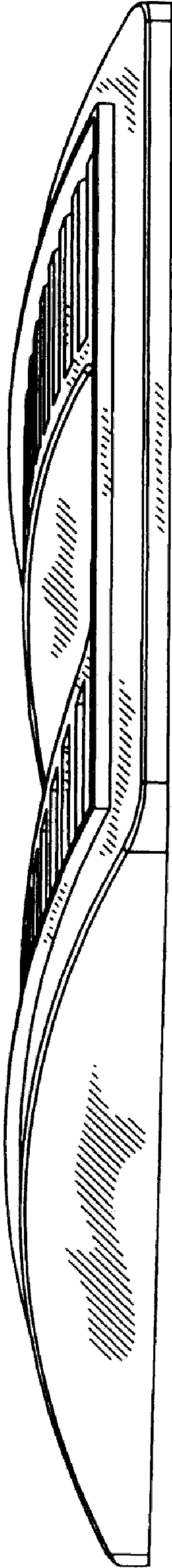

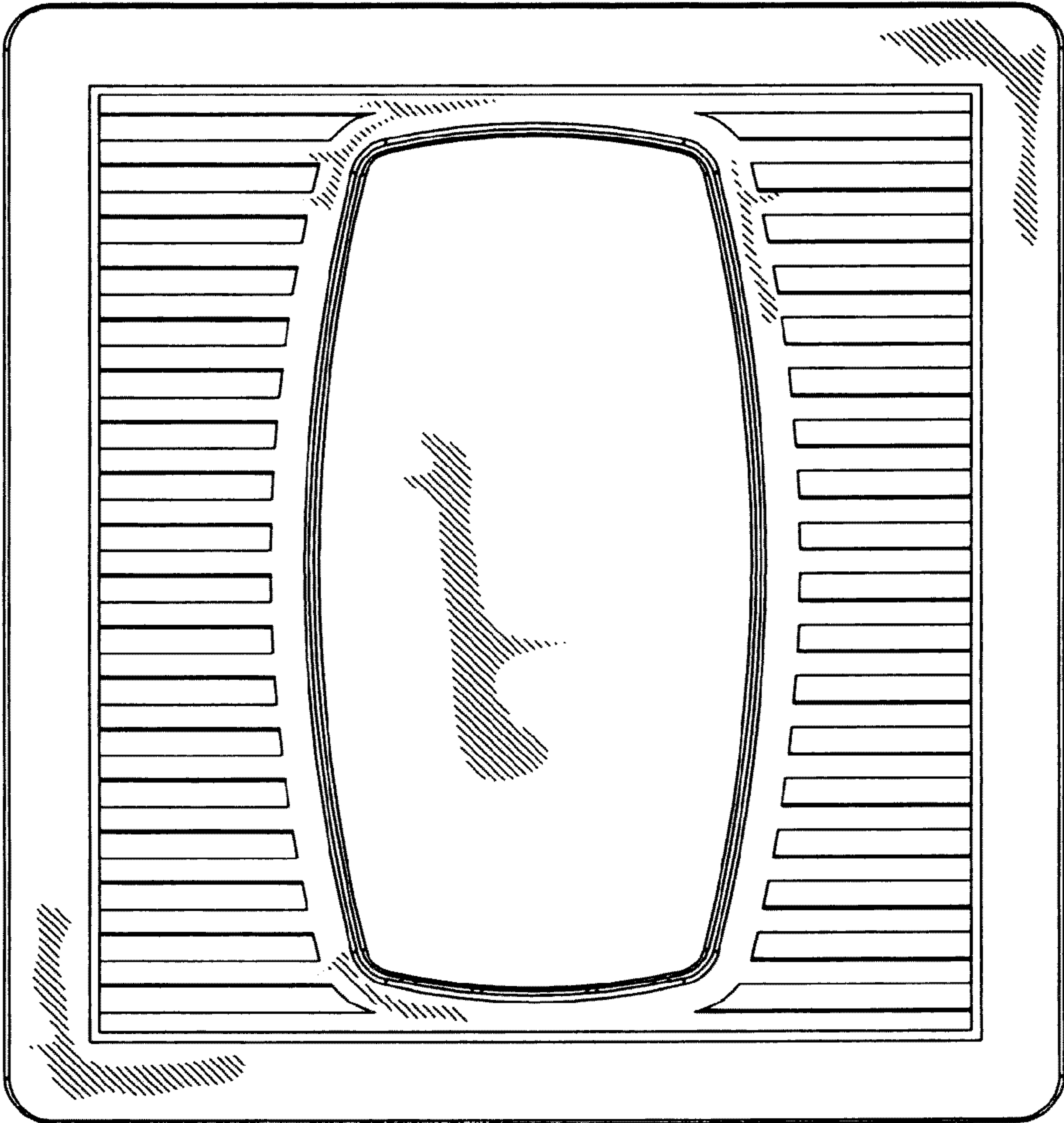

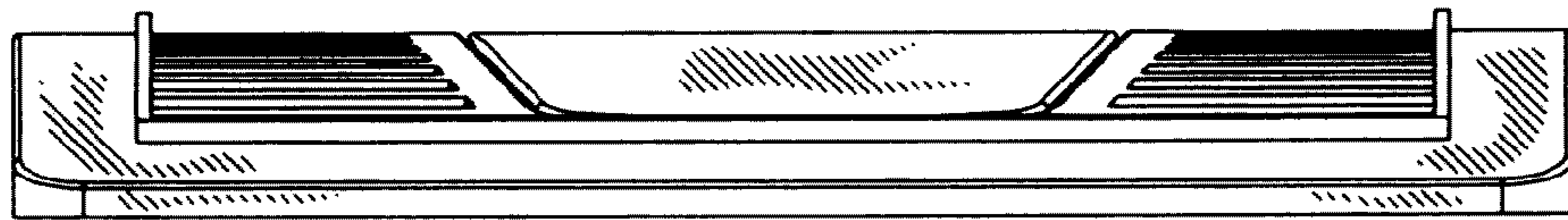

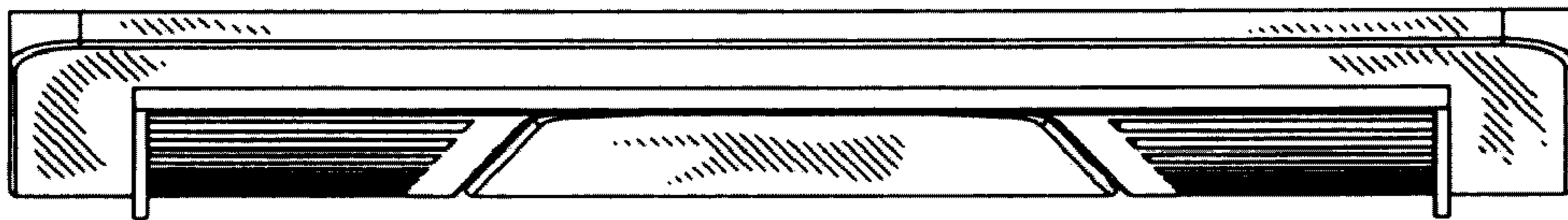

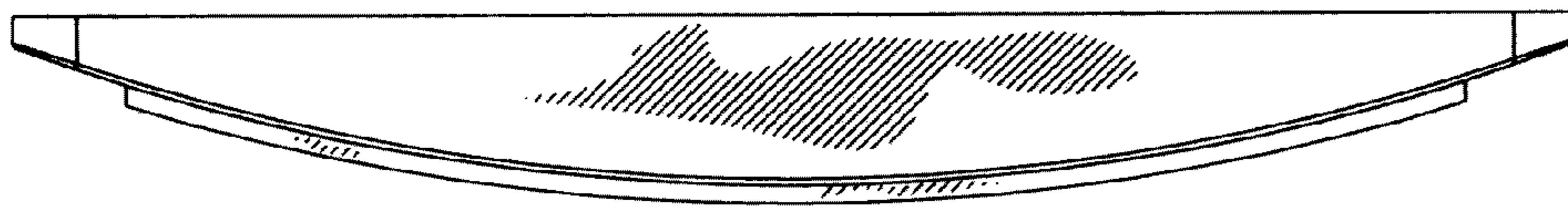

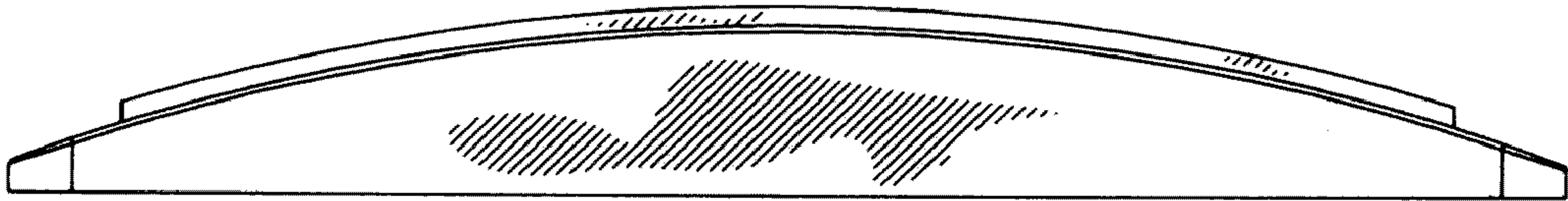

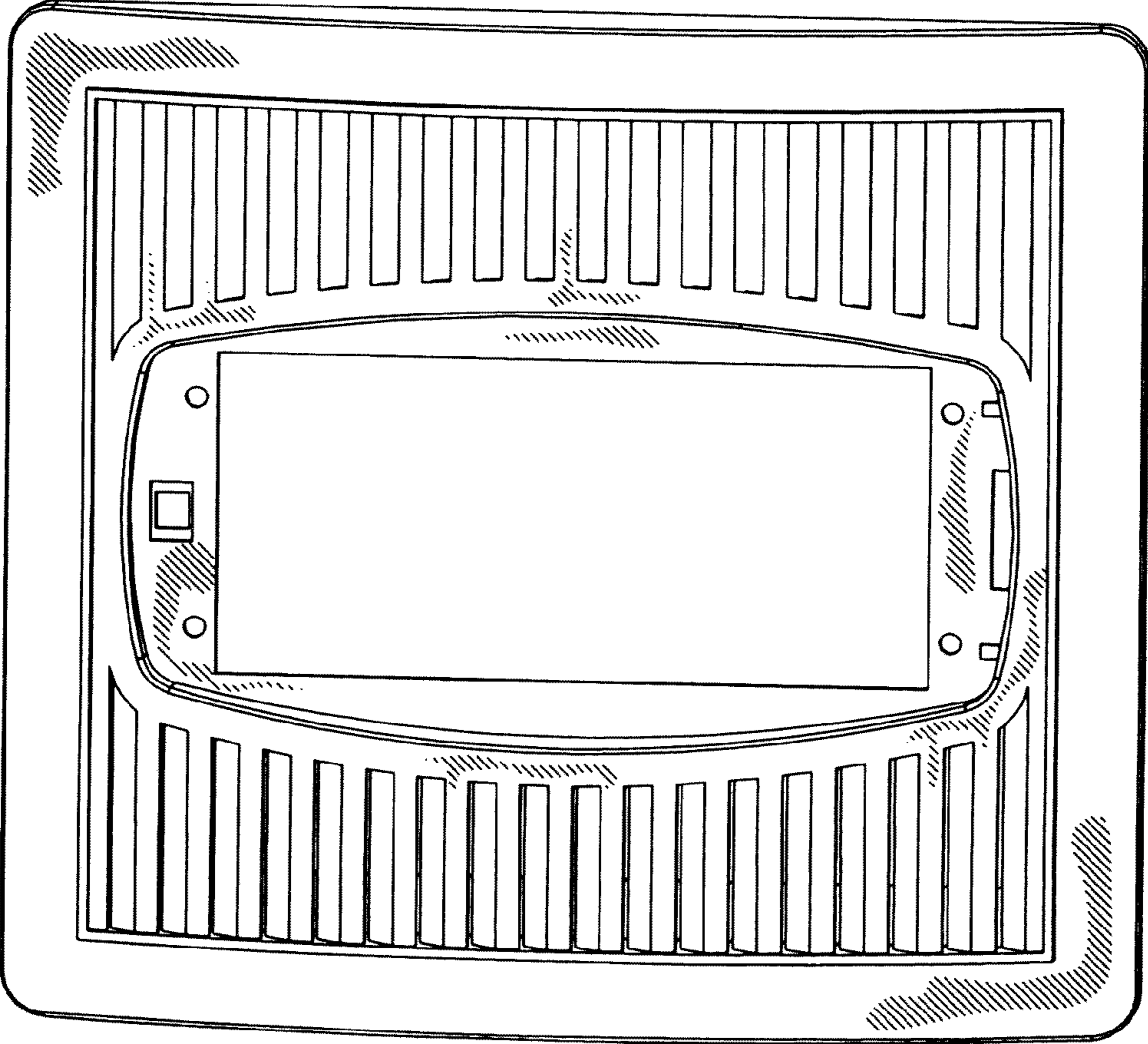

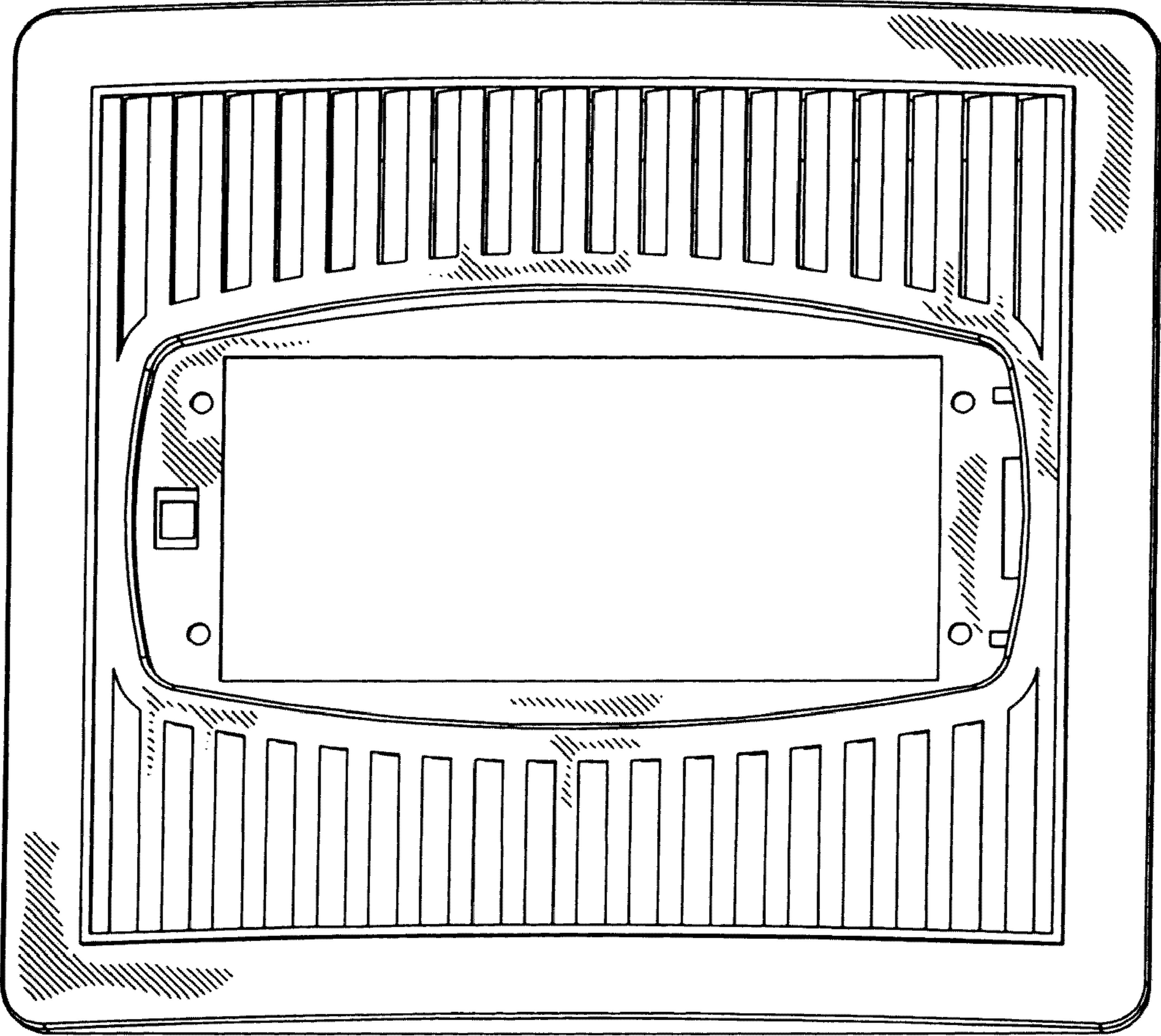

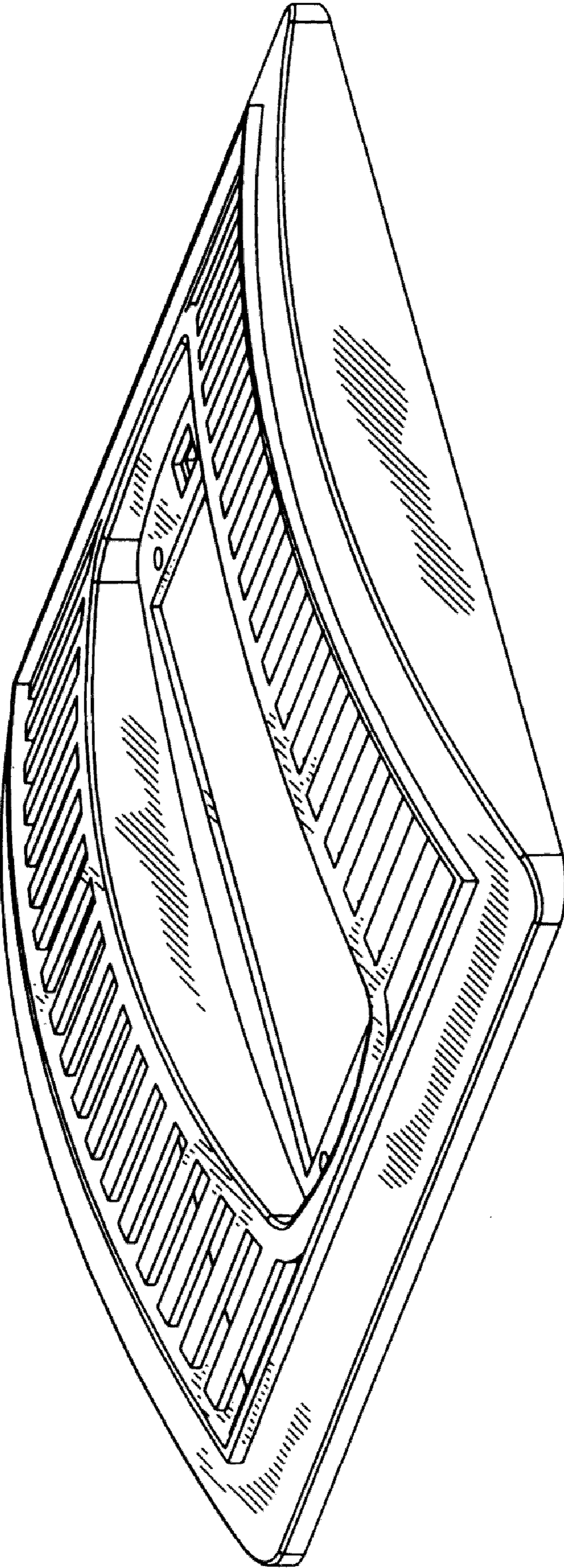

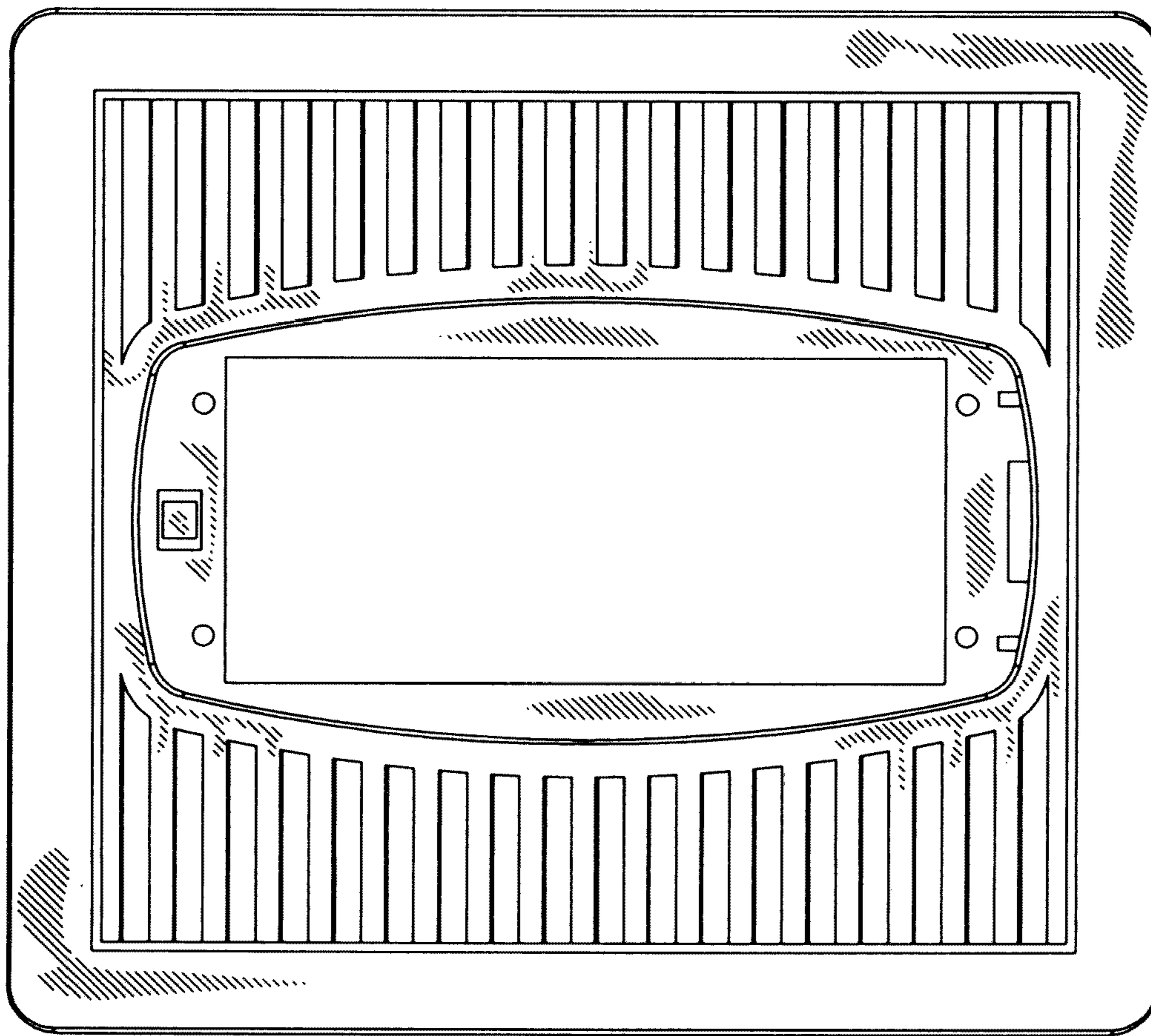

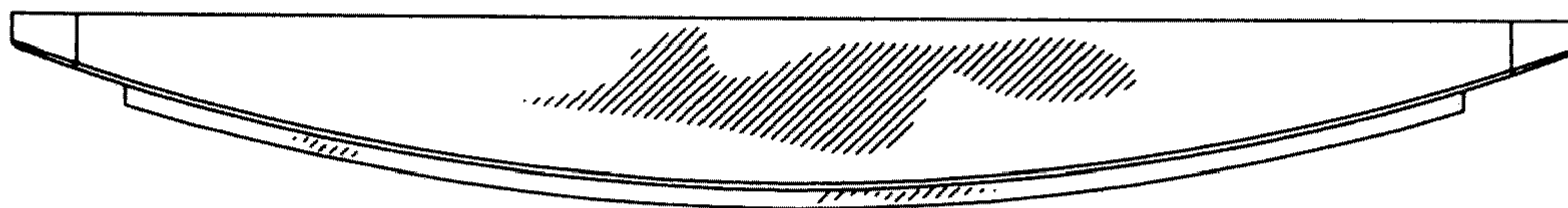

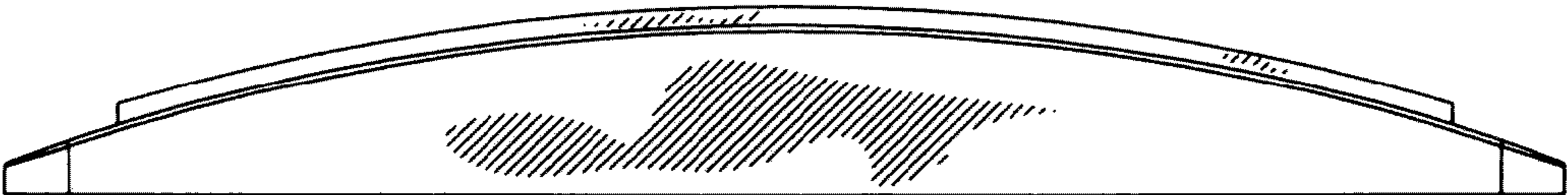

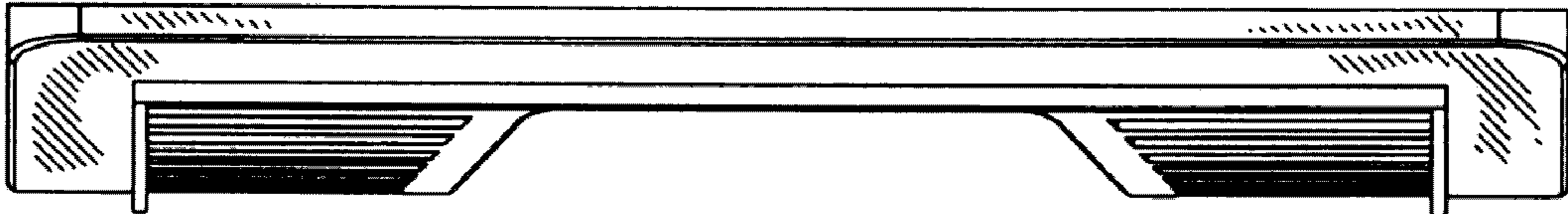

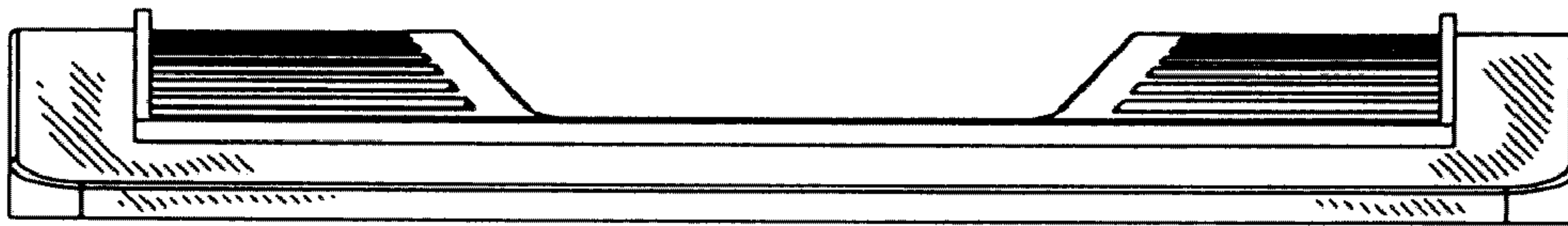

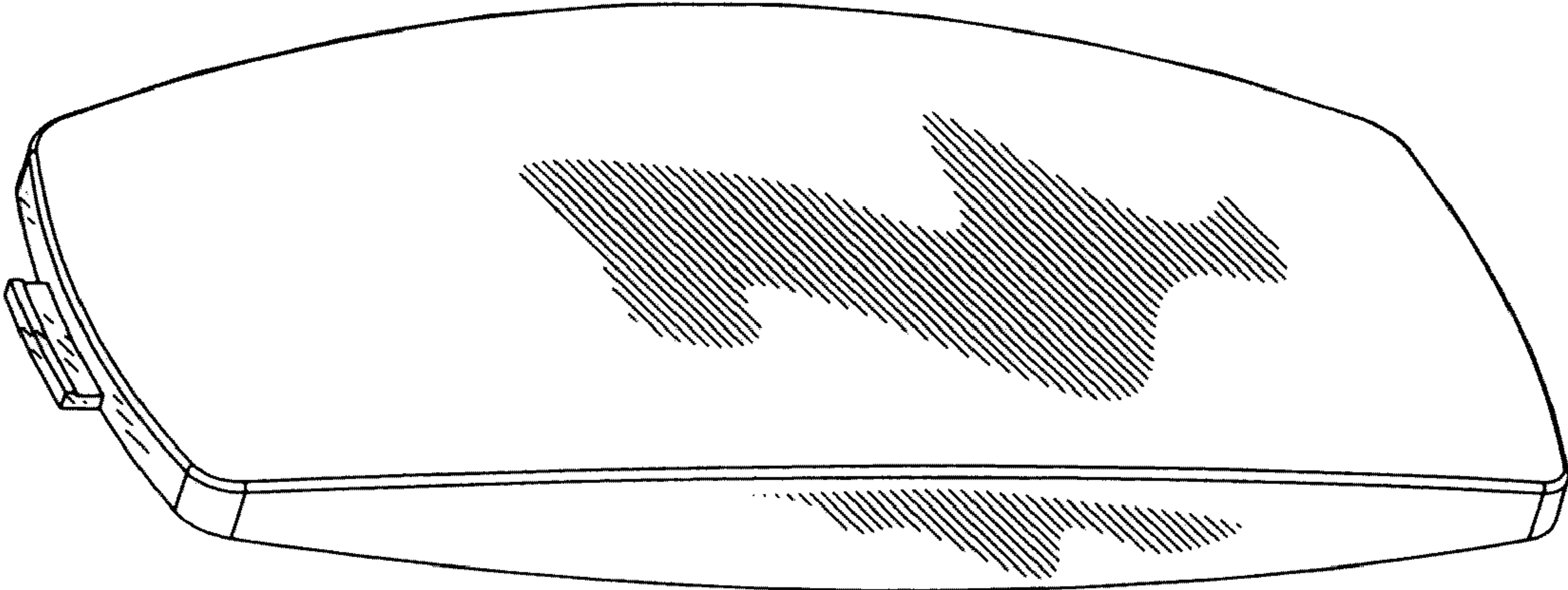

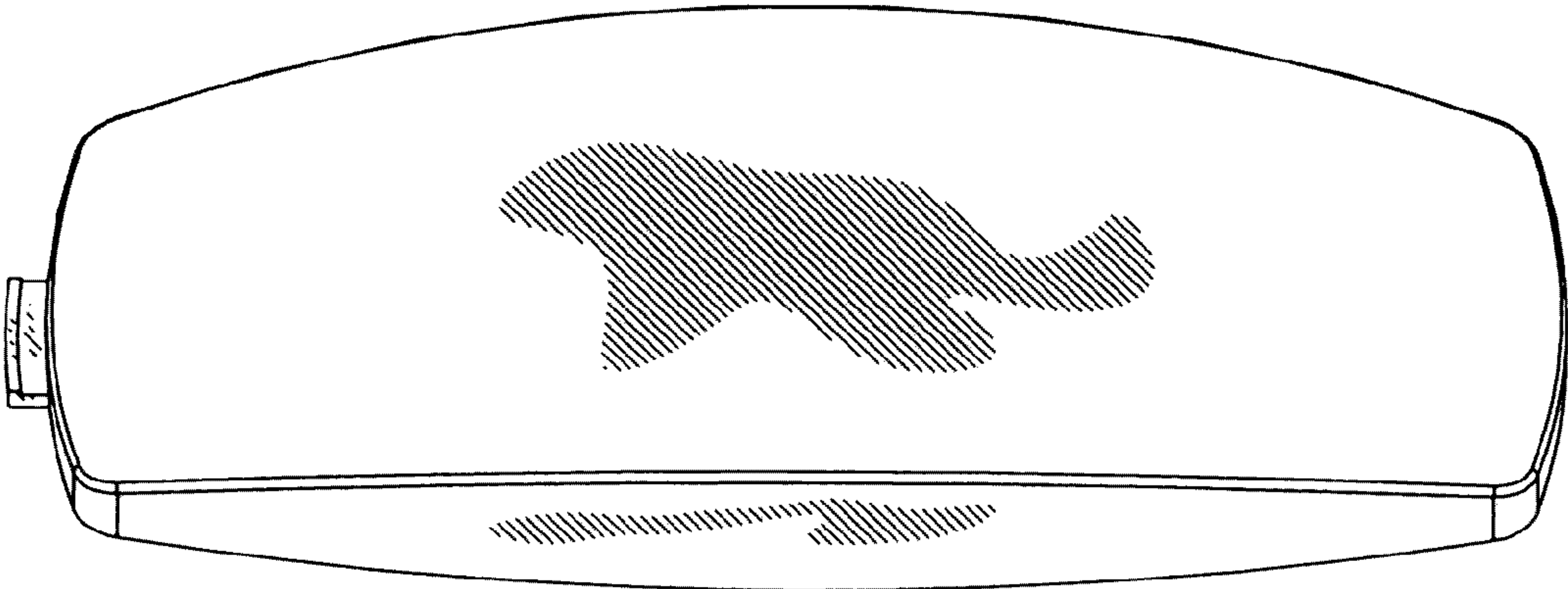

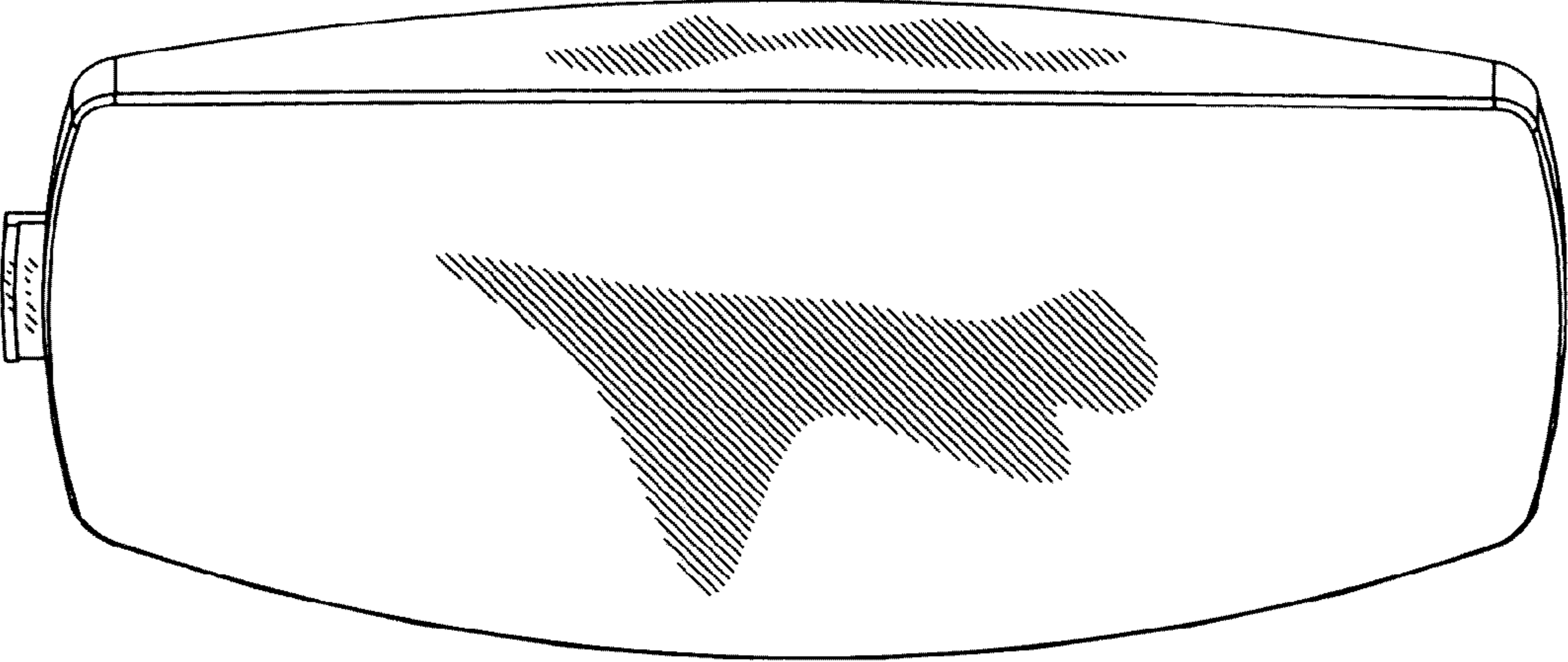

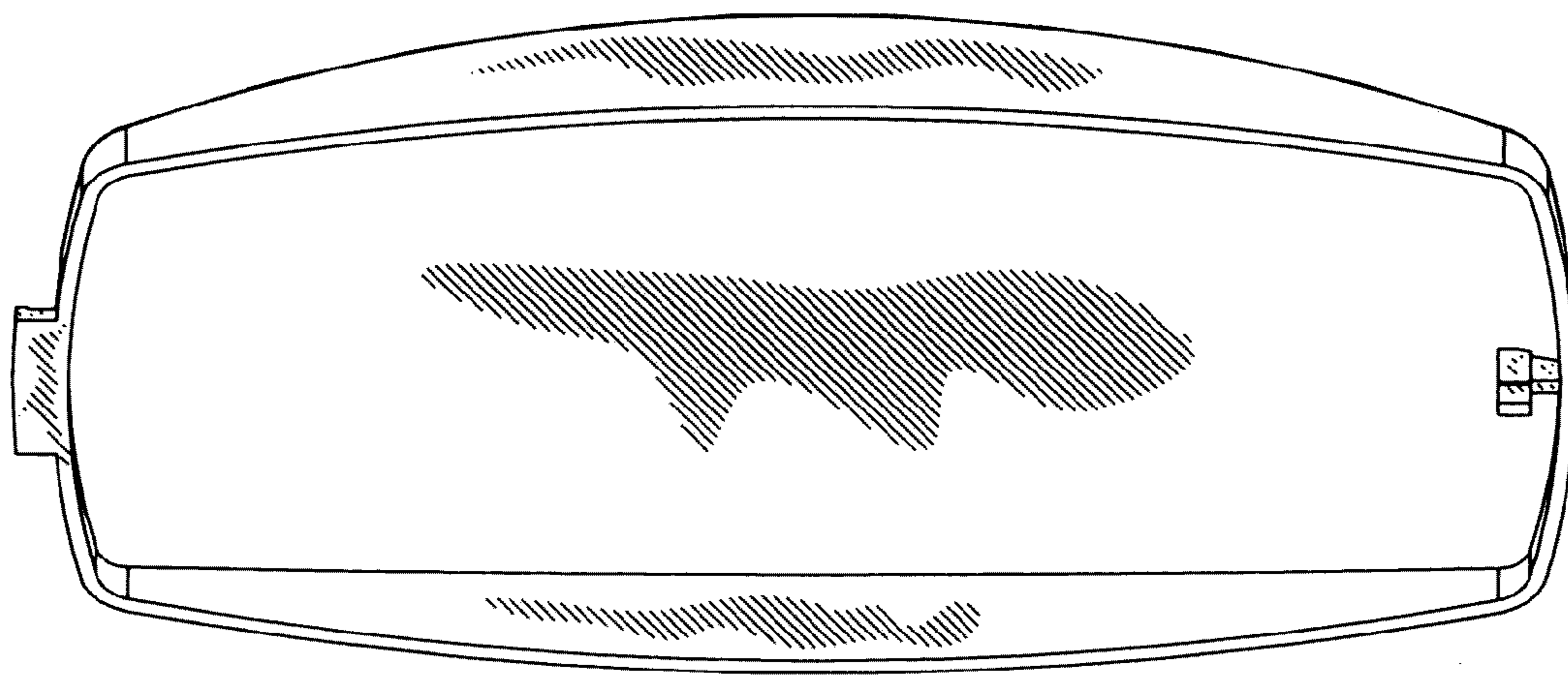

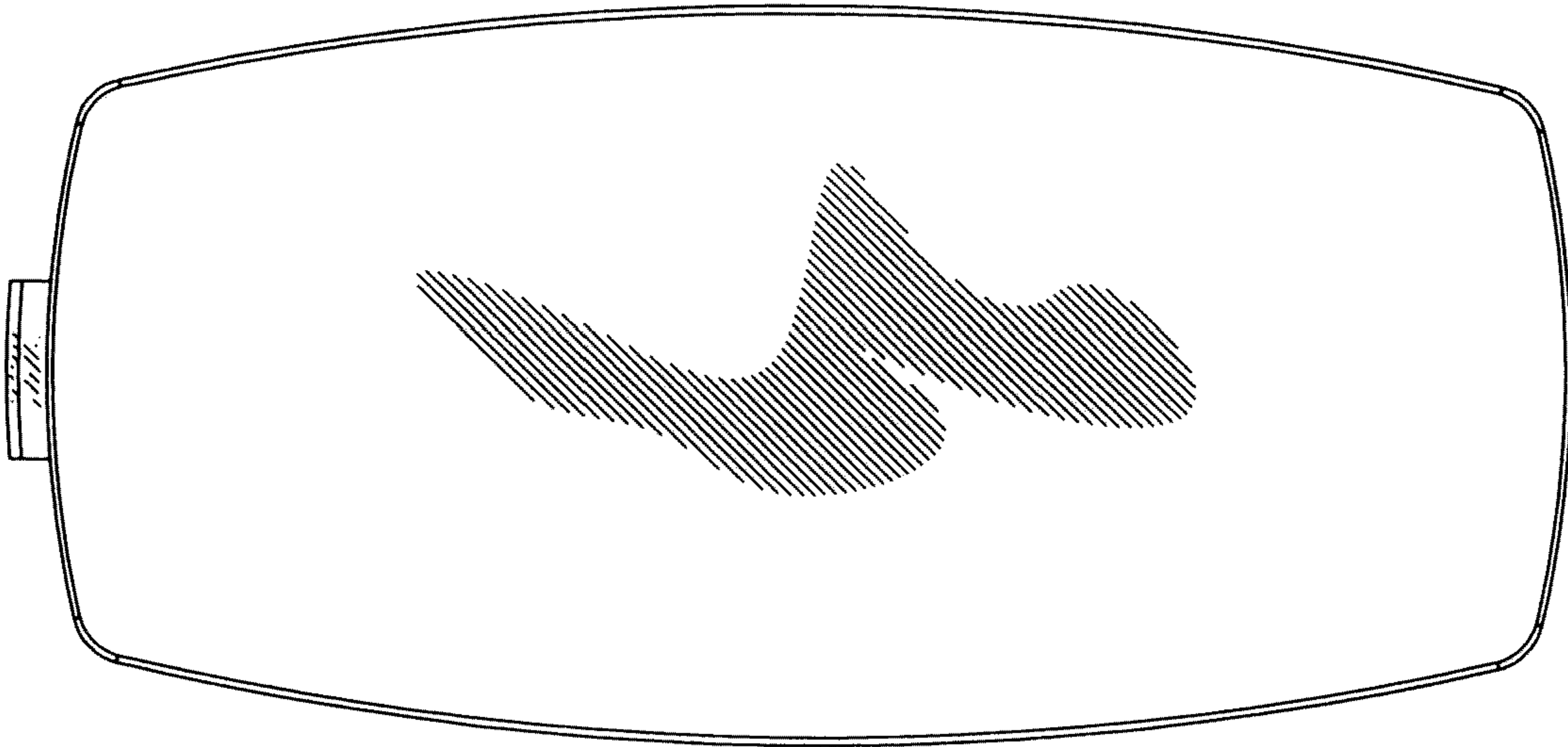

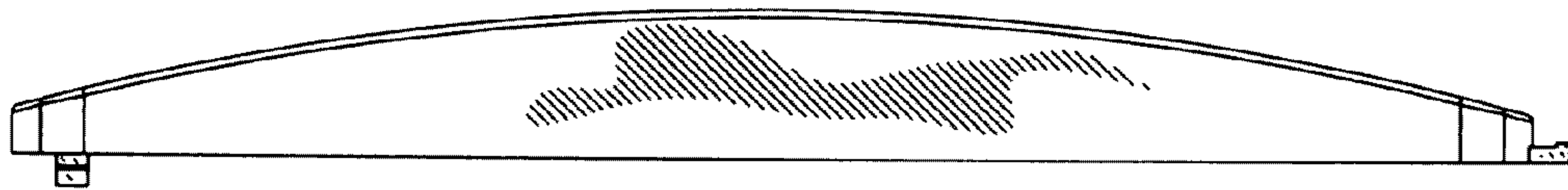
