**DESCRIPTION**

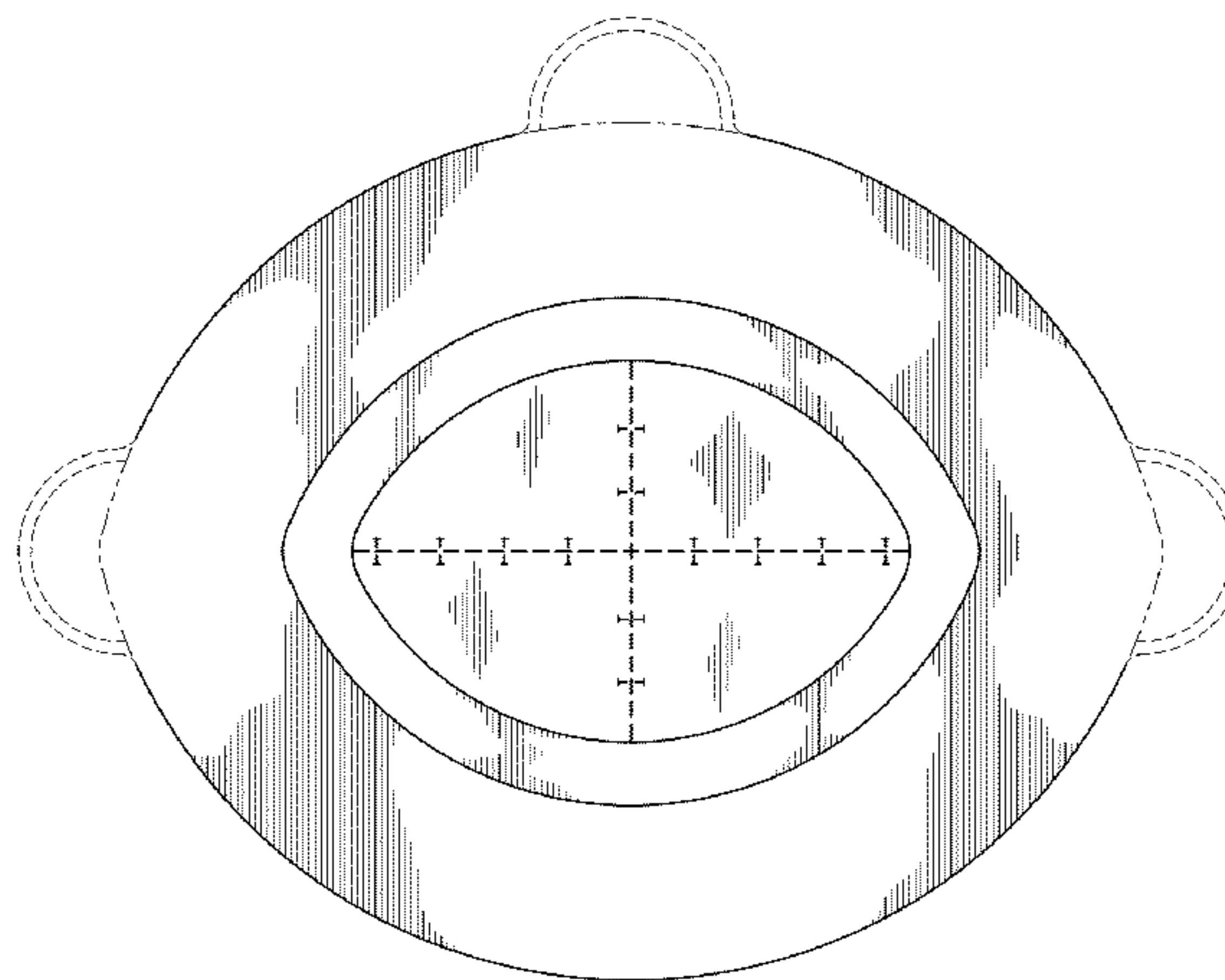
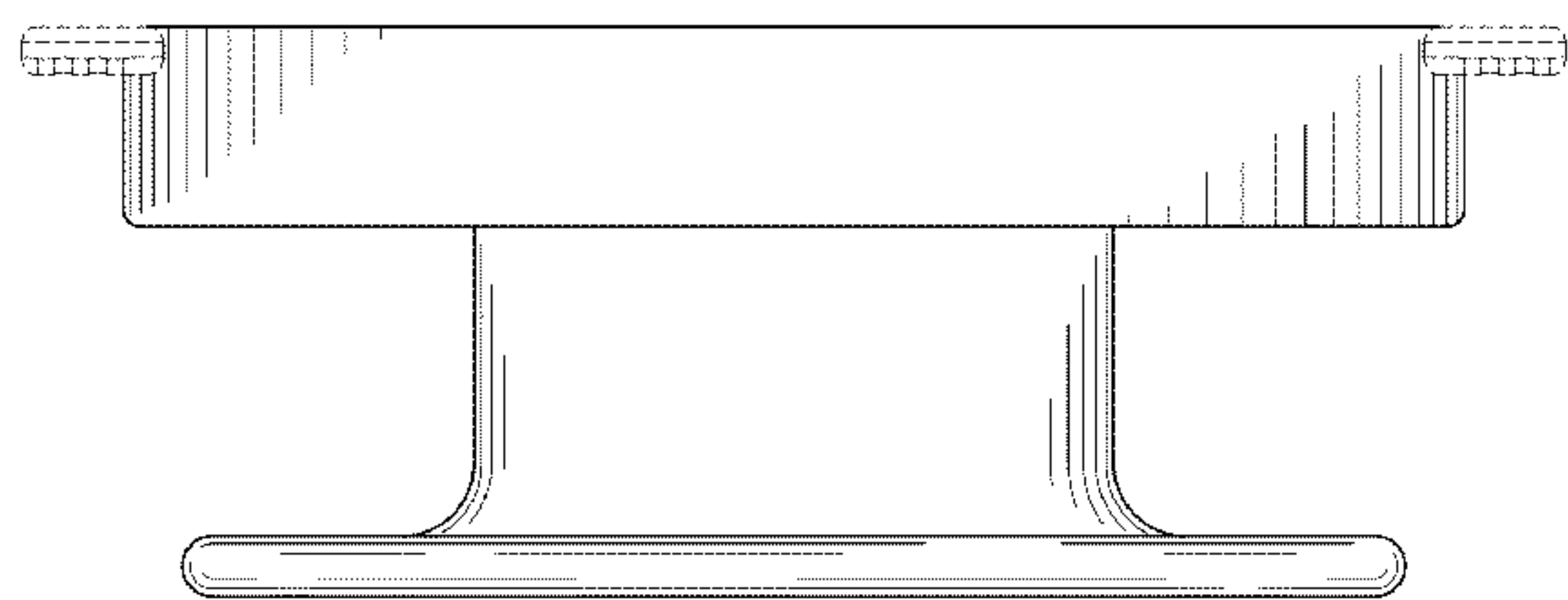
FIG. 1 is a front view of an access device for endoscopic surgery showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a back view thereof; FIG. 7 is a perspective view thereof; FIG. 8 is a front view of a port unit of the access device for endoscopic surgery shown removed from the retractor unit in order to show aspects of the design otherwise not shown; FIG. 9 is a top plan view thereof; FIG. 10 is a bottom plan view thereof; FIG. 11 is a right side view thereof; FIG. 12 is a left side view thereof; FIG. 13 is a back view thereof; FIG. 14 is a perspective view thereof; FIG. 15 is a front view of a retractor unit of the access device for endoscopic surgery shown removed from the port unit in order to show aspects of the design otherwise not shown; FIG. 16 is a top plan view thereof; FIG. 17 is a bottom plan view thereof; FIG. 18 is a left side view thereof; FIG. 19 is a perspective view thereof; and, FIG. 20 is an exploded view of the access device for endoscopic surgery showing our new design.

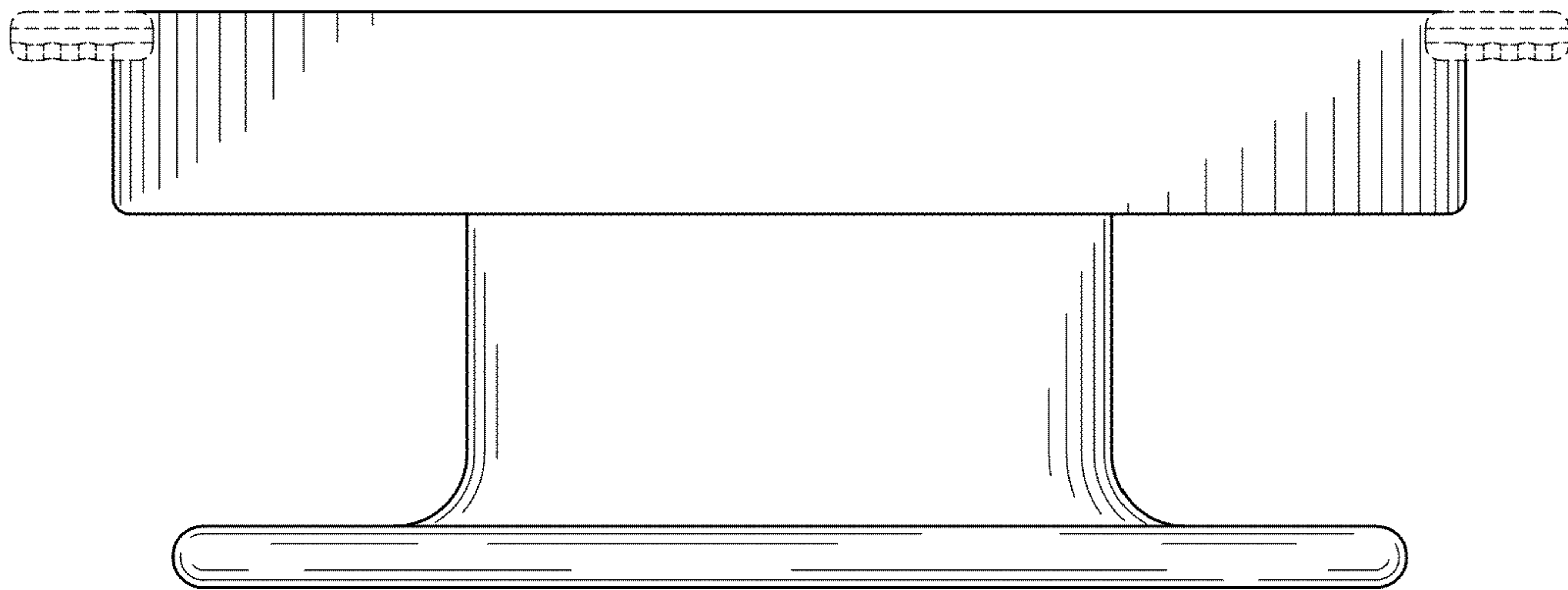

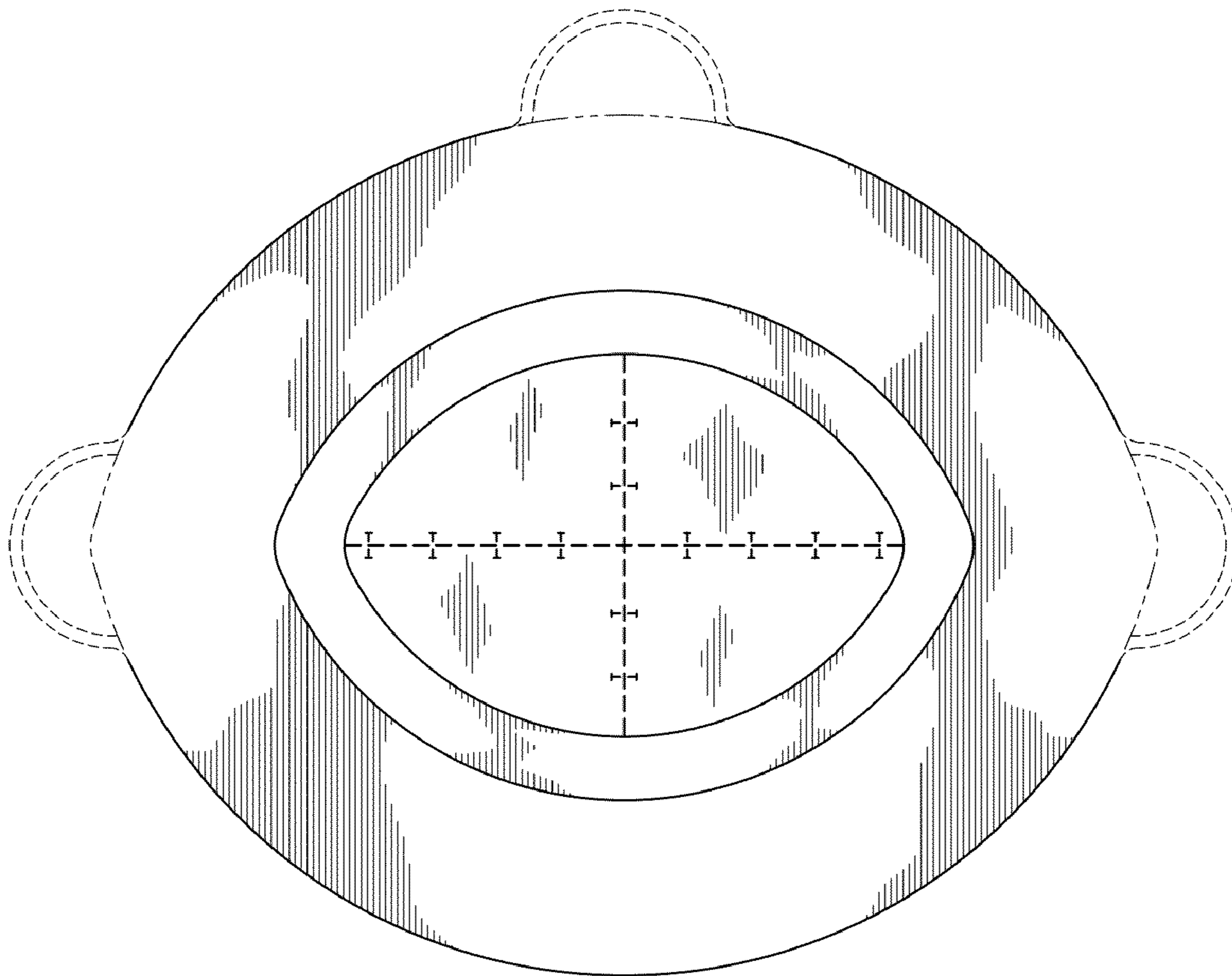

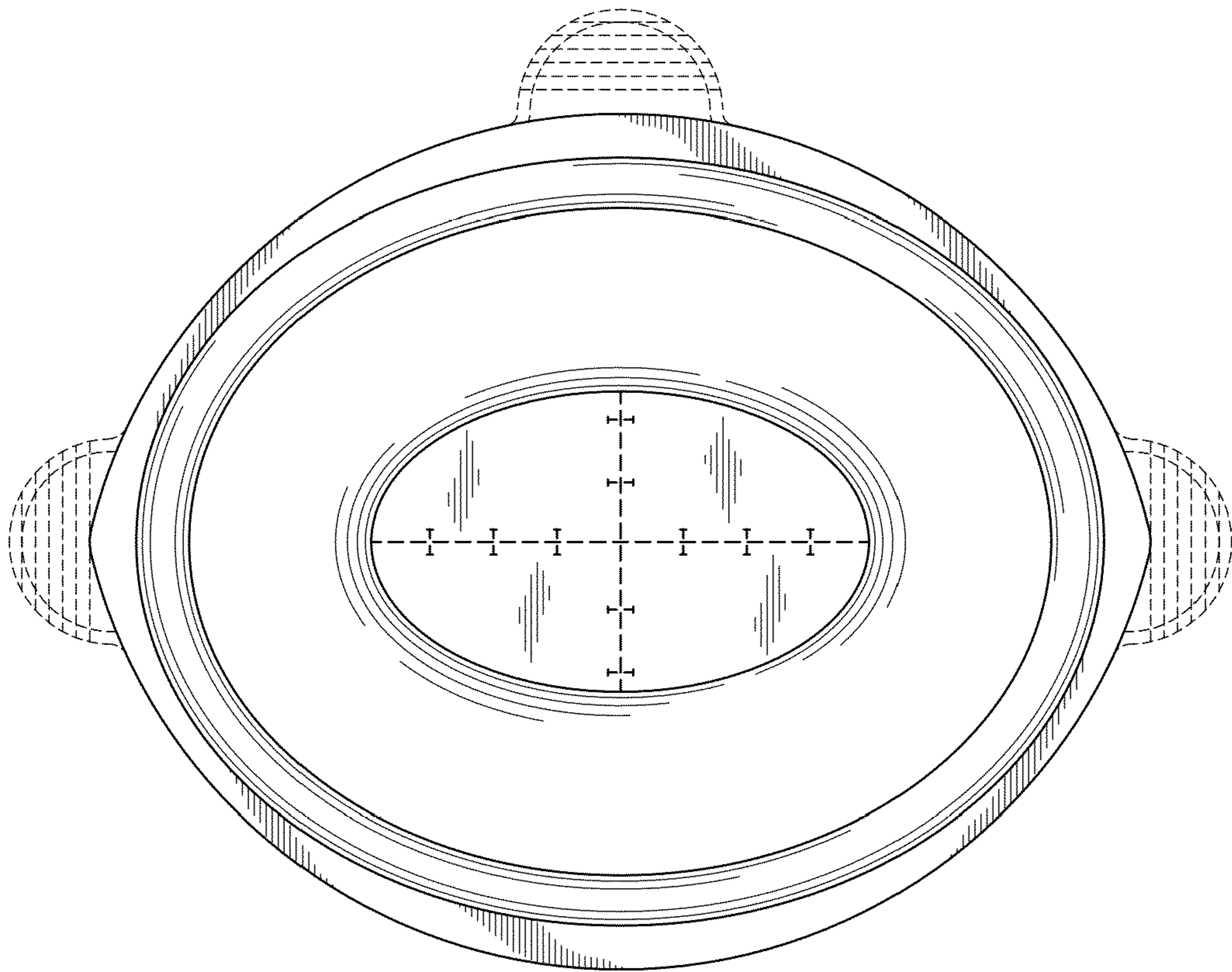

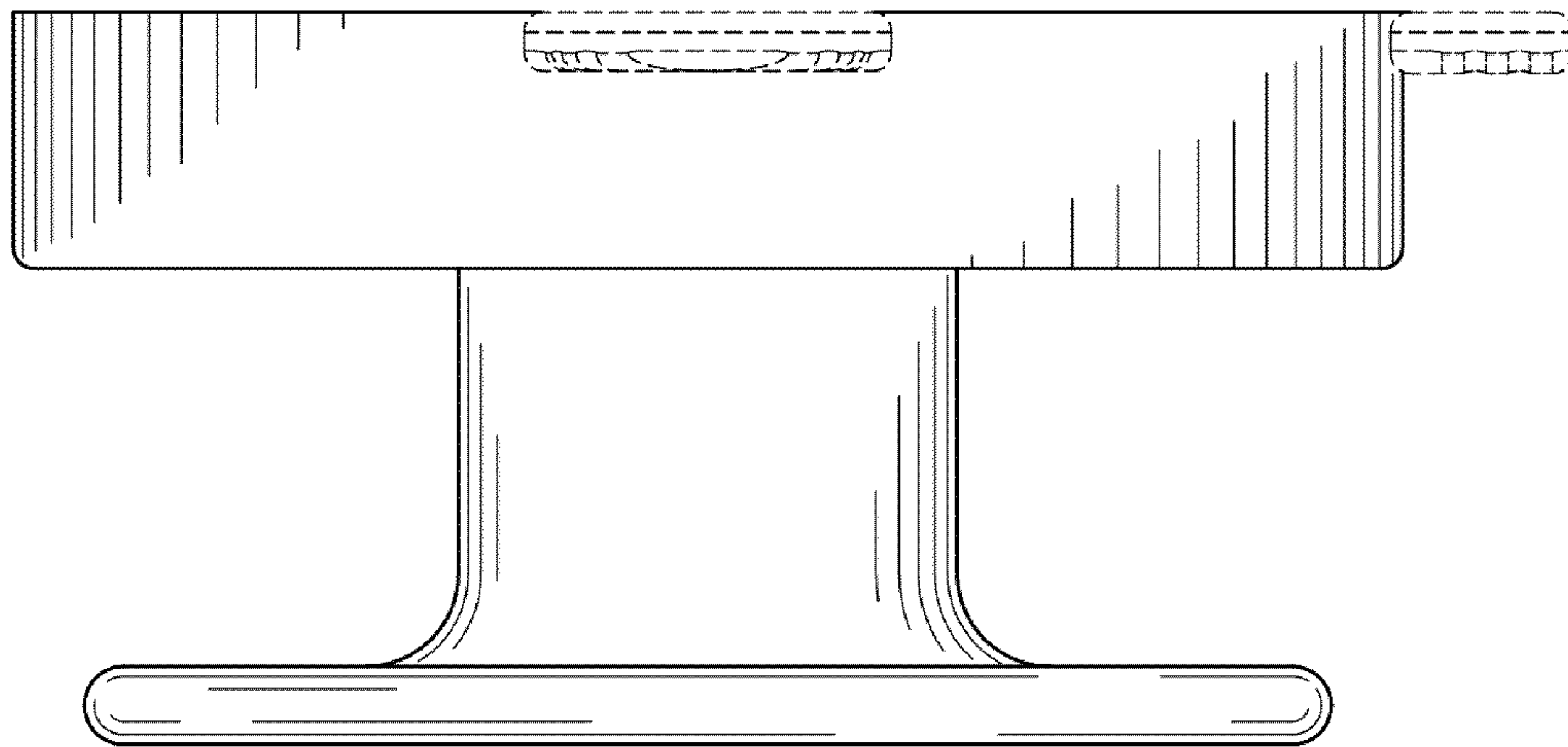

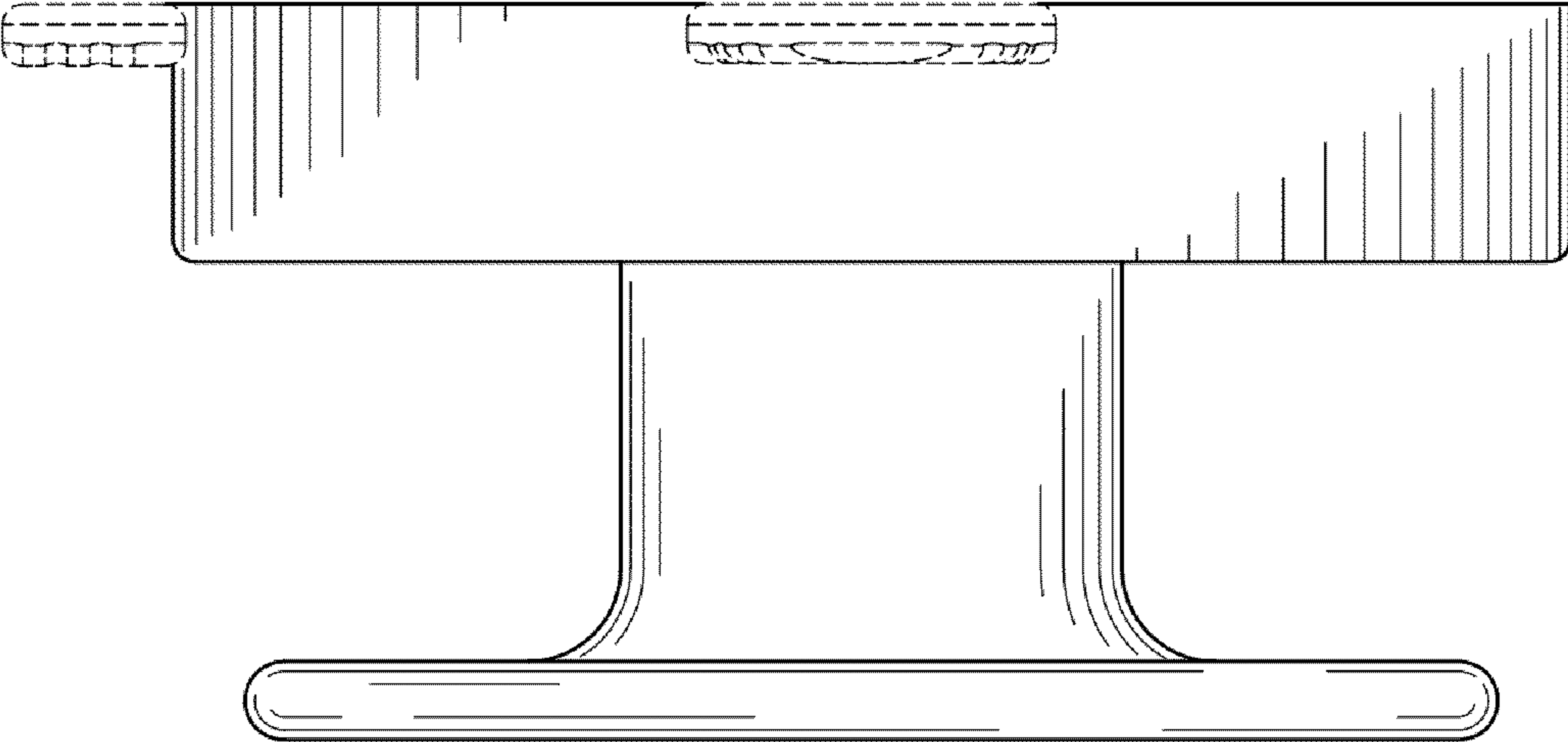

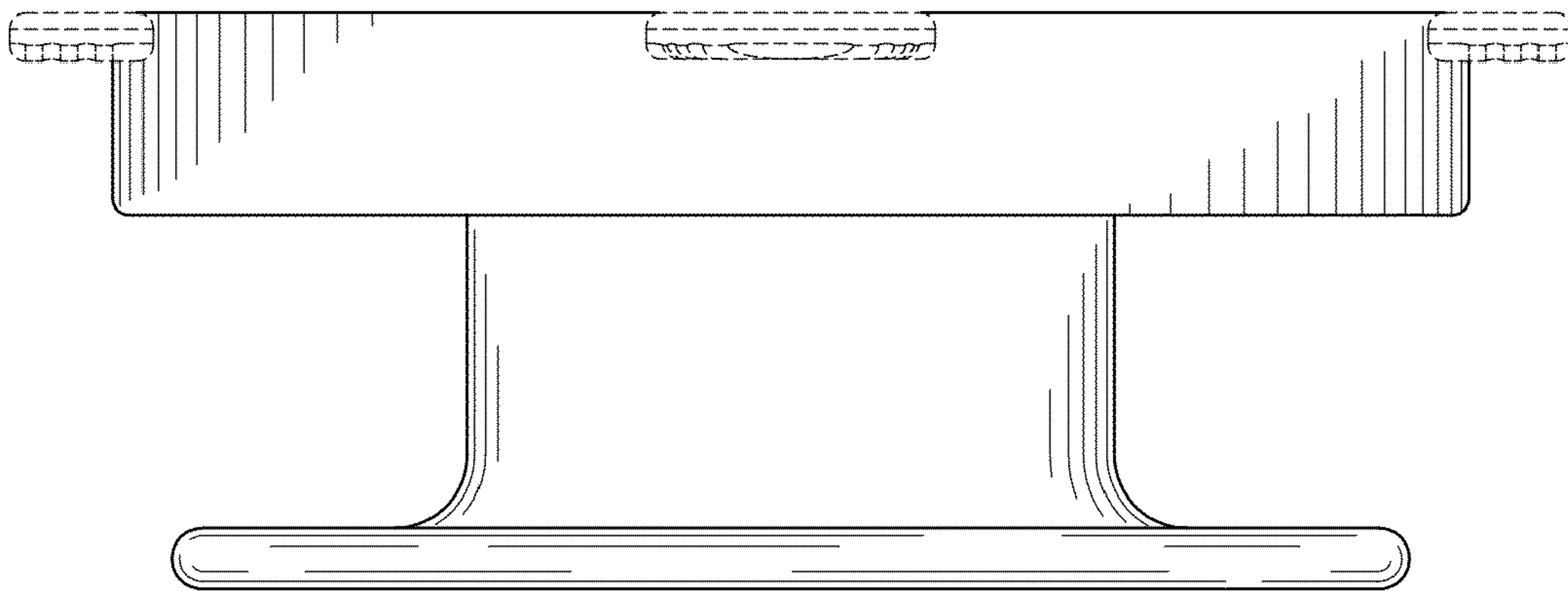

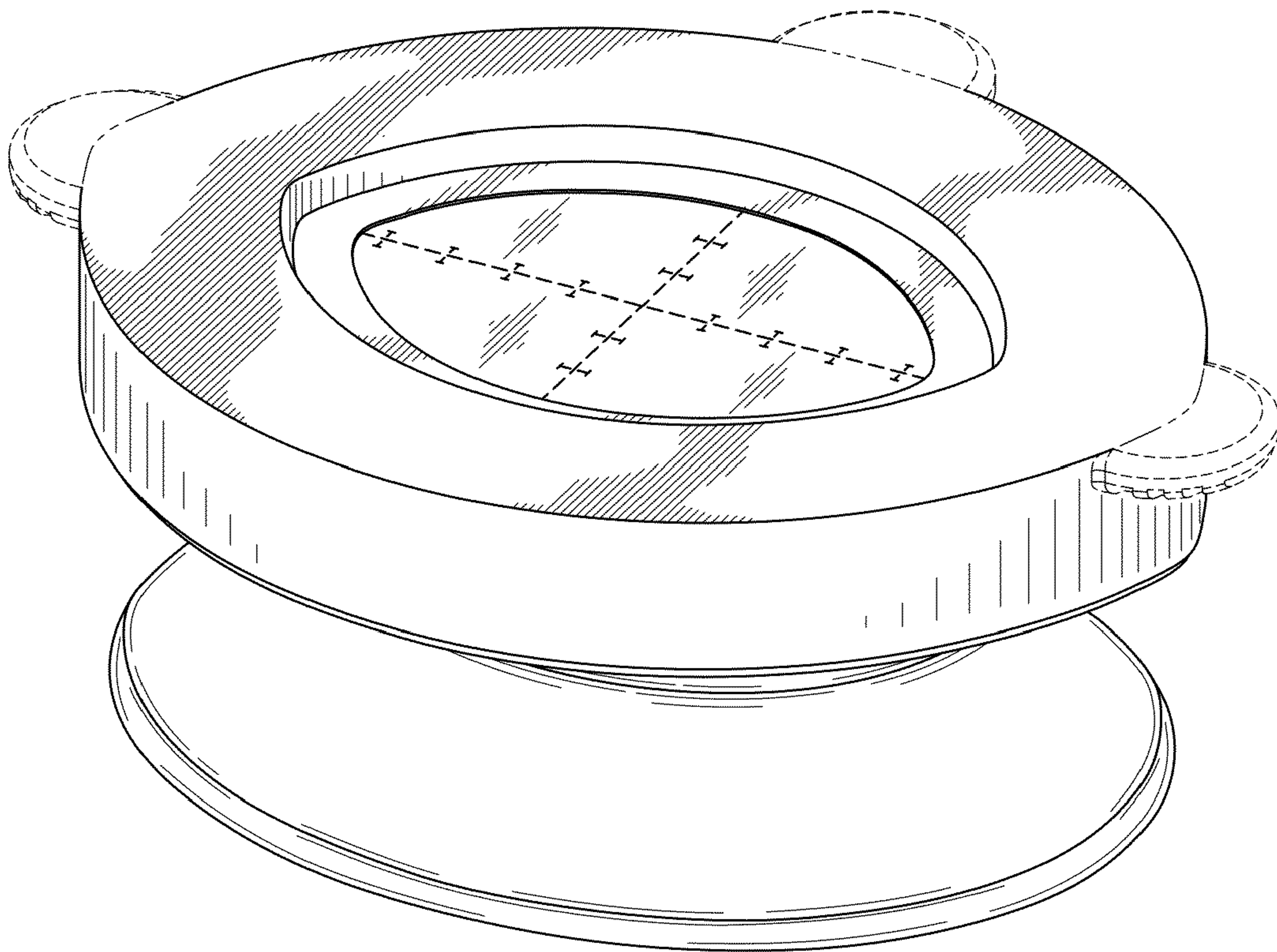

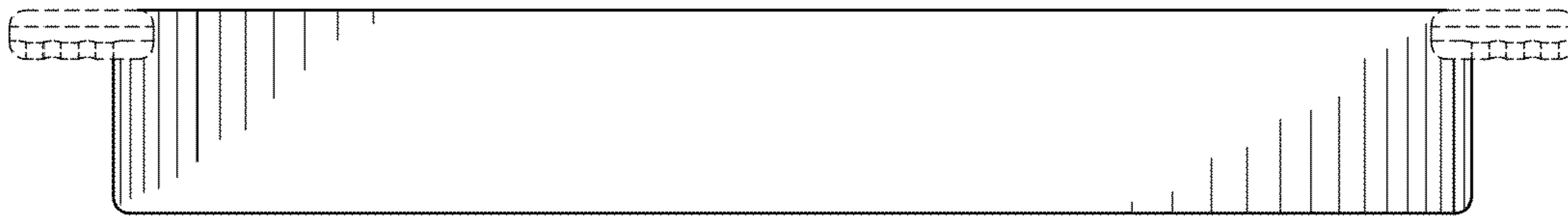

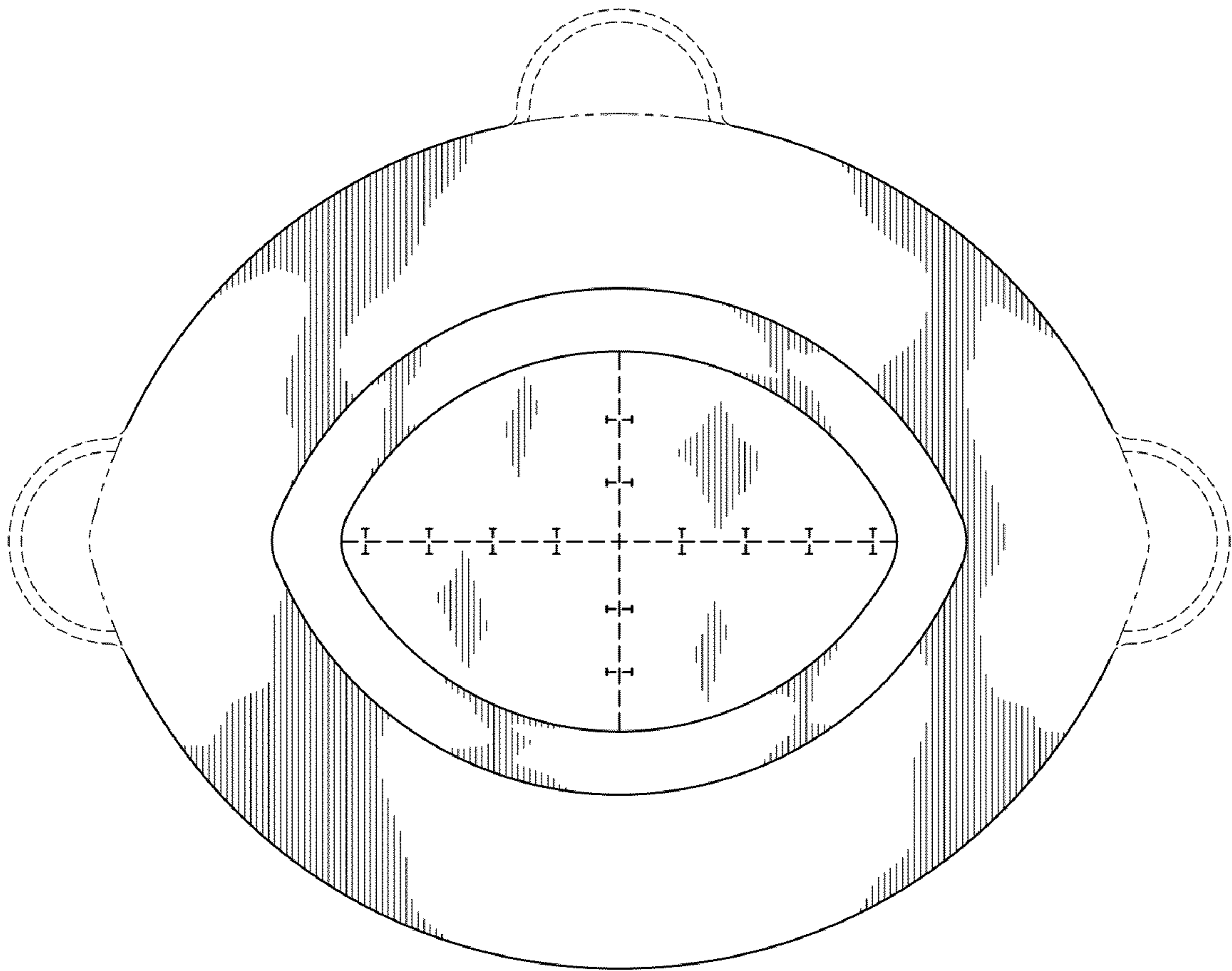

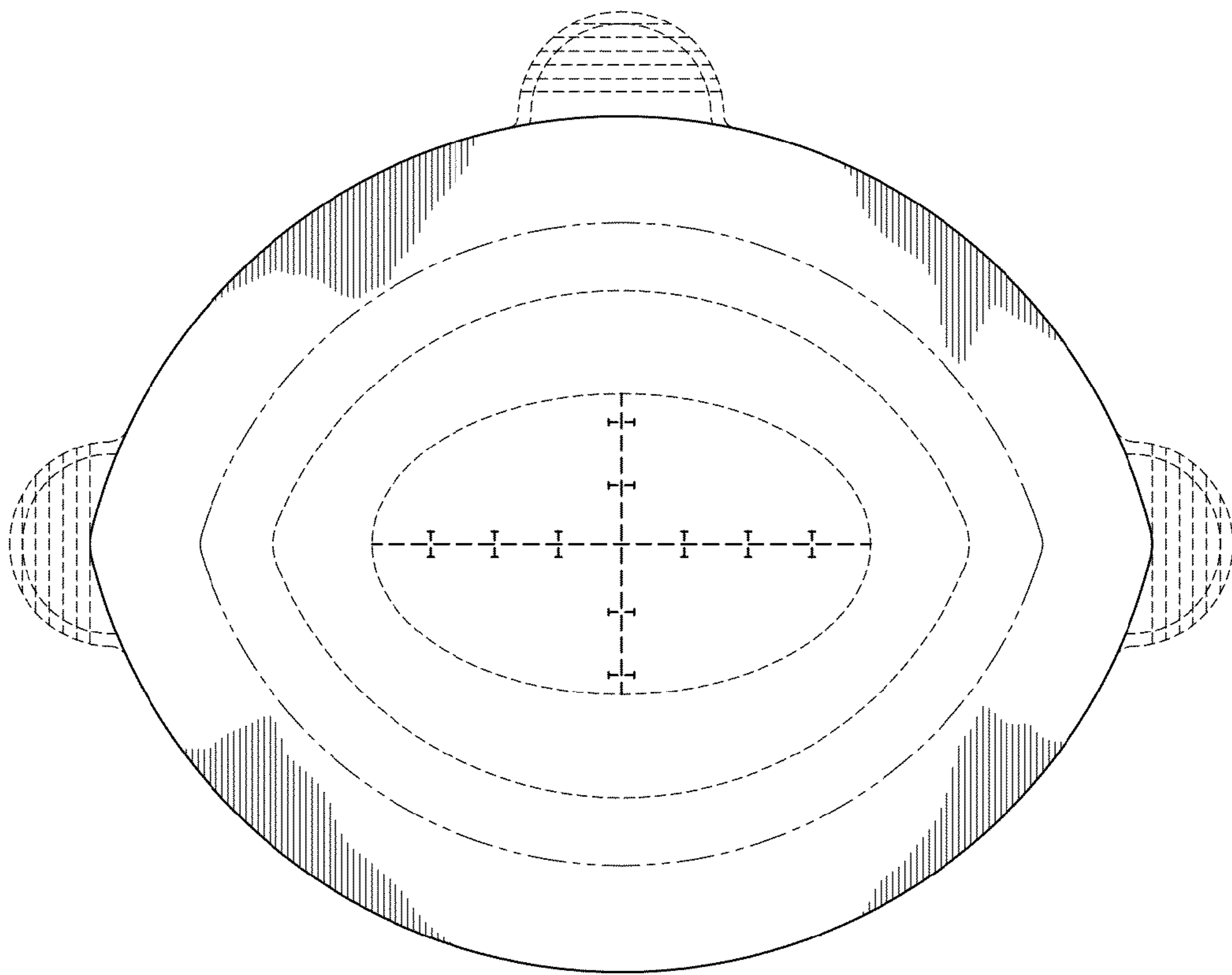

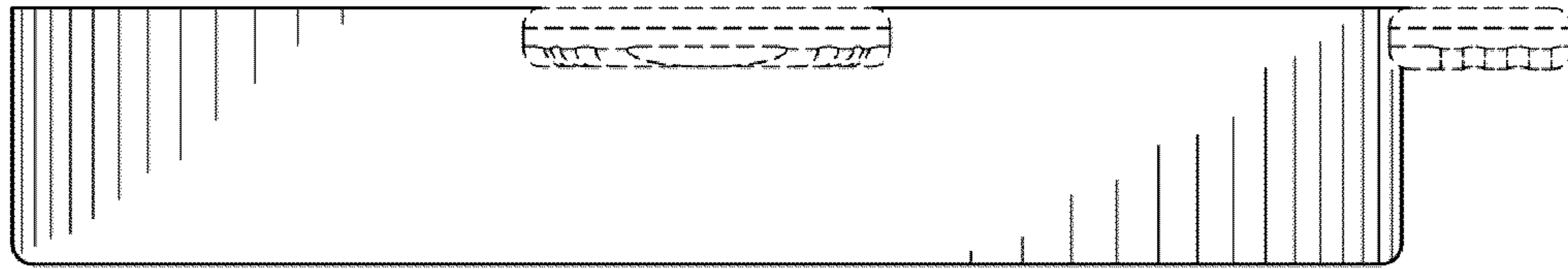

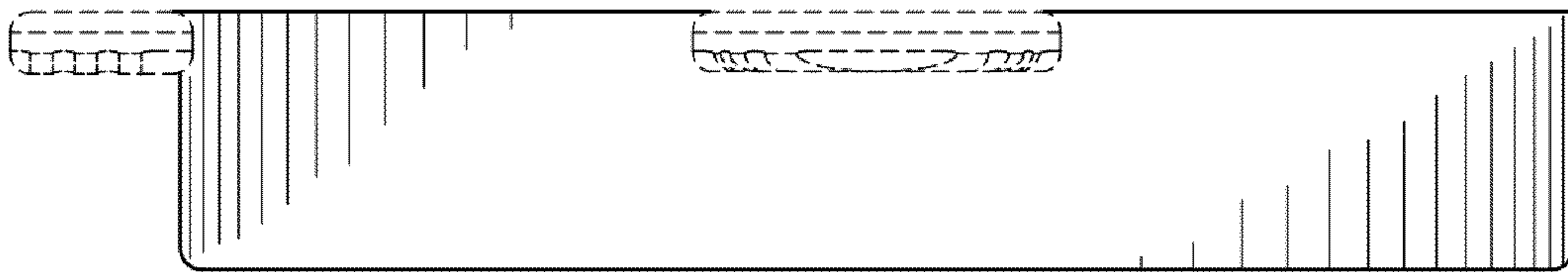

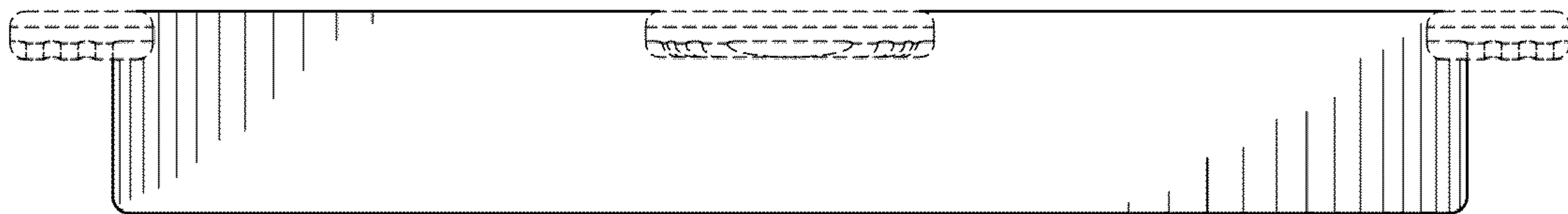

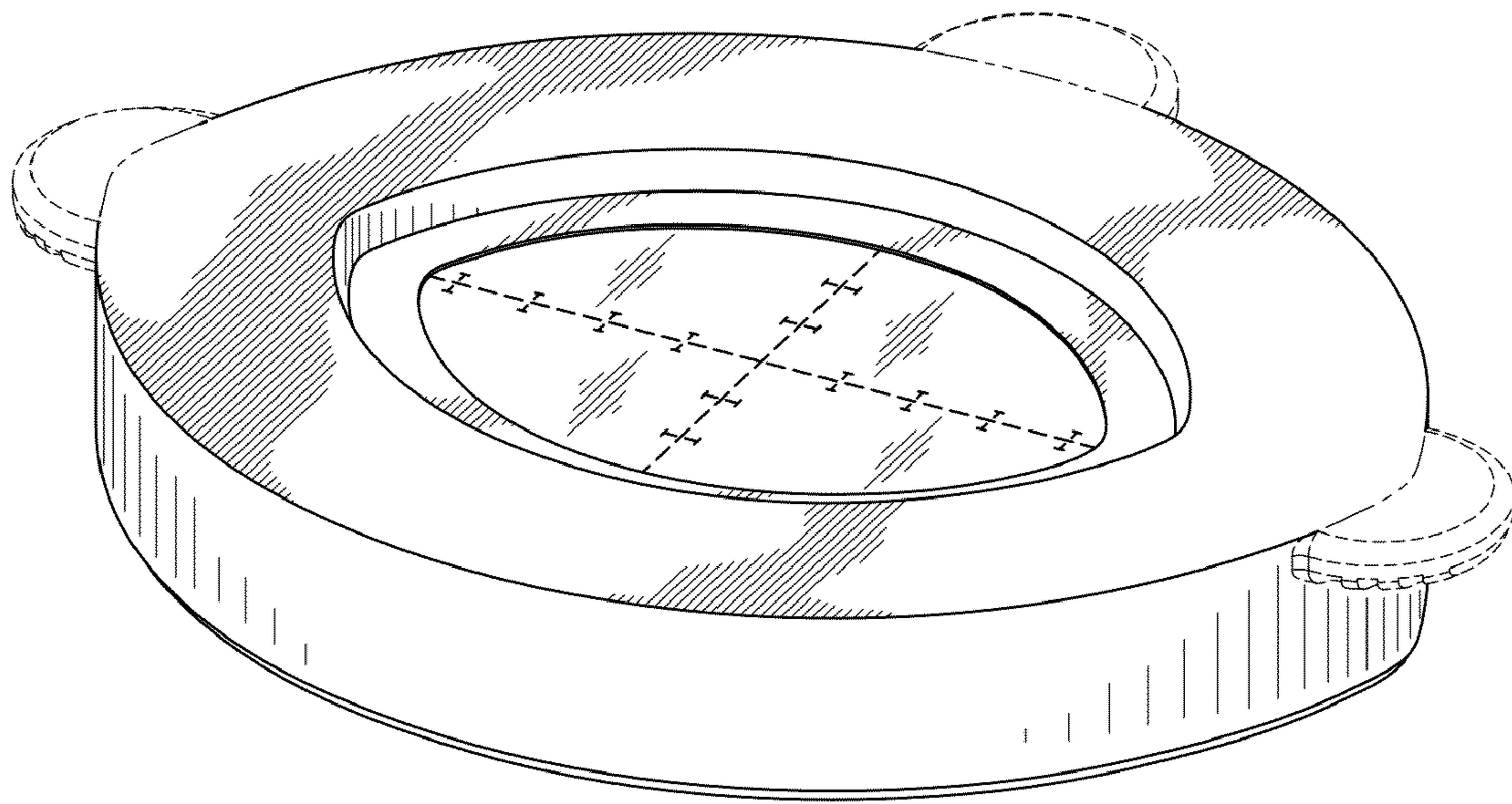

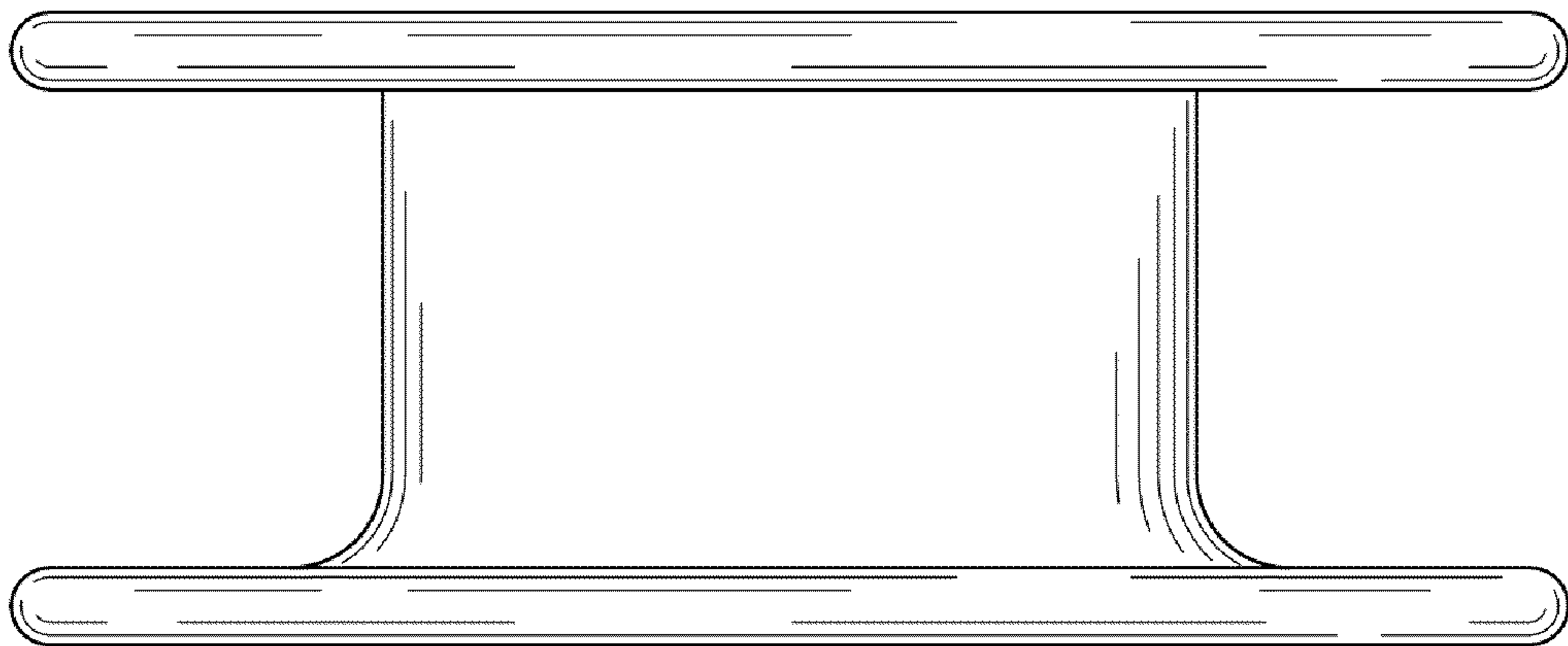

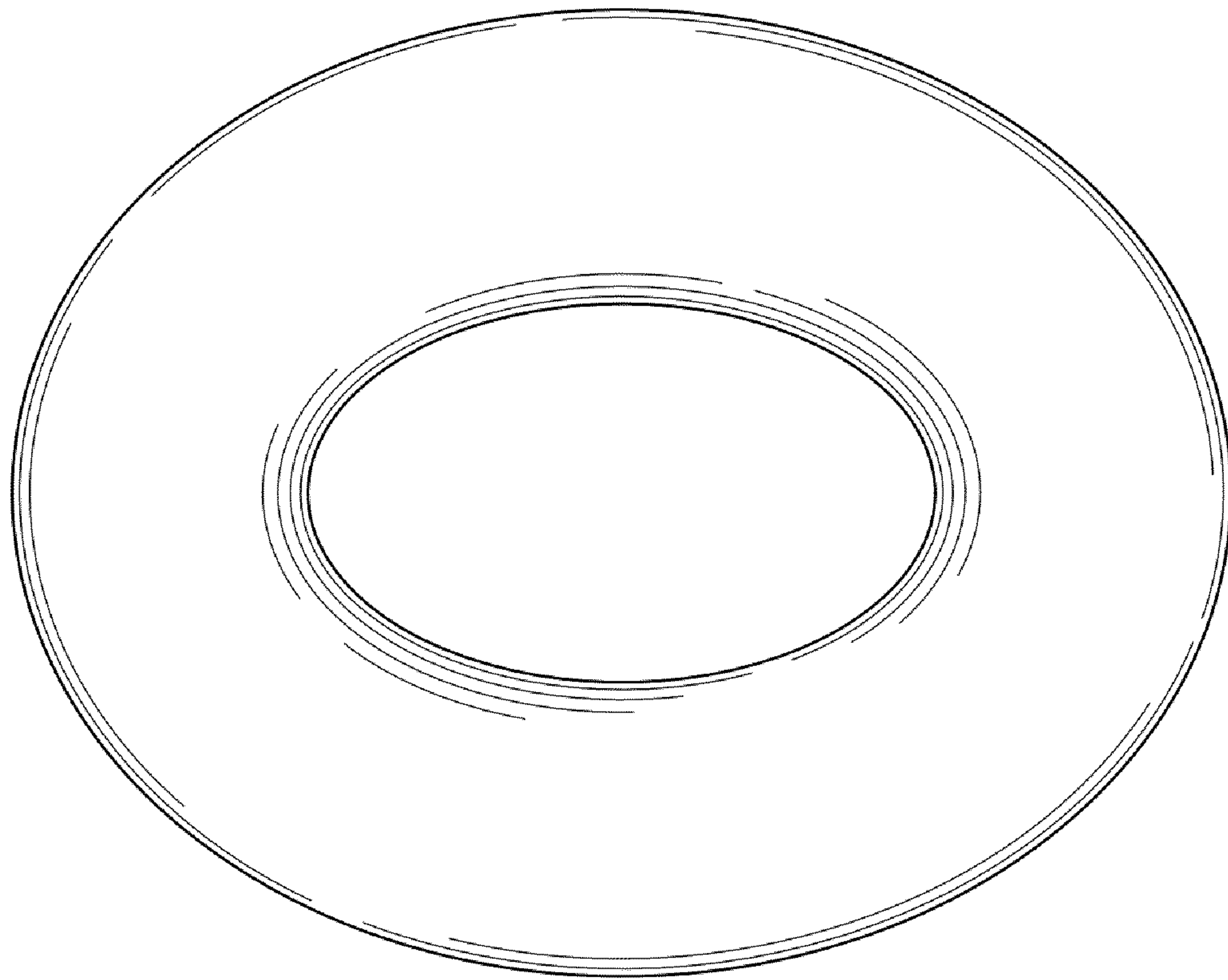

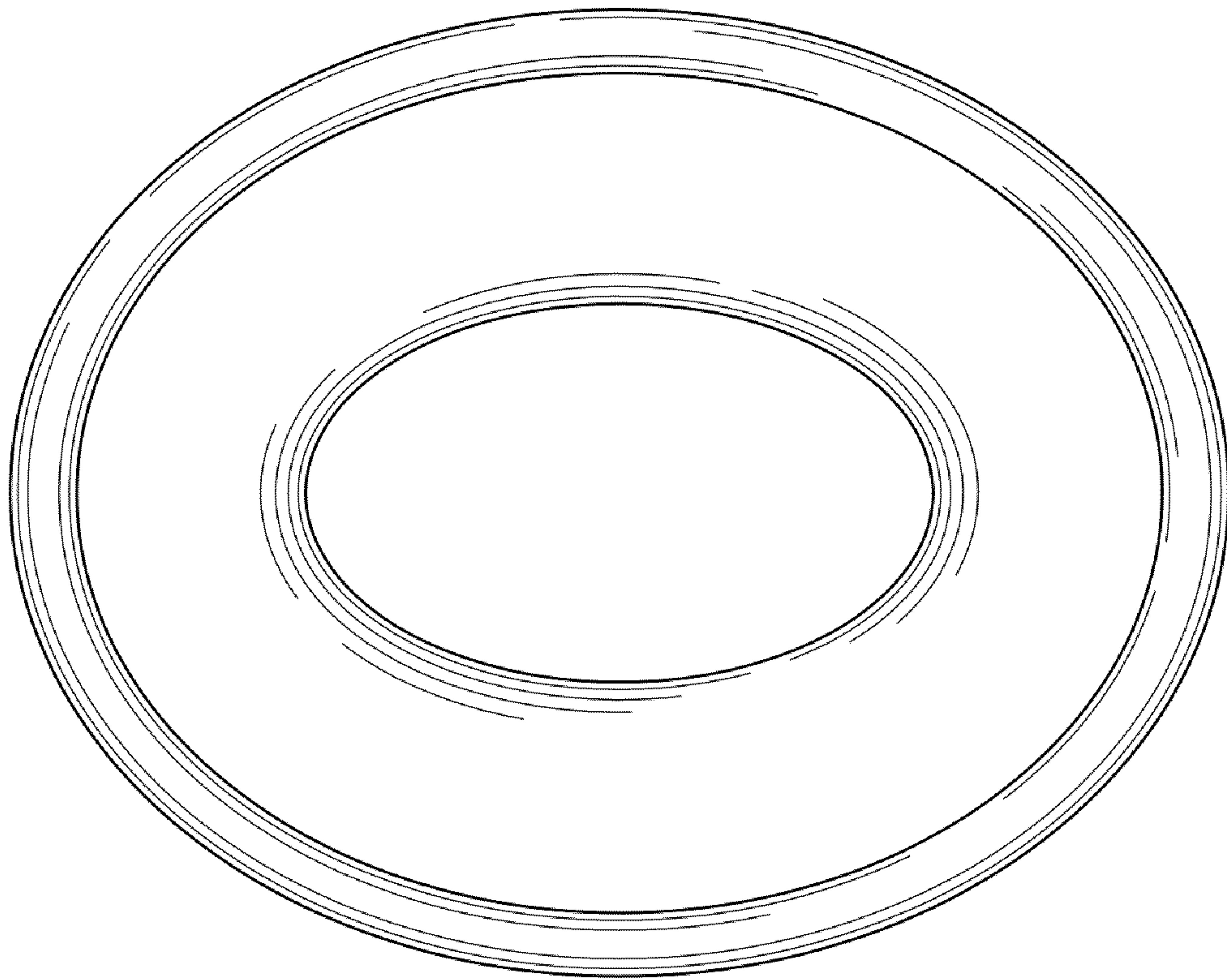

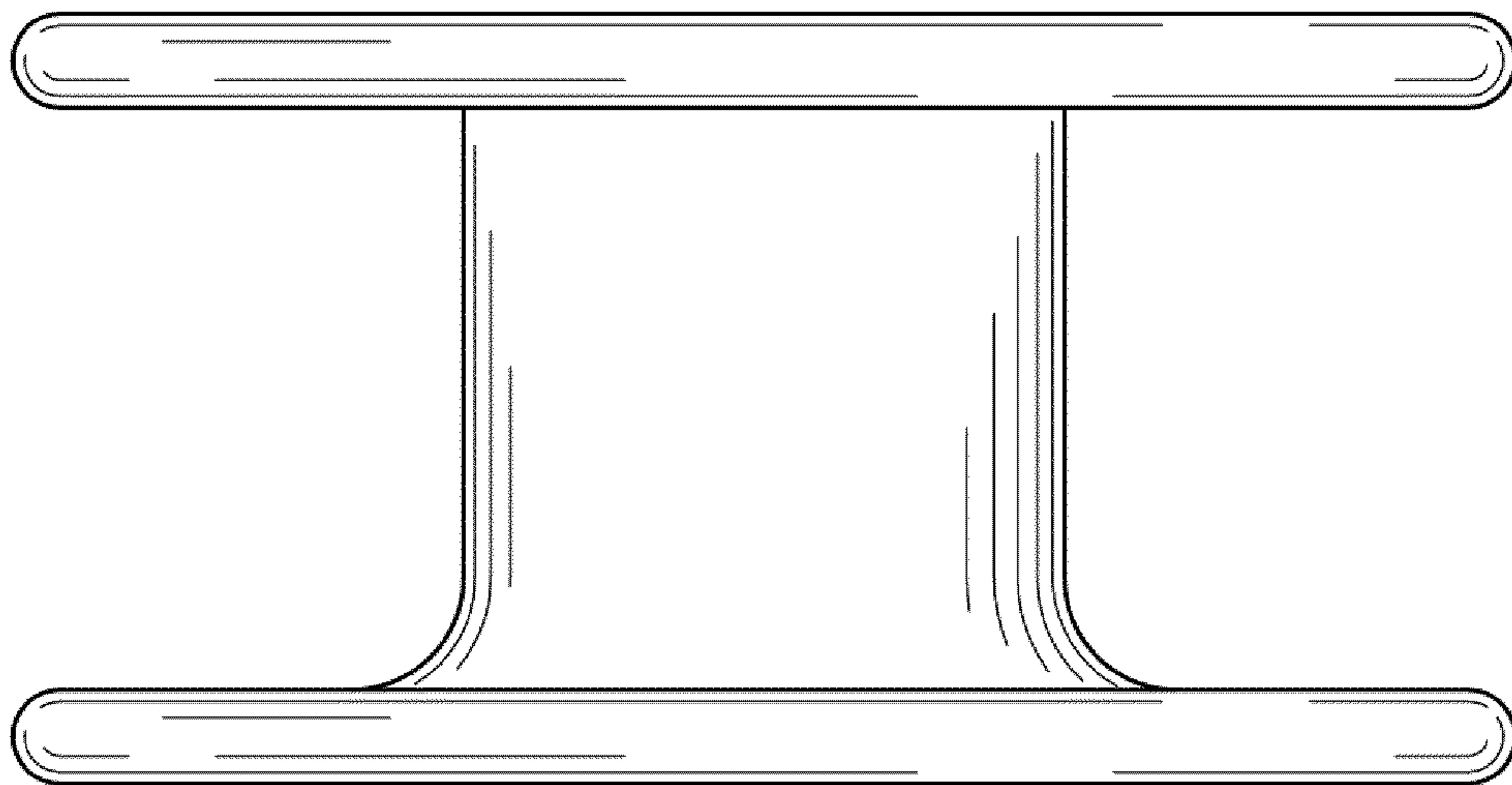

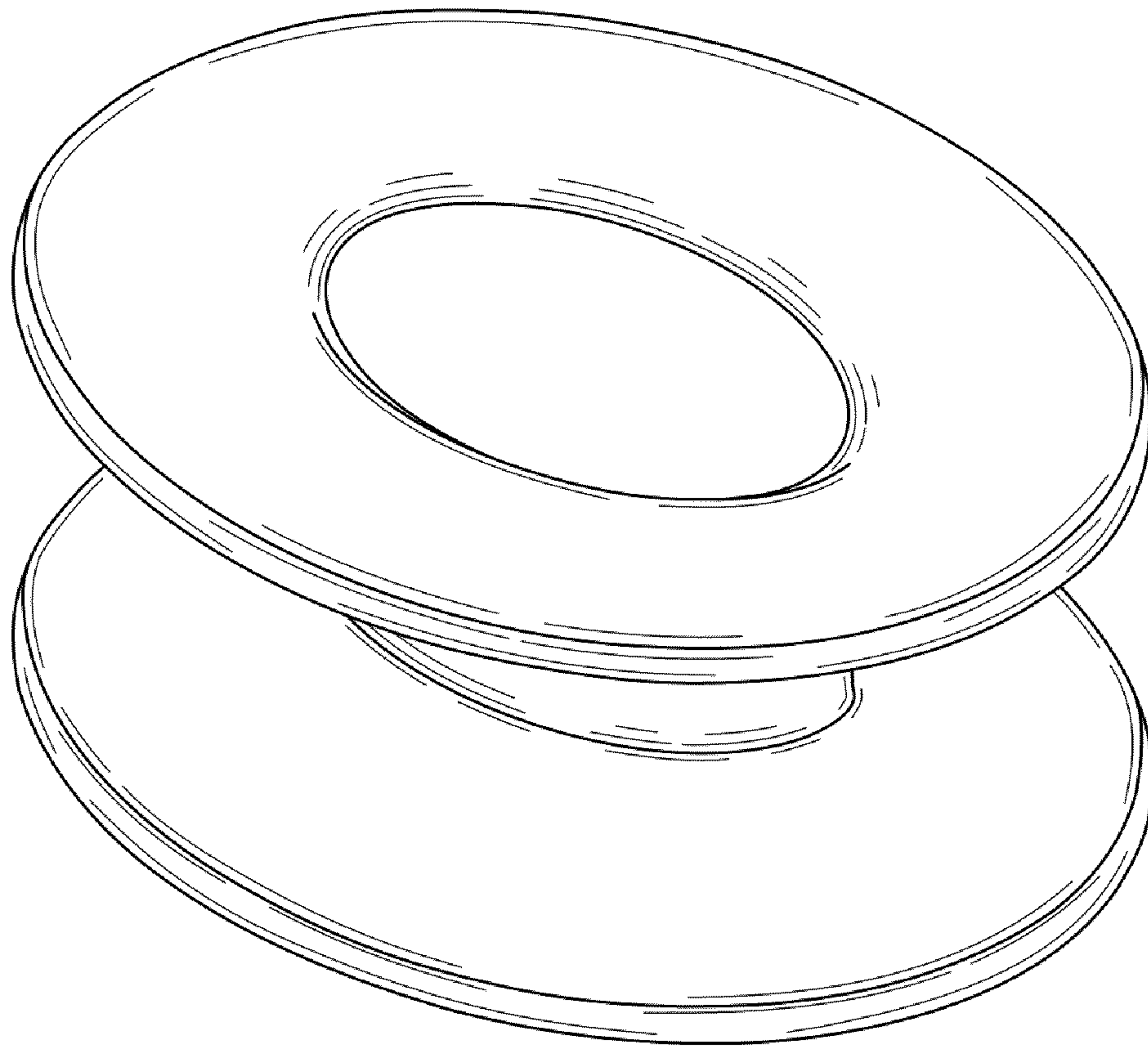
