(57) **CLAIM**

An ornamental design for an arch sleeve, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an arch sleeve showing my new design in condition of use on a human foot;

FIG. 2 is a top plan view of my new design;

FIG. 3 is a rear end view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a bottom view thereof;

FIG. 6 is a right side view thereof;

FIG. 7 is a front end view thereof;

FIG. 8 is a bottom, cross-sectional view thereof, taken along sectional line 8-8 in FIG. 3

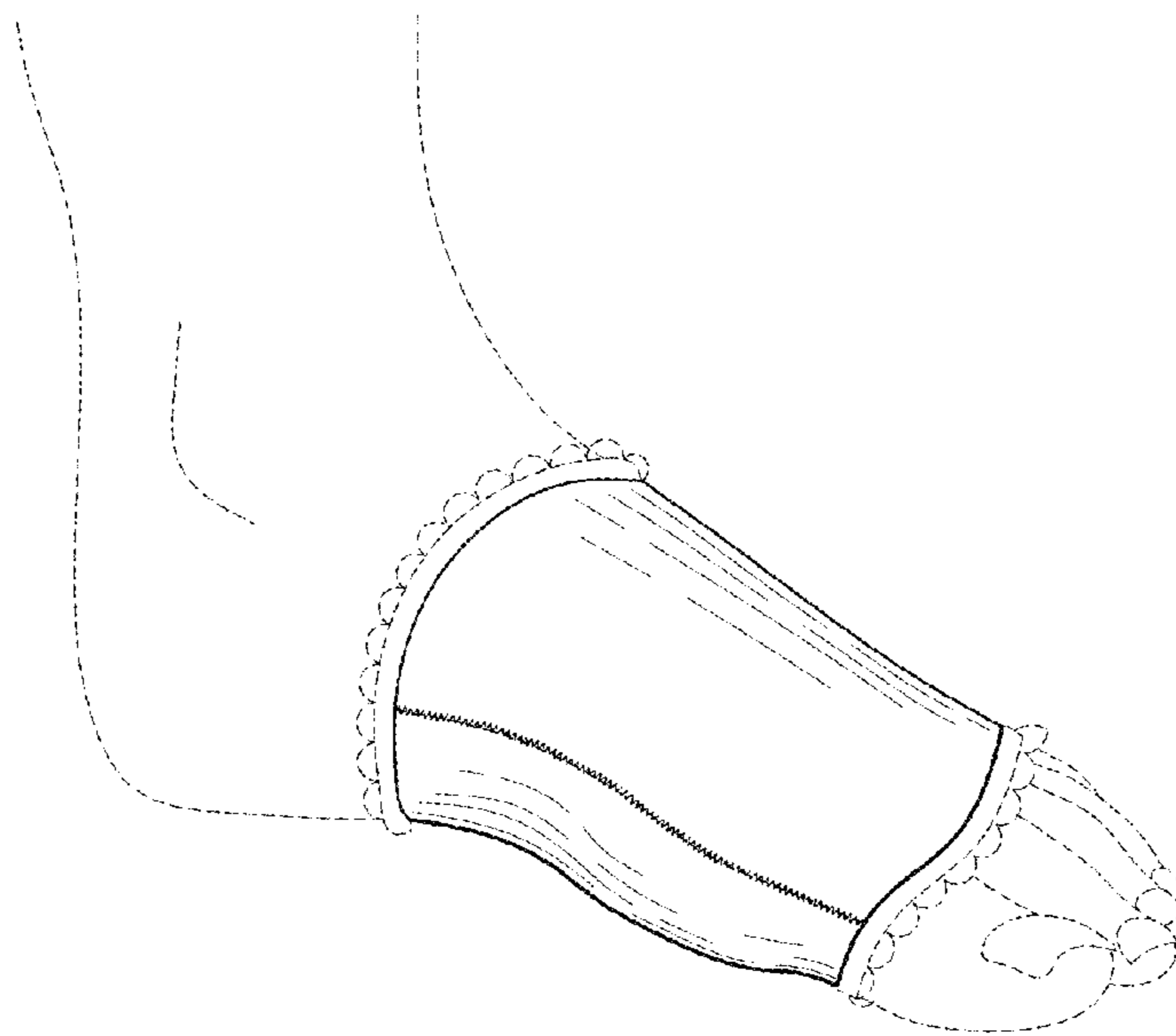
FIG. 9 is a left side view thereof, with a portion of sleeve material removed to expose a position of a pad relative to a human foot while the arch sleeve is being worn;

FIG. 10 is a bottom, cross-sectional view thereof, taken along line 10-10 in FIG. 7; and,

FIG. 11 is a right side view thereof, with a portion of sleeve material removed to expose a position of a pad relative to a human foot while the arch sleeve is being worn.

The broken lines in FIGS. 1-11 illustrate portions of the arch sleeve and environmental structure which form no part of the claimed design. Contour lines are provided merely to illustrate contours of the sleeve material, and also form no part of the claimed design. Any hatching appearing in a sectional view does not identify any specific material.

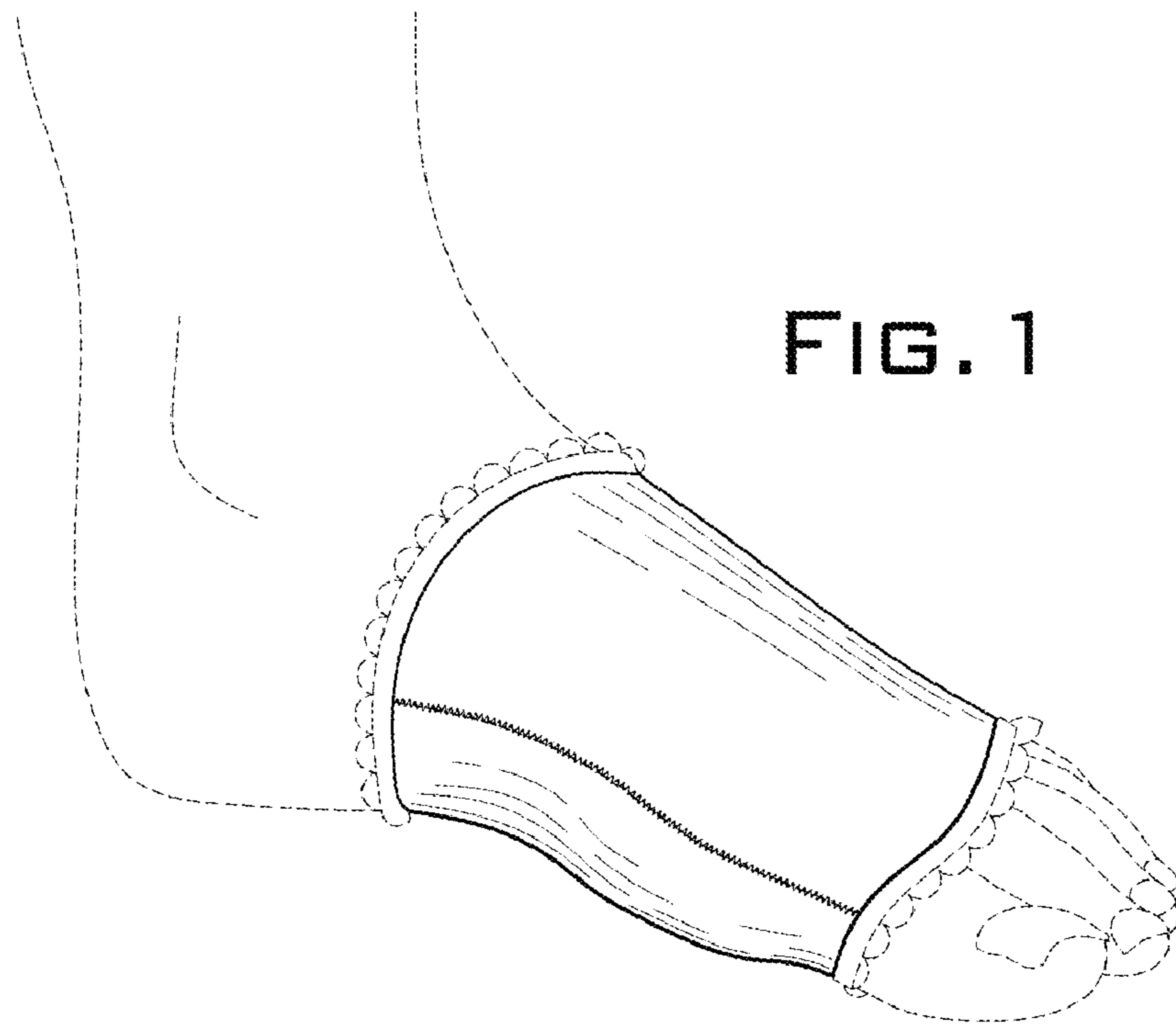

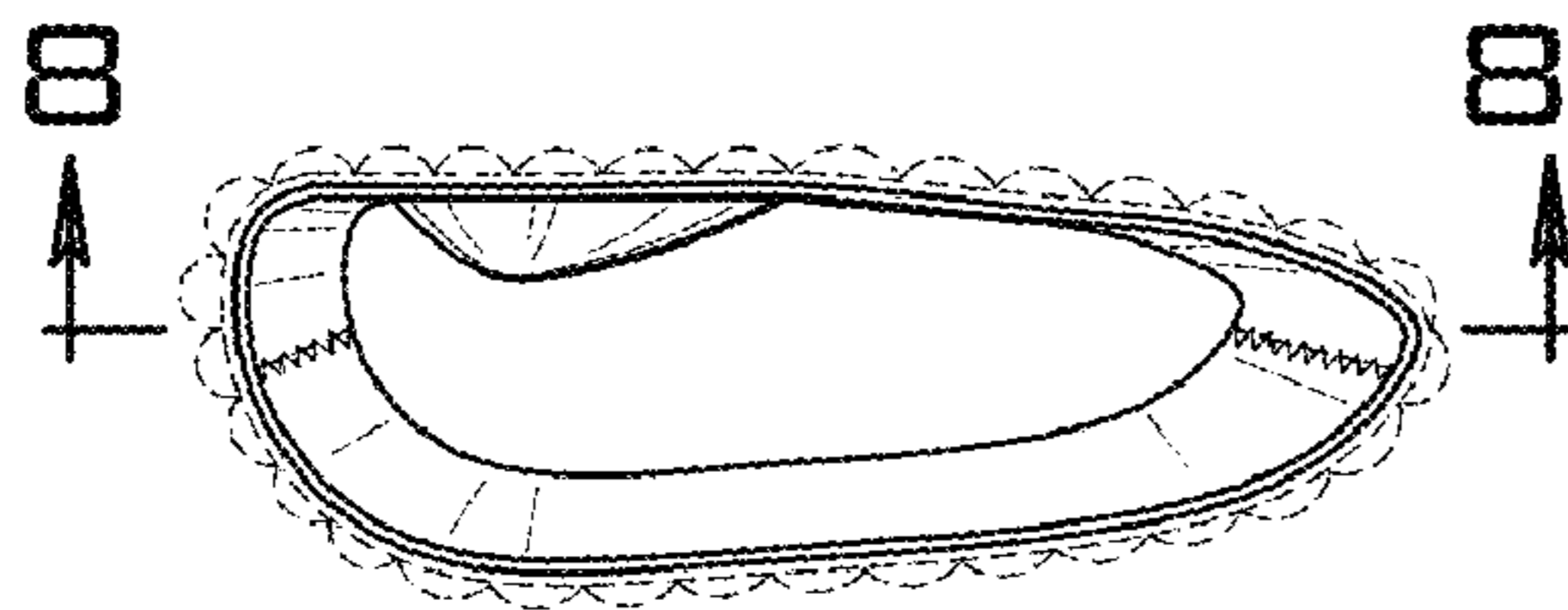

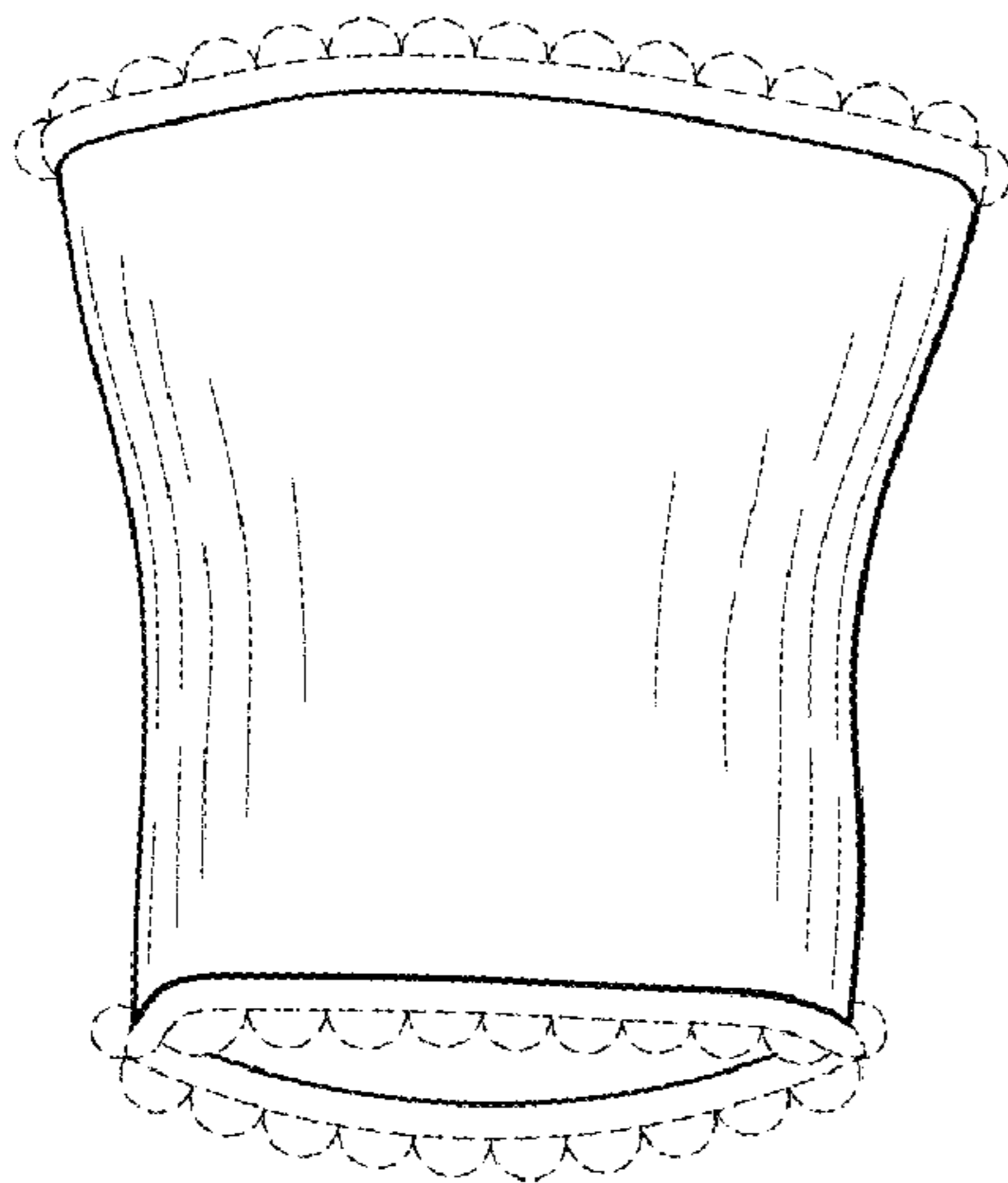

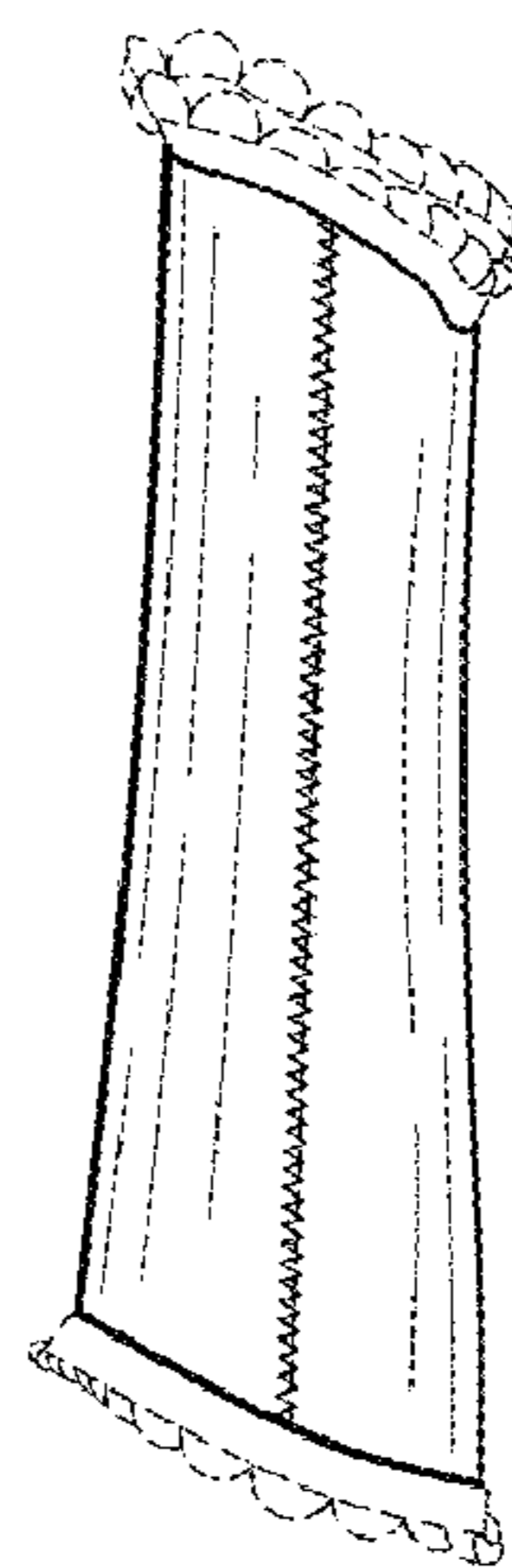

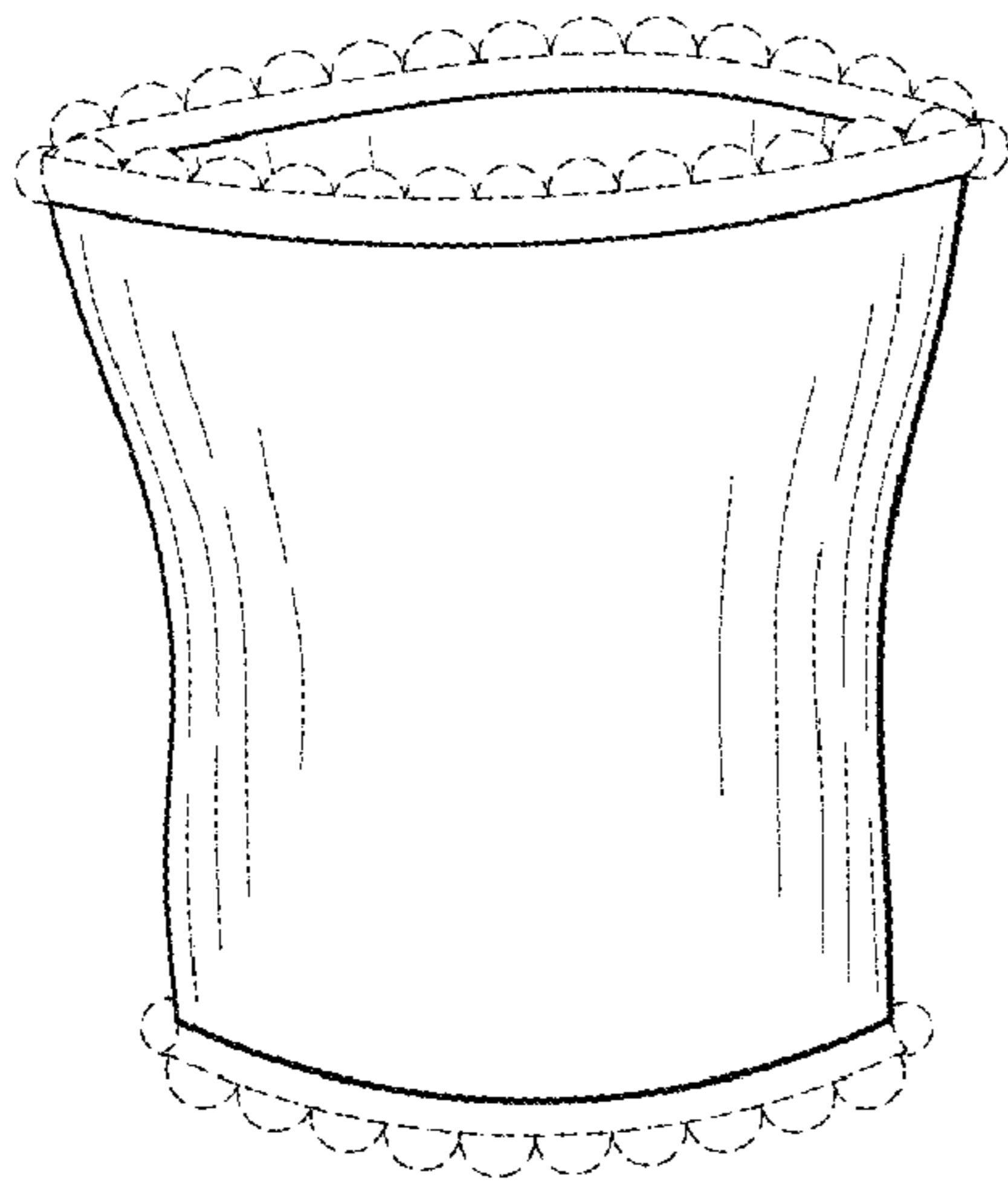

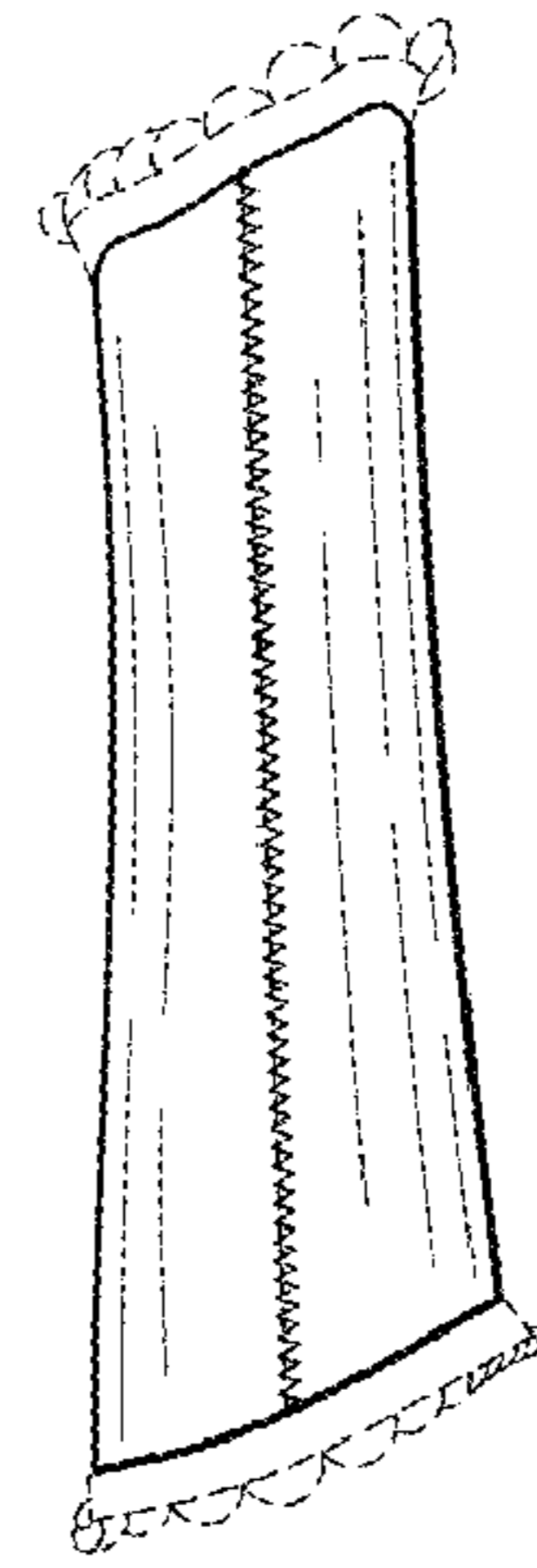

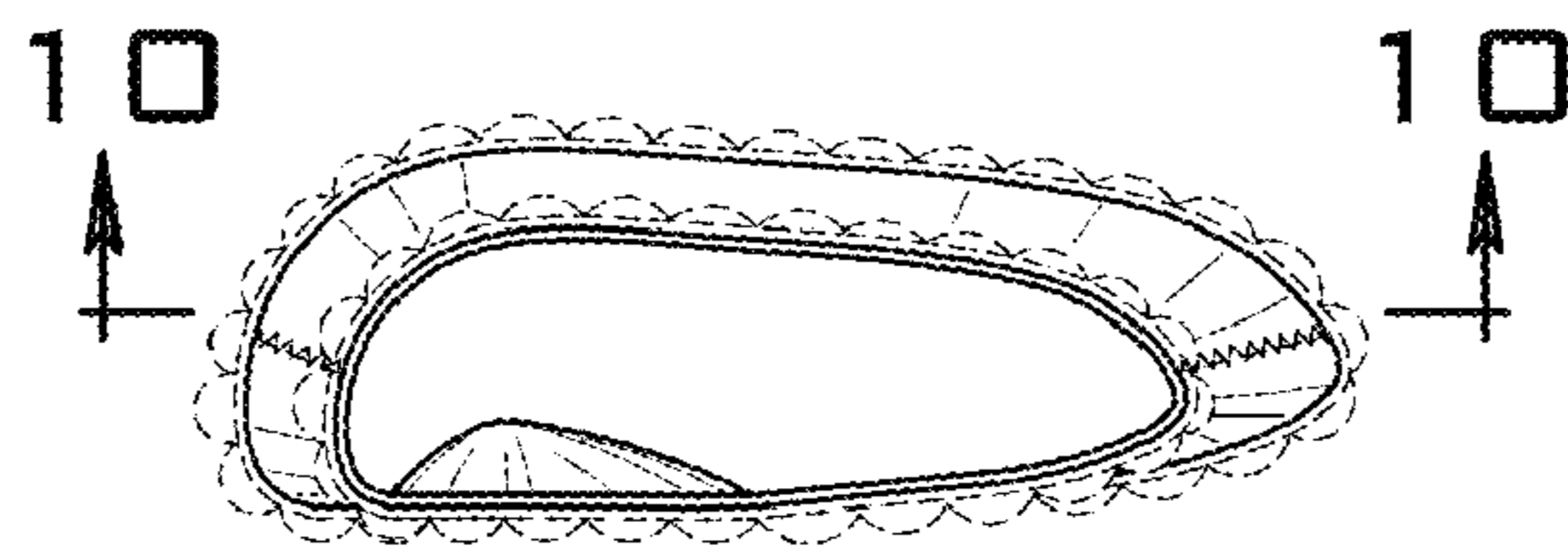

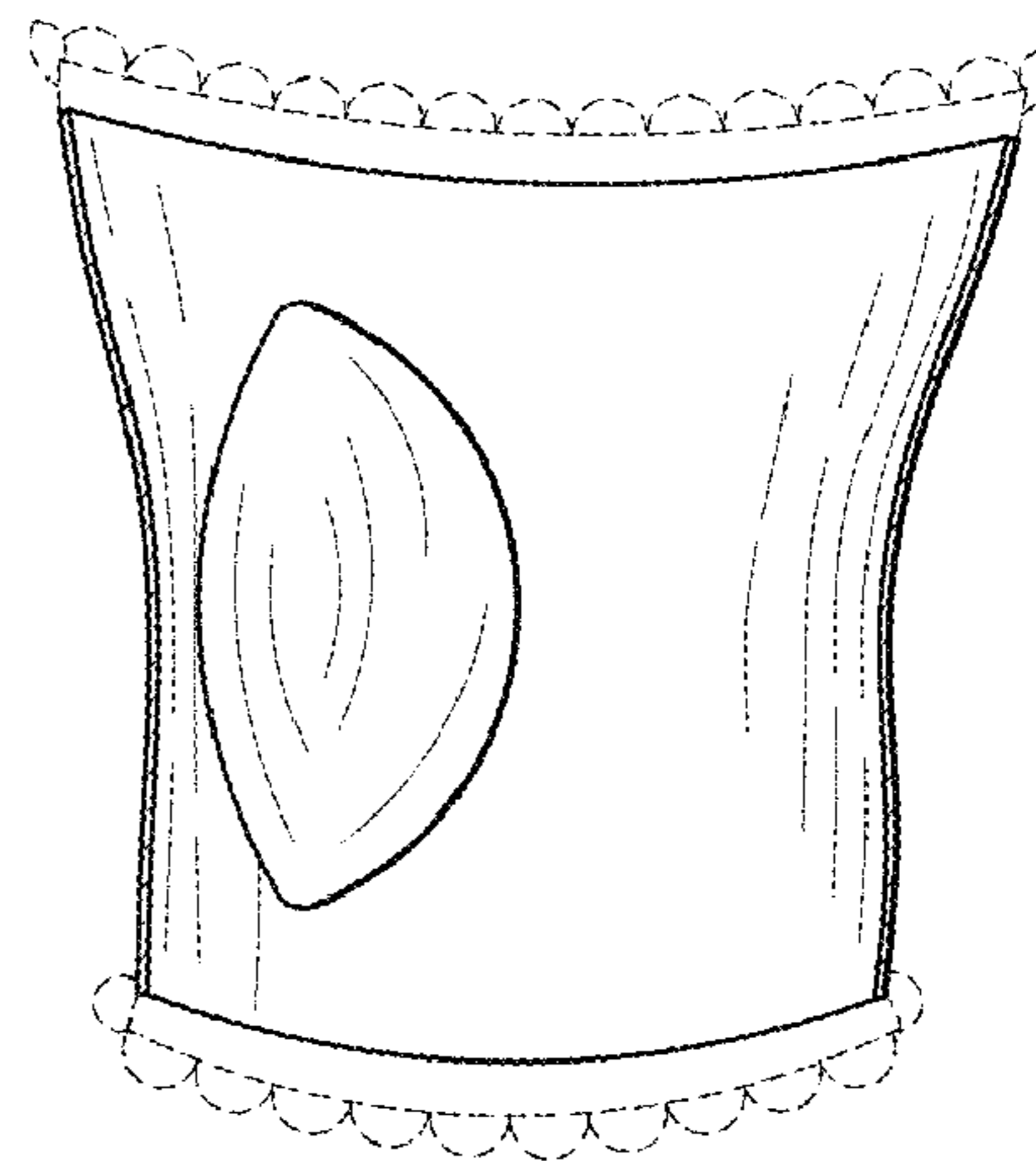

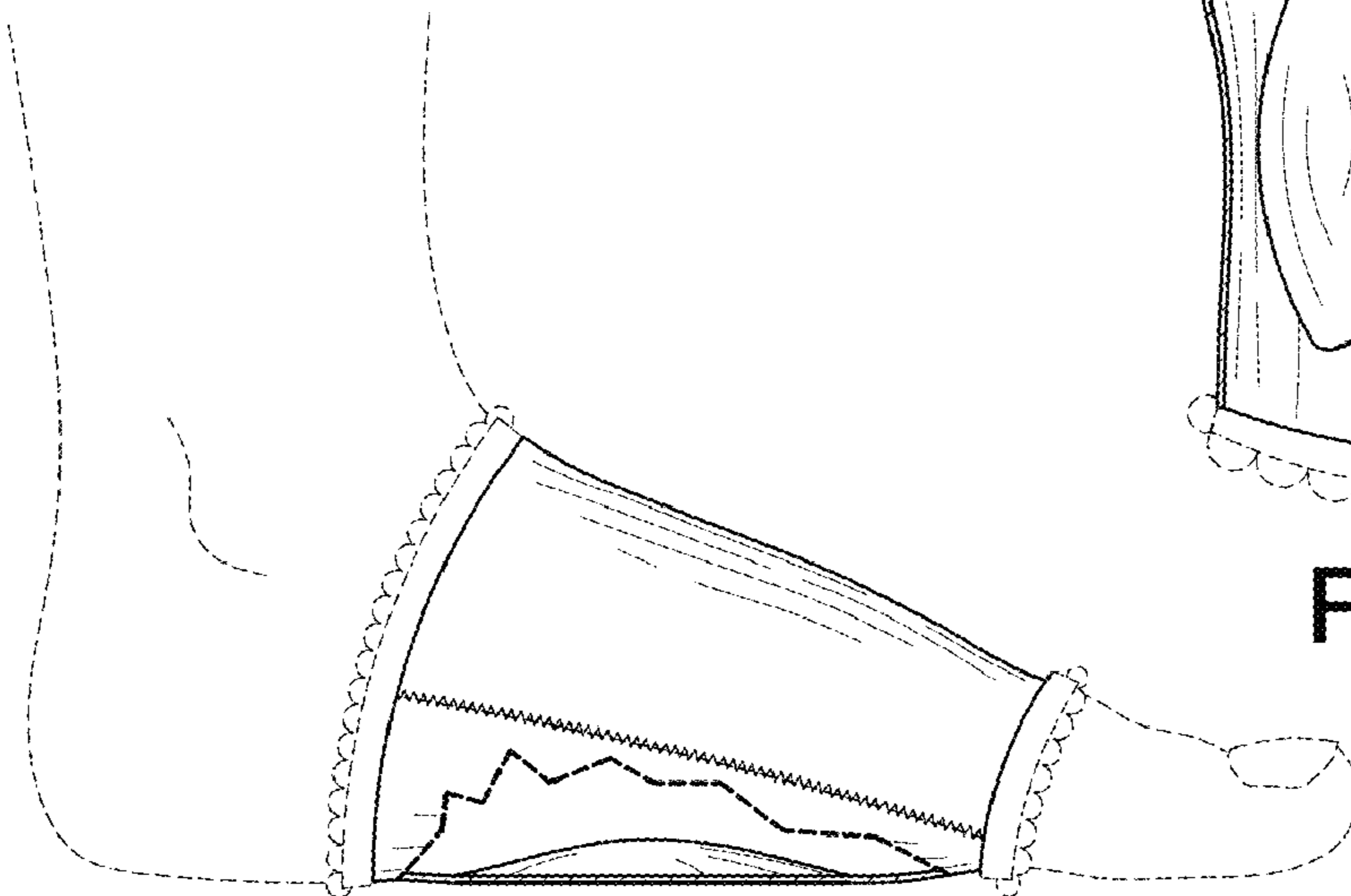

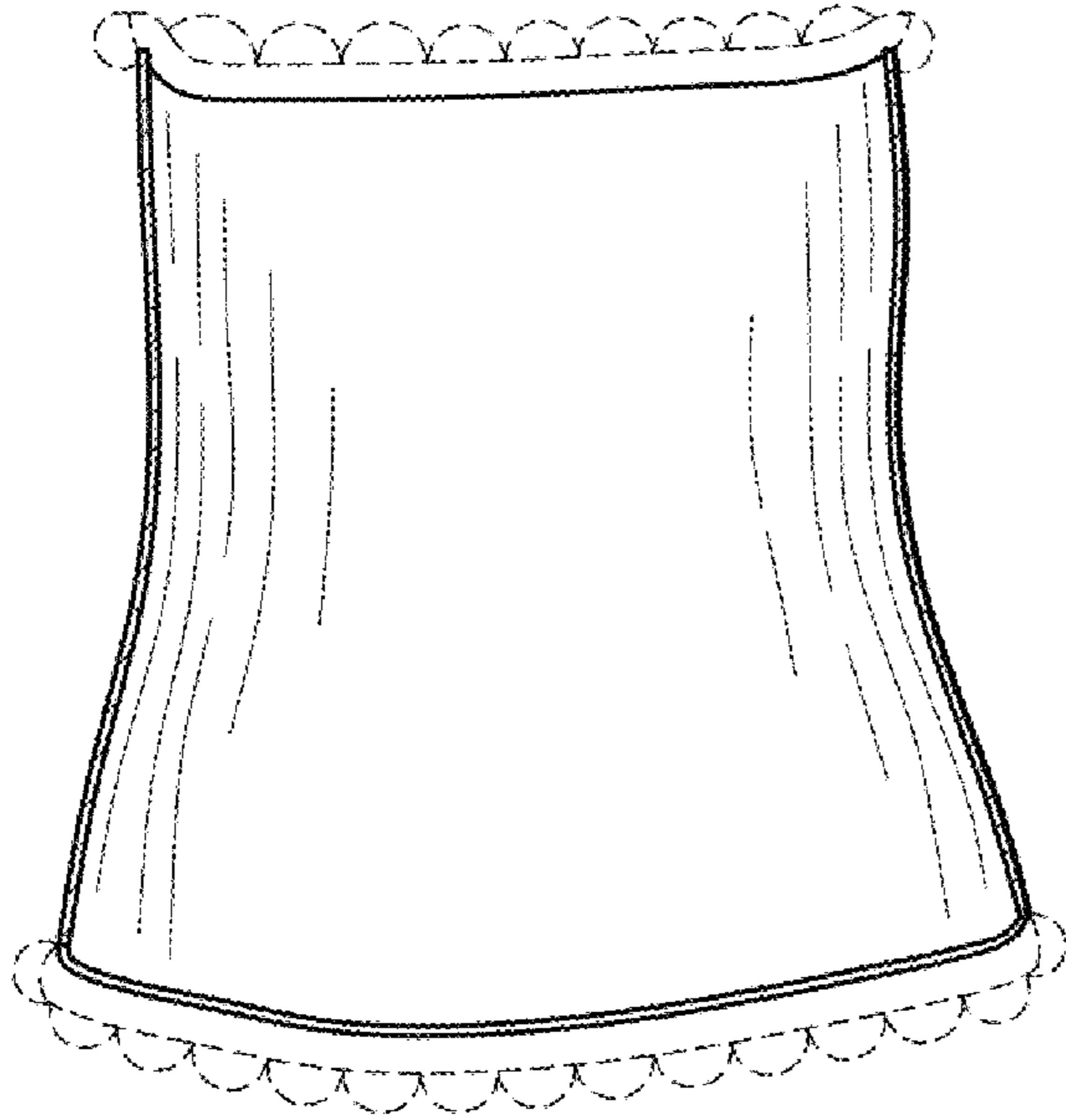

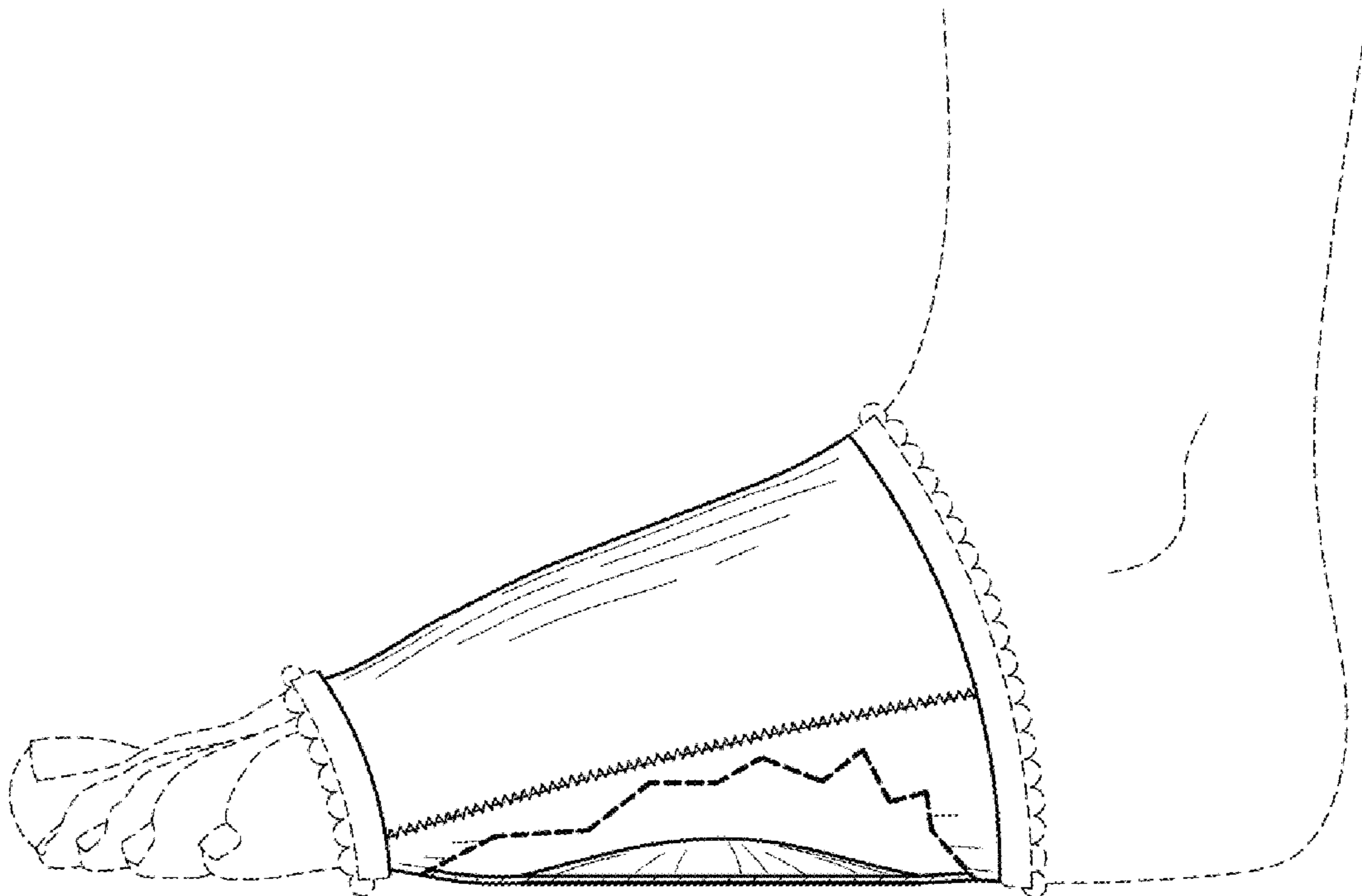
