The ornamental design for a light fixture, as shown and
described.

DESCRIPTION

FIG. 1 is a bottom perspective view of an embodiment of a
light fixture.

FIG. 2 is a bottom plan view of the light fixture of FIG. 1.

FIG. 3 is a top plan view of the light fixture of FIG. 1.

FIG. 4 is a right side elevation view of the light fixture of FIG.

of a light fixture.

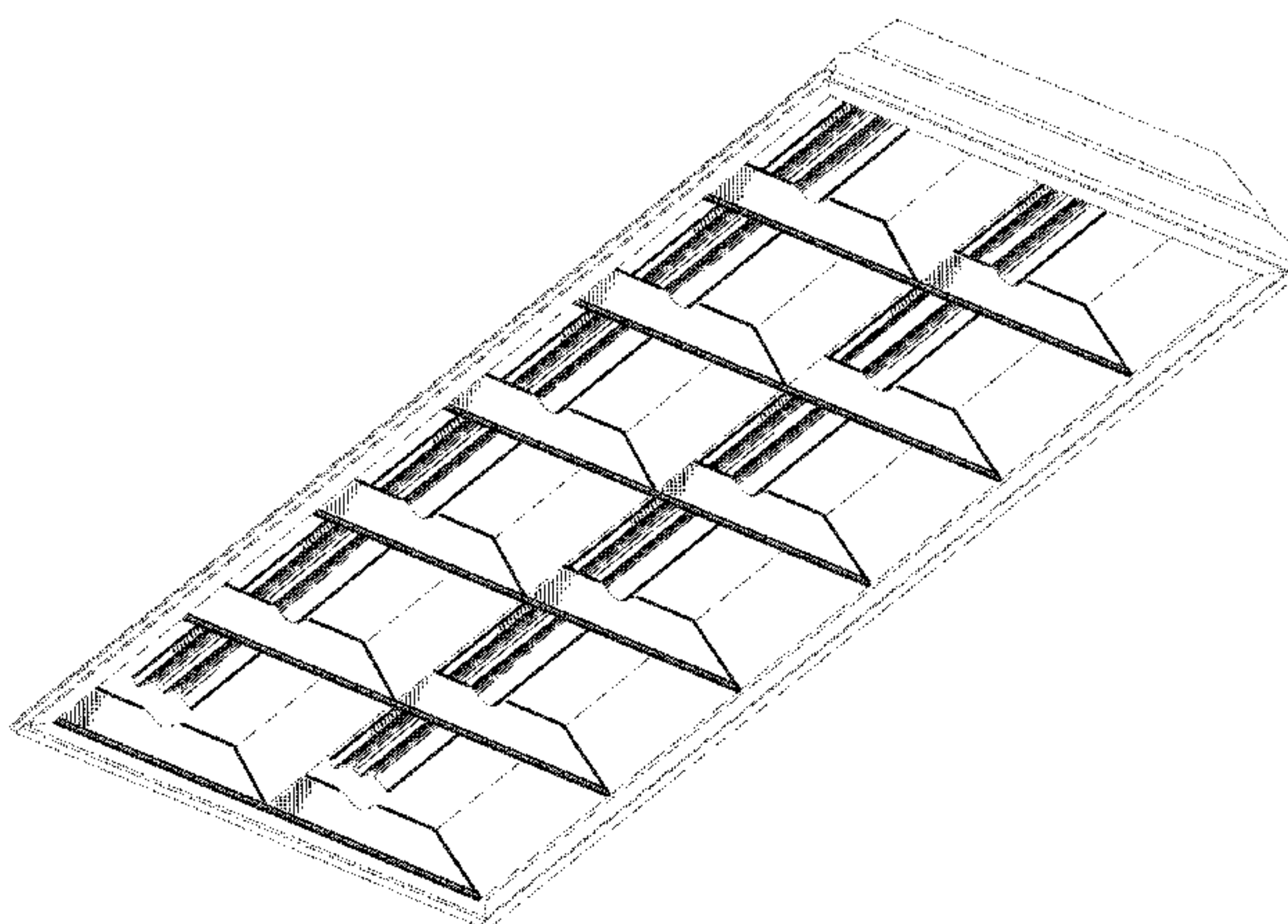


FIG. 11 is a bottom plan view of the light fixture of FIG. 10.

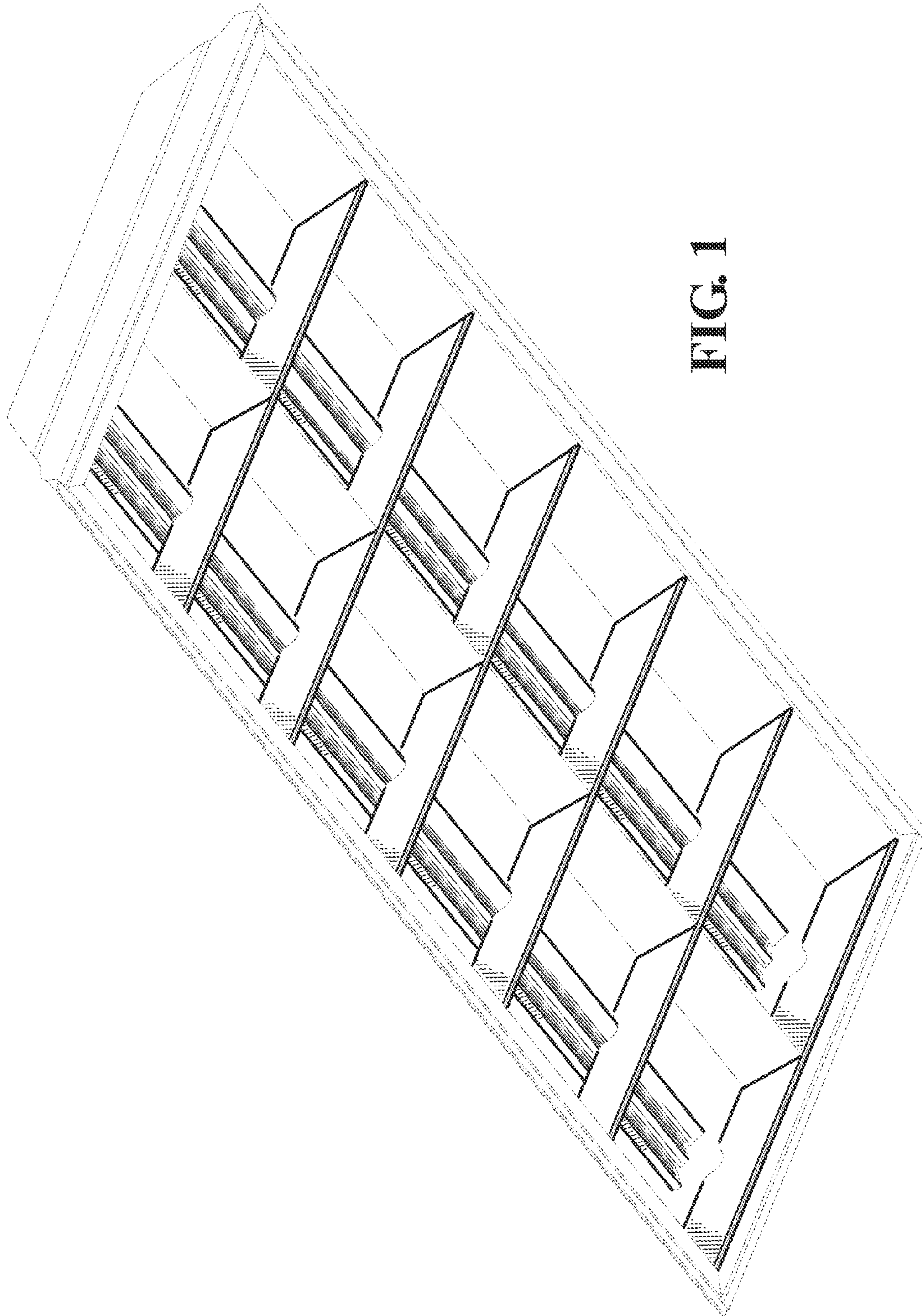

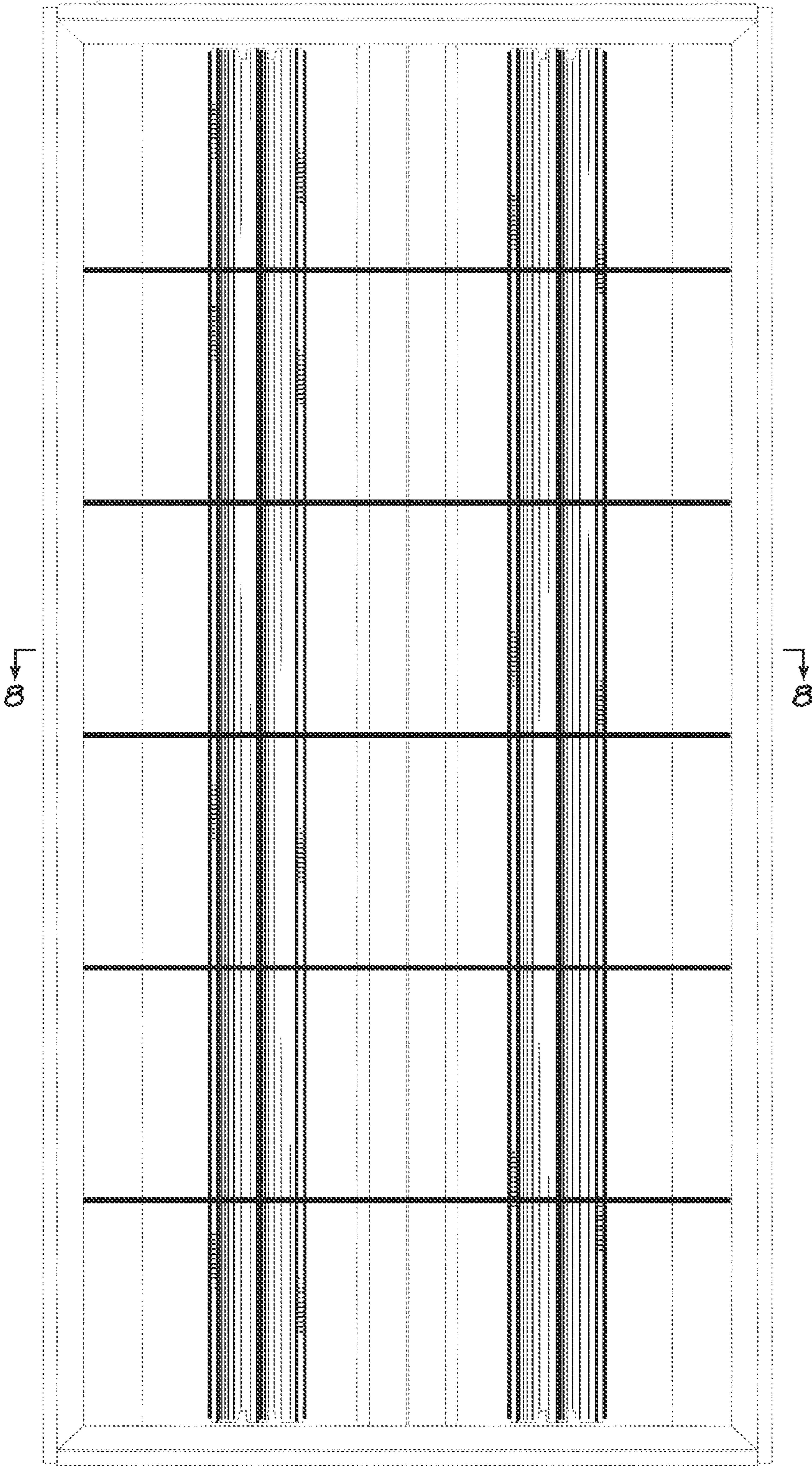
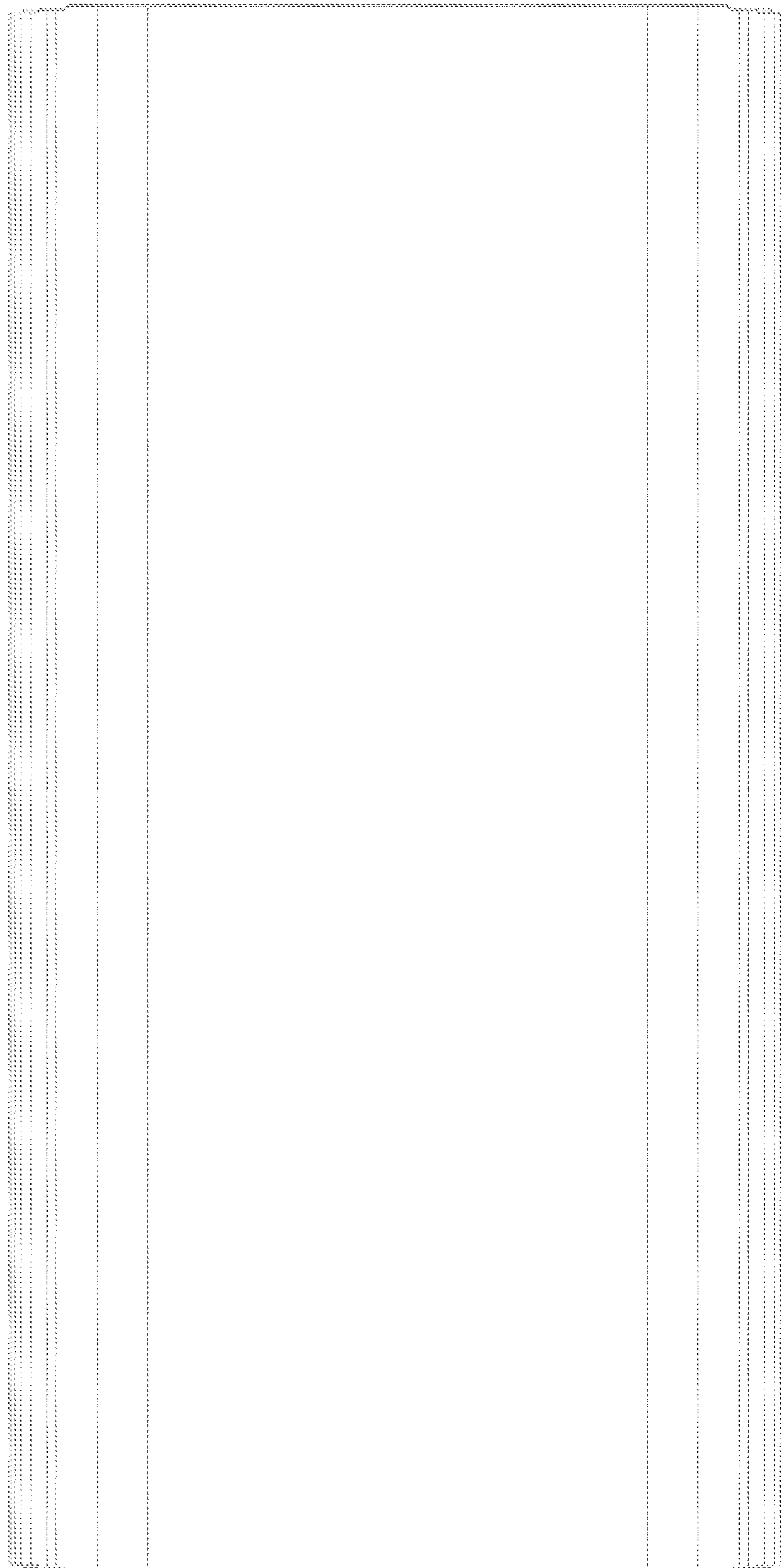

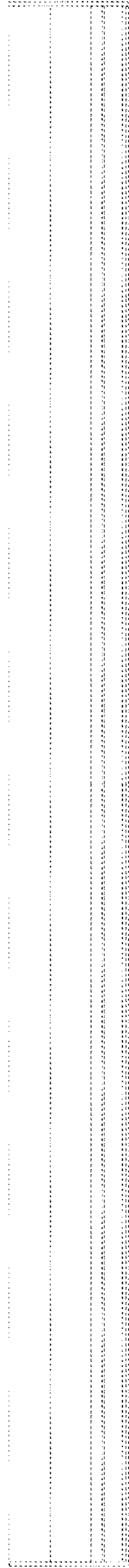

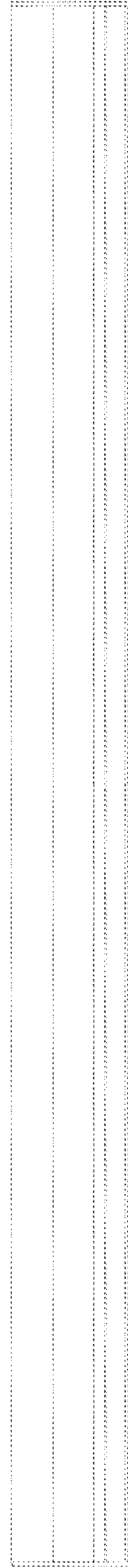

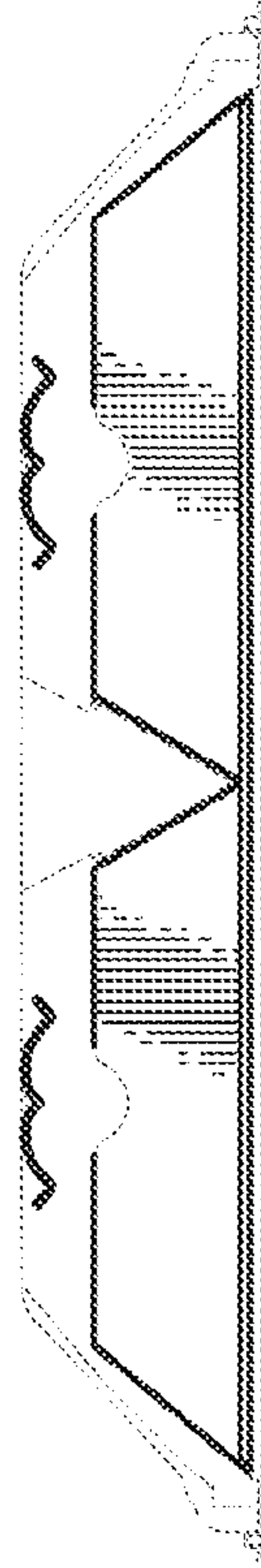

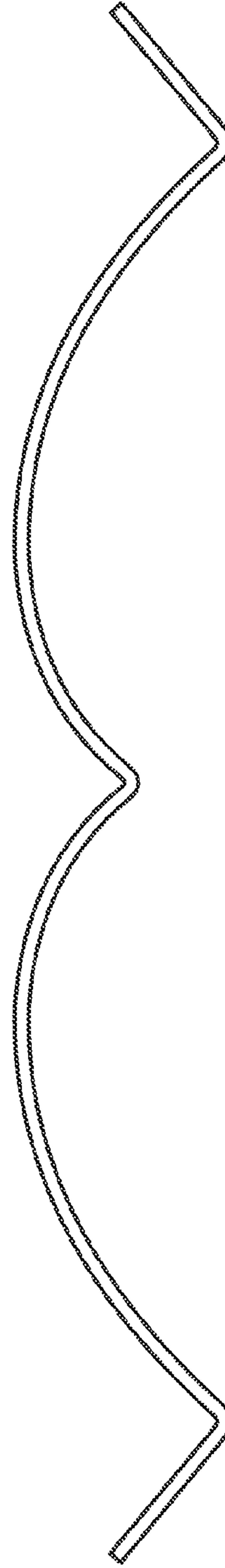

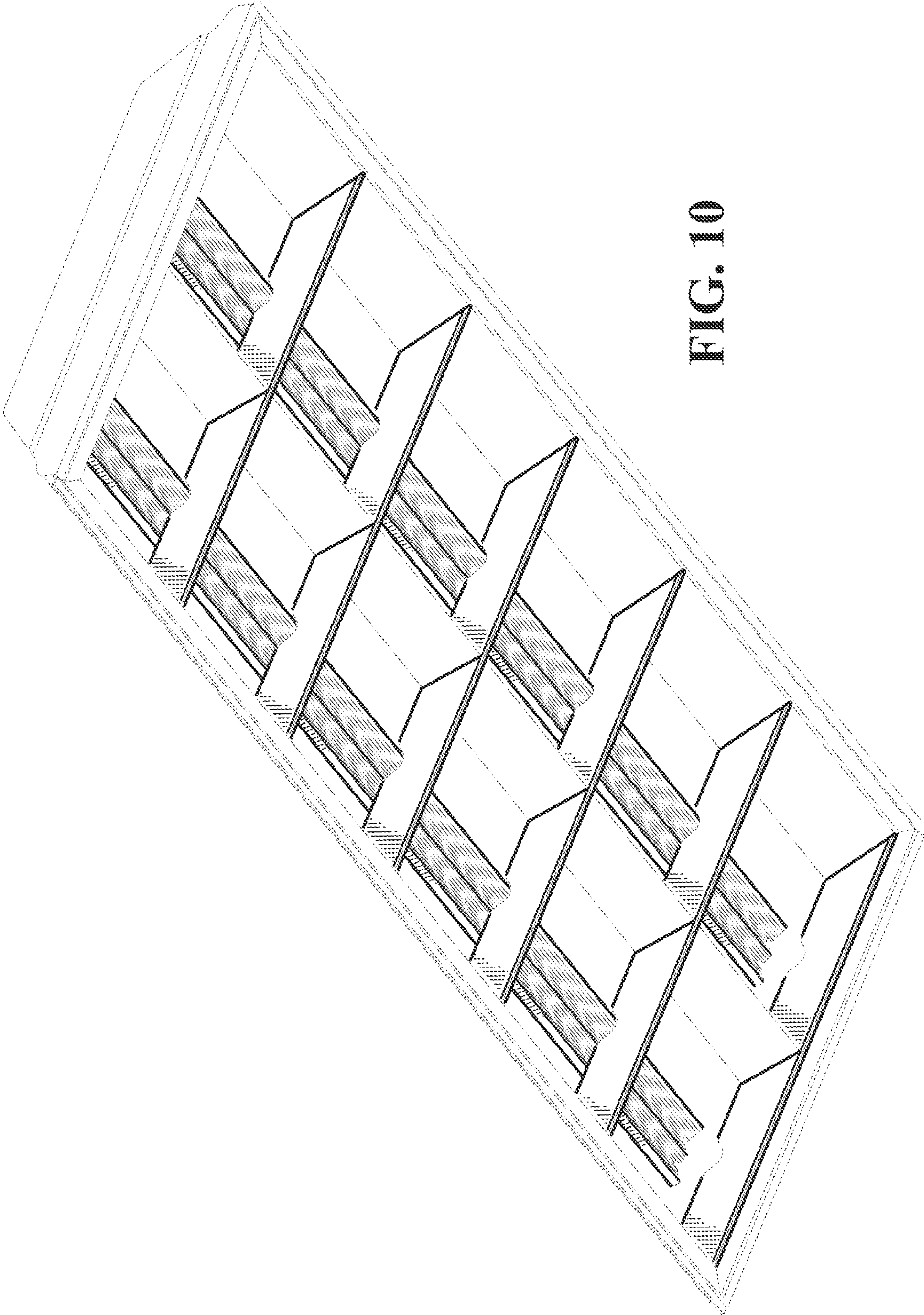

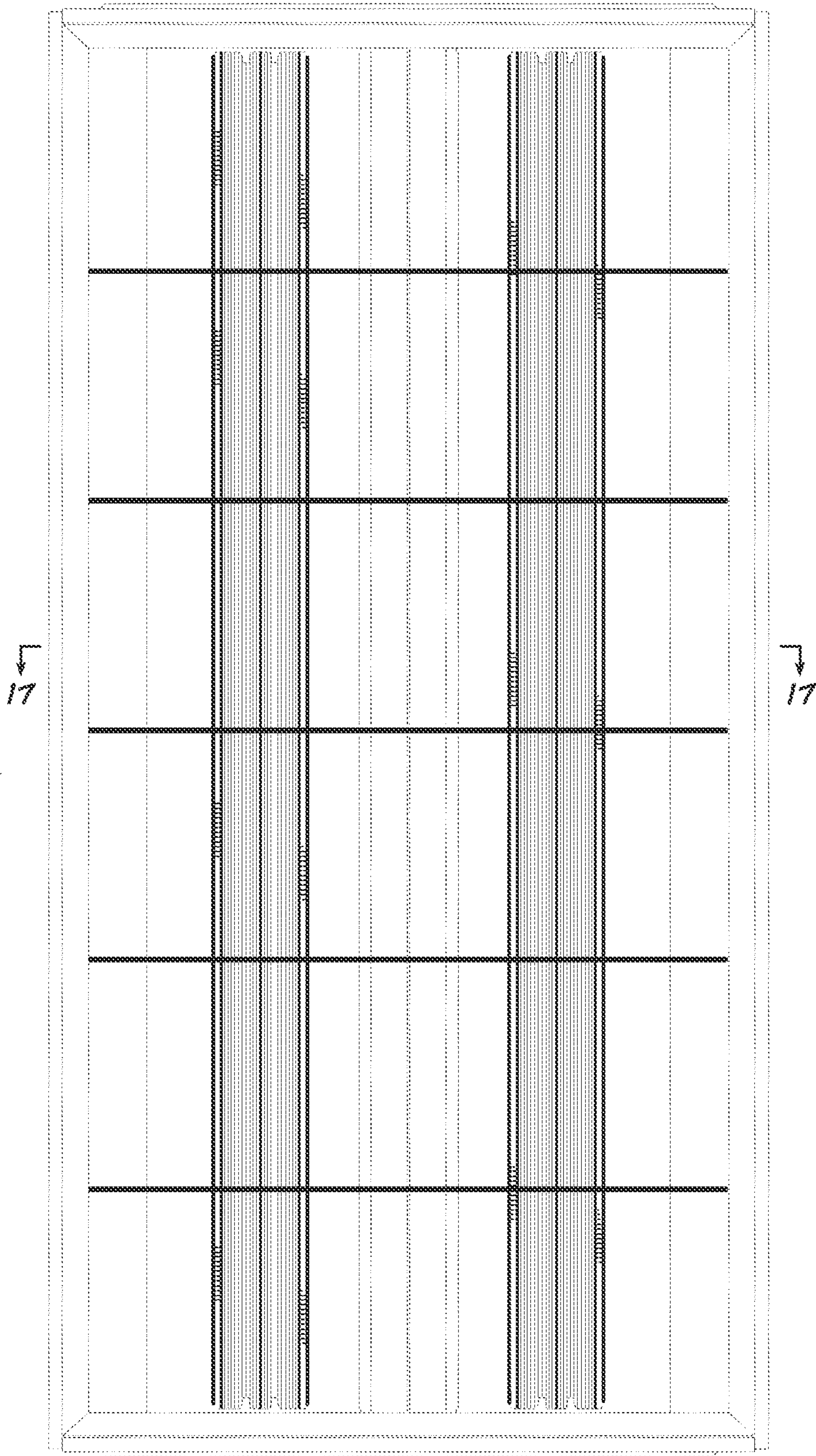
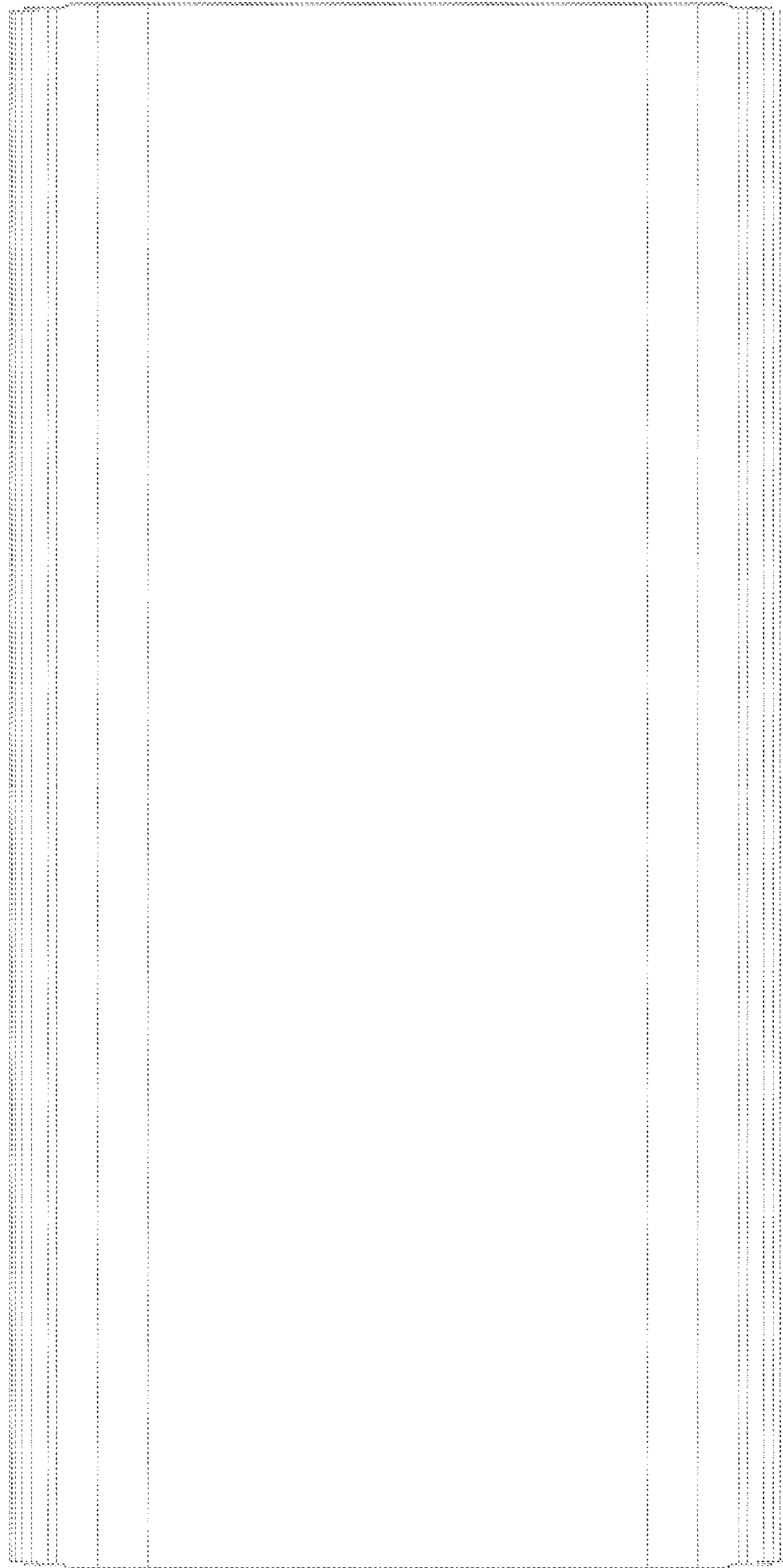

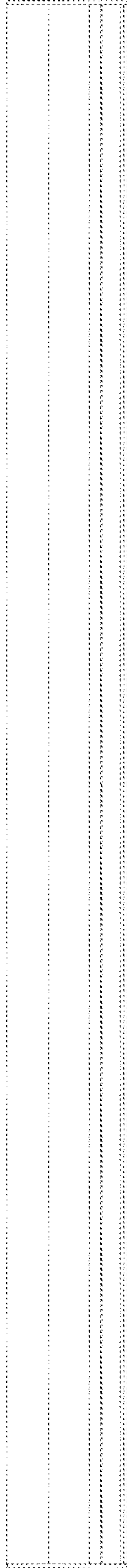

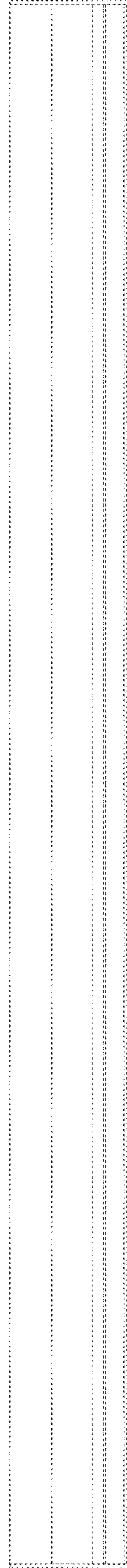

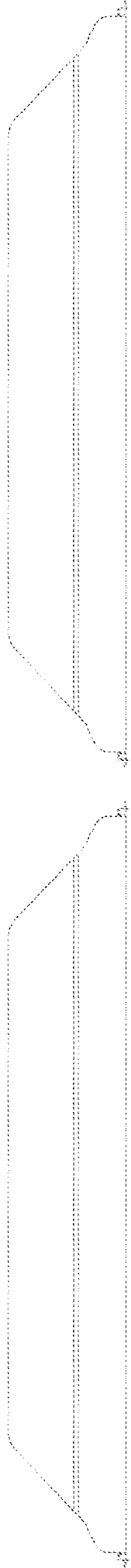

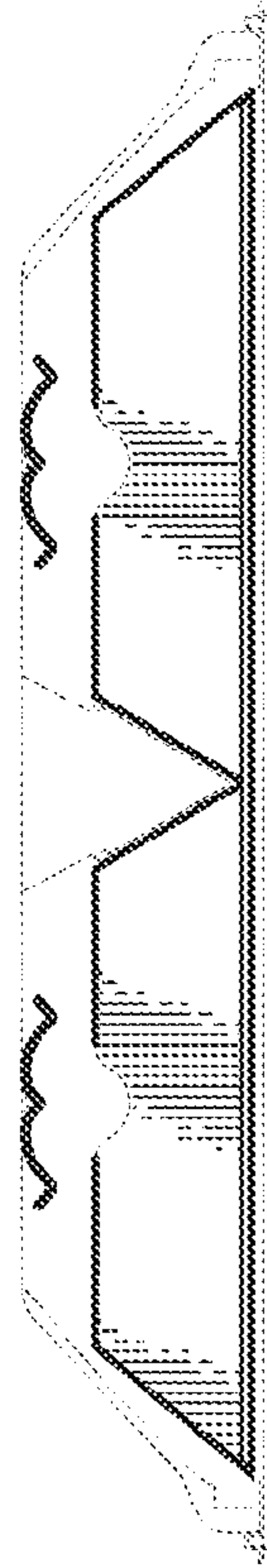

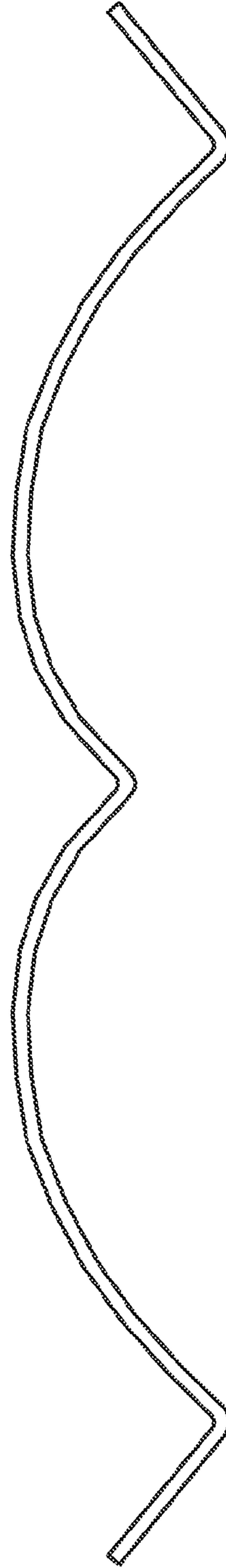

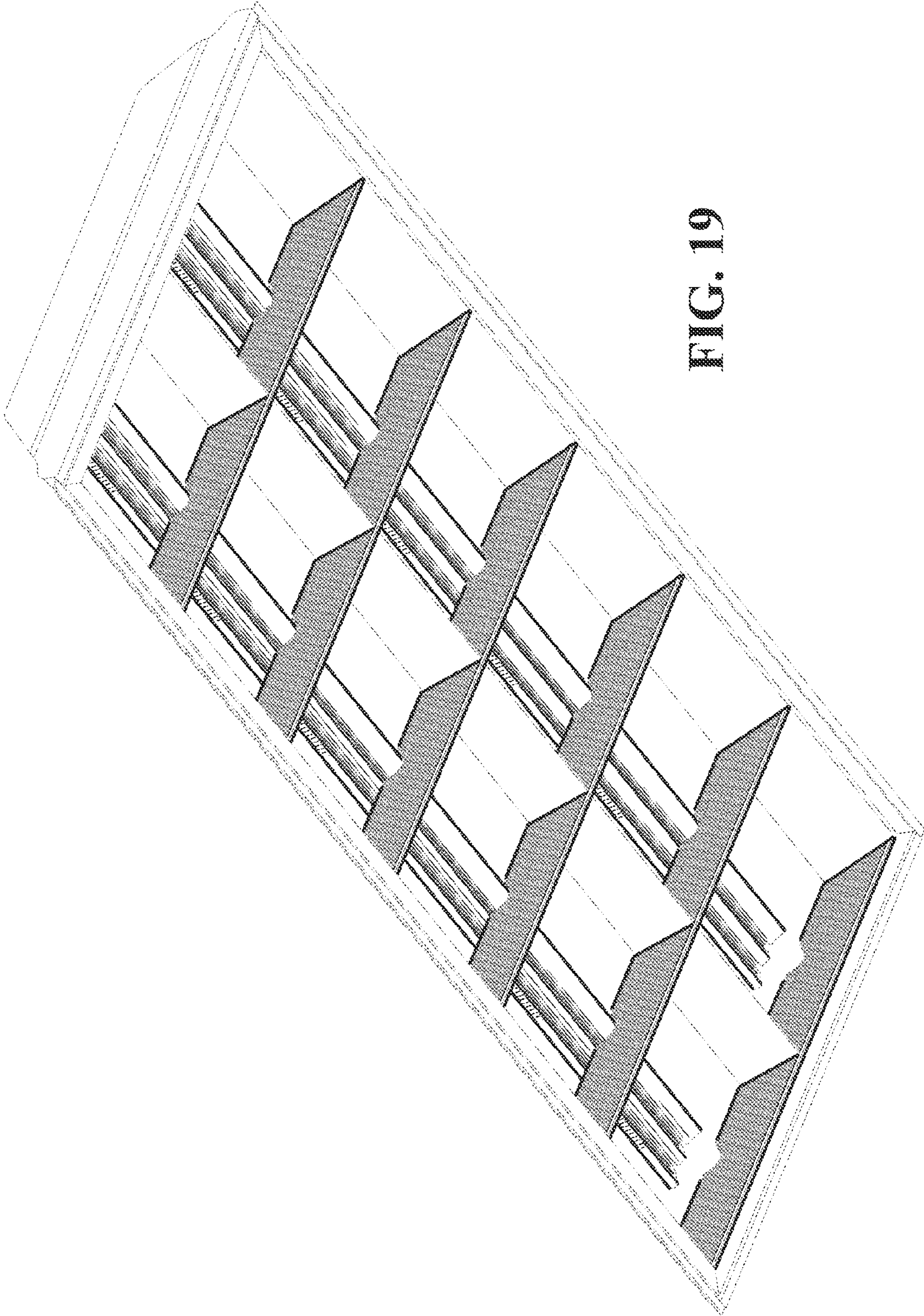

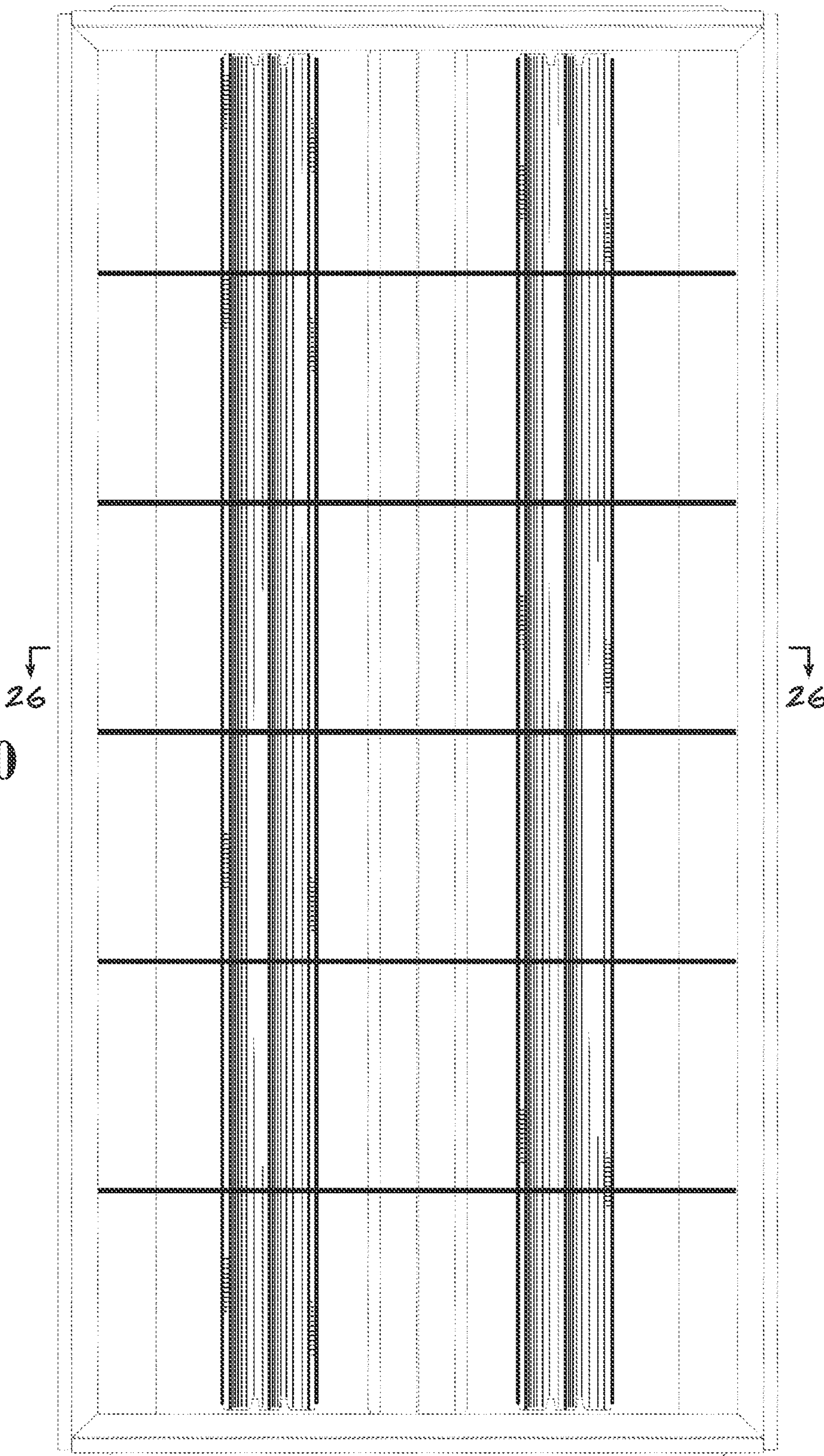
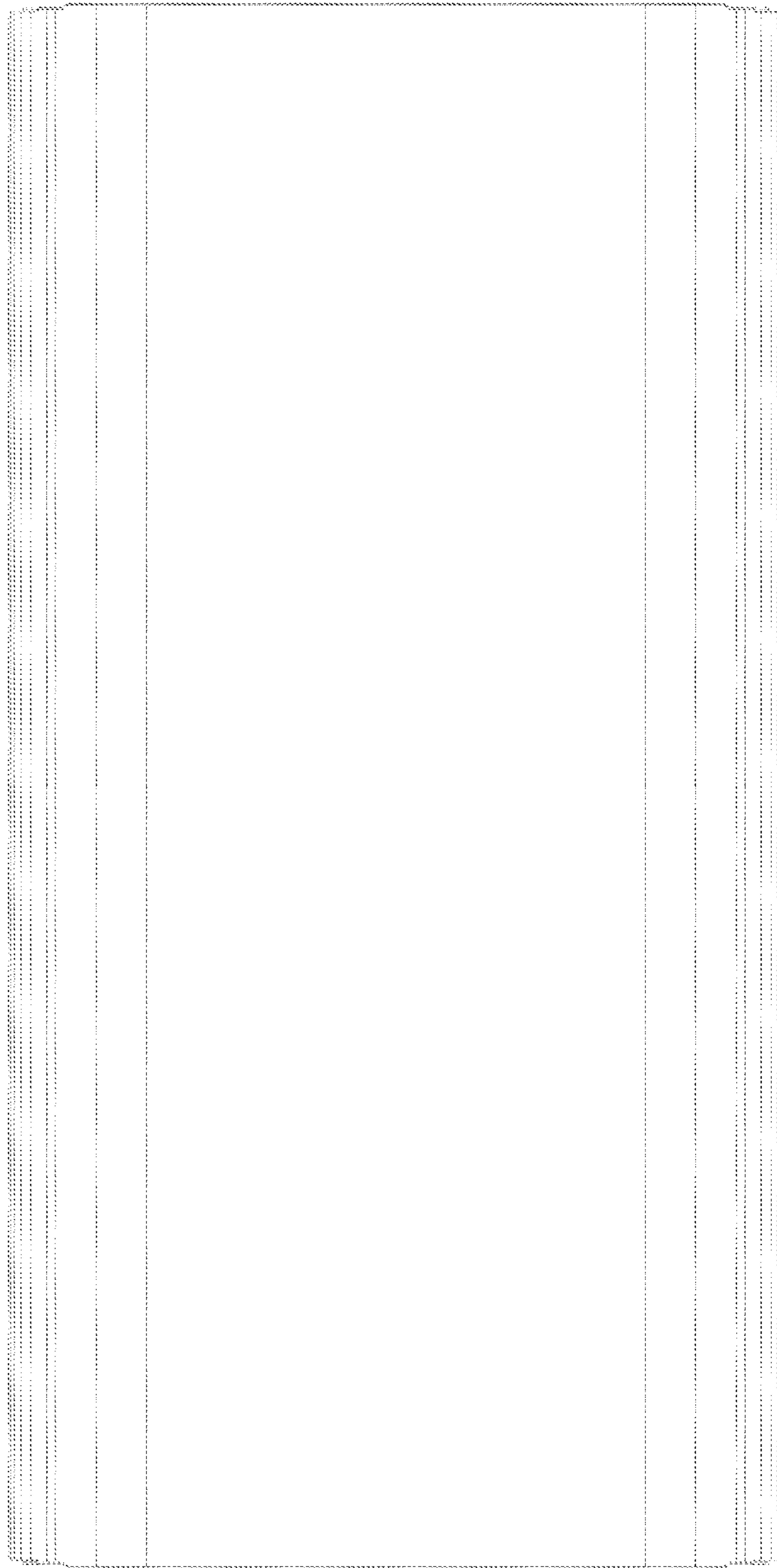

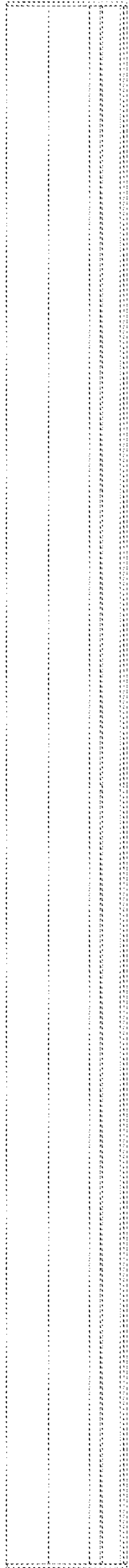

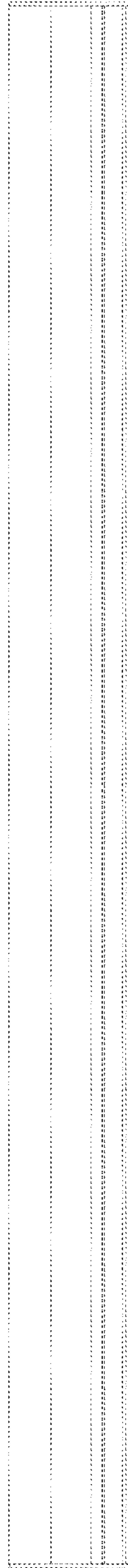

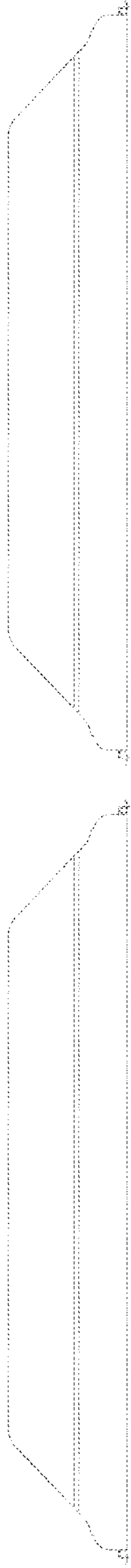

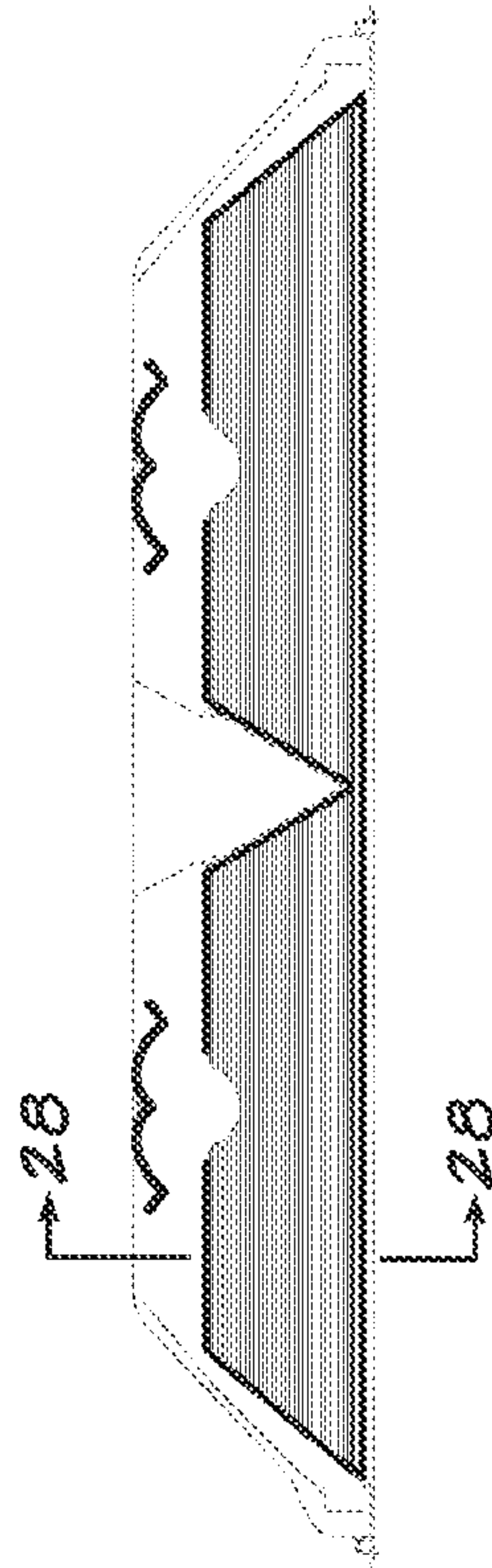
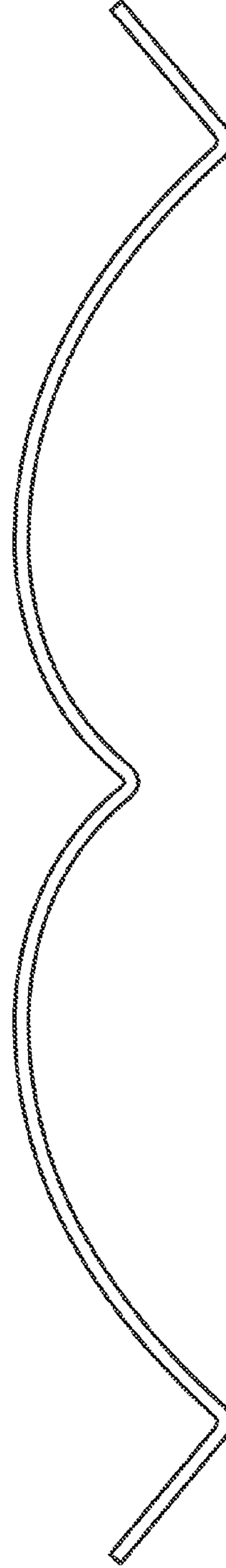

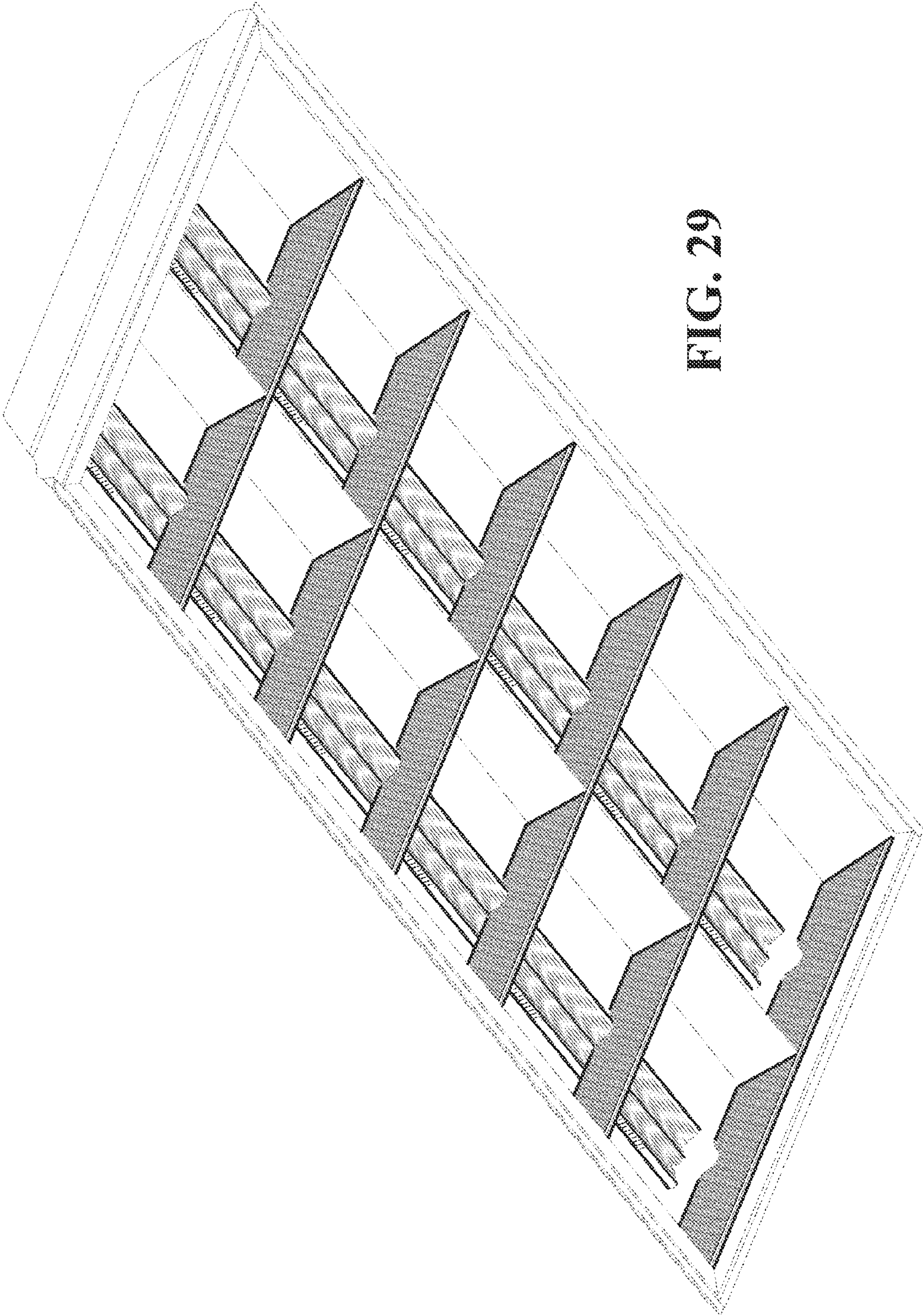

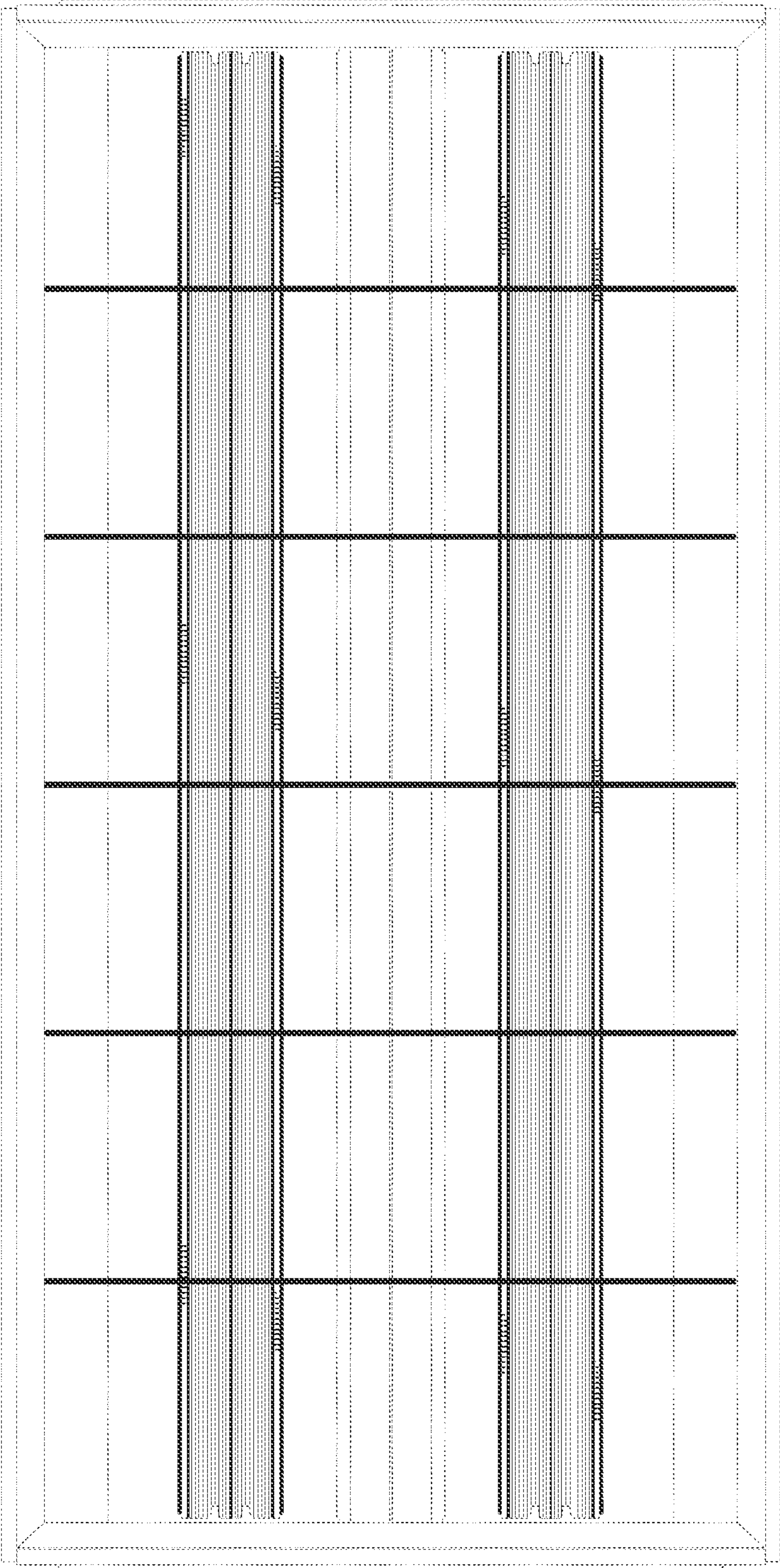

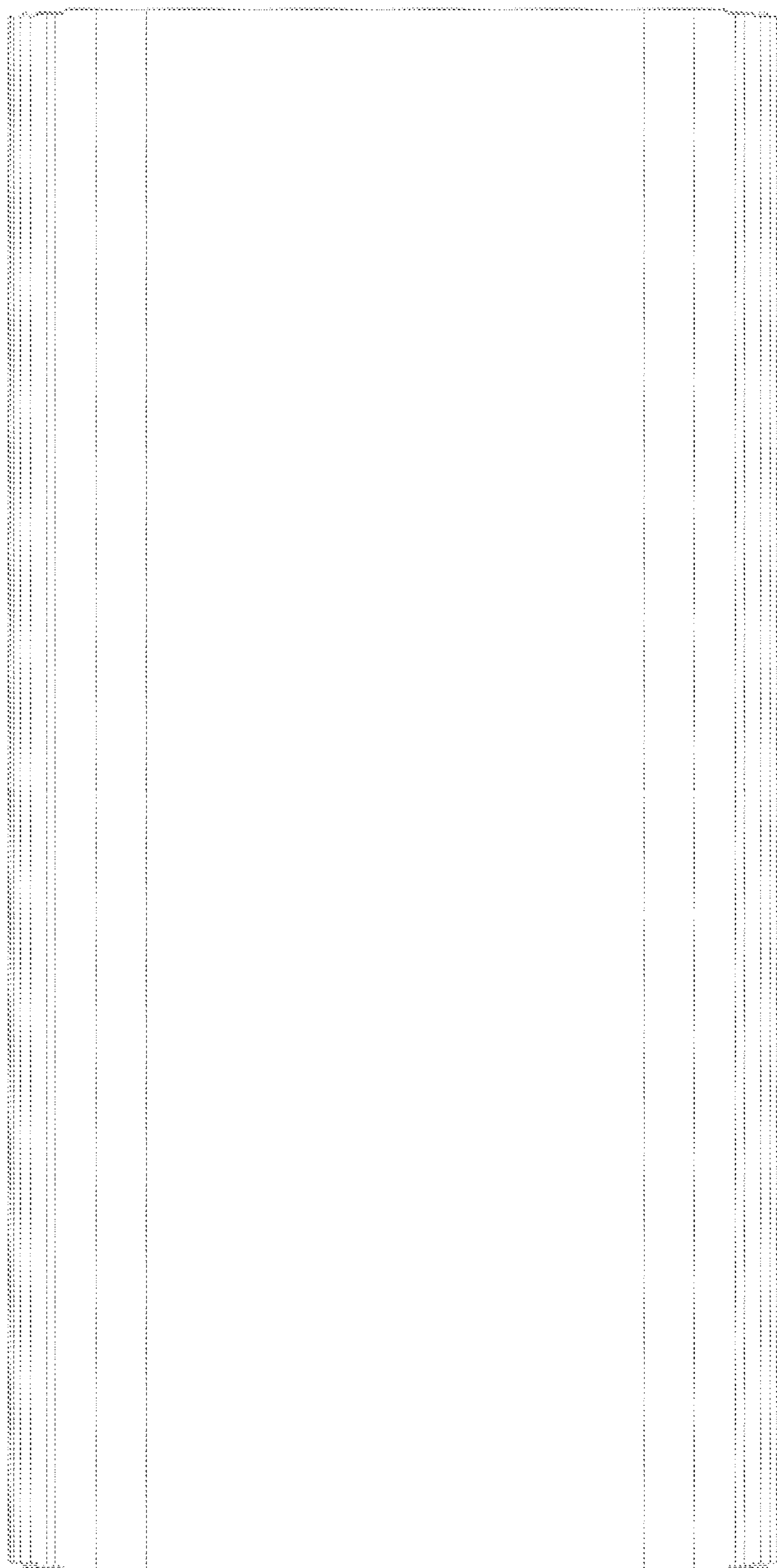

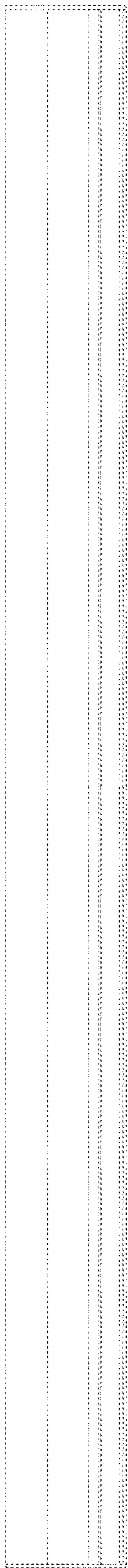

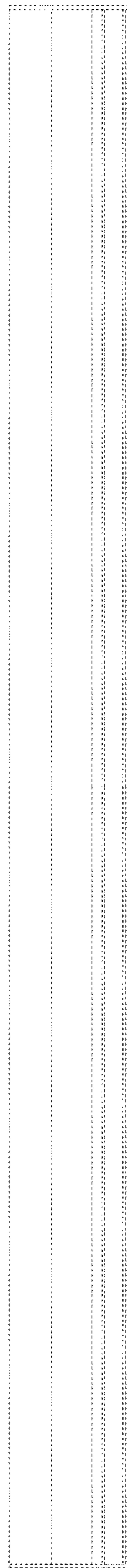

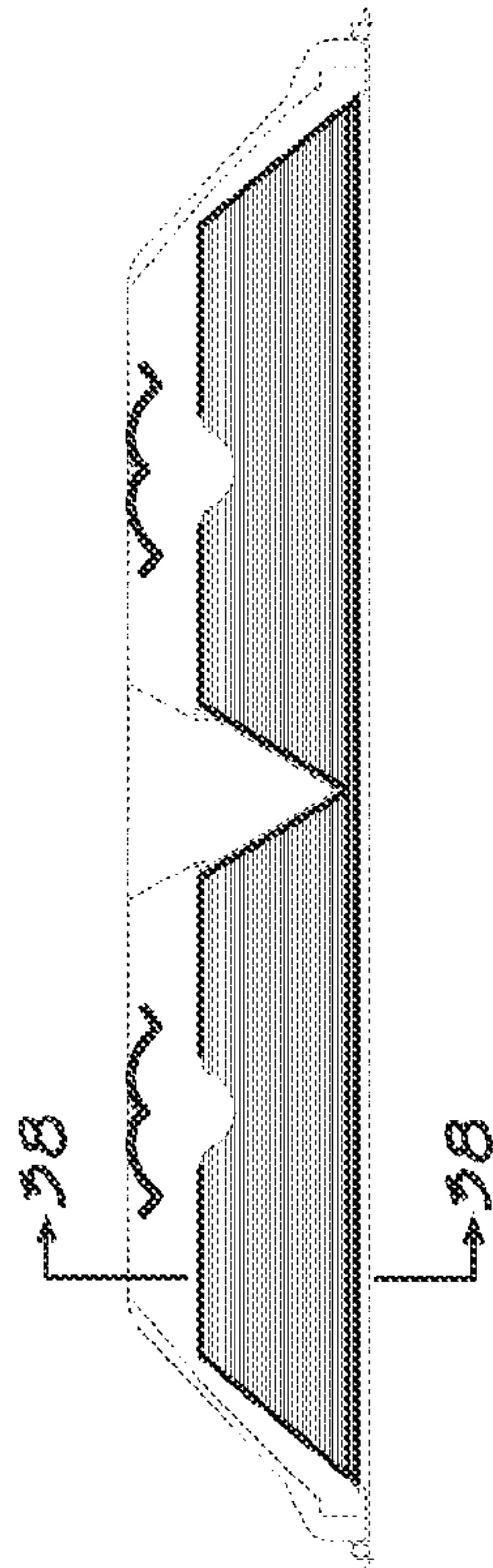
