FIG. 4 is a left side view of same;

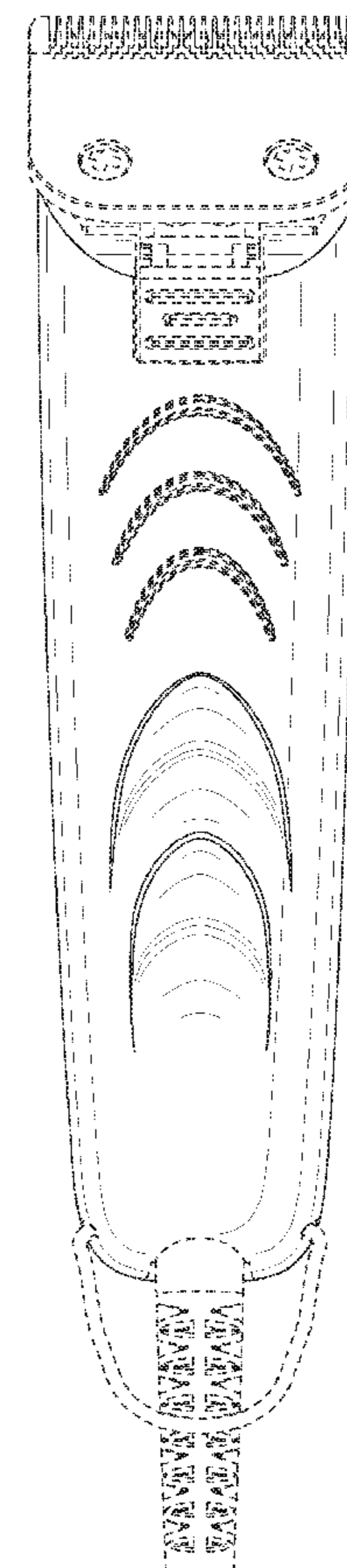
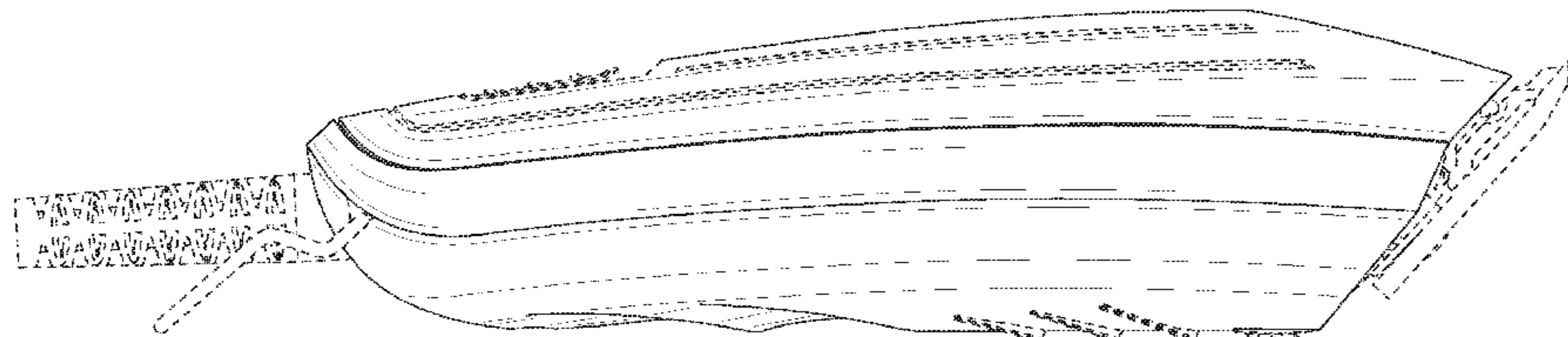
FIG. 5 is a right side of the housing of FIG. 1;

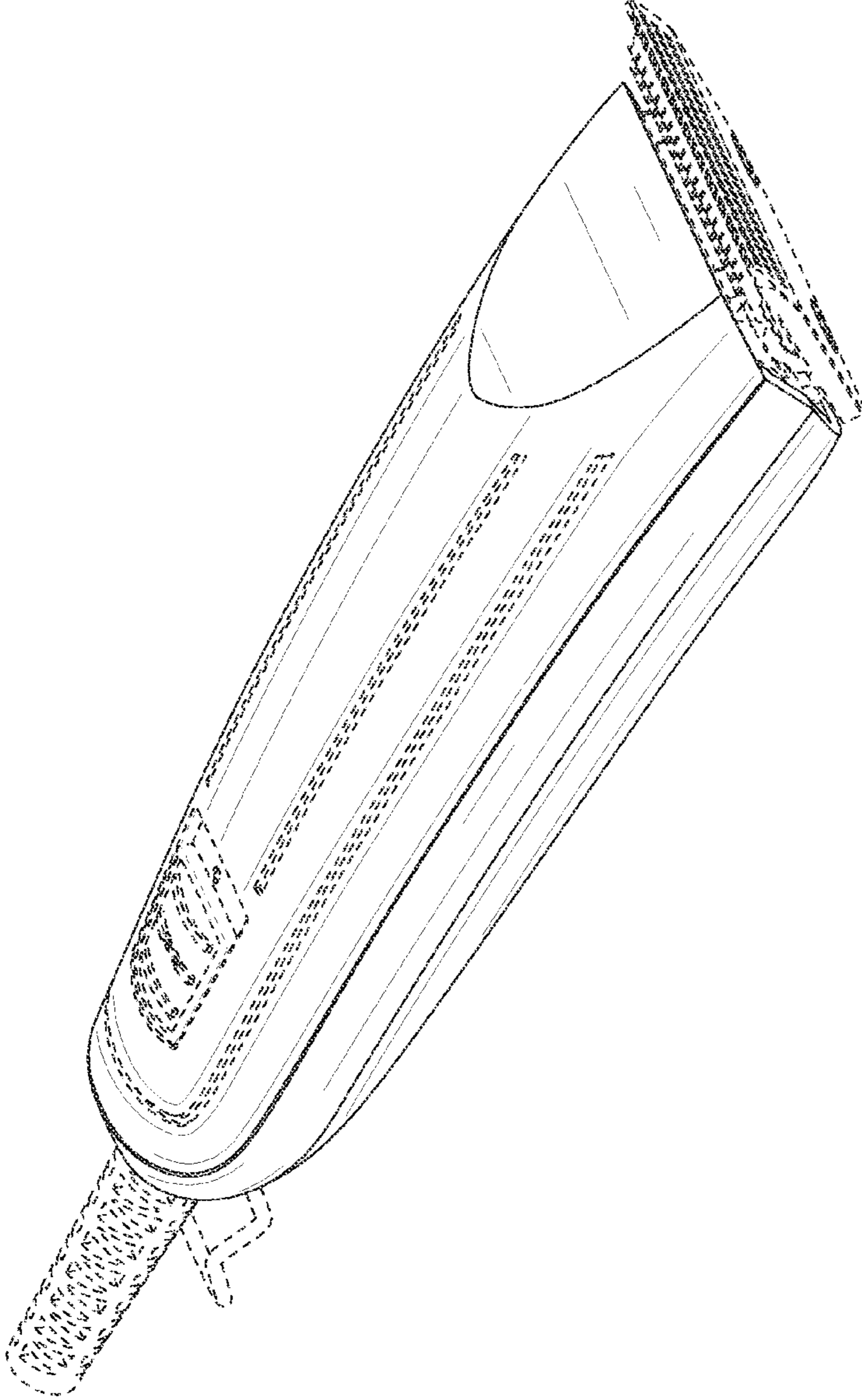

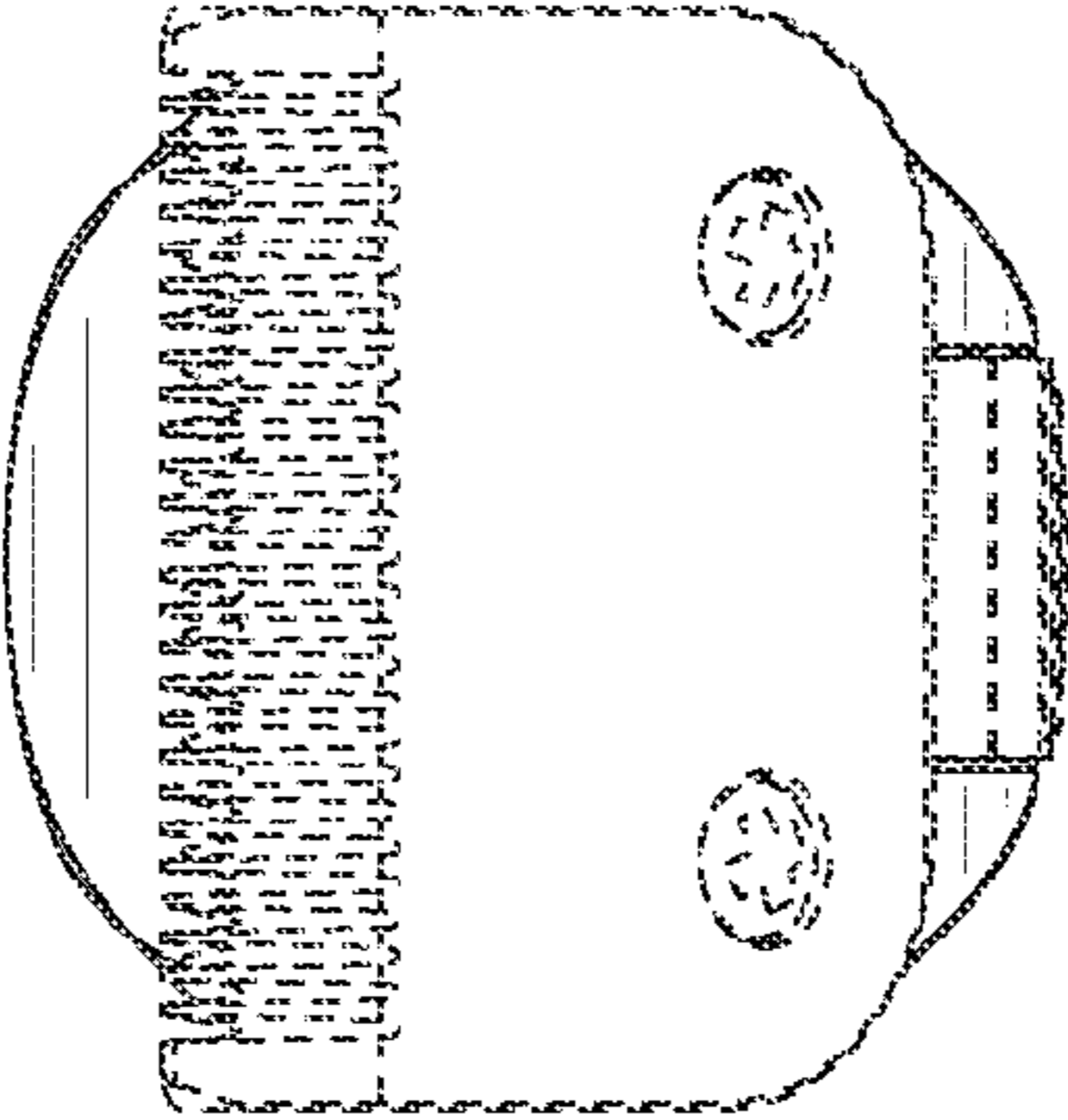

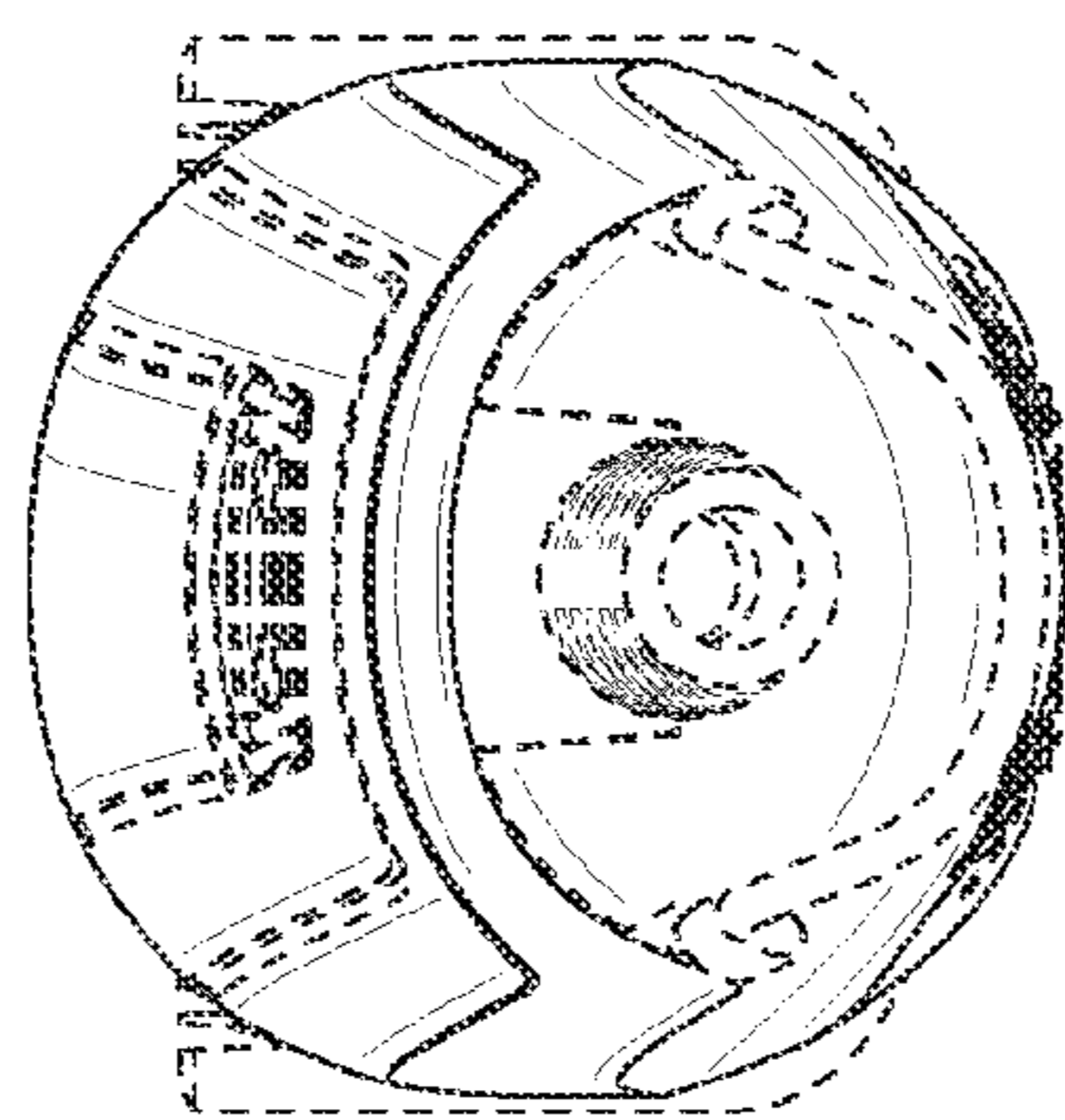

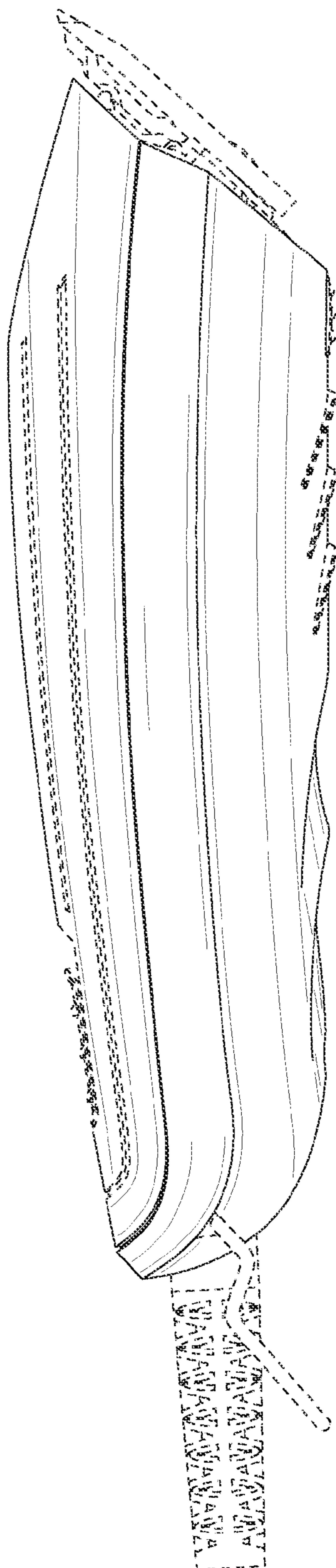

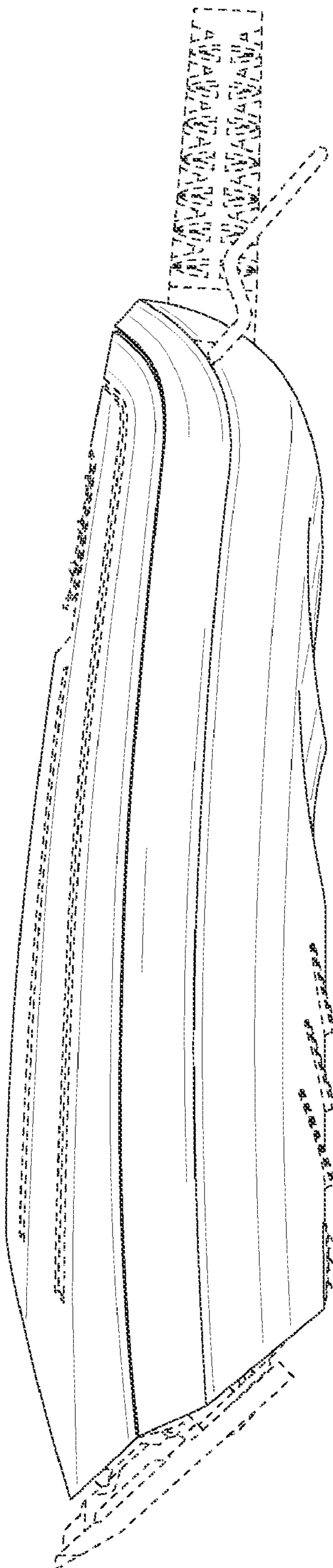

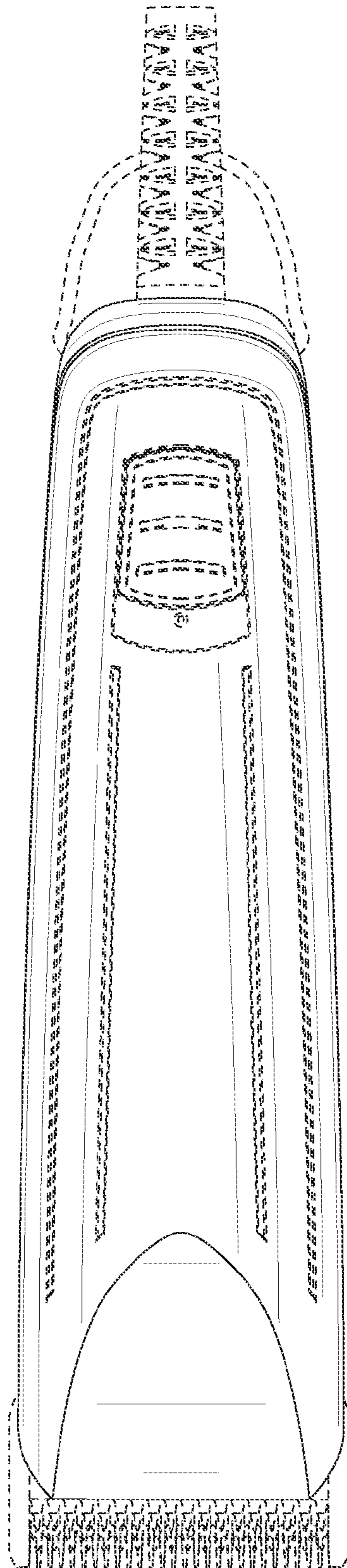

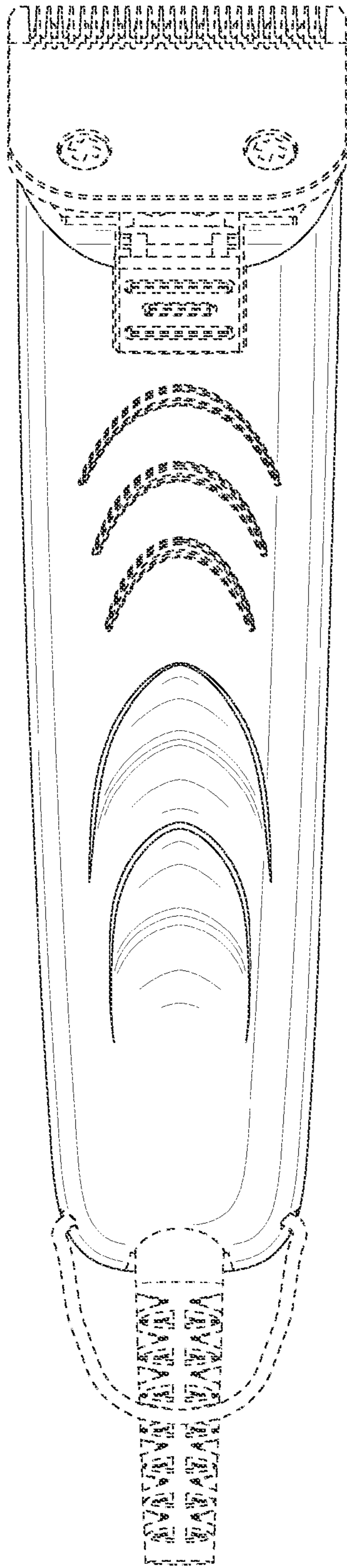
