FIG. 3. is a rear elevation view thereof; showing our new design.

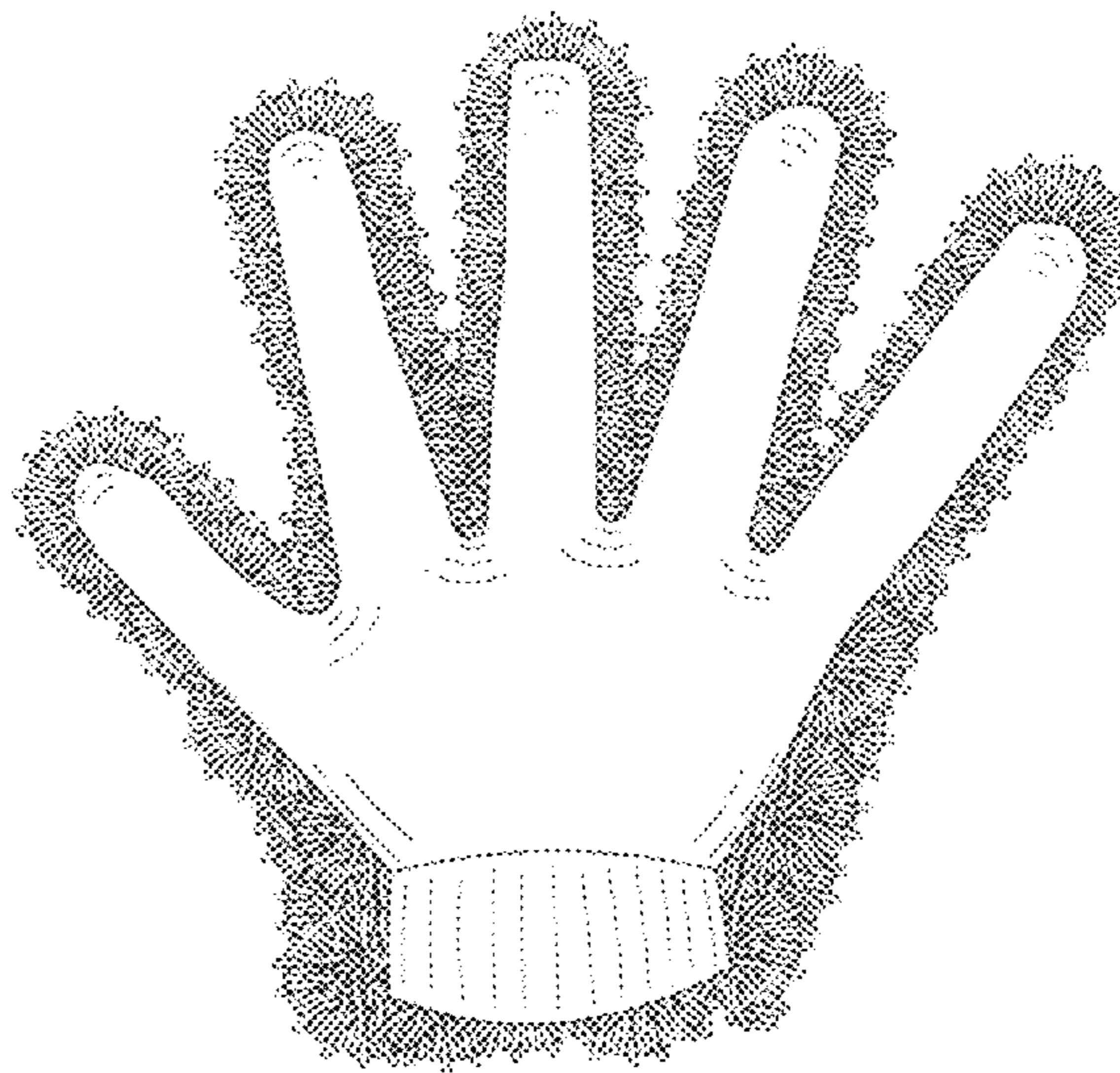
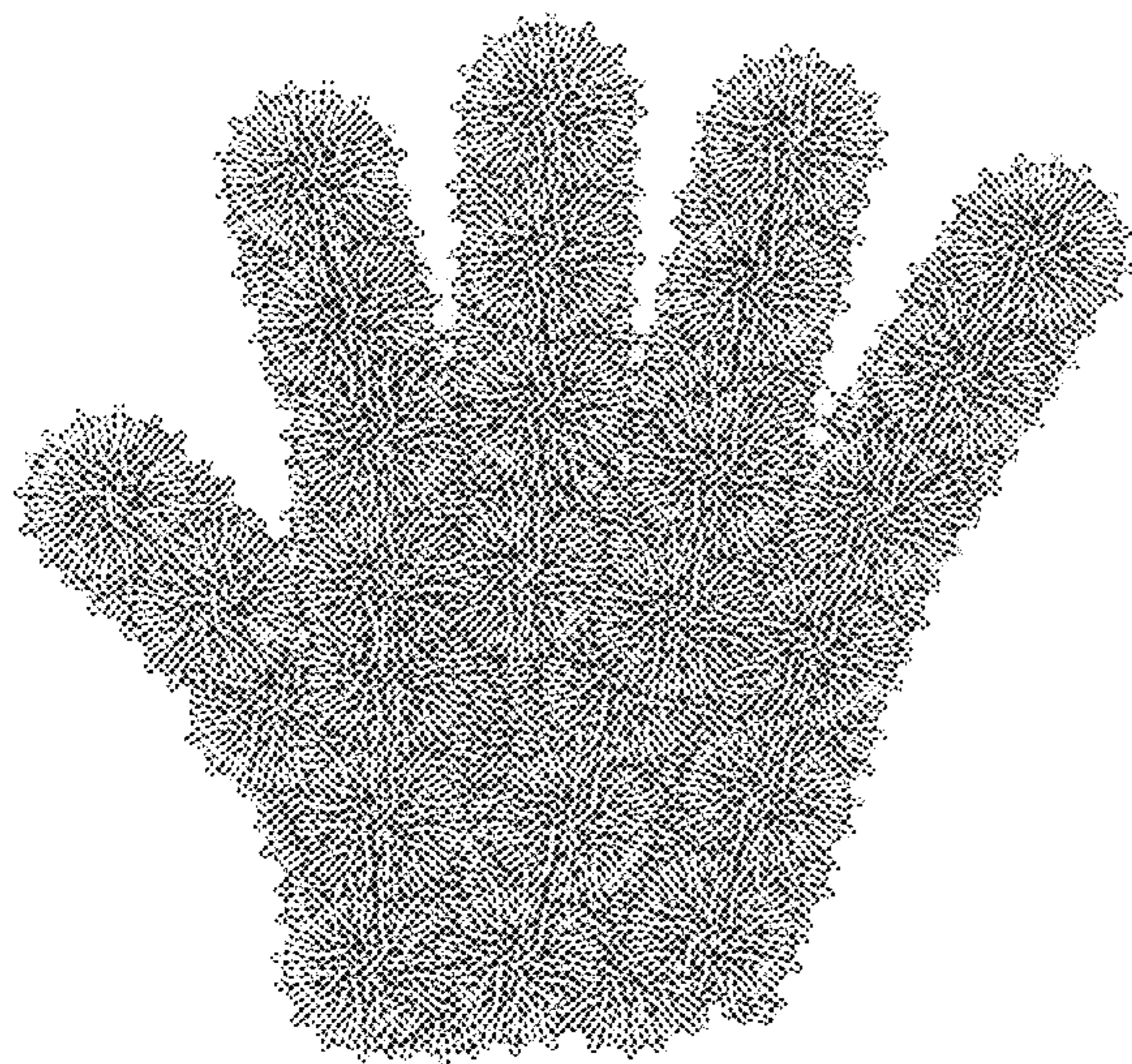
FIG. 4. is a left side elevation view thereof; showing our new design.

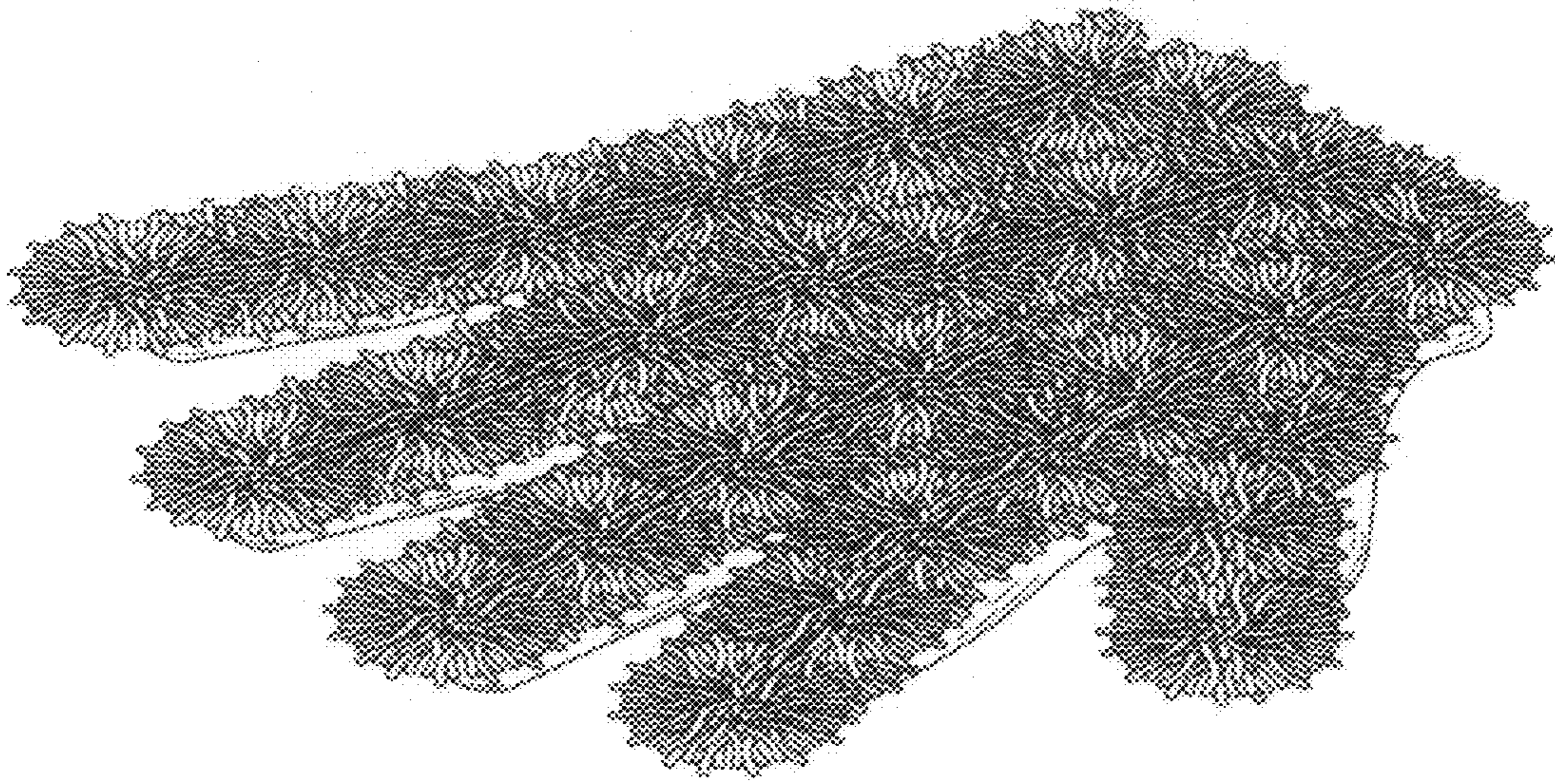

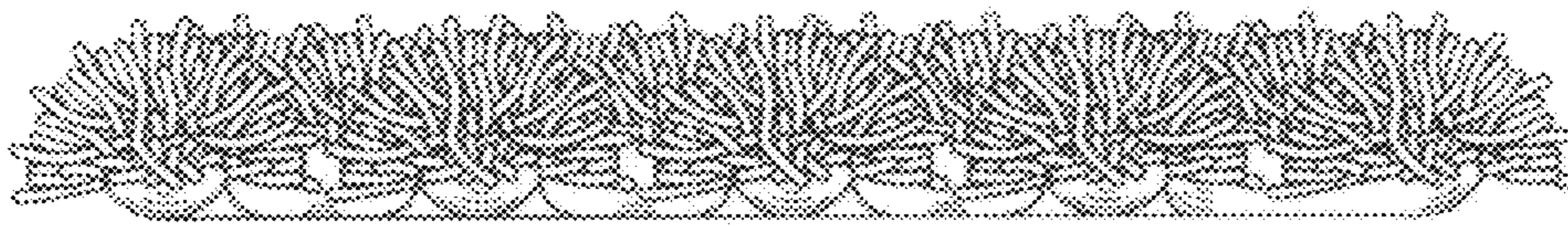

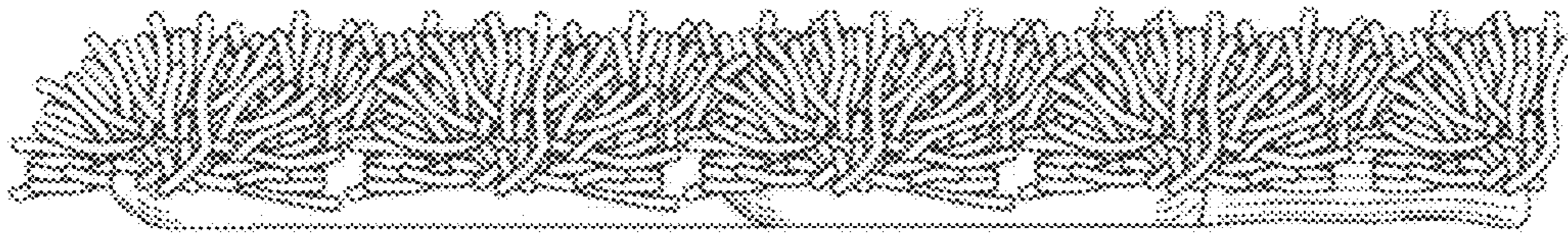

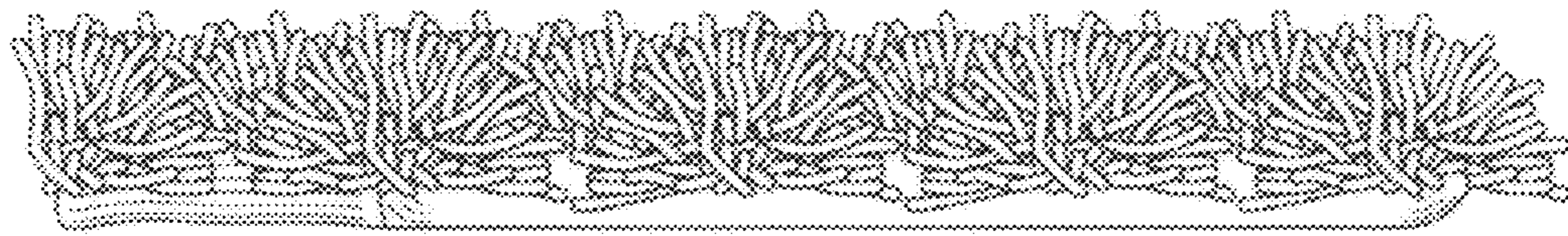

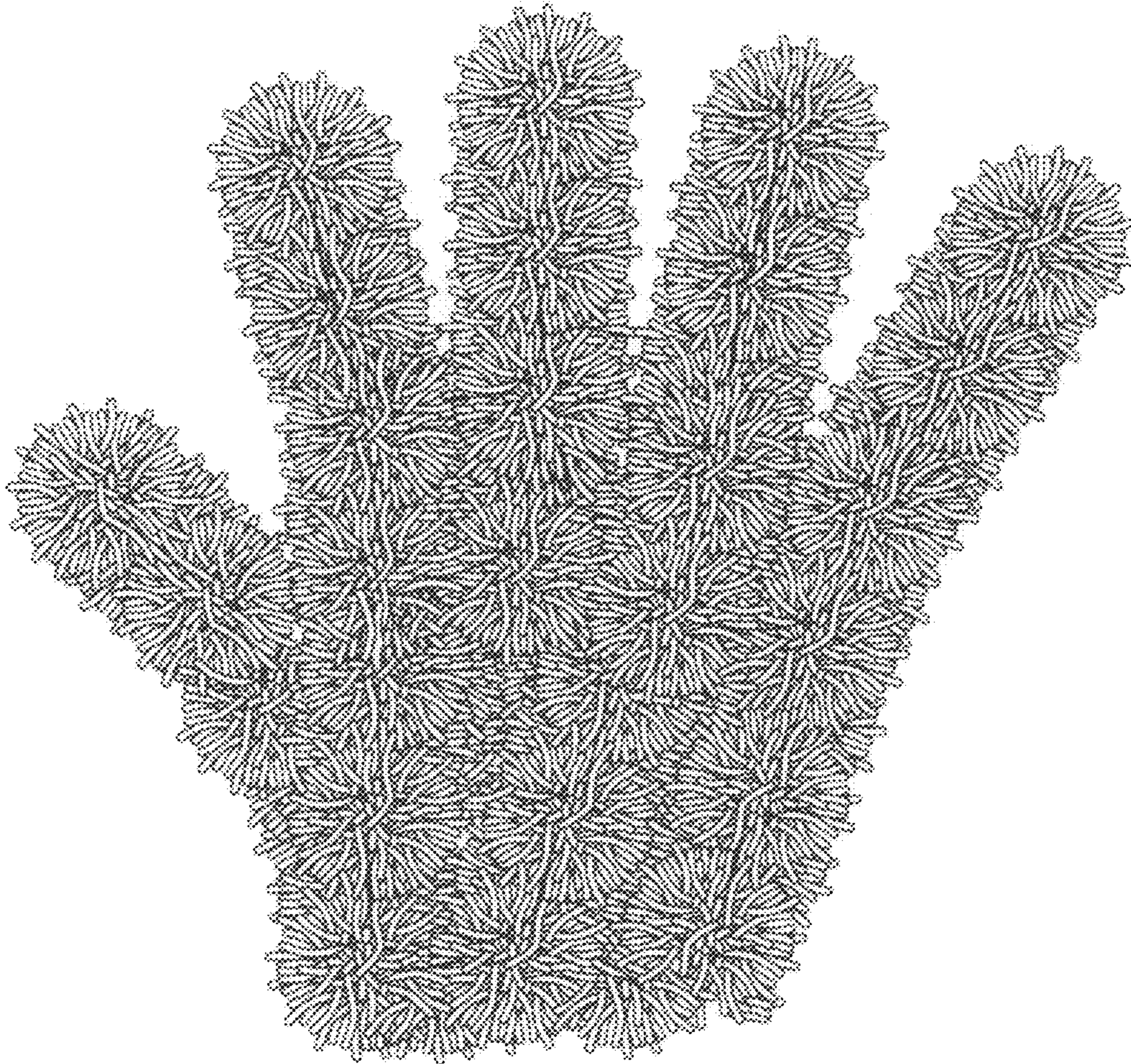

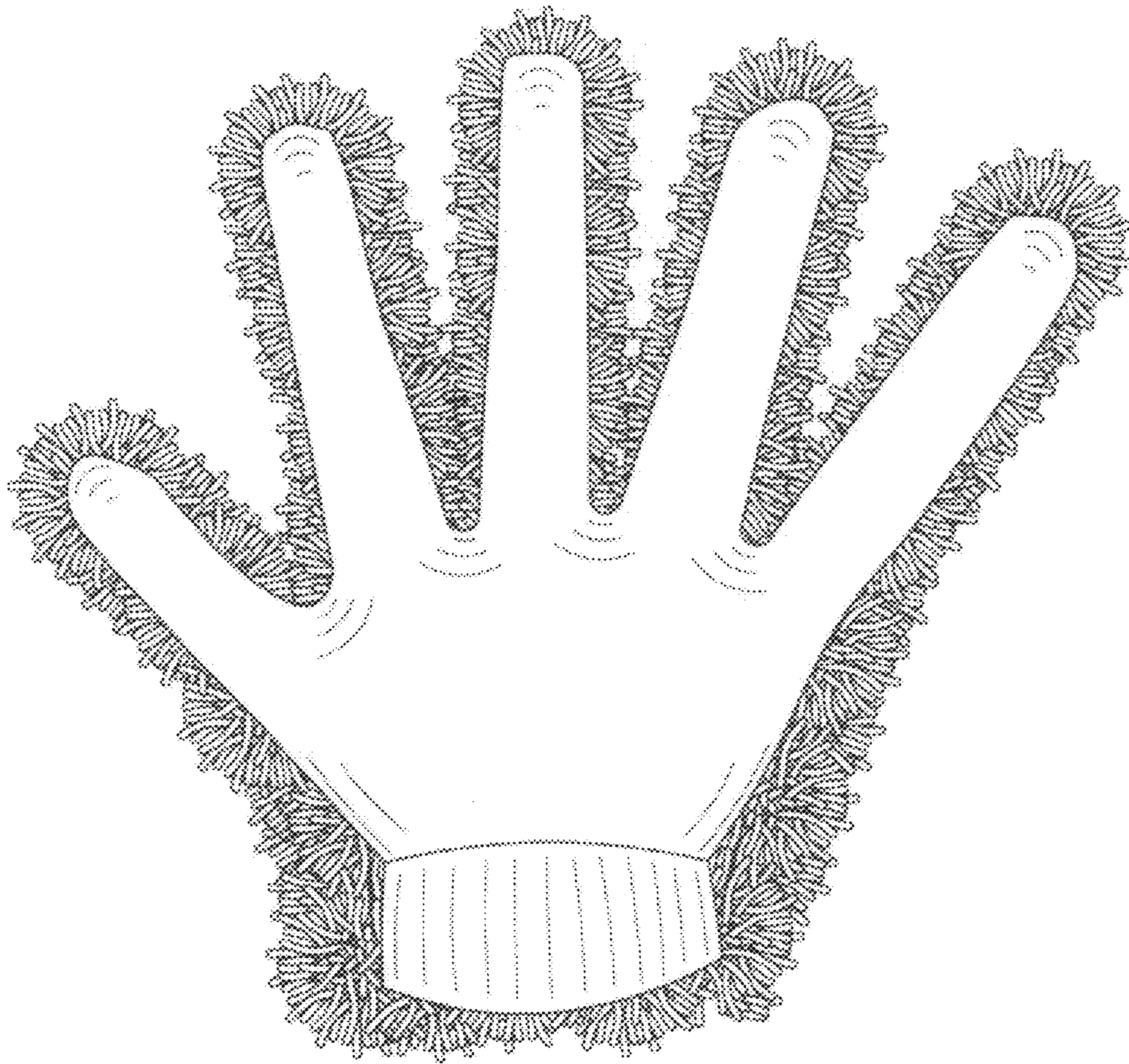
