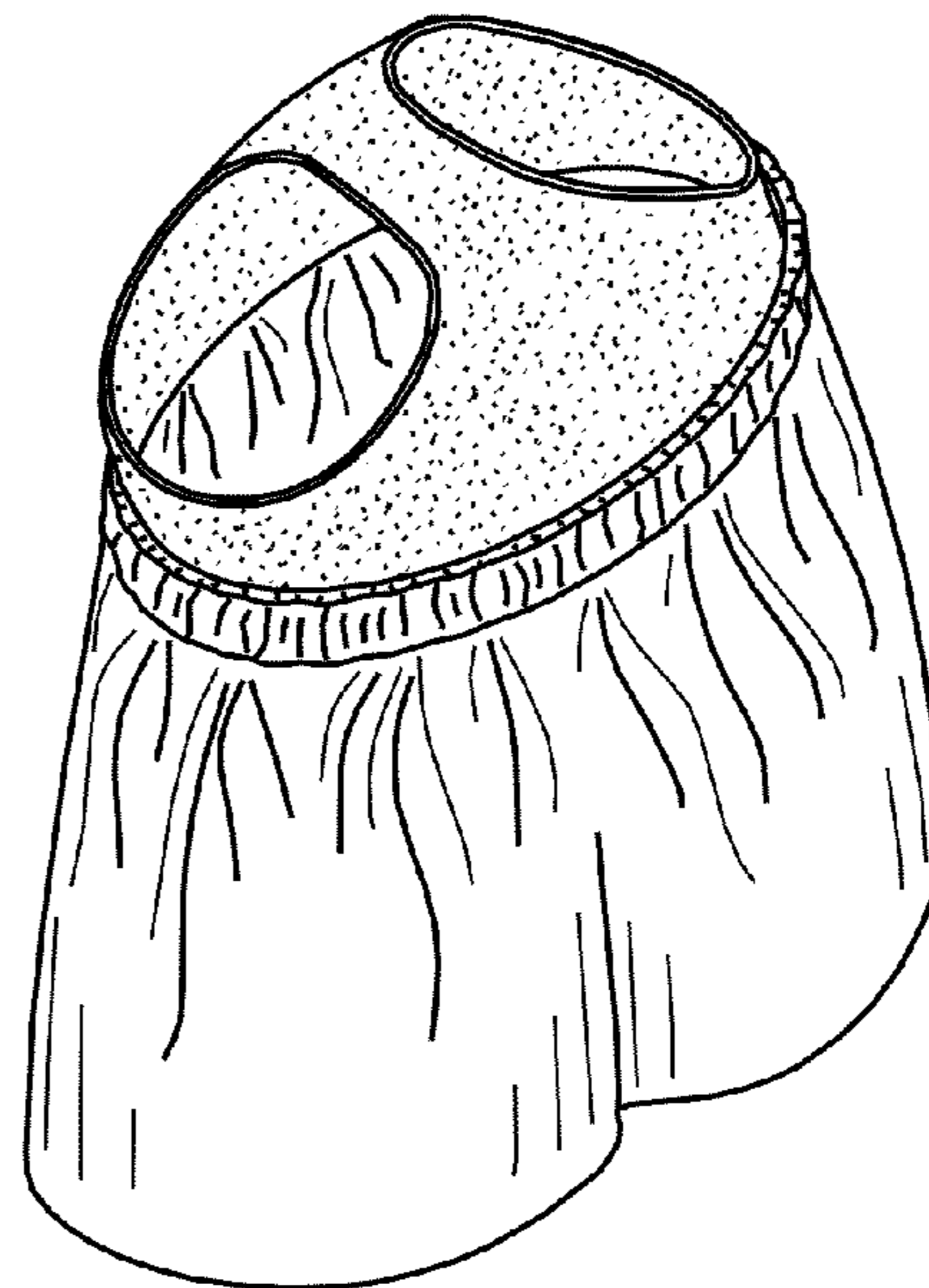
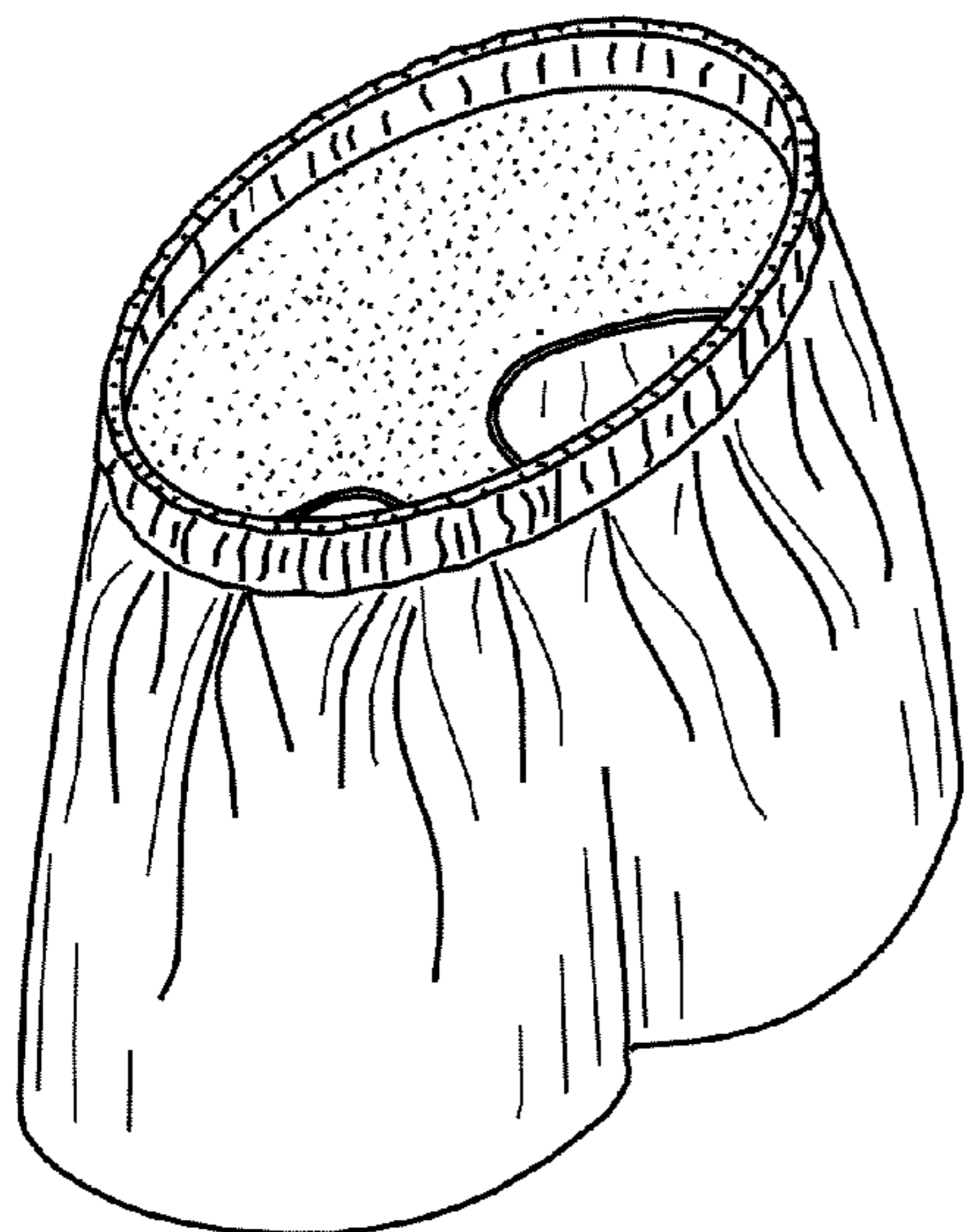
(57) **CLAIM**

I claim the ornamental design for a combination boxer and inner undergarment, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a combination boxer and inner undergarment, illustrated with the inner undergarment in a retracted configuration, showing my new design; FIG. 2 is a front elevational view of FIG. 1, the rear elevational view being a mirror image thereof; FIG. 3 is a left-side elevational view of FIG. 1, the right-side elevational view being a mirror image thereof; FIG. 4 is a top plan view of FIG. 1; FIG. 5 is a bottom plan view of FIG. 1; and, FIG. 6 is a perspective view thereof, illustrated with the inner undergarment in an extended position.

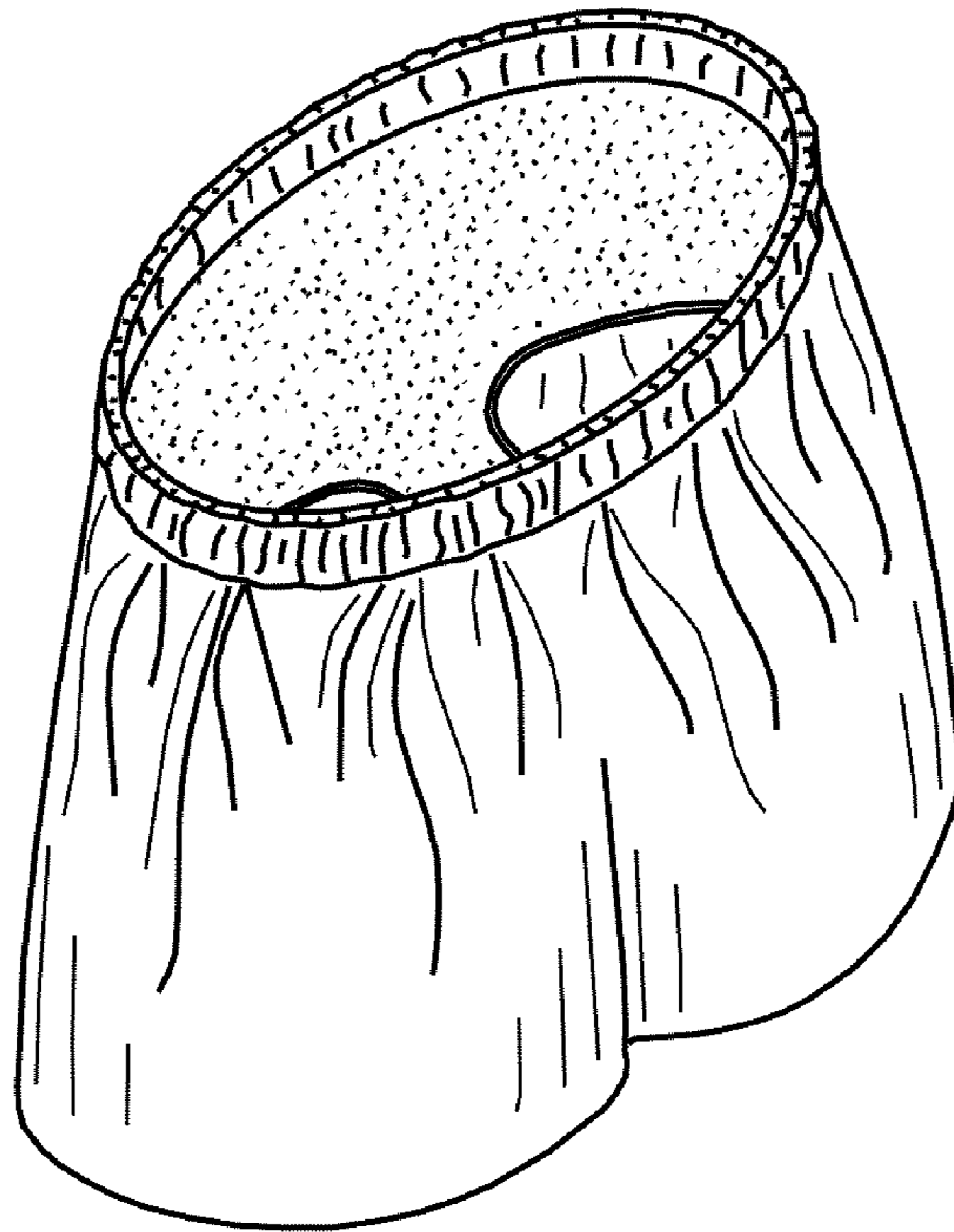

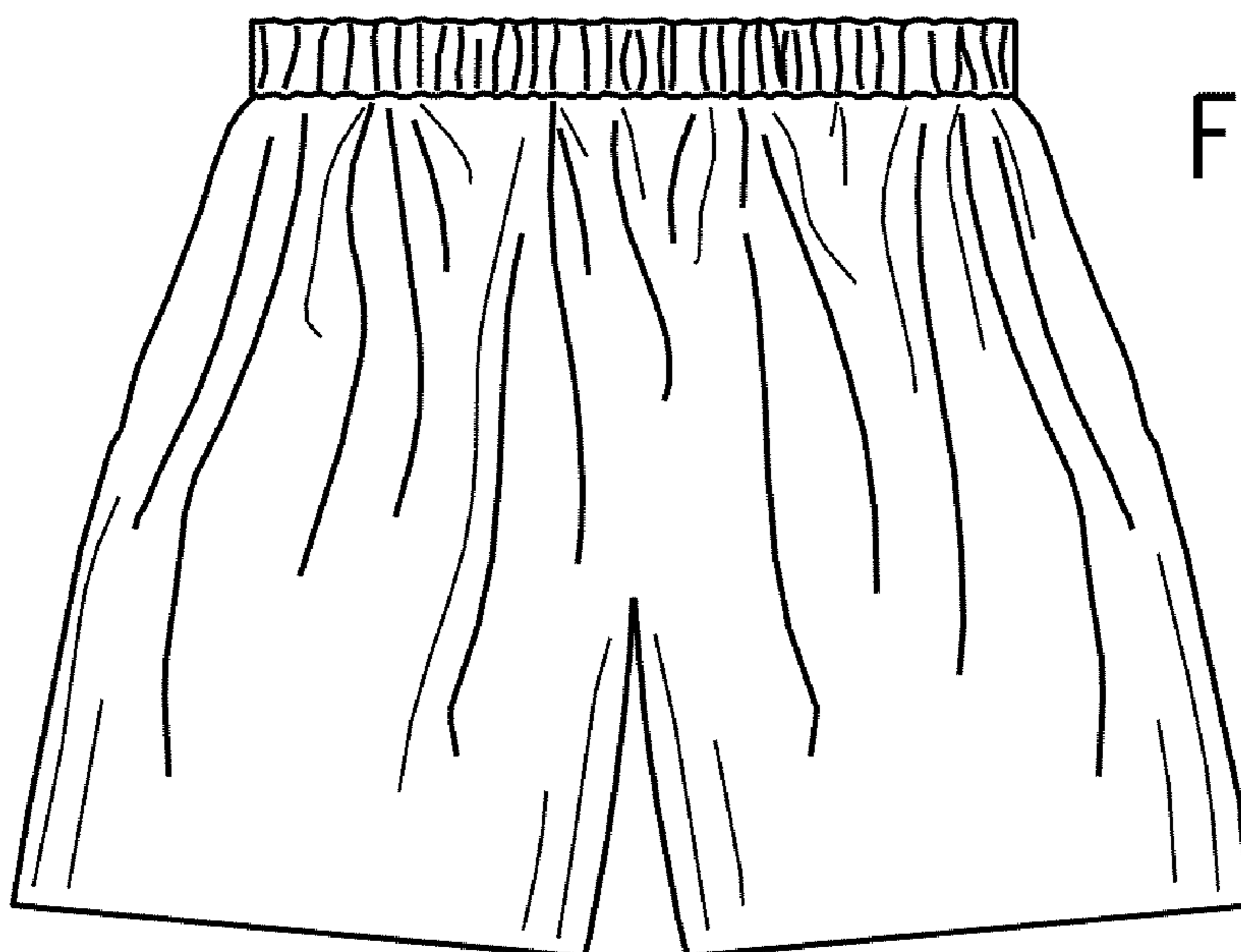

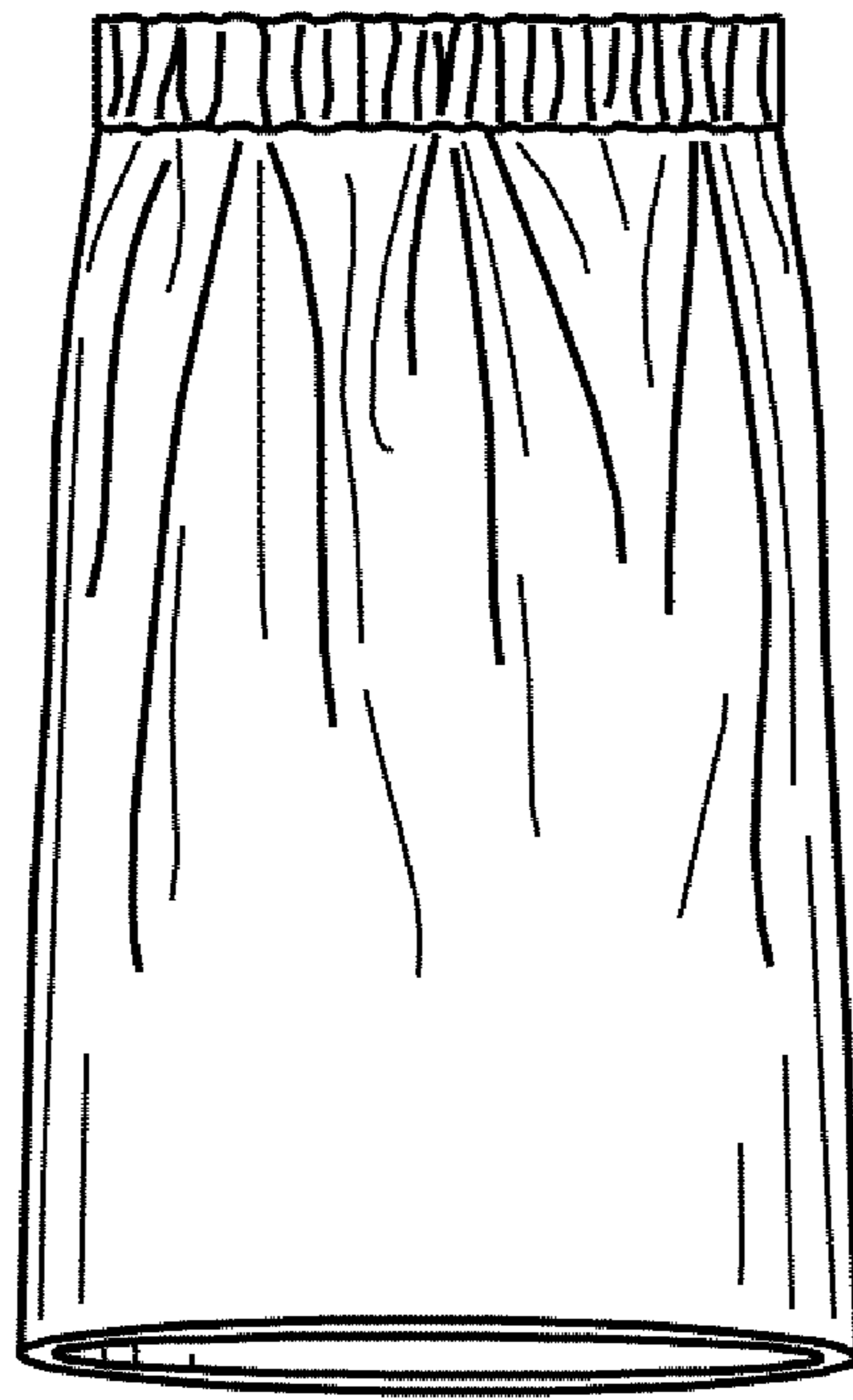

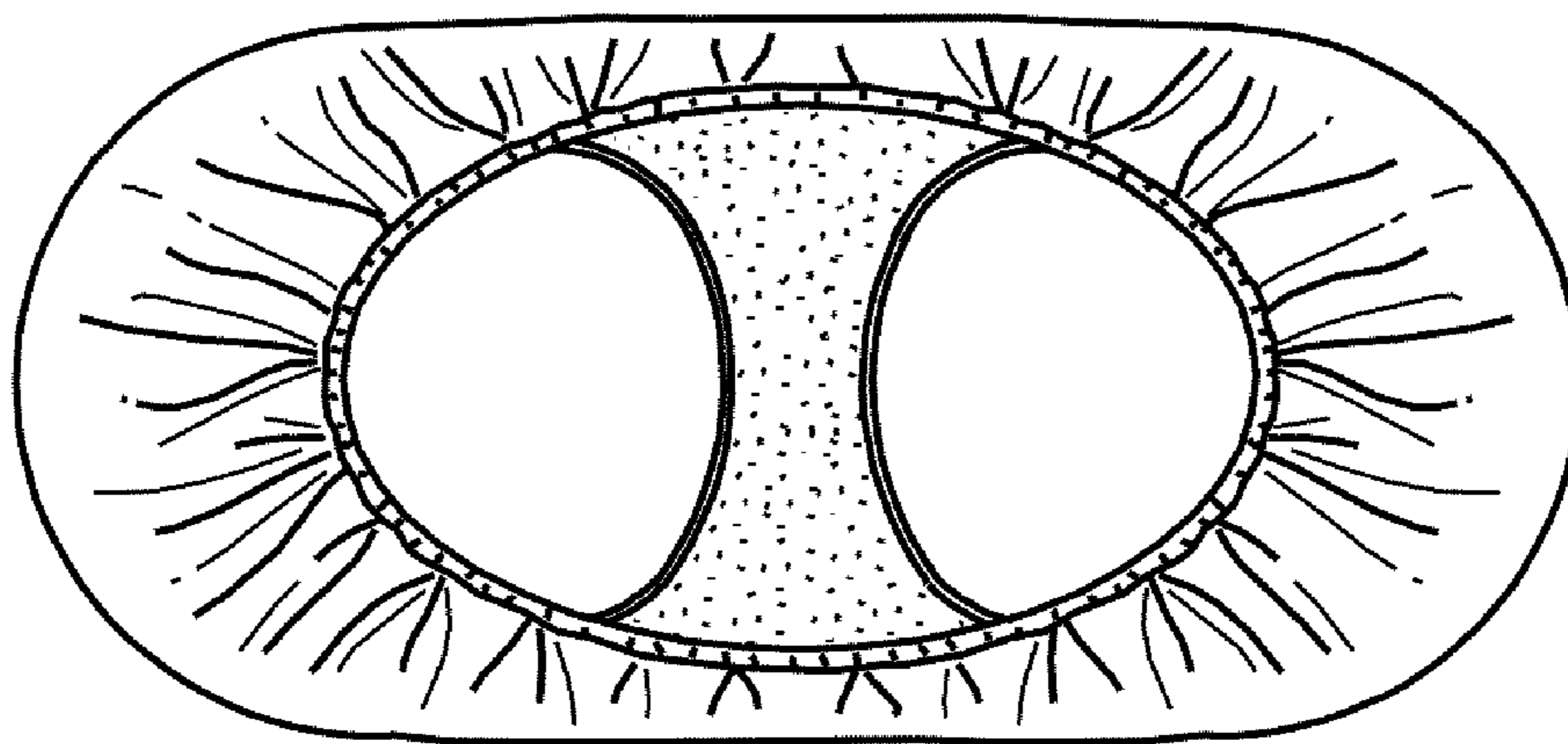

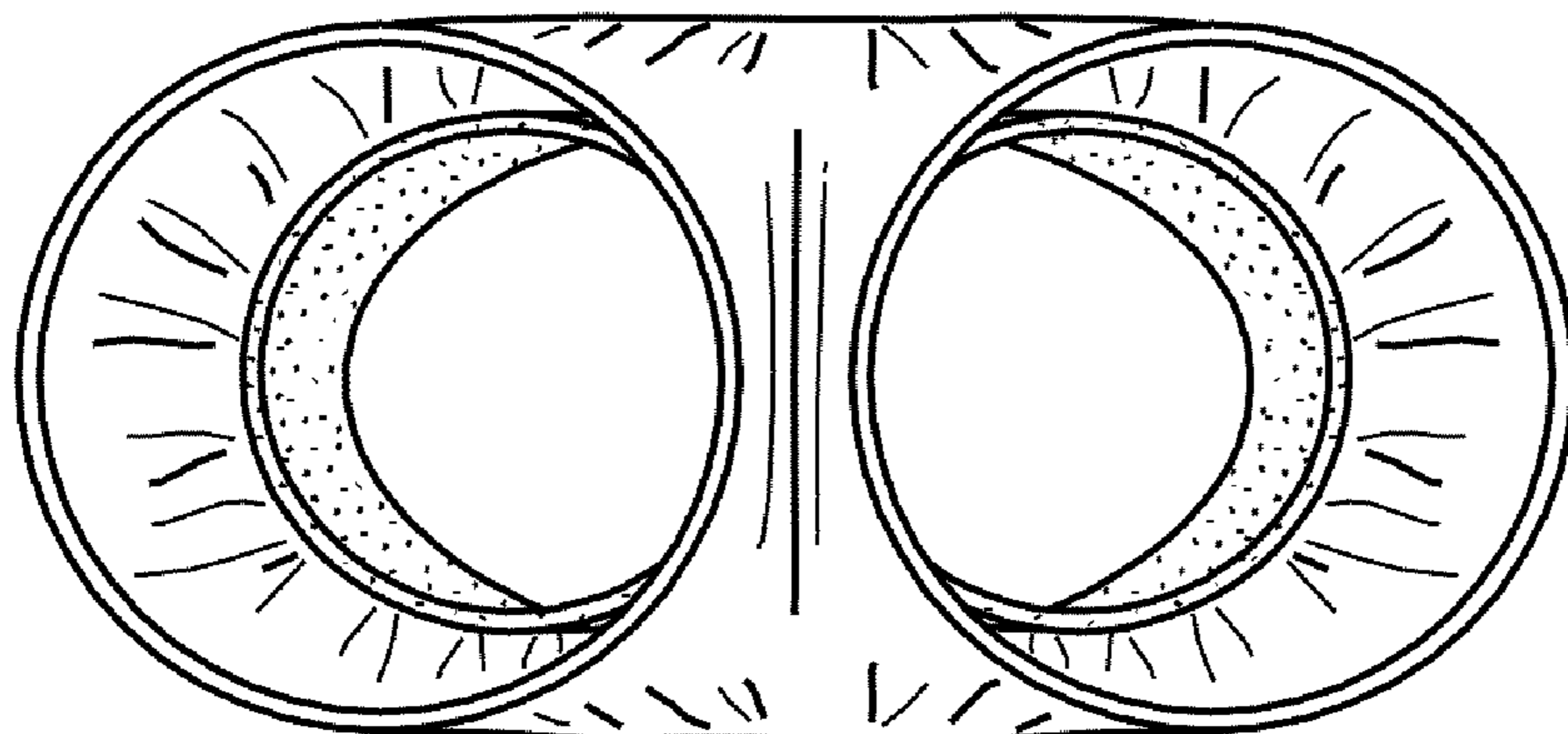

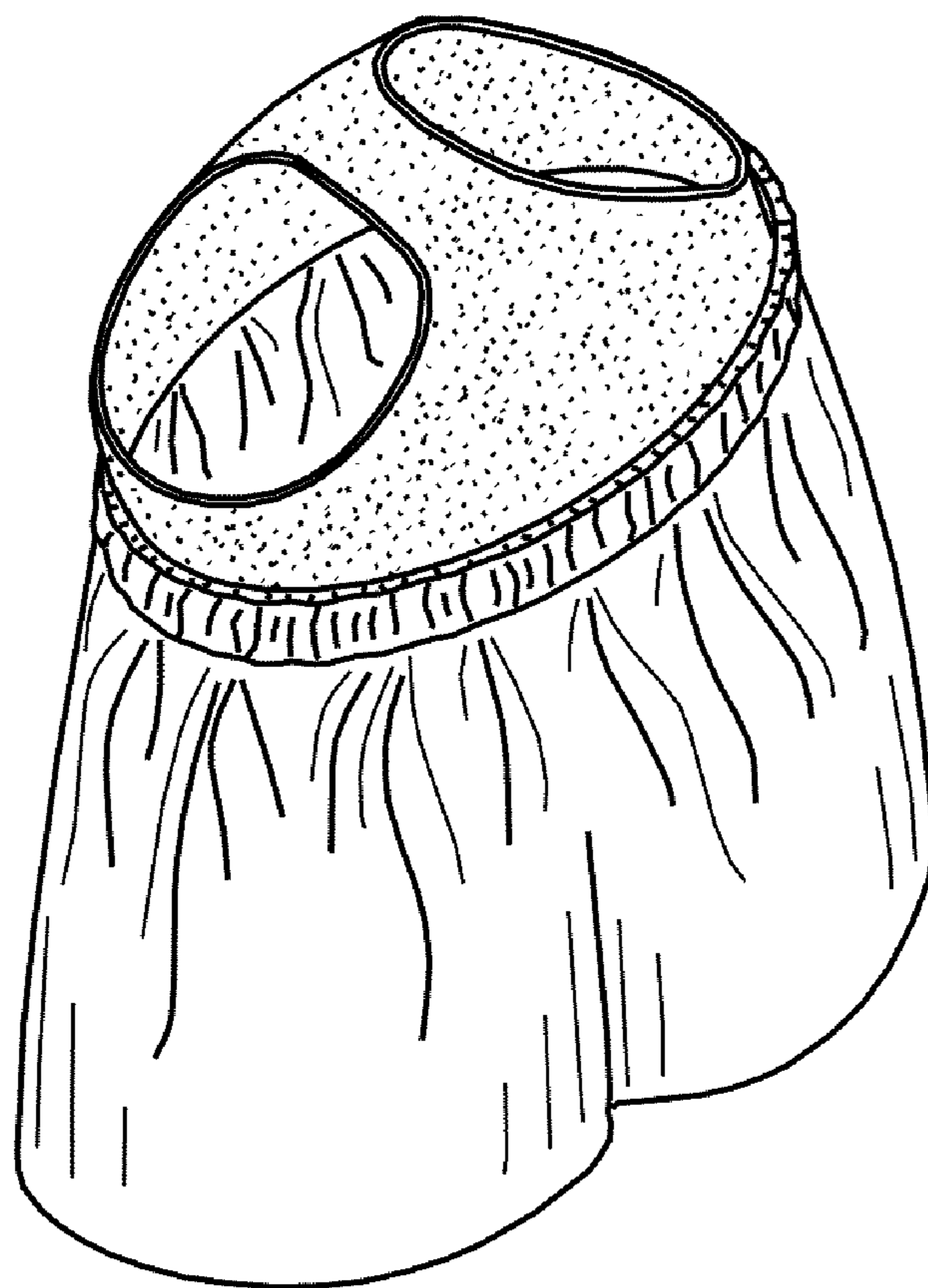
