(57) **CLAIM**

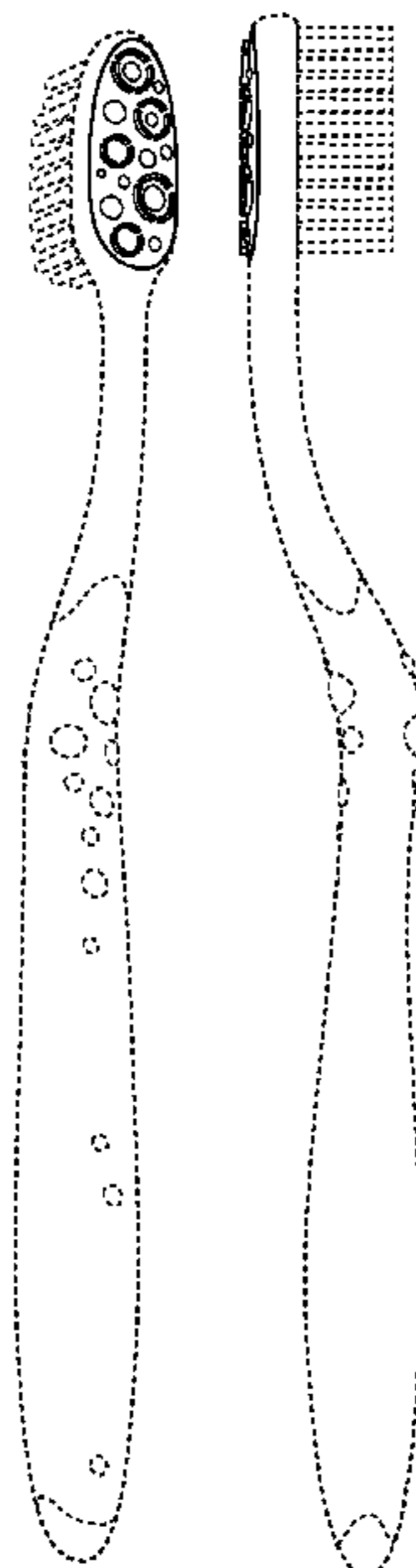
The ornamental design for a toothbrush, as shown and described.

DESCRIPTION

FIG. 1 is a right front perspective view of a toothbrush according to the new design;
FIG. 2 is a left front perspective view thereof;
FIG. 3 is a left rear perspective view thereof;
FIG. 4 is a right rear perspective view thereof;
FIG. 5 is a front view thereof;
FIG. 6 is a rear view thereof;
FIG. 7 is a left side view thereof;
FIG. 8 is a right side view thereof;
FIG. 9 is a top view thereof; and,
FIG. 10 is a bottom view thereof.

The broken lines showing the remainder of the head portion and the entire handle portion of the toothbrush form no part of the claimed design.

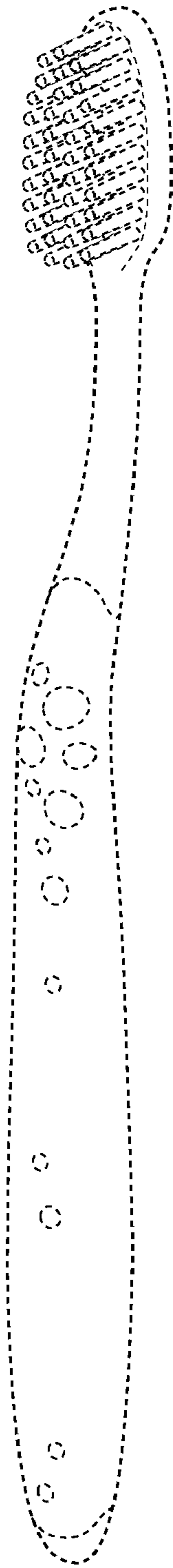

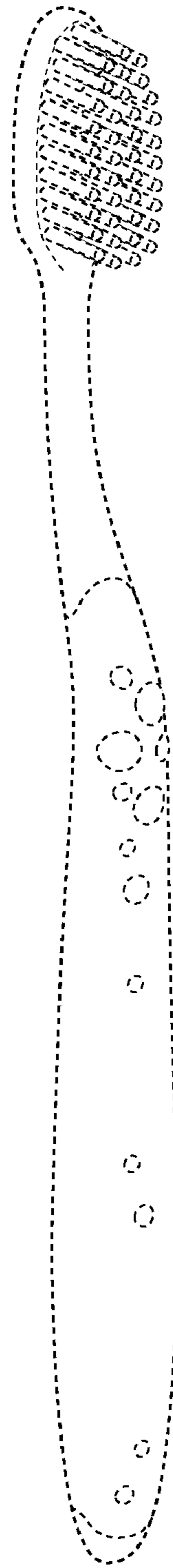

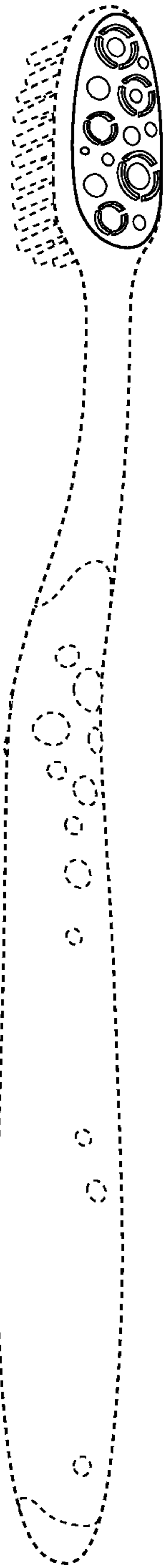

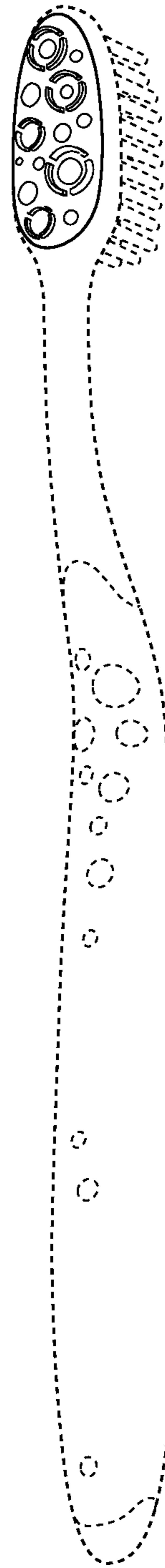

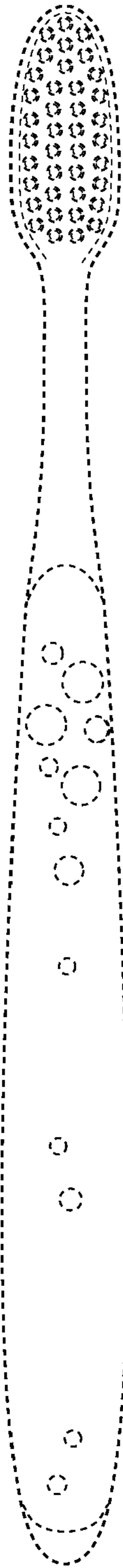

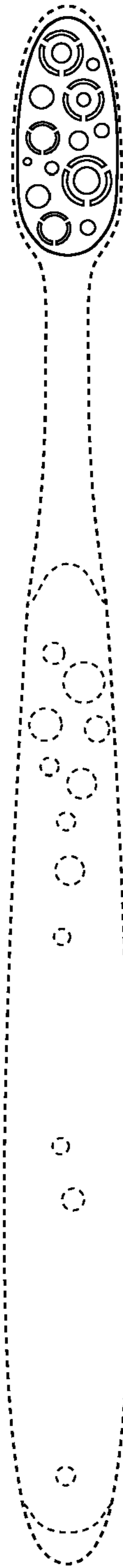

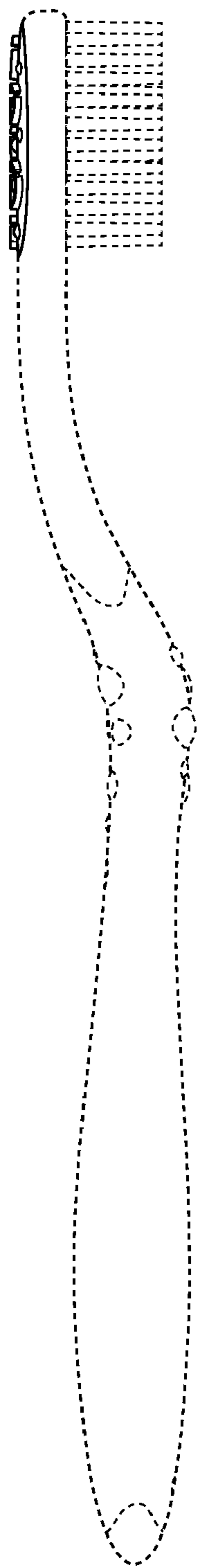

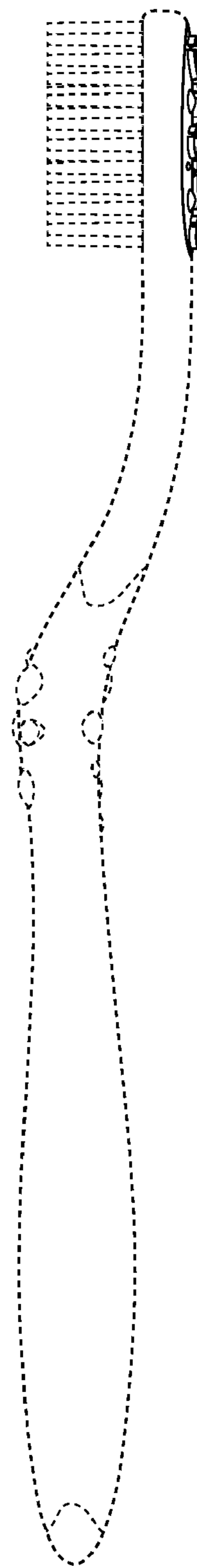

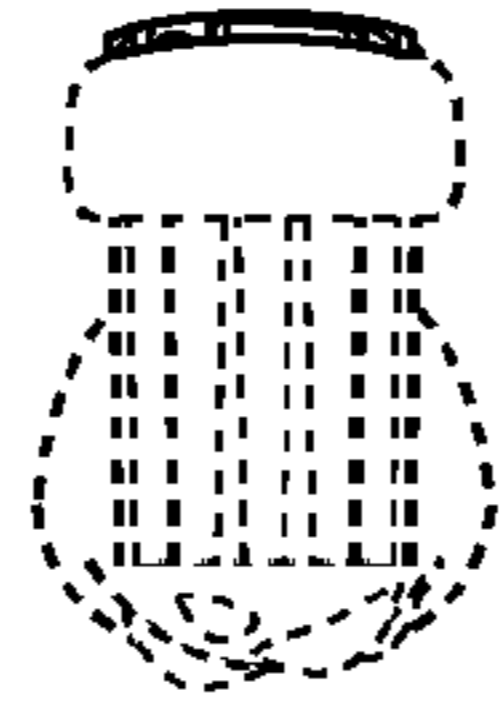

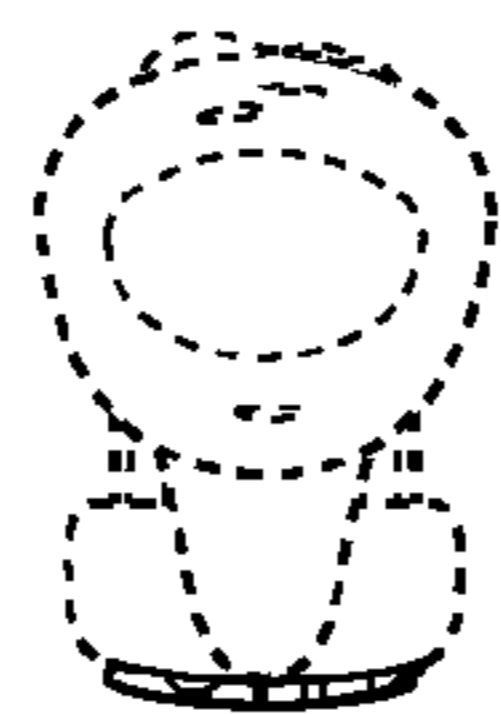
