The ornamental design for a drinking vessel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the drinking vessel;
 FIG. 2 is a front view of the drinking vessel depicted in FIG. 1;
 FIG. 3 is a rear view of the drinking vessel depicted in FIG. 1;
 FIG. 4 is a left side view of the drinking vessel depicted in FIG. 1, with the right side view being a mirror image thereof;
 FIG. 5 is a top view of the drinking vessel depicted in FIG. 1;
 FIG. 6 is a bottom view of the drinking vessel depicted in FIG. 1;
 FIG. 7 is a perspective view of the drinking vessel shown in an alternate environment of use;

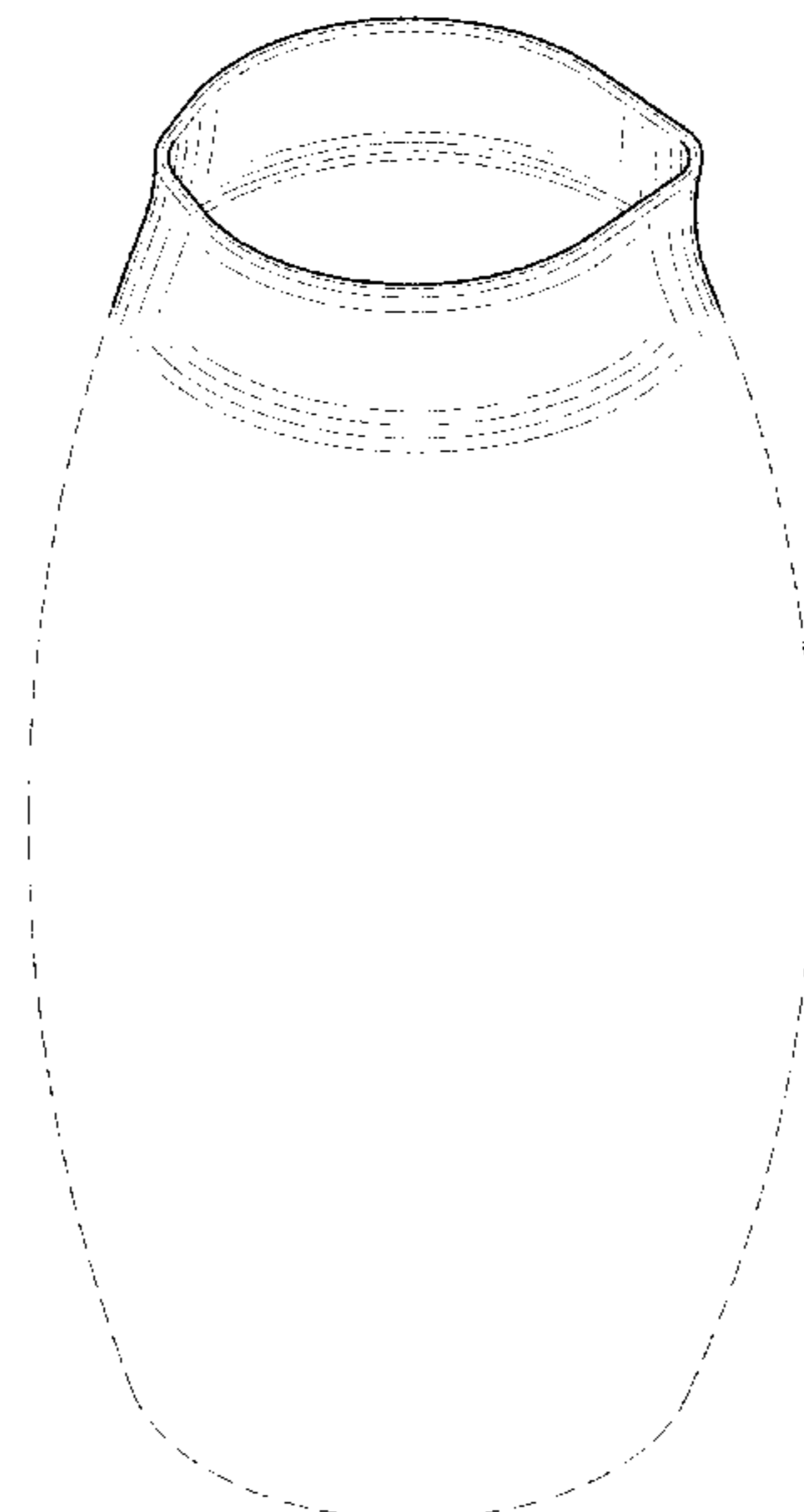

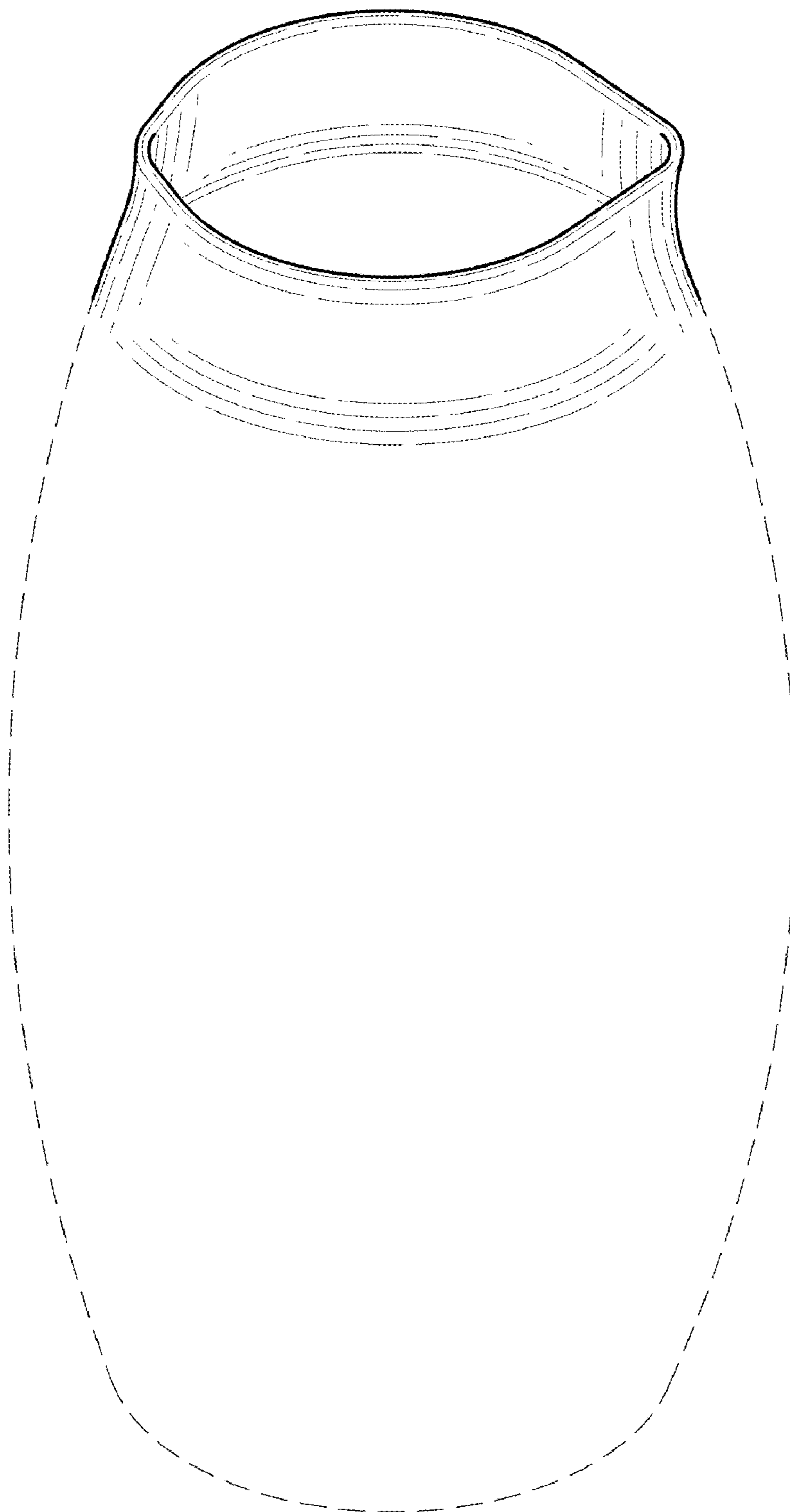

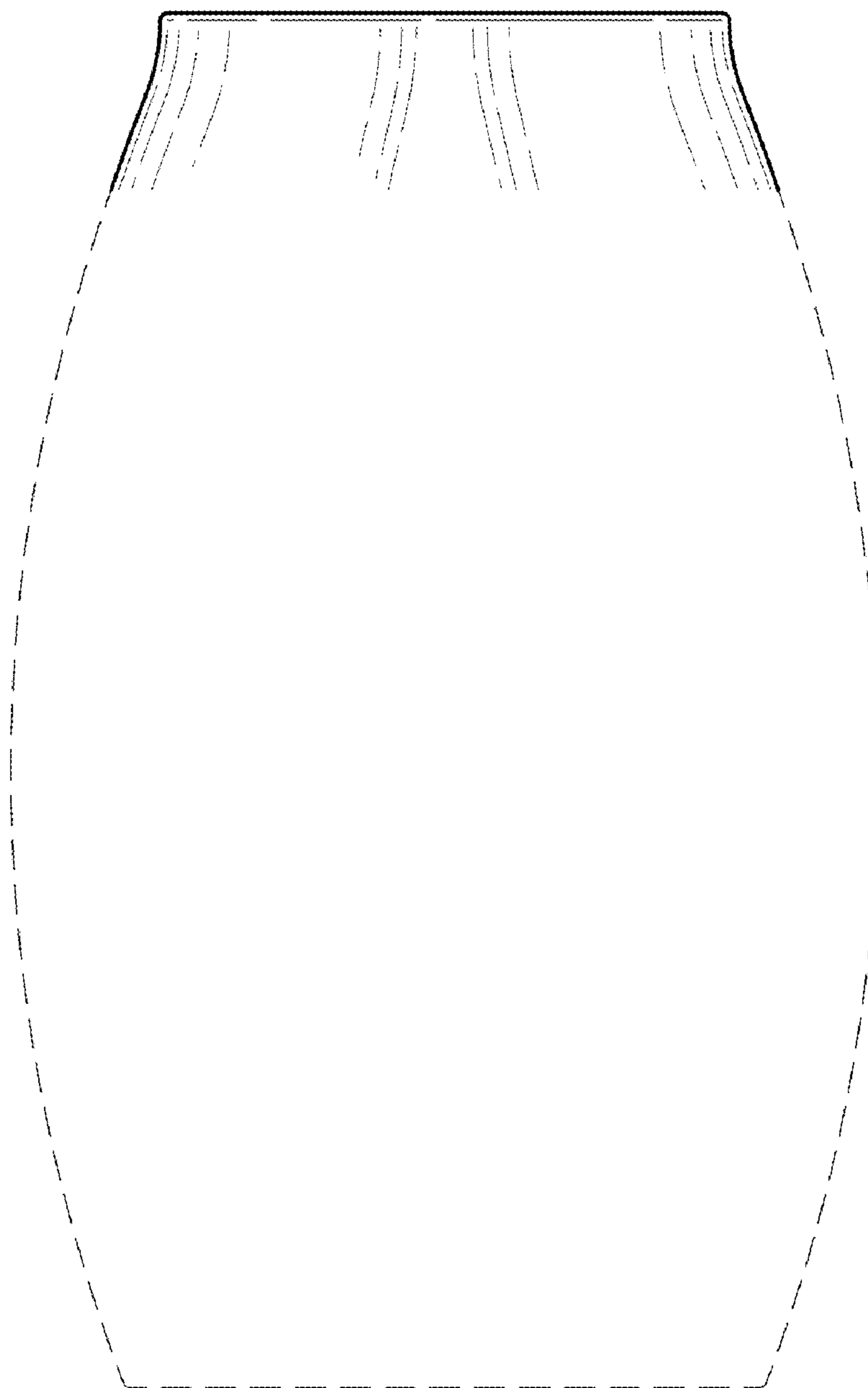

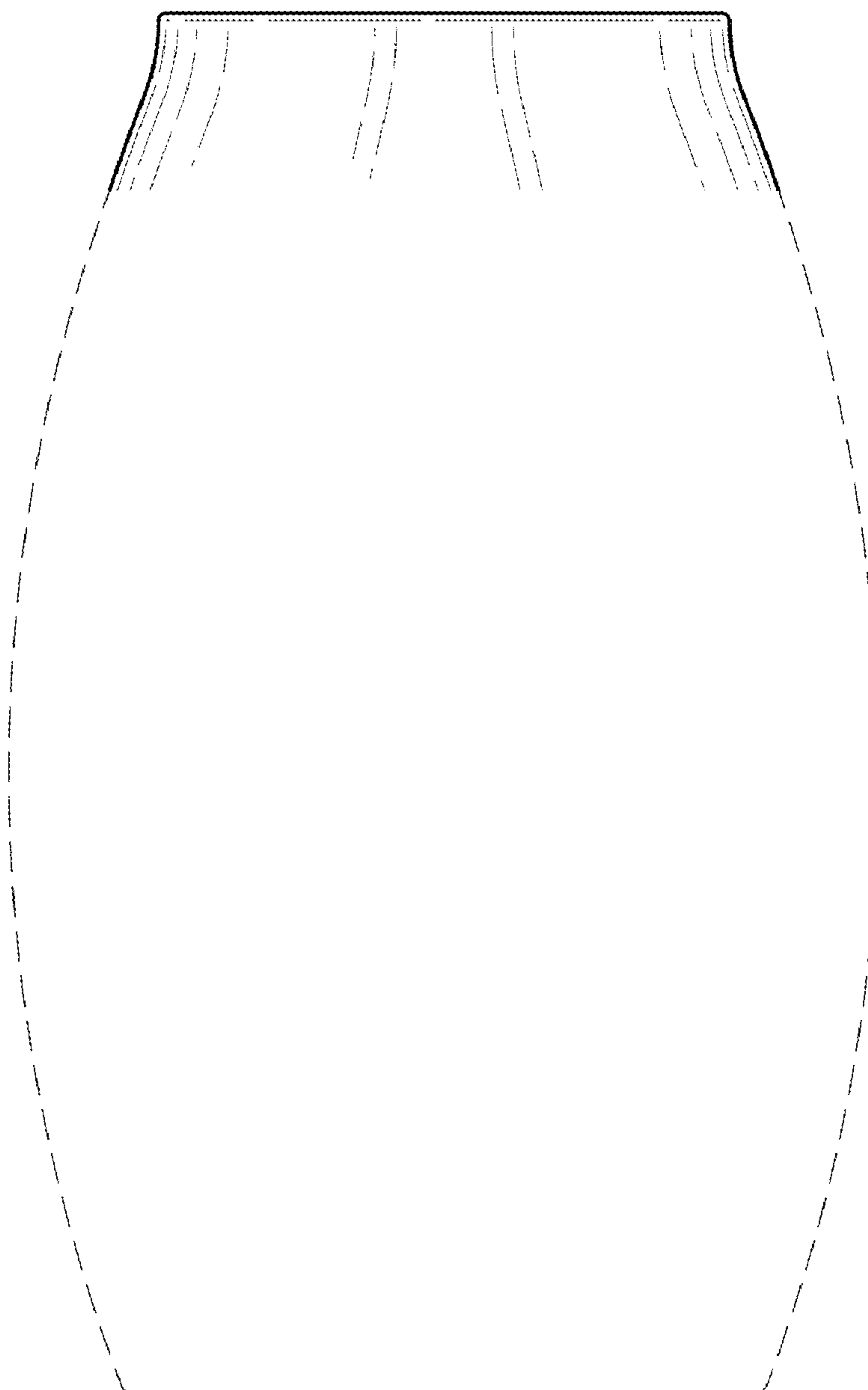

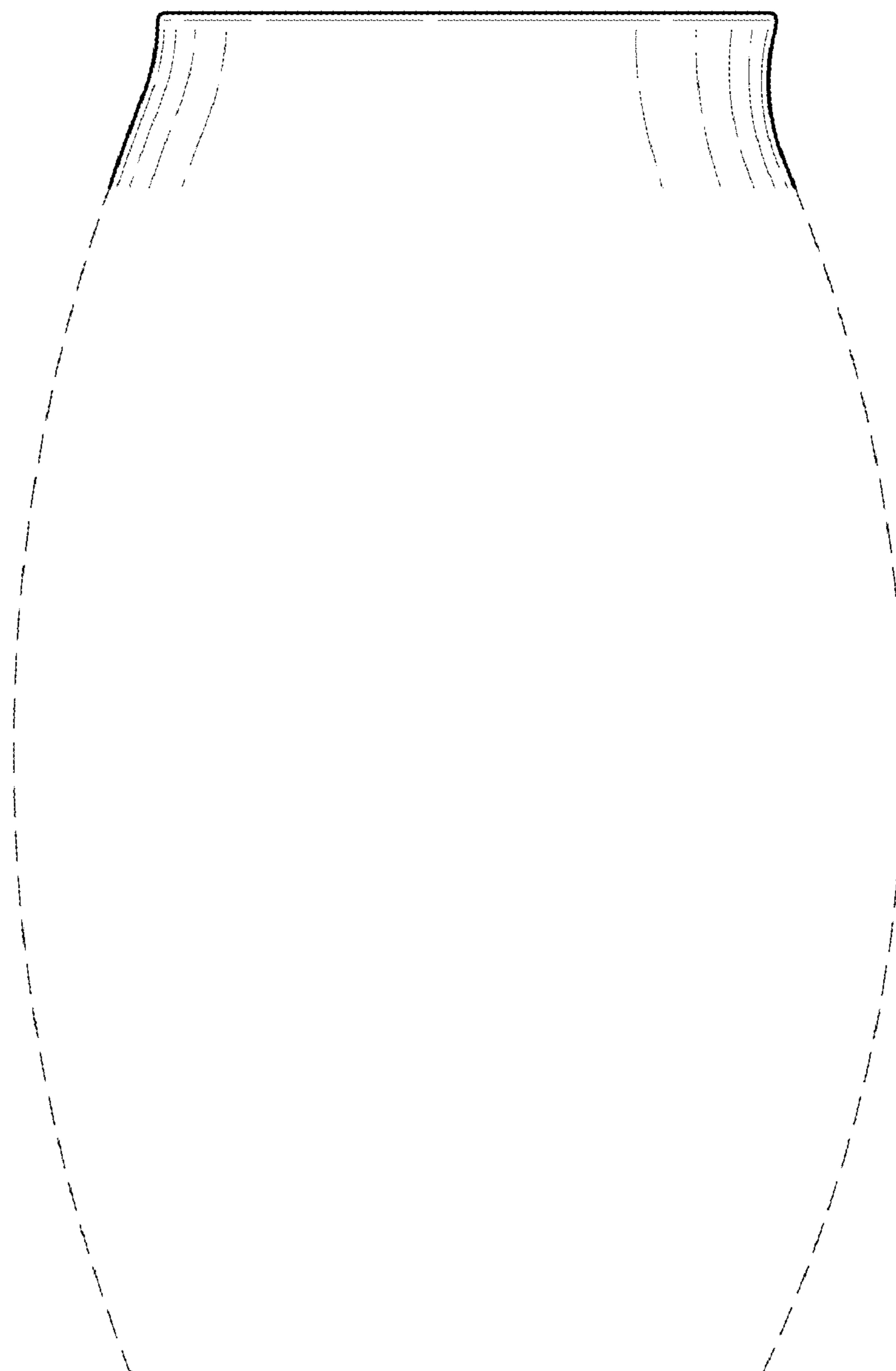

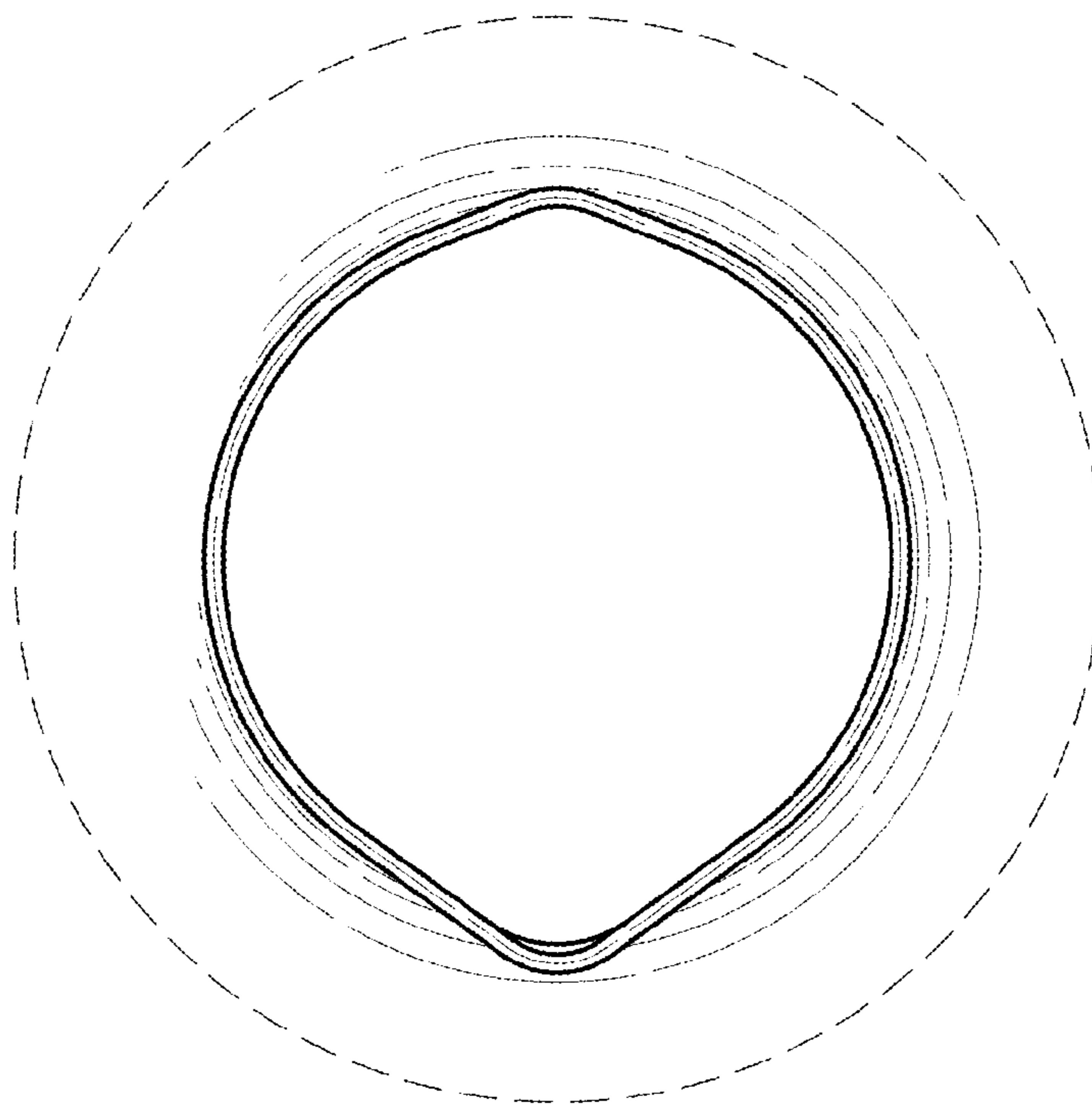

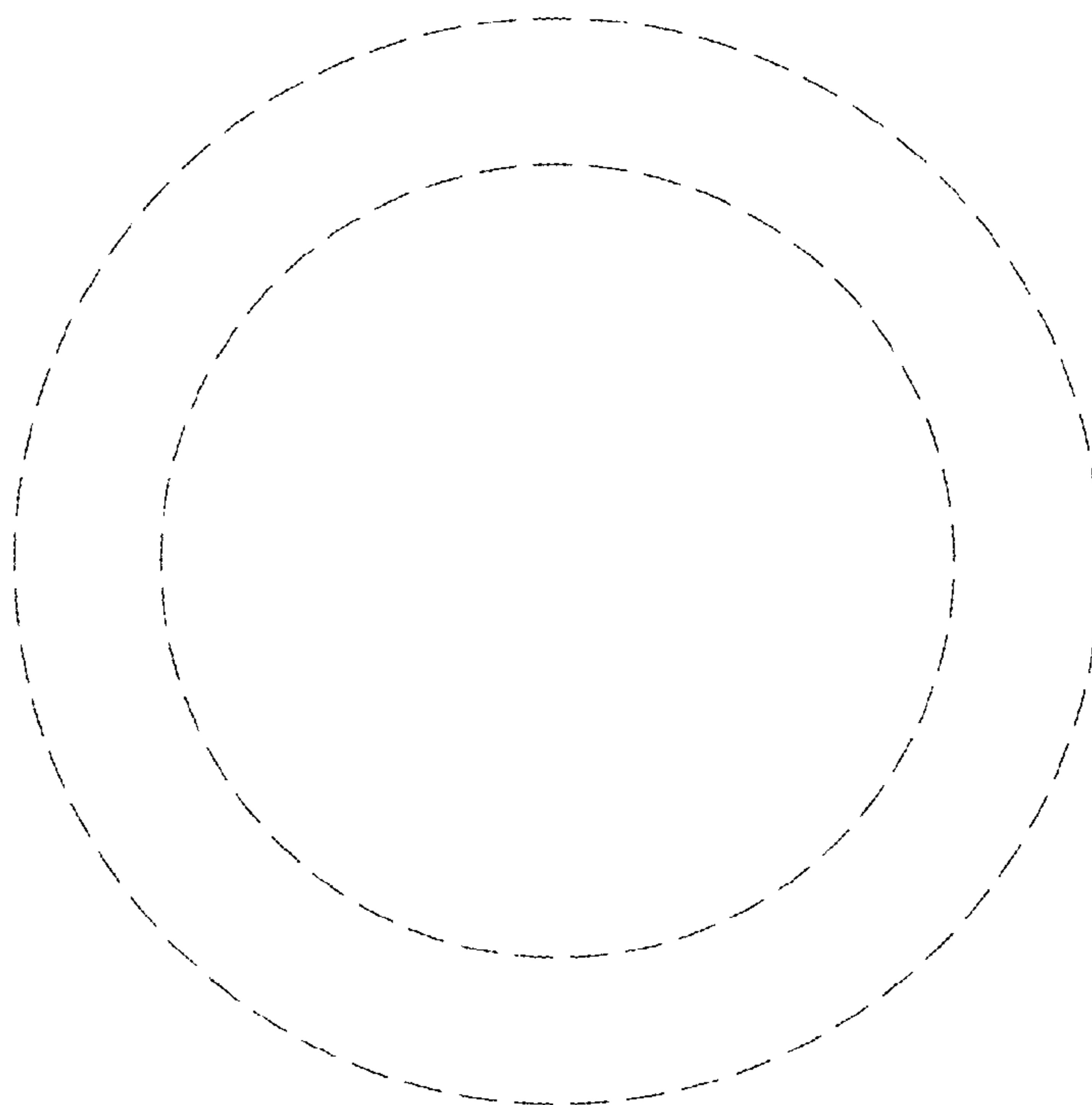

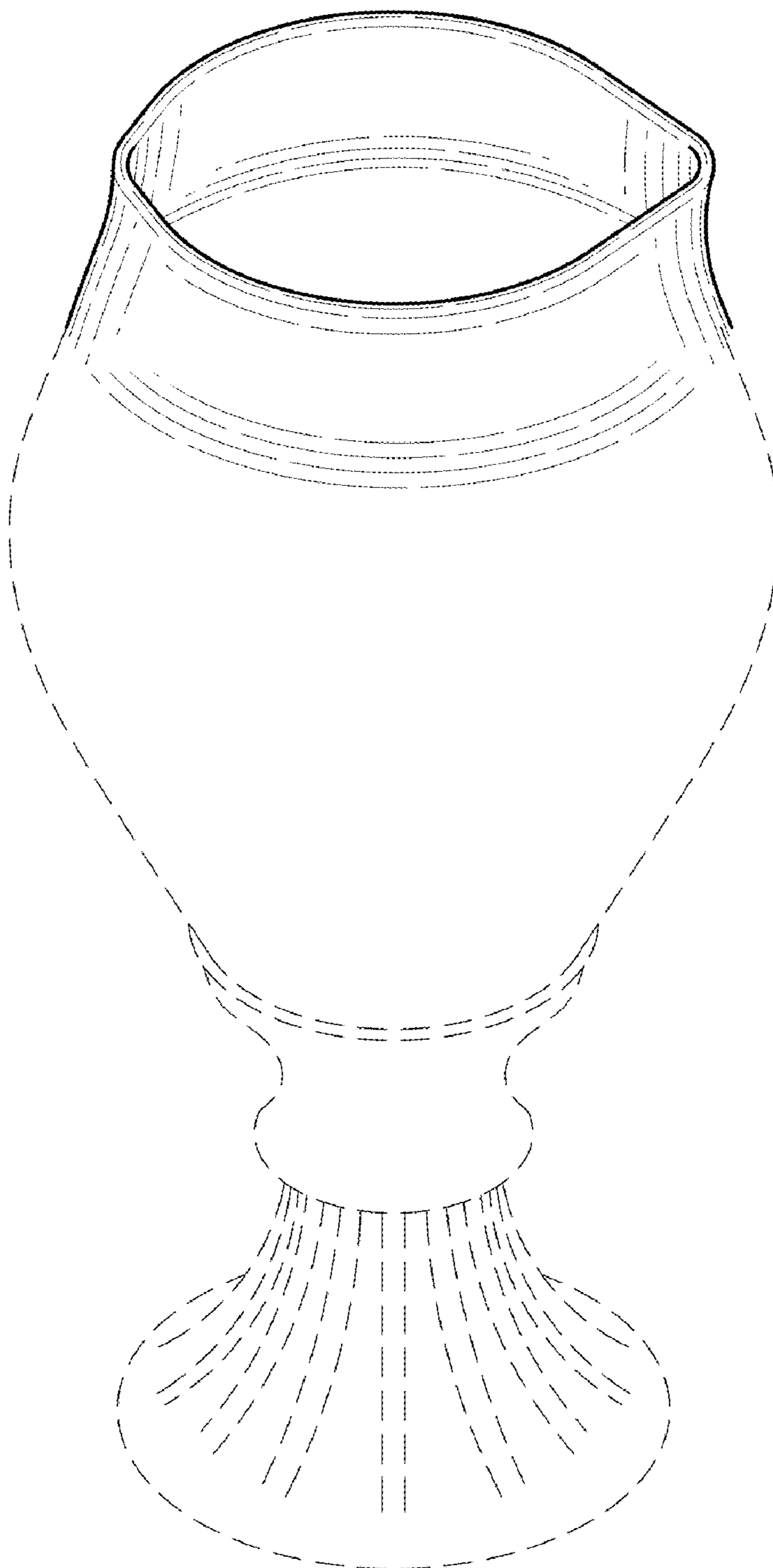

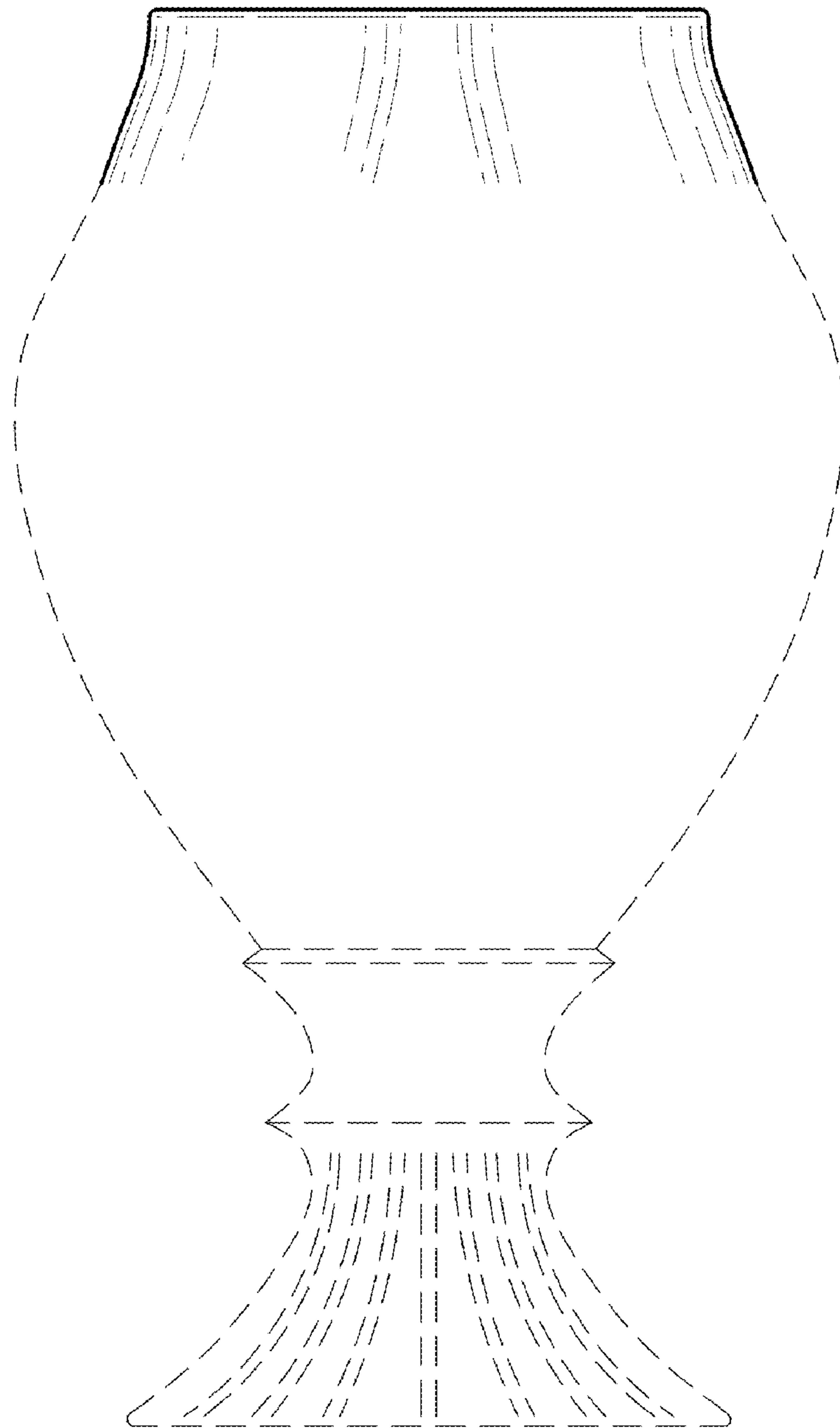

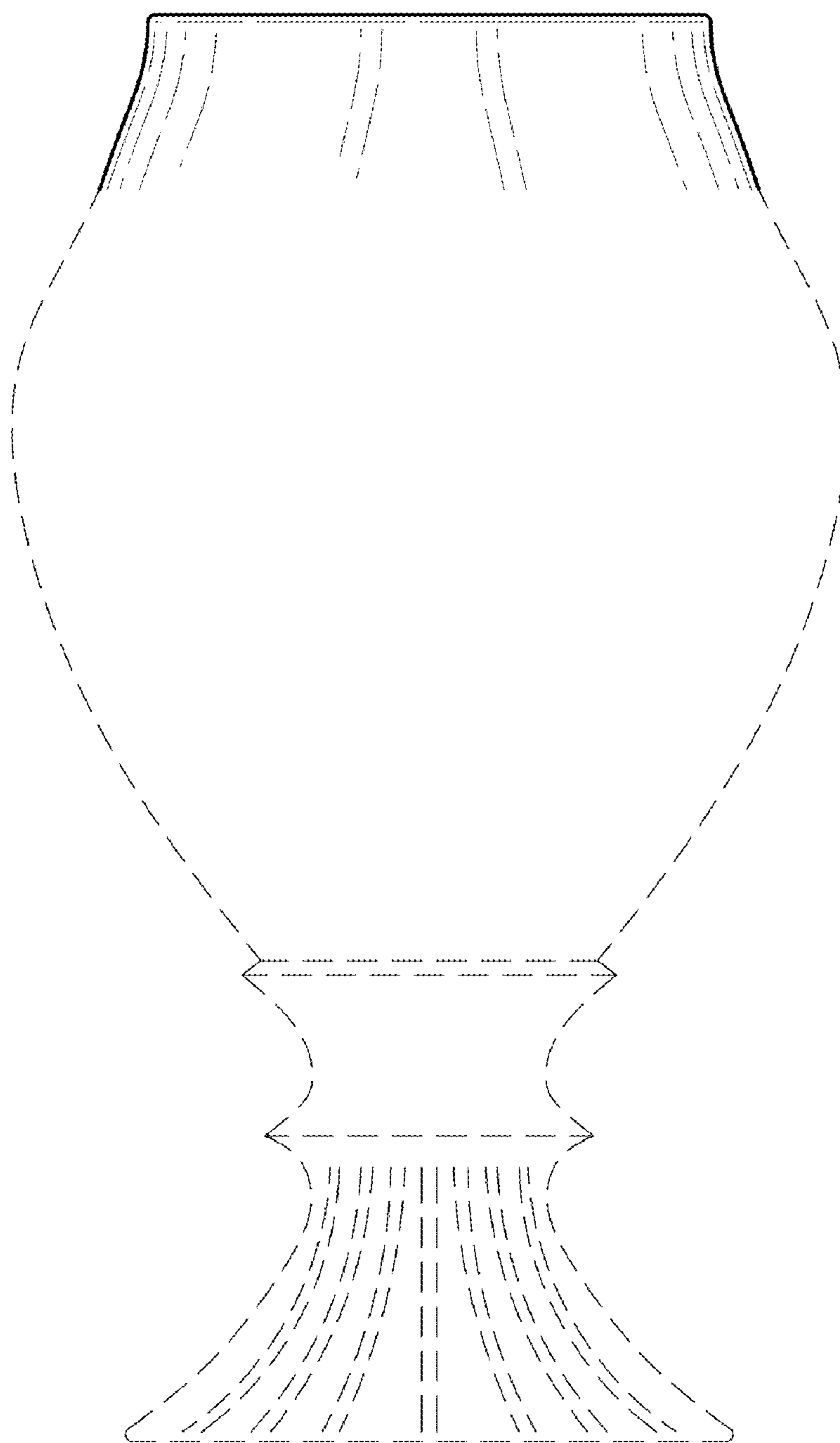

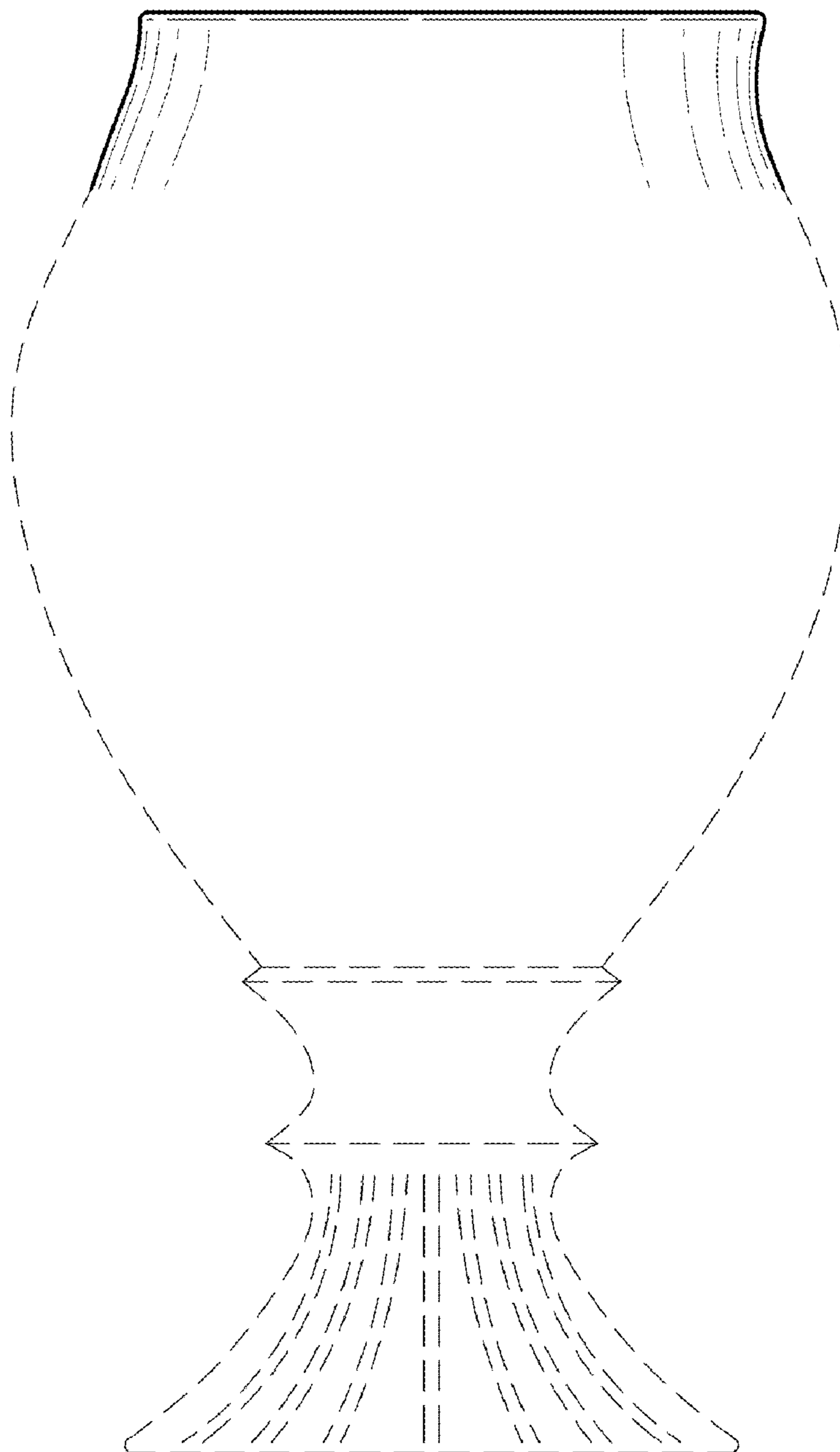

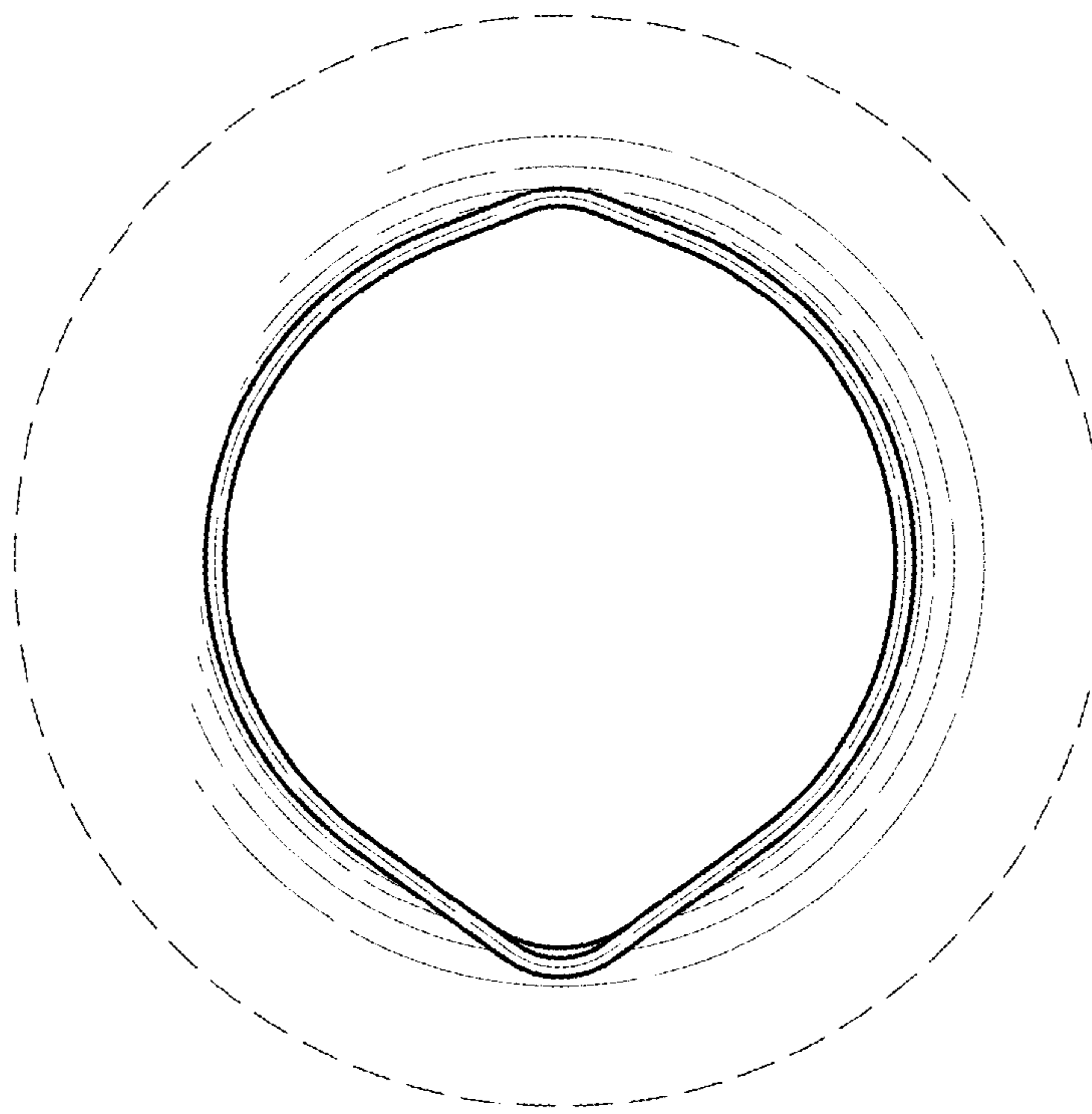

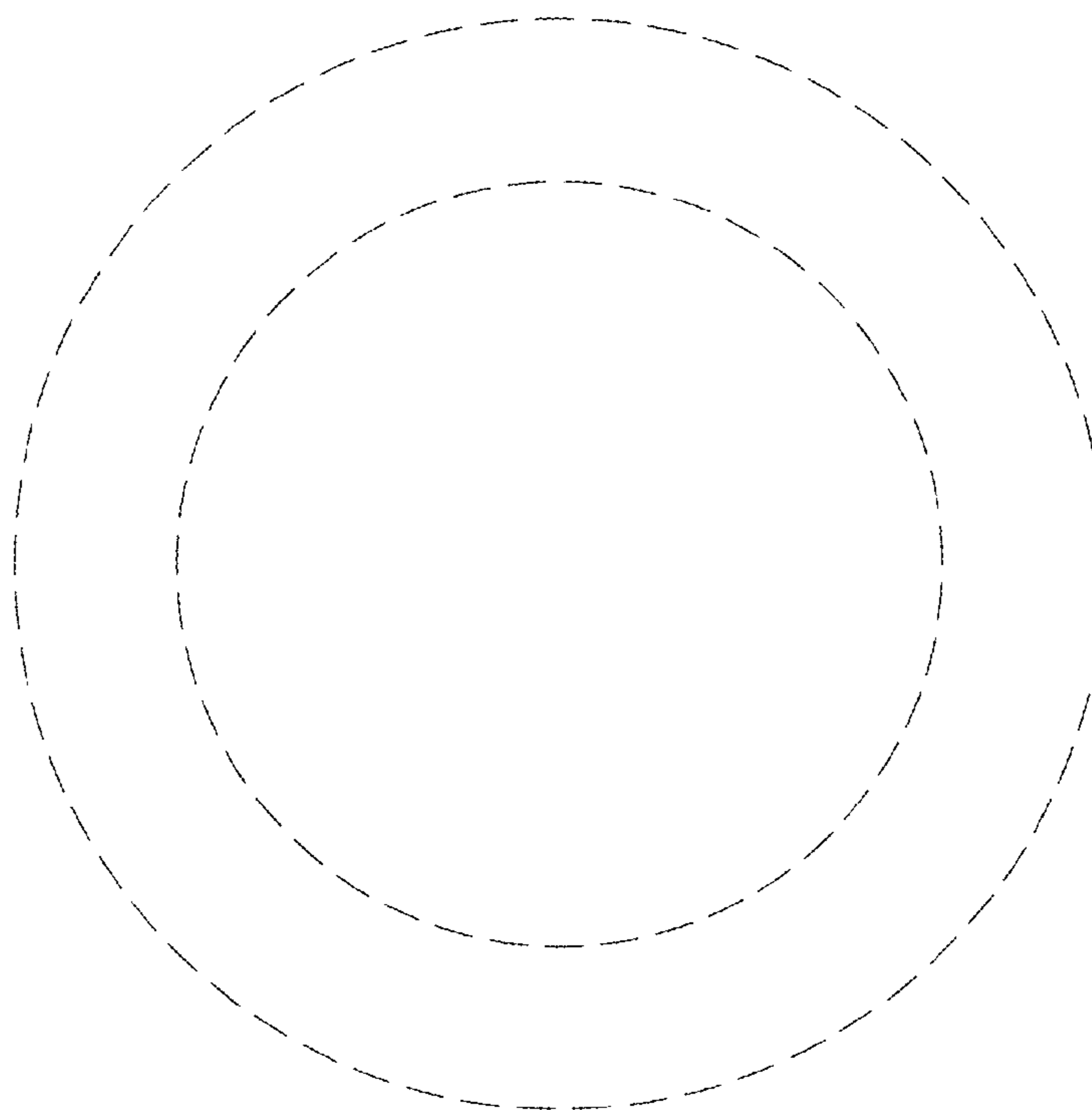

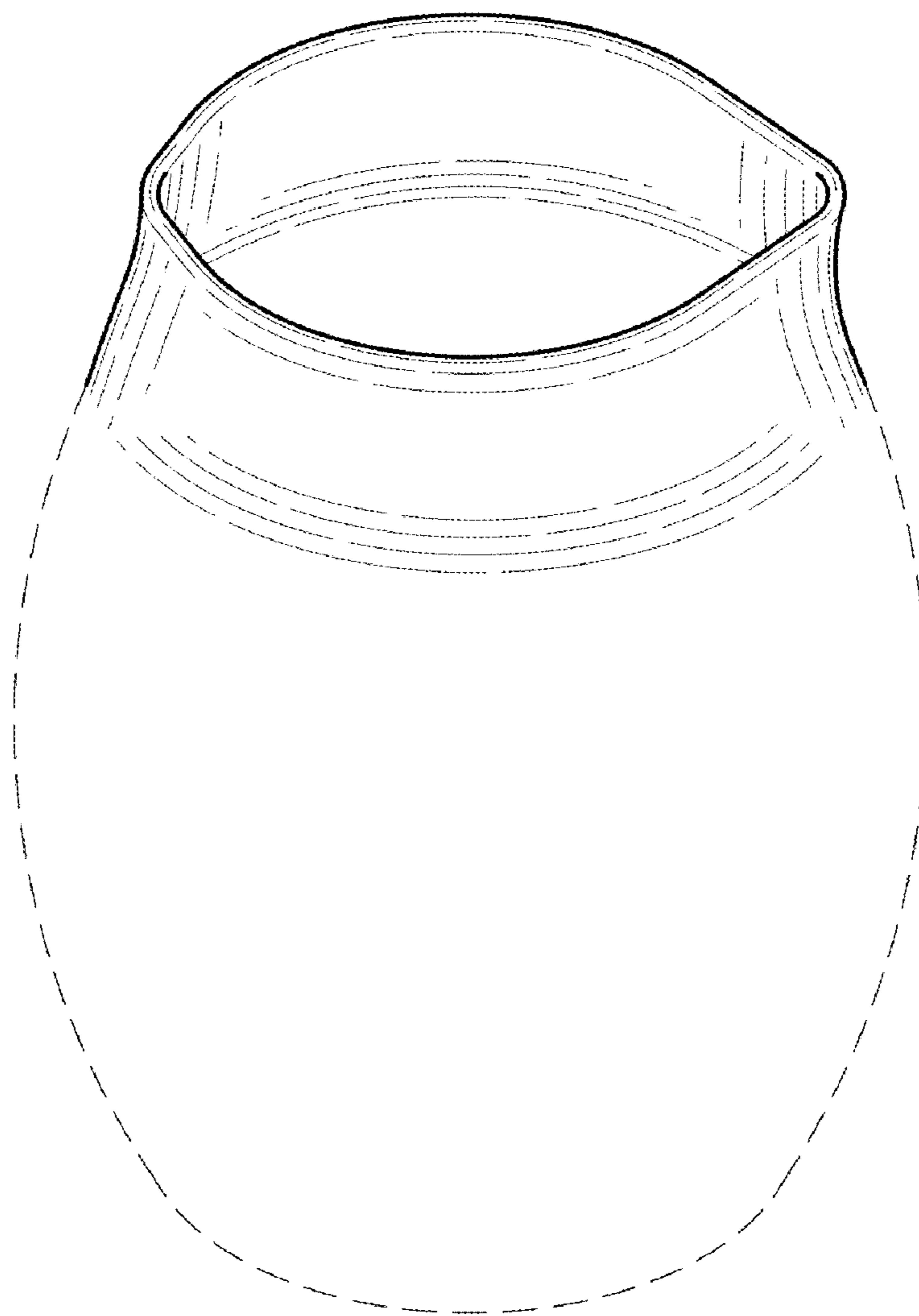

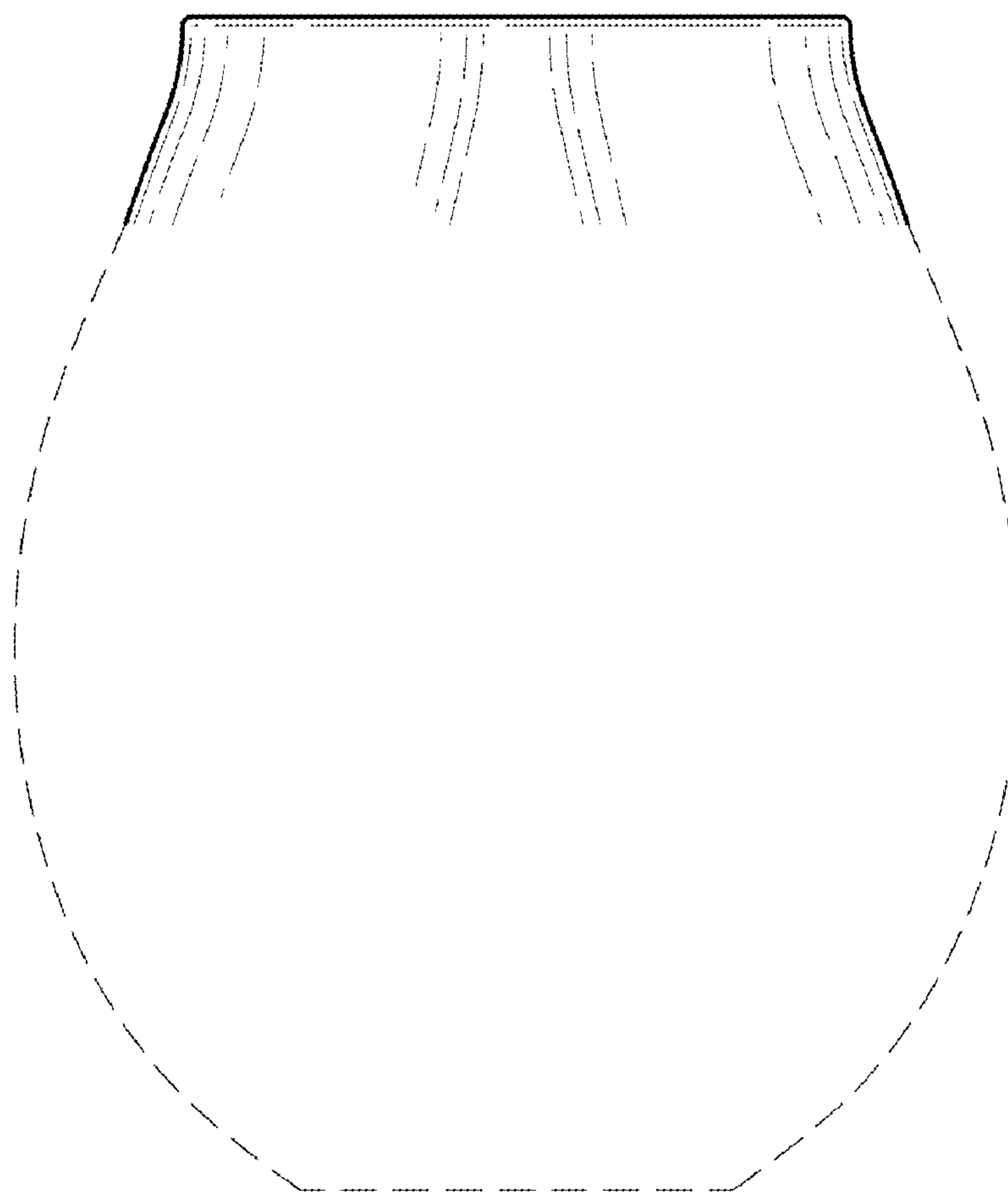

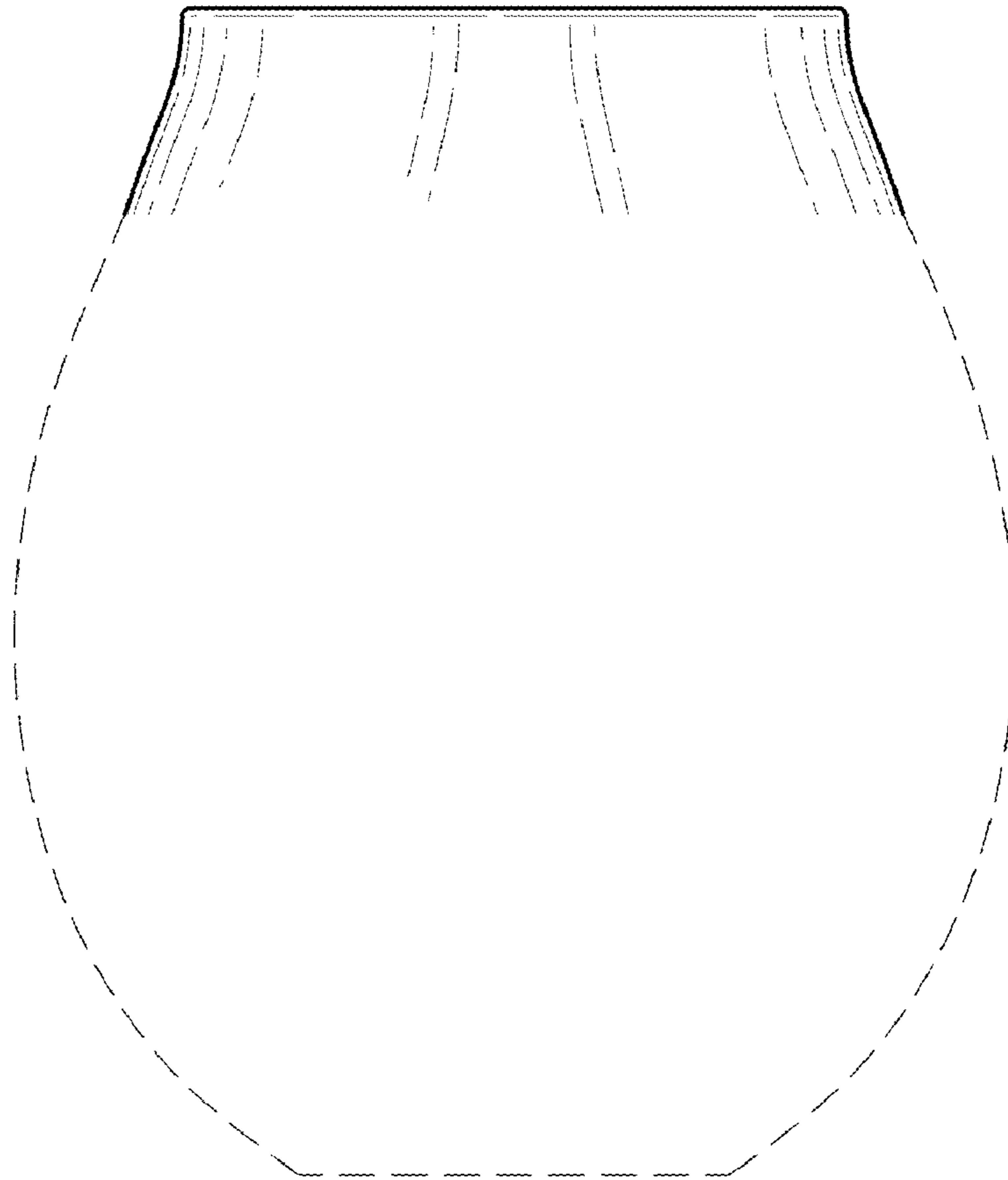

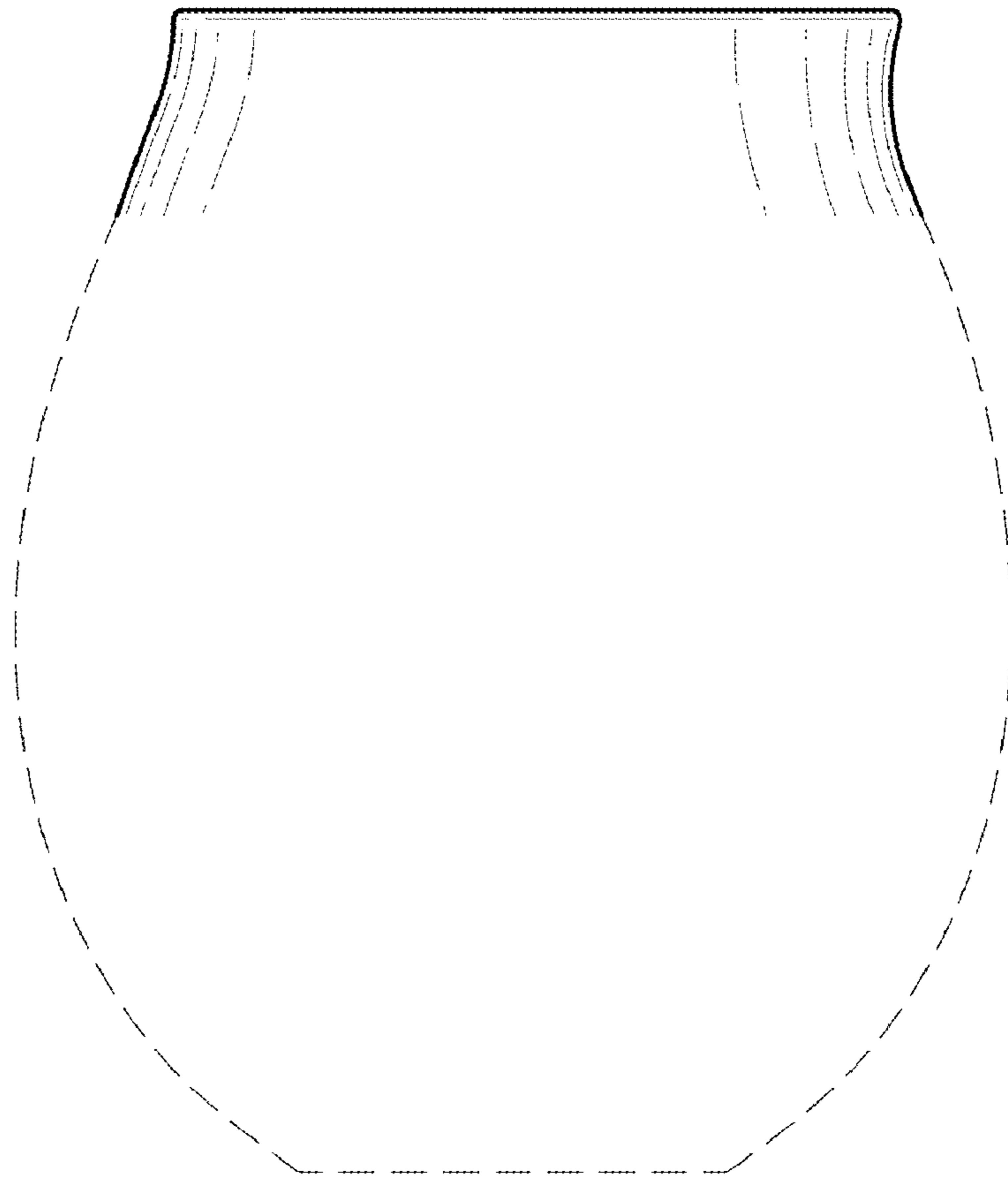

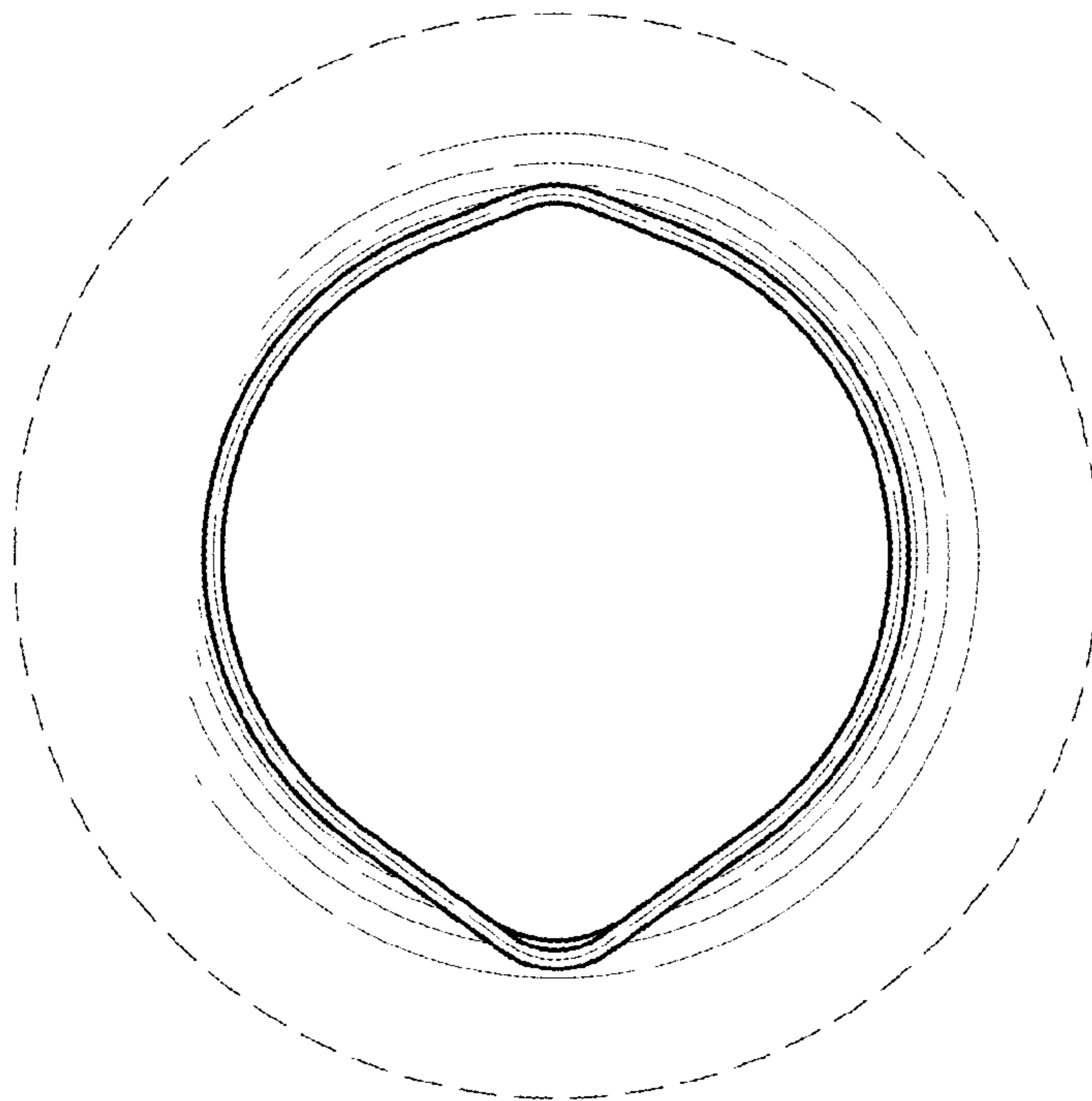
