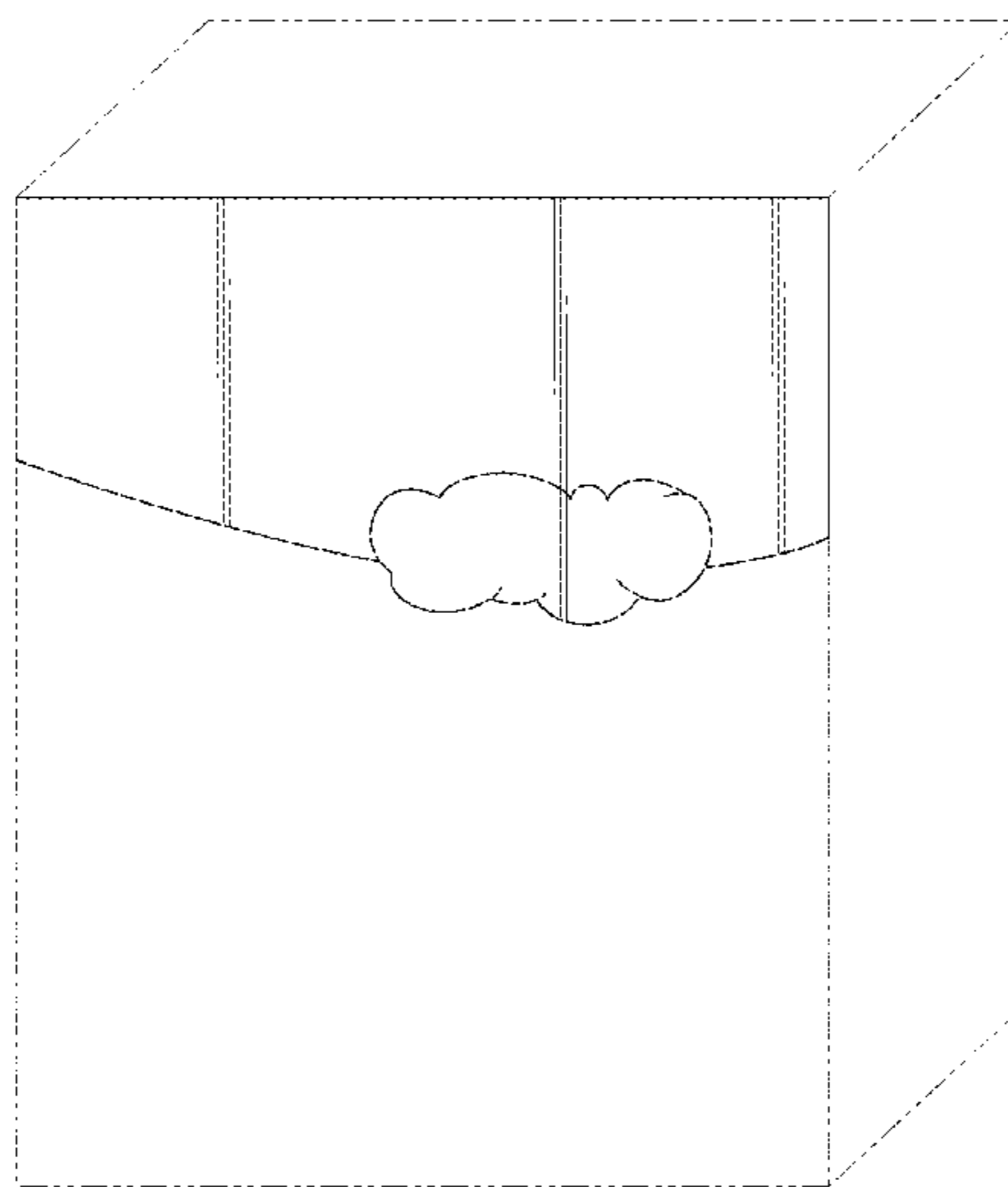
We claim the ornamental design for a package, as shown and
