FIG. 5 is an assembled, side view thereof taken from the left of FIG. 1;

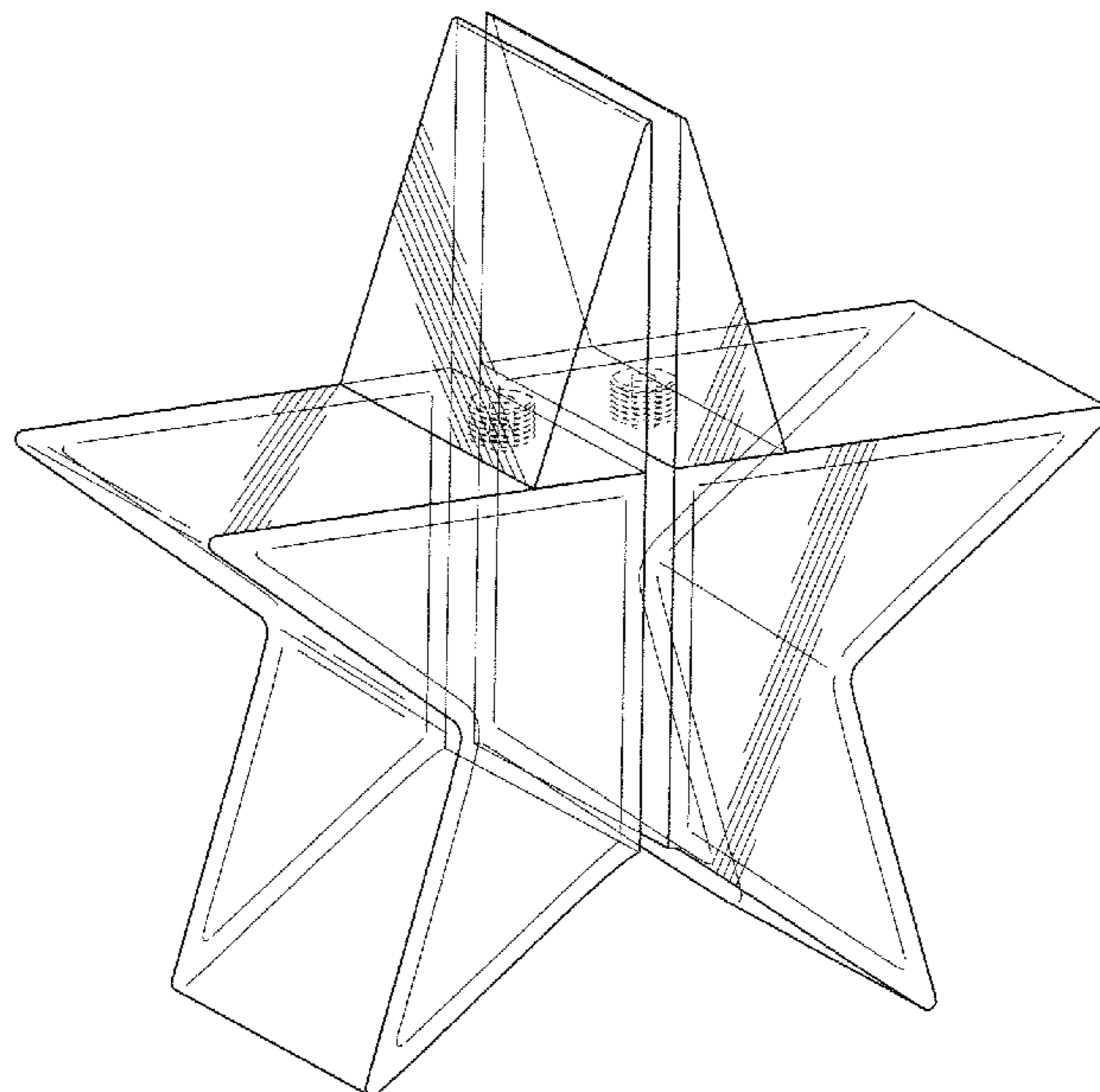
FIG. 6 is an assembled, top view thereof;

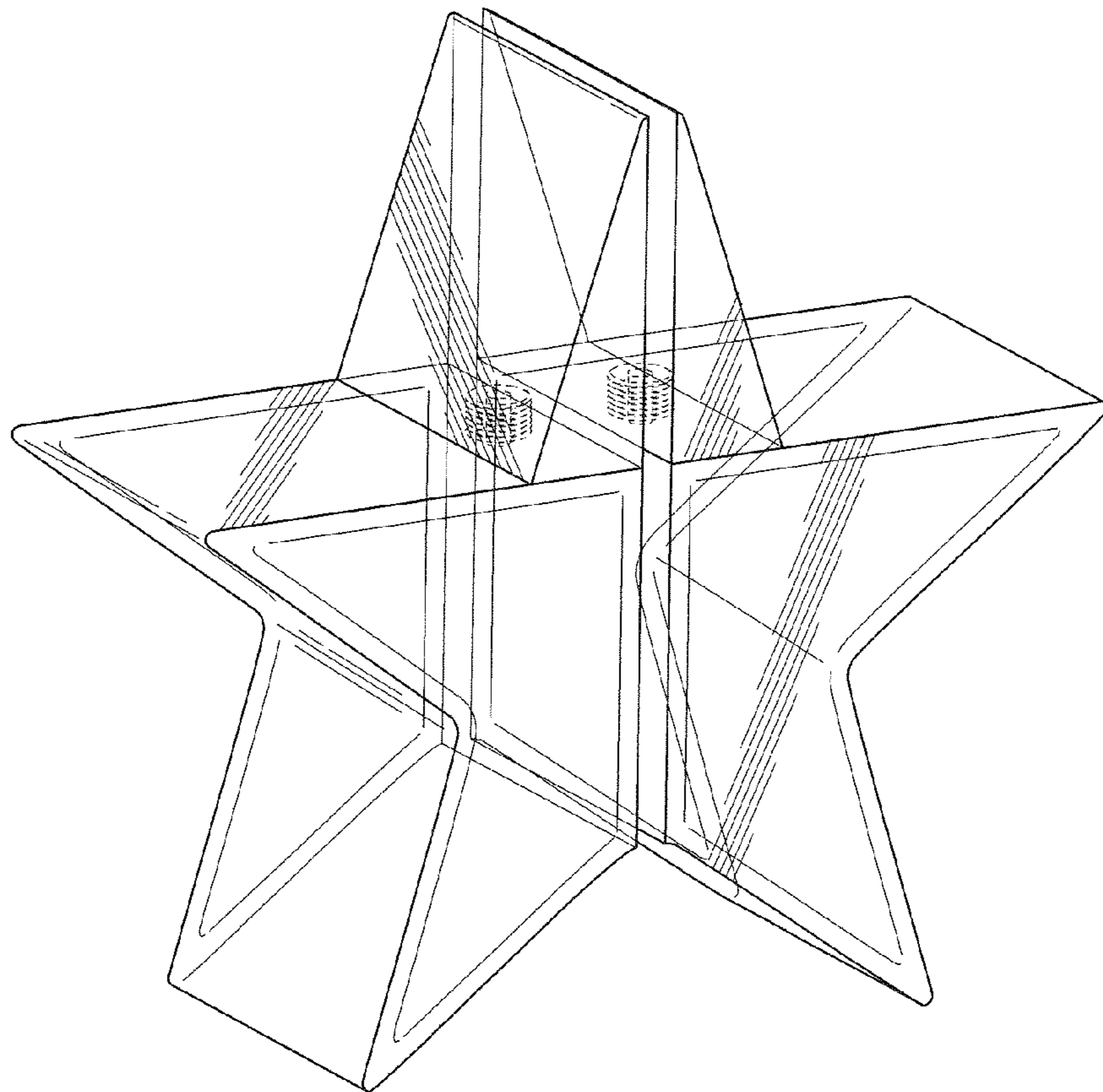

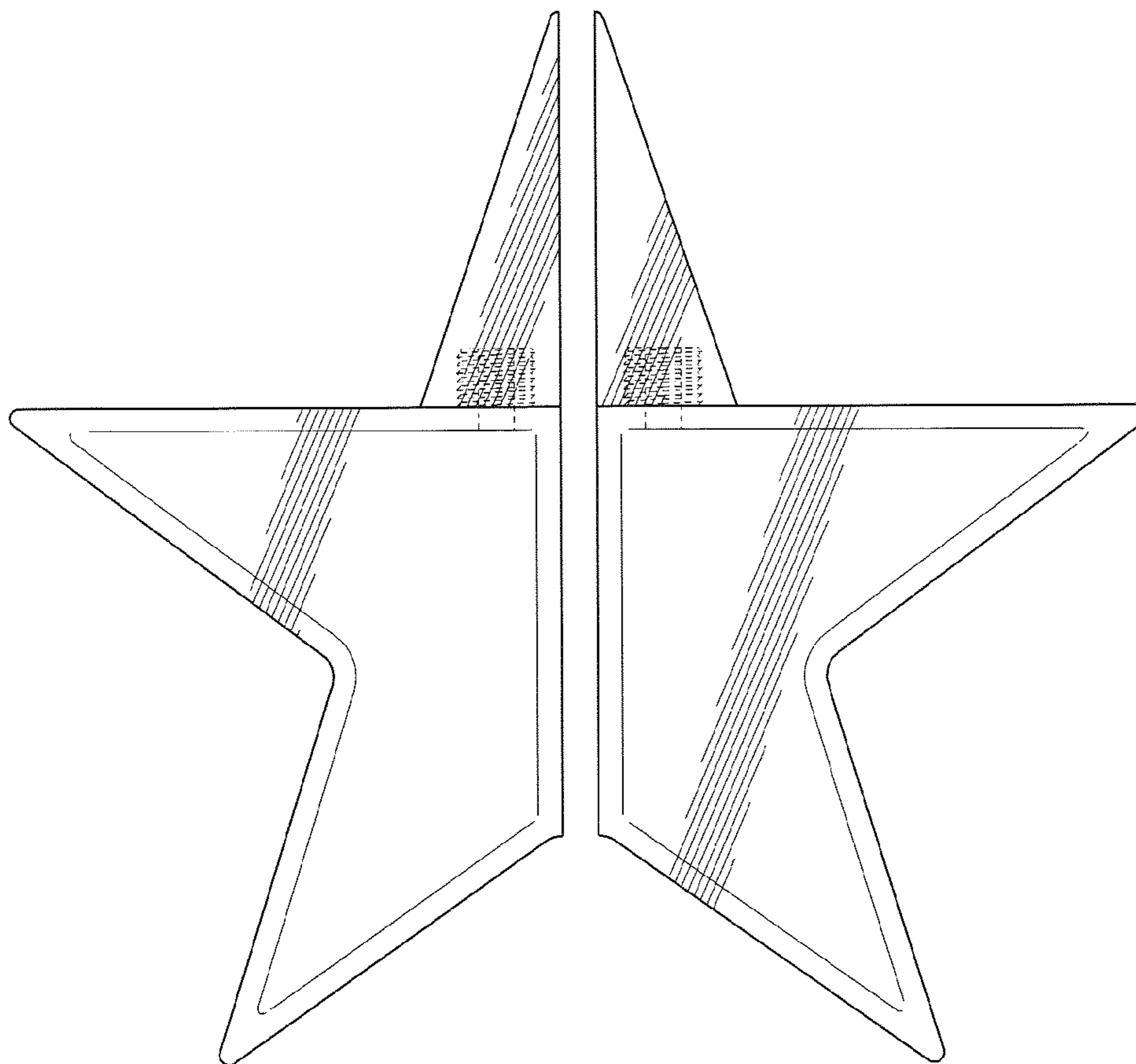

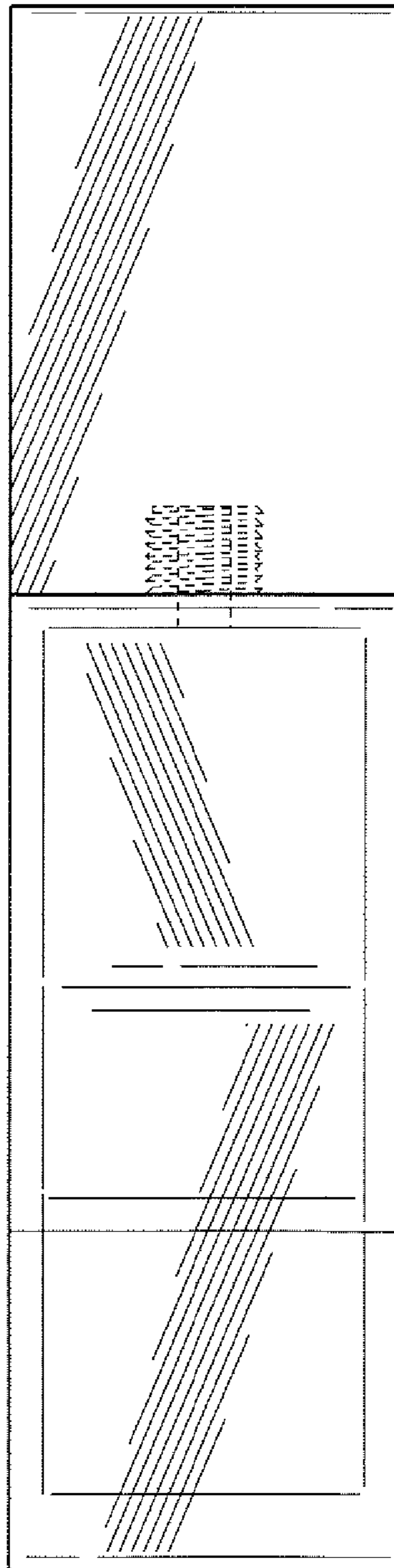

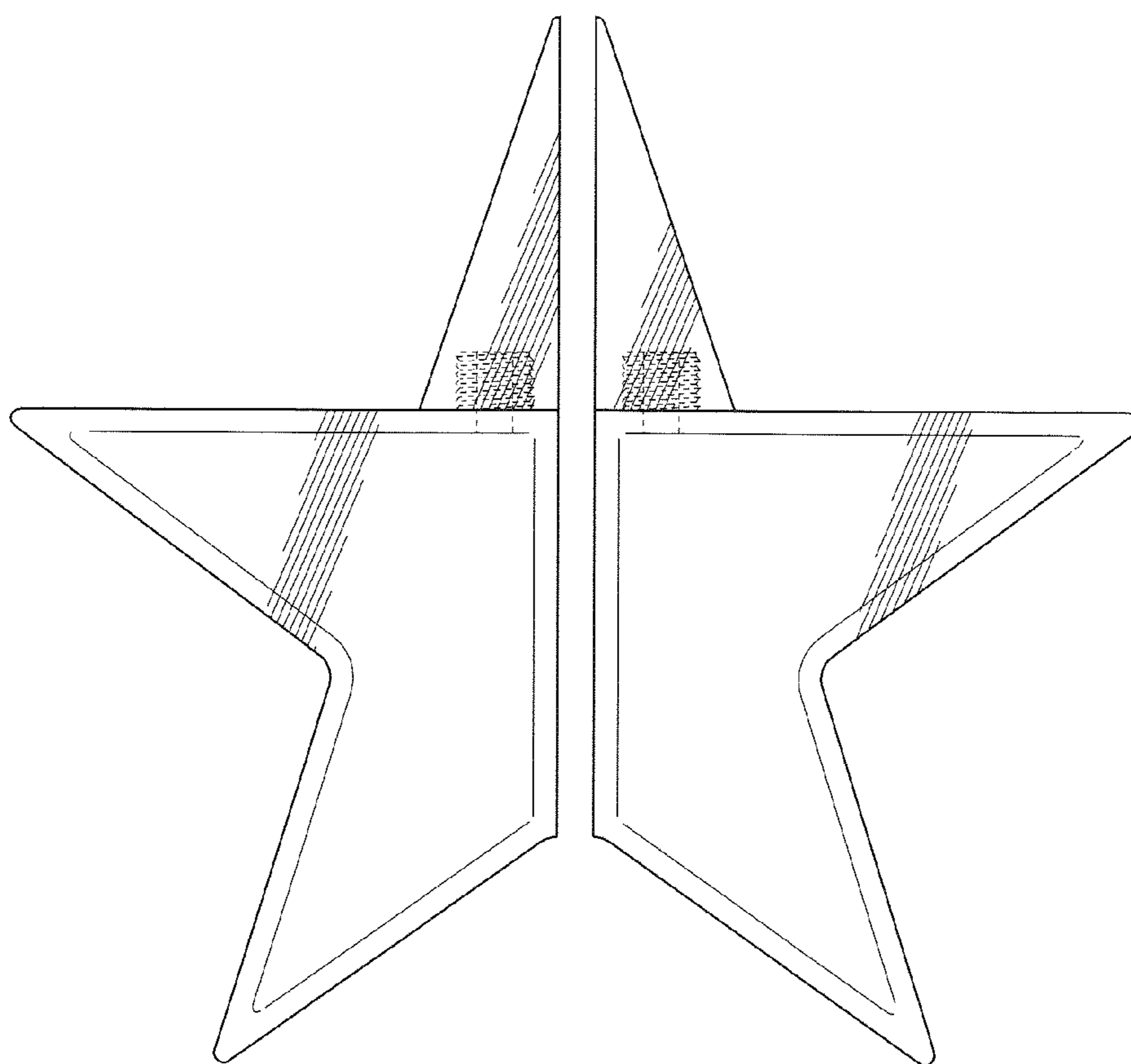

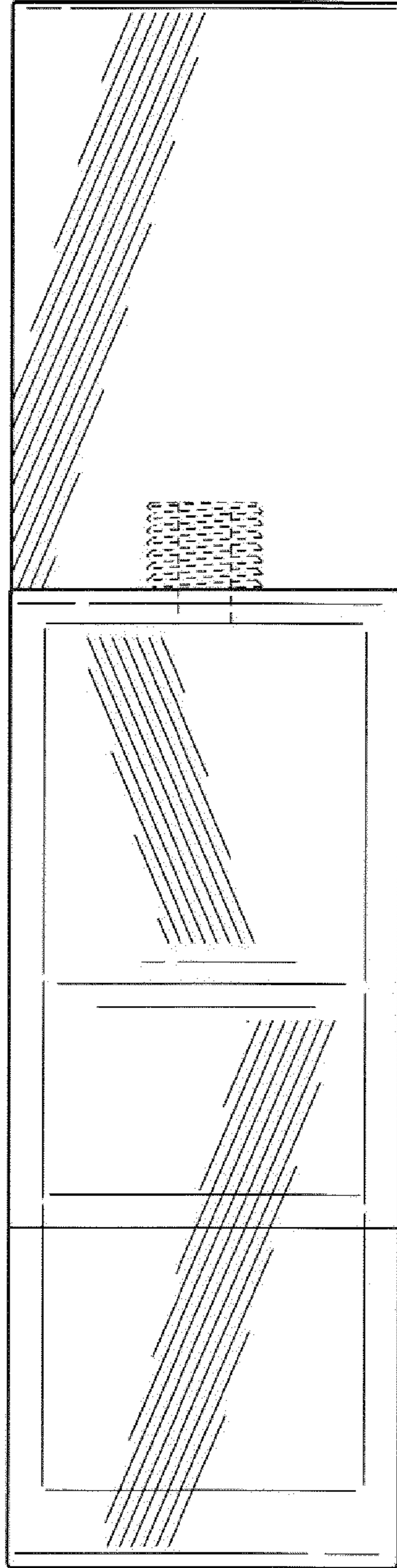

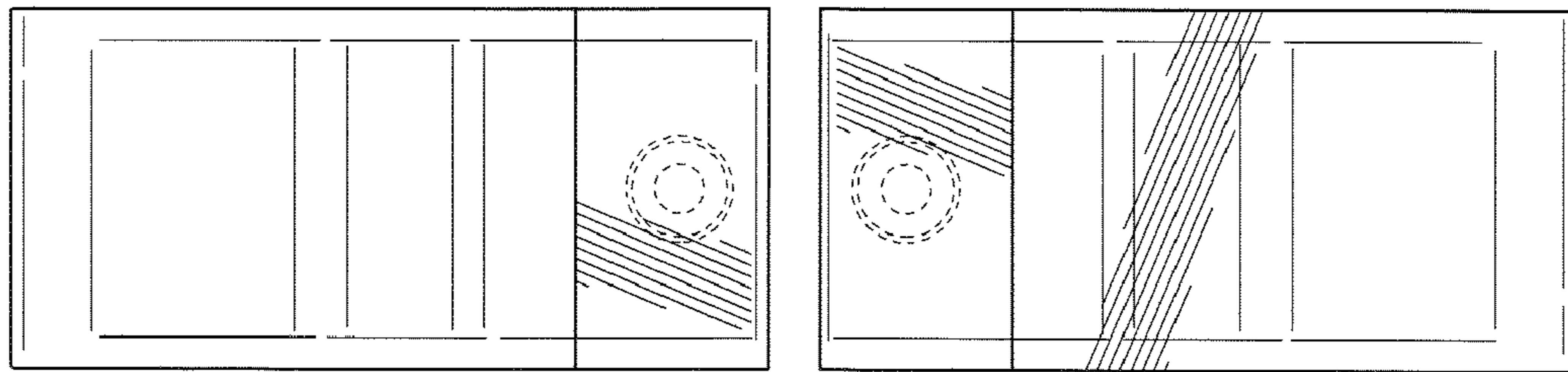

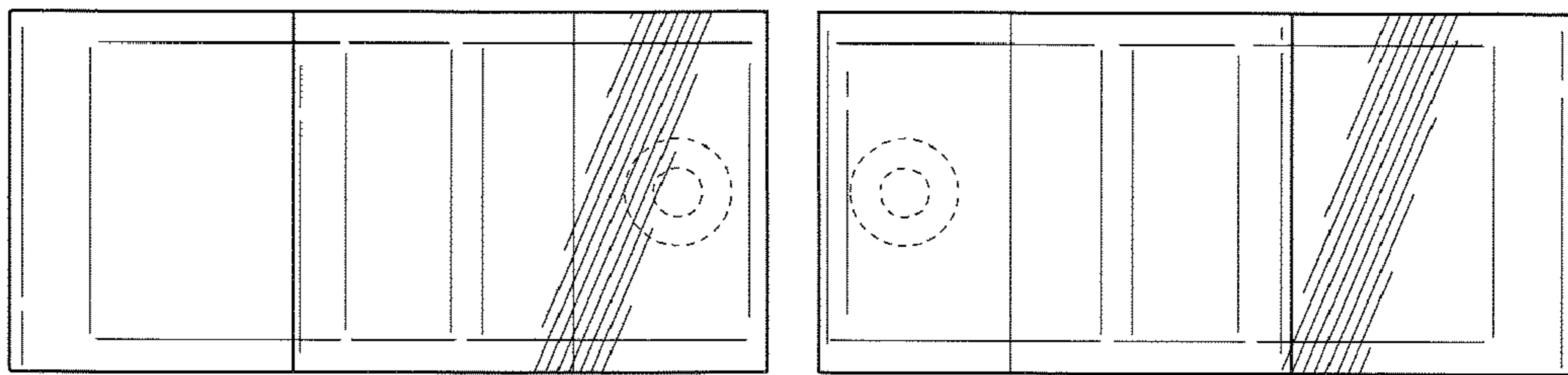

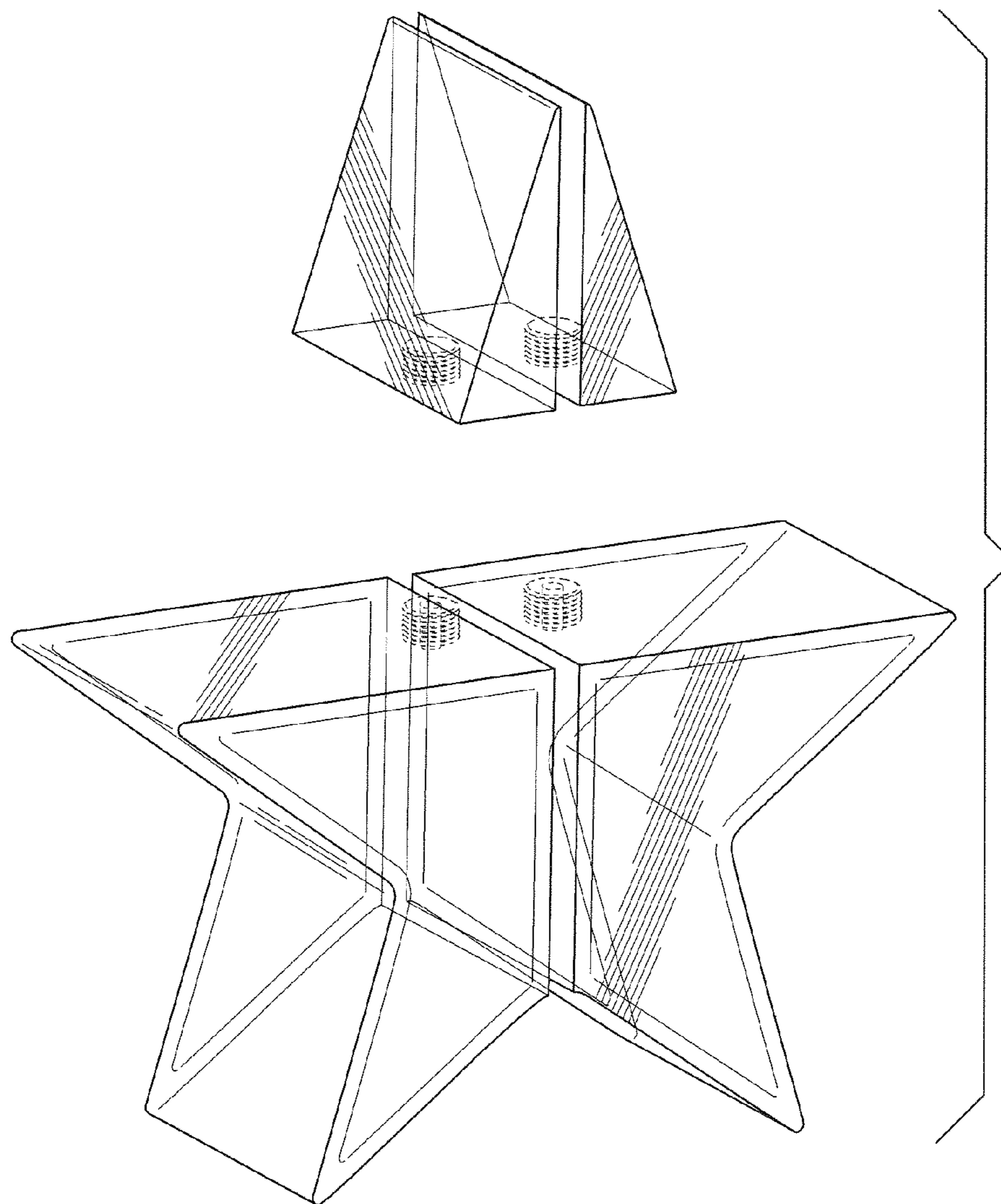
