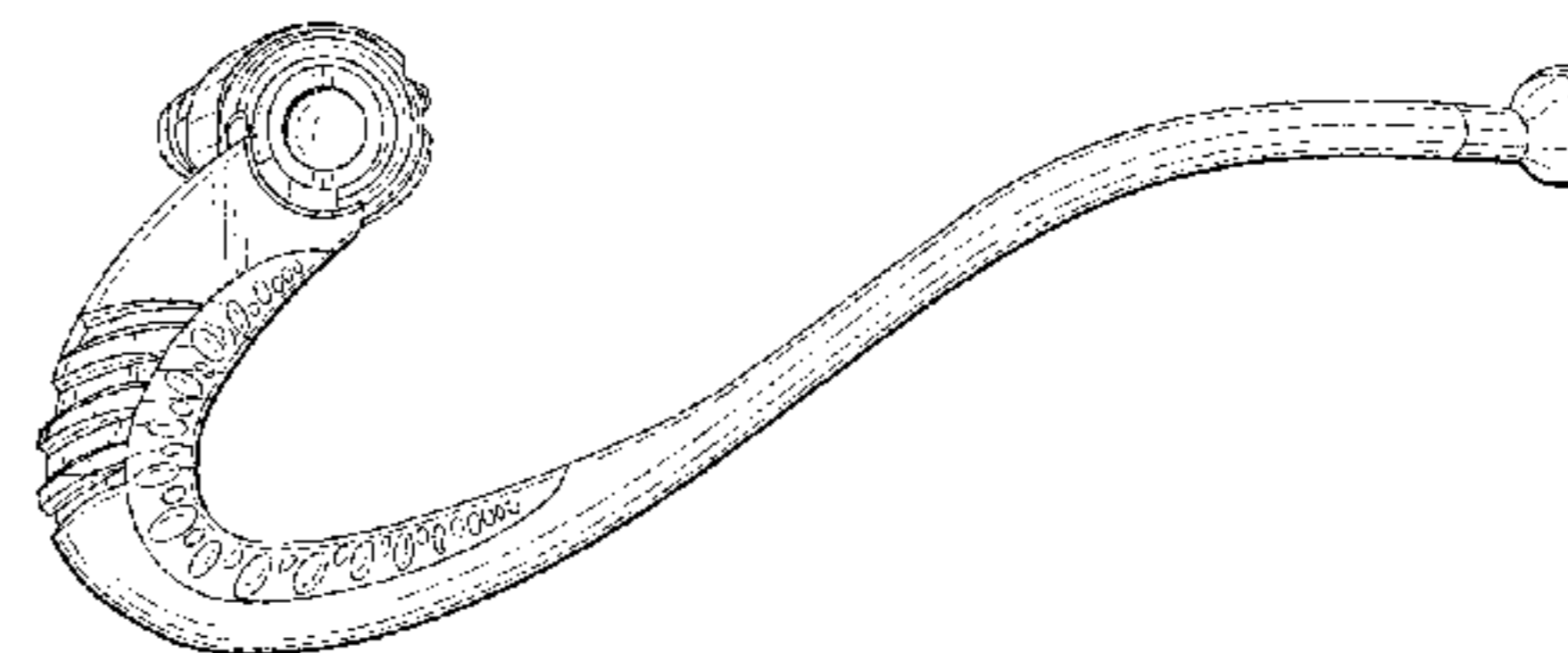
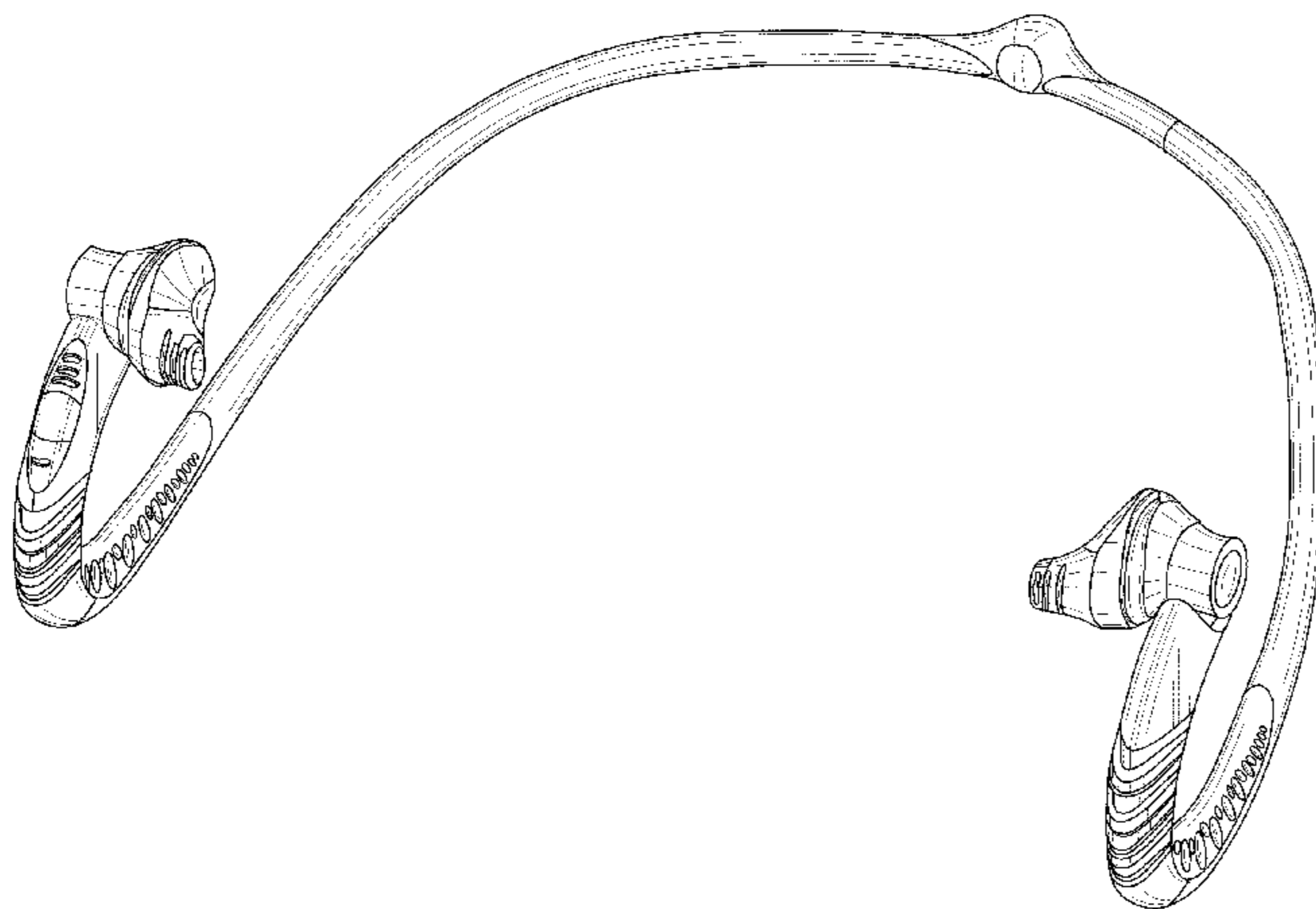
(57) **CLAIM**

The ornamental design for a behind the neck wireless headset,
as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the behind the neck wireless headset showing our new design, the opposite perspective front face of the ear insert being a mirror image;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevation view;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a rear elevation view;
FIG. 6 is a (partial) right-side elevation view thereof; and,
FIG. 7 is a (partial) left-side elevation view thereof.

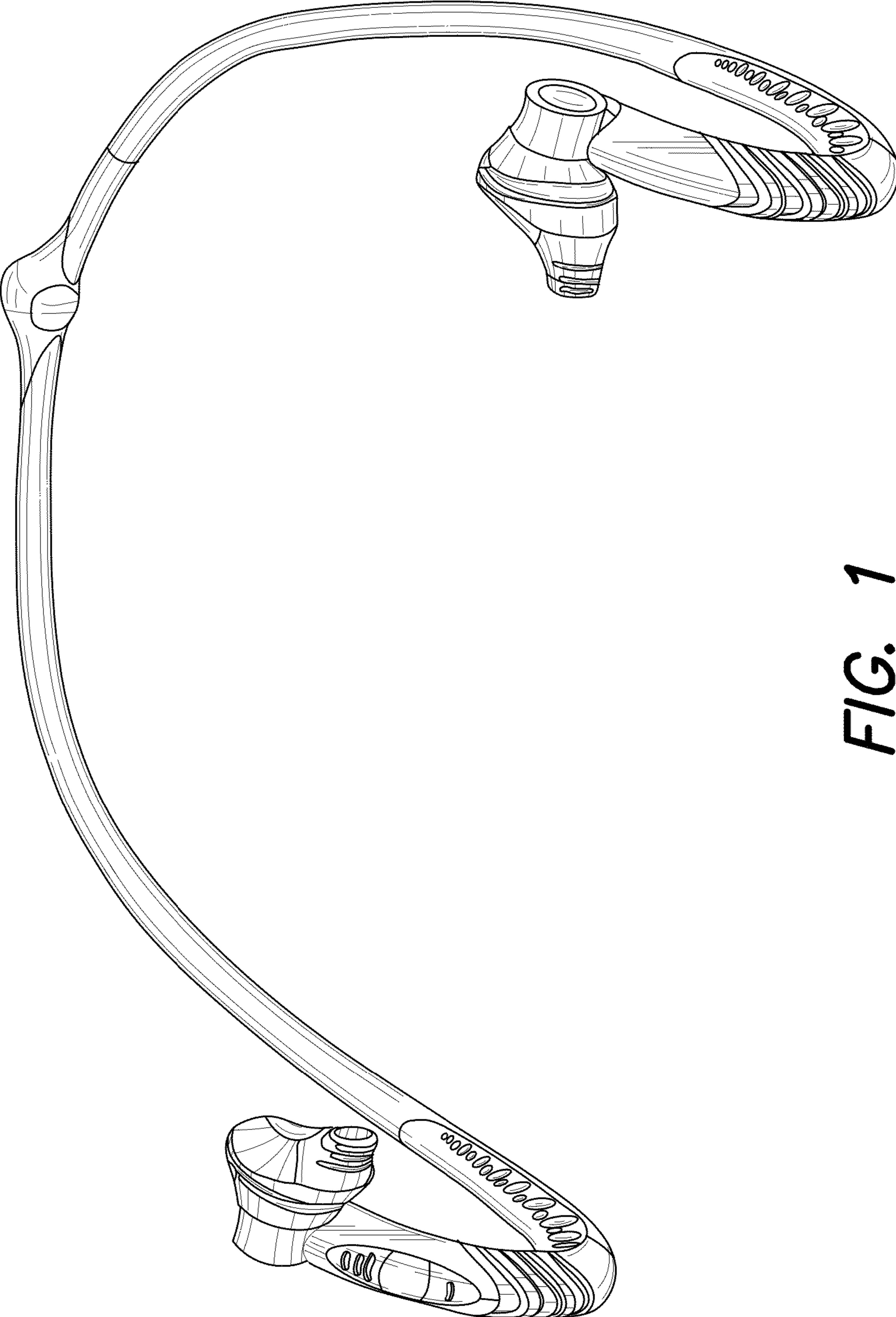

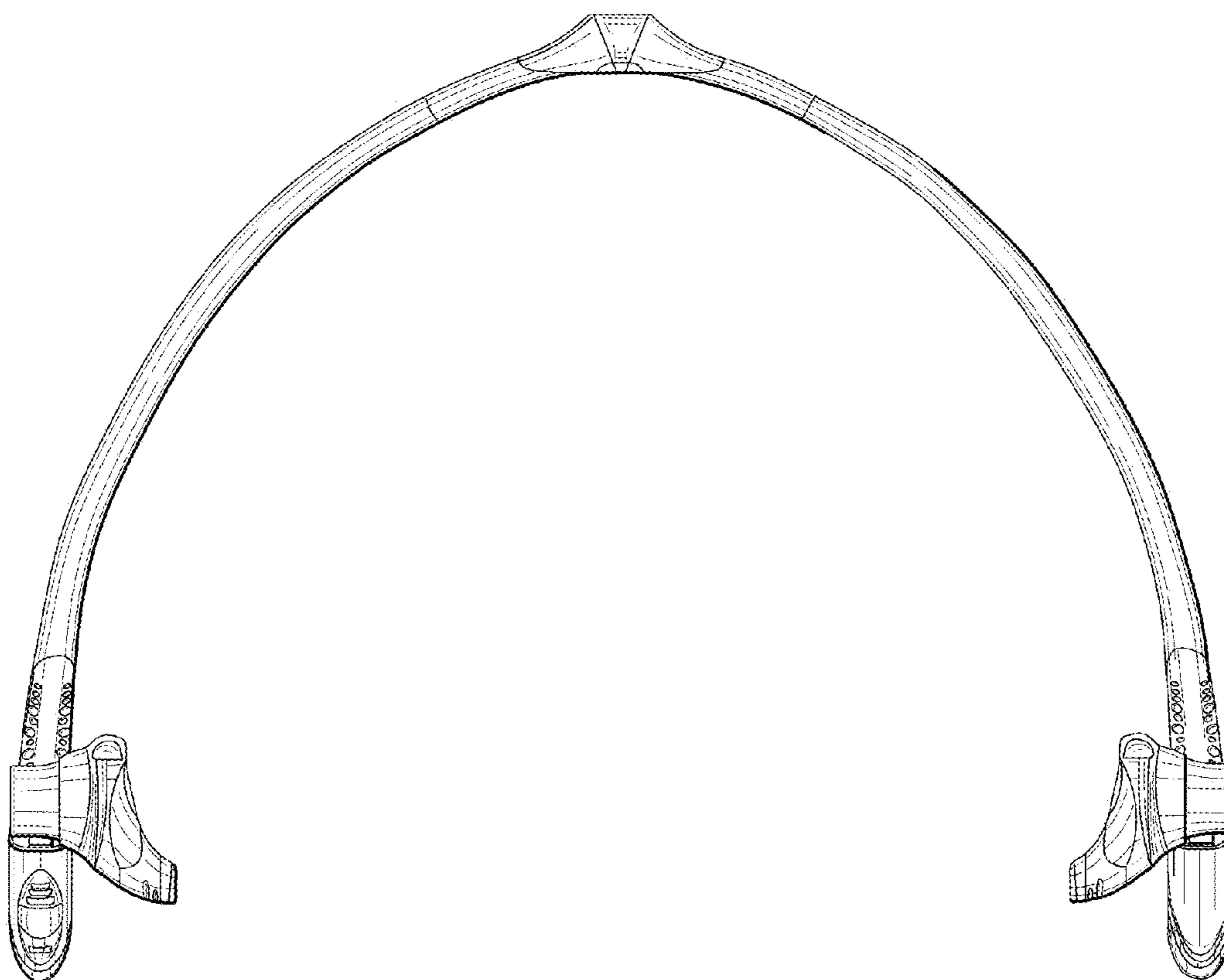

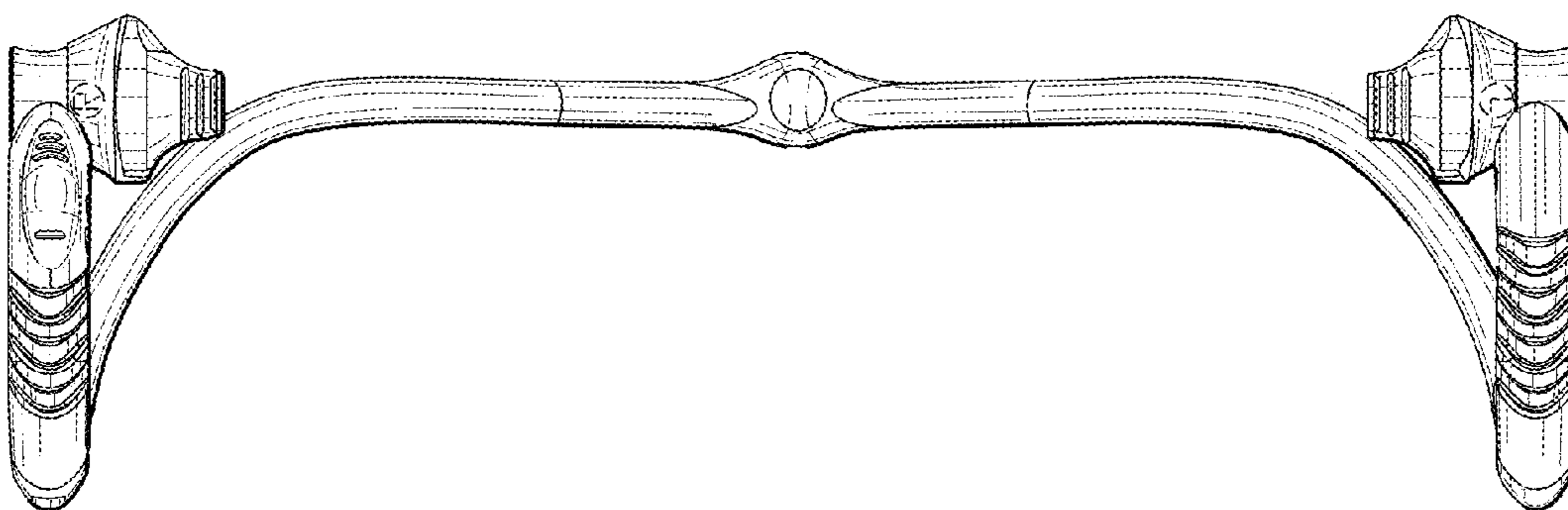

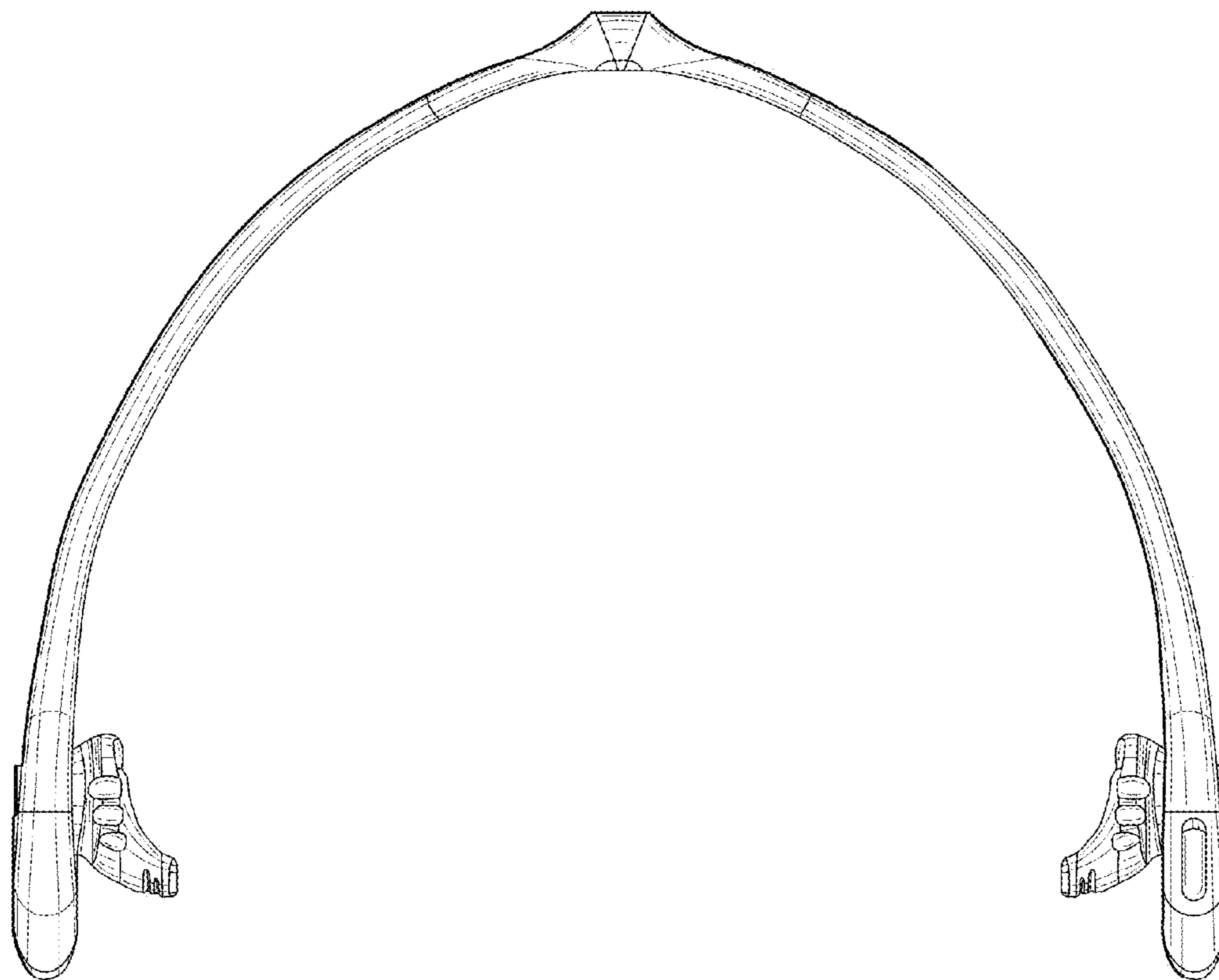

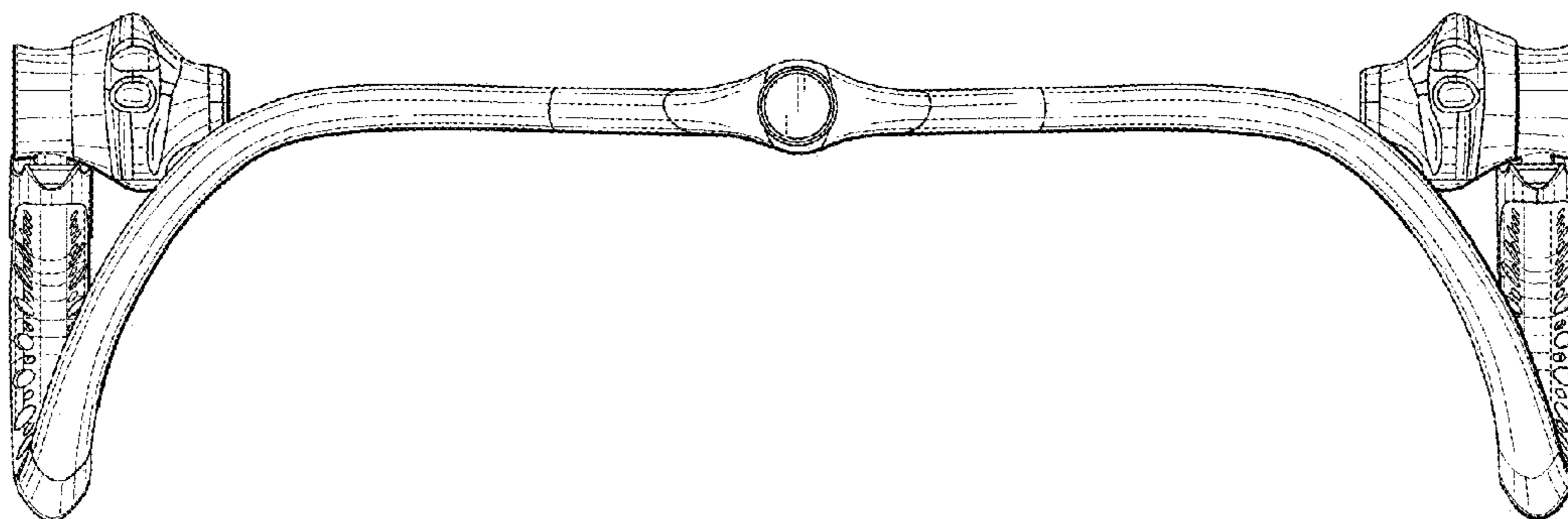

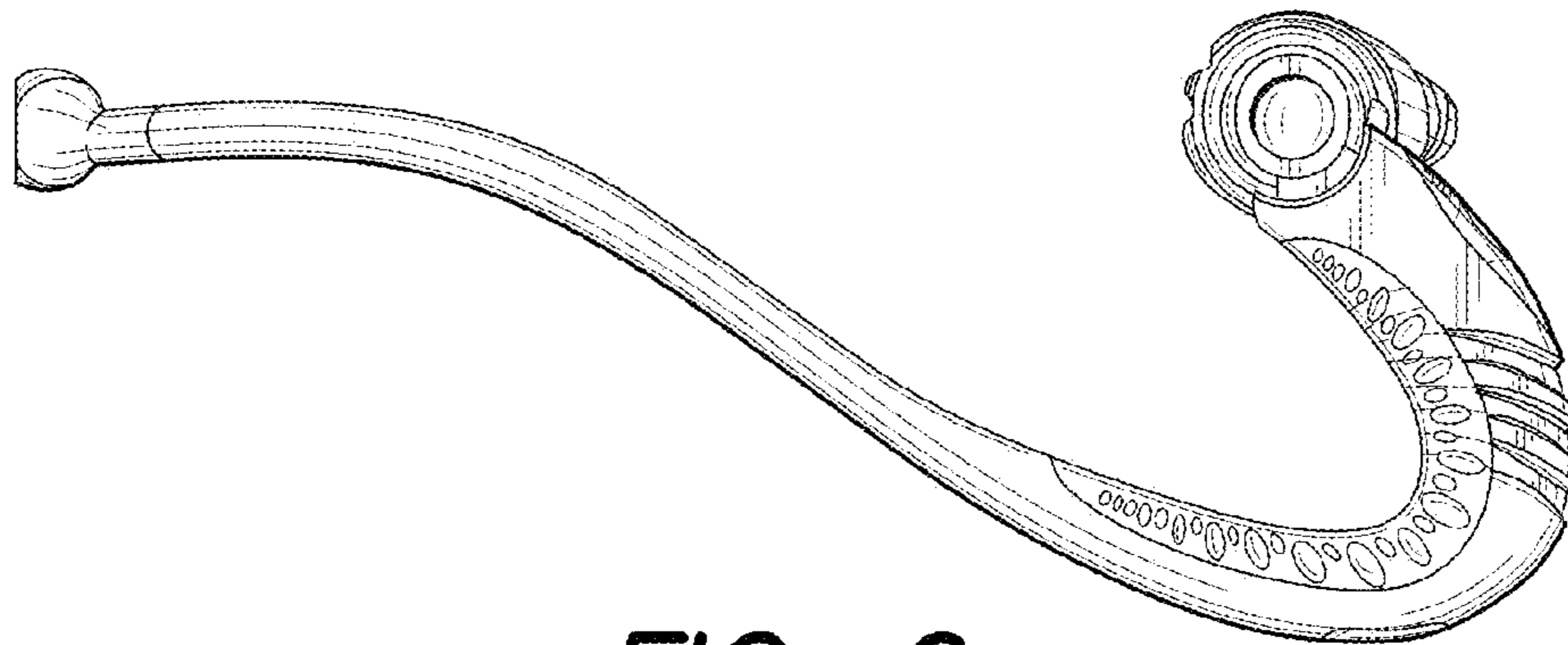

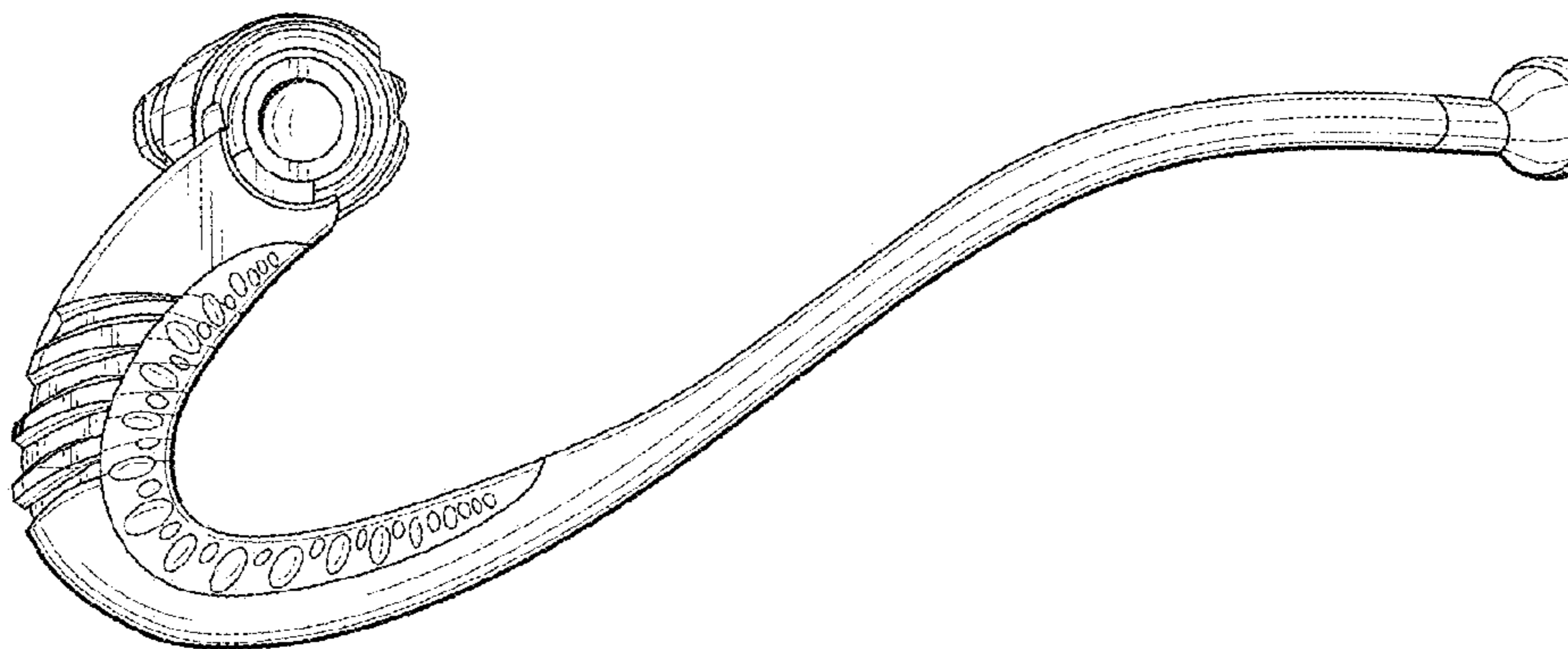
