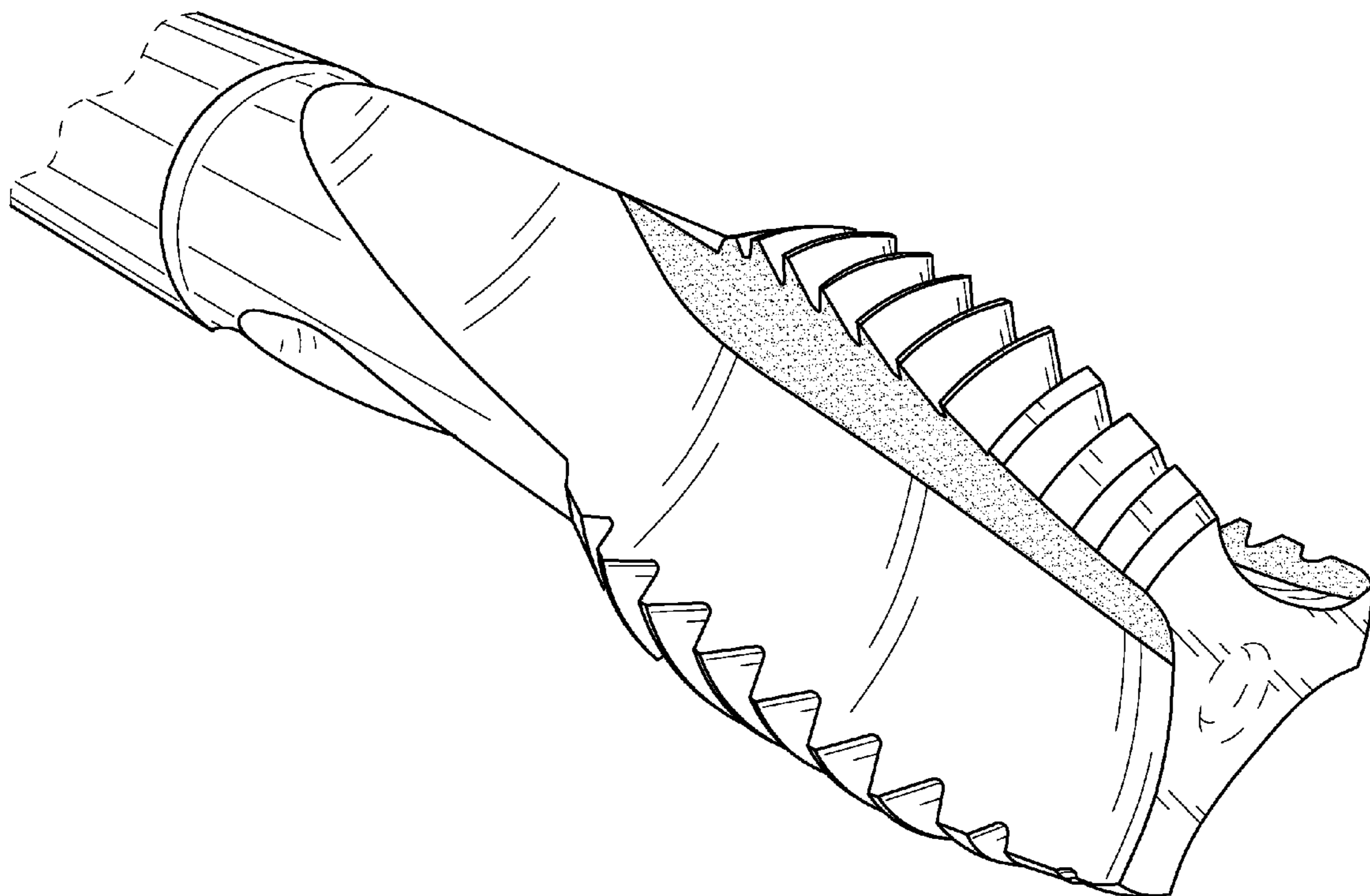
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an upper perspective view of our new design for a screw thread cutting tool;

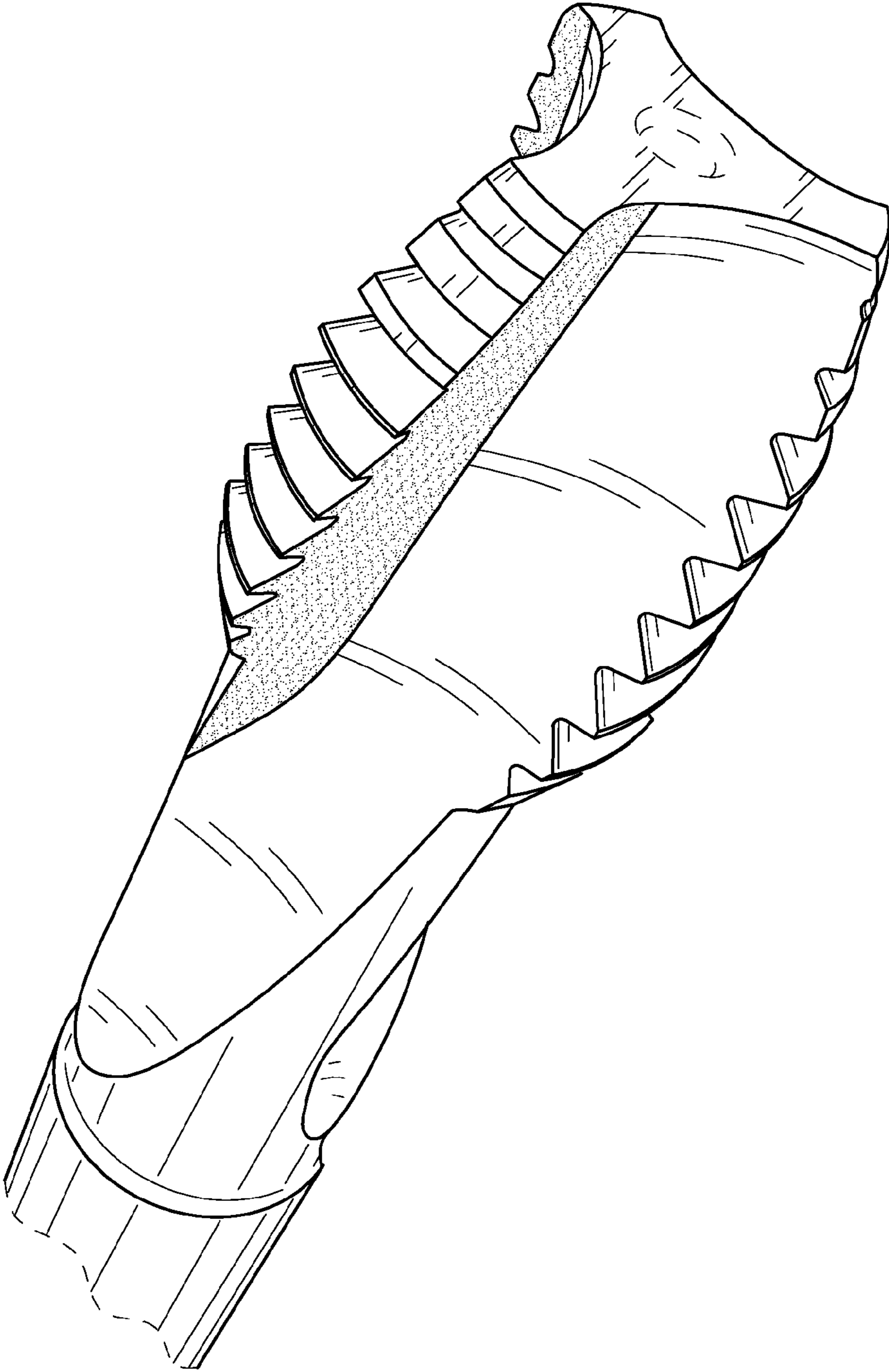

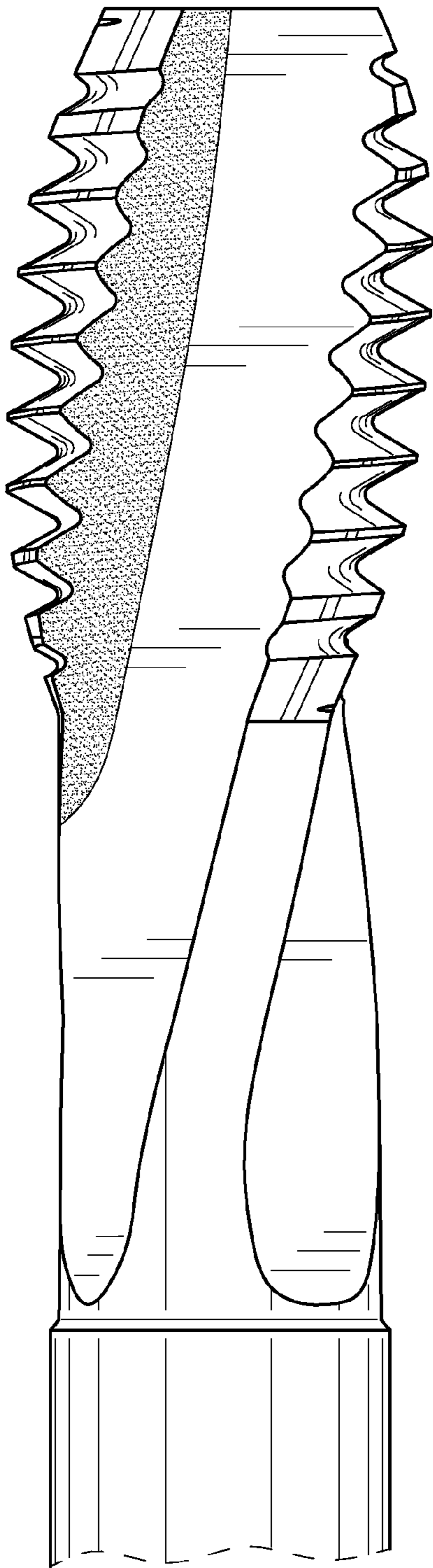

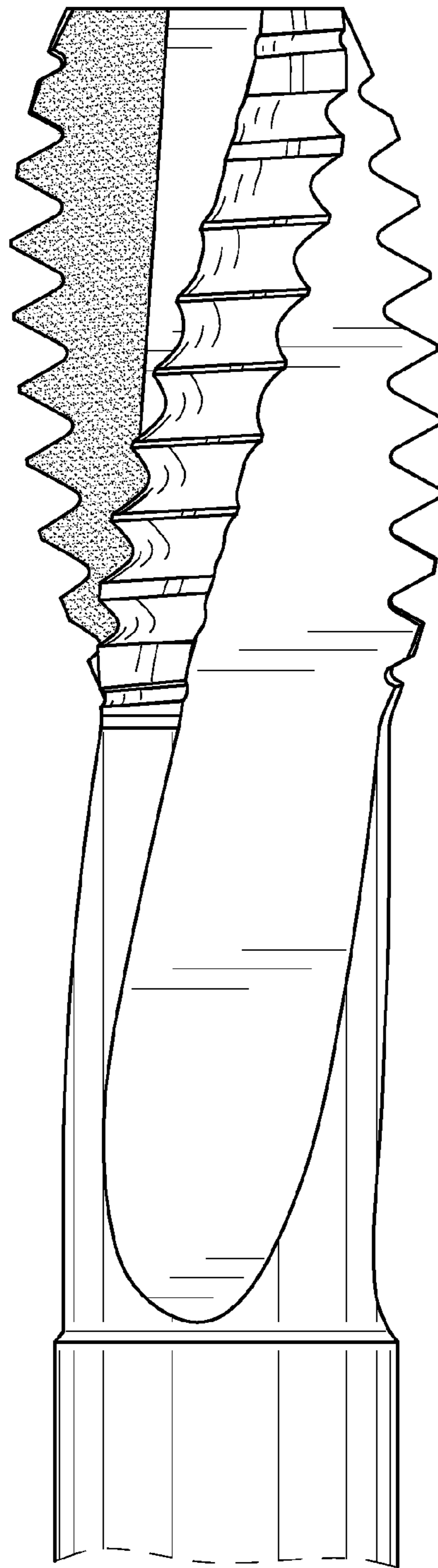

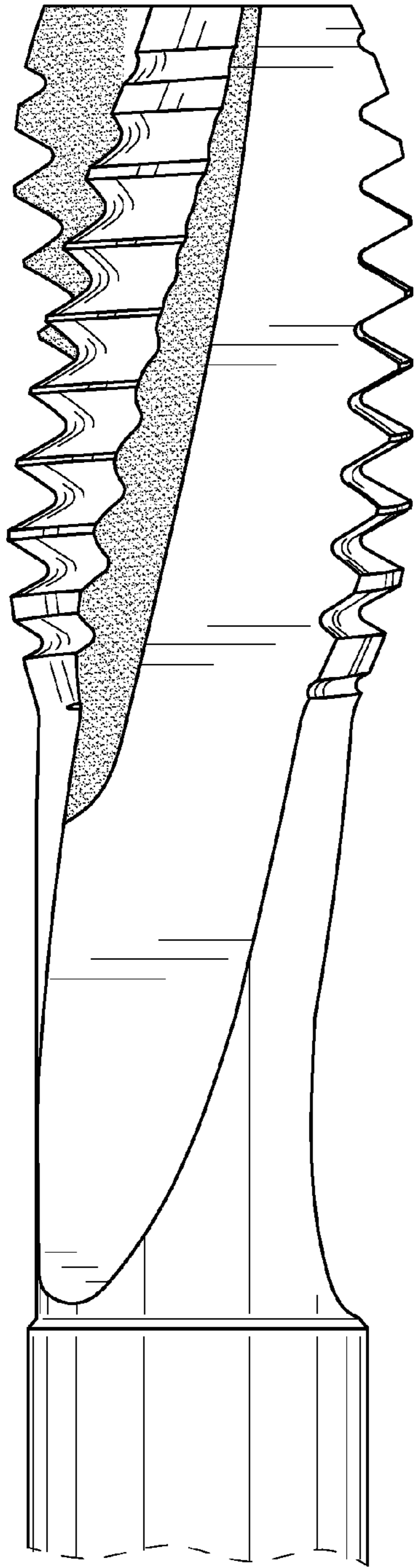

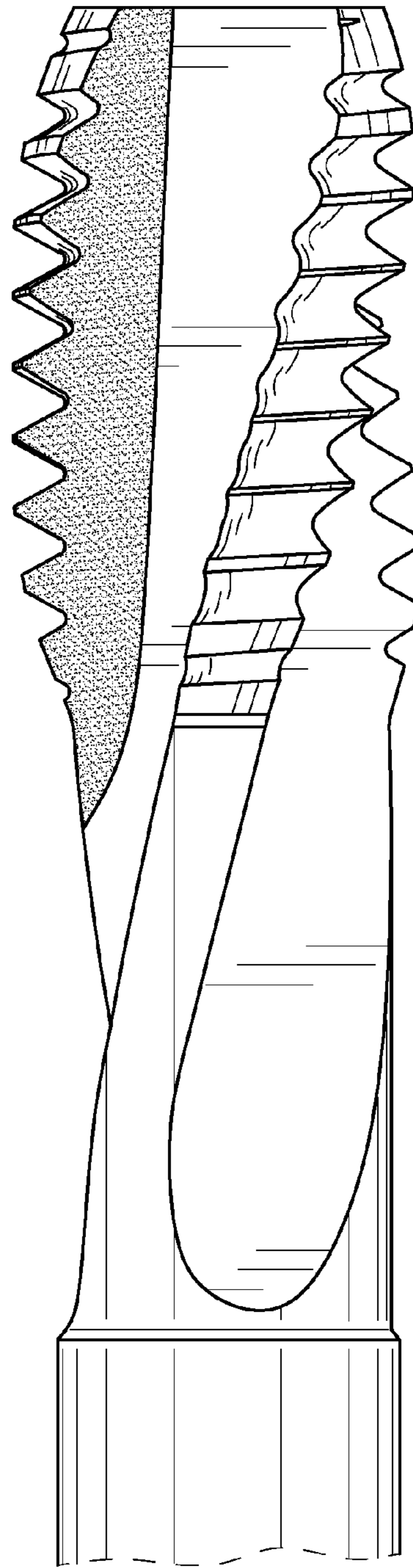

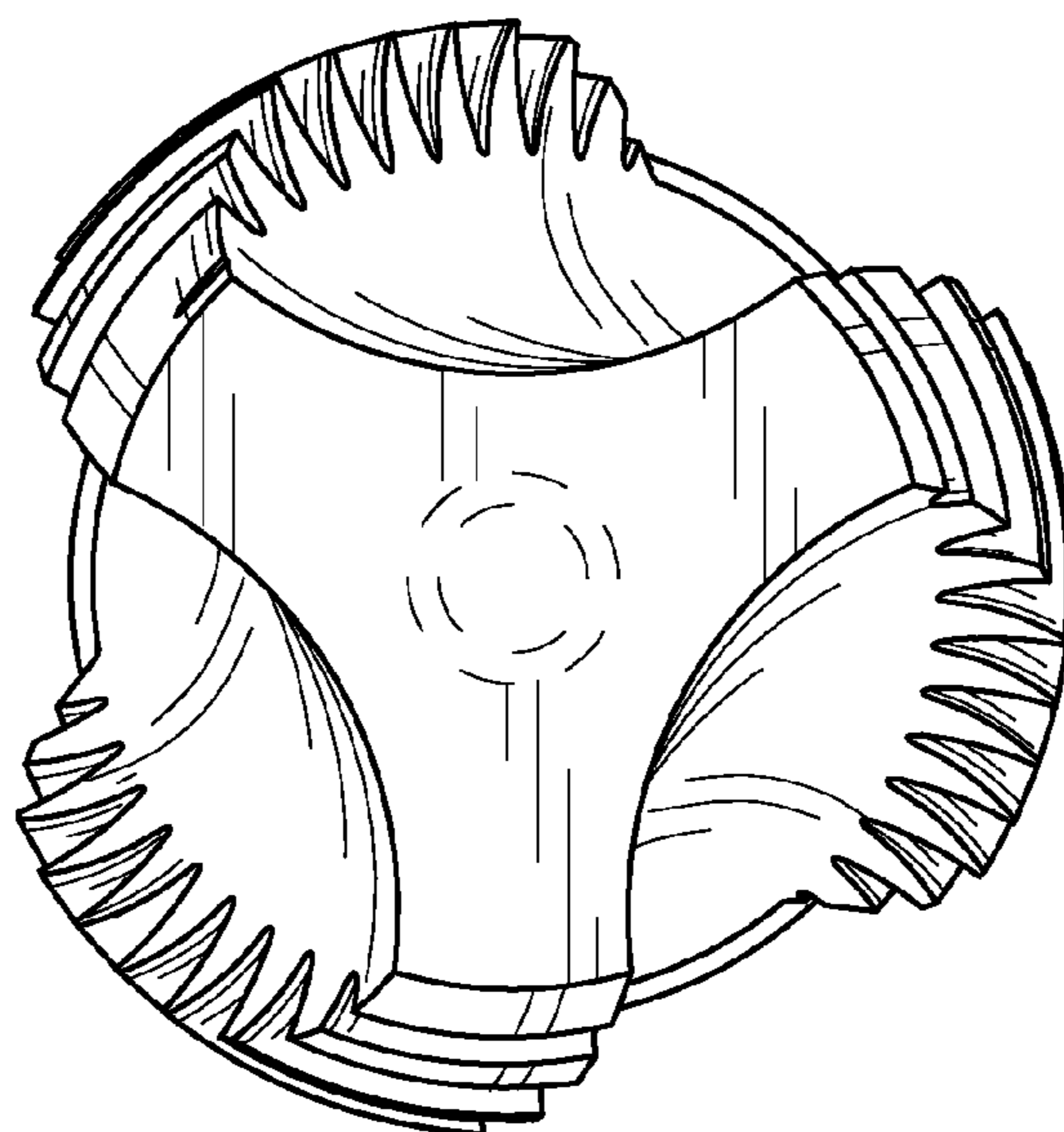

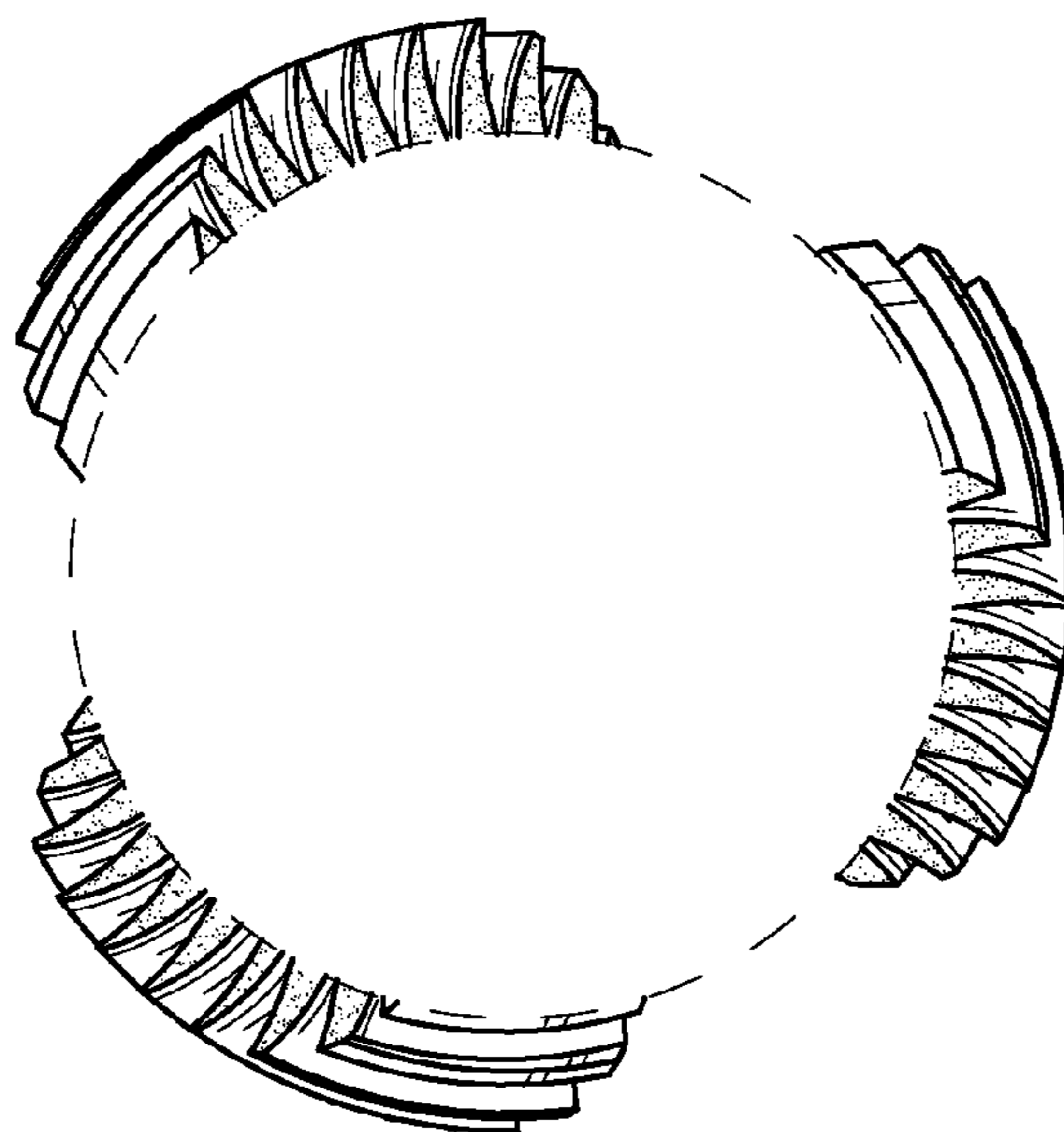
