(57) **CLAIM**

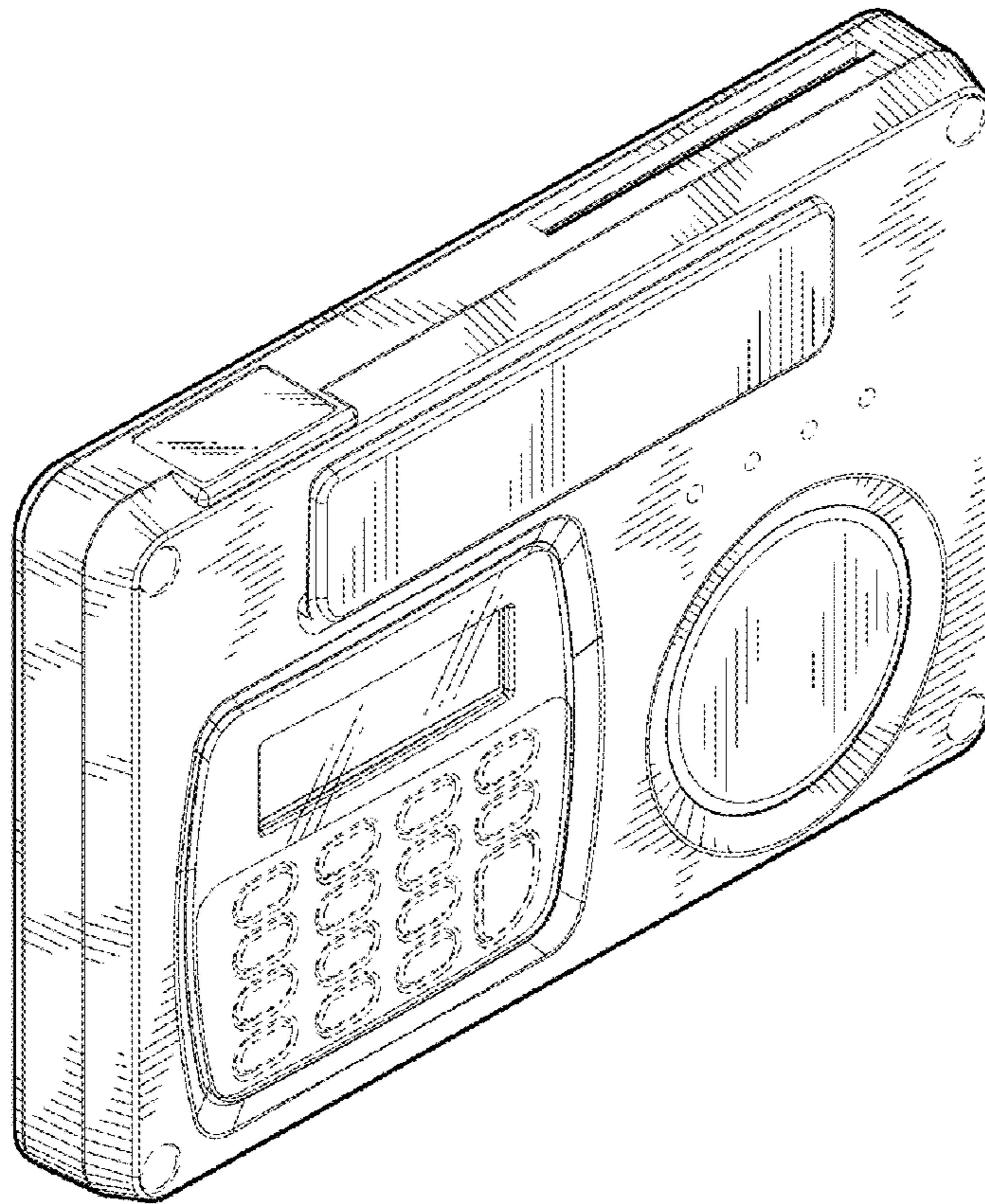
The ornamental design for a 5-in-1 payment module, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a 5-in-1 payment module;
FIG. 2 is a front elevational view thereof;

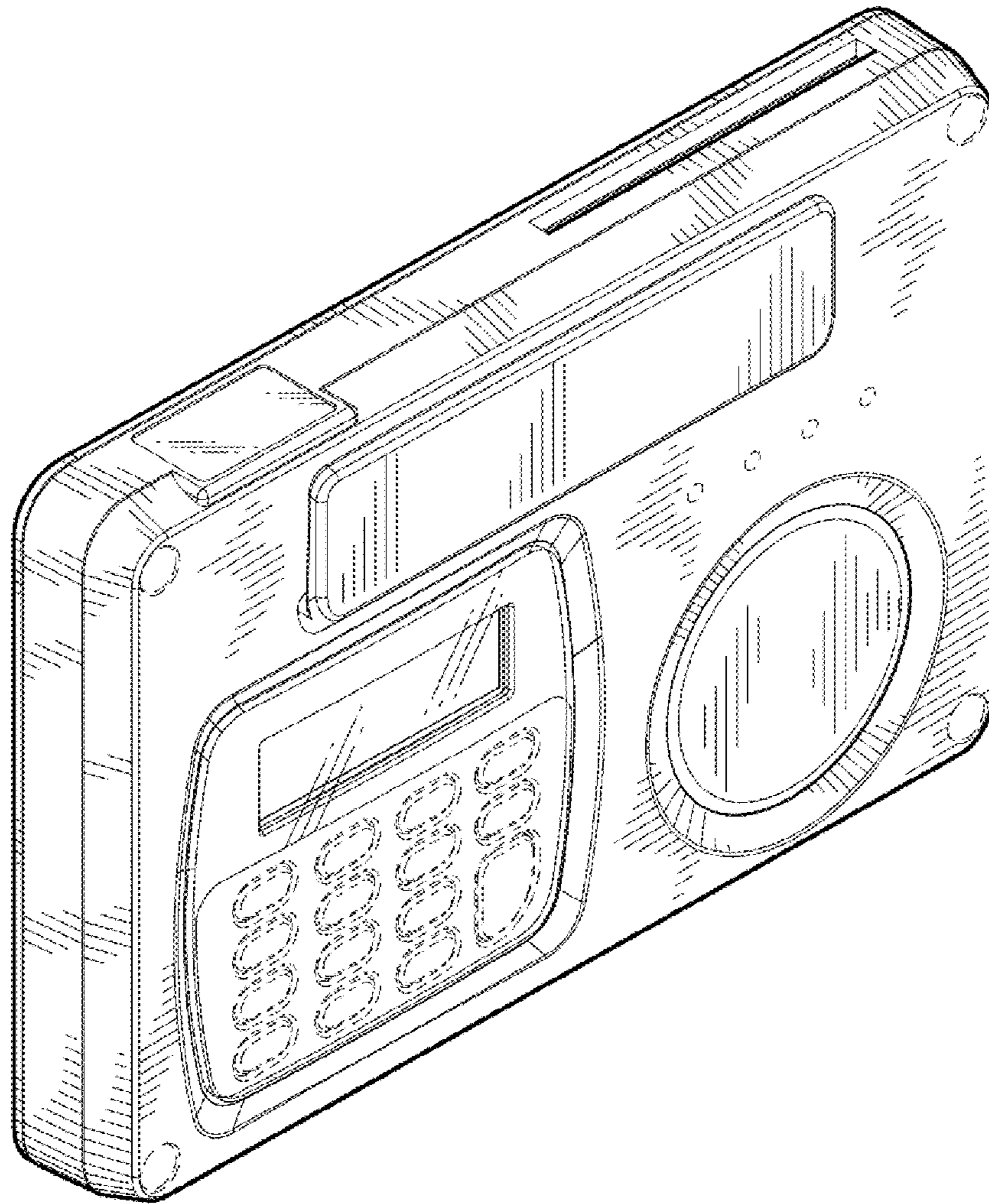

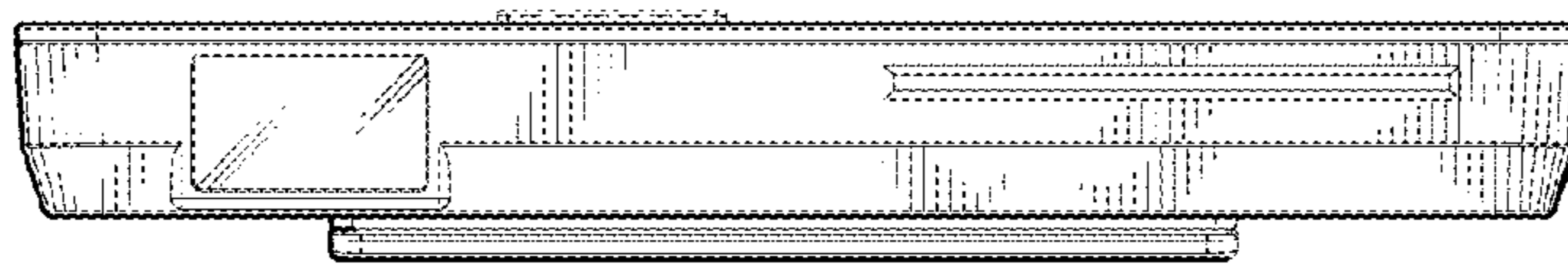

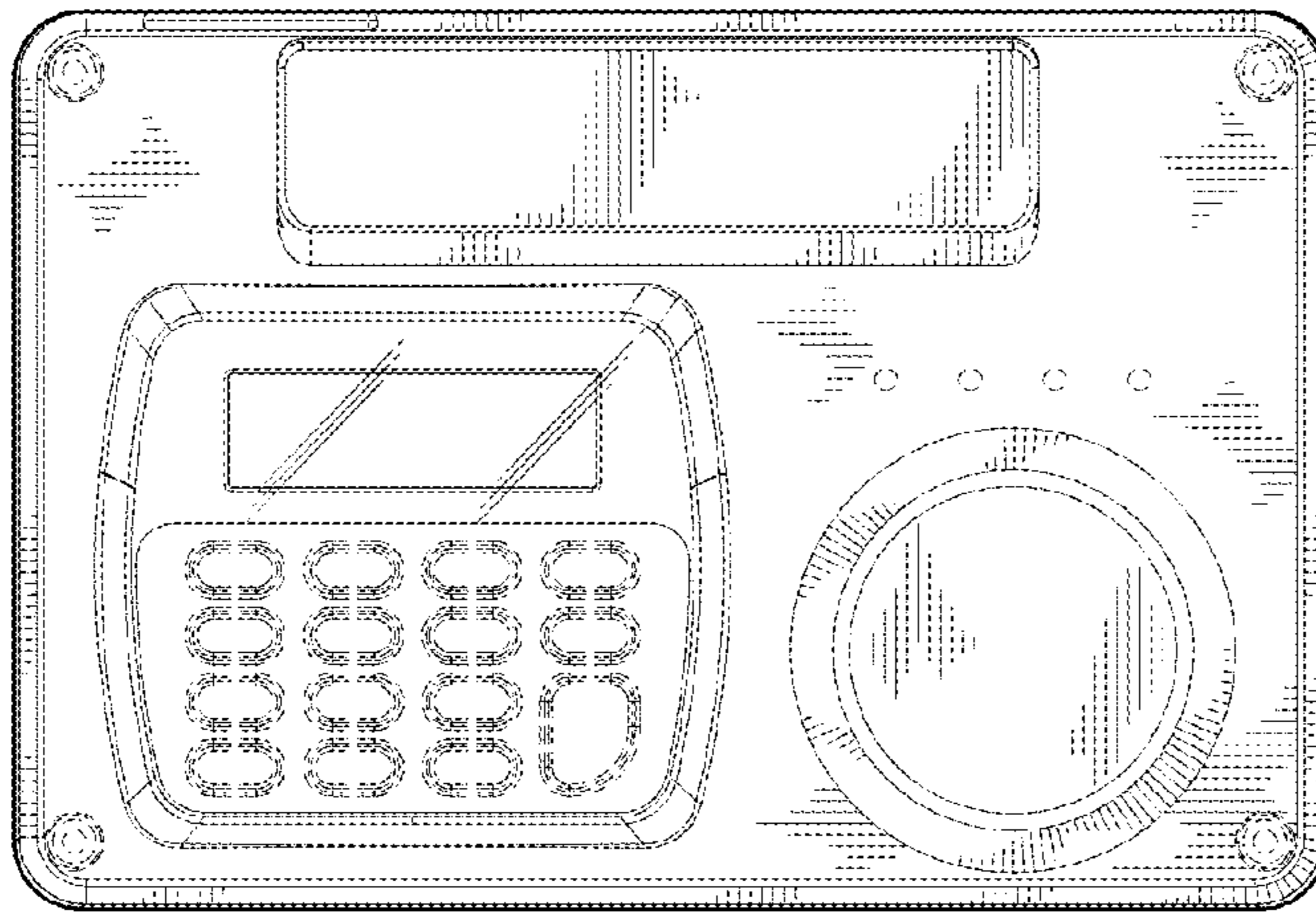

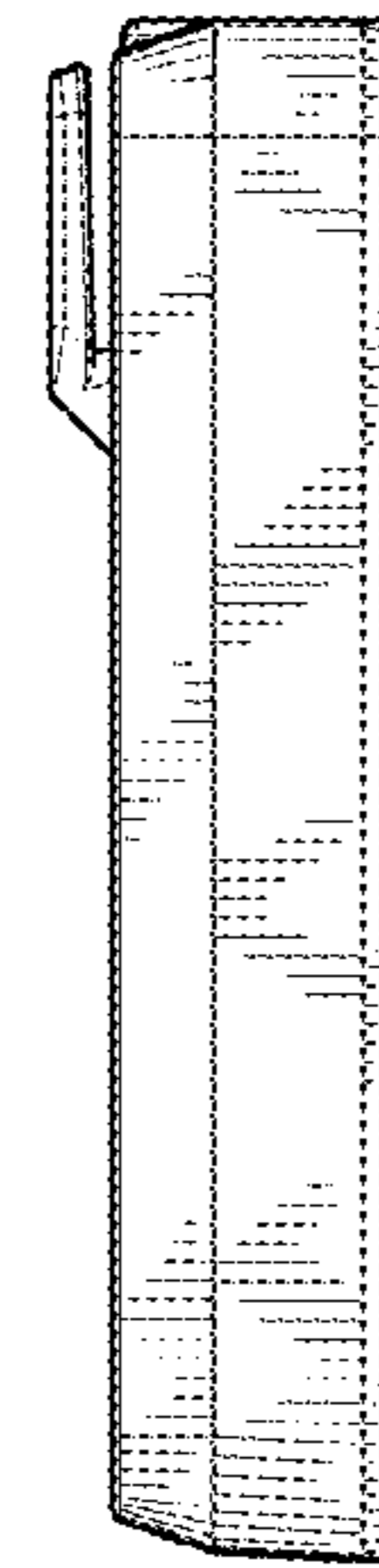

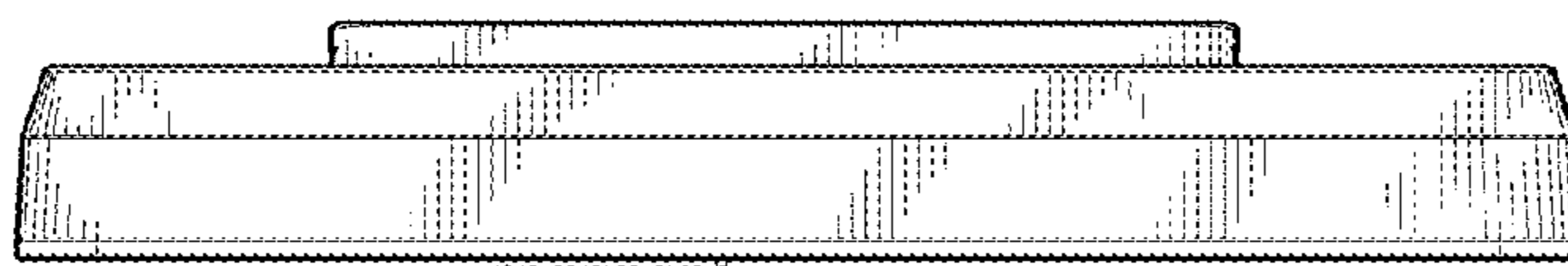

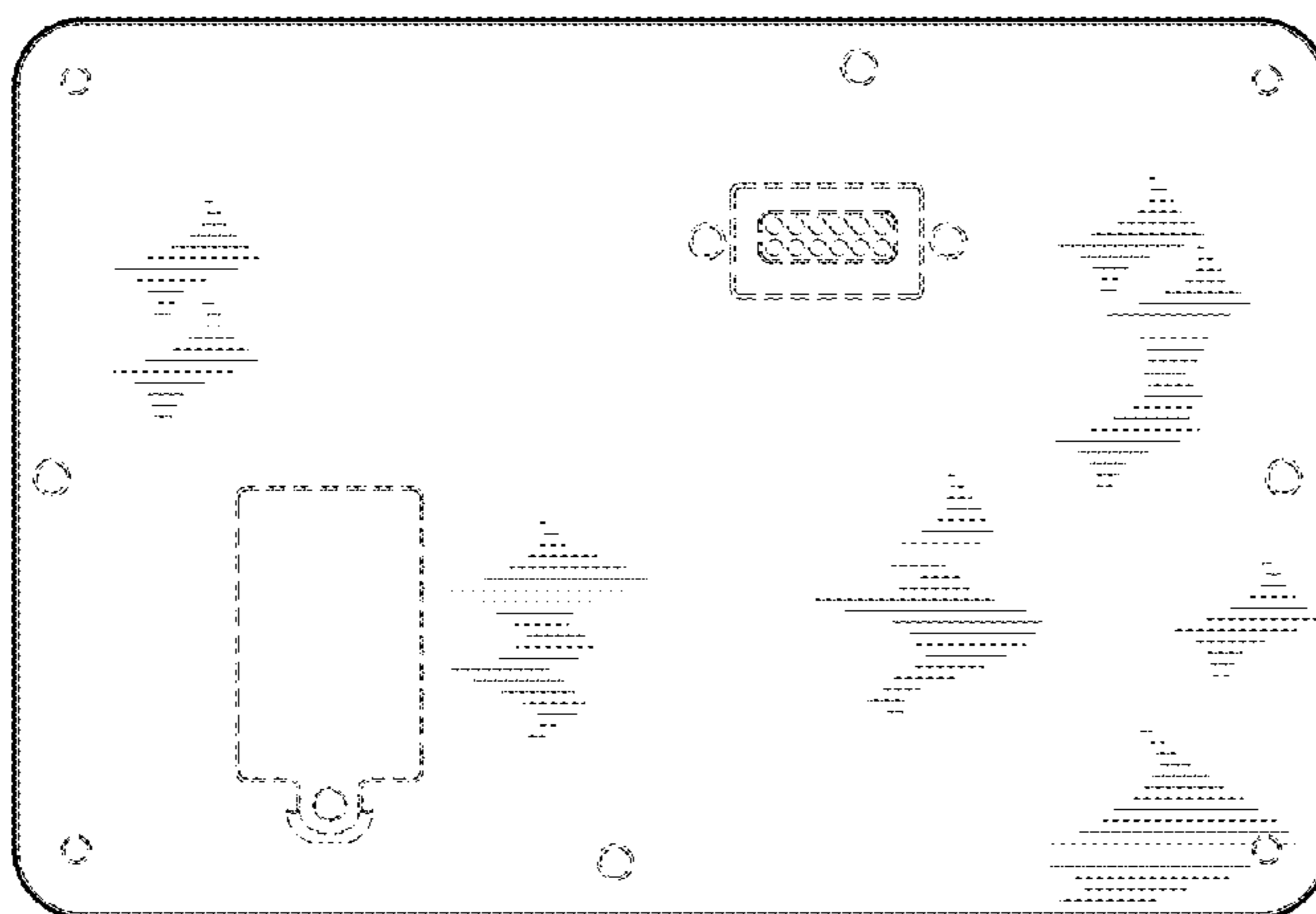
