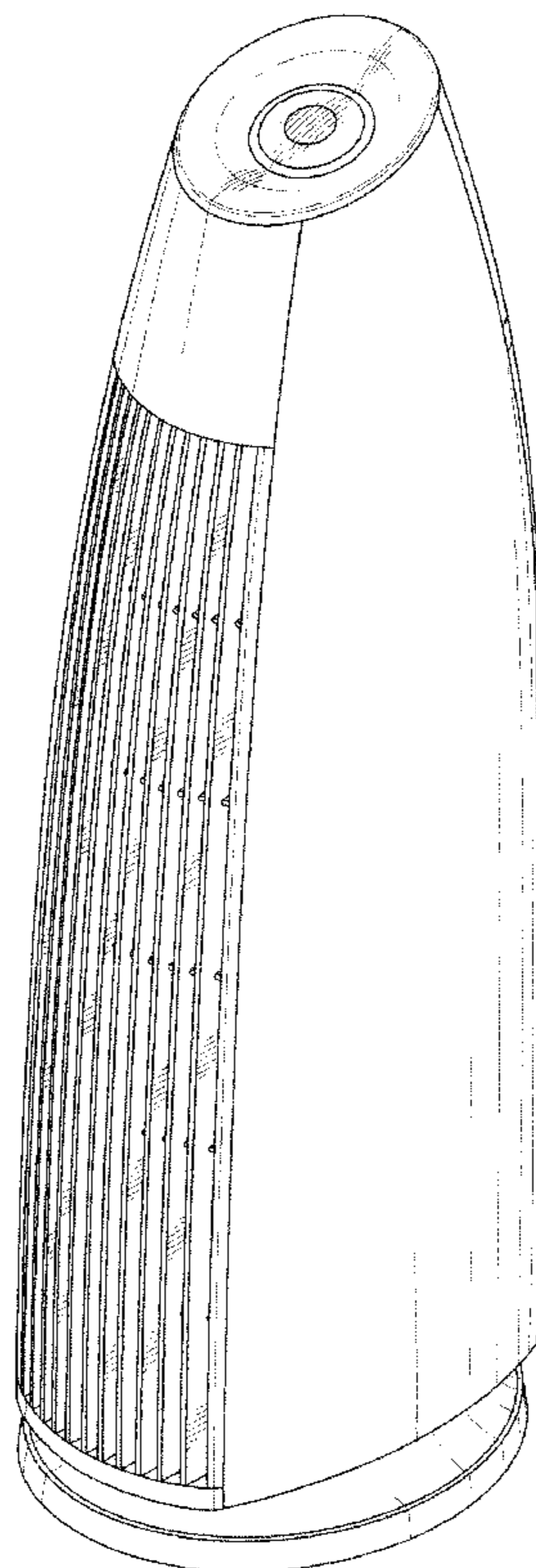
The ornamental design for an air purifier, as shown and described.

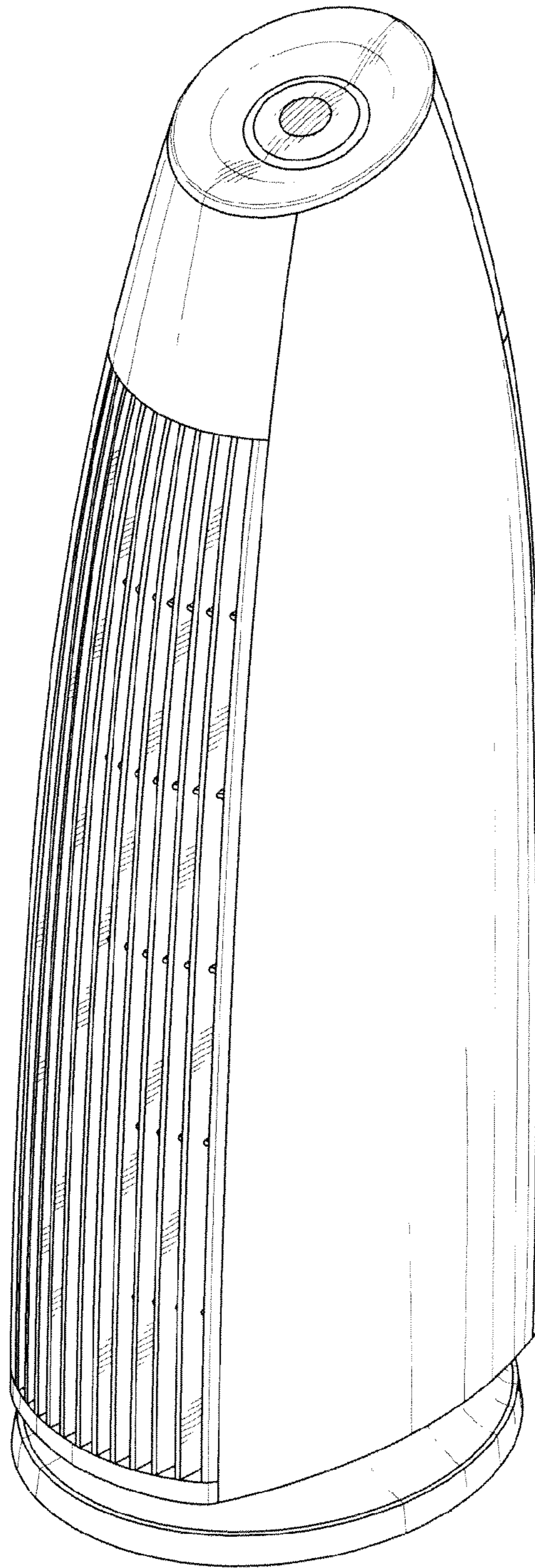

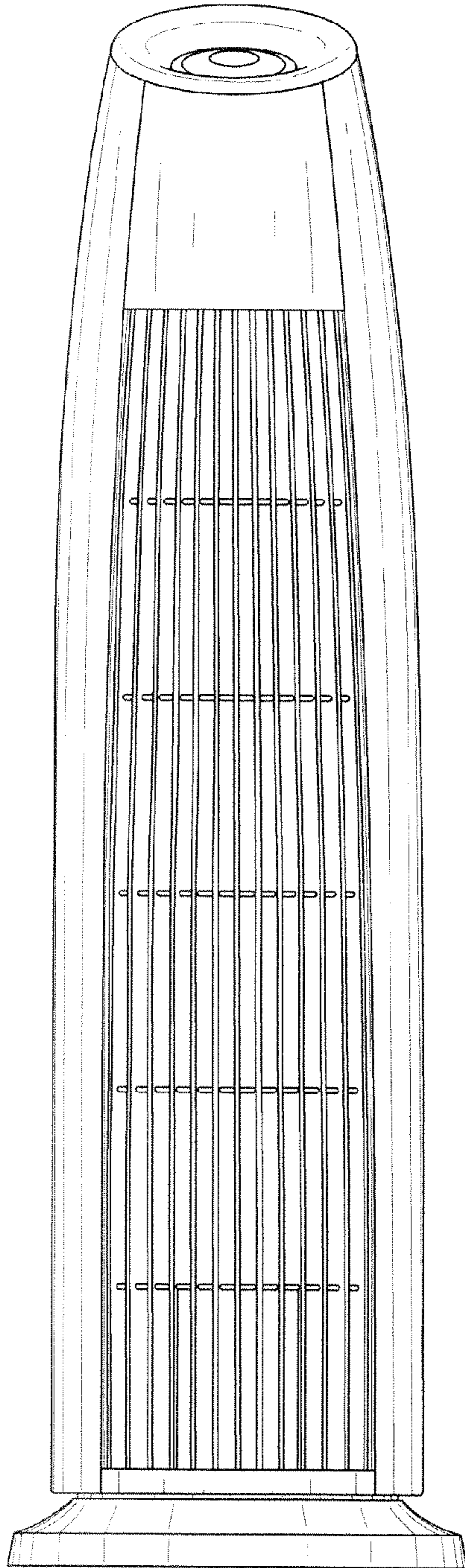

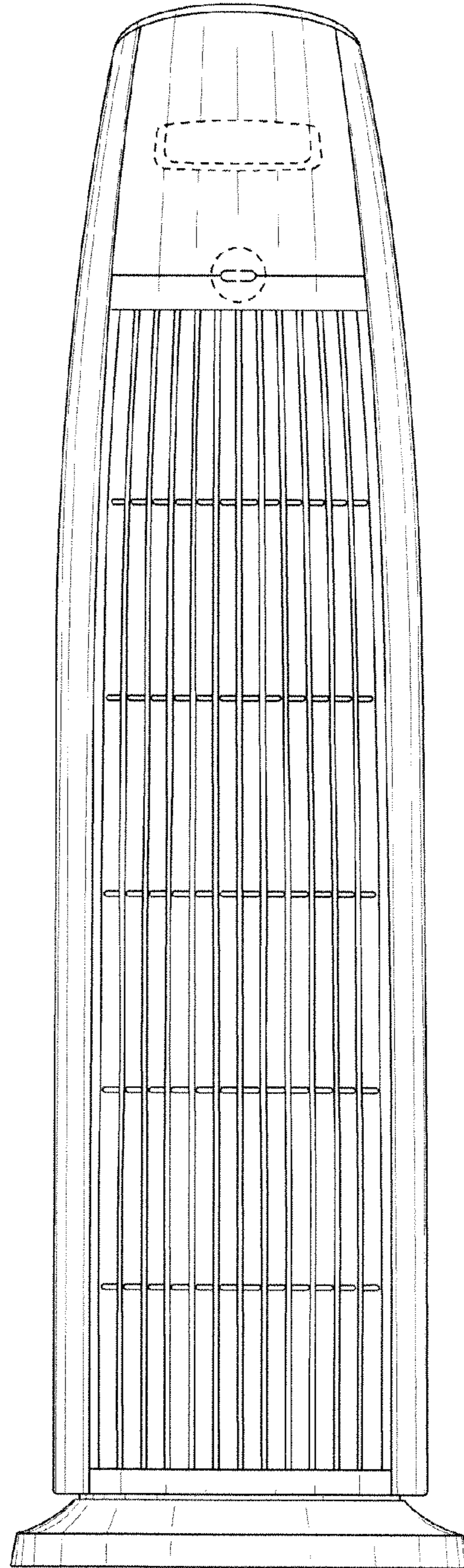

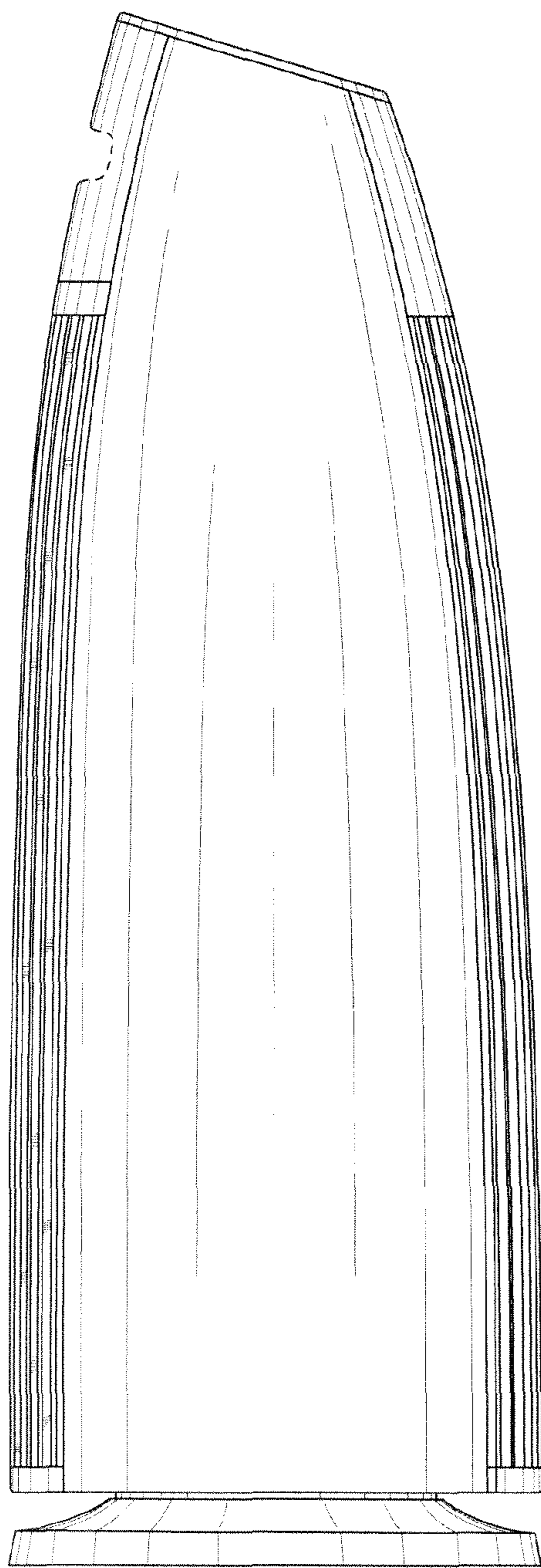

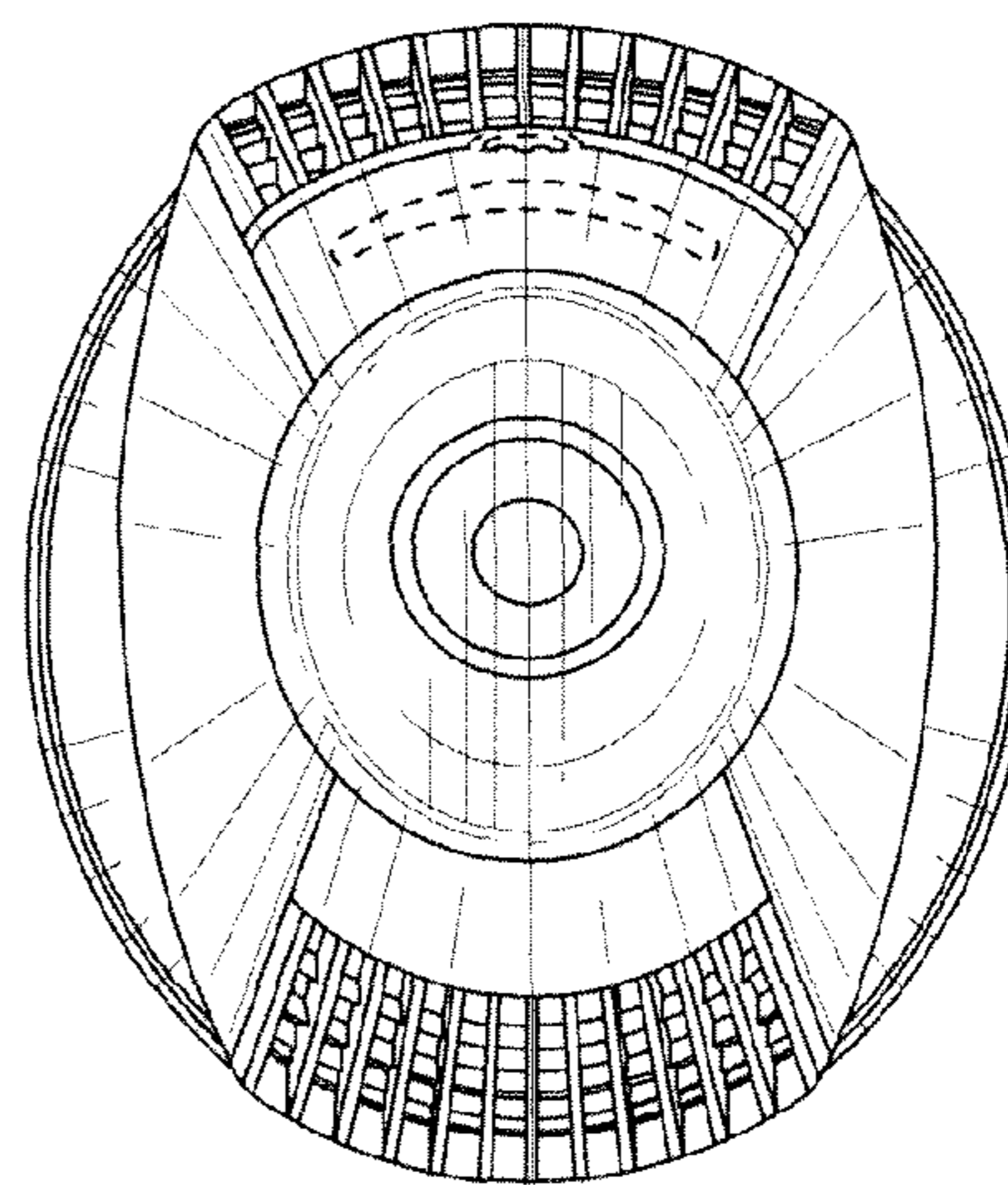

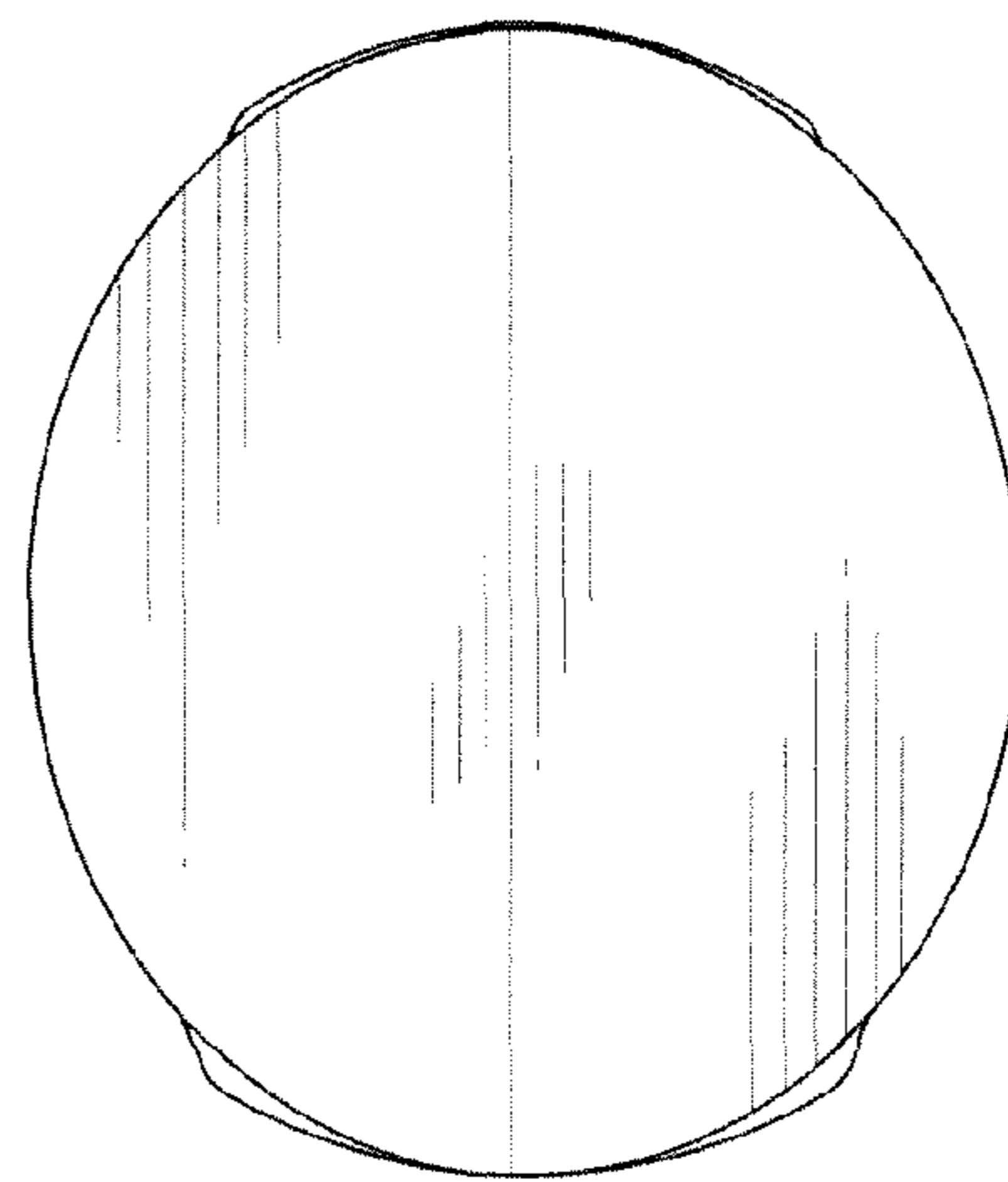
